Torgy's Travel Tips - March 2020

75th Anniversary of WWII European Liberation

2020 is a milestone year for many reasons: The 100th anniversary of the ratification of women's voting rights with the 19th Amendment, the 50th anniversary of Earth Day, the beginning of the 3rd decade of this millennium, etc. But today I would like to remind you of the 75th anniversary of the end of WWII and the liberation of Europe. Get your map and calendar out as I guide you to a celebration that you won't want to miss: Liberation Festival Pilsen.

Pilsen is located 56 miles west of Prague, Czech Republic and most folks know it as the home of Pilsner Beer. You can definitely quaff some of that excellent beer here and tour the brewery as well at the nearby Pilsen Underground with its cellars and wells dating back to the 1300's. But every year since 1990, the town of Pilsen commemorates its liberation from Nazi Germany by US forces, under the command of General George S. Patton. I had the opportunity to be there last year, and I shed tears of joy at the sight of thousands of regular, everyday Czech citizens, from toddlers to seniors, waving US and Czech flags and saying, "Thank you, America".



Let me give you a little background. The country many of us still think of as Czechoslovakia was formed in 1918 at the end of World War 1. This sovereign nation was comprised of several distinct cultural groups. The westernmost portion was home to many whose primary language was German. In 1938, Hitler overtook this area, the Sudetenland, without challenge and thus began the first of his conquests of Europe.

Fast forward to the spring of 1945 and the dwindling days of the Nazi regime; Berlin had fallen to the Soviets on April 20th and the Western Allies had crossed the Rhine and spread throughout Germany.



On May 4th, the US broke through the eastern frontier and entered Czechoslovakia. The next day the civilians in Pilsen rose up against the German occupiers and tore down Nazi flags and symbols. At 8AM on May 6th, Patton's 16th Armored Division entered the city, and German General Von Majewski surrendered. At 2:45pm that day, he committed suicide before his wife and staff. Pilsen was free!



Germany formally surrendered on May 8th. Pilsen was the furthest eastern point in Europe that Allied forces fought. The Soviet Army, advancing from the east, overtook the rest of the German occupied territory in Czechoslovakia, including the prized city of Prague. Czechoslovakia remained under Soviet control from 1948 until 1993. During those 40 years, Pilsen was not allowed to commemorate or celebrate their liberation because of Soviet belittlement. Nevertheless, first-hand accounts, equipment, photos, memorabilia and strong family traditions were secretly preserved and finally, in 1990, the first public Liberation Festival occurred. Two and half years later, with the exit of the Soviet regime, the Czech Republic was born. On the first weekend of May each year, Pilsen can now express its thanks to the US, and it does so in a grand, 5 day celebration.

So what takes place at the Liberation Festival, you ask? People come from all over the world to witness and participate in the “memory of crucial moments of history and strengthening of the current freedom”. But it’s so much more than that. Pilsen has collected and preserved hundreds of US trucks, tanks, half-tracks, uniforms, airplanes, music, clothing and other nostalgia. Local citizens dress in period clothing and a huge parade with US Army vehicles, replete with young men dressed as US soldiers rolls through the same streets as on May 6, 1945. There are loud speakers playing period music and a fly-over of US aircraft. The light standards are bedecked with Czech and US flags throughout the whole town and everyone jockeys for the best viewing position. There are celebrations in several museums and gatherings for veterans and their families. Drinking and toasting abound in the bars and restaurants. There are smiles and pride, everywhere!

In anticipation of the parade I brought 2 small US flags from home, hoping it might be OK to wave them. OK? You bet it was! While driving into Pilsen on the morning of the big parade, we spotted several WWII vehicles entering the roadway. I rolled down my window and waved my flags. The response from the young Czech fellows in period US uniforms was enthusiastic waving and horns honking. How cool was that!

Introducing the EWR-DCA shuttle



As United previously announced during the Media Day Event in October, United is launching a new hourly shuttle service between EWR-DCA (Reagan Washington National) that will offer customers 13 daily flights between the Beltway and the Big Apple – more than any other airline.

Most of the flights will be operated by United’s first-of-its-kind two-cabin, 50-seat Bombardier CRJ-550 aircraft that offers first-class seating, Wi-Fi, amenities,

more leg room and enough space for every customer to bring a roller bag on board.

Tickets will be available for purchase beginning Jan. 18 and service starts on March 29.

“Our customers who regularly travel between Washington, D.C., and New York – one of the busiest routes in the country – have told us they value convenient flights and a comfortable ride above all else,” said United Express SVP Sarah Murphy. *“With our new shuttle service aboard the one-of-a-kind CRJ-550, United Airlines is the only carrier to deliver both.”*

United is changing terminals at PHX



Check out United’s new digs at PHX!

Starting February 4, United will operate out of the new Terminal 3 at PHX (Phoenix). This facility will offer United’s customers and employees a modernized experience with updated architecture, more food and retail options, and later this year we also will open a brand-new United Club location.

Here are a few things you should know about the new terminal:

- * Ticket counters will be located on Level 1 of Terminal 3.
- * Cargo drop-offs (i.e. PetSafe, QuickPAK) location is unchanged.
- * Employee parking will be on Levels 7-8 of the Terminal 3 garage.
- * For crews on layover, the hotel shuttle bus pickup location will be in front of Door 6 on the baggage claim level. Note that the regular courtesy shuttle will be across from Door 9 on the baggage claim level if you prefer to use that instead.
- * TSA Precheck security checkpoint will be located on Level 2 of Terminal 3.
- * The Known Crewmember checkpoint will be located on Level 2 of Terminal 3. Use elevator 5 to go up to Level 2 – you will see signage right outside the elevator.
- * United will primarily be using Gates E1/E3/E5/E7/E9/E10 in Terminal 3.
- * A flight planning area will be available in the

Ops office under Gate E5. Access from inside the terminal will require an escort (no change to current policy).

- * The Inflight base is located on Floor 5 of Terminal 3. Take Elevator 5 to the fifth floor and go to room T35WT367T.
- * Baggage claim will be located on Level 1 after you leave the secured area of the terminal.
- * The new United Club location will be located between Gates E3 and E5.

Please note that the United Club location in Terminal 3 won’t open until later in the year, but it’ll be worth the wait! This brand-new club will feature a modern and beautiful design, a uniquely regionalized menu and a wellness room. At 5,400 square feet, it’s much larger than United’s club in Terminal 2 and it will offer 108 seats. Watch for more information – and photos – of the new club in the coming months.

Get REAL (ID)



If you haven’t already, now’s the time to get “real” ... as in making sure your state-issued driver’s license or identification card is compliant with the U.S. Federal Government’s REAL ID Act.

Beginning October 1, 2020, TSA will require air travelers 18 and older to present a REAL ID-compliant driver’s license or state identification card or another acceptable form of ID at airport security checkpoints for travel within the United States. The REAL ID Act, which passed in 2005, set minimum security standards for license and ID card issuance and production as an added security precaution. Over the past 14 years, the law has been enforced in phases, giving states and ID holders ample time to comply, with commercial airline passenger enforcement being the final phase.

To help minimize disruption, the TSA launched a public awareness campaign, posting signs at airports nationwide to remind travelers of the upcoming deadline. United is also posting an alert on united.com and is informing its customers of the new requirement. Check TSA’s website to determine if your current identification meets REAL ID standards before traveling. A

passport, passport card, or Global Entry or NEXUS membership card will still be acceptable forms of identifications for customers and employees who don't carry a compliant state-issued ID.

This month, we are highlighting one of our very active members, **Ron Paluch**:

I was born in Chicago, and grew up on the south side, and a Cubs fan all my life. I started playing softball in 1995, and have continued playing every year since, and have enjoyed it very much. Before playing softball, I was involved in hot air ballooning. I was part of an officiating team that traveled to cities in the United States for competitions. I also traveled to different countries for World competitions and was fortunate to fly with some of the pilots.

After getting out of the Air Force in 1964, I went back to Chicago and found out from a softball friend that United was hiring, as the ramp and mechanics had just come off a strike. I applied and got the job; had a couple weeks of classroom training and then out on the ramp for more training, driving tractors and loading planes. I was put out on the jungle ramp to begin my career. Being junior, I spent a lot of time in the belly pits, loading and unloading bags, mail, cargo, and animals, etc.

*After 35 years working on the ramp, in 1972, when United went to Midway Airport, I put my bid in and got it. I lived on the south side, so it was nice not having to fight traffic going to O'Hare. I had a great highlight and a very sad low light while working at Midway. My low light was on December 8, 1972. I was waiting on my tractor for a flight from D. C., Flight 553, when my supervisor, **Wally Powers**, came running up to me and said the airplane had crashed in the neighborhood. We jumped in a van and headed to the crash scene. When we got there, the firemen were pulling people out of the airplane. The plane had crashed into several homes; a grandmother and her granddaughter had died in one of the houses the plane hit, but the other two homes had no one in them. The firemen were chopping a hole above the first class door to get the flight attendant out; they were pouring water on her to keep her from burning. They were successful and got her out alive. She had broken bones and burns, but she survived.*

*My supervisor, **Wally Powers**, asked me to go to the local hospital to check on the two flight attendants, who were in the back of the plane. When I arrived at the hospi-*

tal, there must have been 20 reporters and camera men rushing to me. I told them I didn't know anything. A doctor standing to the side, called me over and asked who I was looking for. I told him the flight attendants, and he took me to this room. One flight attendant was smoking a cigarette and calm as could be. I asked them if they got hurt and they said no. One flight attendant told me she thought that they had landed, until the back door opened up and they saw a tree standing there. Eighteen of the 61 people aboard died; the flight crew didn't make it either. Very sad!

On a brighter note, in January of 1973, I got to go to the Super Bowl 7. They had a drawing of all the people who worked at Midway, and I was the lucky winner. I got positive space to LAX, hotel room for a couple of days, and two tickets to the game on the 40 yard line; not far from the field. Miami Dolphins beat the Washington Redskins 14 - 7. That was the year, Miami was and still is the only undefeated team in NFL history.

After about a little over a year, United pulled out of Midway. A friend of mine suggested we go to AF at O'Hare on midnight's and work cargo there. My friend lasted about 3 months, and went to days at the terminal. I stayed on graveyard for the next 13 years. The guys I worked with were great! We had a ball and had a lot of fun doing our job.

In 1986, after commuting to SEA for 5 years, I finally got my transfer there. I worked at AF on swing shift. Worked with a lot of great bunch of guys working there also.

In 2001, the tragedy of 911, United offered us a deal to retire. We were in contract talks and United said that if we wanted to retire while contracts talks were going on, we would get whatever the new contract gave us. So, Shirley and I decided to take up the offer and retire. I've been retired for 18 years now, it is the best decision we ever made. We were at United at the right time. It was a great company to work for. We saw the highs and lows, and to me, there were more highs than lows.

After retiring in 2002, Shirley and I went to Mesa, Arizona, to look around for a place to live as snowbirds, and ended up buying our present home. We both joined the Re-United's Chapter and also RUAEA that same year.

Shirley (Claggett) and I have been involved with RUAEA and for several years being Registrar and Treasurer of the Conventions.

A quote from Ron: "As we all get older, remember to cover as much ground as you can before it covers you."
