



## United Expands World's Largest Flight Training Center to Prepare for Pilot Hiring Surge June 1, 2022



United Airlines today announced it is expanding its Flight Training Center, already the largest facility of its kind in the world, as the airline seeks to hire an additional 10,000 pilots by 2030. The airline will add

a new four-story building on the 23-acre campus in Denver's Central Park neighborhood that will house 12 additional advanced flight simulators, training classrooms, conference rooms and offices.

Marc Champion, Managing Director of the Flight Training Center, was joined today by Toby Enqvist, United's Executive Vice President and Chief Customer Officer, Matt Miller, United's Vice President of Airport Operations in Denver, Denver's Mayor Michael Hancock, and Phillip Washington, CEO of Denver International Airport, at a groundbreaking event to kick-off the expansion project that is expected to be completed before the end of 2023. United has embarked on an aggressive plan to recruit and train thousands of pilots in the next decade and remains an attractive option for aviators because the airline has one of the largest global networks in the world and flies more widebody aircraft than any other North American carrier.

"The expansion of this world-class facility gives United even more resources to recruit and train the next generation of aviators," said Marc Champion, Managing Director of the Flight Training Center. "Our pilots are the best in the industry and flying remains one of the best, union careers in the world – great pay and benefits and the chance to captain the biggest planes to the most places around the world."

United's campus – seven buildings, across 550,000 square feet of training space – is the sole training facility for the airline's 12,000 active pilots and all newly hired pilots. Every nine months pilots must visit the training center to remain up-to-date on certifications. At any one time, there may be up to 600 pilots training at the facility.

United's Flight Training Center campus currently has 39 full-motion flight simulators and 15 fixed training devices – the additional building means United will soon have the capability to have a total of 52 full-motion simulators and 28 fixed training devices.

United expects to add more than 2,000 new pilots this year alone and is on track to hire 10,000 pilots by 2030. The airline plans to train around 5,000 pilots by that date through United Aviate Academy, the airline's own pilot training school. United's goal is to have at least half of the pilots trained at the United Aviate Academy to be women or people of color.

United and its pilots' labor union (Air Line Pilots Association) recently reached an agreement on new contract terms, a first among the major U.S. carriers.

"United Airlines was the only airline to work with our pilots union to reach an agreement during COVID," CEO Scott Kirby said in a post. "It's not surprising that we are now the first airline to get an Agreement in Principle for an industry leading new pilot contract."

Companywide, the airline has embarked upon an historic hiring effort, planning to hire 50,000 people in the next five years. Close to 90 percent of United's domestic workforce is unionized, and all employees of the airline, even part-time employees, earn more than the federal minimum wage and are eligible to receive company-sponsored medical coverage, participate in company-funded retirement programs, receive paid vacation and flight benefits to travel the world.

More than 1,000 of United's 7,000+ Denver-based employees work at United's Flight Training Center in roles including instructing, evaluating, scheduling, human resources and flight standards.

The facility demonstrates United's longstanding commitment to the Mile High City. It was originally constructed between 1966-68 as part of the Stapleton Airport complex and has served as United's main pilot training facility since then. Within the last five years, United has renovated the entire facility and added an additional building as recently as 2020.

This May, United celebrated 85 years of continued service in Denver. Today, the carrier is the largest airline in Denver area, connects Coloradans to more places in the world, and operates the most flights and carries the most passengers in the state of any airline. United has invested \$825 million to add new gates at Denver International Airport, with several gates already open. The expansion will soon bring United's total gate count at the airport to 90.

# <u>United Becomes First U.S. Airline to Sign Agreement to</u> <u>Purchase Sustainable Aviation Fuel Overseas</u> <u>May 10, 2022</u>

United, which has invested in more sustainable fuel production than any other airline in the world, became the first US airline to sign an international purchase agreement for sustainable aviation fuel (SAF).

The airline has signed a new purchase agreement with



Neste that provides United the right to buy up to 52.5 million gallons over the next three years for United flights at Amsterdam's Schiphol Airport, and potentially other airports as well.

"Reducing carbon emissions from fuel is the fastest way United will reach our 100% green goal by 2050. As the airline that has invested more than any other airline in sustainable aviation fuel production, it makes sense to expand our network of partners internationally with a leading company like Neste," said Lauren Riley, United's Chief Sustainability Officer. "The demand from our customers to limit their emissions from flying is growing exponentially, and this agreement means that United customers flying from Amsterdam and potentially other airports will be partners in our sustainability efforts."

Neste will provide United with 2.5 million gallons of SAF in Amsterdam in the first year. United will also have the right to purchase up to 20 million gallons in the second year, and up to 30 million gallons in the third year, at Amsterdam or other locations that Neste can supply throughout the globe, as Neste increases its SAF production.

This supply agreement is enabled by Neste's ambitious growth strategy, which will see the company producing 515 million gallons of SAF (1.5 million metric tons) per year by the end of 2023. Neste has been producing and delivering SAF since 2011 and has a proven track record of supplying SAF to customers in Europe, Asia and the Americas.

"We're excited to be partnering with United in this milestone purchase agreement and make our SAF available to United, also an industry leader in SAF investments," said Thorsten Lange, Executive Vice President, Renewable Aviation at Neste. "Our global, fast-growing SAF production and supply chain supports airlines and their customers in reducing greenhouse gas emissions. Neste is committed to helping aviation transition to a more sustainable future, and we look forward to expanding our cooperation with United."

SAF delivers the performance of conventional jet fuel but with a significantly smaller carbon footprint on a lifecycle basis. Neste's SAF reduces lifecycle greenhouse gas emissions ("GHG") by up to 80% compared to conventional jet fuel and burns cleaner than conventional jet fuel reducing non-CO2 emissions, including particulate matter (PM). Neste MY Sustainable Aviation Fuel<sup>TM</sup> is produced from 100% sustainably sourced renewable waste and residue raw materials, including used cooking oil and animal fat waste.

United has aggressively pursued strategic investments in SAF producers and revolutionary technologies including carbon capture, hydrogen-electric engines, electric regional aircraft, and urban air mobility. United has invested in more SAF production than any other airline globally.

# "Good Leads The Way": United's New Campaign Celebrates Employees Doing the Right Thing for Customers and Communities May 16, 2022



United Airlines today launched a new, national campaign – "Good Leads The Way" – that tells the story of United's leadership in areas like customer service, diversity and sustain-

ability, and captures the optimism fueling the airline's large ambitions at a time of unprecedented demand in air travel.

"In the past few years, United has emerged as a force for good and an industry leader," said United CEO Scott Kirby. This launch coincides with the kickoff of the summer travel season and a historic increase in demand – United's April seat fill in was the highest ever for a non-summer month, with 88 percent of seats occupied.

The Campaign ~ Each distinct piece across the integrated creative campaign represents a page in United's brand identity story, and aims to deliver inspiring ads with engaging storytelling around customer, employee and community benefits. No two pieces are the same, from anthemic film to dynamic live billboards counting the number of connections saved on United.

"At the heart of everything we do and say at United – every decision – is doing the right thing. We confronted them head-on with optimism and a determination to be a force for good for our customers and the communities we serve," said United chief communications officer Josh Earnest. # CLE's Mike Yuschak is our latest Taylor Award honoree By Pete Rapalus



Line Technician **Mike Yuschak**, who has spent most of his professional career with United, was honored by his CLE (Cleveland) colleagues and special guests when the FAA and United presented him with the Charles Taylor Master Mechanic Award on January 18.

Mike served in the U.S. Air Force as a technician on F-4 fighter and F-105 fighter-bomber aircraft from 1967 to 1971, and graduated from the Quaker School of Aeronautics in Philadelphia with his A&P (airframe and power plant) license in 1973. He then worked for the commuter carrier Ransom Airlines in PHL from 1973 until 1984.

when he joined United as a line technician at CLE. Mike's career with United included several location changes as a technician (CLE, DCA (Reagan Washington National)) along with taking a promotion to Aircraft Maintenance Supervisor with stops in MCO (Orlando) and ORD. Ultimately, Mike returned to CLE as a technician where he retired in 2003 in lieu of furlough.

He continued working as a technician in CLE, however, first at the charter airline USA3000 and then at CommutAir, until United welcomed him back to his current position at CLE in February 2015.

Mike's son, Mike Yuschak Jr., is a technician with PSA Airlines at their maintenance base at CAK (Akron-Canton, Ohio) and was a guest at the ceremony. Aviation Safety Inspector Steven Steele presented the award on behalf of the FAA, joining CLE Line Maintenance Senior Manager George Hujo and IAD Hub and Region Managing Director Jim Hammer. George and other speakers praised Mike for his skills as a technician and as George said, "Mike's dedication and passion for his craft is an example for all of us." In addition to his long history of service to aviation safety and reliability, Mike is known for collecting and working on vintage Corvettes.

To qualify for the <u>Taylor Award</u>, an aviation maintenance technician (AMT) needs 50 years of experience in aircraft maintenance, including a minimum of 30 years as an FAA-certified AMT; has to obtain peer recommendations; and must pass a thorough FAA review of his or her service record. The award is named for Charles E. Taylor, who was the Wright Brothers' engine builder and mechanic and is considered the first AMT in the history of aviation.

Mike's name will be added to the roster of United's Taylor Award honorees on our ORD monument featuring a bust of Taylor. That installation is located airside on the departures level of Terminal 1 near the walkway to Terminal 2. Mike and a guest will also be invited to our next annual Taylor Award group tribute event.

#### <u>Torgy's Travel Tips – July 2022</u> A PNW Circle Trip of the Past and Present



Over 6 years ago, I wrote in this column about a very interesting World War II era site worth a visit in the Pacific Northwest. This site has now reopened after a multi-year closure due to Covid. I've put together a circle trip itinerary you might consider that incorporates this site along with some nearby outstanding venues and vistas that would make

for an interesting, relaxing vacation. Summer and fall are the best times to enjoy a trip like this, so pack a bag, make a listing, reserve a rental car and fly out to Seattle or Portland.

We're headed east of the Cascade Mountains to the Manhattan Project National Historical Park in Richland, Washington to visit the "B" Reactor which produced the plutonium used in the first detonation of a nuclear weapon, in July 1945. It then fueled the Fat Man atomic bomb that was dropped on Nagasaki, Japan, one month later. That event led to the end of WWII. The reactor was built in just 11 months, due to increasing fears that Nazi Germany would develop an atomic device first. When visiting this site you are allowed to stand beneath the face of the reactor, where 200 tons of uranium "slugs" were loaded into aluminum tubes. Inside the control room, you see where the scientists and engineers brought the reactor online for the first time in 1944. There was speculation that it might initiate an uncontrollable chain-reaction and blow up. As we know, that did not happen. On the tour, docents explain the various rooms and functions and you have time on your own to view thought provoking displays. The tour takes about 4 hours and begins at the Richland Visitors Center located at 2000 Logston Blvd. Reservation registration is available at (509) 376-1647 or www. https:// manhattanprojectbreactor.hanford.gov/

Now Richland is situated within a lovely wine growing area, with more than 100 wineries extolling their award winning wines. Think of this as a pleasant alternative to crowded Napa, California. The nearby city of Walla Walla ("the town they loved so much they named it twice") is the usual jumping off spot for touring and tasting the predominant verities of Merlot, Syrah and Cabernet Sauvignon. There are wonderful B&B's all over and tasteful, tasty restaurants, ranging from funk to elegance!

If you travel in September, consider stopping in Pendleton, Oregon for the annual Pendleton Roundup. This is a real, honest-to-goodness, full-fledged rodeo that brings about 50,000 people to this small city just to the south of the mighty Columbia River. The Roundup, which began in 1910, offers parades, concert entertainment, a night pageant and competition rodeo bull riding and roping. Check out <a href="https://www.pendletonroundup.com">www.pendletonroundup.com</a> for all the details.

If you began this trip in SEA, you would then head westbound towards PDX along the Columbia River Gorge, using I-84 on the Oregon side of the river. This is a majestic route offering gorgeous (pardon the pun) vistas the whole way. You will encounter world-class wind surfers competing on the river between The Dalles and Hood River. Delicious local cherries and honey abound from roadside stands and magnificent Mt. Hood towers over, as you get closer to PDX. A worthwhile detour to Multnomah Falls is a must, as is Crown Point Vista House. Between May 24 and September 5, a Timed Use Permit is required to access the land adjacent to Waterfall Corridor if arrive between 9A-6P. Check www.travelportland.com for further info.

And a stop to see the famous mountain that blew its top in 1980 can be made on the drive between PDX and SEA. Just 52 miles north of Portland (or 98 miles south of SEA) is the exit to Winlock via WA504. This highway will take you all the way to Mt St. Helen's National Vol-

canic Monument. Be sure to go all the way to the Monument, not just to the Johnston Ridge Observatory. More info at www.mountsthelens.com

Of course, you could also add a trip out to the nearby Pacific Ocean beaches of Seaside or Astoria, Oregon and / or Long Beach and Ilwalco, in Washington for whale watching, stunning sunsets and the best seafood around. And Mt. Rainier, less than 50 miles from Sea-Tac airport beckons travelers to its glaciers, meadows and trails yearround. Whatever you choose to do, it will be pleasant, memorable and easy.



The Canopy Project is part of the mission of Earth Day. Forests are essential to life on this planet as we know it. Forests enable the growth of thousands of plants used in medicines and food production, and compose vast ecosystems for thousands of species of animals.

Despite the planet's need for forests, they have been disappearing at alarming rates. Since 1990, an estimated

420 million hectares of forest have been lost to deforestation and destruction. Though deforestation rates have slowed in the past few decades, it is estimated that 10 million hectares of forest were lost annually from 2015 to 2020. It is not enough to simply slow down, or even stop, the deforestation and destruction of forests. They must be rebuilt. Source: email from Kathleen Rogers, President of Earth Day, April 14, 2022

Since 2010, <u>earthday.org</u> has partnered with local environmental groups across the globe to plant tens of millions of trees with The Canopy Project. Areas that are most at-risk from climate change and environmental degradation have been reforested. The project has also conducted broad tree planting in the wake of environmental disasters.

On the earthday.org website, there is a worldwide map showing all the areas that have been replanted with The Canopy Project. For example, go to California, and you will see that what the Earth Day Network (EDN) has accomplished in our state. earthday.org supported the planting of 20,000 trees in National Forests of California that were destroyed by forest fires in 2018. EDN has partnered with Mokugift to plant over 400,000 trees in California since 2011. EDN also worked with Friends of the Urban Forest to plant 1,200 trees in urban San Francisco neighborhoods to improve air quality, increase shade cover and, since the trees are cared for by home owners and renters, increase community involvement and empower residents to care for their city. In 2010, EDN worked with Tree People and teams of volunteers to plant 3,500 fruit trees in urban LA. The project provides free healthy food to low income communities, helping to provide food security and combat diabetes. EDN also worked with Tree People to clear invasive species and replant native trees and ground cover across the Santa Monica Mountains Recreation Area. As you cruise the worldwide map, it is amazing to read about the projects in so many countries. It is also a sobering reminder of the importance of reforesting our entire planet.

Kudos to two of our members who volunteer their time as docents at attractions in our area. Russ Kennedy is a docent at the Blackhawk Museum in Danville. He offered to give our group a private tour of the museum. Unfortunately, this requires a lot of walking so many of our members couldn't go. On April 20, Russ gave a tour to Rich & Georgia Bouska, Jan Soderstrom and **Tracey Blanchard**. The museum is huge and really can't be seen in one trip but this overview tour let us see a bit of everything so we know what we want to see in depth on a future visit. Joe Leather is a docent on the USS Hornet in Alameda. Joe will be 90 in August and is the second oldest docent on the ship. The oldest docent is 93! I have had visiting the Hornet on my Bucket List for years and I am determined to go this year once my hand is healed. At my latest DAR District Meeting we saw a great program on the Hornet. It is amazing to see all the

love that the docents and volunteers have for the ship, many of whom, like Joe Leather, served on the ship.

The Lincoln Memorial just turned 100 years old! May 30, 2022, marked the 100th anniversary of the dedication of the Lincoln Memorial. It honors the 16th president of the United States, Abraham Lincoln, and was inspired by the Parthenon in Athens. The memorial features a statue of the seated Lincoln; engravings of the Gettysburg Address and Second Inaugural Address, two of his greatest speeches; and murals with allegorical depictions of his greatest accomplishments as president - the reunification of the United States following the Civil War and the emancipation of more than four million enslaved persons. The dedication of the Lincoln Memorial took place on Decoration Day (now known as Memorial Day) weekend. An estimated crowd of 50,000 attended the ceremony, while as many as two million listened across the country via the new medium of radio. Speakers included President Warren G. Harding, former president and Chief Justice of the United States William Howard Taft (who also served as chairman of the Lincoln Memorial Commission, which had overseen the design and construction of the memorial), and Dr. Robert Russa Moton, principal of the Tuskegee Institute. The latter, despite his honored place in the program and his remarks promoting equality among the races, addressed a segregated audience that day, a symbol not only how far the nation had come, but how much work remained.

Over the nearly 100 years since the Lincoln Memorial was dedicated, the edifice and the surrounding landscape have taken on a significance beyond merely commemorating the 16<sup>th</sup> president. As one of the most recognized buildings in the world, the Lincoln Memorial has become a symbol of the United States of America, a backdrop for national celebrations and the nation's pre-eminent stage for rallies and demonstration, particularly those for civil rights. During May, the National Park Service and its partners sponsored a number of commemorative activities which reflect on 100 years of honoring the legacy of Abraham Lincoln, including such topics as the meaning and memory of the memorial, the Lincoln Memorial as a work of art, the memorial and the monumental city, the many sides of Abraham Lincoln and the Lincoln Memorial's pivotal role in the civil rights movement.

According to Feeding America, an estimated 160,000 military families experienced difficulty putting food on the table in 2020. Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me. This is such an easy thing to do to support our troops. If you are scissors impaired, ask your grandkids to help! For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say "Manufacturer's Coupon". The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. In my area, the coupons come in Tuesday's mail along with the supermarket ads, and then in the Sunday paper. I can't wait to see how many coupons you all send me (to address I would like to thank Tracey Blanchard, Glenda Kennedy, Carol Parks and Noelle Sakamoto who bring coupons to our monthly meetings. I would also like to thank Carol Hulsebos and Sheryl Schubert who have seen my request in the newsletter and have mailed me coupons. The lady in charge of my DAR chapter's coupon project reports that as of May, she has sent in 13,300 coupons totaling \$34,200.

The guests were Judie King's granddaughter Serenity and Orville Harshbarger's daughter Julie and his two friends Michelle and Russ. The lunch was terrific with tamales, chili rellenos, rice, beans, grilled chicken and fish. It was a very warm day so it was nice having lots of water, soft beverages and a few adult beverages to accompany the delicious meal. Vicky and George's home is on a hill with plenty of views and enough shade with large oak trees and several umbrellas on the patio.

Dave started the meeting with big thank you to Vicky and George along with their neighbors who helped cook our lunch. He then passed on some information associated with the theme of our lunch. It was some history of Mexican food. "The history of Mexican food is a long a diverse one. It is believed that authentic Mexican food might have been derived from the Mayans. They were traditionally nomadic hunters and gatherers. Corn tortillas with bean paste were a common food item, but they also ate wild game, tropical fruits and fish. In the mid-1300s the Aztec Empire was thriving and though the Mayan food staples were still in use, chili peppers, honey, salt and chocolate found its way into their cooking. Some

of the wild games had become domesticated such as turkey. In 1521, the Spanish invaded Mexico and Spanish foods became an influence in Mexican cuisine. Spanish introduced sheep, pigs and cows along with dairy products and garlic along with other herbs. The early natives of Mexico did not have ovens; instead they heated food over an open fire using cast iron skillets and ceramic ware. Another method was steaming. They would suspend meat wrapped in cactus or banana leaves over boiling water in a deep pit. Frying was also a popular method. Salsa was sold in the Aztec markets. Salsa, the Spanish word for sauce, is uncooked and sometimes pureed until chunky, smooth or chopped. Large red tomatoes, tomatillo, chipotle (staples of Aztec diet) and the avocado are found in the modern salsa. The term enchilada is first referenced in the US in 1885. Yet the concept of tortillas being used as a wrap can be clearly linked to the Aztecs. The word enchilada means, 'in chili.'

As for reports; there was only one anniversary in May, Penny & Terry Greenacre with 60 years, Treasurer Judie King advised that we are still solvent. We heard that Ken Norton is home and doing well and wanted to thank all the Gold Diggers for their cards. Jack Raynor had new rosters for all. Dave continued with celeb birthdays on May 25<sup>th</sup>; Ralph Waldo Emerson 1803, actor Bill 'Bojangles' Robinson 1878, boxer Gene Tunney 1898, actor Claude Akins 1918, and a host of others. One very interesting was Dorothy Straight 1958. In 1962 her mother asked her 'Who made the world?' Dorothy wrote and drew her response all in one evening. Her parents loved it so much that they sent it to Pantheon Books which published it in 1964, making her the youngest published author.

In addition, there were many significant events on May 25<sup>th</sup>. In 1919 Casey Stengel pulled one of his famous stunts. Then a member of the Pirates visiting the Dodgers at Ebbets Field, he was visiting old friends in the bull pen he found that pitcher Leon Cadore had captured a sparrow. Stengel took it and quietly placed it under his cap. When he was called up to bat in the sixth inning he received mixed cheers and boos from the Brooklyn fans since he was an ex-Dodger. At the plate he took a deep bow and doffed his hat whereupon the bird flew away to great laughter from the crowd. In 1927, Henry Ford ends production of the Model T but begins production of the Model A. In 1935, Jesse Owens equaled or broke six world records in less than an hour. At a Big Ten meet in Ann Arbor, Owens from Ohio State equaled the 100 yard dash record and set the world records in the long jump, the 220 yard sprint and the 220 yard low hurdles. In 1945, Arthur C. Clarke proposes the idea of satellites in geosynchronous orbits. This will become a reality hence we have GPS in our cars and on our phones. In 1961, President John F. Kennedy announces that the nation is committed to putting a man on the moon by the end of the decade. In 1979, American Airlines flight 191 a DC10 leaving Chicago O'Hare loses an engine and crashes with 258 people dying. The DC10 would be grounded for inspections after this incident. 1992, Jay Leno replaces Johnny Carson on NBC's 'Tonight Show.'

Lastly, May 15<sup>th</sup> was the 90<sup>th</sup> anniversary of Stewardess Service. In 1930, Ellen Church went to Boeing Air Transport attempting to become a pilot. Being denied that position she and seven other ladies convinced the company to have Stewardesses. There are a couple of different versions of what happened on May 15, 1930. One account say four of the new stewardess flew from San Francisco to Cheyenne and the other four from Cheyenne to Chicago. The other version is that Ellen flew from Oakland to Chicago in a Boeing 80A holding 14 passengers. That there were thirteen stops and it took 20 hours. Either way it was groundbreaking. Of course we all know that BAT was the predecessor of United Air Lines.







It is always nice to receive our Newsletter. I love reading about people I have worked with over the years. I have been retired for 25 years, although I have not flown anywhere since 2018, I know my passes are available and that is comforting. Living in Florida, we take more cruises than flights.

Since March 4, 2021 life has been a challenge. After 6 weeks of in-home infusion 3 times a day, Kennedy ended up losing his right big toe; then 8 weeks of hyperbaric therapy June through August. He did not heal. It was not diabetes, as most people thought, it was poor vascular circulation. He ended up re-hospitalized from September to mid November, resulting in an amputation be-

low the knee of the right leg and 5 days later, above the knee which offered better blood flow for healing.

His hospital was across the street from the Tampa Bay's football stadium. We enjoyed watching the football fans going to the football games from the 7<sup>th</sup> floor of St Joseph's hospital. He came home 4 days before Thanksgiving.

Through it all, we thank God for our strength to keep on keeping on. We are also thankful for our Aetna Insurance supplement and Medicare. You pay for what you get.

At no time did he/we lose faith that God would take care of us. Our lives have changed forever, but we are still the same people, Kennedy and Joyce.
