

'Why don't we fly there?'

# **United Airlines**



"This route is great, but can we please start flying to X, Y or Z city/country/region? Other airlines do, but we don't. What gives?"

That's a perfect example, albeit tongue-in-cheek, of one of the most-asked questions in the comments section of Flying Together any time we make a new route announcement. It's one we're all familiar with; maybe you've even asked it yourself a few times. And now, to address that query and others like it, here are answers to some of your burning network questions.

So, first things first: How do we decide when and where to open new routes? It all starts with hours upon hours of research. The Domestic and International Network Planning groups continually analyze passenger load and fare data for routes we don't currently support before determining where opportunities for new service lie.

They'll take 100 city combinations, for example, then slowly whittle that list down until they reach 10-15 that are viable for us based on customer demand and profitability forecasts. Then they measure the impact of introducing new service versus adding more flights be-

tween cities we already serve. It's a constant negotiation between dozens of variables, and there's a lot of consideration that goes into those decisions, since we never want to launch a route that ultimately fails.

Which brings us to the decision to end service on a route. That is one that is never taken lightly, given the impact it has on employees, customers and communities. When it becomes clear that a route is no longer profitable, and it's clear there isn't a path to acceptable profitability in the foreseeable future, we will exit. In some cases, Network Planning might salvage a route by reducing it from year-round to seasonal, but that isn't always an option.

Now, let's say Network Planning unearths a potential new route that looks appealing. The question then becomes one of aircraft availability. Do we have existing capacity in the fleet to support it? If not, can we move equipment from an underperforming route? Or, would it be better served by United Express.

Before building a segment into the schedule, Network Planning estimates customer demand by evaluating connection options, the route's popularity and what the competition offers, among other things. Finally, planners look at different aircraft capabilities, things like number of seats, range, and takeoff and landing limitations, then decide if the route should be flown with mainline or regional equipment.

That's all fine, you might be saying, but there's still the question of us versus them. Why can't we offer a flight that one of our competitors does? The simple answer is, we can't be everything to everyone, everywhere. No, we don't have LAX-PDX (Portland, Oregon) like Delta (DL), for instance, but we do great with our LAX to IAH, IAD and ORD routes, which is why DL doesn't offer those flights. As mentioned above, we operate within constraints. A new segment requires assets, like airport gates and airplanes, not to mention paying customers. We're not going to cannibalize assets being used for more profitable routes just to compete with a competitor in places where we would be operating at a deficit.

There are plenty of places where the competition is firmly in our rear-view mirror. Hawaii and the great ski and national park destinations in the West, to name just two. Our overall strategy is about leveraging the network in the right ways to ensure United's long-term success.

President Scott Kirby likes to say we have the most network potential of any airline, and he's right. Unlike our competition, we have room to grow at our hubs. That means there's more route expansion to come, particularly in our mid-continent hubs. While this is by no means a fully comprehensive look at the work of our Network Planning teams, we hope it demystifies the thought process that goes into those decisions.

#### Changes coming to MileagePlus award travel

# UNITED **M**

United announced that award charts will no longer be published for travel on or after November 15, 2019. This change allows United to match award pricing to customer demand.

Where there is more availability, United will be able to offer lower prices than what the company offers to-day. That means one-way award flights within the U.S. and Canada that are currently 10,000 to 12,500 miles today may be available for fewer miles moving forward. You might have already noticed these lower award prices, and you'll be able to get them right away. If your travel dates are flexible, these changes will help you make the most of your miles.

Also beginning November 15, United is getting rid of the \$75 close-in booking fee for award tickets issued within 21 days of the departure date. That fee was waived for employees last year, so this change only impacts customers.

The award calendar on <u>united.com</u> or in United's app will continue to show the lowest available price for your destination.

#### **How United Express drives growth**



The kind of network expansion United has seen over the past year has been nothing short of monumental. United is moving down a historic path, and it's taken everyone at the airline pulling in the same direction to accomplish what it has – and that includes United Express flying partners.

Thanks to United Express, United entered several new, smaller markets in 2018, establishing a presence in more regions of the United States than ever before. As a result, last year United flew the largest number of customers in its history, driven in part by the fact that United Express saw an increase of roughly 4 million passengers compared to 2017.

"Simply put, it would be impossible for United to operate in as many places as we do without the help of United Express," said United Express SVP Tracy Lee. "Mainline service isn't financially feasible in every market, but we still want to offer those customers the choice of flying United."

As background on how those decisions are made, before building a new segment into the schedule, the Network Planning team estimates customer demand by evaluating connection options, the route's popularity and what the competition offers, among other things. Next, planners look at aircraft capabilities, things like number of seats, range and takeoff and landing limitations, then decide if the route should be flown with mainline or regional equipment.

Though many of the domestic routes United introduced last year are served by United Express, the reality is that, over the past five years, mainline departures are up by more than 22 percent, while United Express departures are down by the same percentage. Mainline is growing faster than at any point in United's history, even with the added United Express flights. And it's important to remember a majority of the customers who fly United Express ultimately end up on a mainline aircraft at some point in their journeys.

"The regional jets bring passengers to our hubs, where they connect to other cities on mainline flights. United Express is an extremely valuable conduit in that sense," Tracy continued. "Without our flying partners, those customers might never step foot on a United aircraft."

To that point, some of places in which United has launched service in the past year were formerly strongholds for its competition. United Express allowed United to break into those markets and show those customers what they were missing.

"We hold our flying partners to the same high core4 standards that we hold our in-house employees to," said Tracy. "It's so important that we give our customers a seamless experience, regardless of who is operating a flight. The good news is, United Express is delivering. Even with last year's higher load factors, those carriers combined to record the best-ever completion rate and the second-best-ever on-time departure rate in United Express history. They're taking good care of our customers and earning repeat business. Our express carriers are a big part of the foundation on which United is growing, and that's a real source of pride for everyone involved."



#### <u>Torgy's Travel Tips – May 2019</u> International Travel Updates and Tips



As we head into the busy summer travel season I thought I would pass along some updates and a few helpful hints to assist you and your eligible travelers who may be thinking of an overseas trip. With all the wonderful destinations that United serves it's a hard choice to decide just where to visit!

A new nonstop to Amsterdam

began March 30th from our west coast gateway San Francisco. UA986 operates daily using 787-9 Dreamliner aircraft. Coming up real soon are 2 new European destinations that we have not previously served: Naples and Prague! Naples service begins May 22 and becomes our fourth destination in Italy, including yearround flights to Rome and Milan, and seasonal service to Venice. United will be the only airline to offer a nonstop flight between Naples and North America. Then on June 6 the beautiful city of Prague will be our first venture into the Czech Republic. This will likely be an extremely popular destination so standby travel may be a bit tight during the late summer season, but remember that Munich is a close-by alternative. Both Naples and Prague will be served out of Newark, using 767-300 aircraft. And if Portugal is on your wish list, Newark to Oporto seasonal service begins again April 29th.

Now onto South America ~ Good news if you are planning a trip to Brazil. This country has always been part of the A-B-C group (Australia, Brazil, China) that require US citizens to have a visa in order to enter the country. The visa cost alone was \$160 plus lots of paperwork. Last year, Brazil experimented with a streamlined \$40 electronic version to encourage visitors to attend the 2018 Summer Olympics. It proved so successful that Brazil will lift all visa requirements for US citizens effective June 17th! So, if the urge strikes, you can now travel to Brazil on a moment's notice. UA serves Sao Paulo, Brazil from Chicago, Houston, Newark and Washington Dulles. Rio de Janeiro flights originate in Houston.

Somewhat the opposite of Brazil's relaxation of entry requirements is the upcoming regulation change concerning the European Union. In 2021 US citizens (as well as those from 60 other countries, including Canada and New Zealand) will be required to "pre-register" their passport details electronically before arriving in any of the 26 countries that make up the Schengen Area. This area is defined as those EU countries that do not have internal borders and allow people to move freely

between them. France, Germany, Greece, Spain, Italy and Poland are just some of the 26 Schengen countries. The new program is called the European Travel Information and Authorization System, or ETIAS. Travelers will complete an online registration and pay a €7 (about 8USD) service fee. Completing the form and waiting for the automatic authorization will take about 10 minutes and the authorization will remain valid for three years. Again, this does not begin until 2021 and there will be more instructions and information coming out later on.

Something else that all US citizens traveling internationally should put on their checklist is to register in STEP: Smart Traveler Enrollment Program. This can be found at <a href="https://www.travel.state.gov">www.travel.state.gov</a>. If you are caught in a flood, hurricane, earthquake or civil unrest while overseas, the US Dept of State will have a chance to help you if you register in this program. They don't know to look for you if you don't register.

Effective November 1, 2019 there will be a big change in the entry rule for the United Club (Red Carpet Club). All United Club members (or those who purchase a day pass) must provide a same-day ticket on United or Star Alliance carrier in order to use the club. This applies to lifetime members as well.

And lastly, if you are just itching to fly somewhere and want to know which destinations have the best availability for you to travel standby on your passes, don't forget to use the Open Search feature in Flying Together: <a href="ft.ual.com">ft.ual.com</a>>travel</a>>employee res</a>open search. As a reminder, Open Search allows you to ask the system to display the total number of available seats to a specific city from anywhere, <a href="fc.ue">or</a> vice-versa. Your search parameter is limited to dates within the next 15 days and it works for United destinations worldwide. Those folks who fly from United hub cities like DEN, EWR, IAD, IAH, ORD and SFO benefit greatly when using this feature.

So get out there and make some memories!



If you want to hear some of his entertaining stories, ask Ken about his associations with such industry luminaries as Boeing test pilot Tex Johnston and United's late Joe Mortinson.

Based on his work at Boeing, Storey was exempted from the draft, but the Army grabbed him after he left Boeing in 1957, sending him to Ft. Bragg, North Carolina, where he became a crew member on a 20-man helicopter, the H212 Vertol, as part of the famed 82<sup>nd</sup> Airborne. He installed radios in all 21 of those copters before they were placed in service in Vietnam. He also flew as a 'copter crew member to various Air Force bases around the country, delivering the 77<sup>th</sup> Special Forces personnel to their new training bases.

Boeing reclaimed Ken for 4 months after his honorable discharge. There, Ken worked on preparing the 707s for delivery to early customers, such as Pan Am, Braniff, Continental and Qantas in addition to the U.S. government. He installed seats, carpets, bulkheads, tables, etc., which doesn't sound as glamorous as some of Ken's experiences, though his projects included the table that President Johnson used on Air Force 1, which is on display at the Museum of Flight. As junior man in the shop, Ken often worked 12-hour days when fuel tank leakage was a common problem.

Not enough? Tune in next month. If there's enough space, we'll continue the Storey Story with his work for United Airlines. He's a great storyteller, and it's hard to condense all the information published in our local chapter newsletter last year.
