How Often Should You Review Your Estate Plan?

How often do I need to review my estate plan? Although there's no hard-and-fast rule about when you should review your estate plan, the following suggestions may be of some help:

- ▲ You should review your estate plan immediately after a major life event
- ▲ You'll probably want to do a quick review each year because changes in the economy and in the tax code often occur on a yearly basis
- ▲ You'll want to do a more thorough review every five years

Reviewing your estate plan will not only give you peace of mind, but will also alert you to any other changes that need to be addressed.

There will be times when you'll need to make changes to your plan to ensure that it still meets all of your goals. For example, an executor, trustee, or guardian may change his or her mind about serving in that capacity, and you'll need to name someone else. Other reasons you should do a periodic review include:

- ▲ There has been a change in your marital status (many states have laws that revoke part or all of your will if you marry or get divorced) or that of your children or grandchildren
- ▲ There has been an addition to your family through birth, adoption, or marriage (stepchildren)
- ▲ Your spouse or a family member has died, has become ill, or is incapacitated
- ▲ Your spouse, your parents, or other family member has become dependent on you

- ▲ There has been a substantial change in the value of your assets or in your plans for their use
- ▲ You have received a sizable inheritance or gift
- ▲ Your income level or requirements have changed
- ▲ You are retiring
- ▲ You have made a change in your estate plan (e.g., you created a trust or executed a codicil to your will)

While trusts offer numerous advantages, they incur up-front costs and often have ongoing administrative fees. The use of trusts involves a complex web of tax rules and regulations. You should consider the counsel of an experienced estate planning professional and your legal and tax advisers before implementing such strategies.

United Announces Accelerated Timeline for Starlink's Industry-Leading Connectivity in the Sky **January 5, 2025**



United Airlines today announced an accelerated timeline to bring Starlink – the world's fastest, most reliable connectivity in the sky – to United travelers around the world.

The airline now expects to begin testing

Starlink next month with the first commercial flight anticipated to take off this spring on a United Embraer E-175 aircraft. United now plans to outfit its entire two-cabin regional fleet by the end of this year and have its first mainline Starlink-enabled plane in the air before the end of this year.

Ultimately, United will add Starlink to its entire fleet.

Access will be free for all MileagePlus customers and includes game-changing inflight entertainment experiences like streaming services, shopping, gaming and more. Membership to MileagePlus is also free and people can sign-up now at united.com/starlink.

"We have a lot planned for our MileagePlus members this year and adding Starlink to as many planes as we can – as quickly as we can – is at the center of it all," said Richard Nunn, CEO of United MileagePlus. *"It's not only going to revolutionize the experience of flying United, but it's also going to unlock tons of new partnerships and benefits for our members that otherwise wouldn't be possible."*

Last September, United signed the industry's largest agreement of its kind with SpaceX to bring Starlink to its entire fleet. And starting in a few months, the airline's customers will enjoy the same high-speed, low-latency internet service in the air that they enjoy on the ground. This gate-to-gate connectivity will enable experiences in the sky at scale that no other major U.S. airline provides, on seatback screens and personal devices simultaneously.

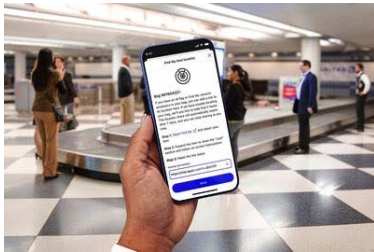
MileagePlus was recently rated the world's best airline loyalty program and includes the following features:

United Integrates Apple’s New Share Item Location Feature for AirTag December 12, 2024



United today announces the integration of Apple’s new Share Item Location feature for AirTag into its mobile app, a move that’s expected to drive a much-improved customer service experience for the fewer than 1% of customers whose bags arrive on a later flight.

Now available with iOS 18.2*, Apple’s Share Item Location feature enables United customers everywhere who travel with an AirTag or Find My network accessory to privately, securely, and seamlessly share the accessory location with the airline’s customer service team to help locate their luggage in the event that it is mishandled.

While more than 99% of customer bags flew with – or even beat – their owner to their destination so far this year, this new digital innovation is the latest example of United’s infrastructure, training and technology investments geared towards making travel easier and bag handling more seamless, especially when plans don’t go as expected.

“For years, every customer has been able to track the journey of their bag through the United app as it is scanned on and off the plane, and previously, they didn’t have a way to directly share their AirTag information with our baggage team,” said David Kinzelman, United’s Chief Customer Officer. “Now, Apple’s new Share Item Location feature will help customers travel with even more confidence, knowing they have another way to access to their bag’s precise location with AirTag or their Find My accessory of choice. They can easily and securely share that with us in the United app, and our team can use the location information to find the bag and get it reunited with its owner much more quickly.”

United offers all customers the ability to track their bags directly in the United app, giving them peace of mind throughout the entire travel journey. Now, cus-

tomers will be able to generate a Share Item Location link in the Find My app on their iPhone, iPad, or Mac for an AirTag or Find My network accessory, and share that with United to help locate a misplaced item more quickly and securely.

Here’s how it works:

- ▲ In the event a bag doesn’t arrive to its final destination, customers can file a delayed baggage report in the United app, and those who travel with an AirTag or Find My network accessory can additionally now create a Share Item Location link in the Find My app on their iPhone, iPad, or Mac, and add that to the delayed baggage report in the United app.
- ▲ Once the report has been submitted, authorized United customer service agents will receive the Share Item Location link and be able to view the location of the item on an interactive map. The map will automatically update when a new location is available and show a timestamp of the most recent update.
- ▲ United will use the shared location to more quickly find delayed bags and reunite them with customers.
- ▲ For customers’ privacy and security, the shared location will be disabled as soon as a customer is reunited with their bag, can be stopped by the customer at any time, and will automatically expire after seven days.

Share Item Location is built on the Find My network, a crowdsourced network of over one billion Apple devices — including the 120,000 iPhone, iPad, and Mac deployed by United — that use Bluetooth wireless technology to detect missing devices or items nearby, and report their approximate location back to the owner. The entire process is end-to-end encrypted and anonymous, so no one else, not even Apple or Find My Network accessory manufacturers, can view an item’s location or information.

To experience the new feature, customers should verify that their iPhone is running on iOS 18.2 or later* and that their United app is up to date. For customers without the United mobile app, they will receive an automatic text notification with information to track misplaced luggage and add a Share Item Location link for their AirTag or Find My network accessory.

For years, United has led the industry on adding game-changing innovations and policies across the airline to help customers self-serve and increase transparency, including:

- ▲ *Live flight updates for iPhone and Apple Watch:* United was the first U.S. airline to support Live Activities for iPhone, allowing customers to get live, personalized flight notifications for details such as countdown to boarding, gate number,

seat, bag tracking and more right on their iPhone Lock Screen or Dynamic Island – all without opening the United app. Similarly, with Live Activities on Apple Watch, customers can access important flight information right from their wrist. The live updates have helped millions of travelers since last year especially during peak travel times.

- ▲ *Bag drop shortcut:* United travelers can skip the check-in line and drop off bags in under a minute at the designated bag drop shortcut location at the curb or in the lobby by checking bags in the app before arriving at the airport. New this year, travelers who opt-in to TSA Pre-Check® Touchless ID can drop off their bags in seconds by leveraging facial scanning technology at Newark International Airport.
- ▲ *Real-time weather delay updates:* Earlier this year, United started texting real-time radar maps to help customers understand how inclement weather in one part of the country can impact a flight elsewhere. United is the first and only U.S. airline currently providing its customers these kinds of specific messages, and the airline is sending them with assistance from gen AI tools.
- ▲ *Automatic rebooking assistance during flight disruptions directly in the app:* When travel doesn't go as planned, customers will get alternate travel options automatically served to them in the app. Saving travelers about 15 minutes in line on average, the tools help them get back on their way more quickly after a flight disruption or cancellation. Plus, only United offers Agent on Demand – allowing customers to scan a QR code or use the United app to video chat, text or call a customer service representative instead of waiting in line at the airport.

Buffalo Chicken Dip:

½ cup ranch dressing

8 ounces cream cheese, shredded

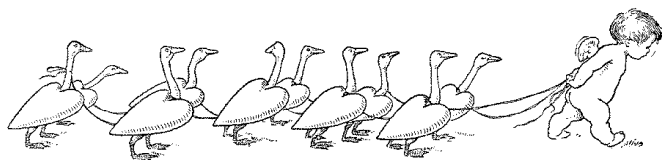
1 and ½ cups cheddar cheese

Green onion, chopped for garnish (optional)

Boil chicken breast until done. Remove from water and allow to cool. Shred using a knife and fork or tear with your hands. While the chicken is cooling, mix together cream cheese, hot sauce and ranch. Fold in shredded chicken and 1 cup cheddar cheese. Spread evenly in an oven safe dish or pie pan. Top with ½ cup cheddar cheese. Bake at 400 for 15-20 minutes until cheese is bubbly and browned. Serve with Frito or Tostito scoops and/or carrot and celery sticks.

*You can also use rotisserie chicken, discarding the skin and shredding the meat.

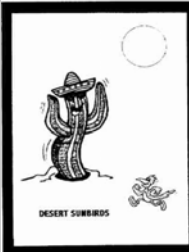

However, please send me coupons at least every other month so the troops have a longer time to use them. Please help me spread the word about this worthwhile project. The number of coupons in the newspapers has dropped dramatically so the only way we can maintain our level of support is if more people send me coupons. Ask your friends and neighbors, and the people at your RUAEA meetings, to send me coupons as well.

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022. On January 7, I turned in 508 coupons. The birthdays for February are **Louie Semon** (2nd), **Paul Zadrozny** (15th), and **Calvin Iida** (28th).

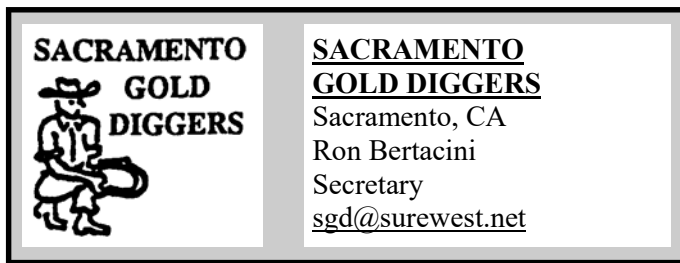

Jim's comments about the airline industry piqued my interest to dig a little deeper with some of the following. Going back to 1961 when Capital Airlines merged into United Air Lines.

Allegheny Airlines ~ 1972 Mohawk Airlines was acquired by Allegheny Airlines which became US Air in 1979 then US Airways in 1997. PSA (Pacific Southwest Airlines) merged with US Air in 1988. Piedmont Airlines merged into US Air in 1989 America West Airlines merged into US Airways in 2007 and US Airways merged into American Airlines in 2013. Ironically, America West management took control of US Airways and then US Airways management took control of American Airlines.

Continental Airlines ~ Texas International Airlines merged into Continental Airlines in 1981, as did Peoples Express in 1987 and Frontier Airlines in 1987 and New York Air in 1987 then Continental would merge with United Airlines in 2010. This was to be a merger of equals but Continental's management took control of United Airlines.

Delta Airlines ~ Northeast Airlines merged into Delta in 1972 then Western Airlines would merge into Delta in 1987 and lastly Northwest Airlines would merge with Delta in 2010. Delta would also pick up much of the assets of Pan American in 1991 including the Atlantic routes.

Eastern Airlines would go out of business in 1991 and Continental would pick up many of its assets and many of its employees. Another irony was that the Eastern pilots were on strike when the company ceased operations and there was a 'classic' photo of an Eastern pilot carrying a sign "We Won!"

Lake Central Airlines would cease operations in 1968.


Pacific Airlines, Bonanza Airlines and **West Coast Airlines** merged into Air West Airlines in 1968 and later became Hughes Airwest Airlines in 1970 and then became Republic in 1980 and finally merged into Northwest Airlines in 1986. North Central Airlines bought Southern Airways in 1979 and would become part of Republic Airlines.

TWA (Trans World Airlines) began as Transcontinental and Western Air would merge into American Airlines in 2001 due to financial problems.

Midway Airlines ceased operation in 1991.

Pan American Airways acquired National Airlines in 1980 in an effort to have domestic feed for its international routes. Financial difficulties gave to the company selling its Pacific Division to United Airlines in 1985. In 1989, the company tried to take over or merge with Northwest Airlines but failed. In 1991, it ceased operations with Delta acquiring much of its assets and the Atlantic Division, American and United took over much of its Latin America Division.

Braniff Airlines took over Mid-Continent Airlines in 1952. With deregulation, Braniff tried to expand rapidly and it ended up costing them. Howard Putnam was the CEO when things started to go bad. Howard had started as a sales rep for Capital Airlines and moved on to United Airlines with the 1961 merger. Howard moved on to be Group Vice President of Marketing with United. In 1978, he became President and CEO of Southwest Airlines. In 1981, he became the CEO of Braniff. Story has it that Howard was led to believe that Braniff was not having financial problems when he was offered the CEO position. In 1982, the company ran out of cash and ceased operations.



All of us wish everyone a Blessed and Healthy New Year!

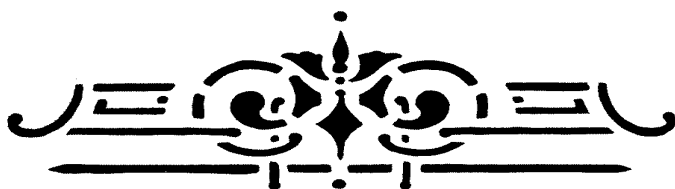
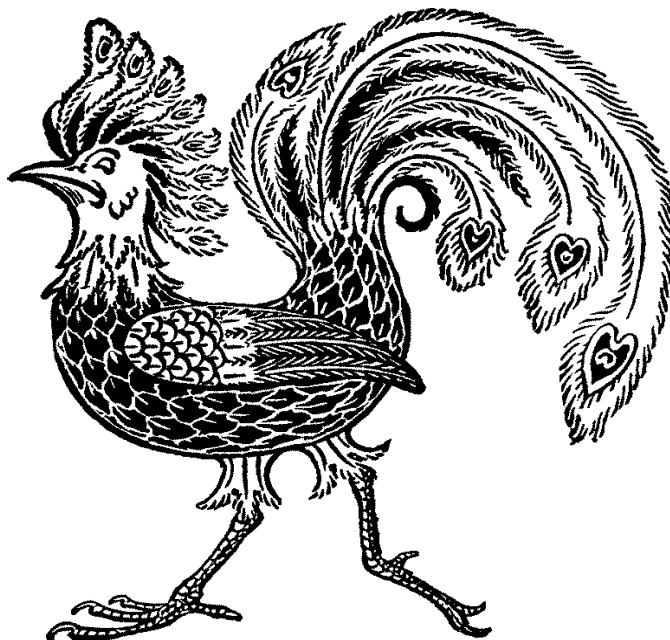

check-ins without showing ID or boarding pass. To use this, United passengers must enroll in the UAL's app using their passport and Known Traveler Number. Users opt-in to facial recognition ID verification when booking flights from supported airports. TSA PreCheck members flying on UAL can then verify their identity at security checkpoints and baggage drops simply by scanning their faces instead of showing boarding passes or physical ID's. How far we've come! One more United story, it started in August, UAL's basic economy customers can use online check-in, but they need to provide a credit card to pre-authorize \$65 that the airline can charge if you bring a carry-on to the gate. That's \$40 checked bag fee and \$25 extra gate handling fee. I'd rather go with the 20% ticket, can carry on for \$00.

There are some new laws in Illinois that could affect your life. Check on ABCNews.go.com. There are 300 of them, check them out.

Due to inclement weather, we do not meet during the winter months so there is no report this month from the Garden Staters chapter of RUAEA. Following is another excerpt of Marty Etler's trip down memory lane:

One day when I came into work, my chief said we have a DC-6 down in Bradley Field, Connecticut. He told me and my partner to get some parts, take the pickup truck and head up there right away to fix it.

It took us a couple hours but we finally got there and found the plane. We checked the logbook to see what the complaint was, we put a brand-new set of spark plugs in and change the distributor, we ran it, and it ran like a top.

We called both Newark and San Francisco line maintenance to let them know that the plane was back in service. Just as we were packing up and about to leave, a Navy A4-D plane comes alongside of us. It was a single engine piston plane, but it is a big engine. Frankly, I don't know what they use it for. Anyway the pilot gets out, sees us, and asks us for some help.

Of course, we asked what happened, and he said I lost all my hydraulic fluid and now I'm on emergency air for my brakes. Normally, we don't do any maintenance without being authorized, however, after we agreed, he did show us how the cowl came off on the side of the engine. When we opened it the whole inside was covered with hydraulic fluid. Sure enough, I saw what the trouble was, it was a broken rubber hose from

his hydraulic pump, and easy fix. However, we still have to clean out that whole accessory compartment.

We went up to the base supply and we found a kerosene pump and a rubber hose, and we fixed everything up for him. However, I told him, that he has to get refilled with hydraulic fluid. One thing that they taught me in aviation school, the Navy uses a blue fluid, and everybody else uses red, and under no conditions do you ever mix them up. You will destroy the system. Therefore, I told him to call Pawtuxit Road Island, his base, and tell them to bring the proper fluid.

I told him to get his guys to fill the system, and then run the engine and exercise all the controls, and he would be good to go. He thanked me and my partner very much. He then asked if there is anything he should sign for charges. I said are you Navy or Marines, he said Marines, I said in that case, all our labor was on the house. We wished him well and left, when I got back I told my chief the whole story and he said, "you did good Ollie".
