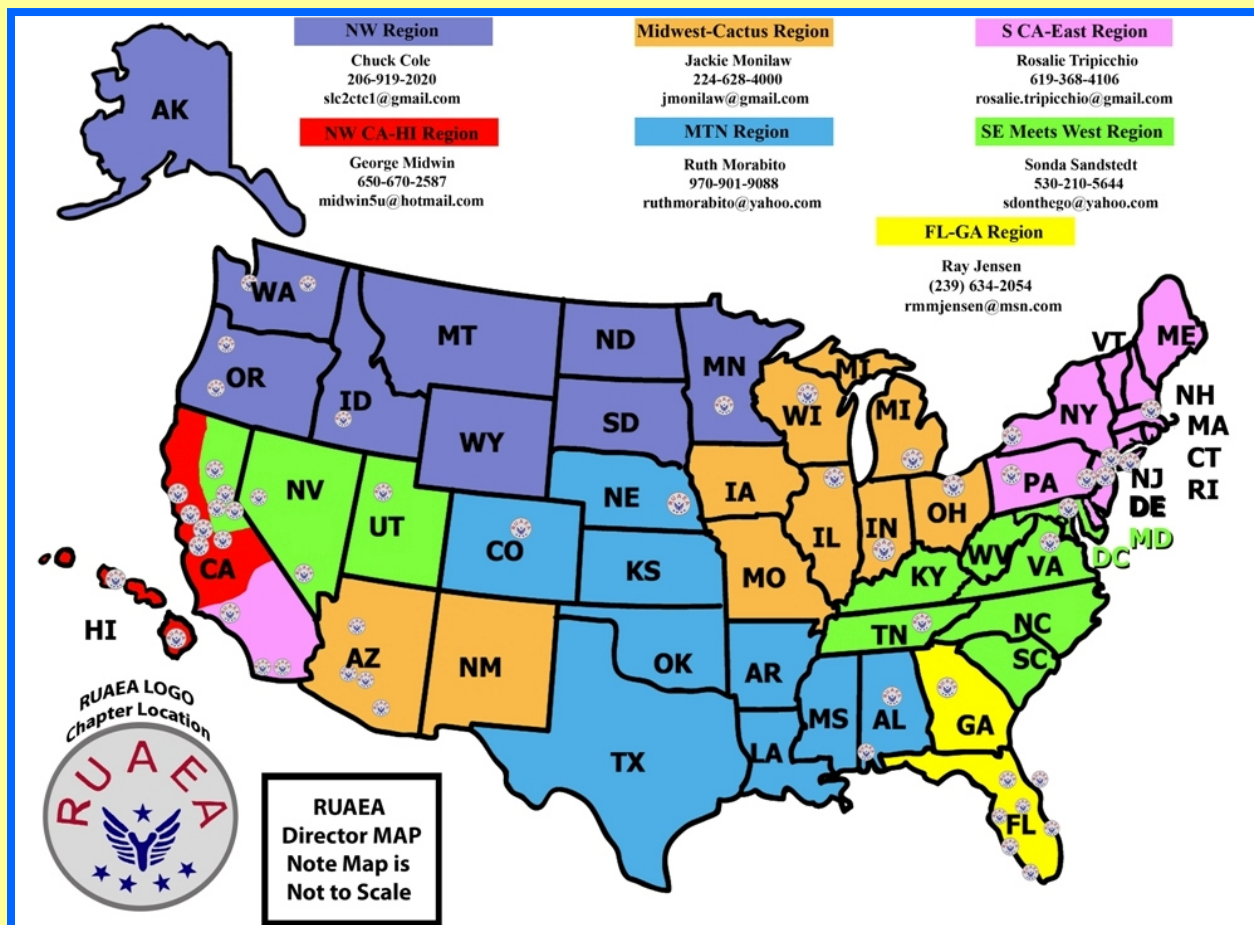

## Change fee waiver extended to July 31 June 30, 2020

### What you need to know about COVID-19

As we continue to provide added flexibility to our customers, we are extending our current change fee waivers to Friday, July 31 (previously June 30), for new itineraries as well as existing itineraries with travel through December 31.

Here are the details of our two change fee waivers:

#### **Tickets purchased on/before March 2:**

- ★ Change fees are waived for travel between June 1 and Dec. 31, 2020
- ★ You must change or cancel by July 31 using waiver code 7JC51

#### **Tickets purchased on/after March 3:**

- ★ There are no change fees for new tickets purchased by July 31
- ★ No waiver code is needed as change fees are waived according to the fare rule

We will continue to waive redeposit fees on award tickets with travel departing on or before July 31.

## What to know about restrictions on travel to the EU July 1, 2020



The Council of the European Union (composed of representatives of the EU Member States) has adopted a recommendation on the gradual lifting of the temporary restrictions on non-essential travel into the EU from July 1. Specifically, the Council recommends the lifting of travel restrictions for non-EU countries listed in the Council's press release, with this list being reviewed and, as the case may be, updated every two weeks. The Council also noted that individual European Member States may decide to take a progressive approach to lifting restrictions on travel from the listed countries.

As of now, persons traveling from the United States are not allowed to enter the EU unless they qualify for an exemption under the rules of their destination Member State.

For countries where travel restrictions continue to apply, the following categories of people should be exempted from the restrictions, although travelers must consult the rules of each individual Member State for a definitive list of exemptions:

- ★ EU citizens and their family members
- ★ long-term EU residents and their family members
- ★ travelers with an essential function or need, as listed in the [Recommendation](#)

## Proposed financing to be secured by MileagePlus June 15, 2020



Recently, we announced that we have obtained committed financing of \$5 billion to be secured by our MileagePlus loyalty program. With the MileagePlus financing, as well as \$4.5 billion expected to be available to United through the Coronavirus Aid,

Relief, and Economic Security Act (the “CARES Act”) Loan Program, and other financing, we expect total available liquidity of close to \$17 billion at the end of the third quarter of 2020. While the majority of this liquidity is in the form of loans that must be repaid, better liquidity gives us more flexibility to manage through the impact of COVID-19 on our business and to be ready to bounce back quickly when travel demand returns.

**What makes this deal unique?**

This proposed transaction allows for the use of MileagePlus as collateral to finance a loan, and also allows us to continue to operate, evolve, and grow the MileagePlus program. This transaction is only possible because of the strength and value of our loyalty program. MileagePlus has more than 100 million members, over 100 program partners and drives “customer lifetime value,” meaning MileagePlus members are more likely to choose United over and over again.

**If we have all this money, why are we still talking about furloughs?**

Without a continued emphasis on aggressive cost management, this new liquidity would only last several months. While demand is trending upward from its April low down 95%, we have lost billions of dollars and are still spending far more than we are taking in. We expect an average cash burn of approximately \$40 million per day in the second quarter of 2020 and to reduce our average cash burn to approximately \$30 million per day in the third quarter of 2020.

Liquidity helps assure we can survive this crisis. But remember that the majority of this expected, new liquidity is in the form of loans that must be paid back.

We expect that travel demand will not go back to “normal” until there is a vaccine for COVID-19. So until then, our ability to right-size our organization and cost structure are essential to our long-term success.

That’s why we continue to offer voluntary programs and move forward with our M&A reorganization to align our payroll expenses with overall demand. And we’re talking to our union partners to find creative solutions for our frontline employees, but it’s possible we may need to use furloughs or other measures. This includes the likely scenario where we will issue WARN notices in July that signal furloughs that are effective October 1.

We have spent the last few months aggressively and proactively cutting costs, including canceling or postponing most events and programs, suspending salary increases, implementing an unpaid time off program for M&A employees and more. We’re also making smart decisions (check out the latest Straight from Scott) so that we maintain a schedule that’s closely aligned with actual customer demand, based on travel bookings, cancellations and other data.

The bottom line: Our primary goal is to save cash and set ourselves up for long-term success, which includes preserving as many jobs as we possibly can. We believe innovative financial solutions, smart decisions about our schedule, right-sizing our organization to align with demand and cooperating with our union partners to cut costs is how we can best position our company for long-term success.

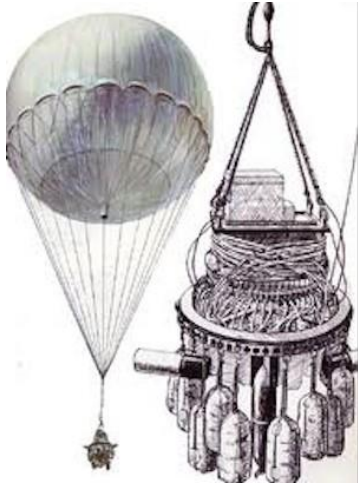
**The Writers’ Column**  
**Japanese Balloon Bombing During WWII**

In a previous article, I discussed the only time the continental United States was bombed during WWII. The bombing resulted in no injury or deaths, or any real damage to speak of. However, that was not the case in another attempt by the Japanese to attack the continental US. Only instead of the use of an aircraft launched from a submarine, this attack made use of balloons.

The Japanese sought to use, balloon launched bombs to attack the US. The idea involved small incendiary bombs to ignite fires along the coast, with the purpose, to incite fear. Although the concept was simple, the process to carry it out, was not. The Japanese Navy conducted numerous tests using radio-equipped balloons launched from ships. They discovered that the balloons would not remain aloft long enough to reach the US. Continued tests consisted of launching balloons to reach varying heights. After a considerable number of months, they discovered what we know today as the ‘jet stream’. It was concluded that this fast moving air at higher altitudes could carry a balloon from Japan to the United States.

Next step was to design a hydrogen balloon capable of reaching high altitudes and carry the required load. Initial designs centered around a rubber type bag, but it proved to be so heavy, that only a very insignificant load could be taken aloft. A much lighter bag or envelope was needed. One which could sustain the rigors of flight, temperature variations, carry the required load and remain aloft for three days, the estimated time to travel the great distance to reach the West coast.

Many fabrics were considered, but their weight proved to be too much for the required purpose. It wasn't until the bark of a kozo tree, was pulverized and made into a mush, pressed out, forming a thin sheet and allowed to dry, that a solution was discovered. The dried product was similar to paper, yet quite strong. It was such a laborious process to produce the paper, a means of mass producing this, needed to be developed quickly. This was resolved by utilizing thousands of high school girls, working in public buildings, to manufacture these sheets. None of the girls had any idea as to what the paper was to be used for. Using a specially developed adhesive, the sheets were layered and then glued together to form the envelope, that would hold the hydrogen. Initially 20,000 balloons were to be manufactured, however just fewer than 10,000 were actually made.



A unique lightweight system was needed to control the balloon. The balloon would be subjected to day and night temperature variations, causing the balloon to gain or lose altitude. A large ring would be attached to the balloon. On this ring were a number of sand bags, small battery, series of tiny explosives and a simple device that would sense altitude variances, as well as small incendiary and personnel bombs. As the balloon would gain altitude, a circuit would close that caused the explosives to release sandbags as necessary, to maintain the preset altitude. This process would be repeated over the estimated three days it would take to reach the West coast. At this point a lanyard would release the hydrogen, causing the balloon to come crashing down, setting off the bombs.

Three launching sites on the coast of Japan were selected. Hydrogen processing plants worked extensively to produce the required volume, while a rail transport line was built to deliver the hydrogen. Each balloon required 30 personnel, one hour to prepare and could only be launched during favorable conditions. Operations began on Nov 3, 1944.

Just two days later, a US Navy patrol picked up some tattered material with Japanese markings. While investigators examined that wreckage, similar material, was discovered two weeks later. Within a month more findings appeared on the US mainland. The military became gravely concerned. While the government continued to evaluate the balloons, a campaign was begun to keep silent, in an effort to prevent panic. As more balloons were discovered by civilians, they were instructed by the military to remain quiet. News media were cooperative in keeping their silence as well. Balloons fell throughout the West from Canada to California and a few as far East as Michigan.

As ironic as it may seem, a balloon bomb landed on a high power lines in the center of the state of Washington. This cut power to the Hanford Facility, where plutonium that would be used for the atomic bomb was being produced. The silence continued.

However, all that all changed on May 5, 1945. In the tiny logging town of Bly, Oregon, near the California boarder, Reverend Archie Mitchell, newly assigned to Bly, his pregnant wife and five children from his Sunday school, went on a picnic. The Georgia Pacific Lumber Company had set aside a small section of the forest, about 9 miles from town, which was a favorite place among locals. When they arrived at the site, the reverend dropped his wife and the children off and went to park the car. One of the children noticed a strange object high in a tree. Several lanyards were hanging down from the object and the children tugged on them. Just then the reverend heard a very loud explosion. As he neared the site, he found his wife and all five children dead. They had come upon a balloon bomb, in a very remote location, on an innocent outing and became the only Americans ever killed on the continental US. Their bodies are buried in simple graves in Klamath Falls, OR.

By this time the military had established a unit with the responsibility to hunt down balloons using aircraft. Additionally they would recover balloons and send them to a central facility to gather more data on their origin. This incident created great concern as news spread, requiring the government to now inform the public about the dangers of the balloons.

Of the estimated 9,500 balloons launched, only 245 have been documented as having been discovered in the US. Most have been thought to have ended up in the ocean, or in extremely remote areas. Balloons have been discovered throughout the years since, the latest being in 2014 in Canada.

The bombing site became the Mitchell Monument and is listed in the National Register of Historic Places. In 1997, one of the girls who had worked on making the paper for the balloons, heard the story of the balloons and the death, one caused. Along with others who had worked making paper over 50 years prior, they folded 1,000 paper cranes, a symbol of peace. They then personally delivered the cranes to the monument site and asking the town for forgiveness. The cranes can still be seen today.

Dear Friends,

The following recipe is one that can be enjoyed with the family or a group of friends when you feel it is safe to be socializing. It is a quick recipe:

Prep time - 6 minutes, Marinate - 8 hours, Cook - 16 minutes.

Hope you are all staying safe.

### Honey Grilled Flank Steak

1 (2 lbs.) Flank Steak

$\frac{3}{4}$  cup vegetable oil

1 small onion, finely chopped

$\frac{1}{4}$  cup soy sauce

$\frac{1}{4}$  cup honey

2 tbsp. cider vinegar

1 $\frac{1}{2}$  tsp. garlic salt

1 $\frac{1}{2}$  tsp. ground ginger

$\frac{1}{2}$  tsp. pepper

\*Score steak diagonally (both directions) across the grain at  $\frac{3}{4}$  inch intervals. Place steak in a heavy duty Ziploc bag or large shallow dish. Set aside.

\*Combine oil and seven remaining ingredients; pour over steak. Seal or cover and marinate in refrigerator 8 hours, turning occasionally.

Remove steak from marinade and bring marinade to a boil in a small saucepan; set aside. Grill steak covered with grill lid over medium-hot coals/heat (350-400) 8-10 minutes on each side or to desired doneness. Baste with the reserved marinade last 5 minutes. To serve, slice steak diagonally across the grain into thick slices.

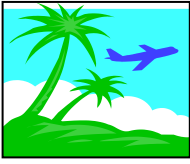

I was reminded by one of the chapter's June issue's item by **Ken Price**, about the operation of the SFOMB when dock overhauls were done in 5 days. It was always a challenge to expedite parts in order to get the plane out on time. One time, when checking out the docks, there was a private plane that I noticed had completed its maintenance. As I checked it out, it happened to be Arnold Palmer's plane. I always enjoyed checking out docks 3 thru 7, just to see what activities were going on. I forget what dock this was in, but in order to get to and from the balcony there was an elevator that you could stand on. All you stood on was a small platform with a hand hold. I can just imagine what the Safety Committees would say about what you would need to wear in order to use it now or even use it again. I never heard of someone ever got hurt. It was a pleasure to work with Dock maintenance and I'm glad I was able to do that.

Trying to think of what to write, during these times, lets me think back to some of the wonderful times with CAP. The company invested in the Viscount and this was the beginning of the end. I happened to be working in communications the day a flight crew flew from DCA to MDW in a Viscount. They could not land at MDW since it was not equipped with the battery starter. This plane had the newest radio transmitter and they came in loud and clear around DTW (Detroit). The Captain wanted me to check with the tower for a "Fly Bye" giving his estimate over MDW. They gave the OK and the Viscount buzzing the field was a beautiful thing to witness. They only did this once and after getting their clearance back to DCA the pilot called in to see if we saw them and of course I told him the entire operation was outside to watch. I think they were flying over 30,000 feet when the pilot called back and had me ask Dispatch at what temperature fuel freezes? When I called Dispatch with the question there was complete silence and then they said they would call back. Within minutes I was told that aircraft fuel will not freeze. I passed it on to the flight and they continued their round trip back to DCA. Since that time I had several opportunities to fly in the Viscount and many times I was invited by the crew to stay in the cabin with them. It helped to know the crews.

I noticed that since this is the June issue it reminded me of another June back in 1987. I looked up my past records and that is when I retired. That makes it 33 years of retirement. If we still had UAL's standby system instead of the present one, it might encourage me to start flying again. Prior to the merger my seniority was able to get my family of five on all the flights first class. It seemed like the flight attendants knew the standbys because one time when I was flying alone I was given a first class seat after all passengers were boarded. I don't think those days will ever return.

On June 15<sup>th</sup>, our little resort town made big news. We had a fire started in the hills not too far from our community and lucky for us the wind was blowing the flames and smoke away from us. It did shut down the



main highway since the flames were jumping over and even burned the leaves of some palm trees in front of one of the hotels. Avila has only two roads that take us to the freeway and during the height of the fire the freeway was shut down. If our area caught fire our only alternative was to head for the ocean. Our residence is 55 years old and older which would be a problem for those with medical problems. Three days later the fire was pretty much contained. It was interesting to see the helicopter fly over our house dragging that water container and heading for the ocean. I counted about five flyovers and he couldn't have been more than 500 feet over us.

My wife and I are in that age group where we have to limit outside contacts as much as possible. #### **Beer Bread:**

2½ cups self-rising flour (Important, because regular flour will not work).  
2 Tablespoon sugar  
1 can beer (any kind)  
2 eggs

Place all ingredients in a bowl and mix, no need to sift. Place in small loaf pan and bake at 375 for 45 minutes. You can also add grated cheese or diced green chiles. Delicious.

To date I have visited 550, from North to South and East to West. Some are quite easy to locate, while others require somewhat of an adventurous route to get to. I enjoy the challenge and planning involved in traveling to various sites. It also has been an interesting learning experience, understanding how California became to be. I have been permitted access to the nuclear submarine base in San Diego, as well as Camp Pendleton. I met an owner of a 6,000 acre estate who allowed me to seek out a landmark, completely alone. One private oil drilling facility provided me an escort to take me 4 miles to see a landmark. I've been on roads I never traveled and others have seldom used as well. Most of my travel has been with my wife, who is not always very pleased as to where some of the landmarks are located, very remote areas with no one around. Other times I visit landmarks on my own, however I don't wander too far off the beaten path.

We live in a very unique state, with a history going back hundreds of years and into modern times. From discovering gold to discovering the micro chip. From those who established missions, to The Beach Boys. These are all landmarks where events took place, people are honored and our state history is revealed. You have seen the signs on the highway, "Historical Landmark ahead." Stop and read the plaque. You never know what you can find out about where you are. Covid has disrupted my many plans for trips to a number of sites, however, shortly I will be on the road again."

**Jan Soderstrom** has a delectable recipe for Scottish Shortbread. This is another simple recipe with only three ingredients. Her friend's mother is from Scotland and this is their family recipe.

**Scottish Shortbread:**

1 pound sweet (unsalted) butter

1 Cup sugar

4 Cup flour (or up to 5 C if dough is too sticky)

Cream butter and sugar with a mixer and blend well. Add flour and mix with a wooden spoon, then use hands to mix thoroughly. Press into a cookie sheet. Cookies will be thicker than other rolled cookies. Prick to the bottom of the dough with a fork, with pricks close together, to form a cutting line after baking.

Bake for 10 min at 350 degrees, then reduce heat to 300 degrees and bake 40 min more. Do not over bake. Wait two minutes, cut into finger-sized bars, and cool thoroughly in pan.

I would also like to share some recommended reading suggestions. I'm a huge fan of the Gabriel Allon spy thriller series by Daniel Silva. His latest book, The Order, comes out July 14. It's #20 in the series, and you really should read them in order, so this will keep you busy for a while.

I just finished Meet Me in Monaco by Hazel Gaynor, a historical fiction novel about Grace Kelly's wedding. I was swept away by the fabulous setting of the Cote d'Azur and the lush fields of lavender and jasmine in Grasse at the center of the perfume industry.

With things opening up the beginning of July, we knew there would be an increase in Covid cases, but I don't think anyone expected such a huge increase in cases over the last couple of weeks. A lot of my friends are saying people are throwing caution to the wind - only wearing masks when it is required and not social distancing. Until further notice, my only outings will be essential errands. I suspect many of you are doing the same. Take care everyone and stay safe!

Ahead of her time, Ellen Church walked into the office at Boeing Air Transport in San Francisco and helped change the face of air travel. Creating a new profession for women, they were called "sky girls" and were paid \$125 a month to fly a minimum of 100 hours.

Their duty, in addition to serving meals, a welcome smile was an essential requirement. A rigid military salute was to be given to the pilot and copilot when they came aboard. Also included were the tasks of weighing passengers and their luggage, making sure the wicker seats were bolted firmly down, swatting flies that got into the cabin and carrying buckets of fuel to the airplane.

Now called Stewardesses, they passed out slippers to passengers on night flights and polished their shoes and swept the floor.



There were very strict requirements for hiring at that time. Applicants had to be under 25 years of age. Maximum height was 5'4 inches tall and weight no more than 115 pounds. They must be single to apply for the job. During the interview an applicant would be asked to lift her skirt so the interviewer could see her legs. Girdles were required and stocking seams must be straight.

The above information is from *The Age of Flight* by William Garvey and David Fisher.

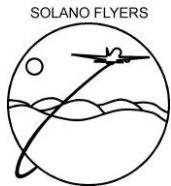

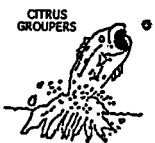

Those were the salad days for Pan Am, and Bob enjoyed traveling all over the globe. Finally, Bob qualified for his first command, as captain of the Lockheed L1011.

By the mid 1980's, Pan Am's fortunes darkened and it was compelled to sell its Pacific routes. Again Bob was lucky to be in a small group that was acquired by United along with the L1011 aircraft.

The transition to UAL was a bit of a challenge for Bob and his family as they had to adjust to new methods and a new domicile, San Francisco. Thank goodness the folks at United were very open and welcoming. The company had recently experienced difficult labor relations, and Bob said he felt like Switzerland amongst warring factions, but fellow airmen made them feel very comfortable. Chosen as a flight manager, Bob flew proving trips to Europe and early familiarization trips to Beijing. 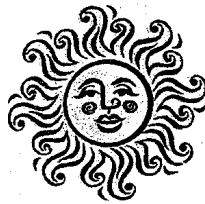

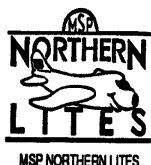

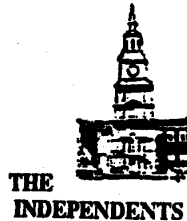

The novel corona virus and COVID-19 yet dominate life styles in the Pacific Northwest. Because of still-increasing cases of the disease in early July, masks are required for all social contact except inside one's home with one's family. The latest attempt to halt the spread requires all businesses to refuse opening their doors to anyone not wearing a mask. Instead of the familiar "no shoes, no shirt, no service," we now are advised that "no mask – no entry." Much of Washington State has moved on to Stage 2 in the reopening process, but rescinding that allowance is a distinct possibility.

We hope all RUAEA members, their friends and families are staying safe and healthy and abiding with whatever restrictions are deemed in the best interests of all.

Unfortunately, the lack of chapter activities and socializing has produced only unpleasant news. **Tom Lucas** shared the news of the passing of **Karl Goering**, who had been in ill health for several years. Karl immigrated to the United States from Germany and eventually joined United as a cook in the Flight Kitchen with his late wife **Jean**, a pantry worker.

**Howard Clark**, a former trainer in Customer Service in Seattle, died June 2. Long-time Emerald City Slickers, Howard and his wife **Ruthann** lived in Mesa, Arizona.

Catching up with old news, we've been informed of the passing last year of **Rosemary Akre**, aged 88. Rosemary had worked in the Flight Kitchen and later in Cabin Service and was well-known to many. Rosemary had been diagnosed with cancer in 1994 and, when discouraged about the possibility of success with traditional treatments, sought care abroad and in her faith, adding 25 years to her life. Rosemary was preceded in death by her husband **Forrest** and is survived by her 3 children.

Last month we profiled the UAL career of **Jim Fauber** in Part I. Here we continue the saga with Part II, which follows Jim's post-retirement career and involvement with RUAEA. Thanks again to **John Haferbecker**, who wrote and published the original story in Contrails, the Seattle chapter's newsletter, which is liberally – and sometimes literally – plagiarized here, with John's permission.

This is a "name-dropping" compilation of United executives, employees and retirees, all connected to **Jim Fauber**. How many names do you recall from your own UAL past and how did those folks impact your UAL experiences?

Following his retirement, Jim developed a second UAL career, focusing his considerable energy on involvement with RUAEA. In 2000 the late **Frank Murdock**, retired station manager in several cities, including Salt Lake City, served as RUAEA president and quickly informed his Executive Vice President **Jim Fauber** to expect delegation of duties, Jim immediately became involved with RUAEA convention-planning.

Jim began researching convention sites for RUAEA's annual convention, being especially interested in security and availability of outside-the-hotel safety. When negotiating with hotel management, Jim made it clear that United Airlines did not fund the convention and that each attendee paid his own way, while trying to keep costs down, so lower-paid employees like cleaners and kitchen workers could afford to include the convention in their vacation plans – they were not all well-paid pilots (remember, this was many years ago). Jim also bargained with tour bus companies to get the lowest rates.

Jim did a lot of traveling during this period, flying to different cities and meeting with various individuals in the course of his research that led to several agreements, fully supported by the RUAEA Board of Directors.

One significant trip was to Boulder, CO where at the Spectrum Data Corporation Jim met with Knut Moe and Susan Persche, who were graduates of the University of Colorado and who specialized in technology. Together with Jim they made a handshake agreement that they would design the RUAEA website for free if RUAEA agreed to contract with them to run the website. He then worked with Chicago retirees **Bob Kalicki** and **Jim Sommerfield** to help maintain the website. Through Jim's aggressive actions the RUAEA website was developed and went on line. When the late **Martin Lade** was elected Executive VP, he was instrumental in the further development of our website.

While Jim served as RUAEA president in 2002-2004, he negotiated the agreement with the Doubletree Inn to host the 2004 Seattle convention. Hearing the terms, RUAEA financial expert in Chicago, **Mort Wax** quickly urged signing. During this time, Jim also got to know CEO Glenn Tilton, brought in to handle United's bankruptcy. Thanks to Jim, Mr. Tilton was prevailed upon to give the banquet speech at the Chicago convention in 2003. A schedule conflict prevented Tilton's attending in 2004, and he sent a vice president in his stead. During the convention, the VP presented Jim and his wife Bonnie with lifetime passes to Red Carpet Rooms.

That evening, Jim invited the late **Bob Ellis** to be seated at the rostrum, where those who knew and worked for him could come forward to greet him. Long-time retired maintenance manager in Seattle, Bob was, at that time, #2 in UAL seniority.

Jim also was a charter member of the Phoenix area RUAEA chapter and early-on traded leadership with the late **Bud Hubbard**. Each Christmas, Jim & Bonnie hosted a chapter Christmas party at the Palo Verde Country Club in Sun Lakes.

Back in 1987, Jim chaired the RUAEA convention at the Hyatt Regency in downtown Phoenix where naysayers claimed the 1000-seat ballroom was too large for the banquet, which ended up with 1300 attendees. Entertainment was provided by Igor and the Jazz Cowboys at Friday night's Friendship Dinner and Captain Al Haynes spoke at the Saturday night banquet.

Jim continued a healthy relationship between RUAEA and the United Historical Foundation in Denver, initially serving on the board, being succeeded by **Tom Goodyear**. During the bankruptcy from 2002-2006, Jim was involved in seeking and disseminating information of interest to UAL retirees and keeping us informed of benefits. He worked closely with **Mort Wax**, who regularly updated Jim on developments.

For someone who was supposed to be retired, Jim seemed to be busier than ever, devoting much of his time to serving our RUAEA membership. We owe a great deal to **Jim Fauber**.

One of the most unusual aircraft to fly United's colors was a converted military cargo/troop carrier design, the Fairchild C-82 Packet.

On October 1, 1947 a specially equipped Packet inaugurated in-flight mail sorting over the original coast-to-coast air mail route from New York to San Francisco. Touching down at 23 cities along the way, it carried three postal clerks who sorted a couple tons of mail and imprinted each with a special cachet commemorating the maiden flight.
