

### The Writers' Column By Jeffrey Leavitt (Former UALer) Geezer Seeks Connection and Friendship



The date was on or about June 16, 1966 and it was a hot, muggy day at 6 am on the way to the Minneapolis-St. Paul International Airport.

Anyone who has ever lived in Minnesota knows how uncomfortable the summer weather can be, even in the early morning. But I didn't care about that because I was on my way to the greatest adventure of my life. Having briefly visited family in my hometown of St. Paul following my graduation from college, I was on my way to New York to begin my first real job, a pivotal moment in my 23 year old life. United Air Lines had made me a job offer I could not refuse, and they had even thrown in a business pass for the trip east. Pretty heady stuff at the time! The first flight to Chicago left at 7 am and

I didn't want to be late.

17 hours later, I was still at MSP. I had watched 13 full flights depart (727's and Caravelles) without me onboard and it had been a rough day. At 11 pm I bought a full fare ticket on Northwest Airlines to JFK and life went on. I think I learned two things that day. Traveling on an airline pass could be tricky at times and, boy, was business ever good for United Air Lines in the Twin Cities!

About 21 years later (and with a whole bunch of successful flights under my belt), I faced another pivotal moment. Storybook endings happen in storybooks but not always in real life. I had a ton of personal problems and to address them I had to make changes, which included resignation from UAL and a totally different focus.

Now, 31 years later, life has flown by (no pun intended) and I am just trying to sort it all out. Wrote my autobiography, not that I am any great personage, but that I fear the written word in depth is dying out in this

technological era and pretty soon we won't be talking to each other or sharing our common history at all. I like our generation, well most of it anyway. I think we did a lot of things right and where we made mistakes, we worked hard to correct them. Some of the very finest people I have ever known were fellow UAL employees and I do not wish to close the book on my own life without reaching out in sharing and friendship to any of you who might be interested in reading about the world according to Jeff. #### **UAL received tentative approval to increase IAH-HAV service**



The U.S. Department of Transportation (DOT) tentatively awarded United and Mesa Airlines authority to begin offering daily nonstop service between IAH and HAV (Havana). Subject to final government approval, United will expand from our current Saturday-only service to daily service.

United's increased service will help ensure better choice, convenience and competition for customers in Houston and 44 other destinations in the central and western United States.

UAL plans to operate the route with either Boeing 737-800 mainline aircraft or Embraer E175 regional aircraft. Mesa Airlines will operate the regional jet aircraft as United Express.

From IAH, United's gateway to Latin America, the company provides the only service to Havana from the entire central and western United States.

"On behalf of United Airlines, we applaud the U.S. Department of Transportation's decision to increase United service between Houston and Havana from Saturday-only to daily," said Regulatory and Policy VP Steve Morrissey. "We also want to congratulate Texas Governor Greg Abbott and Houston Mayor Sylvester Turner, as well as Texas Congressmen Kevin Brady, Gene Green, Pete Olson, Ted Poe, the Houston Airport System, the Greater Houston Partnership and the Houston Hispanic Chamber of Commerce for supporting our collective goal to improve air service between Houston and Havana and offering customers throughout the central and western United States more opportunities to make convenient connections in Houston."

#### More service to New Zealand



Waiheke Island ~ In conjunction with United's Star Alliance partner Air New Zealand (NZ), United announced new nonstop service between AKL (Auckland, New Zealand) and ORD. The announcement deepens United's two-year-old joint venture with NZ.

Starting November 30, 2018, NZ will operate the route three times weekly, year-round, using its new-configuration Boeing 787-9 aircraft.

In addition to the new route, United will also extend its current seasonal service between SFO and AKL to year-round beginning April 2019. The

company will operate that route three times weekly with a Boeing 777-200ER between April and October and continue operating daily with a Boeing 777-300ER between November and March.

"By adding Chicago to the Air New Zealand route network, and with United's increased service between San Francisco and Auckland, we are proud to offer our customers more ways to get between the United States and New Zealand and more connection opportunities in those cities than any other airline in the world," said International Network VP Patrick Quayle. "Today's announcements are great examples of the customer benefits that result from the strong, strategic alliance and partnership between United Airlines and Air New Zealand."

Since announcing the partnership in 2016, the joint venture has offered travelers more choice and convenience across United's combined networks.

United's Flying Together website is getting a make-over and it's coming <u>soon</u>! "Everyone can experience and become familiar with the new site during a soft launch before it becomes permanent in a few weeks. Built based on extensive feedback from team members across United, the new intranet includes fresh features, functionality and navigation. Click the yellow links to see a preview of the new FT or switch to the new site now. Tips:

- 1. You will be able to import all your existing tools and favorite shortcuts into the new Flying Together.
- 2. All information about Pass Travel will be in the Travel section of the new Flying Together, but some information may reside in new locations or menus. Click around to find out!
- 3. When you find a page you need often, use "Add to favorites" at the bottom of the page and you will be able to quickly access it with one click on your "Favorites" link.

#### Change EFs in June for July-December travel



Plan ahead! Keep in mind only retirees will be able to change their Enrolled Friends during the mid-year open enrollment period beginning in June for travel July 1 through December 31, 2018.

The enrollment will take place just like it normally does via FlyingTogether > Travel > "Update pass riders and buddies". If you do not want to change your current EFs for July-December no action is needed. Your current EFs will automatically roll over on July 1. More information will become available on Flying Together in May.

#### Transit tax refund request: LHR/NRT

Thanks to Gina Sui-Oerelius for a heads-up on the new procedure.

New Procedure: To request a refund for the transit tax from London Heathrow (LHR) or Narita (NRT) you must submit an offering via United Service Anywhere. Do not email <a href="mailto:EPC@united.com">EPC@united.com</a> or <a href="mailto:ETC@united.com">ETC@united.com</a>.

Be sure to have the following prior to submitting your request:

- London Heathrow (LHR): If you connected from another airline and departed on a United flight in less than 24 hours, submit the other airline's boarding pass and United ticket number.
- Narita (NRT): If you connected from another airline and departed NRT on a United flight in the same calendar day, submit the other airline's boarding pass and United ticket number.

#### <u>Torgy's Travel Tips – Using "Custom Routing" to list on UA Flights</u>



Sometimes you are aware of UA flights that exist, but when you try to list on them, they just don't appear. Or, you may want to intentionally have an extra long layover at a connection point, but again, the combination of flights don't appear. Well, this month's article will help you solve that dilemma by using a wonderful little gem called "Custom Routing", which can be located inside *QuickLinks* on the listing menu in EmpRes.

Let's say you want to fly to Sydney via San Francisco. You are allowed a layover of less than 72 hours when connecting to/from an international flight. So why not take advantage of a nice day at Fisherman's Wharf instead of just waiting it out at the airport, either by arriving in SFO early on the day of departure or staying overnight the previous night. After all, there's BART, the rapid transit line, right at the airport that whisks you to downtown SFO and back. And you'll have plenty of time to rest

on the 16 hour nighttime flight to Sydney, hopefully in a Polaris flatbed seat! So, how do you do this?

- 1. Go to EmpRes and click on the blue QuickLinks
- 2. Next, click Custom Routing
- 3. Fill in the city-pairs and date of each flight you want, then enter
- 4. All flights for the first city-pair will show
- 5. Click View to show all the flights for the next city-pair (You can toggle back and forth between the flights until you decide on the best choices)
- 6. Click Select on the flight you want for each segment to begin the listing process
- 7. Follow the prompts to add the traveler names, class of svc and type of pass you want to use.

Another advantage of using Custom Routing is the ability to list pass riders who originate in different cities, but are traveling <u>together</u> from the connecting point. In the example above, let's say you originate in Phoenix but your enrolled friend will originate in Denver. You will meet in SFO and fly together to Sydney. By using Custom Routing, you will only use 1 pass which covers <u>both</u> of you on all the flights. Here's how:

- 1. Type in the 3 city-pairs and dates you want to see: PHX-SFO, DEN-SFO and SFO-SYD
- 2. Select the desired flights from the response
- 3. A screen appears with eligible traveler's names and a blue click "HERE" to customize prompt
- 4. Click on Person 1, then click the flights for that person, along with class and pass type
- 5. Click on Person 2, then click the flights for that person, along with class and pass type, then hit enter. You will see 2 itineraries, tailor-made for the trip.
- 6. Click on Book Itin at the bottom of the page and proceed as normal.

The result will be 2 PNRs with separate record locators, but they will be "linked" behind the scenes to connect your pass usage. If your travel partner is an enrolled friend, their boarding priority on the unaccompanied flight will be lower, but it will rise up to yours once you meet and travel together on the long-haul flight.

Custom Routing is a great way to be creative with your flight listings. Do be mindful that minimum connection times still apply to non-rev travelers, so don't book a connection too close!

Later this year, EmpRes will be changing to make the listing process even more user-friendly. No specifics

have been announced yet, but once the new changes arrive, I will update everyone on any differences or new procedures. In the meantime, get out there and have some fun!

This year's Spring Luncheon was a smashing success! It was held on March 20 at Ristorante Don Giovanni with 69 people attending. Despite concerns about parking logistics and weather, all went very well and some even took a stroll down the main street of Mountain View to check out some of the stores and other restaurants afterward. Our next large event gathering will be our Summer Picnic on June 12 at Vasona Park.

At one of our weekly breakfast meetings in March, we had representatives from the local Stroke Awareness Foundation present information about the different types of strokes that occur (ischemic and hemorrhagic), what signs to look for when having one (one side of face droopy (**F**), one arm weak (**A**), slurred speech (**S**)), and what to do (time (**T**)). The most important action to take when seeing a stroke is calling **9-1-1**. The sooner it is addressed and treated at a hospital, the greater likelihood of a successful recovery. One of the representatives actually experienced a stroke a few years ago. He talked through what was going on in his life at the time and what he believes led to the stroke (extreme stress). Thankfully he was with someone at the time who recognized what was happening and called for help. High blood pressure and diabetes are significant contributors toward having a stroke and many are not even aware of whether they have these. So it is very important to have an annual physical as well as eating a balanced diet and exercising regularly to reduce the possibility of having a stroke. There is now an app to download onto your mobile device that will 1) Identify stroke signs and symptoms, 2) Locate certified stroke centers, 3) Accelerate 911 calls, 4) Notify emergency contacts, and 5) Send your GPS location. Search for "Stroke Awareness" in your app store for this helpful information. Contact the National Stroke Association at www.stroke.org for additional information or if you have any questions.

On a lighter note, one of our members who will remain anonymous related the following story of an incident that happened at work while on the overhaul docks one day.

Safety was always emphasized at United and this was especially true when welding with aircraft in a hanger. One day, welding was needed at a particular dock and a person was selected to operate the combustible gas detector while the welding was in process. The detector had a tube with a rubber bulb at the end that needed to be squeezed every few seconds to pull air in from the area to check if any combustible gasses were present. This wasn't the most exciting job to experience; it could be somewhat boring.

The welding was proceeding normally and there was no indication of any combustible gasses. The mechanic felt some flatulence coming and being a curious individual he decided to make sure the equipment was working properly. As the urge increased he could not resist the temptation. He let loose with something to be proud of and placed the tube behind his backside and squeezed the bulb. The reaction was immediate on the dial of the detector with the needle going all the way to the red. This was truly a combustible atmosphere.

Now this presented a problem. The detector was showing a combustible atmosphere when there really wasn't one and the detector was no longer checking the environment. The mechanic looked around to make sure no one was aware of what had just happened and began pumping the bulb to clear the detector. He then continued his job as he was supposed to do.
