

New rule on service and emotional support animals December 3, 2020



The U.S. Department of Transportation announced new rules, which permit carriers to treat emotional support animals (ESAN) as pets unless they are dogs specifically trained to as-

sist with a disability. The rule will be effective 30 days after it is published in the Federal Register, which will likely occur later this week. Our policies regarding service animals and emotional support animals have not changed at this time. However, we are reviewing the ruling and evaluating its impact to our future policies.

As a reference, the ruling defines that:

- * A service animal is as a dog, regardless of breed or type, that is individually trained to do work or perform tasks for the benefit of a qualified individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability.
- * Airlines are not required to recognize emotional support animals as service animals and may treat them as pets.
- * Psychiatric service animals are treated the same as other service animals that are individually trained to do work or perform a task for the benefit of a qualified individual with a disability.

Shop safe, shop local December 3, 2020



We are deep in the holiday season and many of us have begun to shop for gifts for family, friends and colleagues. This year, COVID-19 has forced many small businesses to shut down.

while others are struggling to stay afloat.

The Market and Community Innovation team has spearheaded an initiative to support "shop local" efforts across the communities where we fly. To do exactly that, we recently partnered with two great causes to help boost business for the small business owners in two of our hubs, Chicago and Denver.

Shop In Place Chicago is a website designed to help you find Chicago's hometown entrepreneurs. The site includes mapping technology that allows Chicagoans to sort through and patronize small businesses, whether the shops are in a nearby neighborhood or across town.

"Shop in Place Chicago was just featured in a <u>Chicago Tribune Black Friday article</u>," said Senior Manager for Market and Community Innovation Tina Koenig. "I'm thrilled that our employees were able to add all of these small businesses to the site before the busiest shopping period of the year."

Additionally, in Denver, we partnered with the Denver Broncos to support the team's 'Broncos Business Boost' program, which encourages fans and the Colorado community to support local businesses. Broncos

First COVID-19 vaccine shipment lands at ORD November 27, 2020



The Wall Street Journal reported that United operated a dedicated charter carrying the first shipment of COVID-19 vaccines. While we cannot comment on our specific customer's

shipments, United began preparing to support initiatives like this earlier this year by establishing COVID Readiness Task Force to help ensure we had the people, products, services and partnerships in place to support vaccine distribution.

When shipping pharmaceuticals, including vaccines, time and careful handling are key. Well-developed operational procedures and oversight, as well as properly temperature-controlled shipping containers, are critical as the U.S. prepares for vaccine distribution. The team worked closely with the FAA, aircraft manufacturers, the International Air Transport Association (IATA) and several other organizations as we continue to move cargo safely and in compliance with both domestic and international requirements and regulations. This includes a recent certification from the FAA allowing us to carry higher volumes of dry ice which help to keep the vaccines chilled and viable during transportation.

Our deepest gratitude goes out to our Cargo, Tech Ops and Airport Operations, Flight Ops and Network Operations teams whose roles have been instrumental throughout the pandemic. While the vaccine is still pending FDA approval, we stand ready to do our part in the national distribution to ultimately put this crisis in the rear-view.



Happy New Year to everyone in RUAEA Land from the San Francisco East Bay. I hope that 2021 brings an end to the pandemic and that things return to normal, albeit it a New Normal, that will be with us for many years.

Ken Price, our resident storyteller, has another memory to share with us: I sure am enjoying his stories! Having worked in reservations my entire 16 years with United, I have no idea of what all went on at the San Francisco Maintenance Base. His stories are a real learning experience for me. "With the introduction of wide body aircraft, it required larger engines to provide the necessary thrust. Pratt & Whitney, General Electric and Rolls Royce were up to the task. United had the Pratt & Whitney JT-9 for the 747 and General Electric CF-6 for the DC-10. However, these engines were larger than most commercial aircraft air freighters. The military had large C5A's / C-130's to move an engine but there was limited commercial capacity.

United was flying the 747 to Honolulu so how do you get a spare engine to Honolulu or across the country? If time is not a problem it can go by ship or truck. If it is an Aircraft On Ground (AOG) situation then maybe an entire C-130 would have to be leased to expedite the shipment. Boeing came up with a solution, called a "Fifth Pod" whereby a spare (Non Operating) engine was attached to the aircraft on the left side between the fuselage and the #2 engine. The wing had to have special attach points with special fittings to accept the engine. Not all aircraft had this provision and a kit was necessary to bundle the engine against air flow. This provided engine movement on a scheduled flight at much less cost. I don't recall how long it was before 747 / DC-10 freighters were available which could handle the larger engine shipments. I suspect similar situations are also possible with today's huge engines."

And adding to this story of the difficulty of moving large aircraft engines in the early days of the 747 / DC-10 aircraft: "When Continental Airlines purchased the DC-10 aircraft they entered into a maintenance agreement with United for the repair / overhaul of their CF-6 Engines. As was bound to happen, they had an engine failure in Honolulu and needed to ship the off engine to United at SFOMB. The engine was put on a flatbed truck trailer, taken to the ship dock in Honolulu, and shipped off to Los Angeles to be off loaded and trucked to SFOMB. As the Honolulu truck company wanted their trailer back, upon arrival in Los Angeles the engine was removed and placed on a local trailer. A trucker was contacted to pick up the engine and take it to San Francisco.

As you drive along highways and pass under overpasses you may recall there are small signs which tell you the height of the overpass: 14 feet/10 inches and so forth. The truck with the Continental engine enters the freeway headed north when all of a sudden there is a **boom**, **jolt** and terrible noise. The engine had hit an overpass, resulting in damage to the overpass and almost scrap for the engine.

How did this happen? When the engine was removed from the Honolulu trailer and placed on the local trailer, the local trailer was higher than the original. The trucker took for granted the height was the same and **boom**. Big Bucks!"

<u>Book Corner.</u> Here are some more recommended books.

1. I have just started reading These is my Words: The Diary of Sarah Agnes Prine 1881-1901, by Nancy E. Turner. I am enjoying it very much and can now recommend it firsthand. I'm pushing to get it read by the time my book club meets on December 18. Our country's early settlers faced so many hardships. I am humbled by their strength and determination.

- 2. Another book that will resonate with all of us is The Day the World Came to Town by Jim De-Fede. It's the true story of what transpired following the September 11 attacks when 38 planes were ordered to land unexpectedly in Gander, Newfoundland and Labrador, Canada. The musical "Come From Away" is based on this book. I read it over a year ago and even now there is a waiting list for it at my local library.
- 3. For rose lovers, I heartily recommend For Love of a Rose: The Story of the Creation of the Peace Rose by Antonia Ridge. The book is a bit hard to find, but it you're patient, it often is available on EBay and in some libraries.

This 2005 article, entitled "Peace - The Rose of Our Time," was written by Ludwig Taschner, the owner of Ludwig's Rose Farm in Pretoria, South Africa: "The story of the 'Peace' rose is one that can be told over and over again because it encapsulates everything that we hold dear in roses – drama, love and greatness of spirit. This year marks the sixtieth anniversary of the naming of this enduring rose that remains an excellent garden rose, and a symbol of our desire for that ever-elusive peace. The creation of 'Peace' was beautifully chronicled in Antonia Ridge's book 'For Love of a Rose' and it was something of a miracle that the rose ever saw the light of day.

In 1935, the French rose breeder, Francis Meilland, the third generation in a family of rose growers near Lyon, selected 50 'promising' seedlings from his seedbeds. One was tagged 3 - 35 - 40 and over the next four years Francis and his father, Papa Meilland, watched its development with interest. In spite of war clouds gathering, the unnamed rose was introduced to friends and professional rose growers who gave it an enthusiastic 'thumbs up'. But three months later Hitler invaded France and, with the nursery under threat of destruction, three parcels of budwood were hastily sent out of France, one of which was smuggled out in the diplomatic bag to America.

For the duration of the war the Meilland family had no idea whether any of the budwood had survived. In America their agent planted the rose in his own trial beds and gave it to other rose growers for testing in all the climatic zones throughout the United States. The rose did so well that it was decided to release it in the United States and thousands of plants were propagated. Although the war was still raging in Europe, the launch date was set for 29 April 1945, in Pasadena, California.

On the same day that two doves were released into the American sky to symbolize the naming of the rose, Berlin fell and a truce was declared. It was sheer coincidence. In naming the rose, this simple statement was read: 'We are persuaded that this greatest new rose of our time should be named for the world's greatest desire: **Peace**.'

'Peace' went on to receive the All American Award for roses on the day that the war in Japan came to an end. On May 8, 1945, when Germany signed its surrender, the 49 delegates who met to form the United Nations were each presented with a bloom of 'Peace' and a message of peace from the Secretary of the American Rose Society."

Here are two more feel good stories about our precious wildlife.

Rocky the stowaway Saw-Whet Owl: The northern saw-whet owl is one of the smallest owl species native to North America, just seven to eight and a half inches tall. They can be found in dense thickets or conifers, often at eye level, and can also be found as high as 20 feet up.

On November 16, a worker setting up the holiday tree at Manhattan's Rockefeller Center found a tiny saw-whet owl trapped in the 75-foot tall Norway spruce. The owl was apparently trapped in the tree when it was cut down in Oneonta in upstate New York on Nov. 12. Four days later, after traveling 170 miles across the state, the tree arrived at Rockefeller Center. How the owl ended up in the tree remains a bit of a mystery. A spokesperson for the Rockefeller Center told CBS News that while each branch is individually inspected before it is wrapped, "birds can find their way into the tree on its journey."

The female owl, initially thought to be male, was uninjured but hadn't had food or water for at least three days when she was discovered. She was affectionately named Rocky, short for Rockefeller, and sent to Ravensbeard Wildlife Center in the Hudson Valley town of Saugerties. Rocky was treated for dehydration and hunger and began to recover after getting fluids and "all the mice" she could eat.

After a week of rehabilitation, Rocky was cleared to continue her migratory journey south. The center said a return trip to Oneonta would likely be too traumatic for Rocky, so she was released in a conifer forest on their grounds on November 24. The center consulted with owl experts and avian veterinarians to determine the best time for her release. Rocky was released at sunset so that she could find a safe place to rest by nightfall, before continuing to fly south. Rehabilitator Ellen Kalish held the winsome raptor aloft in a field against a backdrop of rounded mountains. In a video posted on Ravensbeard's Facebook page, Rocky sits quietly on Kalish's fingers before winging her way over to a nearby grove of pines. "She is a tough little bird and we're happy to see her back in her natural habitat," the center wrote on Facebook.

For a week, Rocky's rescue and rehabilitation captured the hearts of many people across the U. S. The

Since taking in Rocky, Ravensbeard Wildlife Center has so far raised more than \$17,000. Ellen Kalish, the founder and director of the nonprofit, told CBS News that the money will go to a new facility.

Kaavan, the "World's loneliest elephant", goes to sanctuary in Cambodia: Four Paws International is a global animal welfare group that has been leading the charge to save Kaavan since 2016. Because of the abysmal living conditions blamed on systemic negligence, Pakistan's high court in May ordered the closure of Marghazar Zoo in the capital of Islamabad, where Kaavan has lived for much of his life.

Kaavan has languished in the zoo for 35 years, most of those years in chains. He lost his partner in 2012. She died after an infection turned gangrenous and her body lay beside Kaavan for several days before being removed. Dr. Amir Khalil, veterinarian with Four Paws, said Kaavan was heartbroken after his partner died. Activists dubbed Kaavan the "world's loneliest elephant" after his plight gained international attention and the unhappy elephant was diagnosed as emotionally as well as physically damaged.

For the past three months, a Four Paws team including Dr. Khalil and the Islamabad Wildlife Management Board have been treating Kaavan's many wounds and ailments. Kaavan was diagnosed as both overweight and malnourished. He was put on a diet of fruit and vegetables and has lost half a ton. Previously, Kaavan was eating 550 pounds of pure sugar cane every day, with only an occasional fruit and vegetable.

He has also developed behaviors including shaking his head back and forth for hours, which the medical team of wildlife veterinarians and experts blame on his isolation and total boredom.

Over the past three months, Dr. Khalil has developed a very strong emotional bond with Kaavan. Now, when the "world's loneliest elephant" hears Khalil's voice, he comes lumbering over. The vet has also been training Kaavan to willingly back into the huge crate that he will be in for the duration of his flight to Cambodia.

Kaavan was set to leave for a sanctuary on November 29. Iconic singer and actress Cher took up Kaavan's cause and has been a loud voice advocating for his reset-

tlement. She was in Pakistan to celebrate Kaavan's departure and to accompany him to Cambodia with the Four Paws International team. Cher said she is making a documentary on Kaavan which people will find "heartwarming."

Even after he's in Cambodia, Kaavan will require years of physical and even psychological assistance. Dr. Khalil said there are many elephants at the sanctuary, but in particular three female elephants are awaiting Kaavan's arrival. The veterinarian joked that Kaavan might just find a new girlfriend there.

Multiple uses for Hydrogen Peroxide: According to the Centers for Disease Control (CDC), hydrogen peroxide kills yeasts, fungi, bacteria, viruses, and mold spores. Hydrogen peroxide, ammonia and bleach are the real workhorses of household cleaning. You don't need a whole cupboard of different cleaning supplies. You could clean most of your house with just these three cleaners. When I googled this topic, I was amazed at the number of uses I found for hydrogen peroxide. One article even listed 50 items! I will list here just a few uses, and suggest you also google this to find other uses relevant to you.

- ★ Wound Cleaning. Hydrogen peroxide can be used for the initial cleaning of a wound, such as a small scrape or abrasion. Its bubbling action helps remove debris that may be stuck in the wound. But it should not be used for large open wounds or deep cuts, or for a long time.
- ★ Carpet Cleaner. Mix two parts water with one part hydrogen peroxide and five drops of lemon essential oil. Make sure you use a dark bottle (like the one peroxide comes in). Shake it up and it's ready to go. Just spray it on the stained carpet, let it sit for a minute or two, and then use a brush to scrub the stains out. This solution

- works on upholstery, too, and you can repeat the process a few times until you get your carpet and fabrics squeaky clean!
- ★ Makeup brush cleaner. Prevent breakouts by cleaning your makeup brushes. Simply drop a teaspoon of hydrogen peroxide into a bowl of warm water, and soak the brushes in there for 10 minutes, then rinse them with cold water.
- ★ Laundry helper. Remove yellow armpit stains. Combine two parts hydrogen peroxide with one part Dawn dishwashing liquid and let the solution sit for at least an hour. Then just spray it on the stain and scrub, scrub, scrub. You can add some baking soda for heavier duty staining.
- ★ Scouring burned pans. Make a paste of baking soda and hydrogen peroxide, and apply that to the burnt, dirty areas. Let it marinate for a bit and then use warmish water to scrub it away. The stain should come off pretty easily, but if it doesn't, simply repeat the process, leaving the paste on a little longer the next time.
- ★ Detoxify fruit and vegetables. Just because you didn't pay extra for organic produce doesn't mean you have to ingest the harmful pesticides generally used on fruits and veggies. Water alone might not do the trick, but this hydrogen peroxide solution sure will. Spray your produce with some food-grade peroxide; let the mixture sit on the food for a minute or two, and then rinse and dry. Next, spray the produce with some vinegar; combined, the two agents work detoxifying wonders!

This is my first report of 2021 and I am sure everyone is hoping this year will be one that will let us put the past behind us and move on with our lives.

I would like to send our very best wishes for a special year to those celebrating their Birthday this month: **Betty Tomaino** (1/1), **Helen Hutchinson** (1/5), and **Arnold Pollack** (1/20).

Everyone that I talk to seems to have fallen into a routine of reading, gardening, crosswords, and other hobbies to help with the quarantine and everyone seems to be doing well with it. We are anxious for the time when we can all get together again at our monthly breakfast. What a great time that will be with all of us trying to catch up on the news of the last year.

This month I am again going into United history and my subject is our past president and CEO, Pat Patterson. He transformed United from a collection of airlines into one of the world's largest carriers.

In 1929, William Allan Patterson gave up a position at Wells Fargo bank to join Boeing Airplane Co. and Boeing Air Transport. At the time, there was only about 25,000 miles of airways in the United States and all passenger airlines combined carried less than one million passengers annually.

Few major corporations have been so completely shaped by the wisdom and direction of a single person at United Airlines. From the beginning, United was the unmistakable creation of Pat Patterson.

Born in 1899 in Hawaii, his father ran a sugar plantation. Pat sailed to the mainland after his father's death and began his career at Wells Fargo in 1915 as a 15 year old office boy. Twelve years later, as a vice president, he was approached by Vern Gorst, president of the failing Pacific Air Transport. Gorst needed a loan to stay in business. Airline and business did not go well together at that time but Pat had been fascinated by airplanes and had flown. He paid \$5.00 (two weeks salary) in 1919 for the thrill of a 20 minute flight over San Francisco Harbor.

One of his first major decisions, made in the early 1930's, was to hire eight young nurses to care for the needs of passengers. This was a new profession in the airline industry and they were to be called stewardesses.

Patterson also opened commercial aviation's first flight kitchen. It was the first airline to fly regular scheduled service from coast to coast and the first to use two way radios, in-flight telephones and television. He pioneered promotional for executives only called "take your wife for free".

In 1934, Patterson was elected President. Soon after he established priorities and the biggest asset was the employees. Everything possible was done to encourage employee participation. We had to get our ideas from our employees. He spent up to a third of his time along the front lines seriously listening to the people he believed made the airline work.

Pat Patterson retired from United in 1966, he was a legendary visionary whose eyes have always been on the stars but kept his feet firmly planted on the ground. He created modern air transport.

When I joined United in 1975, I heard many of my fellow employees talk about Pat Patterson and several had met Pat. I was told he was everywhere and talking to everyone. In the many stories I heard over the years, no one seemed to know about his earlier years. That began my search through United history and I share the story with you.





What happens when the Government controls Private Business. (Part 1 of 3)

n 1927 William Boeing began flying San Francisco - Chicago on an Airmail Contract. In 1928 he added Pacific Air Transport which flew the Los Angeles - Seattle Airmail route. Then in late 1928 Fredrick Rentschler suggested they join their companies.

On February 1, 1929 the United Aircraft & Transportation Corporation (UATC) was formed with Philip Johnson as President, Johnson was also made the President or Vice-President of each of the individual companies and other UATC subsidiaries such as Boeing Airplane Company, Pratt & Whitney Engines, Chance Vought, Hamilton Standard Propeller Co., Sikorsky Aircraft Co. (which then built flying-boats), Stearman Aircraft Co. and Northrop Aircraft Co. Within a year Stout Air Services was added. On March 31, 1930 National Air Transport was added and three months later Varney Air Lines was acquired.



In July 1931, William Alan "Pat" Patterson was named General Manager of the Air Transport division and he moved from Seattle to Chicago taking charge of the new United Headquarters building at Midway Airport. At this time, the Air Transport division owned no Airplanes or

other equipment, had signed no contracts, had no earnings and was supported by the four Air Transport companies.

This fact was to become important on February 1934 when the Franklin Roosevelt Government abruptly canceled the Mail Contracts effective February 19th. The government's decision to have Army pilots fly the mail was disastrous. The pilots were unprepared for flying long distances in foul weather and at night. In 78 days twelve Army pilots died in crashes, ten died in the first 3 weeks.

Roosevelt put the airmail contracts back for bids, but decreed that all Airline Executives who had attended the former Postmaster General Brown's "Spoils Conference" were barred for five years from participation in any future Airmail Contracts.

Money from the Airmail Contracts had been 45 percent of United's total revenue and although increasing steadily, the Passenger, Express and Cargo Revenue fell far short of supporting the Airline. Patterson made the decision to keep all of his Transport Companies flying their full schedules, hoping that additional Passengers, Express and Cargo would replace the lost Mail Revenue.

His argument was "Our Pilots and Ground Crews have to eat ... this is our opportunity to show our people that they are in a Stable Business". United lost more than one million dollars (over \$19,500,000 in 2020 dollars) during the quarter that followed, flying with airplanes half-full of passengers.
