United Debuts New Plant-Based Menu Items From Impossible Foods June 15, 2022



United Airlines is today adding two new Impossible Foods menu items on select flights and in certain airport lounges, as part of the carrier's new push to add more plant-based options to its food offerings.

Foods, the United-exclusive ImpossibleTM Meatball Bowl is now available to first class customers on all domestic flights more than 800 miles in the continental U.S. The ImpossibleTM Sausage is available in Polaris® lounges in Chicago, Los Angeles, Newark and San Francisco.

The collaboration comes as more than half of U.S. consumers are increasing their plant-based food consumption and sales of plant-based meat continue to climb, according to a recent Nielsen report.

"We want our food offerings to evolve and change along with people's preferences – we're proud to work with Impossible Foods and think our customers are really going to love these new options," said Aaron McMillan, United Managing Director of Hospitality and Planning. "To many travelers, the quality of food choices at the airport and in the sky are a really important part of the customer experience, so we're invested in making sure our menu items exceed their expectations. This is the first of many updates we look forward to sharing in the months ahead."

The Impossible Meatball Bowl features three Impossible MeatballsTM Made From Plants and broccolini served on a bed of couscous and topped with an herb-infused tomato sauce. Impossible Meatballs are made with a custom mix of Impossible BeefTM Made From Plants and Impossible Sausage, seasoned with a savory home-style spice blend. Additionally, during breakfast at Chicago O'Hare, Los Angeles, Newark and San Francisco Polaris lounges, United will offer ground Impossible Sausage as an optional omelet ingredient and Impossible Sausage breakfast patties in the buffet.

"United is all about offering the highest quality customer experience, which is something we have in common here at Impossible Foods," said Dan Greene, Senior Vice President of Sales at Impossible Foods. "It's exciting to see the airline bring new options to consumers that are better tasting and better for the planet. We think United flyers are going to love having access to Impossible dishes in the air and in the lounge."

Impossible Foods is on a mission to create delicious, nutritious meat made from plants with a far lower environmental impact compared to meat made from animals. Impossible products are designed to look, cook and taste like animal meat, delivering the crave worthy benefits of meat without many of the negative qualities. Both Impossible Meatballs and Impossible Sausage are a good source of protein and other essential nutrients, while containing 0 mg cholesterol and trans fat, and no animal hormones or antibiotics. Furthermore, they require a fraction of the land use, water consumption and greenhouse gas emissions associated with producing their animal meat counterparts, according to preliminary lifecycle analyses.

Transforming Yesterday's Emissions Into Tomorrow's Sustainable Aviation Fuel: United Announces Agreement with CO2 Utilization Company Dimensional Energy June 15, 2022

United and United Airlines Ventures (UAV) today announced an investment in and commercial agreement with Dimensional Energy, another step forward to reach United's 100% green net zero commitment by 2050, without the use of traditional carbon offsets. Dimensional Energy's novel technology removes the need for fossil fuels, converting carbon dioxide and water into usable ingredients for the Fischer-Tropsch process – a nearly 100-year-old proven technology used to produce fuels from coal or



methane. While facilities around the world continue to use Fischer-Tropsch to produce fossil fuels, Dimensional will be one of the first to use it to produce sustainable aviation fuels (SAF).

Under the commercial agreement, United has agreed to purchase at least 300 million gallons of SAF over 20 years from Dimensional. This agreement further cements United's status as an airline industry leader in sustainability. United's SAF agreements represent the largest volume of SAF of any airline over the next 20 years, based on publicly announced agreements.

"Sometimes you have to look to the past to solve new problems, and we recognize that decarbonizing air travel is going to require combining proven technologies, such as Fischer-Tropsch, with the latest advances in science and engineering," said Michael Leskinen, President of United Airlines Ventures. "As we grow our portfolio of companies like Dimensional, we are creating opportunities to scale these early-stage technologies and achieve United's commitment carbon neutrality by 2050, without the use of traditional carbon offsets."

Dimensional Energy was founded in Ithaca, New York, in 2016 and has spent the last six years refining its reactors and catalysts in both lab and real-world demonstrations. The company's early success led to its status as a finalist in the first Carbon Xprize, and in September 2021, global climate technology nonprofit investor Elemental Excelerator funded Dimensional as part of its 10th cohort, which led to the company's introduction to United. Dimensional has also received grants from the National Science Foundation and both the Department of Energy's ARPA-e and Solar Energy Technology Office (SETO). The company began construction on a carbon dioxide to fuels demo in Tucson, Arizona in 2021. Commissioning of the facility has already begun, and it is set to begin operation this July.

"I am continually impressed by the team at Dimensional Energy as we scale our advanced carbon dioxide to fuels technology. On top of delivering clear environmental impact, our business model includes delivering durable benefit to local communities through creative partnerships. We envision a world run on conflict-free energy. United's support of sustainable aviation fuel made from captured emissions is an important step in the aviation industry's pursuit of carbon neutrality," said Dimensional Energy

Co-founder and CEO Jason Salfi.

Dimensional's technology can run on all forms of renewable energy. At the Tucson site, they are using electricity from the Arizona grid, which gets an increasing amount of power from local solar panels. Future plants are slated to use hydro-power, wind-power and rapidly maturing concentrated solar, which utilizes heat from direct sunlight.

Dimensional can also utilize carbon dioxide from a variety of sources, be it straight from industrial sites (like cement plants), from Direct Air Capture (a technology that can capture CO2 from anywhere in the world), and biological processes like fermentation and biomass gasification.

Today's announcement marks UAV's fourth SAF-related technology investment, but its first the pathway of power-to-liquids: which creates SAF synthetically without the constraints of feedstock growth that is prevalent in other biofuel pathways. Launched in 2021, UAV targets startups, upcoming technologies, and sustainability concepts that will complement United's goal of net zero emissions by 2050 – without relying on traditional carbon offsets. Over the last decade, United has built a first-of-its-kind sustainability-focused ventures fund. UAV's portfolio now includes SAF producers and other technologies including carbon capture, hydrogen-electric engines, electric regional aircraft, and urban air mobility.

United Becomes First U.S. Airline to Add New Transpacific Destination Since Pandemic June 8, 2022



United today announced year-round, nonstop service between San Francisco and Brisbane, becoming the first U.S. airline to add a new transpacific destination to its global net-

work since the start of the pandemic. From Brisbane, United customers will be able to easily connect to nearly 20 other cities within Australia thanks to the airline's new partnership with Virgin Australia. United was the only carrier to maintain passenger service between Australia and the U.S. during the pandemic.

"With United's strong history in Australia – and now with a great partner in Virgin Australia – it's the ideal time for United to expand service to Brisbane as demand for travel continues to grow," said Patrick Quayle, senior vice president of international network and alliances at United. "Throughout the pandemic, we've looked for strategic ways to grow our international network, and we're proud to be the first U.S. airline to put a new dot on our route map across the Pacific."

In addition to the new Brisbane route, United currently flies nonstop to Sydney from San Francisco and Los Ange-

les and offers nonstop flights between Melbourne and the U.S.

The launch of this route is supported by The Queensland Government's Attracting Aviation Investment Fund, which was established to help rebuild the country's international tourism industry. United's new service will support 385 local jobs and bring an estimated \$73 million into the economy. Pre-pandemic, San Francisco was the second largest mainland U.S. inbound passenger market and destination for Queensland travelers. United's hub at San Francisco provides convenient one-stop connections for more than 80 North American destinations.

"This new service from United is a gamechanger for Queensland and we look forward to welcoming guests from across the United network to experience the sunshine, beaches and Queensland's unique outdoor lifestyle," said Gert-Jan de Graaff, CEO, Brisbane Airport Corporation. "Australia is often mentioned as a bucket-list destination for North American travelers, so now is the time for customers to jump on board and see it for themselves."

United's new Brisbane service will operate three times weekly on a 787-9 Dreamliner aircraft that includes 48 lie-flat, United Polaris® business class seats, 21 United Premium Plus® seats and 149 economy seats. All seats are equipped with seatback on-demand entertainment to help customers pass the time and relax during their travels.

United is the longest serving U.S. carrier in Australia, serving the country for more than 35 years with its first direct service to Sydney in 1986. The airline first began offering nonstop service to Melbourne from Los Angeles in 2014 and recently restarted its San Francisco-Melbourne service this June.

This story goes back to the summer of 1988! There was an engine change on a 737-200 at Newark Airport in New Jersey.



As part of a crew from LaGuardia, we left for Newark. The job was going well, except the clouds were building and the thunder started. First a few drops, then a few more, and the sky opened up. We ran inside but got completely soaked.

We went up, had a nice meal and headed back to LGA. When I got back and was asked how everything went, I said, "Great", there was no need to explain any situations, and all is good.

As a child growing up in Cleveland, Ohio our family would usually fly to the East Coast of Florida each winter and spend a couple of weeks. Of course, I became slightly partial to the East Coast. However, in 1998 my job with United took us to the Tampa area and we fell in love with the West Coast of Florida. If you have never tried it, you should!

First of all, Tampa International Airport (TIA) is one of the easiest airports to maneuver. Early on, Aviation Authority Executive Director George Bean had a vision for a new complex centered on functionality and convenience for passengers. His goal was that folks wouldn't have to walk more than 700 feet from their car to gate.

TIA became the first major airport to have wall-towall carpeting. It was brown and orange and Mr. Bean was fiercely protective of it. He wouldn't allow airport



shops to sell gum as he did not want it getting stuck on people's shoes or in the beautiful carpet he installed which was to done to reduce noise and create a sense of coziness. Of course, today, there's different flooring and plenty of gum being sold at the airport.

Over the years, TIA has also undergone several renovations and expansions, however in 2018 the airport announced a billion-dollar update. But the original concepts which made it so convenient and revolutionary still put passengers at ease today.

Upon leaving Tampa International Airport if you head south on 275, come across the Howard Franklin Bridge you will arrive in the city of St. Petersburg. It's truly a lovely city, lots of things to see, plenty of nice places to eat and plenty of nice places to stay. There is everything from the Dali Museum, Chihuly Glass Museum, the newly renovated Pier, Tropicana Field (Home of the Tampa Bay Rays), Al Lang Field (home of the Tampa Bay Rowdies) and lots of restaurants and boutiques on Beach Drive to visit, just to name a few; truly a nice place to see. To top off all of these accolades, the St. Petersburg area averages 361 days of sunshine per year, and holds the Guinness World Record for the most consecutive days of sunshine — 768 days in a row!

Once you get settled in your hotel (or wherever you

select to stay) you will find that there are so many things to do. Dolphin watching, sunset dinner cruises, parasailing, fishing charters, or just soaking up the sun rays, you will find that your day flies by. The Writers's Column - The Jackalope By George Midwin

During my travels about California historical sites, I met a number of interesting people. These same people have told me stories about the local area, events that occurred and about some of the wildlife that live there. This story is about the strangest animal I've ever heard of and recently came across an example of, the Jackalope.

In the early 1800's, settlers from the East began migrating to California. These long trips required a great deal of preparation for the long journey. Although they expected to provide food for their families by fishing and hunting along their route, they also realized there may be times when this would not provide sufficient amounts. Due to the harshness of conditions, food storage was very limited, thus live animals were often brought with them. Additionally, live animals were captured during their travels. These would include animals such as squirrels and rabbits. These animals required very little to no food support from the settlers as they would forge on the grasses and berries. Since they would have no way of knowing about the conditions and especially the food sources ahead of them, they would 'stock up' when opportunities presented themselves. One of the favorite animals was the rabbit. These were often plentiful and easy to catch in a simple trap. Additionally, the rabbits were very good eating. As the wagon trains neared California, in the area of the Nevada and Oregon area, they noticed a unique breed of tiny deer, no larger than a small dog. The children of the settlers were so excited about seeing these animals that almost all of the families would capture a few to take with them for pets when they arrived at their new homes. There may have also been an interest by some of the single settlers that others at their final destination would be interested in purchasing a small deer. In hopes of offsetting the cost of the journey, their wagon often contained a large number of these tiny deer.

Most of the travels across the country were accomplished in relatively flat land, although some places being a bit more rugged than others. However, they discovered the final leg of their journey to be all rugged. The tall mountains of the Sierra Nevada range created extreme difficulties, requiring the settlers to make even more difficult decisions. They often decided that they needed to lighten the load on their wagons, discarding some household items and eventually their animals captured along the way. Animals that were originally brought with them for the purpose of establishing a herd at their destination, were being released each day.

The animals captured along the way, including the rabbits and tiny deer, to the loud cries of the children, were also released. Thus during the last leg of their nearly eight month journey, they distributed an entirely new animal species to California. Imagine, a wagon trains numbering as much as one hundred, abandoning their animals in a desperate attempt to make it to their destination, which was so close. In later year,s wagon trains would discover safer routes, the need to discard household goods and animals diminished. Thus a situation developed for those previously released animals to have fewer and fewer animals with which to continue their species with. Nature, being what it is, always finds a way. Thus it was with the tiny deer and the rabbit; this cross breeding created and entirely new creature. Many decades later, this strange animal was being spotted by native inhabitants in the mountains. Indians living there for thousands of years had never seen anything like it. Fear spread as word of this creature reached tribes from all over. Miners panning for gold began seeing these as they forged during hunting trips. These reports reached entrepreneurs in San Francisco, who quickly mounted expeditions in search of this creature.

Soon, just as the word of gold reached people from around the world to descend on California, people in the state became keenly aware of what the possibilities this creature could provide. But it didn't have a name that had been attributed to it. Veterinarians called the animal "antilopes-rabit-ticus", however since it resembled a jack rabbit with small deer antlers, the name Jackalope became accepted among the population. Even as people were warned to the dangers of approaching this creature, tens of thousands of people set out in search of the Jackalope. With its speed and antlers, a Jackalope could impart considerable



harm to the unsuspecting hunter. That didn't stop top restaurants from San Francisco, seeking out the creature for its unique taste, which was reportedly to be a lot like chicken. Butcher shops hired people to provide the animal for them as more customers requested they make it available for purchase. Hunters wanted one to mount above their fireplaces. Businesses sought out taxidermists to provide one they could show cus-

tomers. Museums sought one for displays. Others developed a bustling business stuffing Jackalopes to sell to souvenir hunters. Still others organized tours to take the wealthy to see first-hand the Jackalope in the wild, or for the purposes of hunting the animal themselves. Shippers were sending mounted jackalopes to Europe and beyond.

You can quickly imagine what all this attention did to this unique species, during the period of time that government programs were yet to be established. It became more and more difficult to find a Jackalope. By the end of the century the Jackalope was rarely seen. It could be that it became extinct or evolved into a creature with stealthy abilities. Perhaps it developed similar traits as that of the Big Foot or the Loch Ness Monster, due to the fact that a few sightings have occurred throughout this century. The story goes that if you do see one, you toast it with a drink. During my most recent travels, I was fortunate enough to see one mounted on the wall in a bar. I don't remember if that was before or after I toasted it.



To celebrate the Fourth of July, we wore patriotic colors and **Barbara Cunningham** brought in red, white and blue leis for everyone.

We had 13 members in attendance. Several of our regulars were missing. **Diane Griego** was in Oregon relaxing at a friend's home in a lovely wooded setting. We also missed **Joe & Wilma Leather**. Wilma has been having hip pain and sciatica and was able to get a last minute doctor's appointment. As we all know, when you can get in to see a doctor in one or two days, you change plans to grab that appointment! **Jack & Judi Smith** could not attend either. Jack had ear and eyelid surgery and could not see to drive. We passed around a get-well card for Jack and everyone signed it.

Well, I improvised. I cut up address labels, wrote the numbers 1-20 on them, and then everyone drew a label. Ticket #1 got the money and then people went up in numerical order to choose a gift. I was in a huge elastic bandage splint for two weeks and then a full arm cast for two weeks. I then got a "mini cast" which still immobilizes the thumb and goes around my wrist, leaving the four fingers free to move. I started 3-4 months of twice-weekly hand therapy on May 24. I could not drive for eight weeks and Russ & Glenda Kennedy graciously gave me a ride to our meetings during that time. I had to wear the mini cast 24/7 until July 5. As I write this on July 7, I can have the cast off up to 50% during the day, and can use both hands to type, until the thumb starts to ache. As my thumb continues to get better, I'll be able to write longer articles for the newsletter.

If you read historical fiction, you may have noticed that many books are being written about World War II. I am thinking that a lot of documents from that period are being declassified now. Here are a few that I've read recently and really enjoyed. The Long Flight Home by Alan Hlad is about the British Pigeon Service. For mystery lovers, the latest book in Donna Andrews' Meg Langslow series, Round up the Usual Peacocks, has just been released. Another new release is Portrait of an Unknown Woman, the latest book in Daniel Silva's Gabriel Allon spy thriller series.

According to Feeding America, an estimated 160,000 military families experienced difficulty putting food on the table in 2020. Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me. This is such an easy thing to do to support our troops. If you are scissors impaired, ask your grandkids to help! For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say "Manufacturer's Coupon". The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. In my area, the coupons come in Tuesday's mail along with the supermarket ads, and then in the Sunday paper. I can't wait to see how many coupons you all send me (to address above). I would like to thank Tracey Blanchard, Glenda Kennedy, Carol Parks, Noelle Sakamoto, Barbara Cunningham and Margaret McGhee who bring coupons to our monthly meetings. I would also like to thank Carol Hulsebos and Sheryl Schubert who have seen my request in the newsletter and have mailed me coupons. The lady in charge of my DAR chapter's coupon project reports that as of May, she has sent in 13,300 coupons totaling \$34,200.
