### Changes to printable boarding passes for SA0 and SA1 travelers June 4, 2024



Effective June 12, 2024, employees, active retirees and eligible enrolled friends traveling on standby space-available passes domestically (SA0 and SA1) will need to use the United app to access their boarding pass. Printing boarding passes at airport kiosks will no longer be available for SA0 and SA1 passes.

Our goal is to reduce paper boarding passes, which are often out of date as soon as they're printed. Using the United app gives customers the most up-to-date information and the best experience possible.

**SA0V, Regional Partner SA0X:** Employee/Retiree Vacation ePass Travel & Regional Partner Personal Travel on own metal (previous reference code A\*):

- ▲ Employee, retiree & their eligible accompanied pass riders traveling on a vacation ePass
- ▲ Employee's & retiree's unaccompanied spouse/domestic partner & accompanied pass riders traveling on a vacation ePass
- ▲ Unlimited extended family buddy pass riders accompanied by the employee or the employee's spouse/domestic partner traveling on a vacation ePass (includes retiree when eligible)
- ▲ Maximum of two regular buddy pass riders per employee ID accompanied by the employee or the employee's spouse/domestic partner traveling on a vacation ePass (includes retiree when eligible)
- ▲ Operating regional partner employees & their eligible accompanied pass riders will board equal to SA0V when traveling on their own metal, using years of service to the company to prioritize

**SA1P:** Employee Personal Travel (previous reference code B\*)

- ▲ Employee & their eligible accompanied pass riders
- ▲ Employee's unaccompanied spouse/domestic partner & accompanied pass riders
- ▲ Unlimited extended family buddy pass riders accompanied by the employee or the employee's spouse/domestic partner
- ▲ Maximum of two regular buddy pass riders per employee ID accompanied by the employee or the employee's spouse/domestic partner

## August Is National Make A Will Month

## United Applies to Expand Service Between San Francisco and Washington National Airport July 8, 2024



United Airlines today filed an application with the U.S. Department of Transportation (DOT) for a new daily roundtrip flight between Ronald Reagan Washington National Airport (DCA) and

San Francisco International Airport (SFO).

If approved, the new route will give customers more nonstop options between DCA and SFO and provide connections from SFO to about two dozen domestic markets within the Western U.S. – as well as seven international destinations. At least nine of these destinations are without United connection options to DCA via San Francisco today. Furthermore, United’s proposed route seeks to avoid the busiest travel times at DCA, which is already one of the most congested airports in the country.

*“With our hub in San Francisco, United is well positioned to serve the strong customer demand for air travel between Washington National and the Bay Area,”* said Patrick Quayle, Senior Vice President of Global Network Planning and Alliances at United Airlines. *“If awarded by the DOT, this new service will give customers a unique morning departure from Washington National and a unique afternoon departure from San Francisco, as well as more connectivity for both domestic and international travelers via SFO.”*

United’s proposed flight would avoid the most congested travel times at DCA and provide additional scheduling options to customers by offering for the first time a morning departure from DCA to SFO and an afternoon departure from SFO to DCA. United plans to use the Boeing MAX 8 aircraft, with 150 economy cabin seats and 166 total seats.

The Washington, D.C. region is a major center of commerce, hosting over 15 Fortune 500 companies, and is a hub for companies focused on emerging technologies, like AI and data sciences. The region is also home to the U.S. Federal Government and global institutions like the World Bank, International Monetary Fund, and over 100 foreign embassies/consulates.

Like Washington, D.C., California is also a significant hub for innovation and business, and the state with



the highest number of Fortune 500 companies. Its economy — the fifth largest in the world at \$3.9 trillion in 2023 — has grown by 6.1% since the year prior, highlighting the state’s robust and growing economy. San Francisco, the heart of Northern California, and its surrounding areas are home to over 30 Fortune 500 companies, including Airbnb, Apple, Alphabet, Chevron, Gap, Visa, and Wells Fargo. United provides customers a comprehensive global network in San Francisco, serving more than 60 domestic destinations and over 30 international destinations. The airline has an average of 240 daily departures from SFO and employs more than 12,000 people in the Bay Area.

As an alternate proposal to United’s additional DCA-SFO flight, United has applied for its first-ever DCA-Los Angeles (LAX) flight. The proposed LAX flight would help foster healthy competition, as three other airlines currently fly the route. The proposed flight, which would also be operated on the Boeing MAX 8 aircraft, would also provide greater flexibility and schedule choice for customers with the earliest arrival in LAX of all airlines and the latest morning departure to DCA.

### **United Now Texts Live Radar Maps and Uses AI to Keep Travelers Informed During Weather Delays** **July 3, 2024**



United now texts customers links to local, live radar maps during weather delays, as part of its industry-leading effort to give travelers as much real-time information as possible about their trip, especially if things don’t go as planned. For the past few years, the airline has used dedicated teams to write and send text messages to customers that give near-instantaneous details about a given flight – everything from gate changes and boarding times to more specifics regarding aircraft swaps, crew rescheduling and weather events – and the teams now use generative artificial intelligence (gen AI) tools to assist in giving more travelers real-time updates during flight delays.

United’s latest innovation – real-time radar maps – can help customers understand how inclement weather in one part of the country can impact a flight elsewhere. United is the first and only U.S. airline currently providing its customers these kinds of specific messages, and the airline is sending them with assistance from gen AI tools.

*“With more people traveling this summer than ever, we wanted to give our customers an easier way to stay*

*connected to real-time information about their flight and texting was the simplest solution,”* said Jason Birnbaum, United’s Chief Information Officer. *“We know customers appreciate transparency and by combining innovative technology-enabled tools with people power, we can give more people, even more in-the-moment details about their flight.”*

The release of these new innovations comes as United expects its busiest Fourth of July weekend on record with more than five million passengers flying between June 28 and July 8, up more than 7% compared to last year.

Here’s how it works:

- ▲ Specialized customer service teams sit in the network operations center alongside the flight operations teams and tap gen AI to review flight data and write customer messages that tells the complete story of a flight change. These messages are sent to customers through text or email in an effort to provide more helpful and relevant information about why flight plans are changing.
- ▲ During weather events, messages will include links to local, live radar maps showing weather details across flight paths. This helps customers stay informed on weather-related delays, including showing how weather in one part of the country can impact a flight elsewhere. Plus, customers on all flights can access links to weather maps in the United app under flight status updates, and United displays radar maps in the gate area when a flight has been delayed due to weather.

**Leading with Customer Transparency:** For years, United has led the airline industry on implementing new technologies and policies across its operation to increase customer transparency, including:

- ▲ *Automatic rebooking assistance:* Instead of waiting in line to talk to an agent or search for new options, United’s self-service tools automatically present travelers personalized rebooking options, bag tracking information and meal and hotel vouchers when eligible if their flight is delayed or canceled.
- ▲ *Real-time flight updates:* United is the first and only U.S. airline to give customers real-time access to their boarding pass, gate and seat number, and countdown clock to departure time directly on their phone screens, all without opening the United app.
- ▲ *Free family seating:* United is the first and only airline to offer a dynamic seat map feature that makes it easier to seat children under 12-years-old next to an adult in their party for free – even travelers in Basic Economy.

- ▲ *No change fees:* In August 2020, United got rid of change fees, offering more flexibility for travel plans, and started complimentary standby travel, becoming the only U.S. airline that lets all customers in all classes of service fly same-day standby for free.

**United Teams Up with Chicago Bears  
to Support Special Olympics  
June 12, 2024**



United teamed up with the Chicago Bears today at O'Hare International Airport to support

Special Olympics, Inc. ("Special Olympics"). Chicago Bears Tight End Cole Kmet worked alongside the airline's Special Olympics Service Ambassadors for the day to help drive awareness of the organization's travel needs.

United launched the Special Olympics Service Ambassador (SOSA) Program in 2019, inviting Special Olympics athletes to work in airports as part-time employees. These employees welcome United customers, helping them locate check-in kiosks, showing them where to drop bags and also how to find TSA PreCheck lines. Beyond the lobby, SOSAs also help travelers with wayfinding, gate recovery, and assist with Agent on Demand. To-date, there are currently 18 SOSA workers at United hubs in Chicago, Houston, Denver and Washington, D.C., with further expansions to follow this year in Los Angeles and San Francisco. The airline has also sponsored Special Olympics Plane Pull® competition, supported local volunteer events and on a global level, the Special Olympics World Games.

Last year, 4,000 Special Olympics athletes, coaches, Unified partners, and staff from North America traveled across the country and around the globe for sport and educational development, athletic competitions and leadership events. United supports Special Olympics by providing travel to the organization while encouraging its loyalty program members to donate their unused miles through the airline's industry-leading crowdsourcing program, Miles on a Mission. In addition, United's role as a sponsor of Special Olympics' annual Capitol Hill Day events helped to ensure that 49 Special Olympics Programs from 47 states had the opportunity to participate in more than 300 vital meetings between athletes and lawmakers in Washington, DC. Since 2017, United has contributed more than \$8.5 million in travel miles and cash to support Special Olympics athletes.

Today's unification between United and the Bears is just the latest way the organizations have shown their support.

Chicago Bear Tight End Cole Kmet had a hard time keeping up with United SOSA Daniel Smrokowski. *"Daniel's energy was tremendous. He was moving around all day, smiling and greeting each passerby that he interacted with. It was hard trying to keep up with him! Daniel is an inspiration, I'm proud and honored to have spent the day with my new friend."*

The Chicago Bears remain proud supporters of Special Olympics of Illinois, a connection and bond that dates back decades and carries strong into today.

The Special Olympics Service Ambassadors are gearing up for United's busiest summer season ever, with 5% more customers flying the airline this June, July and August.

*"I've been a part of the United Airlines team as a Service Ambassador since the Service Ambassador position was created. I'm excited to not only have support from the Chicago Bears but to also see United expand our Service Ambassador team across hubs,"* said Smrokowski. *"As athletes who are on teams, both ourselves as Special Olympics athletes and the Chicago Bears know the importance of collaboration and communication. We use those skills in the airport to help travelers."*

United has been a Best Place to Work for Disability Inclusion for eight years in a row and has consistently earned a top score on the Disability Equality Index. According to a 2018 report by the Institute on Disability at the University of New Hampshire, only 19.1% of people with intellectual disabilities were employed in the United States compared to 61.8% for people without a disability. *"Employing Special Olympics Service Ambassadors is truly a gift to both our United team and our customers in airports,"* said Omar Idris, Vice President United Airlines, Chicago O'Hare Hub. *"Through the SOSA program and business resource groups like Bridge for people of all abilities, United Airlines strives to create an inclusive and dynamic workplace environment."*

Some of the airline's measures to improve accessibility include:

- ▲ Plans to improve the travel experience for customers who use a wheelchair, including a new digital filter on [United.com](https://www.united.com) that helps determine which aircraft can accommodate different sized chairs, and refunding the fare difference if a higher-fare flight is needed to accommodate a specific wheelchair size.
- ▲ Last summer, United became the first U.S. airline to add Braille to aircraft interiors, helping millions of travelers with visual disabilities to more easily navigate the cabin independently. United expects to outfit its entire mainline fleet with Braille by the end of 2026.
- ▲ The United mobile app was recently redesigned to make it easier for people with visual disabili-

ties to use. The app offers increased color contrast, more space between graphics and an enhanced display and announcement of information to better integrate with the screen reader technologies like VoiceOver and TalkBack.

- ▲ United's Inflight Seatback Entertainment screens offer a wide range of accessible features such as closed captioning, text-to-speech controls, magnification, explore-by-touch capabilities, audio-described movies, and adjustable and high-contrast text and color correction. As part of United Next, the airline's historic growth plan, the carrier expects to take delivery of about 700 new narrow and widebody aircraft by the end of 2032, all of which will include the latest in seatback screen entertainment options.

### **United Adds Nearly 200 Flights for Political Conventions June 11, 2024**



United today added nearly 200 new flights to make it even easier for convention attendees and political enthusiasts to travel to this summer's national political conventions. United will increase its Milwaukee flying by more than 75% for the Republican National Convention in July and will fly its largest schedule from its Chicago O'Hare hub since 2019 for the Democratic National Convention in August, including a 40% increase in flying between Chicago O'Hare and Washington Reagan.

In total, the airline will add 72 flights to and from Milwaukee in July and 118 flights to and from Chicago in August.

*"These conventions are steeped in tradition and have now evolved to become a weeklong celebration of our political process,"* said Patrick Quayle, United's Senior Vice President of Global Network Planning and Alliances. *"We're proud to give people even more options to visit two great cities, and participate in these historic events and make their voices heard."*

Tickets are on sale now on the United app and [United.com](https://www.united.com).

**Republican National Convention Schedule** ~ United is flying a 75% larger Milwaukee schedule for the Republican National Convention, enabling nearly 5,000 more people to attend the historic event. In total, United will have more than 280 flights to and from Milwaukee the week of the convention including:

- ▲ A new, nonstop flight between Milwaukee and Washington Reagan airport.
- ▲ 72 additional flights from United's hubs in Chi-

cago O'Hare, New York/Newark, Denver, Washington Dulles and Houston.

- ▲ 20 roundtrip flights on larger aircraft.

**Democratic National Convention Schedule** ~ United will fly its largest Chicago O'Hare schedule since 2019 for the Democratic National Convention, with more than 530 flights per day on peak days. The schedule includes:

- ▲ 38 additional flights between Chicago O'Hare and Washington Reagan. All flights between the airports on peak convention days will be on Boeing 737 MAX 8, with United's signature interiors.
- ▲ More than 80 added flights between Chicago O'Hare and cities like Albany, Atlanta, Austin, Baltimore, Boston, Portland, Phoenix, Sacramento, San Diego, San Jose and Seattle.

This recipe is for a large amount, but you can easily cut the recipe in half. ■



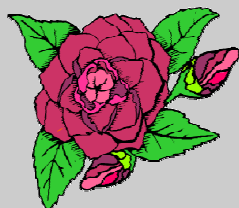

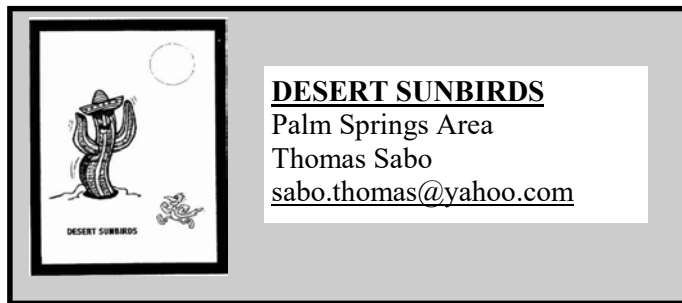

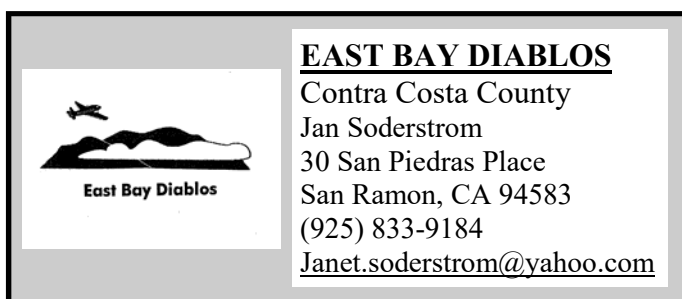

Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me at 30 San Piedras Place, San Ramon, CA 94583-3018. This is such an easy thing to do to support our troops. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer's Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too; however, please send in coupons at least every other month so the troops have a longer time to use them. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated. I get so excited when I get a coupon for eggs!

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022. I

don't have a count for July yet because the "Coupon Lady" delayed her pickup until the week of July 8 due to the heat wave. I will have the count for July and August in the next newsletter. Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. All the coupon cutters are telling me that they are not getting coupons like they used to. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons. If it weren't for the RUAEA folks from all over the country sending me coupons, my chapter would have very few coupons. Membership information had no birthdays or anniversaries but **Carol Slater** and **Lydia Rolfe** are on the

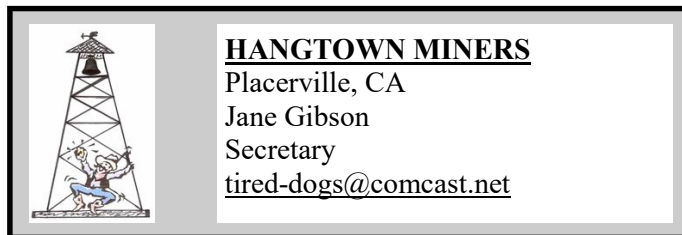
“not feeling so good” list. Cards will be sent. We had 21 members at our shindig today.

called Oakley, Idaho." "Where did grampa grow up?" "He didn't".

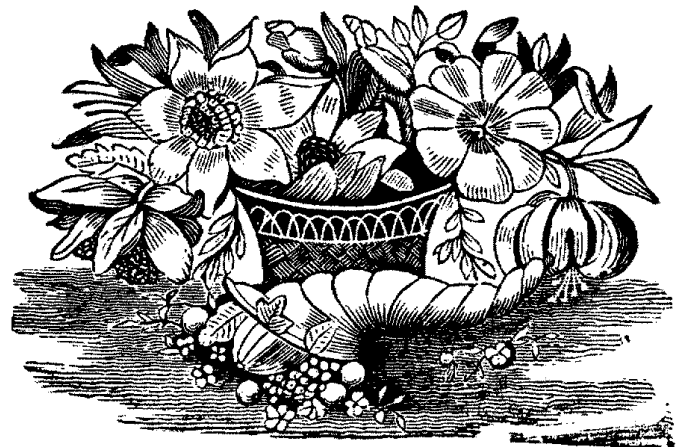
- ☺ I really don't mind getting older, but my body is taking it badly.

## United Airlines Historical Foundation

### United Airlines L1011



**L**ockheed developed an entirely new plane using the latest technology while Douglas used technology from its DC-8 to save money. Lockheed's problem was that the L1011 cost much more than the DC-10, leading American Airlines to order the DC-10 rather than the TriStar. Despite losing out to Douglas with American, orders for the TriStar were placed by Trans World Airlines (TWA) and Eastern Airlines. The L1011 made its maiden flight on November 16, 1970, and entered service with Eastern Air Lines in April 1972. Ultimately, the DC-10 won the battle, and Lockheed stopped building the L1011 Tristars in 1984 after manufacturing 250 aircraft.

After a long history going back to 1927, Pan American World Airways (PanAm) began to struggle financially in the 1970's due to a rise in the price of oil. PanAm thought it could ride out the storm by modernizing its fleet. In 1980, Pan Am began taking delivery of 12 Lockheed TriStars.

This proved challenging as the new airliner increased the airline's training and maintenance costs. By the mid-1980's, PanAm needed to raise cash to offset some of its debts and began selling its slots at Narita International Airport (NRT) in Tokyo, Japan.

United Airlines was interested and made a deal that included several DC-10 and L1011 aircraft. The sale was completed in February 1986, giving United the Tokyo airport slots plus six Lockheed L-1011 TriStars and PanAm's Pacific fleet of Boeing 747SPs.

By 1986 United Airlines was flying to 13 destinations in Asia from its Narita hub.
