## Torgy's Travel Tips - March 2019 75<sup>th</sup> D-Day Anniversary

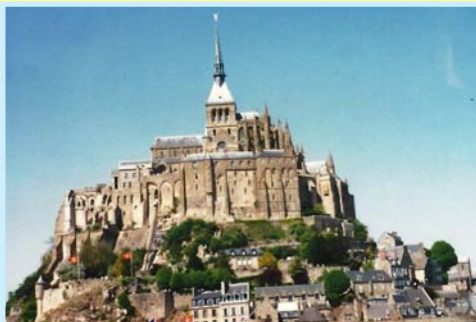

June 6<sup>th</sup> will mark the 75<sup>th</sup> anniversary of the Normandy Invasion by Allied troops during WWII. If you have not yet made a visit to this area, you really should. You may have visited the USS Arizona Memorial at Pearl Harbor or the Punchbowl cemetery nearby and come away humbled. A similar but much more magnified experience awaits those who make the pilgrimage to the D-Day beaches and memorials. You cannot help but come away a changed person, a more humble human being and one who recognizes the sacrifice of those who fight for liberty and freedom. Since the 75<sup>th</sup> anniversary will be marked by many events over several days beginning June 4<sup>th</sup>, hotels and tours are already nearly fully booked. But that should not deter you from coming either before or after the actual landing date. This entire year will be marked as a special event year for the coast of Normandy, France. So, let's take a look at how you can start planning for your own Normandy "invasion".



The 5 landing beaches, code named Utah, Omaha, Gold, Juno and Sword lie between Caen and Cherbourg. On my last trip to this area, we used a rental car and made the beautiful town of Bayeux our base. (Bayeux is the home of the nearly 1000 yr. old Bayeux Tapestry, a 230-foot-long embroidered frieze depicting the Battle of Hastings in 1066 when William the Conqueror invaded England.) From here it is only a 15 min drive to Arromanches, site of the not-to-be-missed Arromanches Museum located on the beach separating the Omaha and Gold beach landing sites. Not only will you see how the Allies built an artificial pontoon harbor with floating roadways protected by sunken ships in order to supply advancing troops but also remnants of the harbor that are still visible today. You can also walk on the cliff to the German gun battery emplacements which have been left in their natural state, to see how close they were to the landing troops.



A 30 min drive west from Arromanches brings you to Colleville-sur-Mer, the location of the Normandy American Memorial Cemetery, which overlooks Omaha Beach. This was one of the most humbling sites we visited. 9,387 US military dead are interred here. Local students in the area each "adopt" a gravesite for 1 year and are responsible for maintaining it.

Take time to read the inscription on the walls of the memorial, too. This cemetery was included in the film "Saving Private Ryan". A short distance away is another cemetery for German soldiers who fell during the invasion. It is interesting to visit both.



8 miles westward is Point du Hoc. The cliff edge above the beach looks much as it must have looked on June 6, 1944. There is a circular gun emplacement and bunkers that you can wander around.

Another 1 hour drive west will bring you to St. Mère Église, where Allied advance troops parachuted 2 days before D-Day in the dark of night. Some soldiers' parachutes were caught on the spire of the church. You might remember seeing this depicted in the movie "The Longest Day". The Airborne Museum is located at: 14 rue Eisenhower.

A short 30-minute drive further west brings you to Cherbourg (remember the movie "The Umbrellas of Cherbourg"?). This is a beautiful seaside city where ferries can take you to Portsmouth, England.

Now if you don't wish to drive but prefer to visit some of these locations from Paris as a day-trip, check out [www.linkparis.com](http://www.linkparis.com). This company offers a small group van tour (maximum 8 persons) with excellent guides at a very moderate price. You take the train, on your own, from St. Lazarre station in Paris around 7AM to Caen. They meet you at the Caen train station. After visiting the Caen Memorial and having lunch, you proceed to Arromanches. From there you visit the Normandy American Cemetery and Omaha Beach. They return you to the Caen train station in time to take the 6PM train back to Paris. You arrive in Paris before 10PM. Since this is a shared van tour, there may be stops at the British beaches and/or cemetery as well, depending on the nationalities of your co-travelers. I have heard that this company can also assist you in finding a location or gravesite for relatives of those who fought here if you notify them in advance.

Only one more thing that I would also add to a trip to Normandy: Mont St. Michel. The iconic Gothic Abbey, perched atop a tiny island, is just a 1 ½ hr. drive south from Bayeux and totally worth it. The island is connected by a causeway (no cars allowed). You must walk the 440 yds. from the parking lot. (If you wish to make this a day trip from Paris, take the high-speed train to Rennes from St. Lazarre station, which connects to a bus to the island's main gate).

The lanes on the island are cobblestone, steep and narrow but it is truly not-to-be-missed. If you wish to tour the Abbey at the top you must purchase a ticket, but everything else is freely open to walk around. I had the most delicious crepes and wine at "La Mère Poulard" overlooking the bluff down to the sea on my last visit. What a memory! Caution: Do **not** attempt to park on the causeway – the tide will wash away your car!

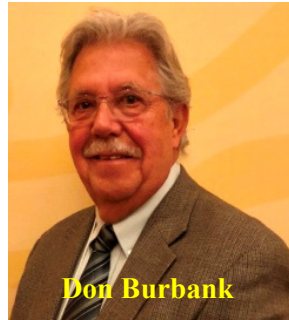
United currently offers non-stop flights to Paris from Chicago, Newark, San Francisco and Washington Dulles. ■

#### **Update: Jet fuel tax bill passes** **NJ General Assembly**



New Jersey bill A4392, which seeks to increase taxes on jet fuel purchased in the state, passed the New Jersey General Assembly recently by a 42-31 vote, receiving just one vote above the minimum it needed to pass.

More than 1,000 employees sent letters to their assembly members opposing the bill but, despite United's efforts, the bill now goes back to the Senate for a concurrence vote before advancing to Governor Phil Murphy for signature.



This bill illegally proposes to use jet fuel tax revenue to fund non-aviation infrastructure projects, which is a clear violation of both federal law and the Federal Aviation Administration's (FAA) revenue use policy.

If enacted, the law could result in a \$20 million annual cost increase for United.

United continues to stand firm in the company's opposition to the bill and will urge Governor Murphy to veto it if it reaches his desk. United will keep you informed of the process. Stay tuned to local communications and Flying Together for updates.

### **United demonstrates historic 'green' power unit at LAX**



It's one thing to be the North American - and worldwide airline - launch customer of the groundbreaking battery-powered ITW GSE 7400 ground power unit (GPU), and it's

quite another to hook the unit up to an aircraft on the ramp at LAX and demonstrate it for a group of airport and air quality officials and curious aircraft technicians.

The electric GPU passed its test with flying colors, silently providing power to a brand-new Boeing 787-10 that was on layover at LAX and borrowed for the occasion. The ITW 7400, which is the first of what United hopes will be a large fleet of the zero-emission units, is designed to power a smaller aircraft such as an Airbus or a Boeing 737 for an entire 8-hour shift or longer. It can also provide enough electricity for a larger aircraft for shorter periods.

Before starting the electric GPU, technicians started one of the diesel GPUs that will eventually be phased out at California airports and elsewhere. While not as loud as older units, the standard GPU is loud nonetheless, even outside, and because of emissions cannot be used inside. The ITW 7400, on the other hand, can operate in a hangar, even a closed hangar.

*"This is the clean, quiet future of ground power units,"* said United Ground Service Equipment and Facilities Director Barbara Sullivan. *"These units also promise to be much less costly to maintain and operate over the years, so the more we can add to our fleets, the better."*

United's guests included officials from the Los Angeles World Airports and the California Air Resources Board, as well as ITW and other vendors.

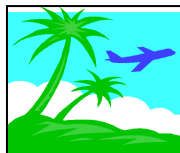

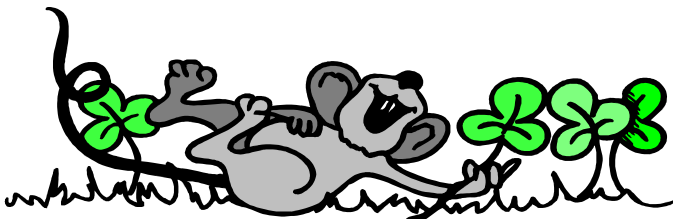

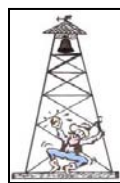

This subject is quite serious: Fraud Against My PBGC Account: I’m not sure who sent this info to Bill, but, here’s what happened: “On 12/7, someone called the PBGC customer service center claiming to be me. They were able to provide sufficient info (name, address, phone, SSN, DOB. etc.), they had the PBGC change my phone number to a Miami area number and also the name of the bank where my payments are supposed to be direct-deposited.” Goes on to say that the bank immediately started trying to get hold of him. Checking into “My PBA”, he saw the changes that had been made and changed them back but had to wait to call PBGC. This was a deliberate fraud which he was fortunate to catch quickly. PBGC is investigating.

It is important to be vigilant with your information. We were asked to tell you to please immediately do 3 things:

1. Log into your “My PBA” PBGC account online and check your profile to be sure everything is accurate, especially the bank where their money is to be deposited.
2. Set up Notifications in that account so they send you an email about any changes made to your info outside of that online account.
3. After doing those 2 things, call the PBGC and sit on hold for however long it takes, to arrange to set up a password you have to provide to them in the future before they will make any changes to your account over the phone. **Jerry Avallone** agreed that the password is very important.

*Contributions ~ Bill Gibson* shared his “adventure” to the DMV to get his real ID driver’s license. Words of experience – don’t wait to make your appointment. Take all the paperwork they say on their instruction sheet. If you want to have “Veteran” put onto your card, your DD214 won’t qualify. You have to have the plastic card from the VA, get it first.

Members sang happy birthday to **Jene Marcolina** who just turned (ya right) years old. We were happy to see both **Keith Marcolina** and her in attendance.



Our summary of 2018. Traditionally, we Ohio Buckeyes do not have a meeting in January. We never know what the weather will be like. Just a few years ago people were jogging in our Metroparks wearing shorts. This January of 2019 we shoveled snow. Over a foot of that white stuff fell in just 1 day and temps dropped below zero. Therefore, we spend the month by just hibernating and regrouping. Yes, some deserters go south.

January 1<sup>st</sup> of 2010, **Dolly Taucher** became president. The very first thing that was done was the filing for tax exemption status with IRS and the State of Ohio. We do not pay sales tax which saves 8% on expenses included monthly luncheons, newsletter printing, office supplies and other taxable purchases. As an example of the savings we have experienced, in 2009 our luncheons had hit the \$20 per person for salad, rolls, meal, dessert, beverage, and gratuity. Not until last year (2018) did we exceed the \$20, and that was for only 2 months. Our average cost for lunch was only \$17.55 in 2018. We do not

increase the cost. Our income comes mainly from "Dues" and "50/50".

In 2009 we had a total of 217 members. Since then a total of 54 members have passed away, and some of their spouses did not renew their membership. Also, some members moved, while others have serious health issues. But our membership count has stabilized because in the past 9 years we have added 115 new members. Our count for 2018 is a total of 220 members. We have never raised our membership dues. In fact, at our 2016 Christmas party we announced our "Christmas Present" for all members was that we were not collecting dues for 2017.

We go to restaurants with good food, service, and reasonable prices. Every year we have 2 special events:

1. August is our Annual Picnic. The usual attendance ranges from 90 to 114 with many coming from other states. In 2011 we did a huge upgrade to another location. Now we rent the entire "Chalet" and grounds located in Strongsville. We have the facility from 9am to 5pm. Members cost to attend is a "dish" for 8 to 10 people. We provide the chicken, coffee, bottled water, and just to make sure we do not run out of side dishes, we also include some potato salad, coleslaw, etc.
2. December is our "Christmas Party". The attendance ranges from 72 to 83. It is held at the Diamond Event Center where everything is great. We also raffle off "Christmas \$ envelopes" with at least half of the attendees being winners. Every year we have had a special guest. He wears "RED", has a white beard, but not a little round belly, and he is Not chubby and plump. But he is a United Retiree who puts a smile on everyone's face. We are hoping SantaPy will have time to stop in again this year.

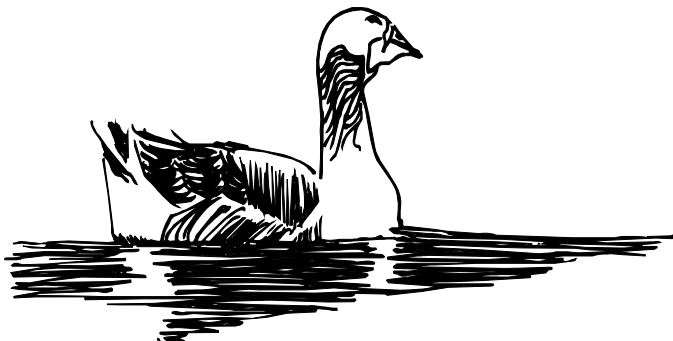

### UALers' Participation in Evacuation Tests.

*"We are extremely grateful to all the United employees, retired employees and members of their respective families who have taken part so willingly in this important series of tests. By their volunteer participation, at some risk of personal injury, they have made a real and vital contribution to the entire air transportation industry."* President William Keck.

That statement was given following a series of DC-8 emergency evacuation tests at Chicago on April 9, 1964. He was speaking not only of the 337 Chicago members who participated that day, but also of the several hundred San Francisco personnel who took part in the earlier demonstrations.

C.M. Mason, Senior Vice President-Personnel stated - *"804 employees, retired employees and some family members have taken part in various emergency evacuation demonstrations". "To assure a considerable degree of realism and thus make the tests more meaningful, none of these people were told exactly what would happen or what they would be expected to do." They were simply told they would participate in a simulated airplane trip, during which certain safety features would be evaluated."*

In the Chicago tests, representatives of the CAB, FAA, ALPA, Flight Safety Foundation, other airlines and the news media were invited. Four evacuations from a DC-8 were conducted in a hangar at O'Hare.

The two groups taking part approximated a total "mix" that were found on a typical United flight. Approximately 20% of each group represented adults 65 or older, children under 12 and handicapped persons. (Two dolls represented infants in arms). The adults in the remainder of the group were about 45% men and 35% women.
