United launched advance seat assignment option for Basic Economy customers



United continues to refine its Basic Economy product in order to address both customer and employee feedback, as well as make the product more competitive with other air-

lines. On February 2, the company rolled out new functionality that allows Basic Economy customers to purchase an advance, standard economy seat assignment up to 24 hours prior to departure. This will give Basic Economy customers, such as those traveling with small children, a simple way to ensure they sit together if they need to, while still purchasing a Basic Economy fare.

Here's how it works: Basic Economy customers will be able to access the standard economy seat map from time of purchase and up to 24 hours prior to their flight. If they wish to pre-assign their seat(s), they will be directed to pay the associated fee for the selected seat(s).

The option to purchase a seat assignment is not available within 24 hours of departure, and customers will receive their seat assignment either at check-in or at the departure gate, just as they did before.

Additional information has been sent to United's Customer Service and Customer Contact Center employees.

Basic Economy is United's fare option for its most price-sensitive customers. Along with standard economy, Economy Plus, and premium cabin options, Basic Economy gives customers more choice in their onboard experience. Since launching in April 2017, United has also seen some important operational benefits, including faster boarding times, fewer gate-checked bags, fewer flights with full overhead bins, fewer delays attributable to carry-on bags and increased customer satisfaction scores.

New Flying Together preview launches



Nearly all United employees visit Flying Together, whether it's to read company news, book travel or access the tools and information they need to do their jobs. The site gets hundreds of millions of views every year. And now Flying Together has been completely reimagined with the users in mind.

Flying Together is an important tool for many of United's employees, so the company wants to give its employees time to familiarize themselves with the new site during a soft-launch period. You make the new site your permanent landing page by clicking "switch to new site"; if you're not ready to commit to the switch, you can revert to the current site by visiting the same page.

United gathered extensive feedback to make sure this next generation of the intranet site gives you what you need most. The new Flying Together offers greater personalization and customization, so your homepage shows what's most relevant to you. It has more social features, like the @weareunited Twitter feed. And it's mobile-friendly, so you can easily use it on the go.

Top things to know about the new site:

- United expects to make new Flying Together permanent in the first quarter of 2018.
- The new site has the same look, feel and functionality on mobile devices as on a desktop or laptop, because United knows many of you are always on the go.
- Company departments can be found through the "Our Airline" tab. Important notifications, such as password alerts, will appear in the header.
- Your saved "Favorites" will not transfer over, the new Favorites allows you to add and organize all of your most important links in one location.
- You can import the tools you've saved on the current Flying Together or you can create a fresh list of tools.
- United has refreshed the News page.

United's planes are getting lighter



United is always looking for ways to fly its aircraft more efficiently and in a more eco-friendly way, and the company made some significant strides in 2017.

United began installing Split Scimitar winglets on 41 of its Boeing 757-200s. Winglets on this fleet type save approximately 30 gal-

lons of fuel per flight on average. United recently started printing Hemispheres on new paper that makes each magazine one ounce lighter. It may not sound like a lot, but that small change will save 170,000 gallons of fuel each year. That's a savings of \$290,000 at current fuel prices. United has done a similar paper weight-reduction project on its seatback service guide.

Earlier this year, United also removed its onboard duty-free products, which is leading to fuel savings of 1.4 million gallons per year and cost savings of more than \$2.3 million.

Catering Operations adjusted provisioning of several items, including reducing the amount of orange juice on certain flights, reducing soda and juice on flights to China and Japan, and reducing the number of wine arcs for the wine tasting service. These adjustments in addition to others resulted in a savings of more than \$673,000.

All together, these changes will result in nearly 30,000 fewer metric tons of carbon dioxide released into the air each year. That's equivalent to taking 6,400 cars off the road.

United revises its emotional support animal policy



As part of United's ongoing efforts to keep its employees and customers safe and better cared for, on February 1, the company announced changes to its emotional support animal policy. Starting

March 1, 2018, United will require customers traveling with an emotional support animal to provide additional documentation.

United has experienced a 75 percent year-over-year increase in customers traveling with their emotional support animals, and the number of reported incidents involving these animals has also increased. These changes align with United's core4 balance of protecting its employees and customers, while continuing to accommodate and care for customers with disabilities.

Based on the current policy, customers who travel with emotional support animals must provide 48 hours' notice to the Accessibility Desk and a letter from a licensed medical/mental health professional.

In addition to 48 hours' notice and an enhanced letter from a mental health professional, United will require customers traveling with an emotional support animal to provide the following:

- ✓ The customer must provide confirmation that the animal has been trained to behave properly in a public setting and acknowledge responsibility for the animal's behavior.
- ✓ The customer must also complete a health and

vaccination form signed by the animal's veterinarian. The veterinarian must also affirm that there is no reason to believe that the animal will pose a direct threat to the health and safety of others on the aircraft or cause a significant disruption in service.

- ✓ Customers who currently have approved documentation on file may use it for their next trip. Any additional reservations would be subject to the updated policy requirements effective March 1. Additionally, United has listened to one of its supervisor's recommendation to allow the authorization to be valid for a year once approved. United will continue to enforce this practice moving forward. The new forms will be available soon at united.com.

United's service animal policy, which covers animals that are individually trained to perform tasks for the benefit and safety of an individual with a disability in all public facilities, will remain the same.

United does not require any documentation or advance notice from passengers who travel with service animals (other than for foreign travel if required by national law).

Providing the best possible service to all customers ~ United will continue to support customers with disabilities including those traveling with emotional support animals through its 24/7 Accessibility Desk, which has been in place to provide service and care for nine years.

United will continue to support veterans in their travel needs and make every accommodation to ensure their experience with United is as comfortable and efficient as possible.

Animals prohibited from traveling in the cabin include hedgehogs, ferrets, insects, rodents, snakes, spiders, reptiles, sugar gliders, non-household birds, exotic animals and animals not properly cleaned or carrying a foul odor. United will update this list as needed.

United is implementing these changes in an effort to better protect its employees and customers while also accommodating United's customers including veterans with disabilities. The company is dedicated to providing convenient and comfortable service to all of its customers and employees. United knows that some customers require a service or emotional support animal to assist them through their journey, and United strives to provide the best possible service to everyone traveling.

Transforming the Smithsonian's 'America by Air'



United is partnering with an aviation landmark to re-make an exhibit for the next generation. With support from United and a group of other U.S. commercial airlines, the Smithsonian's National Air and Space Museum will transform its "America by Air" exhibit – which is one of the museum's main attractions – to better tell the incredible story of aviation history in the United States in a relevant and engaging manner. *"United is excited to partner with the Smithsonian Institution to make aviation come to life for the millions who visit the museum each year,"* said Community Affairs Managing Director Suzi Cabo. *"Our gift will assist in educating and inspiring aviation enthusiasts and future leaders of the industry, which aligns with United's commitment to the community."* Construction on the new exhibit space is expected to begin this summer and will take several years to complete. The "America by Air" exhibit features aircraft, including a Douglas DC-3 and a Ford 5-AT Tri-Motor, and artifacts such as uniforms, models and engines, and a gallery that traces the history of commercial aviation in the United States.

United and the other airlines are combining to contribute \$28 million toward the remodel.

All Smithsonian exhibits in the U.S. capital are free and open to the public. Plan a visit to the current "Air in America" exhibit before it closes for the transformation.

Torgy's Travel Tips – Important Notices

2018 has brought some new baggage and travel restrictions that all travelers, revenue and pass travelers alike, need to know. Here's the lowdown:

Smart Bags – In order to reduce the risk of fire onboard or in the cargo hold, luggage that uses lithium ion batteries to power a USB port built into the bag (to charge a phone or

track the bag, for example) will not be accepted for transport, either as checked or carry-on, *if the batteries cannot be removed*. If you intend to travel with such a bag as a carry-on, once you have proved that the batteries are removable, you may be allowed to keep the batteries intact, provided that you power them off. This provision applies only to a carry-on bag. All checked bags must have the lithium ion batteries removed.

Note: Several airlines as well as many Asian airports are even stricter than UA's policy. Please be very cautious if you are even thinking of purchasing/traveling with these new-fangled bags. And don't be swayed by luggage ads claiming "TSA Approved" as, to date, neither the TSA nor FAA has endorsed any smart bag as approved.

Hologram Stickers – Sport team merchandise and other memorabilia that contain hologram stickers (like those found on the underside of baseball cap bills) can trigger security sensors in checked baggage. Put such items into your carry-on bag to avoid having your checked bag opened and searched by the TSA.

Electronic Device Screening – Additional screening of electronic devices larger than a standard cell phone has begun on international flights inbound to the US. If the device has a case or outer packaging that requires a screwdriver or special tools to remove, you have to remove such cases before you come to the airport – no assistance or tools will be available for your use at the airport.

Cuba – No *independent* (people-to-people) travel to Cuba on UA is allowed. All travelers must be part of an authorized eligible category. For touristic purposes, you must be traveling with an authorized group that falls within the scope of a General or Specific License as defined by the Office of Foreign Assets Control of the US Dept. of Treasury. Further, US credit and debit cards do not work in Cuba. You are allowed to bring in USD cash (up to \$5000) but there is a 10% currency conversion fee. Lastly, non-US medical insurance is required but can be purchased upon arrival. See www.travel.state.gov for more info.

Airport Updates

BOS – Boston has no more UA curbside/skycap service.

CVG – Cincinnati's TSA checkpoints close promptly at 9PM, regardless if flights are delayed.

DFW – The nearest TSA pre-✓ line at Dallas/Ft Worth for UA departures is near gate E18, but UA uses gates E4-E9. Allow additional time to reach your UA gate when using this security line.

EWB – Be aware of which terminal your UA flight departs from in Newark, as the check-in counters are not located on the same level in each terminal. Terminal A check-in is found on the "upper level" whereas Terminal C check-in is located on level 2.

LGA – Lots of airport construction is causing detours on roads leading to the terminals and parking lots at LaGuardia in NYC. Allow more time than normal to reach the terminal.

United Clubs (Red Carpet Clubs of yore...) - Due to construction and/or conversion of clubs to support the new Polaris lounges, be aware that locations and capacity of existing clubs are changing. So for those of you

lucky enough to be a member, take significant note of the following:

SFO – There is no club at the international terminal in San Francisco. Instead, you will have to use the one on the mezzanine level in the domestic terminal, across from gate 71A (or the one way far down on Concourse F). Allow 10-15 min to walk from 71A to your departing international flight.

EWR – At Newark, there is a small “pop-up” location near gate C125 as well as the club near C74, but both have significantly limited seating until the Polaris lounge opens in mid-2018 near gate C120.

That’s all the news for this time around!

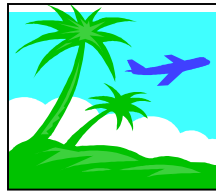

We meet every second Monday of each Month. Come and enjoy The Museum, if you have not attended.

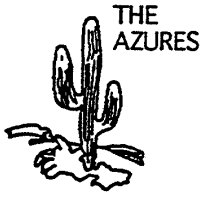

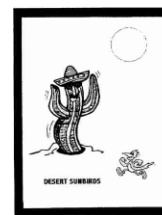

I worked a couple of odd jobs for a year, then four years with the Bank of America, leaving as an Assistant Operations Officer. I left because I had been hired by United Air Lines (Ticket Agent) at LAX.

In 1967, I was promoted to Senior Agent - the best job and the most enjoyable for me in my career with UAL. I remained in that position until 1974, when that category was discontinued. For one of those years, I did "Time Studies". I gathered statistics on anything that could be timed ... How long it took for a passenger to stand in line before he or she got to the Ticket Agent; from "Block" time to the first bag arriving in the Baggage Claiming Area, etc. I did the same studies at our chief competitors, Continental, Western, and American.

Backing up a bit - In 1964, while still working full time, I started back to school, at El Camino Junior College. Five years later (10 semesters) I got my degree; Associate in Arts. Then, transferring to Long Beach State, I continued pursuing my 4 year degree with another 5 years (10 semesters again). I finally graduated in 1974 with a Bachelor of Science in Business Administration from "now called" California State University, Long Beach.

I had been told that completing my education would greatly help my chances for promotion.

In October, 1975, I was advised I had been selected in a new Program - Friendship Director. It was to start in a couple months. But in early January, I was promoted to Supervisor in Passenger Service. My 10 years spent completing my education had paid off. But, long story short, I was not happy as a Supervisor, and, 6 months later, gave it up to go back to CSR, Customer Service Representative.

I transferred to Reservations in 1983. I had expressed an interest in working at the Ticket Offices and got my chance in the summer of 1984, with the Olympic Games in Los Angeles. I worked at the Beverly Hilton Ticket Office for a month - then back to Reservations - now in Apollo Services - and was on call to any Ticket Office for Vacation relief, sick calls, etc.

Then, in the Spring of 1986, Burbank opened. I thought, "This is perfect!" I lived 5 minutes away. I would finish my career not having to drive a 60 mile round trip every day. But it wasn't meant to be. Things did not go well in Burbank (whole other story some other time).

I transferred back to LAXCS in July of 1987 and finished my 28 year career December 1st. 1989, the last year in Baggage Service - a much better name than Lost & Found, don't you think?

Most of my years with UAL were happy and satisfied ones, and I sometimes wish that I had stayed longer and made it a 30+ year career. I've been retired longer than my 28 year career. But there are close to 20 of my former co-workers in the Desert Sunbirds, and we are all close, and enjoying retirement.

Sonda Sandstedt provided information regarding the new pass and enrolled friends travel information.

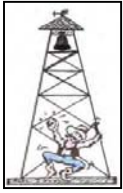
Francis Domaratius advised that you do not have to be a member of RUAEA to attend the Convention.

Sometimes a person may not have someone who is helping them with their finances/affairs, they can “forget” that they even have this account or policy. So, if you have any accounts that you just “let ride”, give a call or go into the bank and make sure that you keep all your accounts up to date. 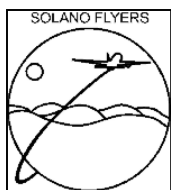
Dick Hooning won the 50/50 raffle and **Sharon Simonton** won the lunch certificate.

The RUAEA red label reminding me of owed dues is appreciated because I lose track of time more easily nowadays. I believe that's acceptable for an 86 yr. old.

2017 has been a medical year for me. It began in May with a crushed foot. It took June and July to recover enough to use a walking cane. In mid-August I needed eye surgery in my right eye. Healing took until October; then, surgery in my left eye in mid-October. This one seems to be healing slower but I'm thankful for no complications.

I hated missing the RUAEA Convention in LAS. My husband and I were married in LAS at St. James Catholic Church while we were both working for United Airlines. Chic had worked for Challenger Air Lines as

dispatcher in LAS before working for United in SLC. He still had good friends living in Vegas. One of those friends was best man at our wedding. They had served together in the Air Force during the Korean War. Chic had already served in the Navy. He joined right after his High School graduation. He served on a Destroyer, the USS Stribbling, in the Atlantic. When he came home to SLC he took classes at Westminster College and got a part time job with United Air Lines. He took flying lessons and got his private license. He joined the Air Force Reserve at Hill Air Force Base because he wanted to get a commercial flying license. Right after he got his commercial, the Korean War broke out and he went to Korea with his squadron. When he returned home to SLC, United Air Lines hired him back. 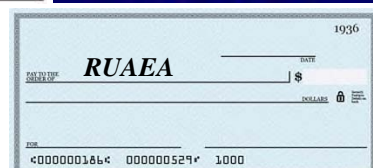

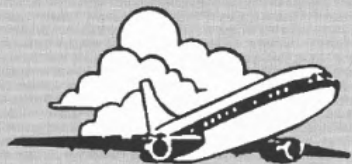

Milt Jines

Milton "Milt" Jines was born in Baton Rouge, Louisiana (The Pelican State) in 1934 and peacefully passed away November 17, 2017 in San Mateo, CA. He will be missed by a great many people. He wrote the "Skyclopedia" - "The Air Traveler's Guide to the Whole United States of America".

If you ever wondered how the pilot on your flight's P.A. system knew so much about the area below ... chances are he was reading from the Skyclopedia. This 307 page (plus a 49 page Index!) book required many hours of research.

In Milt's words: The Skyclopedia is intended for the serious skyway flight-seer who prefers getting some real-life stimulus from looking out the airplane windows ... it contains thousands of little factual tidbits of Geographical, Geological, Historical and Statistical information - and a goodly amount of just plain Inconsequentialia. - The Skyclopedia was issued in loose-leaf form for several reasons. It was certainly cheaper and also I didn't want to induce any hernias. You can carry the pages of the areas you need ... and leave the rest behind.

The following excerpts have been selected at random.

Tombstone, Arizona: "The town too tough to die." Tombstone is without a doubt the west's most remembered old mining camp, thanks to Hollywood and Tee-Veland's immortalization of the key figures of the famous gun battle (ambush?) at OK Corral which really happened.

Newspaperman John Clum came here from Tucson in 1880 to establish a newspaper in this "rough and ready" town. He decided every tombstone needed an Epitaph so that's the name the paper got. Folks here still sit down to breakfast and read their own Epitaphs.

Rayne, Louisiana (Pop. 1,611): Located approximately 15 miles west of Lafayette in rice-growing country. This is the "frog capital" of the world. Remember that frog you dissected in Biology-1? It probably came from Rayne where they have frog "farms" which ship to gourmet restaurants, biological supply houses, aquariums and schools. Every September a festive "Frog Festival" is held to honor the critters. "Rivet".

St. Helens (Mount) Washington: Beautiful symmetrical and snow-capped cone towering 9,677 feet tall. That was prior to Sunday, May 18, 1980. On that day, at exactly 8:32 A.M. (PDT) Mount St. Helens suddenly dropped from 5th to 30th among Washington mountains in height (to 8377 feet). The volcanic explosion, the first in the continental U.S. since 1914 (California's Lassen Peak), and the largest in recorded history in the lower 48 states, leveled every tree in a 150-square-mile region north of the peak, killing 62 people and a multitude of wild animals, and blew 1.3 billion cubic yards of debris more than 11 miles into the atmosphere.

Long Island, New York: So named because it is; 125 miles east from New York City, to Montauk Point State Park (Montauk is Indian for observation point). It covers 1,723 square miles and four counties: Kings (Brooklyn), Queens, Nassau and Suffolk. The first two are constituent parts of the Big Apple, so when a New Yorker refers to Long Island he is talking about Nassau and Suffolk, mostly bedroom communities for commuters. Don Rickles the "great" insulting (obnoxious) comic was born on Long Island. Yeah, right, who cares.
