## Denver Convention 2019 Updates

he August 24, 2019 deadline for registering at the convention hotel, Doubletree By Hilton Denver-Stapleton North, is coming soon. Please register now so you don't miss out on getting the convention rate and having a great vacation. The RUAEA June Newsletter contains all the information on the hotel, tours and meetings. For your convenience, the 2019 Denver Convention Registration Form is included on page 29 and 30 of this Newsletter.

When arriving at the Denver International Airport you will have 4 options to choose from

to get from the airport to the Double Tree Hotel Denver-Stapleton North; now that the hotel discontinued the shuttle service from/to the airport on April 22, 2016:

- 1. A-Line University of Colorado Train ~ By far the train is the best way to get to and from the airport as it is ~18 miles to the hotel and there are no worries about getting stuck in traffic, the train ride is only 23 minutes. Get off the train at the *Central Park Station*, which is stop number 4 from the airport. Call the hotel at (303) 321-6666. The hotel shuttle will be there to pick you up as the hotel is only .5 miles from the station. If you have any mobility issues, then order a wheelchair and they will take you from the airplane to baggage claim and to the train. Trains have wheelchair access and have luggage racks and overhead storage. An elevator is available to take you down to the trains. There is also a very steep escalator. Trains are located below the Westin Hotel and that is just outside of the United Terminal. Trains run every 15 minutes. The cost for the train is a discount for seniors of \$5.25 for an all day pass p/p. Once at the hotel, you can also take the hotel shuttle back to the *Central Park Station*, board the train to downtown and the 16<sup>th</sup> Street Mall on any day, for only \$3.00 for an all day pass.
- 2. Taxi cab for \$55+ depending on what company you use
- 3. <u>Uber or Lyft will cost between \$22-\$30</u>
- 4. <u>Super Shuttle</u> will cost about \$43 but United has a discount code to use (YUS68). This will save you about \$5.00 p/p or more

Once arrived at the hotel and you check-in, each room will get 2 free breakfast tickets for each morning. Breakfast is from 6 am to 10:30 am. Hotel shuttle will take you to the Central Park Station and anyplace within 1 mile radius from the hotel for shopping or local restaurants. RUAEA tours will have designated pickup areas.

#### Employee Travel team wishes you an epic summer



School is out for summer, and the travel season is in full swing! That means busy airports, long lines and full flights. We all want a seamless travel experience as we make our way to family, friends and vacation destinations. Here is our summer travel checklist to help you have a smoother trip and at the same time help out your fellow employees who are working during this busy time.

Our award-winning United app is your travel toolkit. You can check in, check flight status, view your position on the standby list; receive a mobile boarding pass and more, directly from your mobile device. Download the <u>United app</u> free before your next trip.

Before you decide what to wear on the plane, check out the <u>Pass Travel Attire policy</u>. Remind your pass riders, too. They represent you – and United – when they are pass traveling, so we expect them to follow the attire policy, whether you are traveling together or not. Explain to your pass riders how the <u>standby process</u> works and that they should contact you if they have questions.

Keep in mind that some of our more popular destinations like Honolulu, London and other European locations are in high season and may make pass travel a challenge. In addition, there are certain countries that may have different boarding process requirements than others – like Buenos Aires, where pass travelers have to be cleared at the check-in counter. These differences in process can be stressful for pass riders who are not aware. It is always a good idea to research your destination – including its airport and travel policies, before you go.

Make your travel planning easier by using the helpful tools in <u>employeeRES</u>: Open Search lets you check flights with the most seat availability to or from anywhere, and you can set up Flight Watch to send you notifications with boarding totals for up to 10 flight segments of your choice.

We have 122 interline ZED agreements that increase our global reach far beyond the United network. You can purchase your interline tickets online ahead of time. Check out our <u>other airline travel page</u> to learn about eligibility, ticketing and more.

Expect long lines at airport security, and make sure to get there early. At the security checkpoint, be patient and cooperate with security officials.

Be kind to your fellow pass riders and to employees who are handling the summer crowds. Remember that caring is always important, whether you are at work or on your way to a vacation destination!

#### **Good News of the Month**





**Wallace Wong** ~ I was recently invited to speak when the Asian American Arts Alliance held a program in honor of my sister, Jadin Wong and the 30<sup>th</sup> anniversary of the release of the documentary, "Forbidden City". Jadin was the first headliner at the renowned San Francisco nightclub, Forbidden City. I have previously written about her, and my own work with the Pan Asian Repertory Theatre, as well as my experiences with United Airlines at the SFO Maintenance Base.

At this time, when we are so aware of D-Day and the unsung heroes of World War II, I realize I did not share one of her World War II experiences. Jadin was a volunteer entertaining U.S. troops. While she was flying to join Bob Hope in a show, her plane experienced mechanical difficulties. She was forced to parachute from the plane and was found by a farmer dangling from a tree branch. Fortunately, he contacted military personnel who rescued her and took her for medical treatment for her injuries. Jadin joined Bob Hope that evening and, despite her injuries, performed without costumes or props to a standing ovation. Although she was well known and recognized for her professional achievements, this is one event that is not well known, but makes me feel very proud of her.

#### **So Simple From Sheryl**



Expecting company? Looking for something simple to prepare in advance for breakfast? I have just the recipe for you. Enjoy!

#### **Baked Cinnamon Apple French Toast:**

- ► 1 small loaf sliced French bead
- ➤ 2 eggs
- ➤ 1½ cups milk
- ➤ 2 teaspoons vanilla
- ➤ 3 large tart apples, peeled, cored and cut into thin slices
- ► ½ cup sugar
- ➤ 1 teaspoon ground cinnamon
- ➤ 1 tablespoon butter cut into small pieces

Lightly oil or spray with Pam a 13x9 baking dish. Arrange the bread on the bottom of the pan. In a bowl, whisk together eggs, milk and vanilla until smooth and well blended. Pour over the bread mixture (this dish can be prepared in advance to this point. Cover and refrigerate for several hours or overnight).

Preheat oven to 400 degrees. Arrange the apple slices on top of the bread. Combine the sugar and cinnamon and sprinkle on top of apple slices. Dot evenly with butter. Bake for 35 minutes or until the apples are soft and the custard has set. Let cool for 5-10 minutes before serving. Serve with syrup.

Their Tondelayo never saw combat. The original "Tondelayo" was used in the Pacific, but not in the Doolittle raid, and crashed during the war. Also, the Doolittle raid was essentially a one way mission. 15 of the 16 aircraft crashed or ditched in the ocean. One made it to Russia. None of the aircraft have been recovered.

I hope that others in "RUAEA Land" are able to see this when it's in their area ... and take your children and grandchildren! It started in May in CA and will end in October in SC, with shows in WA, MT, WY, CO, NE, IL, IN, OH, PA, NJ, MA, NH, MD and SC. 

### United Airlines Historical Foundation

"Preserving the Past, Inspiring the Future"

aul Goodyear has worked as an Aircraft Technician for United Airlines at Denver International Airport for nearly 35 years, inspecting planes daily to ensure they are safe to fly. While some mechanics joke that there is "Oil in their Blood", the Goodyear family might as well have Jet Fuel in theirs. "I got into this because it's my family heritage", Paul said, after finishing his inspection of a landing gear. That's when Paul's father, Thomas Goodyear, stepped out from behind one of the 787's massive engines. "Come on, Papa", Paul said to his dad. Tom Goodyear spent 40 years working at United as a Zone Controller, responsible for Ramp Operations. "I'm only 84", Tom said.

A few days before this past Father's Day, Paul walked around the United hangar with his dad, showing-off a new Boeing 787 Dreamliner and all its new



ing-off a new Boeing 787 Dreamliner and all its new Bells and Whistles. "They can do so much more up here than when I was working", Tom said, sitting in the cockpit of the new airplane.

Showing-off new and impressive airplanes runs in the family. "This is my father", Tom said, pointing to an old black & white photo, "this is me in his arms and we're looking at a DC-3 in Chicago."

The photo was taken in the 1930s at Midway Airport. Tom's father, **Merl Goodyear**, spent an additional three decades working for United as a Chief Mechanic. "He started in 1928, 91 years ago with United", Paul explained about his Grandfather. Those three Generations have worked a combined 105 years, all for one airline.

"Every year since 1928 there has been a Goodyear family member working for United Airlines", Paul said.

So will there be a fourth Generation? Paul has a 17-year-old son. I would love to have him continue on, but his son is currently leaning towards becoming a Diesel Mechanic. "Millennials", Paul joked.

Paul is now the only Goodyear still employed by the airline. He said, "I'll be spending Father's Day here at the airport, it's very fitting for me to be where my Father & Grandfather were on Father's Day".
