<u>United Invests Another \$15 Million in</u> <u>Electric Flying Taxi Market with Eve</u> September 8, 2022



United today announced a \$15 million investment in Eve Air Mobility and a conditional purchase agreement for 200 four-seat electric aircraft plus 200 options, expecting the first deliveries as early as

2026. This marks another significant investment from United in flying taxis – or eVTOLs (electric Vertical Take-Off and Landing vehicle) – that have the potential to revolutionize the commuter experience in cities around the world.

Under the terms of the agreement, the companies intend to work on future projects, including studies on the development, use and application of Eve's aircraft and the urban air mobility (UAM) ecosystem.

"United has made early investments in several cutting-edge technologies at all levels of the supply chain, staking out our position as a leader in aviation sustainability and innovation," said Michael Leskinen, President of United Airlines Ventures. "Today, United is making history again, by becoming the first major airline to publicly invest in two eVTOL companies. Our agreement with Eve highlights our confidence in the urban air mobility market and serves as another important benchmark toward our goal of net zero carbon emissions by 2050 — without using traditional offsets. Together, we believe our suite of clean energy technologies will revolutionize air travel as we know it and serve as the catalyst for the aviation industry to move toward a sustainable future."

"United's investment in Eve reinforces the trust in our products and services and strengthens our position in the North American market," said Andre Stein, co-CEO of Eve. "I am confident that our UAM agnostic solutions, coupled with the global know-how we have been developing at Eve and Embraer's heritage, are the best fit for this initiative, giving United's customers a quick, economical and sustainable way to get to its hub airports and commute in dense urban environments. It is an unparalleled opportunity to work with United to advance the US UAM ecosystem, and we look forward to it."

United was the first major U.S. airline to create a corporate venture fund, United Airlines Ventures (UAV), designed to support the company's 100% green commitment to reach net zero emissions by 2050 without the use of traditional offsets. Through UAV, United has led the industry in investments in eVTOL and electric aircraft, hydrogen fuel cell engines, and sustainable

aviation fuel. Last month, United gave a \$10 million deposit to a California-based eVTOL company for 100 aircraft.

United's investment in Eve was driven in part by confidence in the potential growth opportunities in the UAM market and Eve's unique relationship with Embraer, a trusted aircraft manufacturer with a proven track record of building and certifying aircraft over the company's 53-year history. Critically, their relationship includes access to Embraer's service centers, parts warehouses and field service technicians, paving the way for a reliable operation. Upon entry into service, United could have its entire eVTOL fleet serviced by Eve's agnostic service and support operations. Moreover, United joins the consortium led by Eve, which will simulate UAM operations in Chicago from September 12th.

Rather than relying on traditional combustion engines, eVTOL aircraft are designed to use electric motors, providing carbon-free flights and to be used as 'air taxis' in urban markets. Eve's design uses conventional fixed wings, rotors and pushers, giving it a practical and intuitive lift-plus-cruise design, which favors safety, efficiency, reliability and certifiability. With a range of 60 miles (100 km), its vehicle has the potential not only to offer a sustainable commute but also to reduce noise levels by 90 percent compared to current conventional aircraft. Eve is also creating a new air traffic management solution designed for the UAM industry to scale safely. This software is intended to perform at the same safety level as Embraer's existing air traffic management software and expected to be a strategic asset to helping the entire industry grow.

United to Launch New Platforms for Corporate Customers to Fully Customize and Manage Business Travel Programs August 11, 2022



United today announces a new platform that will allow corporate customers to fully customize their business travel program contracts with the airline. This could in-

clude higher status in United's loyalty programs including United Corporate Preferred, the airline's loyalty program for corporate customers; options to make working while traveling easier, including reserving more spacious seats in Economy Plus® and wi-fi access; and incentives like discounts on leisure travel for employees.

In an innovative shift from discounted airfare being the only option available during the contracting process, customers will now be able to work with a United sales representative to choose from the airline's extensive product catalog to design a program that best fits their business travel needs. With the additional ability to customize these options down to individual flights, travelers and destinations, United is set to be the first airline to offer this level of customization in the contracting process through its new platform, United for Business Blueprint, which is scheduled to launch in late 2022.

"The needs of our customers are changing, and it's the right time to move beyond the one-size-fits-all contracting model that has become standard across the industry," said Doreen Burse, senior vice president of worldwide sales for United. "United has a best-in-class suite of benefits and services and our customers deserve the opportunity to take advantage of the offerings they value most. The voice of our customers played an essential role in how this new platform was built, and will continue to shape how it evolves in the future."

In addition to launching United for Business Blueprint, United will begin rolling out a new website in late 2022 that will make it easier for companies who book business travel on united.com or the United app to enroll in and manage their travel program. The site will have one of the most intuitive sign-up processes in the industry. With just a few clicks, customers can register with United for Business, browse programs and enroll in an option that best meets their business travel needs. Customers will gain access to a variety of new capabilities, including the ability to easily rebook and exchange travel and view and use future flight credits. Customers will also be able to view reports on travel activity based on money spent or trips taken, with the option to filter based by date of travel, origin, destination and more. New customizable booking and payment settings will also give travel administrators more choice in the payment options and spending guidelines they set for their travelers. The site was designed with small businesses in mind but will also bring great value to larger organizations that book their business travel through united.com or the United app.

From the first day I started at LGA, to the day I left, maintenance ran a coffee club. It consisted of a rented machine that would brew a pot, and keep 2 pots hot. It was run by "Big Jim", a no-nonsense get the job done, lead. Filters, coffee, and cups were delivered to the hangar. Midnights were a fairly quiet operation. Working afternoons, it became a busy operation. Pilots and

Flight Attendants on through trips, ground personnel, including Pan Am, and Air Canada were all welcome guests. Coffee was constantly brewed, pots washed and the area constantly cleaned. If not, you got the look from "Big Jim". Then "I got it". Over time it escalated into bringing in donuts, bagels, and Kaiser rolls. Different items on different days, along with butter and cream cheese, maybe some jelly. Milk was the hard part. One day we ran out and went to a vendor upstairs to buy a half gallon. Not at that price, no thanks. One day we had to shut down. After "Big Jim's" retirement, I took a leading role with a few other mechanics in the operation.

The milk was a daily delivery, if it was your Friday, you brought in 2 milks. There was always someone who would forget. This was a day we could not make it through. Executive meeting, we have to go to "scrounge mode".

First thing, milk is always hard to find on an arriving trip; always nothing or a couple. After a couple of attempts and no milk found, we had to shut down. Now, to put this in perspective, you need a clear shot from the jet way stairs to the break room to not meet any supervisors. The white plastic bag was always a dead giveaway. I scored on a trip and brought it down the stairs, got a "thumbs up" from my partner and put it in the fridge. The operation up and running, the maintenance supervisor comes in for a coffee. He asks "who sells the milk in the small containers?" "I had to stop in Queens at a small convenience store because I forgot"; like he didn't know.



After all this hard work, there was an occasional reward. There was a tool warehouse, in Farmingdale,

NY that sold me tools at wholesale prices. One tool we used all day, every day, was an Xcelite reversible screwdriver. When we had enough money in "the bank", I would ask \$5.00 payout for a new screwdriver. A new screwdriver always won. They would have the tips worn out and the handle melted from hydraulic fluid, so a new screwdriver was always received well. I've included a picture of a new screwdriver and my first screwdriver, modified of course.

A plastic tray for the money, everybody paid, and if it got busy, someone would make coffee; a great bunch of people who would always help out.

The money was always piled up and not touched. Holiday was, no money tray, free all day, including, bagels, donuts, and Kaiser rolls. A great social event and worth all the work!

So Simple From Sheryl



Broccoli and Cauliflower Salad:

This recipe is a fairly new recipe for me, but everyone has enjoyed the recipe when I have made it for family or an event. It has a wonderful "crunch" and each crisp ingredient adds to that delight. I believe that the secret is making the dressing a day

ahead of time to allow the flavors to blend.

2 cups mayonnaise

½ cup sugar

1/3 cup grated Parmesan cheese

2 tablespoons vinegar

2 tablespoons finely chopped onion

½ cup dried cranberries (or you may use raisins)

1 bunch broccoli, cut into florets

1 small head cauliflower, cut into florets

1 can (8 ounces) sliced water chestnuts, drained

½ pound bacon, cooked and crumbled

2/3 cup slivered toasted almonds

In a small bowl, combine mayonnaise, sugar, Parmesan cheese, vinegar, onion and cranberries.

Refrigerate several hours or overnight. Just before serving, combine broccoli, cauliflower, water chestnuts, bacon and almonds in a large bowl. Pour dressing over and toss to coat. Serves 8-10.■



Happy October and happy Halloween from the East Bay Diablos group! As I write this on September 7, I cannot believe that three-fourths of 2022 is almost over with.

As of early September, my area continues to have a fair number of Covid cases and hospitalizations. Although the latest variant is not as deadly, it is much more contagious, and people at high risk - like us - are still getting sick enough to be hospitalized. I am sorry if I sound like a broken record over this, but I want people to be careful, no matter how tired they may be of taking precautions to stay safe. My therapy dog and I visit the local hospital every Thursday. We visit two med-surg units and about 25-33% of the rooms are Isolation due to Covid.

Our group is now holding in person monthly meetings on the first Monday of the month all year long. The restaurants are still dealing with staff shortages, so we have to give them a count beforehand for our meetings. Our September meeting, due to be held on Labor Day at the Old Spaghetti Factory in Concord, was canceled due to the excessive heat wave all over the West Coast. When the authorities are urging people to stay inside and drink lots of water, or go to a cooling center if they don't have air conditioning, it did not make sense for us to risk our health to go to lunch. As I write this on September 7, I am chasing down our members to see if they still want to meet on September 12 or 19.

I hope you all enjoyed last month's story about the lost sea turtle hatchlings in Miami being rescued from a hotel pool by sheriff's deputies and rerouted to the ocean with flashlights showing the way. This month's feel good story about baby animals features Fritz the baby hippo born at the Cincinnati Zoo: The Cincinnati Zoo welcomes a baby hippo! Zoo staff discovered Bibi the hippo was pregnant around April Fool's Day. It came as a surprise because Bibi was on birth control. She gave birth to a full term calf on August 3. The calf has an older sister named Fiona, who became an international celebrity after being born six weeks premature in 2017. Fiona has been the Cincinnati Zoo's star animal ever since. Fiona only weighed 29 pounds when she was born and wasn't able to stand on her own. She now weighs 2,000 pounds.

As is usually the case, the zoo asked the public for help naming the baby. The birth gained worldwide excitement and the zoo received 90,000 name submissions from people in every state in the U.S. and more than 60 countries around the world.

It took zookeepers until August 8 to determine that the newborn was a male. The hippo team narrowed down the 90,000 possible names to Fritz or Ferguson. The zoo then conducted a poll. More than 200,000 votes were received and Fritz won with 56% of the votes cast. The hippo keepers love the name and think it's fitting since Bibi's birth control was obviously on the fritz, and it goes well with Fiona. As of August 15, Fritz still wasn't visible to the public, but zoo members have access to cameras in the outdoor habitat and can monitor the Hippo Cove live from 8:30 a.m. 5:30 p.m.

Therapy animals at San Jose and San Francisco airports: Many of you already know that SJC was the first airport in the U. S. to start a therapy dog program. The South Bay airport started its program immediately after the tragedies of 9/11, when the airport's interfaith chaplain volunteer, Kathryn Liebschutz, recognized that getting people back on planes was going to be problematic - perhaps forever. Liebschutz owned a trained therapy dog named Orion, and she asked permission to bring the boxer-Great Dane mix into the airport to help alleviate travelers' anxieties. Orion was an immediate hit with passengers and employees alike, and the airport animal therapy program was born. Today, SJC has 25 active therapy dogs and two therapy cats. The dogs are certified with Alliance of Therapy Dogs, a national therapy dog organization with over 15,000 teams. SFO's Wag Brigade was started in late 2013, inspired by the therapy animals at San Jose International. The animals undergo an almost year-long training program through the San Francisco SPCA to become certified therapy animals. Their only goal is to ease tensions, put smiles on faces and delight children. The menagerie includes a tutu-obsessed pig named LiLou, an assortment of large and small dogs, a cat named Duke and a 32-pound Flemish Giant rabbit named Alex who travels in a custom remote-controlled car. 

Deaths which occurred on August 31: 1057 Leofric husband of Lady Godiva, dies, 1688 John Bunyan preacher/novelist/author of Pilgrim's Progress, dies. Bunyan an English Puritan clergyman and writer John Bunyan was 69. Imprisoned several times between 1660 and 1672, Bunyan used these periods of isolation to pen his two literary masterpieces, Grace Abounding to the Chief of Sinners (1666) and Pilgrim's Progress (1678), 1888 Mary Ann Nicholls a 42-year-old prostitute, was found stabbed to death in London, 1st of at least five murders by Jack the 1964 Rocky Marciano former heavyweight champ, dies in a plane crash. On August 31, 1969 (the day before his 46th birthday), Marciano was a passenger in a small private plane, a Cessna 172 heading to Des Moines, Iowa. It was night and bad weather had set in. The pilot, Glenn Belz, had 231 total hours of flying time, 35 of them at night, and had no instrument rating. Belz tried to land the plane at a small airfield outside Newton, Iowa but the aircraft hit a tree two miles short of the runway. Flying with Marciano in the back seat was Frankie Farrell, 28, the oldest son of organized crime figure Lew Farrell. Marciano, Belz and Farrell were killed on impact, 1997 Princess Diana In the early hours of 31 August 1997, Diana, Princess of Wales, died from the injuries she sustained in a car crash in the Pont de l'Alma tunnel in Paris, France. Dodi Fayed, Diana's partner, and Henri Paul, the driver of the Mercedes-Benz W140 S-Class, were pronounced dead at the scene.

On this day in History: 1887 Thomas A. Edison patents Kinetoscope, (produces moving pictures), 1894 Phillies Billy Hamilton steals 7 bases, 1895 1st pro football game (QB John Brallier paid \$10 & won 12-0), 1919 Communist Labor Party of America formed in Chicago, 1934

1st football All-Star game - Bears tie collegians 0-0 in Chicago, 1941 Great Gildersleeve, a spin-off of Fibber McGee & Molly debuts on NBC, 1955 1st microwave TV station operated (Lufkin, TX, 1955 1st sun-powered automobile demonstrated, Chicago, IL. The first solar car invented was a tiny 15-inch vehicle created by William G. Cobb of General Motors. Called the Sunmobile, Cobb showcased the first solar car at the Chicago Powerama convention on August 31, 1955. The solar car was made up 12 selenium photovoltaic cells and a small Pooley electric motor turning a pulley which in turn rotated the rear wheel shaft. The first solar car in history was obviously too small to drive, 1962 Trinidad & Tobago gain independence from Britain, 1971 Dave Scott becomes 1st person to drive a car on the Moon, 1978 Symbionese Liberation Army founders William & Emily Harris plead guilty to 1974 kidnapping of newspaper heiress Patricia Hearst, 1986 Aeromexico jet & a Piper PA-28-181 Cherokee collided and crashed into the Los Angeles suburb of Cerritos, killing all 64 on the DC-9, all three on the Piper and an additional 15 on the ground. Eight on the ground also sustained minor injuries.







United Airlines has finished reinstalling an Iconic Brand Symbol on the United hangar at O'Hare International Airport at the newly-constructed Ground Equipment Storage and Maintenance facility overlooking the runway network at O'Hare. For decades, the familiar red-logo sign was a hugely visible symbol of Chicago-based United's rich heritage to millions of passengers flying into and out of O'Hare, and to the carrier's tens of thousands of employees. It was easily visible by day and brightly lit at night.

Its removal was necessary because that hangar had to be torn down to make way for a new runway at O'Hare. Since that time, United employees have been painstakingly restoring each of the letters that spell out "United" on the sign.
