Farewell UAL Boeing 747 Final Flight by Mary Jane Stewart

What a thrill it was to be part of the Farewell to the Boeing 747 flight on November 7th from SFO to HNL. At the September RUAEA Convention in LAS there was a lot of buzz about the upcoming flight and how it had sold out within 2 hours. My best friend, **Wilda Squires**, decided to write a letter to CEO, Oscar Munoz, sharing some of her experiences and photos from when she served as an instructor for the initial inflight crews on the newly delivered B747.

Much to her shock, Wilda received a personal phone call from Mr. Munoz inviting her and me to be his guests on the flight. The conversation was videotaped from both ends and is available on Twitter and Facebook. Check it out; it is worth seeing.

The event had a 1970's retro theme with many long forgotten outfits and uniforms. Everyone was so excited to be there and to share their piece of history. The boarding area was one big party with photo ops, a huge signature card and, of course, dignitaries and speeches.

The first person to board was the Mileage Plus Member with over 18 million miles. We met the gentleman who was seated in 1A who, when asked how he managed to be first, told us he was a journalist who was tipped off to the booking schedule. The media was there in full force and Wilda was interviewed by several of them.

Naturally we were all anxious to board. As we departed, there was a planned ground stop, so as we taxied out, all of the other aircraft seemed to defer in salute to the "Queen of the Skies" as she passed by. We could see the ground crews waving and taking group pictures. Even the American Airlines employees came out to salute our passing.

As we took off, the passenger next to me said it looked like we were going a little off course and must be flying over the city. Sure enough, we were soon tipping our right wing to the city of San Francisco and, shortly thereafter, tipping the left wing to the Golden Gate Bridge.

Then the party resumed and it was the quickest five hour flight I have ever experienced. A couple got engaged a few rows behind us. Another passenger was celebrating his 50th birthday, proudly wearing a T-shirt proclaiming the milestone. The aisles were filled with passengers eager to share their stories and memories. The Half Way Game was played with the winner accurately guessing the time within 1 second.

We arrived at Honolulu Airport to a wonderful greeting of flower leis and Hawaiian music. But we were not the only ones to receive the traditional flower lei. Our aircraft, truly the "Queen of the Skies", received her own lei as a final tribute. I now have enough memories to last a lifetime.

United offers new ways to check in



On December 5, United announced an exciting new partnership with tech innovators Google and Fitbit. Customers will now be able to access flight information and other amenities through Google Assistant on their phone or Google Home as well as the Fitbit Ionic™ smartwatch, making United the first airline

to give customers the tech-savvy options. United already allows the same features on Amazon's Alexa-enabled devices, which the company announced in September.

The new United app on the Google Assistant lets customers use smart speakers like Google Home, and eligible Android and iPhone devices, to stay up to date on their flights. Once customers have linked their MileagePlus accounts to Google Assistant, users can say "talk to United" to hear their flight status, check amenities and check in for their upcoming flights. The new app also allows Google Assistant users to check their MileagePlus account balances, hear their last account activity, check in for their United domestic U.S. flights and hear flight information. Users of Fitbit's Ionic smartwatch will be able to access the United app – the only airline app available on its AppGallery – to receive flight status information and their boarding passes right on their watches.

"Consumers around the world use smart devices every day to conveniently complete a variety of different tasks," said Digital Products and Analytics VP Praveen Sharma. *"Adding a United app to the Google Assistant and Fitbit Ionic allows us to meet our customers on devices they already know and love, while making it easier than ever to check flight status, check in, learn about MileagePlus account details and receive their boarding passes."*

To access all of these new options, customers will need to link their MileagePlus accounts to their devices.



App updates make managing travel on the go even easier



In October, United debuted two more enhancements to the United mobile app designed to give customers more power and convenience in the palms of their hands when traveling.

First, customers and employees can now change segments and cancel flights for paid tickets from within the app in many cases. As this new feature debuts, certain reservations, such as those purchased through third parties, will continue to united.com to allow changes. Support for more reservation options to be completed in the app will continue to expand in the coming weeks.

Second, you can now store your MileagePlus and United Club membership cards via Apple Wallet.

These changes come on the heels of two other well-received app upgrades: The addition of bag tracking functionality and the ability to access boarding passes for 19 of United's Star Alliance partner carriers.

"Every day, 800,000 customers rely on our mobile app to book reservations, view flight statuses, check in and access a variety of other handy travel tools," said Chief Digital Officer Linda Jojo. *"We're constantly making updates to the app that help our customers manage their travel with us at the touch of a finger and access even more information about their flights as quickly and conveniently as possible."*

TSA rolls out enhanced screening at additional U.S. airports



To ensure the security of airline passengers and the nation's airports, the TSA is implementing new, stronger screening procedures for carry-on items that require travelers to place all elec-

tronics larger than a cell phone in bins for X-ray screening in standard lanes. TSA plans to expand these measures, as part of a program announced in July, to all U.S. airports during the weeks and months ahead. This change does not impact the current Known Crew Member (KCM) or TSA Pre✓® process.

The first Fantasy Flight of 2017 departed Friday, December 1 at PHX (Phoenix). It's a United tradition that gets bigger and better with every coming year. This year, 13 hubs and line stations will be participating, in-

holiday season.

United's women in tech inspire young girls at ChickTech conference



According to a 2016 study by the National Center for Women & Information Technology (NCWIT), only 25 percent of computing-related jobs in the U.S. are held by women. But who says women can't succeed in the tech industry? ChickTech, a

national organization dedicated to retaining women in the technology workforce and increasing the number of girls pursuing technology-based careers, is tackling that fallacy.



On November 18, five of United's very own women in tech, Enterprise Quality and Release Management Managing Director Silvia Prickel, Business Architecture Senior

Manager Diana Krohn, IT Security Intelligence Director Becky Selzer, IT System Principal Engineer Suzan Liu and IT Security Intelligence Intern Sriya Potham, helped ChickTech in its mission to provide supplemental tech education not offered in high schools.

Through uIMPACT, ChickTech invited Silvia, Diana, Becky, Suzan and Sriya to teach a workshop at the ChickTech Chicago Kick-off Conference, where nearly 70 high school girls who are interested in pursuing STEM (science, technology, engineering and math) careers, participated in hands-on STEM workshops led by industry professionals.

"I jumped on the opportunity to participate because it's a small way to give back and help other young, up-and-coming women succeed in their careers and in life," said Silvia. "If I can make a positive impact on just one young person, then my mission is a success. If we all focus on just helping one person, imagine how many lives we can touch!"

The United team hosted its workshop, "Encryption in Web Development," during which the students learned to create an aviation-themed website and adapt it for mobile and desktop viewing while using encryption to ensure security.

The team also provided an overview of STEM career opportunities at United and guidance about various STEM career paths.

For Suzan, the decision to volunteer at the event was a no-brainer because she herself attended a similar conference in high school that led her to pursue an engineering degree in college. In fact, the woman who presented at the conference Suzan attended in high school later hired Suzan when she graduated.

"I know just how life-changing something like this can be to someone making her first true, big decision," said Suzan. "It was an honor to work with this group of bright young ladies, and I look forward to witnessing their future accomplishments."

Aircraft Recovery team's credo: 'Do no harm'

Twenty-four members of United's Aircraft Recovery Team underwent three days of intensive training at IAH earlier this month and they practiced skills the company hopes are never required - safely removing a disabled aircraft that is blocking a runway, taxiway or ramp at an airport United serves.

The team members gathered for a day of classroom training followed by two intense days of field exercises on a remote corner of the airfield. The subject aircraft, a T-43A (modified Boeing 737-200) belongs to the Houston Police Department and is used for various drills and exercises at the airport.

Principal Line Support Engineer and Aircraft Recovery Team Leader Marc Felice said team members came from all seven hubs as well as CLE, GUM, HNL (Honolulu) and MCO (Orlando, Florida) to join others already trained in stations ranging from GRU (São Paulo) and LHR (London Heathrow) to SYD (Sydney).

Working alongside local employees and business partners, they are on call 24/7 as part of the United Emergency Response Team to handle towing, jacking and lifting aircraft that have become immobilized for various reasons – from failed supports or landing gear to slides off runways or taxiways. The complex recovery kits are kept in six locations – HNL, IAD, IAH, MCO, ORD and SFO – so are never more than a few hours away from a recovery scene.

At the IAH exercise, the teams became familiar with the various components of the recovery kit, which is treated as non-calibrated tooling, and they practiced towing an off-pavement aircraft using an emergency towing kit. These are used in situations where a conventional tow tractor or recovery vehicle is not practical.

In a simulation of a plane that landed with the nose landing gear not extended, they raised the T-43A's forward fuselage with a sling lift and a crane, then inflated a set of airbags underneath to support it until a trolley could be moved into place to enable moving the plane.

On the second day, they performed a full lift of the entire aircraft, using sets of airbags underneath both wings and the fuselage. It's not as simple as it sounds.

"The reason we have so many hoses going to so many airbags is that we have strict pressure limits for the fuselage and wing skin contact areas and thus need to control the pressure going into each compartment of the airbag so the plane lifts evenly and safely," Marc explained. "Our first priority in any recovery is – Do no harm," Marc said. "First of all, the recovery needs to be done safely for all the people involved," Marc said. "Also, while we need to work quickly, we need to take every step to make sure we don't cause any secondary damage to the aircraft. Third, we need to work quickly – incidents that require recovery are extremely costly for the aircraft operator and for the airfield."

Twice this year, United's team has responded to incidents that fortunately were relatively minor. An axle collapsed on an Airbus A320 in EWR, and with the support of a local vendor United moved it from the gate to a hangar. In IAH, a wing jack failed under a Boeing 737-800 that was in for maintenance. The team used recovery airbags to free the failed jack and replace it with an operational one. Also, this year in HNL, local team member supported Line Maintenance when a Boeing 737-900 had a tire and wheel failure during taxi.

In addition to United's own recovery teams and kits, United is a member of the International Airlines Technical Pool (IATP) cooperative, which has 12 kits and "go" teams stationed around the world. United is the designated responder in HNL and conduct annual exercises as part of the IATP commitment. Coincidentally, while United was conducting its IAH training, a number of United's Brazil-based employees took part in an annual IATP exercise in GIG (Rio de Janeiro) held by region

recovery provider LATAM Airlines Brasil (JJ). Their kit is based in GRU; and GRU Aircraft Maintenance Manager Jose Lisboa said United's participants got invaluable experience in not only the recovery exercise itself, but also in the logistics of transporting a kit and using it in a different location.

UNITE hosts first-ever African American Networking Seminar



On October 26, UNITE, United's multi-cultural business resource group, hosted its first-ever African American Networking and Professional Development Event at the Chicago Corporate Center in Chicago. More than 150 participants, including employees from CSC, Contact Centers and Tech Ops, got a chance to hear from a panel of African American leaders across various functions at United about career advice, challenges in the workplace and how to successfully move ahead in the company. *"Working as a remote agent in the Contact Centers means that your primary form of communication within United is email and WebEx,"* said Remote Reservations Agent Anthony Vales. *"Attending UNITE's event presented me an opportunity to speak with fellow African-American colleagues and leaders in person about career development."*

Attendees also got an unexpected surprise visit from Oscar, who stopped by the event and candidly discussed diversity at United. He also took the time to answer some questions from employees, which ranged from the NAACP's recent warning about travel on American Airlines to tuition reimbursement for employees and how he stays grounded amidst the challenges of his job.

"Oscar spoke passionately to the group, not as United's chief executive, but as an encouraging elder brother or close family member," said Anthony.

Like Anthony, ORD Flight Attendant Angelique Reddick and Flight Experience Analyst Lindsay Jungers left the event feeling empowered, excited about the future of United and appreciative of an event that allowed them to network with colleagues. *"It was a great event, and I'm glad we're able to have those types of conversations at United,"* said Lindsay.



Call the 50th anniversary chrome for the Plating Shop



The October 1967 issue of *Products Finishing*, a trade magazine for the metal products finishing industry, featured United's then-brand new Plating Shop on the cover and a 16-page feature article. Engine Overhaul and Repair Senior Supervisor Andy Simonetti with the fish tank that contains waste discharge water from the Plating Shop, a testament to the quality of United's water treatment program.



In October 1967, the United Maintenance Base at SFO opened a metal finishing department so modern that the leading industry publication *Products Finishing* devoted the cover and a 16-page feature article to the facility. The article gushed: *"Built for aircraft maintenance plating, this new plating installation has some pointers for everyone; freedom from overhead obstructions, an 'integrated' waste treatment system that discharges 'drinking' water, and all accessory equipment tucked away in a separate area, to name a few."*

Other media marveled at the goldfish tank fed by treated waste water. The Plating Shop recycles thousands of gallons of water a day, and the many chemicals, metals and other impurities are removed and meet drinking water standards before the water goes into San Francisco Bay – except for the amount that is diverted to the fish tank, which is still in place.

Engine Overhaul and Repair Senior Supervisor Andreino "Andy" Simonetti has been associated with the shop for more than 40 of its 50 years, and pointed out that it was, indeed, state of the art when it opened in 1967 and continues to provide United with a high-quality and environmentally sound method of treating metals for engines, landing gear and other components.

"It was very far-sighted of United to build this shop when they did," Andy noted. *"Back then, we would send the piece parts out to a metal finishing shop on the [San Francisco] peninsula, but now if we didn't have the Plating Shop here, we would have to send a huge volume of work out."*

Engine Overhaul and Repair hosted a lunch for more than 100 employees from the Plating Shop and related departments November 2 and held similar events on the other shifts to thank employees who work in the little-known but essential machining and remanufacturing departments of the huge Engine Shop.

Plating and related processes are essential when working with aircraft parts; in many cases they are coated with chrome and similar metal plating to replace coatings that have worn off or corroded. Coatings improve longevity and resistance to corrosion.

United attains top-tier performance amid GDP challenges



Despite having a higher percentage of arrivals impacted by FAA-mandated ground delay programs (GDPs) than any of United's primary competitors, United is firmly positioned in the top tier in

mainline D :00 and mainline completion through the first two weeks of November, trailing only Delta (DL) in mainline performance and sitting in the top spot for consolidated D :00.

As of November 14, United is above goal in both metrics with a 99.87 percent completion factor and a 75.7 percent D :00 average. IAH even set a hub record for D :00 on November 12, with 93.9 percent of its flights departing on time for the day.

On the mishandled baggage ratio (MBR) front, United's employees have the company well below its maximum target, with a 3.05 MBR against a goal of 3.14. All told, it's the kind of exemplary performance that will have United seeing green come bonus time.

"It's the season for rain, ice and snow, not to mention higher load factors with the holidays coming up, so now is our time to shine," said IAH Ramp Service MD Joseph Peloquin. *"I've never been more confident in our operation and in our employees' ability to push through difficult situations than I am right now."*

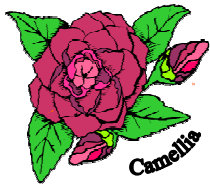

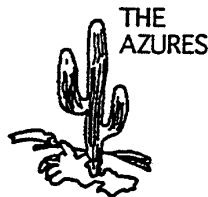

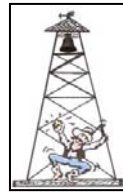

A truck drove up on November 22, 1963 and we were informed that President Kennedy had been shot and was believed to have died. What a shock that was! The base went on lock-down alert and planes were made ready to take off at a moment’s notice. I felt fortunate to work and live with the people I served with. I will always have good memories of my time at Castle. Note: Bob left Castle AFB in 1965 to start work for United.

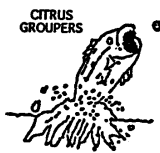

Elaine was born and raised in Chicago in the 1930's in the midst of the great depression. She attended parochial grade and high school and also studied at Loyola University in Chicago. She married Robert in 1950 and was employed at Raytheon Corporation in Chicago, working in the Personnel Department. She left to raise her family which grew to eventually become 5 girls and a boy. Her husband Robert left the workforce because of asbestosis/mesothelioma and was on permanent disability after a serious surgery. To assist in supporting the family, Elaine studied at the American Floral Arts School. The school has taught basic and advanced floral design for over 66 years. Elaine opened her own flower shop and to supplement her family income, she started working at United in the keypunch department. After a short time, she transferred to Airfreight (HDQFF) and worked nights in that department for many years. Along the way she transferred to Chicago Reservations Sales Department until 1987.

That year Robert said *"I can't take the cold anymore. I'm moving to Florida"* so move they did. Elaine closed the business and commuted to Chicago spending weekends with the family in Florida. In 1988 she took a buyout after being an employee for some 19 years. They moved to Merritt Island on the Space Coast. In Florida, Elaine started another business, a Bridal shop selling gowns, flower girl dresses and flower bouquets as well as things like flower arches for outdoor weddings. By this time Robert's illness had really progressed making living in the home difficult. So in 2006 after selling the business, they reluctantly moved to Dell Webb in Summerfield, Florida just north of the Villages. The development has over 3250 homes on 1600 plus acres. In 2009 Robert died.

Since then Elaine has become part of a support group in her community, called "Angels on Request" where members assist anyone with a ride or when a caretaker is needed at home. There are 100 angels in the community who help when asked. She also puts her flower knowledge to use by assisting with decorating the Sacristy at her church. Another angel role for her is visiting the sick in her parish which also can keep her very busy.

Elaine says that *"I love the privilege of our retiree air travel benefits as well as my flight benefits made*

available by my children's employment with American and Norwegian airlines." She is most appreciative of her relationship with all of her retired friends. Elaine has been a member of the Citrus Groupers for 5 years.
