# United Continues to Expand Global Network; Introduces Three New International Destinations and Four New Flights March 7, 2024



Today United announced it is expanding its leading global route network, adding new non-stop flights between New York/Newark-

Marrakesh, Morocco; Tokyo/Narita-Cebu, Philippines and Houston-Medellin, Colombia. United will also increase flying to popular destinations across the globe

including Hong Kong; Seoul, South Korea and Porto, Portugal. Additionally, the airline will add four weekly flights between Los Angeles and Shanghai as the Chinese and U.S. governments recently agreed to increase flights between the two countries\*.

United now has the largest and most diversified international route network among U.S. airlines, offering non-stop service to 134 international destinations across 67 countries. United offers flights to more destinations across the Atlantic and Pacific than all U.S. carriers combined.

In addition to flying to the most popular international destinations, United has been a trailblazer in introducing its customers to off-the-beaten-path locales around the globe – including flights to nine destinations that no other carriers serve from the mainland U.S., like Palma de Mallorca, Spain; Christchurch, New Zealand; Dubrovnik, Croatia and more.

"We have consistently been ahead of the curve in finding hidden gem destinations for our customers to explore and remain committed to providing the most unique slate of travel options for their adventures abroad," said Patrick Quayle, United's Senior Vice President of Global Network Planning and Alliances, "With our leading global network and elevated inflight experience, United has become the airline of choice for discerning customers looking for experiences they can't have with any other carrier."

Tickets for United's new Shanghai and Cebu flights are on sale now on the United app and on <u>United.com</u>; Marrakesh and Medellin will be available later this year.

New York/Newark-Marrakesh, Morocco ~ Next winter, United will have the most flights to the most destinations in Africa from metro New York – and will be the only airline to directly connect the U.S. and Marrakesh – with new service from New York/Newark, launching October 24. The flight will be offered three times weekly on a Boeing 767-300ER aircraft, equipped with 46 United Polaris® business class and 22 United Premium Plus® seats to provide options for an elevated travel experience. This new service further expands United's presence in Africa, building on the airline's existing service to Accra, Ghana; Lagos, Nigeria; and Cape Town and Johannesburg, South Africa.

Tokyo/Narita-Cebu, Philippines ~ United expands its presence in the Philippines with new year-round, non-stop service from Tokyo-Narita, starting July 31. United will be the only U.S. carrier to fly to Cebu with daily flights on 737-800 aircraft, which will have convenient connections from United's flights from San Francisco, Los Angeles, Denver, Newark-New York, and Houston to Tokyo-Narita. United is the only U.S. carrier to offer transpacific service to the Philippines with its daily flights between San Francisco and Manila, and also flies to Manila from Guam and Palau.

Houston-Medellin, Colombia ~ For the first time ever, United will fly non-stop to Medellin, Colombia with daily service from Houston on Boeing 737 aircraft, beginning October 27. This new route expands United's presence in Colombia, complementing existing service from Houston and Newark to Bogota. In total, United will serve 52 destinations in Latin America from Houston.

United's 2024 International Schedule ~ In addition to this new service, United will also expand flying to more destinations across the globe this year. The airline is continuing to rebuild its mainland China schedule, with four weekly flights between Shanghai-Los Angeles on a Boeing 787-9, starting August 29. Further, in late October, Shanghai-Los Angeles will increase to daily service. This service complements United's daily service between San Francisco-Shanghai and San Francisco-Beijing. This enhanced service is enabled by the agreement between the governments of the U.S. and China to increase flights between the two countries.

United is also adding more flights to Hong Kong and Seoul, South Korea. United will launch its second daily Los Angeles-Hong Kong flight on a Boeing 787-9 aircraft on October 26, complementing its two existing daily flights to Hong Kong from San Francisco. The airline will also offer year-round, twice daily flights between San Francisco-Seoul, starting October 25. Additionally, United recently expanded its Tokyo service with a new route between Haneda and Guam, launching in May.

Across the Atlantic, United will add a second daily flight between New York/Newark-Porto, Portugal on a Boeing 757-200, starting May 23. United has more flights to Portugal than all U.S. carriers combined and is the only U.S. carrier to serve Porto.

# United Announces Daily Nonstop Flights Between Guam and Tokyo-Haneda February 23, 2024



United Airlines will launch daily nonstop flights between

Guam and Tokyo Haneda International Airport on May 1\*. Flights will operate year-round and create a more direct link between Guam and Japan's capital, given the Haneda airport's proximity to the city center. These new flights build on United's 32 weekly flights between Guam and Tokyo-Narita, and tickets will go on sale tonight.

"As we grow our global network, we're always looking for opportunities to give our customers more choice and strengthen links between countries. This route – connecting Tokyo's most convenient airport with our unique Guam hub – accomplishes just that. I appreciate the support of the Department of Transportation in recognizing the importance of this route to our customers and stakeholders," said Patrick Quayle, United's Senior Vice President of Global Network Planning and Alliances.

United plans to operate a 737-800 on this route, which has room for 166 customers – including 16 business class seats. The flight is scheduled to depart Guam at 19:00 local time and arrive at Haneda at 22:00 on the same day. On the return, the flight will depart Haneda at 23:55 and arrive in Guam at 04:45 the next day.

United is the largest airline in Guam, offering more than 87 weekly flights to 14 destinations. United has operated in Guam for more than 55 years and is the only airline today flying between Guam and Osaka, Fukuoka and Nagoya in Japan, as well as islands in the Federated States of Micronesia, Marshall Islands and Palau.

With this addition, United will operate six daily flights from Haneda, with service to New York/Newark, Washington D.C., Chicago, Los Angeles, San Francisco, and now Guam. United also operates 10 daily flights to Tokyo's Narita airport, with service to New York/Newark, Houston, Denver, Los Angeles, San Francisco, Guam, and Saipan. United offers more seats from the United States to Tokyo than any other U.S. airline.

# United Expands World's Largest Flight Training Center with Huge, New Building and Room for 12 New Flight Simulators February 22, 2024



United today opened a new, 150,000-square-foot building at its Flight Training Center in Denver. Already the largest facility of its kind in the world, the additional building gives the airline the capability to add

12 more advanced full-motion flight simulators to the facility, six of which have already been delivered.

So far in 2024, the airline has hired more than 300 pilots after hiring more than 2,300 pilots last year. The new building at the campus adds even more training capacity for United's 16,000 pilots.

United's Flight Training Center now has eight total buildings, more than 700,000 square feet of training space, and 46 state-of-the-art full-motion flight simulators

These investments in people, infrastructure and technology continue to fuel the airline's United Next Plan.

United CEO Scott Kirby was joined by leaders from the Flight Training Center and Denver Mayor Mike Johnston to celebrate the opening and show off the facility.

"We're growing faster than any airline in the industry and our investments in our pilots and their training are critical to support the unprecedented number of new aircraft United will add to our fleet in the decades ahead," said Kirby. "United pilots are the best aviators in the world and the way we recruit, hire and train directly supports that high standard of excellence."

New Capabilities ~ Located in the Central Park neighborhood of Denver, the facility spans 23-acres and is the sole training facility for the airline's nearly 16,000 active pilots and all newly hired pilots. All United pilots complete intensive simulator training with pilot instructors and evaluators during the initial qualification process and every nine months thereafter to maintain their certifications at United's Flight Training Center in Denver.

- ▲ Currently, United's Flight Training Center has 46 full-motion flight simulators, including six in the new building, and 21 fixed training devices.
- ▲ In addition to the six already in the new building, it has space to add six more full-motion flight simulators.
- ▲ The addition of the new building allows for a total of 52 full-motion flight simulators and 34 fixed training devices at the Flight Training Center.
- ▲ The new building gives the Flight Training Center the ability to conduct more than 32,000 training events annually and train up to 860 pilots per day.
- ▲ The facility is in operation 24 hours a day for 362 days a year.

Flight Training Center's Local Impact ~ United invested more than \$145 million in the new building and it's expected to lead to more than 370 new jobs. In total, more than 1,600 of United's 10,000+ Denver-based employees work at United's Flight Training Center, representing 24 different departments in roles that include

flight instructing, flight evaluating, scheduling, pilot hiring, human resources and flight standards. In 2023, more than \$44 million was spent on hotel room nights in Denver for pilots visiting the training facility, with an expectation to spend more than \$65 million in 2024.

United's Flight Training Center was originally constructed between 1966-68 as part of the Stapleton Airport complex and has served as United's main pilot training facility since then. Since 2016, United has invested \$370 million in the Flight Training Center overall.

<u>United in Denver</u> ~ United continues to invest in Denver. In the summer of 2023, United announced the purchase of two parcels of undeveloped land near Denver International Airport (DEN), part of which will be used to further expand its Flight Training Center as the current Flight Training Center site does not have capacity for additional growth. United is aiming to have flight training capabilities at the Flight Training Center expansion by 2028.

As home to its fastest-growing hub, the airline has funneled nearly \$1 billion in the past few years alone to further improve the customer experience at DEN. This includes new gates, state-of-the-art United clubs, including the largest in the United network to-date, and a new check-in lobby. United hired more than 2,500 people in Denver last year and plans to hire more than 1,000 people in 2024.

United operates the most flights and carries the most passengers in the state compared to any other carrier. This summer, United will offer more than 500 daily departures from DEN, including 40 new summer flights. The airline provides service to more than 175 destinations, including 10 countries, from the Mile High City.

<u>Careers Take Flight</u> ~ United is the career destination of choice for pilots, offering the largest widebody fleet in North America, and the most comprehensive global network and hubs across the U.S. In 2023, United pilots, represented by the Air Line Pilots Association, International, ratified a new four-year contract.

United offers a broad range of paths to the flight deck to ensure that the best pilots can find their opportunity at United:

- ▲ First Officer hiring For experienced pilots who meet United's hiring requirements and are ready to fly for the airline now.
- Aviate® Program United's pilot career development program offering aspiring and established pilots the most direct path to a United flight deck.
- ▲ United Aviate Academy United's wholly owned flight school designed for those with little to no flying experience.
- ▲ United Military Pilot Program Launched in September 2023, an industry-leading program

that gives full-time, active-duty U.S. military pilots access to conditional job offers as a First Officer.

## United to Resume Service Between New York/Newark and Tel Aviv February 21, 2024



United plans to resume a daily flight from New York/ Newark to Tel Aviv, the first step in restoring vital passenger and cargo service that was suspended in October.

The initial Newark-Tel Aviv flights on March 2 and 4 will stop in Munich to ensure all

service providers are ready to support non-stop service to and from Newark. No Newark departures to Tel Aviv are planned for March 3 and 5. Our goal is to resume daily nonstop service to Tel Aviv beginning March 6.

United conducted a detailed safety analysis in making this decision, including close work with security experts and government officials in the United States and Israel. We also worked closely with the Air Line Pilots Association and the Association of Flight Attendants to develop the protocols to ensure they are safe and well-informed.

United will continue to monitor the situation in Tel Aviv and adjust the schedule as warranted, including changes to the resumed service from New York/Newark announced today. We're eager to resume a second daily Tel Aviv flight from Newark as soon as May as travel demand recovers. Previous flying from San Francisco, Washington Dulles and Chicago O'Hare will be evaluated for resumption beginning in the fall.

Resumed flights are available for booking on <u>United.com</u> and on the United app, alongside service on partner airlines including Lufthansa.

# United Adds New Corporate Partners to Sustainable Flight Fund That Now Exceeds \$200 Million February 14, 2024

United today announced that Aircastle (a Marubeni & Mizuho Leasing Company), Air New Zealand, Embraer, Google, HIS, Natixis Corporate & Investment Banking, Safran Corporate Ventures, and Technip Energies are now among the 22 corporate partners that make up the airline's The United Airlines Ventures Sustainable Flight Fund<sup>SM</sup>, a first-of-its kind effort to reduce emissions and drive production of sustainable aviation fuel (SAF) through investments in startups.



These corporate partners make up all parts of the aviation supply chain – airlines, aircraft and engine manufacturers, fuel producers, engineering and technology experts, financiers, travel management and more – and have now committed more than \$200 million while collaborating to provide strategic expertise to help the Fund's portfolio companies reach commercialization.

Since its inception in February 2023, the Fund remains aviation's first and only venture fund backed by a broad limited partner base and created to identify and support startups advancing feedstock and technology development focused on increasing the supply of SAF.

The airline has included a way for everyday consumers to participate as well. Anyone using <u>United.com</u> or the United app has an option to contribute to supplement United's investment in the UAV Sustainable Flight Fund<sup>SM</sup> before check-out. Users have the choice to contribute \$1, \$3.50 or \$7.00. Continuing in the effort toward climate transparency for our customers, United also now shows an estimated carbon emissions for flights booked through <u>United.com</u> or the United app. In less than 12 months, more than 115,000 people have contributed nearly \$500,000 since February 2023.

SAF is an alternative to conventional jet fuel that, on a lifecycle basis, reduces greenhouse gas (GHG) emissions associated with air travel compared to conventional jet fuel alone. To date, United has invested in the future production of over five billion gallons of SAF - the most of any airline in the world. "SAF is the best tool we have to decarbonize airplanes, but we don't have enough of it. To create the fuel supply we need for our fleet, United recognized that we would have to help build a brand-new industry from scratch – like wind and solar in previous decades," said Andrew Chang, Managing Director of United Airlines Ventures. "As part of our effort to build a new sustainable aviation ecosystem, we recruited a group of partners with the industry expertise to support our startups with both financial and strategic capital, to help them navigate the entire process from conception to commercialization."

UAV Sustainable Flight Fund ~ The UAV Sustainable Flight Fund<sup>SM</sup> is a first-of-its-kind investment vehicle designed to leverage support from cross-industry businesses in order to support start-ups focused on decarbonizing air travel through SAF research, technology and production. The fund is comprised of more than \$200 million in investment commitments from United and corporate partners including: Air Canada, Air New Zealand, Aircastle (a Marubeni & Mizuho Leasing Company), American Express Global Business Travel, Aviation Capital Group, Boeing, Boston Consulting Group, Embraer, GE Aerospace, Google, Groupe ADP, Hawaiian Airlines, HIS, Honeywell, JetBlue Ventures, Natixis Corporate & Investment Banking, Safran Corporate Ventures, and Technip Energies, among others. Consumer Awareness and Call to Action ~ The default option for customer contributions is set at \$3.50 to illustrate the potential impact of customer action at scale: If the 152 million people who flew on United in 2022 each contributed just \$3.50 to the UAV Sustainable Flight Fund, that would be enough to design and build a SAF refinery capable of producing as much as 40 million gallons of alternative fuel annually.

United's Commitment to Net Zero Emissions by 2050 ~ United aims to be net zero by reducing its greenhouse gas emissions by 100% by 2050, without relying on traditional carbon offsets. In addition to the UAV Sustainable Flight Fund<sup>SM</sup>, United has launched a SAF purchasing program called the Eco-Skies Alliance and established a venture fund – United Airlines Ventures to identify and invest in companies and technologies that can help decarbonize air travel. These strategic investments include carbon capture, hydrogen-electric engines, electric regional aircraft and air taxis. In May 2023, United received validation of our 2035 near-term emissions reduction target from the Science-Based Targets Initiative (SBTi) to reduce our carbon intensity 50% from a 2019 base year. In 2023, United became the first U.S. airline to show customers an estimate of each flight's carbon footprint in their search. This year, United was the only domestic airline to receive an "A-"

leadership band score for Climate Change 2023 from CDP, formerly Carbon Disclosure Project.

With most of the holidays behind us I am tired of chicken, turkey, ham and beef. Let's try something different.

#### **Shrimp Alfredo**:

½ cup butter

- 1 pound medium shrimp, peeled and deveined
- 1 tablespoon chopped green onions
- ½ teaspoon minced garlic
- 9 ounces fettuccine, linguine or your favorite pasta
- 4 egg yolks
- 1 cup half and half
- 1 cup fresh parmesan cheese

In large skillet, melt butter and sauté shrimp, green onions and garlic over moderate heat for 5 minutes or until shrimp are firm and opaque. Remove pan from heat. Stir warm fettuccine into shrimp mixture.

In medium bowl, beat egg yolks, half and half and parmesan cheese. Add egg yolk mixture to shrimp mixture and cook over moderate heat until sauce thickens, about 3-4 minutes. Do not boil. Stir in parsley and salt and pepper. Serve immediately.



Update on Flaco the Owl in NYC ~ Many of you will probably remember Flaco the Owl who was freed from his cage at the Central Park Zoo in February 2023. During his year of freedom, he gained a legion of fans worldwide who thrilled to see pictures of him in the trees and perching on fire escapes. Groups of New Yorkers could often be seen watching for Flaco and spotting him with binoculars. He united people in a very special way and he will be sorely missed.

More info on "Forever Chemicals" ~ In the January 2024 newsletter, I wrote about "Forever Chemicals" and the Environmental Protection Agency's proposal to limit toxic PFAs in drinking water. These substances are a group of compounds that are widespread, dangerous and expensive to remove from water. They don't degrade in the environment and are linked to a broad range of health issues, including low birth weight and kidney cancer. They are in the blood of more than 98% of Americans and stay in the body years after exposure.

On February 28, 2024, the Food and Drug Administration announced that PFAS, once commonly found in a range of products, including pizza boxes and popcorn bags, are no longer being used in food packaging in the U.S. This marks a year-long campaign by the FDA to

phase out PFAS in food packaging. PFAs are greaseproofing chemicals that create a barrier that prevents oils, grease and water from seeping through food packaging, keeping food dry and fresh. They may be linked to serious health problems, including cancer, birth defects and immune system suppression.

They were once unavoidable in people's day-to-day lives, being used in everything from fast-food wrappers to pet food bags. Extensive research over the last decade found that PFAS can leach into food and may be associated with serious health problems in humans, and food manufacturers gradually began to phase them out. In 2020, the FDA received commitments from the remaining food manufacturers to remove PFAS from their products voluntarily over the next few years. Per the FDA, "This completion of the voluntary market phase-out of these substances used on food packaging paper and paperboard, eliminates the primary source of dietary exposure to PFAS from authorized food contact uses."

This teacher needs just the cards, no envelopes. The money they raise is for special outings like field trips and other enrichment activities for the special needs students.

Jan Soderstrom is collecting coupons for the charity Support our Troops. This is a service project of her Daughters of the American Revolution (DAR) chapter. According to Feeding America, an estimated 160,000 military families experienced difficulty putting food on the table in 2020. Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me at 30 San Piedras Place, San Ramon, CA 94583-3018. This is such an easy thing to do to support our troops. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer's Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. In

my area, the coupons come in Tuesday's mail along with the supermarket ads, and then in the Sunday paper. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated. I get so excited when I get a coupon for eggs!

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022, and on March 2<sup>nd</sup>, I turned in 1358 coupons worth \$3453.40! Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. All the coupon cutters are telling me that they are not getting coupons like they used to. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons. If it were not for the RUAEA folks from all over the country sending me coupons, my chapter would have very few coupons. Are you planning to watch the Solar Eclipse on April 8? It will travel from Mazatlan, Mexico, through Texas, the Midwest, New England and Newfoundland. This will be the last total solar eclipse that we will be able to see across North America until 2044. Plan on viewing the eclipse and hope for clear skies.

The earliest record we have for a solar eclipse appears in the ancient Chinese text, "Shujing". The eclipse occurred on October 22, 2137 B.C.E. This was during the Zhou Dynasty. More than a century later, a total eclipse on May 28, 585 B.C.E. is believed to have ended the war between the Lydians and the Medes. Greek Historian wrote that just as the day was getting warm, it was suddenly turned into night. When the Lydians and the Medes observed the change, they ceased fighting and both were anxious to make peace.

An eclipse occurred on May 29, 1919 for a total duration of 6 minutes and 51 seconds; it was ranked as the longest. When you watch the eclipse, probably the last one we will ever see, take some notes to leave for your grand children and they will have a comparison of what you say and the views they will have in the future.

United is the only airline to offer non-stop flights to Marrakech, Morocco and Cebu, Philippines, and will fly non-stop to Medellin, Columbia for the first time in its history. We will also increase flying to Portugal, Hong Kong, and South Korea. Flights are from NYC, HOU, Tokyo. United offers flights to more destinations across the Atlantic and Pacific than all US carriers combined. We offer non-stop service to 134 international destinations across 67 countries. Tickets are available for Shanghai and Cebu now, with the others available in July and October. Our little airline has grown. I guess that little purchase of Pan Am's Pacific routes wasn't such a bad idea after all in 1985. In 1991, UAL became the owner of Pan Am's lucrative London Heathrow slots. 

From my memories: Victoria falls ~ On our second trip to South Africa, we flew from JFK in New York to Amsterdam in Holland, then to Kinsasha and Leopoldville, which was the Belgian Congo, but is now called Zaire. The airport at Leopoldville, was constructed of teakwood, however because of a lack of care you could see how deteriorated this beautiful building had become. It seems they had plenty of money for inspectors and soldiers running around with guns, but no money to keep this building in good repair.

We were then on our way to Johannesburg, South Africa and meeting our friends. It was just another happy occasion. We soon made plans to visit the Victoria falls in Rhodesia, now called Zimbabwe. We took a bus starting from Johannesburg and headed North to the South African transvall cities of Pretoria and Petersburg to the border town of Messina and then on to Bulawayo. Anyone who had any ideas that they would be seeing Tarzan holding onto Jane and swinging through the jungle on hanging vines, would be sadly disappointed. To me all this land looked like we were rolling through the lush green fields of Lancaster County in Pennsylvania.

We arrived in Bulawayo, and spent about two hours

walking around. It seemed to me that the place was stuck somewhere in the 1920's. Nonetheless, it was still very interesting to see what they were selling. I then had to go to the railroad station and buy a ticket for an overnight sleeper on the train that would take us directly to Victoria falls. When the train arrived, it looked like something out of Agatha Christie's Orient express. Violet and I took our bags to our assigned car, and as I slid the door back, there were two very young girls on the opposite side of us. I said, I think you made a mistake, they of course replied no this is where we're supposed to be. Anyway who am I to argue! As the train pulled away, about an hour into the trip; the conductor comes around to check the tickets so I explained to him that there are two extra girls in this compartment, so he says what the hell are you complaining about?

A little while later he came and took those two girls away and put them in another compartment. Violet, always the one to rise to the occasion, says Gee Marty we were all getting along so well. Actually we did meet up with them again on our second night at the hotel, and we all had an interesting dinner together at the Victoria Falls hotel. They are truly one of the world's greatest wonders. The cataract is more than a mile wide and has a drop to the bottom over 350 feet, more than twice the size of Niagara. The first thing that you hear as you approach the falls is a gigantic roar, and a spray of mist that looks like a huge rain cloud. The mighty rivers that feed the Zambezi River that flows over the falls, like the Kabompa, the Luena, and the Bungo-Lungue are mighty rivers in themselves, so you can imagine the amount of water that is flowing over those falls.

The tour guide said, in flood tide which occurs in September, about 540,000,000 gallons of water flows over those falls every minute. I always compare that to the Croton reservoir that feeds the city of New York. It has a capacity of about 500,000,000 gallons. If you can imagine it would take just one minute to fill up that gi-



ant water reservoir. When you come to think of it, it is mind boggling. The natives call this "the smoke that thunders", and I think that says it all. We spent another five days and made our return trip to Johannesburg. Alas there were no incidents to report, but we spent a lot of time talking about our experiences with our friends but most of all the memories that still linger to this day are strong as ever.








### United Airlines Historical Foundation

"Preserving the Past, Inspiring the Future"





The Tower is conceived as a monumental, ninety-three feet tall Musical Instrument holding forty Wind Chimes, representing the Forty Passengers and Crew Members. It is intended to be a landmark feature near the memorial entrance, visible from U.S. Route 30, the Lincoln Highway. The Tower of Voices provides a living memorial in sound to remember the forty through their ongoing voices. There are no other Chime Structures like this in the world. The Tower project was constructed from 2017 to 2018 with a dedication of the project on September 10, 2020. Funding for the design and construction of the project was provided through private donations to the National Park Foundation and the Friends of Flight 93 National Memorial. The shape and orientation of the Tower are designed to optimize air flow through the Tower walls to reach the interior chime chamber. The Chime system is designed using music theory to identify a mathematically developed range of frequencies needed to produce a distinct musical note associated with each chime. The applied music theory allows the sound produced by individual chimes to be musically compatible with the sound produced by the other chimes in the Tower. The intent is to create a set of forty tones (voices) that can connote through consonance the serenity and nobility of the site while also through dissonance recalling the event that consecrated the site. The Chimes are wind-activated. Due to variations in wind direction and speed, some Wind Chimes may remain motionless while others are partially or fully activated. The Chimes will sound at wind speeds as low as 7-10 mph. The shape and orientation of the Tower help optimize airflow through the open walls.
