The Writers' Column ~ Remembering 9/11 *By Charles Bogert*

As this 2020 summer slowly begins to close for me, like perhaps many others, this, I believe, hasn't really been our greatest year. The Covid Virus has taken center stage and being confined to a "Shelter in Place" option isn't really my idea of enjoyment. True, many of us probably did find time to complete long overdue projects we had put on hold until after we retired, but the terms of their completion were not always our best enjoyment. As I slowly "visited" this summer, I thought of many things, but like every summer for the last 15 years, I always reflected back to my thoughts of September 11, 2001. In my own way, I always take time to reflect back on that day and to remember the "Airline" family we lost.

In September of 2001, my wife and I had planned a 4 day vacation to visit Maui, but instead we got stuck in Maui and it took us 11 days to return home. I started my career with United, at Newark and grew up in Hoboken, NJ across from New York City and remember the Trade Center being built and to me this event was personal. Although in 2001, I was now working at SFO, I still had many United friends and family still in the NYC area and as a tribute to them, in 2005 I wrote an article highlighting airline employees and their sacrifices they were sometimes forced to make for the public. At the time I wrote the article I was retired, working in security for a worldwide company where people had access to my article and many people who did read it and people researched to find me, to mention they would never again look at airline employees again in the same light. To that I was extremely grateful. I did know friends and employees who were lost during 9/11 and did have family members who only missed working in that area that day because of schedule changes. As I recap my thoughts to put them down on paper, it all comes back and thank God I was able to honor them in some way. All United employees, regardless of their department, I'm sure, all shared the same sympathies.



About 20 miles from San Francisco and 15 miles from where I now live is a town called Union City, CA, which houses a memorial honoring those lost on Flight 93. Most of the passengers were from the SFO area, but several others were also honored including our flight crew, who lost their lives. Who would have known that when Flight 93 departed Newark, their names would be etched on individual 4 foot memorial markers several years later in a place they probably never heard of? The area is visited every "9/11" by many and well maintained by the city. I have visited it several times and always left with sadness and memories. To those we lost, God bless them.

The following was only part of my several page tribute, but I hope the message is still there.

The excerpts from the article begins: Pandemonium seemed evident. The returning passengers, many disoriented, isolated and lonely were now overcrowding the terminals. Still reluctant to accept what had happened, these shaken people sought direction. Windows of information seemed closed and they looked towards United Customer Service to open them.

Airline people serve the public. Proudly representing the company for which they work, their everyday dedication of joining world destinations together are demanding and ever changing, but for the most part their actions go unnoticed. To the flying public, customer service representatives are the first employees the public encounters. They are the first to greet you, check your luggage, assist in seat selection, offer flight information, and many services required to allow your trouble free departure.

Flight attendants welcome you on board your flight, attend to your onboard requests and carry the reassuring comfort sometimes required by the less than frequent flyers.

Flu or COVID-19? September 28, 2020



With flu season beginning in the Northern Hemisphere, it is a good time to familiarize yourself with the differences between flu and COVID-19. We regularly update our Flying Together Q&A on the COVID-19 page with questions and answers. The latest version includes information about how to tell the difference between the two illnesses, how long after exposure symptoms typically begin, and when to seek emergency medical attention for COVID-19. In a nutshell: Both COVID-19 and flu can have varying degrees of signs and symptoms, ranging from no symptoms to severe ones. Common symptoms of both COVID-19 and flu include fever, cough, shortness of breath or difficulty breathing, fatigue, sore throat, runny or stuffy nose, muscle pain, and headache. Some people may have vomiting and diarrhea, but this is more common in children than in adults. Other signs and symptoms of COVID-19 may include a change in or loss of taste or smell.

National Food Safety Education Month in a nutshell September 18, 2020



We've all been there. We drop a slice of bread or piece of cheese, quickly pick it up, blow on it, mutter "five-second rule" and go back to making our sandwich. But what would our food safety

experts in Catering Operations say?

"The five-second rule doesn't prevent bacteria and other germs from getting on fallen food," said Food Safety Director Vanessa Lindstrom. *"If you can't wash the food that's fallen on the floor, don't eat it!"*

As a home cook, you may wonder what other common myths may be impacting the safety of the food you prepare. Here are a couple to marinate on:

Myth: You shouldn't put hot foods in the refrigerator.

Fact: Hot food can be placed in the refrigerator. Large amounts of food should be divided into small portions and put into shallow containers for faster cooling in the refrigerator. Bacteria can grow rapidly on food left out at room temperature for more than two hours.

Myth: When I microwave food, the microwave kills the bacteria.

Fact: Microwaves don't kill bacteria – the heat generated by microwaves kills the bacteria. Microwave ovens are great time-savers and will kill bacteria in foods when heated to a safe internal temperature.

Also, while we typically use the word “safety” on a broad scale, it usually implies the safety of our employees, customers and equipment. Food safety, however, encompasses the safety of the food and beverages consumed by our employees and customers. Every day, our Food Safety team is upholding the highest standards of proper sourcing, processing, handling and preparation of the food and beverages we provide for our customers, Catering Operations teammates and fellow Inflight co-workers. This month in particular, for National Food Safety Education Month, the team put together engaging activities and friendly competition opportunities like building a bacteria, designing posters, educational demonstrations and games.

United to offer customers COVID-19 testing **September 24, 2020**



We announced recently that we are launching a COVID-19 pilot testing program that will offer customers the option to take a rapid test at the airport or a self-collected, mail-in test ahead of their

trip. We are the first U.S. airline to offer such an option, making it easier for our customers to manage quarantine requirements and entry conditions of popular destinations around the world.

The program will launch on October 15 for customers traveling from SFO to Hawaii destinations. Select international destinations will follow.

The rapid Abbott ID NOW COVID-19 test – administered by GoHealth Urgent Care and their partner Dignity Health – provides results in approximately 15 minutes and will be available to our customers on the same day as their flight departing from SFO. The mail-in test option will be administered by Color, and it is recommended that customers initiate testing at least 10 days prior to their trip and provide their sample within 72 hours of their trip. We worked closely with Hawaii officials to ensure that any United customer – both visitors and Hawaiian residents returning home – who tests negative on either test would not be subjected to the state’s current 14-day quarantine requirement.

“Our new COVID testing program is another way we are helping customers meet their destinations’ entry requirements, safely and conveniently,” said SVP and Chief Customer Officer Toby Enqvist. *“We’ll look to quickly expand customer testing to other destinations and U.S. airports later this year to complement our state-of-the-art cleaning and safety measures that include a mandatory mask policy, antimicrobial and electrostatic spraying and our hospital-grade HEPA air filtration systems.”*

We currently offer more flights to Hawaii than any other major network carrier, including daily service be-

tween SFO and HNL (Honolulu), OGG (Maui) and KOA (Kona). We are increasing service to the Aloha State on October 15 with the resumption of service between SFO and LIH (Lihue) and additional flights between SFO and OGG and KOA.

Torgy’s Travel Tips – November 2020 **Cruises, All-Inclusives** **and Trusted Traveler Programs**

Pumpkins adorn the entrance to grocery stores, the candy aisle is stuffed with Halloween goodies, Thanksgiving decorations are prominent eye-catchers at the craft stores and I saw Christmas décor for sale at Costco even before the autumnal equinox. As we prepare ourselves for our first fall and winter of Covid-19’s unwanted embrace, it is not

surprising to long for the normalcy that our traditions provide. For us airline folks, this is also when we often take advantage of “shoulder season” travel opportunities for that trip to faraway tropical lands or popular tourist locations bereft of school groups. But, as Bob Dylan wrote, “The Times They Are A-Changing”. The issue is not **if** we will find a bargain on a balcony cabin or availability of an ocean view room at an all-inclusive resort, it’s whether either of those entities are even operating and/or allowed to welcome guests from the USA. Here’s what my research at this point in time indicates. **(Caveat: The following information was current and correct as of October 1, 2020 but rules and regulations are constantly changing so it is advisable to check before you put down a deposit.)**

Cruises: The Centers for Disease Control and Prevention (CDC) had placed a “no sail” order until mid-February 2021 on cruise ships serving the US. The White House, however, just blocked that order and the new “OK to sail” date is October 31, 2020. Florida, home to the majority of cruise ship departures in the US and crucial to the outcome of the upcoming election, stands to benefit by this earlier reopening. But don’t plan for Thanksgiving onboard just yet. CLIA (Cruise Lines International Association) has indicated this will be a phased-in approach taking 30 to 60 days at least to prepare for the first departures. Destinations will be limited initially to the Caribbean, Mexico and Central America. Crew, from captains to laundry workers must be repositioned and quarantined for 14 days. There will be lower capacity levels to ensure social distancing, touch-free entry and exit zones must be created and tested and, of course, a plethora of disinfection protocol training with the staff must take place.

On a recent cruise webinar I attended, it was clear that cruise lines are carefully addressing safety issues related to every part of the cruise experience. US cruise lines have released a 74 pages report to the CDC detailing safety protocols. Based on successful outcomes from European cruise lines that are currently operating for European citizens only, some of the new standards include:

- * Masks mandatory for everyone onboard whenever social distancing is impossible
- * Masks mandatory during port calls
- * No exiting the ship if you are not on a sanctioned tour
- * Shore excursions will operate in a “travel bubble”
- * 3rd party operators for shore excursions may not be utilized
- * Buffets will not be self-serve
- * More in-room dining options will be offered
- * Plexiglas dividers between chair clusters in lounges
- * Daily health broadcasts will be made
- * Higher water temperatures used in laundry
- * New air-flow management and ventilation modifications
- * Fully provisioned medical facilities
- * Quarantine cabins provided if situation presents
- * Sanitizers, sanitizers, sanitizers everywhere

Cruise lines are offering flexible cancellation policies. As of this writing some are only available till October 31st, 2020, but are likely to be extended as demand is so low. Many cruise companies are not publishing departures until 2021 anyway. Realistically, it will be mid-to-late 2021 before cruising could freely open up to US citizens according to the cruise experts I spoke with. Although European river cruises have already begun, most Christmas markets along those waterways are closing this year. And more importantly, until the European Union lifts the quarantine ban on US citizens, those cruises will be limited to local residents only, according to AAA.

Now if you're afraid to get stuck in the middle of the ocean with no place to dock if the virus breaks out, you might opt for an all-inclusive resort instead. It's like cruising, but you stay in one place. The price includes your room, which is several times larger than one on a cruise ship, all meals, drinks, gratuities, entertainment, large swimming pools, non-motorized sports and vast open spaces so there is less crowding. Since check-in times are staggered, there are no long waiting lines. You pay in advance and there's no bill on the day you check out. There are many all-inclusives in Mexico and the Caribbean. Check out our partner ID90Travel or Trip-Trust for suggestions.

And speaking of international travel, many people were in the midst of applying for Trusted Traveler Program Global Entry and/or Nexus when the enrollment

centers closed in mid-March. For those who received *conditional* approval and have paid their fee but have not had their *personal* interview, the enrollment centers re-opened on September 8th, but the backlog is huge. You can track your status by logging into your conditional account at www.ttp.dhs.gov. If you have the opportunity to enter the US by air before you can get an appointment, you can use the *Enrollment on Arrival* program, which allows you to complete your interview when you arrive in the US from an international flight.

And lastly, a couple of great enhancements are now available on www.united.com. The Destination Travel Guide allows you to filter and view Covid-19 travel restrictions by destination. It's really great as it tells you what medical certification is required, if non-essential shops are open, if restaurants, hotels, bars and museums are open and what physical distance and mask requirements are in place. The other enhancement is the Map Search which filters your search for locations offering beaches, national parks, hiking, culture or romantic getaway locations. Good work from the united.com group!

And like a slogan I recently saw from a cruise line: Like the tide, we will return!

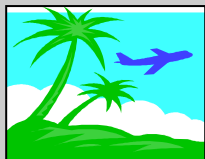

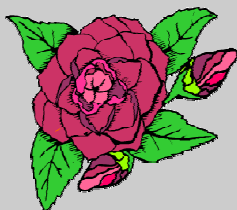



If you live in the San Francisco Bay Area, you may want to bookmark www.baaqmd.gov on your computer. This site gives hourly updates on all the locations in the Bay Area. Given all the microclimates in our region, there is a big difference in air quality between locations. You can also scroll backwards date-wise to see what air quality was like on any particular day.

Every morning, when I turn on my computer, I open the website, move forward to the current date, and then bookmark that. There have been many days when the air didn't look "that bad" but the rating was in the orange range of 101-150, which is "unhealthy for sensitive groups." On those days, I did not walk or do any gardening to play it safe.

For everyone else all over the country, another great

website is airnow.gov. You enter your zip code and it gives you the latest air quality info.

And here is this month's PSA - regarding gift cards of all things. If you're like me, you probably have a nice collection of restaurant and department store gift cards tucked away in your desk, saving them for when you "really need something." With so many retail stores declaring bankruptcy, and restaurant chains going out of business, haul out those cards and go on a spending spree! Remember the adage "Use it or Lose it." Buy things you need if you must, but treat yourself to something fun. It will lift your spirits, and give you something to look forward to until it's delivered. With restaurants, you can order take out online and use up your gift card that way.

Ken Price, our resident storyteller, is back with some more great tales. The first two are about foreign speakers not understanding slang. We've all experienced this in our travels I'm sure.

Years ago I had some guys from China at SFOMB to plan for the overhaul of their airplane and when the meeting was over I said, "OK, are we all okey-dokey?" There were four of them and they all opened their English to Chinese dictionaries. The boss said, "Mr. Price, what does okey-dokey mean?" He had never heard the phrase and it came so natural to me. I said it meant we all understood and agreed with our plan. He smiled and repeated a couple of times, okey-dokey. I shudder to think if things had been reversed and we were in China and using Chinese.

United had an All Nippon Airlines 747 in the Oakland maintenance facility for the 747 Section 41 nose rework. ANA had sent about 10-12 engineering folks to monitor United's work and progress. They were sharp and very knowledgeable and told their boss that United was behind schedule. He had emphasized the necessity for an **on time** completion as the aircraft was going to be a revenue flight from SFO. Well, as often happens, maintenance items don't necessarily cooperate with man-made schedules. I had attended a prior United meeting where the maintenance items were discussed and it was evident the schedule was in jeopardy. The ANA boss came into the office, expressed his concern, and wanted to know what United was going to do to ensure an on time release. I told him the schedule looked "iffy" but everything possible would be done to meet the schedule. He looked at me and said, "What does iffy mean?" I said, "Not good!" Now that he understood and it was a difficult next couple of days. The release was late but it did make a delayed SFO departure.

Who knew that United Airlines had an Airframe Maintenance Center in Oakland, California? As I recall, in 1988 a section of a Hawaiian Airlines High Time 737 had a structural failure and a section of the forward up-

per fuselage departed the aircraft. Extensive investigation indicated evidence of corrosion and metal fatigue compounded by Hawaiian's high airframe cycle rate due to their short trip routes among the islands. This resulted in the FAA requiring increased and more intensive inspections and repairs, which in turn resulted in an increase in overhaul dock days. In the same time period the Boeing High Time 747 Fleet was experiencing some nose section structure cracking which required extensive cockpit removal, repair and reinstallation. It was a **big job** and where do you get the hanger space to accommodate all this additional airframe maintenance?

Lo and behold, World Airways had a large four body / two narrow body aircraft hanger they had just vacated in Oakland. At that time, United was overhauling World's DC-10 CF-6 engines so we made contact to see about the availability of the hanger. It is owned by the Port of Oakland so an arrangement was made to lease it for the additional airframe requirements. Due to the 747 nose problems, Boeing asked United if they could handle the repairs for their customers. United agreed to make one wide body hanger available for Boeing customers in addition to United's fleet in the other three hangers. So the OAK Maintenance Center was opened. Various international airlines 747's were modified there. The center remained open until 2003 and then all activities returned to SFO.

Here are some more recommended books. With cooler weather on the horizon, and Covid-19 still keeping us at home most of the time, curling up with a good book is a wonderful way to pass the time.

I belong to Daughters of the American Revolution (DAR). The new State Librarian has started a virtual book club and the first meeting in August had 135 members in the two Zoom sessions! They read and discussed *The Book Woman of Troublesome Creek* by Kim Michele Richardson. This is historical fiction about the blue people of Kentucky and FDR's New Deal program that brought books to about 100,000 residents of Appalachia from 1935-1943. The book and author were also featured in the February 2020 issue of *The Costco Connection*. Everyone I've talked to has raved about this book. The book we are reading now is *These Is My Words: The Diary of Sarah Agnes Prine, 1818-1901* by Nancy E. Turner. This book chronicles the life of a courageous woman in the Arizona Territories. It won the Arizona Author Award and was a finalist for the Willa Cather Literary Award.

The Spring 2020 issue of my sorority magazine had a fascinating article about Tracy Walder, who was recruited by the CIA during her junior year at USC. "Directly from the sorority house to the CIA, she spent time as a covert operative, assuming aliases, interrogating terrorists, and thwarting chemical attacks." She said her favorite course was "Crash and Bang" which is the

defensive driving course where they learn how to drive defensively and aggressively in foreign countries. They also had poison school and cyber security courses. She has written a book, *The Unexpected Spy*, about her secret life from the CIA to the FBI, taking down some of the world's most notorious terrorists. It went through many revisions because the CIA had to approve what she wrote. Her story has also inspired a TV show that is currently in production under ABC studios.

Adorable Wildlife Babies ~ September 22 was World Rhino Day! Disney's Animal Kingdom celebrated World Rhino Day by announcing that three of their rhinos are pregnant! Kendi's baby is expected in October, and moms Lola and Jao are due in late 2021. The rhino moms were chosen to breed through Species Survival Plans, which are overseen by the Association of Zoos and Aquariums to ensure the responsible breeding of endangered species. Ten rhinos have been born at Animal Kingdom since the park opened in 1998. Disney is hopeful that these three upcoming arrivals will raise awareness about the need to conserve wild rhino species around the world.

On February 22, the Denver Zoo announced the arrival of its first greater one-horned rhino calf. This birth was truly a miracle. The little girl, who has been named Joona, was born to first-time mom Tensing after 11 failed artificial insemination procedures.

The 13-year-old rhino mom was quick to bond with her little bundle of hooves and started nursing, grooming, and napping with her baby shortly after the birth. Just by existing, this female calf is helping preserve her species, which is listed as "Vulnerable" by the IUCN Red List. Once widespread throughout several Asian countries, the greater one-horned rhino, also known as the Indian rhino, dwindled down to a population of just 200 in the 20th century due to being hunted for sport. Strict protection efforts have helped the species rebound. There are now an estimated 3,500 greater one-horned rhinos in the wild. When they attempted to board, all the flights were not allowing carry-on bags. All bags had to be checked and the retirees were charged \$30.00 for each bag checked. Also, not one of the flights were filled to the 70% boarding capacity. All the flights were less than 50% full but not one non-rev person was allowed to board. If it was only one retiree who was not allowed boarding, I would say that was just bad luck, but four different people at different airports on different flights on different dates makes me think that our flight benefits are non-existing, at least until the end of this pandemic.

RUAEA Regional Director **Sonda Sandstedt** checked in with us: "Greetings all, now that things are beginning to settle down a bit with some of the local fires I wanted to check in and see if you are all well and safe. Did anyone have to evacuate? Anyone still in danger? And can we help in any way? If you get to celebrate your birthday this month, we all send you a great big Happy Birthday and many more!

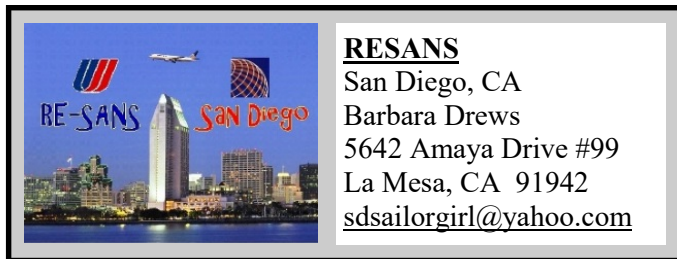

Richard Carey attended as a guest. Richard was a mechanic at the IMC who promoted to management. Richard retired from United in Vendor Management a few years ago and still resides in the Indy area. We're hopeful Richard will attend future meetings.



We also welcomed a new Indy Racers chapter member, **George Atteberry**. George is a retired United 747 captain. He and his wife (retired United Flight Attendant) recently moved to Indy from northern Florida. He was the correspondent for the Gulf Coast RUAEA chapter before moving to

Indy. To help get to know George, he was kind enough to provide his bio and photo for publishing.

George Atteberry was born on the Osage Indian Reservation in Oklahoma. His father, Lee, was an oil production worker living in a lease house on the reservation. At age 9 the family moved to Tulsa, OK where George attended schooling, graduating from Tulsa Central High. Then on to Oklahoma State (formally OK A&M) where he studied Petroleum Geology.

Upon graduation in 1958 he was called into the draft, and took the easy way out, by joining the Marine Corps. Eastern Airlines took him to Washington, DC and OCS at Quantico, VA. After that it was off to flight

school in Pensacola, FL, and points west. A new duty station for a young Marine Fighter Pilot was MCAS Kaneohe Bay, HI; a well-kept secret for Marines. After KB it was west coast in Helicopters at MCAF Santa Ana (formerly a Navy Blimp base with the tall hangers). In 1964, George served on a Diplomatic Passport out of the Air America Base at Udorn, Thailand. Upon his return to the good old US of A, he was assigned to HMM -163 (UH 34-D recip helicopters) to Viet Nam. December 64 - December 65 he was in VN, and later on board the helo carrier Iwo Jima. After returning home he was off to Amphibious Warfare School. He was assigned to NAS Meridian Mississippi as a Fixed Wing Instructor Pilot.

Got off active duty 6/30/68, joined the reserve Marines and then went with United in August 68; he flew out of Newark, Los Angeles, Seattle, San Francisco, Chicago, and Honolulu. Aircraft included Boeing 727, 737, Douglas DC-8, DC-10, Boeing 747. While in HI with UAL, George flew helos with Papillion Tour Helicopters, stand by, on all the islands.

He retired out of SFO on the B-747 (rope start) on November 2000. The most enjoyable experience was to command a Marine Helicopter Squadron in the Reserve with HMM-770. The aircraft flown included the H-34, CH-46, and UH-1N. A very rewarding time to supplement his United endeavor.

Thank you, George, for your service to country and defending our freedom!

On another note, September was probably our last meeting with **Mario Bregente** in attendance. Mario will be moving to Northern California to live closer to family. We all wish Mario the best. 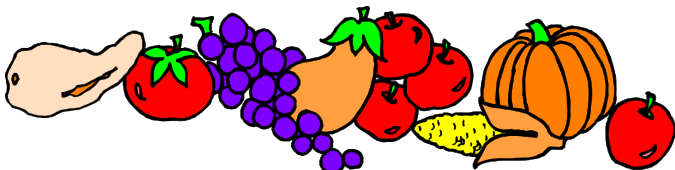

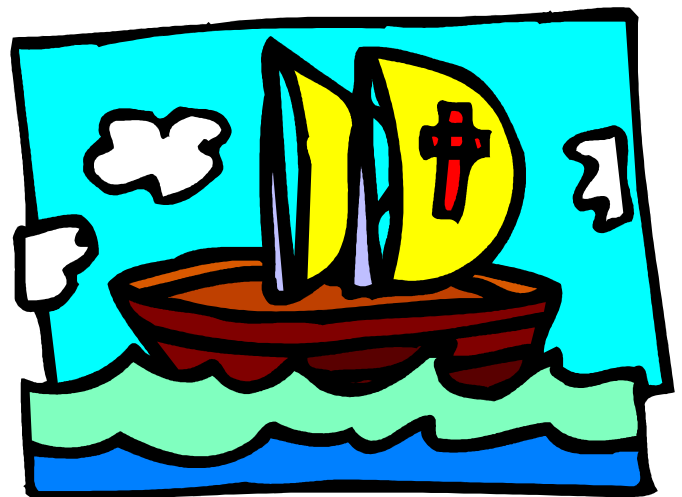

It will be interesting to hear how voters perceive the virus battle and how has affected all our lives, our economic situations, and our political leanings – not to mention RUAEA functions. If you have been following this Seattle column for the past couple months, you may remember that we have been detailing the career of **Dave Jones** (SFOFO). When we left him at the end of October's column, Dave was managing the group involved with giving up United's own weather radar system in the late 1990's and implementing a new vendor product to avoid some of the earlier pitfalls.

We rejoin Dave, mostly in his own words, as the weather radar project proceeded to completion, leading him in yet another direction in United's history.

As the weather radar program moved to implementation, Dave was approached by flight operations management to take on another challenging assignment. United had increased its SFO hub flight schedules with a combination of short haul shuttle service to Southern California and additional flights to the Pacific. The in-

creased volumes functioned well on good weather days at SFO, but the all-too-common morning and early afternoon stratus fog led to large system disruptions. United flight technical pilots were investigating a possible ground-based radar system they believed would provide some relief to the weather delays. Invited to take on the role of project manager for the effort, Dave took up the challenge in 1998, fully expecting a two-year assignment. Little did he know that the project would extend beyond his retirement in June 2003.

The SFO project involved getting FAA to support the purchase and installation of a \$20 million radar system at the airport and the development of procedures for its use by air traffic controllers and pilots. Dave's first task was to understand the many stakeholders' roles and responsibilities in making the project happen, and he quickly learned that the project was a political and technical mine field. It seemed that pilot and traffic controller unions each had reasons why the project wouldn't work. At the core of technical and operational issues was SFO's two parallel runways separated by only 750 feet, risking mid-air collisions and the possibility of wakes from one plane upsetting a trailing plane on an adjacent runway. Existing rules essentially prevented parallel operations in any but perfect weather. The ever-present stratus resulted in only single runway operations for landings.

With United's prodding, SFO airport purchased the radar system and Dave worked with the many FAA, air traffic and pilot groups to develop new rules and procedures for the system. While at the airport for a technical meeting one day, Dave was called into SFO Airport Director John Martin's office, where he encountered then-FAA Administrator Jane Garvey. She had just informed Martin that her staff had told her to cancel the project because ALPA would never agree to fly the new procedures. Dave's impromptu arguments promoted the benefits to SFO and United, noting that ALPA was committed to make it work. He won the day and, after encountering many more bumps, the system was put into operation in 2004.

After 9/11 and then United's bankruptcy, Dave regretfully decided to retire and move on. That was not, however, the end of his involvement with his love of airplanes. He just changed hats.

In his work as engineering new technology manager, Dave had worked beside Boeing engineering staff involved with air traffic technologies and he approached them about rejoining Boeing, where he was offered a position in the Air Traffic group for the Washington DC area. Retiring from United June 30, 2003 Dave moved onto manage a Boeing contract with the FAA tasked with defining a new data collection architecture for air traffic. With the Boeing engineers assigned to the contract located in the Seattle area, Dave became a frequent

flyer between DC and Seattle.

On one of his many trips to Seattle, Dave was asked to provide technical insights into a GPS landing business being explored by a Boeing Seattle group. Familiar with this technology through his work in San Francisco, Dave was deemed an expert in what was then a virgin field. He accepted a job to program manage this new business – and to relocate again, this time to the west coast.

The new adventure took Dave to China to implement the new GPS procedure in Lhasa, Tibet. He subsequently moved to join the Flight Test pilot staff as a technical specialist, coordinating with airline pilots, Boeing test pilots and design engineers. In his last assignment before retirement in early 2011, Dave's boss gave him the lofty title Director of Flight Operations of the Future. He led a multi-disciplinary team in defining Boeing's commercial airplane future strategy for new landing system technologies.

That wasn't the end of airplanes for **Dave Jones**. He became a volunteer for the Museum of Flight and the Flight Restoration programs, as well as becoming a dotting grandfather and serving as president of our Seattle RUAEA chapter. In March of last year, Dave joined 150 former Boeing and industry executives involved in the 777 program for the first 777 aircraft's induction into the Pima Air & Space Museum in Tucson, Arizona after its nearly 20 years of service for Cathay Pacific Airlines.

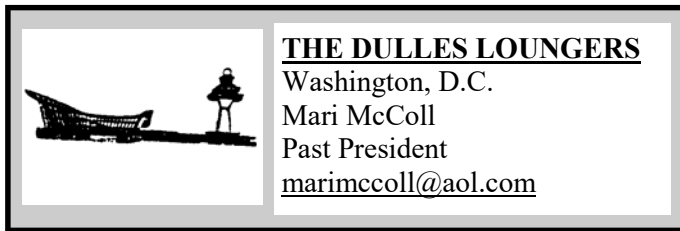

The weather looks like it is going to cooperate. It is Fall here and some days are chilly and sometimes wet.

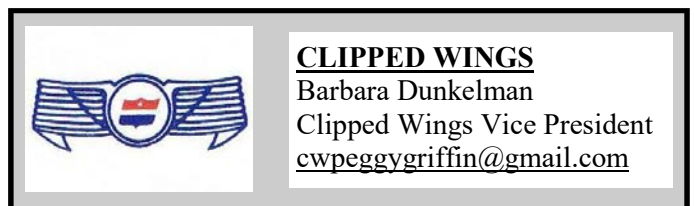
But, we are hoping for mid 70's with no sign of rain. At the moment we have approximately 30 members who gave RSVP that they are coming.

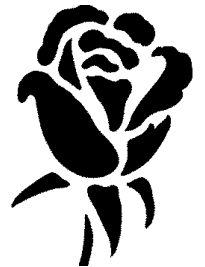
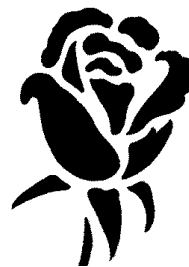
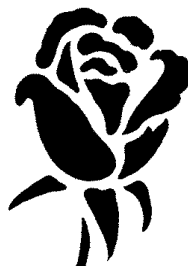

These trained professionals are highly trained in life saving techniques and evacuation performance procedures. And when it comes to training none are more visible, yet unnoticed by the public than the pilots.

Pilots, highly skilled and professionally trained are the ones whose hands we put our lives and trust in every time we board a plane. Millions of people fly every year without incident, yet this fact is seldom noted.

Airline personnel of all departments mourned on this day. Airline employees trapped in this situation were the first the public turned to. Many of these workers had family and neighbors working at the Trade Center, whose fate was unknown to them yet, they were able to control their emotions to assist the general public. Many passengers, unaccompanied minors, and the handicapped needed assistance and patience from airline staff to help them overcome their isolation. Agents assisted the elderly, helping contact their families for pickup while others helped people retrieve their luggage and personal effects. Rebooking of flights was impossible and getting people back to their points of origin became everyone's first concern. These employees silently wept yet kept their composure. Assisting the flying public, many held back tears and some worked days with little sleep to serve the public and for some they were soon to find out they lost friends on Flight 93. Two of these flight attendants I knew. Newark's heart was bleeding, but its employees performed their duties diligently.

Newark was never the same. Sorrow filled the corridors and the employees carried their grief for months. Memorial services were conducted throughout United's system at various locations and airport chaplains and local clergy did their best to console those affected. Newark held a service in a local hotel attended by several hundred people including families of the crew. The service was moving. Father Dave was Newark's chaplain. His comfort and strength proved invaluable during these trying times. For his presence Newark would always be forever grateful.

Since 9/11, when flight crews boarded their flights, fear flew with them. Ever watchful of their passengers, onboard flying with them quickly became an uncomfortable ordeal. Flying the lonely skies thousands of feet above ground now required a character of strength and one of decisive action. Unlike police and firemen, they are there alone, there is no backup. Once trained solely in flight skills now requires meditation and a strong desire to reject intimidation. Many flight crews left the industry, but many refused to submit to fear. Our industry was



temporarily crippled, but our "Phoenix" rose up from the ashes and returned to the skies. To these people America owes a great debt of appreciation.

As this article ends, appreciation is still overdue for many. Countless words have been written within the years, reflecting gratitude for those who answered the call that day, but in the world we live in, yesterday's news is soon forgotten. The names and faces of the crews on the skyjacked flights will probably soon be forgotten. The number of the police and firemen who perished, risking their lives to rescue thousands, forgotten as well and never to be mentioned in a history class and the plight of the common man who sacrificed his daily way of life as well.■
