#### <u>At Large Correspondent – Gerri Adams</u> The James Museum In St. Petersburg, Florida Celebrating Five Years



n April 2018, a brand-new museum opened in downtown St. Petersburg, Florida and it has fast become one of the more accolade additions to the thriving arts community in downtown St. Petersburg. To date, more than 200,000 visitors have enjoyed this world-class museum.


The James Museum provided experiences that inspire a connection through art depicting the peoples, landscapes and history of the American West and wildlife of the word. Currently on exhibit is a selection named Wildlife in Contemporary Art, which has proven to be a family favorite.

From extraordinary sculptures that appear to be ready to buck and ride, to artist exhibits that include Andy Warhol, Ansel Adams, Clyde Butcher and Edward Curtis. There are currently more

than 400 premiere works of art including sculpture, paintings and jewelry on display in the museum's 26,000 square feet of gallery space with a strong emphasis on recent works by living Native American artists from the Southwest. Additionally, visitors will find a gallery featuring depictions of wildlife from around the world.

Despite getting off to a great start after opening in April 2018; the museum closed its doors in March 2020 due to the Covid-19 pandemic. However, that did not stop them. They turned to the internet and began to offer visitors an at home digital first approach to the museum. When the museum reopened later that summer, the staff doubled their ef-





tional opportunities for all ages. It those not often at the forefront of mainstream Western Art. Tours with a docent are available or you can sign up for special events. Once a month on a Tuesday evening, the museum offers a special \$10 entrance fee and remains open until 8 PM. The James Museum is located at 150 Central Avenue, St. Petersburg, FL. #### United hires hundreds from island of Guam for its ramp team at DIA August 30, 2023



Hundreds of islanders from Guam recently relocated to Denver to work for the area's biggest employer: United Airlines.

More than 460 residents of the U.S. territory in Micronesia now call the Mile

High City home after United recruited them for ramp agent roles. Guam is about 6,650 miles from Denver, and was first colonized by the U.S. 125 years ago. As U.S. residents, Guamanians don't need visas.

Magda Morais, managing director of talent and acquisitions at United, said her team faced a "hard time recruiting our ramp agents" in the Denver market, so they had "to get creative."

#### United to Resume Beijing Flying; Reintroduces Daily Service to Shanghai August 11, 2023



United today announces it will resume daily flying between San Francisco and Beijing this November and will increase flying to Shanghai with daily flights from San Francisco, starting October 1, 2023. These enhancements to United's Asia Pacific schedule are enabled by

agreement between the governments of the U.S. and China to increase flights between the two countries.

#### So Simple From Sheryl



This month features another simple but pleasing recipe. Don't tell anyone but this is a Weight Watcher's Recipe. Some people will not eat this if they know our secret. The recipe calls for veal, but it can easily be made with lean sirloin. People love when I make this and they even know it is WW. Enjoy!

#### **Eggplant and Veal**:

1 46 ounce can tomato juice

1 teaspoon garlic powder

2 teaspoons Italian seasonings

1 large can mushrooms, drained

½ teaspoons oregano

2 packages beef bouillon cubes

1 package chicken bouillon cube

1 pound ground veal or ground sirloin

Combine the above ingredients (without the meat) and simmer until juice is cooked down and slightly thickened

approximately 1½ to 2 hours.

Brown the meat in nonstick pan and add to thickened sauce. This sauce can be made a day ahead.

16 thin slices of peeled eggplant

1 can chicken or beef broth

8 ounces grated mozzarella cheese

4 ounces fresh parmesan cheese

Brown eggplant slices in bouillon. (Do not overcook as you do not want it soggy or limp).

Layer a 13 x 9 casserole dish with a little sauce, eggplant, mozzarella cheese, ending with sauce. Sprinkle top with parmesan cheese. Bake 350 for 40 minutes. You could cut this in half but you would waste half an eggplant. This recipe does not freeze well.■



Happy October to everyone from the East Bay Diablos group! As I write this on September 7, there are no 95+ degree days in the ten-day forecast. Thank goodness! I'm looking forward to days where I can garden comfortably and enjoy my patio.

Our group holds in person monthly meetings on the first Monday of the month all year long. The restaurants are still dealing with staff shortages, so we have to give them a count beforehand for our meetings. If you are going to attend our meetings, you must RSVP prior to the meeting. I have put the dates of our upcoming meetings and the RSVP deadlines below. We alternate between The Old Spaghetti Factory in Concord and Black Bear Diner in Walnut Creek. We like The Old Spaghetti Factory because they have both a regular and a senior menu with reduced portions and soup or salad, ice cream and beverage included. They also reserve a room for us. We also like Black Bear Diner because it offers a wide selection of both breakfast and lunch choices. However, they don't take reservations and will not hold a long table for us in the back room. So now we now have a plan. The night before our meeting, I email our count to everyone. The first person there puts our name in for our group to reduce the wait time and so far it has worked out well.

At every meeting we have two raffles, one for money and one for door prizes. We pay two dollars for three tickets and the winner gets a portion of the money collected. The door prizes are whatever people are inspired to bring. We average about 14 people at our meetings throughout

the year, but virtually all our members come to our summer picnic meeting which is a catered BBQ luncheon; and to our December meeting at Zio Fraedo's. Social hour starts at 11:00 and our meal is typically served at noon.

Our September meeting was changed from September 4<sup>th</sup> to the 11<sup>th</sup> due to the Labor Day holiday. I'll report on that meeting in the next newsletter. We will be meeting at the Black Bear Diner in Walnut Creek.

I have been in touch with **Ken Price**'s family and at this point his daughters have decided to postpone his Celebration of Life until after the holidays. I know that there are many retirees from the SFO Maintenance Base who knew Ken, so I will keep everyone updated as I hear from the family.

The San Francisco Bay area has four ships that are unique historical treasures. I am ashamed to say I had not visited any of them until August 12 when I went on a three-hour cruise on the USS Potomac. You know the old saying; you never visit sites in your own backyard. The remaining three are now on my Bucket List. I'm including a bit of info in the newsletter, but for those of you living in the Bay Area, or planning to visit our area, I'm including the websites for each ship so you can read up about them and plan your visit ahead of time.

The first treasure is the USS Potomac in Jack London in Oakland. The website is https:// usspotomac.org/. I cannot believe I did not know about this ship. The Floating White House was originally commissioned as the USCG Cutter Electra in 1934. In 1936, it was renamed the USS Potomac and served as Franklin Delano Roosevelt's Presidential Yacht until his death in 1945. More than half a million people have visited and sailed aboard the former President's beloved "Floating White House," the USS Potomac, since it opened to the public in the summer of 1995. Over a 12-year period, \$5 million was spent to restore the 165-foot-long vessel as a memorial to the President who authored the New Deal and led the United States during the Great Depression and the World War II years. Join us aboard this National Historic Landmark for a cruise on the Bay! After FDR's death in April 1945, the USS Potomac began a long and ignominious decline from her former role in world affairs. After many adventures and many owners-including Elvis Presley at one point—she was seized in 1980 in San Francisco as a front for drug smugglers and impounded at Treasure Island, where she sank. The ship was raised and unceremoniously dumped on the East Bay Estuary, where she sat abandoned and rotting. A week away from being sold as scrap, the ship was rescued by the Port of Oakland, and the process of restoration was begun.

The second treasure is the SS Red Oak Victory which is moored in Richmond, CA. The website is <a href="https://redoakvictory.us/">https://redoakvictory.us/</a>. SS Red Oak Victory is the last surviving vessel of 747 ships of all types built at the Richmond Kaiser Shipyards during World War II. She continues to serve today as a museum ship and as a monument to the thousands of men and women who worked hard to build

these ships in a time of national crisis. The SS Red Oak Victory is also one of the last surviving World War II Victory ships. These ships, along with their cousins the Liberty ships, were built on an emergency basis to carry vital supplies and troops to all theaters of war. The Victory ships remain today as a symbol of the national resolve and industrial might that won the Second World War. The ship is open to the public every Sunday 10am to 4pm. (10AM to 3PM during the winter.)

The third treasure is the USS Hornet Sea, Air and Space Museum in Alameda, CA. The website is https:// uss-hornet.org/. Our members Joe Leather and Russ Kennedy have volunteered on the ship. Both Joe and Russ have worked on the restoration, and Joe still volunteers at the information desk. The ship is open Friday through Monday from 10 AM to 5 PM. One main component of the Museum's mission is the preservation of the ship as she would have been during her time in service. In addition to these restored spaces, the Museum also features traditional museum information exhibits as well as historic aircraft. The Museum features two rotating galleries, one on the Hangar Deck and the other located on the 2<sup>nd</sup> Deck with a growing collection of over 15 historic aircraft. The majority of these aircraft would have flown off of USS Hornet during her career, but all were important to the history and evolution of naval aviation. In addition to the museum hours, there are other events such as overnight stays for youth groups and a New Year's Eve Dance,

The fourth treasure is the SS Jeremiah O'Brien in San website Francisco. The is https:// www.ssjeremiahobrien.org/. The SS Jeremiah O'Brien is one of two remaining fully functional Liberty ships of the 2,710 built and launched during World War II. The O'Brien has the distinction of being the last unaltered Liberty ship and remains historically accurate. Moored at Pier 35, The Embarcadero, she is a premier San Francisco attraction. In June 1943 the Liberty Ship S.S. Jeremiah O'Brien slid down the ways at the New England Shipbuilding Corporation in South Portland, Maine. Shortly thereafter she entered service, operated by Grace Line for the War Shipping Administration. Named for the first American to capture a British naval vessel during the Revolutionary War, the O'Brien made seven World War II voyages, ranging from England and Northern Ireland to South America, to India, to Australia. She also made eleven crossings of the English Channel carrying personnel and supplies to the Normandy beaches in support of the D-Day invasion. After the war, she was "mothballed" and laid up in the Reserve Fleet at Suisun Bay, north of San Francisco. Thirty-three years later, skillful maneuvering by U.S. Maritime Administration official Rear Adm. Thomas J. Patterson (himself a former Liberty ship sailor), saved the O'Brien from the scrap yard. In 1979, after hundreds of hours of labor by volunteer crew members to remove thick layers of preservatives, the O'Brien headed for San Francisco to be restored. No other ship ever has steamed out of the mothball fleet under her own power. Following dry-docking, generous donations of money and supplies by numerous individuals and companies, and thousands of hours of restoration work by her volunteer crew, the old ship entered service on San Francisco Bay in like-new condition. In 1994 the O'Brien, in what was to be an epic eighth voyage, steamed through the Golden Gate, down the west coast, through the Panama Canal, and across the Atlantic to England and France, where the O'Brien and her crew (a remarkable collection of old salts whose average age was 70 and a few cadets from the California Maritime Academy), participated in the 50<sup>th</sup> Anniversary of Operation Overlord - the Allied invasion at Normandy that turned the tide of World War II in Europe. Of the more than 5,000 ships that formed the original D-Day armada, the O'Brien was the only ship to return 50 years later (although smaller vessels from many countries also returned).

According to Feeding America, an estimated 160,000 military families experienced difficulty putting food on the table in 2020. Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me at 30 San Piedras Place, San Ramon, CA 94583-3018. This is such an easy thing to do to support our troops. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer's Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. In my area, the coupons come in Tuesday's mail along with the supermarket ads, and then in the Sunday paper. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated. I get so excited when I get a coupon for eggs!


I am so grateful for the kindness of all the RUAEA

From now through May 2024, I'll be turning in coupons at my DAR meeting the first Saturday of the month. Everyone is telling me that they are not getting coupons like they used to. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons. 



And now, another walk down memory lane ~ New York's World's Fair 1939-1940: Every kid growing up has some great event that stays in their memory forever. Mine was a visit to New York's World's Fair in 1939 and in 1940, in Flushing New York. I was 10 years old, and I don't remember much about the grand opening, but I do recall many people talking

about it and saying Pres. Roosevelt would be there to do the opening honors. My mother who was caught up in the world's fair mania, went out and bought a beautiful royal blue rug for the living room, and in the center was a gold pattern of the Fair's Logo, the Perisphere and the Trylon. I know she took great pleasure in showing it off to all of her friends and neighbors. All this meant nothing to me, until my mother said one day she was taking me to see "the fair"; I immediately ran out of the house and told all my friends of the coming attractions. Getting there from Paterson, New Jersey was not as easy as rolling off a log. First we had to take the bus to downtown Paterson then walk over to the Erie Railroad station on Market Street and that took us to the Chamber Street ferry in Hoboken; when you got off that ferry, then had to take the subway to Penn Station in New York in order to get to the Long Island railroad out to the fairgrounds. While Tom Sawyer, and Huck Finn had their adventures, now at the tender age of 10, I can tell you that mine are just as great.

There were four things that I remember that come to mind: Aviation and railroad buildings, General Motors, and the Perisphere and Trylon. Many of the exhibits were hands on and you can imagine how I felt as a youngster, to make believe that I was flying or in control of a gigantic steam locomotive. My mother was always at my side prompting me to move on because there was so much to see. At the General Motors building, there was the famous "Futurama" exhibit that attracted long lines of people. When you finally got in and sat in a revolving seat and looked down, you saw a vast panorama of what the future may look like. As you rotated around the exhibit, a speaker in your seat described everything. When you come to think about it, not much has changed except now we have more cars, more traffic and a never ending struggle to control pollution. Anyway, there is no such thing as "the good old times". I'm not willing to go back, and I don't know anyone with those kinds of ambitions. To cap everything off, the Perisphere was the greatest of all exhibits. There was an escalator that took you up into a revolving platform of this massive globe. Along the walls, there were continuing displays of pictures of Americans at work in all stages of our industry. What an impression that left with everyone who saw it.

My mother had taken me twice to the fair in 1939 and twice in 1940. I vividly remember the lights going out on the French Pavilion in 1940 and then playing their national anthem because they had surrendered to the Germans in World War II. At the railroad building, my mother bought me a train engineer's hat, and a pair of goggles. Yes with my imagination I was the mighty Casey Jones driving the old "Wabash Cannonball" at full speed down the tracks. That hat and goggles, I had for the longest time are long gone, but those wonderful memories are still with me to this very day.



# <u>The Holiday from Hell</u> <u>By Lt. Col. USMC Ret. James "Chris" Klinedinst</u> <u>Slightly edited by Marvin Berryman</u>

t is 8:45 on Tuesday morning, 18 September 2001, and here I sit, in my fifth floor condominium, staring at the luxurious yachts tied up at Christie's Landing in Newport, Rhode Island. A week ago this past Sunday, I left Hershey, PA and drove to New York City, passing through the Lincoln Tunnel, across Manhattan on 34<sup>th</sup> Street, through the Queens Midtown Tunnel and on to Garden City on Long Island. Cousin Kim and Paul Martirano live in Government Quarters near old Mitchell Field. They were to be my hosts on the first leg of my trip to New England.

The plan was to spend several days with Kim and Paul and their two sons, Zachary and Gabriel. Then Ron Crabb and the Warrens, three of my friends from Exeter, Devonshire England, were scheduled to arrive Thursday evening at Boston's Logan Airport. I was to meet them and be their tour guide for a ten day holiday. Our base was to be Newport, from which we could make excursions to Mystic Seaport, the Coast Guard Academy at New London, the USS Nautilus at the submarine base in Groton and Old Ironsides, the USS Constitution in Boston. The fabulous "summer cottage" mansions of the Vanderbilts and others of the rich and famous of a century ago, as well as the sheer excitement of Newport itself, was to be the icing on the cake.

On Monday, September 10<sup>th</sup>, Paul, Kim and I took the train to Manhattan and spent a lovely day playing tourists. Paul had managed a day off from his job as Commanding Officer of the New York Naval Reserve Center located in the Bronx. We considered going to lower Manhattan for a trip to Ellis Island, but instead enjoyed a tour of the NBC studios at Rockefeller Center and finally lunched on the most monstrous sandwiches imaginable at Paul and Kim's favorite deli on 7<sup>th</sup> Avenue.

#### But the good times were soon to end.

The next day, Tuesday, the 11th of September 2001, Paul went off to work in the Bronx at 4:30 a.m. After sons Zachary and Gabriel were shuffled off to school, Kim and I set off for King's Point on the East River. Kim wanted to show me the Merchant Marine Academy as well as attend to some business at the Navy Federal Credit Union on base. I welcomed the chance to access an NFCU ATM. During our drive to King's Point, Kim's cell phone rang.

#### It was Paul. I heard only Kim's, "Oh, my God," and "Oh, no!"

He had told her that a plane apparently had crashed into one of the World Trade Center towers. We were dumbfounded. We arrived at the academy gate about 10:00 a.m. Kim drove past NFCU and to the waterfront where we parked, got out and then peered down the East River toward lower Manhattan. We could see, amidst the black smoke, only one tower standing. Another spectator said he had seen, only moments before, the other tower collapsing. We were soon cautioned to move the car from the waterfront as they were going to barricade the area. (To be concluded next month)

The UAHF Board of Directors voted to have the William S. Arnott Scholarship Fund (chaired by Dale Dopkins, UAL Captain Ret.) to be sent as an Endowment to Southern Illinois University for university aviation students. After some other contributions to the Fund were made, the total of \$25,000 was recently transferred to S.I.U. This is in memory of UAL Captain Bill Arnott for his tireless organizational and financial efforts to establish UAHF years ago along with the Scholarship Program.
