## **How To Minimize Taxes on Your Estate? By Malcolm Horn, CFP**®

#### How can I minimize taxes on my estate?

This question may seem simple, but the answer is not so easy. In fact, there are experts who make their living answering just this question.

Estate tax liability depends on the year in which you die and the value of your estate when you die. For instance, in 2025, the value of the estate on which the estate tax may be imposed (that is, estates in excess of the applicable exclusion amount), is \$13,990,000, plus any deceased spousal unused exclusion amount. After 2025, the amount is scheduled to be cut by about one-half.

Thus, you can minimize estate tax by reducing the value of your estate until it is below the applicable exclusion amount. There are many ways you can accomplish this. The best way(s) for you may not be the best ways for others and vice versa. (Note: We're discussing only federal estate tax here. Your estate may also be subject to state death taxes. See a tax attorney for more information about state death taxes.)

One way is to make lifetime gifts. Be aware, however, that certain lifetime gifts may trigger gift tax. Gifts that do not trigger gift tax include the following:

- ♦ Gifts made to U.S. citizen spouses and certain charities
- Gifts of \$190,000 or less made to non-U.S. citizen spouses (in 2025)
- Certain payments made for tuition or medical expenses on the behalf of others
- Gifts up to the annual gift tax exclusion amount of \$19,000 (in 2025)
- Gifts made that fall under the applicable exclusion amount (Note: Any portion of the applicable exclusion amount used for lifetime gifts effectively reduces the applicable exclusion amount that will be available for estate tax purposes.)

See a tax attorney for more information about federal and state gifts taxes.

Another common technique to minimize estate taxes is to transfer assets to an irrevocable trust. Such a transfer may be subject to gift tax on the value of the assets at the time of the transfer, but the assets, plus any future appreciation, are removed from your gross estate. There are many types of irrevocable trusts, each created for a

specific purpose. Be aware, however, that as the name implies, an irrevocable trust cannot be revoked or amended.

This is just a brief glimpse of some of the techniques used to minimize estate taxes. For more information, or to discuss how these techniques might apply to your own situation, you should consult a qualified tax attorney.

San Diego Historic UA Hangar on the Move! In 1929, the SAN airport was born at its current location, on Pacific Highway. A terminal building and three other buildings were constructed. One building was built by Pacific Air Transport to be a terminal and hangar.

By the time the building was finished in May of 1931, four companies had joined to form United Airlines. The three other buildings, including the Ryan terminal were demolished in 1952 but the UA hangar was





moved about ½ mile west, near Harbor Drive. UA serviced the Boeing 247D, the Douglas DC-3 and DC-6 from the hangar. It had various other airport uses in the 1952-2022 time period, but then the airport was to expand again, to 30 new gates.

The plan was to demolish the hangar but various groups noted its historic status as the only building from the original airport, so it was disassembled piece by piece and moved again and reassembled with original parts at the intersection of Palm and Pacific highway, only 300 feet from its original location. This is a \$2.4 million project done by Soltec Engineering of San Diego who are committed to maintaining the historical authenticity while integrating modern updates to insure its long-term functionality.

The structure is on airport property, but outside of the ops area (AOA). The airport has not indicated planned use, but it is hoped some sort of aviation museum could occupy the hangar. Thanks to the airport for preserving this little piece of United history and legacy.

# More Than Half a Billion-Dollar Expansion & Modernization Coming to United's Washington Dulles Hub December 3, 2024

United and the Metropolitan Washington Airports Authority (MWAA) today celebrated the airline's growth and airport construction developments of the much-anticipated, more than half a billion-dollar Con-



course E that will transform the customer experience over the coming years at Washington Dulles International Airport. The 435,000-square-

foot, 14-gate concourse will include an expansive new United Club<sup>SM</sup> location and state-of-the-art customer amenities that are expected to debut in late 2026.

The new Concourse E is made possible in part due to collaboration between United and MWAA, and local and federal funding such as grants from the Bipartisan Infrastructure Law for airport improvement projects that will help facilitate Dulles' expansion.

United is the D.C. region's largest airline, with more than 8,000 local employees and more flights and destinations than any other carrier. As part of United's ongoing growth and commitment to the region, United will open a new flight attendant training center in 2025, and the airline is expanding its network even further with exciting new destinations and is currently operating 25 percent more flights as compared to 2023.

"Washington Dulles has emerged as a global gateway and these new investments will help deliver the world-class facility that our employees and customers deserve," said United CEO Scott Kirby. "Today is one of many milestone celebrations to come in United's long-term commitment in advancing our Dulles hub."

United has invested more than \$32 billion across its business since 2021. This Dulles expansion and modernization follows similar investments at airport facilities in Denver, Houston, and Newark, and is part of the airline's United Next plan to invest in infrastructure, people, and technology.

"Dulles serves as a critical economic development hub for Virginia and helps travelers get where they need to go. I've been proud to help secure federal funding from the Bipartisan Infrastructure Law to expand the concourses, which will make traveling to and from the airport more convenient," said Senator Tim Kaine. "I'm thrilled to celebrate the construction of this new concourse because it will enhance the experience of every traveler who walks through the airport. I thank United and the Metropolitan Washington Airports Authority (MWAA) for their partnership in this effort."

"Every day, Dulles Airport serves tens of thousands of passengers coming in and out of the DMV region. I'm glad to see this major expansion build on the historic investments we've made through the bipartisan infrastructure law and support the construction of the newest concourse at Dulles," said Senator Mark Warner. "I look forward to seeing Concourse E come to life with 14 additional gates that will increase flight options

and state-of-the-art facilities that will improve the experience of air travelers."

New Concourse to Modernize Dulles ~ Construction is underway on the new Concourse E, which will exclusively house 14 dedicated United gates that will bring additional space to accommodate United Next's new widebody and mainline planes, which will continue to debut over the coming years.

The modernized concourse will greatly enhance the Dulles experience for United customers, including adding direct and easy access to the airport's existing Aerotrain station that allows for smoother transport between the main terminal and other concourses. The United gates will feature the latest traveler amenities and technology, expansive gate seating, along with concessions and retail space.

The concourse will also be home to a new 40,000-square-foot United Club. This will be one of the largest United Club locations in the network and will subsequently increase the United Club square footage space at Dulles by 70%.

The 14-gate concourse is one phase of a long-term, multi-phase project for United's growth at Dulles that is part of MWWA's master plan for the airport's future.

"Washington Dulles International is a key economic engine for the National Capital Region, and United Airlines is our essential partner in the rapid and ongoing growth of the airport," said Metropolitan Washington Airports Authority President and CEO Jack Potter. "United's commitment to Dulles – through its support of the new concourse, its long-term expansion plans, including new flights and destinations, investment in new training and technical facilities and the addition of thousands of local jobs – is a testament to the strength of our partnership in promoting regional economic growth and pursuing our mutual goal of providing world-class service to the traveling public."

Expanded Flight Network Connects D.C. to Even More Destinations ~ United is the D.C. region's largest airline, offering more flights and destinations than any other carrier. As a result of its ambitious United Next growth plan, the airline continues to expand its flight network out of Dulles. To-date, United has grown to more than 250 daily departures with plans to grow to nearly 280 daily flights by April 2025.

This year, United launched 13 new domestic routes from Dulles – that is more new domestic routes than any other U.S. carrier has added from any U.S. airport this year. Among those new routes are the only nonstop service from the D.C. region to Anchorage, Alaska and Mobile, Alabama, as well as upcoming service to Palm Springs, California that begins December 19.

United serves as a crucial gateway between our nation's capital and the rest of the world, this includes nonstop service to over a dozen world capitals from Ac-

cra and Brussels to Mexico City and Tokyo and places in between. This summer, United will add a new world capital destination with the addition of its inaugural nonstop service to Dakar, Senegal\* beginning May 2025.

As United's operations at Dulles continue to grow as a transatlantic gateway to the world, this summer United will be the first airline to offer the Washington region nonstop service to Nice, France and Venice, Italy.

<u>Local Impact</u>  $\sim$  As one of the largest employers in Loudoun County, United is an employer of choice for many across the Washington region. With its historic growth, in the last two years, the airline hired more than 30,000 people systemwide and plans to hire about 9,000 more in 2024, including more than 700 people in the Washington D.C. area.

United has called Washington Dulles International Airport home for nearly four decades and continues to grow and invest in the Washington region. United recently announced construction is underway to open a new 20,000-square-foot state-of-the-art Inflight Training Center near Dulles Airport in 2025. ## <u>United Sees Nearly 30% Surge in</u> <u>Travel to European Christmas Markets</u> November 19, 2024



United today reported bookings to European destinations are up nearly 30% compared to 2019 and up almost 10% versus last year, as more Americans opt to spend their holiday dollars on experiences. According to a recent Deloitte survey, consumer spending on holiday experi-

ences is expected to rise 16% this year, while spending on physical gifts remain flat.

Europe's markets are a cultural tradition dating back hundreds of years, and millions of people from around the world visit them annually to experience festive offerings like mulled wine, artisan crafts, live music, picturesque scenery and more.

As the world's largest airline, measured by available seat miles, United is ready for its busiest holiday season ever and plans to offer nearly 60 nonstop flights each day from its U.S. hubs to Europe in November and December, more than any other U.S. airline. United ranked first or second in on-time departures among the eight largest U.S. carriers for the last 5 months in a row, including during its busiest summer ever.

- ★ Weather preparedness: The airline will prepare approximately 150 de-icing trucks to ensure aircraft are ready for flights despite lower temperatures.

Dublin is a walk-able city with the River Liffey dividing the city roughly in half horizontally, east to west, with O'Connell St. bridging the river from the north to the south bank. A tram system named Luas



(Irish for *fast*) offers easy, economical routes throughout the city. Purchase your tram ticket before boarding from the vending machines at any stop. You don't need cash as credit cards are acceptable nearly everywhere. Tickets are valid for multiple trips within 90 minutes. Another fun way to discover the city is with the green double-decker sightseeing buses called Do Dublin. They offer a 1:45 hr. one-way circuit throughout the city beginning and ending on O'Connell St. The bus is moderated by informative (and sometimes comic) drivers who stop at 25 destinations including Trinity College, Guinness Storehouse, St. Patrick's and Christ Church Cathedral, Jameson Distillery, Dublin Castle, and Temple Bar. Tickets are valid for 24 consecutive hours, allowing you plenty of time to stay onboard for the whole loop first and then take a break to decide what stops you want to explore before re-boarding ... even the next day. See www.dodublin.ie for more information. And speaking of Trinity College, if you wish to view The Book of Kells (and/or the Long Room library), you must purchase your ticket in advance at www.visittrinity.ie. No tickets are sold at the college. The same rule applies to



the Guinness Storehouse Tour & Gravity Bar. Check out www.guinness-storehouse.com for ticketing information. The view and the beer from the Gravity Bar at the top of the Storehouse makes this a must-see for first time visitors. And nearly every pub offers "trad" music (live, local musicians) beginning at 9PM most evenings.

Venturing away from the city to experience the beauty and history of Ireland is easy. Dublin has 2 train stations: Connelly Station, Ireland's busiest train station, primarily serves routes north to south (Belfast, Derry, Waterford, Cork), while Heuston Station primarily serves the west coast and southwest (Galway, Limerick, Killarney). Railtours Ireland (<a href="www.railtoursireland.com">www.railtoursireland.com</a>) offers one-day, hosted, roundtrip tours for independent travelers, as well as multi-day trips if you have the time. The one-day trips generally depart Heuston station at 7AM and return to Dublin around 9PM. You reserve in advance for desti-

nations such as the Cliffs of Moher, the Ring of Kerry, the Wild Atlantic Way, or the Connemara Coast. After checking-in at a special booth in the station, you are escorted to reserved seats on the train and then met by a Railtours Ireland guide at the destination station. You then board a bus with other passengers for the entire day, stopping at major sights, with commentary along the way. Around 7PM you board the return train to Dublin. Entrance fees are mostly included but not food or beverages. Think of it just like a shore excursion from a cruise ship. It is definitely a great way to avoid rental cars with right-hand drive and navigating narrow, twisty Irish roads! And if you book 2 different tours, you'll receive a free Do Dublin pass, valid for 48 hrs! I booked 2 rail tours, one to visit the Connemara coast and Kylemore Abbey, and a second tour to the Ring of Kerry; reserving these tours in advance for a Tuesday and Friday left 48 hrs of free time in-between to use the Do Dublin pass. It worked like a charm.

I decided to switch transportation modes and try another one-day tour, this time by bus to Belfast and Giant's Causeway. After researching various compachose Wild Rovers nies, (www.wildroverstours.com). It was great! Boarding the bus on O'Connell St was easy and 2 hours later we arrived at our first stop: Belfast. When you book the tour, you make a choice to visit either the Titanic Experience Museum or take a Black Cab Taxi tour of Belfast's divided city. The taxi tour was, by far, the highlight of our entire visit to the Emerald Isle. A local Irish driver escorts up to 4 people in his own traditional black cab and explains in great detail "The Troubles" and how the carving-off of 6 northern counties to be governed by the UK back in 1921 affects residents on a daily basis, even today. You will visit the famous murals that cover the walls separating the 2 sections of the city, as well as walking through the gates that close every evening at 6:30PM and do not reopen again till 6:30AM. These gates are closed all day on Sundays. The driver acquaints you with the political atmosphere and hopes for the future of a reunited Ireland. You are then returned to meet your bus at the Titanic Museum, which affords you time to see the shipyard exterior and some of the free museum exhibits inside. It's really like a bonus!

Leaving Belfast, you head towards the rugged northern Irish coastline to the Causeway Coast ANB (Area of Natural Beauty). Here lies the remains of 500 yr old Dunlace Castle, the historic seat of Clan Mac-Donnell. You are free to wander all around the grounds and ruins and capture panoramic views over the cliffs. If the weather cooperates, you may even glimpse the coast of Scotland in the distance.

Just a short distance to the east brings you to Giant's Causeway, a UNESCO World Heritage Site. Here are hundreds of vertical basalt columns that you have seen

in posters. Legend states that a giant named Fionn Mac Cumhaill (Finn MacCool) was challenged to a fight by another giant in Scotland named Benandonner, to determine who was greatest. The causeway was supposedly built from torn fragments of the coastline rocks fired into the water and walked upon by Finn MacCool. (There are several derivations of what happened next, depending on if you are Scots or Irish!) Scientifically, ancient volcanic activity created these flat-topped columns that stretch out into the Sea of Hebrides. Visitors are allowed to walk out onto the columns but be cognizant of the encroaching high tide which nearly covers them all, twice daily. It is quite a long steep walk down to columns (and an exhausting walk back up) but thank goodness there are little shuttle buses that constantly make the 1-mile loop from the road to/from the beach for the small sum of 2 Euros. It's worth it! And before you board bus back to Dublin, take the opportunity to eat some excellent Irish food at the nearby pub, The Nook.



Irish Rovers can take you on another enjoyable out-and-back one day visit south of Dublin to the Wicklow Mountains and Glendalough. You'll amble through the charming town of Kilkenny, with its 13<sup>th</sup> century Ross Castle, then enjoy a relaxing, contemplative


respite at the ancient monastic site of Glendalough, which translates as "the valley of the 2 lakes". Here you are free to roam through the silent ruins and sacred grounds and walk under trees of one of the last remaining Irish forests to shores of Upper Lake. The scenery is emotive, and some visitors come here for self-reflection and meditation classes. I had the solitude of the lake totally to myself for quite a while until a friendly dog begged me to play fetch with his giant "stick"! The last stop is Cullan's Hill Sheep Farm, the perfect ending for the animal lover, like me. Live demonstrations of working sheep dogs marshalling and corralling sheep at the farmer's command and learning about the management of these types of farms was riveting. And the cherry on the top was the opportunity to hold some of the lambs! Don't miss this.



I hope this overview of Ireland's treasures will resonate with some of you and your families. And if you're not fond of Guinness, ask for a half-pint of what's called "Guinness Black" - typically ordered for the ladies as it combines the sweetness of black current liqueur with the stout of Guiness. Sláinte! (that's "cheers" in Irish).

President **Russ Kennedy** starts our meetings by leading us in the Pledge of Allegiance. At every meeting, we have a raffle for money and door prizes. We pay two dollars for three tickets. The door prizes are whatever people are inspired to bring.

Our December meeting, normally held on the first Monday at Zio Fraedo's in Pleasant Hill, was moved to Tuesday, December 10 at the Old Spaghetti Factory in Concord, for several reasons. With Thanksgiving falling so late this year, several members were still traveling on December 2. The following Monday was a conflict with the RUPA Christmas Luncheon. Everyone present at the November meeting was available on December 10, so that became our new meeting date. We also changed the venue for our Christmas luncheon.

For years, we have met at Zio Fraedo's in Pleasant Hill for a delicious banquet of Prime Rib, Salmon or Chicken Cordon Bleu. As with all restaurants these days, prices have gone up a lot, and this year's price was going to be \$65.00 per person. The members voted unanimously to forego the banquet and go to the Old Spaghetti Factory instead where we will order off the regular menu. It's sad to see a long standing tradition discontinued but we will still have a wonderful time. Restaurants have raised prices due to increased costs for wages and food. People are staying away due to higher costs and then restaurants are raising prices to make up for the smaller

If you want to tip 15% you have to manually enter the dollar amount—guilt trip anyone? I recently went to my favorite Mexican restaurant for lunch for the first time this year. What used to be the two item combo lunch at \$14 was now \$21. Then add on 10% tax, tip of 15% to 18%, and the latest charge, 3% for using a credit card, and my lunch was \$30 out the door. The food and service was excellent as always, but sadly, this has now moved into the luxury category in my budget. Several of my friends have stopped eating out altogether. Having my friends validate my frustration makes me feel less of a cheapskate, thankfully!

And now for a PSA that I hope many of you will check out, consider buying, and find very useful. Since the beginning of 2024, I was practically homebound because I could hardly walk. Long story short, I ended up having right knee meniscus repair surgery in June and total right hip replacement in September. Thanks to excellent surgeons, physical therapists, and exercises, I am now walking again. One of my friends told me about this wonderful assistive device which she used on outings with her 99-year-old father. She brought it when she took me to doctor visits after my surgeries. It's a grab handle that slips into the car door handle so you have something to hold onto at arm level vs. having to grab onto a bar over your head inside the vehicle. I have affectionately named it My Gizmo. I bought it on Amazon for \$9.99; they also sell two for 17.99. The Kounatsuri brand is distinguished by the striped handle and a well defined "cut out" that fits the handle se-You can search for it under "car door handle curely. for elderly." It also has a seat belt cutter and a tip that can break a window in case you drive into a lake. Ha ha! But seriously, if it keeps one person out there from falling, it will be a godsend.

**Jan Soderstrom** is collecting coupons for the charity Support our Troops. This is a service project of her Daughters of the American Revolution (DAR) chapter. According to Feeding America, an estimated 160,000

military families experienced difficulty putting food on the table in 2020. Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me at 30 San Piedras Place, San Ramon, CA 94583-3018. This is such an easy thing to do to support our troops. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer's Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too; however, please send in coupons at least every other month so the troops have a longer time to use them. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated - food, nonfood, baby and pet; and current and expired.

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022. On December 7, I turned in 788 coupons. My total for 2024 is 16,005 coupons! Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. All the coupon cutters are telling me that they are not getting coupons like they used to. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons. If it weren't for the RUAEA folks from all over the country sending me coupons, my chapter would have very few coupons. This month I received coupons from Mary Brennan in MN, Marilyn Carle in IL, Ginger Dahlberg in CA, Francis Domaratius in CA, Marilyn Evans in CO, Martha Gooselaw in CO, Diane Griego in CA, Barrie Hooley in IN, Glenda Kennedy in CA, Marcella Kern in NJ, Carol Koslosky in NY, and Jim Taylor in FL.

Consider donating a bottle of salad oil too. \*Spices or salt and pepper would be a real gift. \*Tea bags and coffee are special when they get them. \*Fresh produce and eggs are a luxury (in our case, we don't bring perishables). \*Seeds are a great donation in spring and summer when growing can be easy for some. \*Cans of tuna and crackers are great food consider adding a jar of mayonnaise. \*Hamburger Helper is often donated but they are unable to get ground beef. \*They get a lot of peanut butter and jelly but rarely any sandwich bread. \*Butter and margarine are greatly appreciated. \*Dish soap/detergent is always appreciated. \*Feminine hygiene products are a luxury and women will cry over that. \*Everyone loves Stove Top Stuffing. \*Also, please consider donating dog and cat food. Some people have hit a temporary low point and don't want to give up their pets but find that they have to choose to feed their families or their pets. Thank you, Bill for these suggestions.

I'd like to add that while wandering thru the grocery store, I noticed that items like little individual containers of fruit or applesauce would be a good idea. As mentioned above - pull top lids are such a convenience. Crackers can be combined with any meal. 



This makes United the only airline that allows pass travel booking on the commercial app, as well as the only airline that allows pass riders to book themselves (app or web).

You will no longer have to be the "travel agent" for your pass riders. To book your pass riders they will have to have a Mileage Plus account. The steps are as follows:

- 1. Go to My Profile Tab in EmployeeRes
- 2. Click on the Manage profile link
- 3. Click on the Traveler profile tab
- 4. Click on the down arrow associated with your pass rider
- 5. Click on the Link MP account button
- 6. Enter their Mileage Plus number

- 7. Click Confirm
- 8. Click Close

I just did this for my two sons who are my Enrolled Friends and it was super easy. This is huge for us to be able to do this and what a privilege it is. Ok, now on to the egg salad sandwich in Japan<sup>©</sup>.



## Stapleton Airport's Last Day By Terry J. Snyder, United Airlines Retiree



The quiet before the crowds – crossing over the space-age pedestrian bridge from parking lot to terminal was a comfortable transition. For those dropped off at the terminal, they got to enjoy a section of the historical original edifice of pre-international Stapleton Airport adjacent to the control tower before arriving at the terminal ticket counter section. Airline offices took up the second floor of the Terminal, with retail shops and restaurants on the main floor.

You have to give Denver credit, they kept improving Stapleton pretty much up to its demise. United widened Concourse B and enlarged Concourse A for mainline jets. A mere few years before Stapleton closed, a new Concourse E was added to the northwest of the terminal, so customers didn't have to suffer as air travel increased dramatically into the 90s. Denver Mayor Federico Pena got the approvals for, and much of the construction of, Denver International out on the plains away from civilization (thus getting the new access highway named after him), but it was Mayor Wellington Webb who suffered the headaches for DIA's serious opening delays due to the baggage system fiasco. Truth be told, we employees were grateful for the 16-months of extra time at Stapleton. But by the time the new airport was ready to open, most folks were in a celebratory mood when Mayor Webb came out to bid Stapleton goodbye in front of many front-line airport employees.
