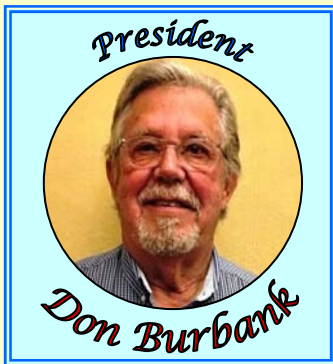

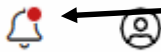

Travel Liability Payment Process
(Imputed Income – Enrolled Friend and Domestic Partner Taxes)

In response to several requests related to the online payment process for pass travel imputed income, we have pulled together a very simple step by step quick reference guide. While Employee Travel doesn't have a quick glance reference they did review and offer a few changes to assist in the process.

Payment by Mail

1. Sign on to Flying Together
2. From the landing page select "Employee Services"
3. From Employee services select "Health & Insurance (YBR)"
4. This will bring you to the YBR (Alight landing page). Look to the top right corner for a Bell and red dot. The red dot indicates you have an alert or an item in your secure message mailbox, tap on the bell.



Select the tab for Secure Mailbox, this always defaults to notifications.

Once in your secure Mailbox, you will see your secure document, Travel Liability Statement in PDF form, click on the statement to open your Travel Liability Statement.



Print the PDF

Cut the bottom portion of page 1. It's the payment coupon and there is an image of small scissors on the page where you are going to cut.

Make your check or money order payable to United Airlines for the total amount due (do not send cash or foreign currency).

Write your account number on your check or money order.

Put your payment coupon and check or money order in an envelope – don't forget the postage.

Payment by Computer

1. Sign on to Flying Together
2. From the landing page select “Employee Services”
3. From Employee services select “Health & Insurance (YBR)”
4. Once the landing page has loaded, scroll to towards the bottom until you see Quick Links “View All”. This will bring up all live links for your profile.



If the Pay Now - Travel Tax Liability link is showing, then you have an invoice waiting to be paid. Click on the link and follow the instructions given.










Four Steps to Valuing an Estate **By Malcolm Horn, CFP®**



Determining the value of an estate is a fundamental first step in estate management and a critical requirement for settling a decedent's estate.¹

How to Assess the Value of an Estate

1. Select the date of calculation. Because values move up and down, you need to set a specific date for a valuation. For a living person, you are free to pick any date. If you're assessing the value of a decedent's estate, you may choose either the date of death or the date six months after their death (the "Alternate Valuation Date"). If you use the Alternate Valuation Date, any asset sold or distributed during the first six months following the death must be valued as of the date of sale or distribution.²
2. Determine the assets comprising the estate. This asset list should include everything an individual owns or has ownership interests in.
3. Gather all financial statements as of the date of calculation. If an account is owned individually, the entire value should be calculated in the estate. If owned jointly with a spouse who has rights of survivorship, then 50 percent of the value should be included. Remember to:
 - Deduct any outstanding mortgage balance.
 - Include life insurance when the policy

owner is the deceased individual, or the beneficiary is the decedent's estate.³

4. Calculate deductions. Subtract any debts from the total value of assets. For the decedent, this may also include any regular bills that may be due (e.g., utilities, medical expenses, etc.), charitable gifts, and state tax obligations.

Assessing the precise value of an estate can be complicated, especially when settling an estate. Please consult a professional with estate expertise regarding your individual situation. **Changes to printable boarding passes
for SA0 and SA1 travelers
June 4, 2024**



Effective June 12, 2024, employees, active retirees and eligible enrolled friends traveling on standby space-available passes domestically (SA0 and SA1) will need to use the United app to access their boarding pass. Printing boarding passes at airport kiosks will

no longer be available for SA0 and SA1 passes.

Our goal is to reduce paper boarding passes, which are often out of date as soon as they're printed. Using the United app gives customers the most up-to-date information and the best experience possible.

Employee/Retiree Vacation ePass Travel & Regional Partner Personal Travel on own metal (previous reference code A*) - SA0V and Regional Partner SA0X:

- ▲ Employee, retiree & their eligible **accompanied** pass riders traveling on a vacation ePass
- ▲ Employee's & retiree's **unaccompanied** spouse/domestic partner & **accompanied** pass riders traveling on a vacation ePass
- ▲ Unlimited extended family buddy pass riders **accompanied** by the employee or the employee's spouse/domestic partner traveling on a vacation ePass (includes retiree when eligible)
- ▲ Maximum of two regular buddy pass riders per employee ID **accompanied** by the employee or the employee's spouse/domestic partner traveling on a vacation ePass (**includes retiree when eligible**)
- ▲ **Operating regional partner employees & their eligible** accompanied pass riders will board **equal** to SA0V **when traveling on their own metal**, using years of service to the company to prioritize

Employee Personal Travel (previous reference code B*) – SA1P:

- ▲ Employee & their eligible **accompanied** pass riders
- ▲ Employee's **unaccompanied** spouse/domestic partner & **accompanied** pass riders
- ▲ Unlimited extended family buddy pass riders **accompanied** by the employee or the employee's spouse/domestic partner
- ▲ Maximum of two regular buddy pass riders per employee ID **accompanied** by the employee or the employee's spouse/domestic partner

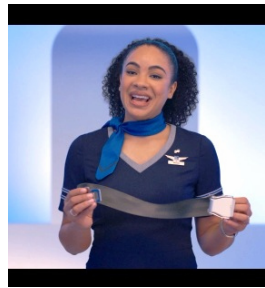

United Airlines Debuts New Onboard Safety Video **May 16, 2024**

United today debuted a new onboard safety video where more than a dozen United employees provide clear, easy-to-follow demonstrations of critical safety procedures. The video was filmed inside a life-sized, airplane-inspired sequential reaction machine, with a creative concept designed to capture and keep the attention of even the most frequent fliers. Development of



the new video began in June 2023 and was inspired by the teams of United employees whose coordinated actions ensure the airline operates safely. The new video will debut on select aircraft starting May 25 and will roll out across the fleet over the summer.

“Safety is the foundation of everything we do at United,” said Sasha Johnson, Vice President of Corporate Safety for United. *“Safety starts with being prepared. We have ongoing, rigorous safety training for our crews. And we also make sure our customers know what to do in the event of an emergency. We are proud that our new safety video empowers passengers by giving them information and clear instructions.”*

United worked with the Federal Aviation Administration (FAA) on the development of the safety video beginning in October 2023 through March 2024 when the video was approved. This included multiple checkpoints along the production process, including review of the storyboard and script before filming even began to ensure the content met the FAA requirements.

United’s New Safety Video by the Numbers ~ The new video – titled “Safety in Motion” – follows a ball as it makes its way through the sequential reaction machine, rolling and bouncing through airplane-inspired set-ups that include chutes, a snack cart and drink cup, seatbelts, windows, seats, directional signage and more as real United employees demonstrate key safety procedures.

“The safest safety video is one that passengers actively watch. Our creative concept was inspired by the idea of connection and the many moments of any given day that our employee work groups have to connect to be able to get thousands of flights off the ground and to their destinations safely,” said Maggie Schmerin, Chief Advertising Officer for United. *“We worked across the airline to ensure our new safety video clearly and succinctly communicates critical information in a way passengers can’t help but watch – no matter their age, background or experience traveling.”*

- ▲ 171 customized versions of the safety video to accommodate United’s 8 different aircraft types, 20 various seat configurations on those aircraft and 18 languages
- ▲ Ten months in the making – Creative development on the new video began in June 2023; filming took place in October 2023 and then the team spent the next five months on edits and translations before the March 2024 FAA approval
- ▲ 12 individual contraptions the ball passes through in the machine

- ▲ 17 employees from across the airline, including flight attendants, pilots, customer service agents, ramp service, tech operations, the network operations center and reservations
- ▲ More than 1,000 real dominoes
- ▲ A 100-year old song, “Rhapsody in Blue” by George Gershwin, that’s been a consistent feature in United safety videos over the years

The airline’s creative agency of record, 72andSunny, production partner, 1stAveMachine, and award-winning director Karim Zariffa worked together with United to execute the complex camera production for the video.

United Investments in Safety Training ~ “Safety in Motion” demonstrates key safety procedures, mandated to all U.S. airlines by the FAA and critical to passenger safety in case of an emergency. United features real employees in the video, who go through a regular schedule of updated training sessions throughout their United career. For example, the airline’s pilots complete simulator training with instructors and evaluators every nine months and flight attendants refresh their qualifications every 18 months. United recently opened a new 150,000 square-foot building at its Flight Training Center in Denver. Already the largest facility of its kind in the world, the Flight Training Center has eight total buildings, more than 700,000 square feet of training space and now has more than 52 state-of-the-art full-motion flight simulators – providing even more training capacity for the airline’s 17,000 pilots. Last year, United also expanded its largest Inflight Training Center, located in Houston, to include new classrooms, additional cabin and door trainers and a state-of-the-art aquatic center to practice the safe evacuation of the plane in the unlikely event of a water landing. And since 2020, United requires pilots to participate in an annual Pilot Professional Development training. This full-day, interactive, in-person training exceeds FAA requirements and industry norms by mandating all pilots, not just captains, participate. The training also uses actual United case studies to ensure the airline’s pilots excel in self-awareness, confidence, mentoring, and leadership. United worked closely with its Flight Training, Flight Standards and Aviation Safety teams plus ALPA in the 100 percent safety-focused curriculum.

United Expects Record Setting Start to Summer Travel Season May 14, 2024

United is ready for its busiest Memorial Day holiday ever – with a record-setting three million travelers expected to fly between May 23-28, up nearly 10% compared to last year. To help fliers navigate the crowds and jumpstart their summer vacations, United



has dozens of features in its mobile app to help travelers skip lines, breeze through security, navigate to their gates, quickly check their bags and more – saving travelers up to 30 minutes on average* at the airport. *“Whether you’re a road warrior or fly just once a year, the United app is a game-changer that saves you time and makes the overall experience of flying United even better,”* said Linda Jojo, United’s Chief Customer Officer. *“With an uptick of leisure travel over the summer months, we’ve found that customers who travel with the app not only save up to 30 minutes on average during their day-of travel experience, but they also feel informed and empowered about their flights, especially as they’re flying into new or unfamiliar airports for their summertime vacations.”*

United continues to release new innovations in its mobile app to help travelers prepare for their trips – offering more transparency, saving time and reducing stress. Here are the top ways the United mobile app can help fliers travel on easy mode:

- ▲ Find live, personalized flight notifications for details such as countdown to boarding, gate number, seat, bag tracking and more right on your phone screen. United is the first and only U.S. airline to support Live Activities for iPhone, and the live updates have helped millions of travelers since last year especially during peak travel times.
- ▲ Request your desired seat with the new seat preferences feature in the mobile app if your preferred seat type isn’t available at the time of booking your flight. Travelers who use this tool are moved automatically into their preferred seat, on average, 35% of the time. United is the first and only U.S. airline offering this option.
- ▲ Receive automatic rebooking assistance during flight disruptions directly in the app. When travel doesn’t go as planned, customers will get alternate travel options automatically served to them in the app. Saving travelers about 15 minutes in line on average, the tools help them get back on their way more quickly after a flight disruption or cancellation. Plus, only United offers Agent on Demand – allowing customers to scan a QR code or use the United app to video chat, text or call a customer service representative instead of waiting in line at the airport. In 2023, Agent on Demand helped more than 1.6 million travelers avoid lines at the airport and get fast help in the app.
- ▲ Take advantage of TSA PreCheck® Touchless ID at O’Hare International Airport, Los Angeles

International Airport and Newark Liberty International Airport† to seamlessly drop off bags or make it through security in seconds by leveraging facial scanning technology.

- ▲ Use Terminal Guide in the app to know in advance which door at the airport to pull up to, drop off a checked bag or head straight to security. These instructions will be personalized by factors such as if a traveler is parking at the airport, getting dropped off by a rideshare, checking a bag, traveling with TSA PreCheck® and more.

Torgy's Travel Tips – July 2024 **The Fastest Way Through Airport Security**

Air travel is back to pre-pandemic levels and that certainly is evident if you or your friends and family have traveled recently. Along with extreme weather patterns that have caused countless flight delays and cancellations, the uptick in travel over 3-day holidays as well as the start of school vacations brings long, long lines to airport security checkpoints. Here is how the knowledgeable traveler navigates this spaghetti bowl of

lines: TSA PreCheck (TSA Pre✓), Global Entry, CLEAR Plus, and NEXUS. Each program is different. Some programs overlap benefits with other programs. All are membership programs that cost money to join. All have separate security lanes, and all have positive and negative attributes. The choice is yours. The following information was current and correct as of May 2, 2024.

TSA Pre✓ is governed by the Transportation Security Administration to specifically expedite the security screening process at US airports for *domestic travel*. The program is open only to US citizens and Legal Permanent Residents (Green Card holders). Members with **TSA Pre✓** are allowed to keep shoes, belt, and light jackets on and can leave laptops and liquids under 3.4 oz in their suitcase/carry-on bag. Children 12 and under can also use this lane without registering if they are traveling with a parent or guardian who has TSA Pre✓. Teens 13-17 can also accompany their parent/guardian without enrolling only if they are booked on the same reservation and their boarding pass shows the **TSA Pre✓** symbol.

How to enroll in **TSA Pre✓**: Complete the application form at www.tsa.gov/precheck, select an enrollment center to schedule an in-person interview and pay the \$78 or \$85 fee. Enrollment centers are located at major airports as well as at Office Depot, Staples and some AAA offices in the Northeast (for AAA members, only). A one-time reimbursement of application fees up to \$100 via statement credit currently applies for those who have UA's Explorer credit card (among others).

Your Known Travel Number (KTN) will be issued to you in 3 to 5 business days (possibly longer) after you complete the enrollment process. It is valid for 5 years. Be sure to add your KTN to every reservation you make in order for your boarding pass to show the **TSA Pre✓** symbol.

CLEAR Plus is a biometric traveler identification program administered by Clear Secure, Inc and is not a federally recognized Trusted Traveler Program because it does not include a background check. It allows the member to advance to the head of the security lane after using iris scan or fingerprint verification at the CLEAR kiosk. It does not include the shoes, jacket, laptop or liquid exemptions of TSA Pre✓, but it does advance the traveler to a screening belt faster. Children under 18 can use the service when traveling with a registered adult. The cost is \$189 per year and additional family members for \$99 per year. There are discounted rates for UA Mileage Plus members along with United credit card holders. Certain American Express cards currently offer full reimbursement of CLEAR Plus fees every year. Enroll at the airport, no appointment needed, and use immediately, or apply online and later register your biometric data at the airport. Clear can also be used at

some stadiums and concert venues. See: www.clearme.com

Global Entry is run by US Customs & Border Protection and provides expedited entry *into* the US by air, land and sea. The cost is currently \$100 and is valid for 5 years but will increase to \$120 on October 1, 2024. A one-time application fee reimbursement of up to \$100 as a statement credit currently applies for those who hold UA's Explorer credit card (among others). This robust program requires an in-person interview, background check, photo and fingerprinting. The process time for approval is approximately 4-6 months. Children, including infants, must have their own membership. **TSA Pre✓** is automatically included in Global Entry for no extra fee. Global Entry is used at US ports of entry kiosks and at select US pre-clearance locations in Toronto, Vancouver, Montreal, Dublin, Shannon and Nassau, among others. When traveling by car, you can use the dedicated expedited border crossing lanes named NEXUS and SENTRI. It is also useful when returning to the US via cruise ships. Begin the application process at: www.cbp.gov/travel/trusted-traveler-programs/global-entry.

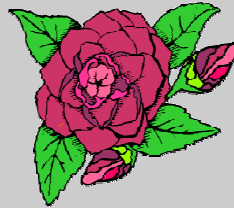
NEXUS is designed for those who travel frequently between the US and Canada. It applies to travel by air, sea and land. When using it for air travel it includes all the benefits of TSA Pre✓ and Global Entry. When arriving in Canada by air, access to NEXUS kiosks speeds government documentation checks. If you drive over the border you may use the dedicated NEXUS lanes, which typically have much shorter wait times. The program is administered by both the US and Canada and therefore requires interviews by border patrol agents from both countries. A demonstrated reason is required for admission to the program. Primarily those who live near the busiest land crossings (New York, Michigan, and Washington state) are eligible. Each traveler must have their own membership, including infants and children. The current fee is \$50 and will increase to \$120 on October 1, 2024, and is valid for 5 years. A one-time statement credit of up to \$100 is possible for UA Explorer credit card (among others). The approval process is long: about 6 months, and interviews are conducted only at land borders. To begin the application and interview process see www.cbp.gov/nexus.

And, for those who travel internationally only occasionally, the free app **Mobile Passport Control** might be just the ticket! It streamlines your entry *into* the US without the cost and long enrollment process of Global Entry. Find it on your phone's Play Store or The App.

The bottom line is to choose what suits your travel style the best and then be sure to add it to all your frequent flyer profiles. Doing so will automatically include your qualifications on every reservation. Then get out there and travel! ■

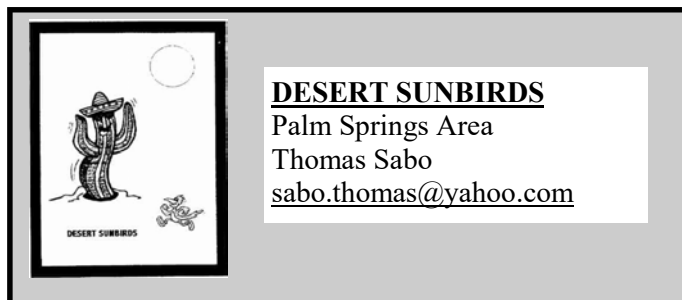
We are a small group of UAL retirees located near Pismo Beach, CA. As you well know the old saying, "No news is good news", and this is certainly the case.

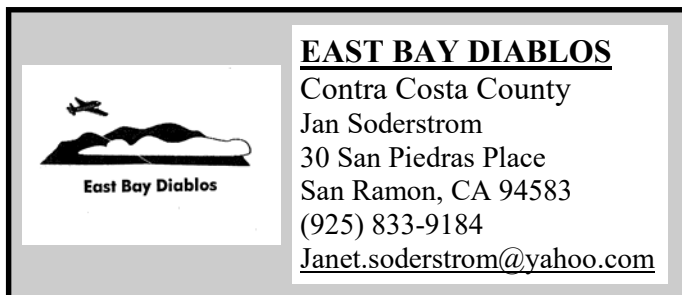
“volunteer”, the group folded. Hal was also a member of our group.

For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer's Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too; however, please send in coupons at least every other month so the troops have a longer time to use them. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated. I get so excited when I get a coupon for eggs!

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022, and on June 6, I turned in a whopping 2396 coupons, a new record high! Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. All the coupon cutters are telling me that they are not getting coupons like they used to. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons. 

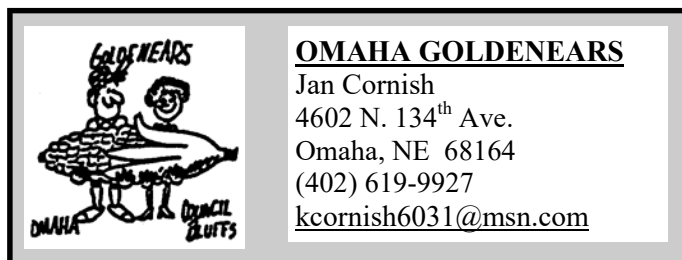

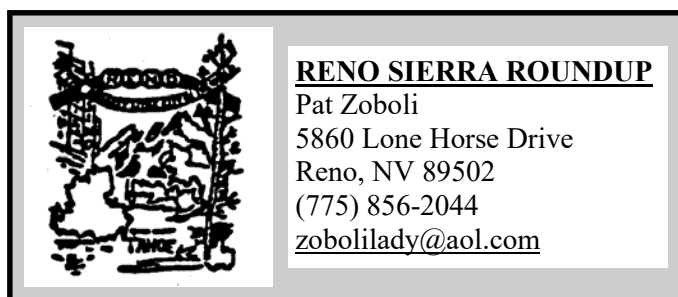

And now another story of the "Greatest Generations" from Marty Etler:

Of the many reunions that the 301 Bomb Group had, the one in Dayton, Ohio seems to have stood out in memory more than any. I say this because military veterans can really only relate to those who they have shared their experiences with.

Anyway, our reunions were well practiced; they ran from Thursday to Sunday. On Thursday, it was usually meet and greet after you have checked in. Violet and I were already seated at a table, when one of our vets came over and asked if he could sit with us, and of course we said yes. When he sat down and began to talk to us, he asked us if we had seen his friend. He told me the friend's name and I said I remember seeing it on a check-in list where we signed in. Now he began to tell me and Violet a story that was beyond interesting.

He was in the 12th Air Force Station in North Africa, and when Italy surrendered, they moved all the bombers to Foggia's airport by Rome. There, they were bombing southern Germany, and more important the Pliosti oilfields in Romania, the only source of oil for Germany.


On one of the raids, as they returned flying over the Austrian Tyrol, they were hit with antiaircraft fire, so bad they had to abandon ship and bailout, they were down to about 2000 feet. He was a gunner in the back of the plane and when it was his turn to jump, he looked to the front of the plane and saw one of the guys jump but the parachute did not open. He was later captured by the Austrians and taken to prison camp. Those who jumped out the front were also captured and taken to a different prison camp. He still didn't know whose chute did not open. Later, he found out through the Red Cross that it was the radio operator and apparently there was so much snow on the mountains and on the trees that they served as a cushion for him when he hit the ground and he survived.

After the war ended, all those men in the prison camps were repatriated back to the United States. He said the two of them kept in touch with each other for many years, but they decided to come to this reunion and see each other for the first time in 40 years since that bailout.

He looked around, and there at the next table, was his friend with his whole family. They saw each other and came together with big hugs and tears streaming down in large quantities from the both of them. I can tell you there wasn't a dry eye in that whole area where we sat. Just one story of a million more. "Lest we forget".

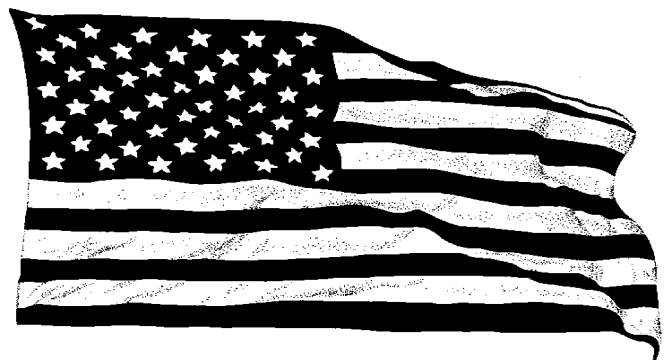

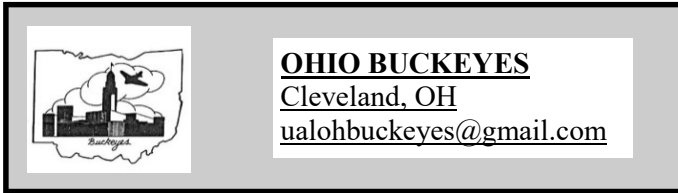

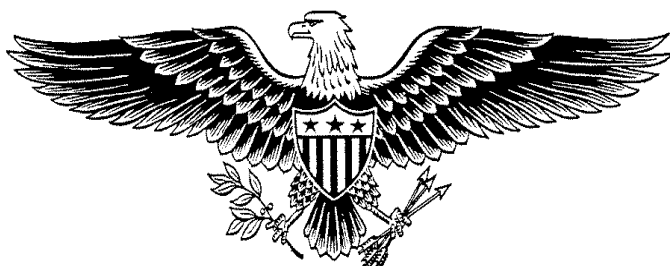

The news has been teeming with "clear air turbulence" (CAT) stories lately. Understandably, it is hazard-

ous to aircraft and passengers and we have reason to be concerned. According to the AGU, Advancing Earth and Space Sciences Research, there is evidence for large increases in CAT over the past four decades. Severe-or-greater CAT increased 55% more frequently in 2020 than in 1979. As we have all heard or read, there have been several incidents in the last few weeks. Our own United Flight 85, on March 30, had an incident while attempting to land at Newark's Liberty International Airport from Tel Aviv where 7 passengers were injured and the plane diverted to Stewart International Airport in Orange County NY. May 21, Singapore Airlines flight 321 from London to Singapore had over 100 injured as they diverted the 777 to Bangkok. Sadly, one passenger died of a suspected heart attack and 22 patients had spinal cord injuries and six had brain and skull injuries. Another CAT occurrence happened on May 24 on Qatar Airways where 12 passengers were injured. This flight was flying from Doha to Dublin and eight of the injured were hospitalized.

What is the lesson we all need to heed due to this increase in CAT? As retired UAL employees and frequent travelers ... **keep your seat belt fastened at all times.** Even when the seat belt sign is **off**, one should always keep it fastened. Personally, this is important to me as a retired flight attendant as we **are** safety professionals. My husband Jim was working in the first class cabin in 1981 when UAL Flight 12 LAX to EWR experienced a CAT and over 100 passengers were sent to Chicago area hospitals when they made the emergency landing in ORD. His main comment is "if they didn't have their seat belts on they hit the ceiling"! Several of the flight attendants in the economy section were severely injured and never came back to flying! The passengers, without injuries, made it to their final destination which was EWR the next day!
