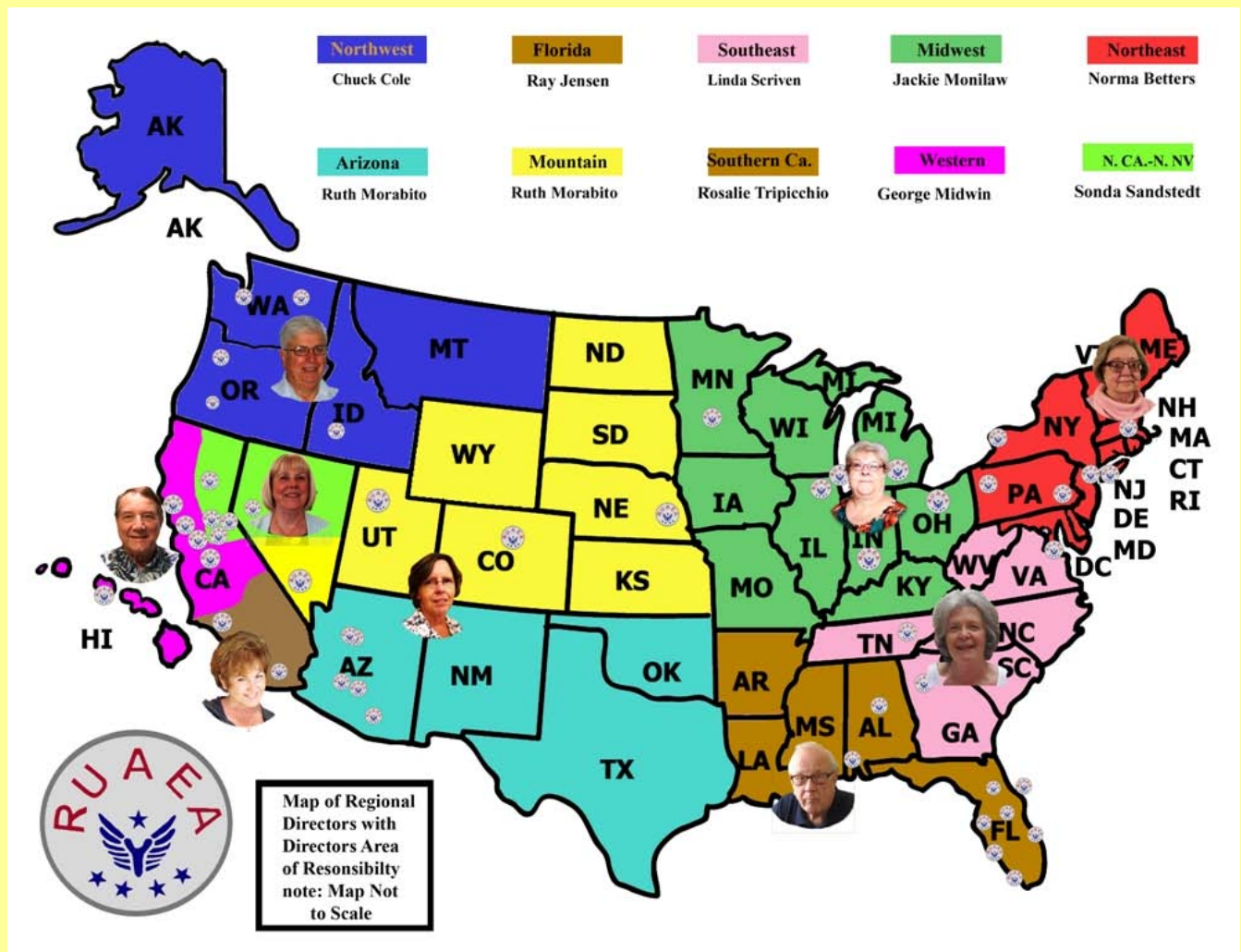

### From The Executive Vice President



To all RUAEA Retirees,  
As a retiree, you have certain advantages that full fare passengers do not have. You can look up loads to find out how many seats are available and sold on all flights. Remember groups and travel agents' bookings should be accounted for also.

By 24 hours before departure, groups and travel agency bookings should be settled. Seats held by travel agents that are not sold will be put back into the inventory.

You can also look up most flight history records to see which flight historically go out with empty seats. The no-show factor can show up to 10% to 25% on some flights. As a retiree, you can re-route yourself, but you must use additional passes, point to point, to get to your destination. Another option is to use SA passes on other carriers for back up.

If you go to Asia during summer months, be sure to get SA backup passes A/C weight restrictions in hot climates. This means open seats which we can't use because of weight restrictions. In this case, it would behoove you to use other carriers for backup. \*Remember the day before

the flight to cancel the listed flight you won't be using. You can also cancel a listed flight while in route on a flight.

If you are taking a tour or meeting with a ship at a destination, be sure to go early or consider discount positive space confirmed flight. All UAL retirees are allowed to list up to 12 flights. This is so you can check to see which flights to try for. You can go from one flight at a gate to another flight without re-listing for that next flight.

Two weeks before your flight, sit down and check what flight to go on. Say DEN from SFO or wherever. Check out available non-stops first. Remember full paying passengers want non-stops between 10 AM and 1600 as their first choice. You will do better with flights early morning, 5 AM to 10 AM, or first ZED between 1400 to 1800 or later. Also remember days of the week on which you will be traveling. Monday is hard. Tuesday is usually OK. Wednesday is usually good. Thursday morning is good. Friday is hard. Saturday early a.m., usually OK and Sunday early a.m. OK but 10 AM to 1600 not so good.

Along with the times, you must consider fares for full fare passengers. Some discount fares require flying at certain hours and days. Full fare passengers usually look for lowest fares with specific rules on when you can fly and how long you can stay. All of these things plus others should be taken into consideration when making your plans and doing your listings. Get advanced seats to make sure you get on a flight if it oversell situation occurs. With positive space, if you get bumped you are entitled to all the passenger perks such as cash, free trips, upgrade on future flights, hotel, meals, etc. Maybe even a free cab ride to get home. Please remember if you do get back up tickets offline, you may get a refund if not used. Within 90 days you may reuse or within one year of purchase you may get a refund. Don't be afraid to get offline back up.

During the trip planning process you might consider changing plans on route. If you get to IAD for a connection to London, and flights are full IAD to London, stay over in WAS instead of going to London. Spend a few days in WAS and see the sights. After a few days, try for a few flights from WAS to London or buy backups on other carriers from WAS to London. This is an example of a plan A and B. Think big. If an airport is closed due to snow, then nothing will get you in or out. If an airport is closed due to fog, some flights will get out late and some early. Depending upon the captains' certification, where landings and takeoffs at one or more airports, flights someplace will depart and others will cancel. Check it out before giving up. In our case, at the Denver airport, the airport was closed. We went to Plan B and found a hotel. When the airport reopens, many seats will be available. Our reservation system can't keep up with all cancellations and re-bookings. It's not unusual to have 50% of flight seats unused. Be sure to go to the airport on the day it opens to try to get on standby. When the airport is open, and you still can't get out DEN to SFO, use a new pass, DEN to WAS to SFO. Using two passes may get you to your destination. There are hundreds of scenarios of having problems getting from point A to B; by planning in advance and using your airline skills, you will get to your destinations.

In 39 years I have only missed three flights. Be sure that you have a UAL App in your notebook or watch.

### **Is there such a thing as a ‘good delay’?**



United’s on-time departure rate, or D:00, is one of the most highly visible and closely tracked performance measurements, for good reason: If a plane takes off on time, it is much more likely to land on time. That makes customers happy while reducing operational headaches and the chances of downline delays. That’s why, as a rule, United does nearly everything possible to get all of its flights out as scheduled.

Sometimes, though, that mindset puts United’s employees in a tough spot, like instances when they must decide whether to risk delaying a flight at the gate to wait for late connecting customers or close the door on schedule and depart on time.

Consistent with other work United is doing to improve the customer experience, United has been testing an automated digital tool in ORD and DEN known as ConnectionSaver that takes the guesswork out of those decisions. Since many of United’s flights are scheduled to land early at their destinations, ConnectionSaver identifies the ones United could hold for late-arriving connecting passengers with relatively little risk of further disruption. The tool considers many factors, including gate-to-gate travel times, United’s crew duty limits, current gate use situation and connecting baggage, among other things, to accurately gauge the impact of a gate hold.

ConnectionSaver is sophisticated enough to tell United the expected ripple effects of delaying any one of United’s flights at any given location. It’s also highly configurable so as to meet the changing needs of the airline and designed to integrate with United’s existing technology systems.

DEN Employees have quickly adapted to the new tool, especially after seeing the impact that it’s had on United’s ability to better serve our customers. During the past four months, more than 14,400 customers, who would have otherwise missed their connections, were able to make their flights thanks to ConnectionSaver. Also, customer satisfaction scores improved to such a level that front-line teams couldn’t help but sing its praises. They also saw little impact to their on-time departure metrics, since United has an exception code that authorized stations can use when holding a flight for connecting passengers. Like their colleagues at ORD are doing now, the people at DEN saw firsthand the core4 benefits of this more caring, dependable and efficient, not to mention flexible, approach.

Just as importantly, customers were equally impressed. “Unfortunately, our inbound flight was delayed,” one reported. “We ran to the gate and, fortunately, the flight was held! I know time is money in this business and gate

*pushback delays are a source of irritation for the FAA and airlines, but I was pleased that the customer was the priority in this case. This was tremendous and has raised my estimation of United greatly.”*

*“ConnectionSaver only works if it allows us to care for as many customers as possible – without inconveniencing others – and that’s exactly what this technology has shown it can do. We’re determined to capitalize on as many opportunities as possible to better serve and care for our customers and that’s part of what sets United apart from our competitors,”* added SVP and Chief Customer Officer Toby Enqvist.

ConnectionSaver also includes text notifications personalized for customers making connections through United’s hubs that will help them efficiently navigate to the right gate for their next flight. Once customers land, they will receive a text message that tells them the gate at which they are arriving, the gate at which they will depart and the expected travel time between the two. The texts will also include a link with step-by-step directions to the departure gate and a map of nearby amenities.

The ConnectionSaver technology will expand to United’s hubs and to all other stations in the future. In parallel, United will continue to enhance the ConnectionSaver systems to include full integration with Aero, the journey management system and our mobile devices. Eventually, United will be able to notify customers on connecting flights when United is holding the aircraft for them, along with offering them solutions when United can’t.

### **A CLEAR path to the gate**



Starting on July 29, getting through security will be faster than ever for MileagePlus members, thanks to United’s new partnership with CLEAR, the company using a secure biometric screening process to verify travelers’ identities to get them through security faster.

This partnership will enhance United’s customers’ travel experience by enabling them to confirm their identities using their eyes or fingerprints, instead of an ID or passport, allowing them to walk straight to the screening bins.

CLEAR is available at more than 60 airports and stadiums in the United States, and United is also making a strategic equity investment in the company to help support its growth, including bringing this technology to its EWR and IAH hubs later this summer. United is also supporting CLEAR’s efforts with the City of Chicago to open CLEAR lanes at ORD in the coming months. This technology already operates at United’s DEN, LAX, SFO and IAD hubs.

*“Our new partnership with CLEAR is another proof point of how we are always looking to improve traveling with United, in this case by making the airport experience more convenient for customers,”* said MileagePlus President and Loyalty VP Luc Bondar. *“CLEAR’s secure and seamless biometric security option creates an expedited travel*



*experience that many of our frequent flyers already use and love. We're excited to partner with CLEAR to expand their presence at our hub airports and to provide all MileagePlus members with either free or deeply discounted memberships."*

As a result of United's partnership, MileagePlus customers can take advantage of discounted memberships. An annual CLEAR membership is \$179, but the special pricing is available for United's MileagePlus members.

### **Torgy's Travel Tips – September 2019** **Dresden, Germany**



In my last article (July 2019), I wrote extensively about one of United's newest destinations, Prague, Czech Republic and how easy it can be to visit other beautiful, interesting and important places nearby. This month I will provide some highlights of a side-trip to Dresden, Germany located only 90 miles northwest of Prague.

Located on the Elbe River, before WWII Dresden was often compared to Florence, Italy due to its architecture, sumptuous art galleries, jewel and porcelain collections. On February 13, 1945 American and British bombers firebombed Dresden at night, killing an estimated 25,000 civilians and decimating the city. (You may remember Kurt Vonnegut's



novel Slaughterhouse Five, which details this horrific event.) After the war, Dresden became one of the Iron Curtain countries under the occupation of the Soviet Union. During the Soviet years, reconstruction of the city was agonizingly slow and followed the typical Socialist Modern style: oblong blocks of concrete buildings. The once beautiful "garden city" still remained a palette of gray. Even the magnificent Lutheran Frauenkirche remained in ruins. Only after the fall of the Berlin Wall and the reunification of Germany in 1990 did the effort and funding for restoration really begin. Now, the original splendor of Dresden's architecture has been replicated, most of the utilitarian gray buildings of the Soviet era have been removed and treasures that were hidden in remote areas during the war have been returned to the city. Dresden has resumed its rightful place among the finest of Germany's cultural destinations.

One of the first things you'll notice about Dresden is its "walk ability". It is flat, easy to navigate and you only have to look up to spot the top of the completely restored Frauenkirche or the Fine Arts Academy dome (nick-named the Lemon Juicer) in order to judge which direction you are headed. Divided by the Elbe River, Dresden's Altstadt (old town) on the west side comprises the major tourist sites such as the Zwinger Palace, the Semper Opera House, the Frauenkirche and the main train station. Neustadt (new town), on the opposite side of the river, is the more "bohemian" side. Both sides offer an esplanade along the river and a stroll across the Augustus Bridge connecting the two sides offers vistas of the entire area. We stayed at the Hotel am Terrassenufer right above the river on the Altstadt side, which gave us gorgeous views and was within walking distance to everything.



The top 3 attractions are located right in the heart of the Altstadt: the Semper Opera House, the Residenzschloss (Royal Palace) and the Zwinger complex. Inside the Zwinger are 3 museums, the most popular being the Old Masters Gallery where priceless works of art by Raphael, Rubens, Rembrandt, Titian, van Dyck and Vermeer are displayed. But wait till you visit the Residenzschloss and view an unbelievable collection of gold, silver, ivory, enamel and jewel encrusted treasures amassed by Augustus the Strong, who ruled here from 1694-1733. Known as the Historic Green Vault, everything is displayed in Baroque rooms as it would have been in his time. The famous Green Diamond, considered by many equal to the Hope Diamond and the Mountain of Light Diamond in England's crown jewels, is

displayed here. Keep your eye out for the porcelain ostrich egg topped with a long neck and head resting on feet in gold trim. The audio guide included with your ticket is excellent. Also, because the collection is so vast an additional upstairs floor called the New Green Vault displays items in a more modern setting. Many of the objects are even more elaborate than those in the historic room. Admission to the Historic Green Vault is limited by timed tickets that you can order online in advance at [www.gruenes-gewoelbe.skd.museum](http://www.gruenes-gewoelbe.skd.museum), but you can usually still get in without reserving in advance by lining up before they open at 10AM. They have about 75 tickets per half-hour time-slot available for sale at the ticket desk entrance, located inside the glass-domed inner courtyard of the Royal Palace. The Green Vault is closed on Tuesdays.



A completely different kind of attraction is the Volkswagen's Transparent Factory (die Gläserne Manufaktur). This futuristic looking but fully-functional factory produced VW's racy Phaeton car until it switched to making totally electric vehicles in 2017. The striking building, which is all glass, looks like a swanky office building. But inside is an open concept, multi-story circular assembly plant. The guided tour takes small groups right onto the assembly lines on 3 levels where you stand just feet away from technicians building the vehicles. The only robots in sight are those used to insert the windshields, install the wheels and "marry" the top and bottom portions of the body together. When the vehicle is finished, a robot places it into a glass elevator which lowers it to an available parking spot inside an adjoining glass tower until the owner comes to drive it away or it is shipped out. Visitors are encouraged to experience a virtual reality test drive (it was really fun!) as well as inspect the forthcoming driverless vehicles which VW will be testing on the streets of Dresden, shortly. You can even take a real test drive of the electric Golf after your tour. I reserved an English tour in advance at [www.glaesernemanufaktur.de/en](http://www.glaesernemanufaktur.de/en) and then paid at the reception desk on the day of the tour. They even offer half-off for seniors. Both my husband and I thought this was definitely a trip highlight.

For a fine meal and great beer don't miss Ballhaus Watzke. There are 3 locations but the one across the Augustus Bridge in Mickten is the "real thing", as the beer is actually brewed at this location. Take tram 4 or 9 from the Altstadt to the corner of Leipziger and Kötzschenbroder streets. The beautiful old yellow building houses a ball-



room on the top floor and a delicious restaurant on the main floor. This is where the locals eat and you can't go wrong, no matter what you order.

Now Dresden is less than 2 hours by car, train or bus from Prague and less than 3 hours from Berlin. There is frequent Flixbus service from either city as well as frequent train service. If you travel by car, be mindful that parking is always a headache in larger cities and once you arrive in Dresden you really don't need a car.

Auf Wiedersehen und gute Fahrt! (Good-bye and have a nice trip!)

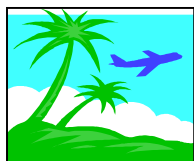

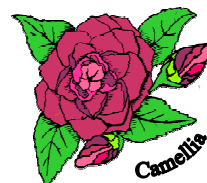
almost waited too long in leaving. All civilian airlines had stop flying. Air Force C-141 carried us out.

This month’s victim ... er, honoree for our Member Highlight report is our wonderful and supremely-capable Vice President **Phyllis Bowman**. Now is her 90s, Phyllis was born in 1926 in Sand Point, Idaho, later moving with her parents to other Idaho and Washington locations and then to Seattle, where she used city buses to attend highly-regarded Queen Anne High School. Though not personally employed by United, Phyllis’ story includes that of her late husband **Herald “Bow” Bowman** (SEAGQ), who passed away in January 2017 after more than 70 years of marriage.

When her parents completed a basement apartment to accommodate young military families, Phyllis was invited by their young tenants to go with them to a USO function, where she danced with several young soldiers. After church the following morning, one of those young men, Herald, presented himself at the front door to spend more time with Phyllis and was immediately invited to dinner by her parents.

The young couple began dating, but Herald was sent to Adak, Atut and to Shemya, Alaska, as a radio operator. From there he was transferred to Louisiana and then Mississippi, going home to Sparta, Michigan after discharge from the Army.

Shortly thereafter, Herald moved back to Seattle. When he approached Phyllis’s father to ask for her hand in marriage, Mr. Katzenstein required that the young suitor first have a job. Thus began Herald’s career with United Airlines, hiring on March 18, 1946 - Bow and Phyllis were married that June. Bow trained as a mechanic at Boeing Field and transferred to SeaTac Airport when it opened a couple years later.

In the meantime, Phyllis honed her skills in various business offices, especially car dealerships. The Bow-

mans raised two sons, who helped in the family’s ice business until leaving for college in 1965. Phyllis served as secretary and treasurer and Bow as property manager at the Des Moines Yacht Club, where they moored their boat. Skiing in Idaho as a family and wintering in Arizona also were part of their lives. When TWA offered special fares for a 3-week around-the-world flight, Phyllis and Bow enjoyed the trip with their good friends **Harold “Mac” McGuire** (SEAMM), a fellow mechanic, and his wife Millie.

**Herald Bowman** retired from United January 1, 1984 and they joined the Emerald City Slickers two years after the chapter was founded by **Norm Strange**. Phyllis gave up her position as an accountant in 1988. In 2008 she was offered the position of vice president for the Seattle chapter and still serves in that capacity today. In addition to handling membership records all these years, Phyllis became a close friend of a neighbor, **Vicki Shumaker**, who now produces our chapter newsletter.

We look forward to Phyllis’ return to Federal Way after recovering from last autumn’s serious fall that has kept her MIA.

As always, we reluctantly report the deaths of former employees of United Airlines. **Lynda Baseden**, retired SEARR supervisor, passed away June 8 at home with her family by her side. **Louise Lewis**, Lynda’s late mother, also a United retiree, had worked in the flight kitchen.

**Arthur Fluke**, who had worked in cabin service and been promoted to supervisor in charge of all ground traffic, died June 1, just a month shy of his 95<sup>th</sup> birthday. Though not a member of the local RUAEA chapter, Arthur helped out at the 2016 Seattle convention. A WWII Navy vet, Fluke was a talented carpenter and restored old cars, which he sold to finance his daughters’ college educations and his son Kelly’s aviation school. Kelly worked for a while in United’s flight kitchen.

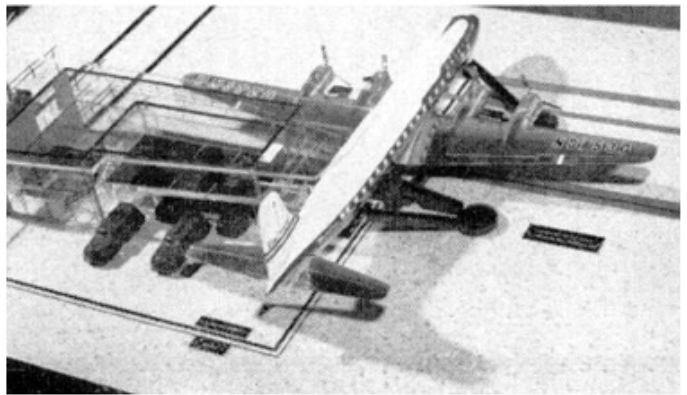
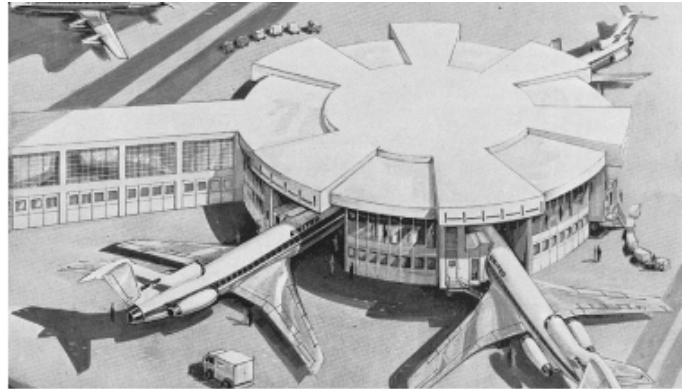
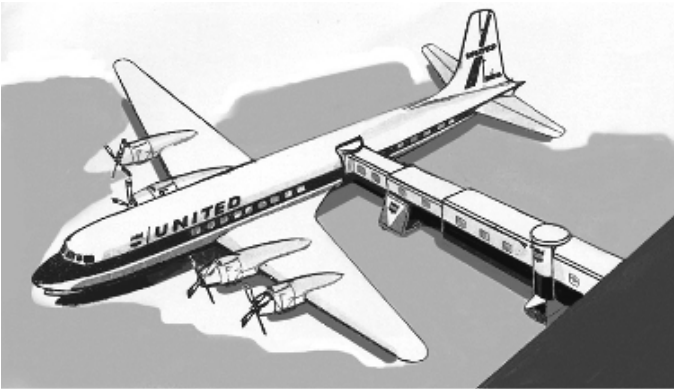
