#### **Turbo-charged decision-making power**



United's Aircraft Routers in the Network Operations Center spend their days working on what amounts to a complex puzzle. When a plane needs to be in a particular city for maintenance, for instance, they figure out how to get it there. When one is taken out of service, they find a replacement. This requires daily aircraft swaps, which the routers oversee, doing their best to not disrupt United's customers, United's crews or operation in the process. Some days, it's like trying to solve a Rubik's Cube on which the squares are constantly changing colors.

This month, routers began using a data-driven tool called Turbo that eliminates much of the research and inherent uncertainty

associated with those decisions. On a single screen, Turbo displays real-time information such as crew availability, scheduled layovers and downline customer connects for every mainline flight in our system, enabling routers to easily and accurately measure the ramifications of shuffling planes around.

"Up to this point, United had to hunt for that kind of information using multiple systems. That cost United valuable time and there was no guarantee we were making the best swap option," said Aircraft and Load Planning Director Jeff Storm. "Turbo provides quicker, more transparent data to help routers solve swap scenarios more effectively. We believe this will provide a better product, help both internal and external customers, and increase the speed and quality of aircraft swaps."

Palantir Technologies, a data analytics and software company, built Turbo specifically for United and partnered with Digital Technology to ensure swaps flow seamlessly into United's operational systems. United is partnering with Palantir as part of a broader strategic agreement. In addition to developing applications, Palantir supplies United with its Foundry analytics platform, which brings together United disparate data sources in an integrated, accessible way, making tools like Turbo possible.

"Foundry provides us with the ability to use a single, common data set and logic to support multiple operational and strategic analytical decisions," said Director of Operational Analytics Rich Alster. "Over time, this will help us keep pace with the demand for insights, eliminate redundant or varying logic within the operation, and in turn, deliver more consistent customer experiences."

#### Changes coming to unaccompanied minor program



Traveling can be a stressful situation, which means it's up to United to do what United can to ease the travel experience for United's customers, especially those that need extra assistance, like unaccompanied minors. In United's ongoing efforts to ensure United provides a safe and comfortable journey for United's youngest flyers, as well as their parents and guardians, United is making changes to its unaccompanied minor policy and procedures aimed at doing just that.

On April 23, the following changes took effect:

- United is limiting the total number of unaccompanied minors per flight to six during regular operations. This change will help ensure that our teams on the ground and in the air can provide the best possible care to all of them.
- ➤ United will seat unaccompanied minors in the aisle seats of the last three rows of the aircraft when traveling in coach (except on 50-seat United Express aircraft, where they will remain in the front). This change will enable United's flight attendants to better monitor unaccompanied minors throughout the flight and provide a more efficient boarding and deplaning process.

- > United will still allow unaccompanied minors to travel in United Polaris business class, United First, and United Premium Plus.
- ➤ United is aligning the service fee with the industry standard for U.S. global airlines of \$150 for every two unaccompanied minors on the same PNR per direction of flight.

This summer, United also plans to roll out a specialized wristband for unaccompanied minors, which will be used to track these travelers along their journey. This allows teams, as well as parents and guardians, peace of mind during the travel experience.

#### **Celebrating United's next livery**



On April 24, at ORD, United introduced more than 400 customers and employees to a modernized aircraft livery, bringing a refreshed look to its fleet. The design is a visual representation of <u>United's ongoing brand evolution</u> that stays true to its 93-year history of proudly serving customers around the world.

"As we improve and elevate our customer experience, we are changing the way people think and feel about United, and this branding captures that new spirit," said Oscar. "Each improvement we've added to our service advances our evolution as an airline,

furthering United's effort to elevate and redefine customer service in the sky. This modernized design, especially our iconic globe, enhances the very best of United's image and values while pointing in the direction of where United intends to go next in serving our customers."

The next iteration of livery prominently features the color most connected to United's core – blue. Three shades – Rhapsody Blue, United Blue and Sky Blue – are used throughout the design in a way that pays respect to United's heritage while bringing a more modern energy. United is keeping its iconic globe logo on the aircraft tail, which represents United's expansive route network of 355 destinations in nearly 60 countries. United's research has showed the company that there's incredibly strong brand equity in the color blue and in the globe logo — to completely revolutionize would be throwing that equity away. The tail is updated with a gradient in the three shades of blue, while the logo appears predominantly in Sky Blue. The engines and wingtips are also United Blue, and the swoop that customers and employees have expressed fondness for on United's Dreamliner fleet is Rhapsody Blue. United's name appears larger on the aircraft body than it did previously, and the lower half of the body is Runway Gray. Near the door of each aircraft is painted our shared purpose: "Connecting people. Uniting the world."

How to place a Website Icon for an Application on Your Apple iPhone Using Safari Browser:

The Safari Browser is located on your cell phone at the bottom by the icon that contains a Blue Circle with a white and red Pen object in it.

- Press the Safari Browser Icon.
- Clear out the top line of the browser of any information by deleting it.
- Type in the URL for the website or search for the website you wish to create the Icon for.
- Then Press enter.
- Upon entering that websites home page.
- Click on the object below the page at the bottom that has a rectangle object with an arrow pointing up through it.

- Then Click the Icon on your phone that has a Rectangle with a Cross in it and the verbiage Add To Home Screen.
- Then Click on Add.

That should create an Icon on your phones home page screen for that website.



How to place a Websites Icon for an Application on your Android Phone

- Unlock your phone
- Press the Home Button on the bottom of your phone.
- Find a Web browser on your phone such as Google Chrome
- > Press on that Icon.
- > Clear out the top line of the browser of any information by deleting it.
- > Type in the URL for the website or search for the website you wish to create the Icon for; for example https://ft.ual.com.
- > Touch the Overflow button (three vertical dots) and select add to home screen.
- Then touch Add, and that websites icon will join the other applications icons on the home page.

#### So Simple From Sheryl



Summer is quickly approaching and it's time for picnics with family and friends. I hope you enjoy this refreshing salad.

#### **Chinese Chicken Salad:**

Toast in oven at 325 for 10 minutes:

- ★ 2 tablespoons sesame seeds
- ★ ½ cup slivered almonds

Salad ingredients:

- ❖ 2 packages pre-shredded cabbage with carrot
- ❖ 6 green onions, chopped, using part of the green

#### Dressing:

- ➤ 1 cup oil
- ➤ 4 tablespoons sugar
- ➤ 6 tablespoons apple cider vinegar
- ≥ 2 teaspoons salt
- ➤ 1 teaspoon pepper
- ➤ 2 teaspoons ground ginger
- > Flavor packet from Top Ramen Chicken Noodle soup

Cook 4 chicken breasts in microwave; cool and cut into bite size pieces.

Immediately before serving, pour dressing over cabbage or the cabbage will get soggy. Add sesame seeds, almonds and break up Top Ramen Noodles and mix into salad. If I know that I am not going to use all of the salad at once, I will set some of the salad aside and put dressing on as needed.

<u>Note</u>: You can do most of the preparation the day before. Toast the sesame seeds and almonds. Make your salad dressing and prepare your cooked chicken.


