RUPA is not a union, but we are a group of retired employees who accepted benefits in lieu of pay. There is no reason to believe that we can't have a voice for our benefits again."

## RUAEA Business Meeting Friday, October 1, 2021 Mission Bay Ballrom, Dana on Mission Bay, San Diego, CA



The meeting was called to order at 0830 by President Don Burbank. Don welcomed the members and thanked them for attending.

Motion: Hank Gosselin made a motion to accept the Business Meeting minutes of September 27, 2019, as published. The motion was seconded by Diane Webb and approved by all.

<u>Don Burbank, President</u>: One of our key issues is getting new volunteers to sustain the organization. At the end of this year, we will be losing three principal Newsletter volunteers. Francis Domaratius, Newsletter Manager, Veronica Domaratius, Newsletter Editor and

Martha Gooselaw, Letter Editor. All will be retiring after many years of dedicated service. Without volunteers for these critical positions, all options were explored. We determined that failure was not an option.

<u>Chris Johnston, Treasurer</u>: Chris agreed that from a financial position we are commitment to continuing based on the following:

- Our financial position is still strong. We are solvent with funds available for an emergency. The fiduciary responsibility of the Board of directors is to act in the best financial interest of our members. Currently we have \$235K of liquid funds in various bank accounts. We also have a bond for \$26K. According to IRS rules if an organizations operating under a 501(c)3 nonprofit status dissolves, money and assets are not returned to the membership. They must go to another nonprofit organization. There would be no benefit to our membership.
- The San Diego Convention is shaping up to be incredibly good compared to Denver two years ago. Denver had 140 attendees and San Diego had 186. Financially due to hotel contracts in Denver, we had a shortage in both guaranteed room nights, food and beverage sales. A check was written for \$26,730 in settlement of the contract. Discussions with the current location, Dana on Mission Bay, have determined that hotel nights, food and beverage contracted goals have been met. Final cost will be determined following a review with Shirley Claggett, Convention Treasurer, to determine income and outgoing responsibilities for future conventions.
- We also have a membership whose support has been maintained before and during Covid.
- A budget for 2022 will be submitted in the Newsletter in the first quarter of the year.

<u>Motion</u>: Ruth Morabito made a motion to accept the Treasurers report. It was seconded by Virgil Gooselaw and approved by all.

<u>Ruth Morabito, Executive VP</u>: Ruth gave a summary of the Regional Directors reports and the commitment from the board to assist in any challenges at the local level as we moved forward. She also conveyed that while the National RUAEA is not a governing body over the local chapters we certainly want to be a resource if needed. Just as we are not tied to United Airlines it is important to maintain a relationship for retiree information and possible issue resolution.

- ▲ We are pleased to announce that Marge Stamn has accepted the Florida Regional Directors position. We welcome and look forward to working with Marge.
- ▲ During this pandemic period, we have found that members have become very inventive in their ability to stay connected. RUAEA's greatest assets are the correspondents who provide local information for the Newsletter.

<u>Virgil Gooselaw, Past President</u>: Attracting new volunteers is the Past President's responsibility. Many of the key positions are being recycled with the same people. We need new volunteers so if anyone has someone who may be interested, please let Virgil know. Many thanks to the Denver office comprised of Michael & Kathy Malesardi, Cas Spokas and Virgil. We also want to thank Veronica Domaratius, Francis Domaratius and Martha Gooselaw for their dedication to the Newsletter publications.

<u>Hank Gosselin, V.P. Conventions</u>: The planning for this convention was quite a challenge. With continuing health concerns this year the Hotels and tour companies were reluctant to make commitments in advance. The local committee worked extremely hard to make it a success. We did find it necessary to cancel three of the preplanned tours and had twenty planned attendees cancel.

Hank recognized Ron Bertacini and Dave Garland of the Site Survey committee for their contributions. Shirley Claggett and Ron Paluch provide their usual fine service with the registration and acting as the convention treasurer.

We are working on next year's convention and have received many positive comments on the current location. As a reminder, anyone can join RUAEA. All are welcome.

Don thanked everyone for coming and encouraged them to attend the Benefits Panel following the meeting. United Airlines sent several representatives and Alliant will be hosting the Friday night Beach Party.

<u>Motion</u>: Hank Gosselin made a motion to adjourn the meeting. It was seconded by Ruth Morabito and approved by all. Meeting adjourned at 0920.

### **Benefit Panel Presentations**

<u>Alliant Credit Union</u>: Janet Meinheit, Key Account Executive provided a video presentation of Dennis Devine, CEO of Alliant, who was unable to attend. He stated that 2021 promises to be their best year yet due to cost savings and new structure. Janet said that they are proud to serve our members and their families.



<u>United Airlines:</u> Joan Smith, Manager Benefits, continues to liaise with Don Burbank on retiree issues. Don Dentzer, Manager of Health and Welfare Benefits presented on behalf of the

individuals who were not able to attend due to travel restrictions. Michelle Pritchett, Human Resources Specialist, did not have a lot of new information to provide but had some important reminders, which we will publish separately.

### London is calling! October 28, 2021



London is calling, and we're answering with five new flights to LHR, including two from EWR, one from DEN and one from SFO, as well as a brand-new nonstop flight from BOS (Boston) beginning March 2022.

With these new routes, we will have 22 flights per day from the U.S. to London, and we will have more flights from New York City to London than any other U.S. carriers. We've seen in booking trends that London is the most popular destination for our business customers, and we expect the trend to continue into 2022.

"For nearly 30 years, United has provided a critical link between the U.S. and London, maintaining service throughout the pandemic and strategically growing our schedule to keep our customers in these key global business centers connected," said International Network and Alliances SVP Patrick Quayle. "London is an integral part of United's network, and we remain confident demand will continue to grow, particularly as international business travel returns in 2022."

Our new daily flight from BOS will be operated with the Boeing 767-300ER. We're resuming daily flights from DEN and adding a second daily flight on the Boeing 787-9. This new announcement adds sixth and seventh daily flights from EWR that will be operated with the Boeing 767-300ER and a third daily flight from SFO operated with the Boeing 777-200ER. And, finally, we'll resume daily service from LAX.

Prior to departure for England, travelers who are fully vaccinated with a qualifying vaccine must complete a passenger locator form and book and pay for a test to be taken within the first two days of arrival. Passengers vaccinated in the U.S. must provide proof of U.S. residency. Further details on the COVID-19 rules governing entry to England (including rules for unvaccinated customers and customers who have been in a red list country in the 10 days prior to arrival in England) are available on flying together.

### Geneva, we're back! November 2, 2021



Lady Liberty, the Empire State Building and Central Park will be easily accessible again for those in Switzerland! After interruption due COVID-19, we have resumed non-stop flights between GVA (Geneva) and EWR four times a week.

"In view of the imminent opening of the U.S. border for vaccinated or recovered travelers on November 8, we are very happy that we can now resume this route, which is important for both business travelers and tourists, with an extended offer in the premium cabin," said Switzerland Country Sales Manager Reto Schneider. "The resumption of these flights is

another commitment by United to the Swiss market and marks the beginning of a further expansion to a total of six routes between Switzerland and the USA in the summer of 2022."

In addition to the resumed flights between GVA and EWR, we are currently flying routes from ZRH (Zurich) to EWR and IAD. Until the end of the year, we will also be flying between GVA and IAD once again. The new daily flights from ZRH to ORD will follow from April 24, 2022. In addition, the seasonal connection between ZRH and SFO is planned again from May 2022.

### So Simple From Sheryl



It is that time of year to perhaps think of a small gift to give to family, friends or neighbors. This was my Mom's recipe and has been passed down to all family members. I have just finished baking 25 small loaves of this wonderful banana bread. It is wrapped in foil and in the freezer ready for me to put a bow on top and give to anyone that drops in or if I need a little something to add to a hostess gift. The surprise when they cut into the loaf is the colorful red cherries. I normally use the small aluminum bread pans, but will some times use a larger loaf pan. When making a large amount I make two double batches.

### Banana Bread:

Cream together: 1 cup sugar ½ cup shortening 2 eggs 3 ripe bananas, mashed Add: 2 cups flour 1 teaspoon baking soda ½ teaspoon salt 5 tablespoons sour cream or orange juice 1 teaspoon vanilla 1/3 cups chocolate chips 1/3 cups nuts (optional) I do not use

1/3 cup maraschino cherries (I cut them up with scissors)

Spray the pans lightly. Bake at 350, 25 minutes for small pans, and 45 for large loaf pans.

Hello again to everyone in RUAEA Land from the East Bay Diablos Chapter. A month ago, I couldn't believe it was October already. This month, I can't believe it is already November. I see a pattern here! My annual personal challenge to see if I can go until November 1<sup>st</sup> before turning on the furnace was a dismal failure this year. After a few colder than normal days mid-October I had the furnace on for a few days. I'm sure all you thick blooded folks back east think this is hilarious.

As things stand now, we are back to holding regular monthly meetings on the first Monday of the month all year long. The only thing that could set everything backward is the Delta variant of Covid getting worse.

The current status is that masks and proof of vaccination or a negative test result within three days are now required to enter a restaurant. Also, because of the way the restaurant has to staff due to Covid, we now have to give them a count beforehand for our meetings. Our November meeting was held on November 1<sup>st</sup> at The Old Spaghetti Factory restaurant in Concord with 18 members in attendance—same number as last month. We have a private room and they configure the tables based on our RSVP number. Social hour started at 11:00 and lunch was served at noon. Instead of paying a flat \$20.00 price for lunch, we are now ordering from the menu and have separate checks. **Joe Leather** collected the raffle money.

We missed **Poldi von Muhlfeld** who was still with her family in Austria. It was great to see **Joe** & **Wilma Leather** after missing them in October. Wilma's eye surgery on October 19 for both cataracts and glaucoma was a success but she is still healing. Congrats to Wilma ... and her surgeon.

After lunch, we held our raffle. As usual, we had an eclectic selection of gifts—wine, a few things I can't remember, and more wine. I think we should rename our raffle the Wine Exchange.

On October 24, a huge storm hit the San Francisco Bay Area. It was the last of several storms over several previous days. Taken together, this series of storms may be one of the biggest of this year's rainy season. The storm predicted for Sunday, October 24, supercharged by a classic <u>atmospheric river pattern</u>, was called a "bomb cyclone" because of its ferocity.

What is an atmospheric river? Made visible by clouds, these ribbons of water vapor extend thousands of miles from the tropics to the western U.S. They provide the fuel for the massive rain, snowstorms and subsequent floods along the West Coast. Atmospheric rivers are responsible for up to 65% of the western USA's extreme rain and snow events, a 2017 study said.

"An atmospheric river marked as a category 4 or a 5 is capable of producing rainfall totals over three or more days, likely to exceed 10-15% of a typical year's precipitation", Marty Ralph, director of the Center for Western Weather and Water Extremes at UC San Diego, told CNN. The October 24 atmospheric river was predicted to be a rare Category 5 event.

What is a bomb cyclone? Meteorologists define a bomb cyclone as a rapidly strengthening storm with central pressure that plummets by 24 millibars or more within 24 hours, <u>AccuWeather said</u>. The process is known as bombogenesis. A millibar is a measure of pressure. The lower the pressure, the more powerful the storm

The cyclone will rival, in some aspects, the intensity of strong hurricanes from the Atlantic this season. For example, the bomb cyclone could be at the intensity level of Hurricane Larry, a long-lived and intense cyclone that churned across the Atlantic in early September, according to AccuWeather. Meteorologist Ryan Maue tweeted that "this monster hurricane-force bomb cyclone on October 24 will challenge observed historical low pressure off the U.S. West Coast."

Reservoir Levels ~ With our rainy week, it is now time to start checking reservoir levels regularly. All of the reservoirs across California are at historically low levels and the stats are, frankly, scary. If we don't have a wet winter we are going to be in terrible shape. As of the end of March, the levels were way below historical levels for that day, and over the summer the situation got much worse. Shasta and Oroville paint a typical picture of the other ten reservoirs. On March 23, Shasta was at 52% of capacity, which is 66% of historical average for that date. Oroville was at 40% of capacity, which is 53% of historical average for that date. On October 20, Shasta had dropped to 21% of capacity, which is 36% of historical average for that date. Oroville had dropped to 22% of capacity, which is 37% of historical average for that date. When full, the water level of Shasta would be at an elevation of 1067 feet. On October 24, the elevation was 883 feet, which means the water was down 182 feet from the top. Wally the Walrus ~ And now for your heartwarming and hilarious wildlife story for the month. Wally the Walrus found fame this year during his travels around <a href="Europe"><u>Europe</u></a>. The Arctic walrus, thought to be about four years old, was first <a href="mailto:spotted">spotted in County Kerry, Ireland on March</a> 14. Sightings of walruses in Ireland are extremely rare; only two have been reported since 1999. It is not known if Wally is a male or female, but the name Wally has stuck. According to a wildlife expert, Wally is likely an adolescent that left the Arctic in search of new breeding grounds and food. Tom Arnbom, a senior advisor to WWF on the Arctic and its marine life, told BBC News that Wally probably deliberately traveled far from home in the North Atlantic and came close to the Irish coast to find food. "Sooner or later they have to come to the shallows, i.e. less than 325-650 feet deep, to feed on mussels or clams. They eat up to several thousand clams a day", he explained. "He is lost while he is far from any friends, but I am not afraid that he will die", Mr. Arnbom stated, adding that the walrus does not appear sick in photographs.

From March 14 to the beginning of September, The 400-pound walrus traveled 2,485 miles and was spotted in England, Wales, the Isles of Scilly, France and Spain. On May 3, Wally was relaxing and basking in the sun on the west Wales coast at the Pembrokeshire resort of Tenby. On May 19, Wally was spotted off the coast of Cornwall, the first ever sighting of a walrus there. In every harbor Wally visited, he climbed into boats and sunk or capsized at least one or two. It's not known if he actually wanted to relax in the boats, or if he was stressed by eager sightseers getting too close to him.

On May 27, Wally was spotted in Les Sables d'Olonne in western France. It was the town's first walrus sighting in 50 years. Unfortunately, he was slightly injured and stressed after colliding with a boat and was cared for by local experts.

Wally arrived at the Isles of Scilly, off the coast in Cornwall, in June. Four wildlife organizations collaborated to build Wally a pontoon platform in St Mary's Island harbor. The pontoon served several purposes. To stop him from boarding boats, the platform would become his safe place, where he could relax, sleep and gain strength. People were told not to disturb him and keep a distance of 165-330 feet away. Wally injured one of his flippers climbing into boats so the pontoon also kept him from injuring himself further.

Wally needed to "feed up" and rest peacefully without interruption to have the energy to make the 1,990-mile journey home to the Arctic. His R&R in the Isles of Scilly is what encouraged Wally to begin his journey

home. He arrived at Crookhaven Harbor in County Cork, Ireland on August 18 and was spotted at West Cork around September 1. He then disappeared for 22 days, sparking concerns for his safety. All his fans and followers were thrilled when Wally was spotted in Iceland on September 23, 550 miles away. His identity was positively confirmed based on scars on the front of both front flippers. And so ends Wally's six month European adventure!

<u>UA Flight 93 Memorial</u> ~ Did you know that there is a Flight 93 Memorial in the San Francisco Bay Area? I am ashamed to say that I did not. The Flight 93 Memorial is in Sugar Mill Landing Park, which is located on the back side of the Union Landing Shopping Center in Union City, California. This memorial monument and garden honors the passengers and crew members who lost their lives aboard United Flight 93. The crew and passengers of Flight 93 are regarded as heroes for their efforts to fight back against the hijackers, ultimately forcing the plane to crash in an unpopulated area, saving hundreds or thousands of additional lives.

The Flight 93 Memorial was completed and dedicated on December 8, 2007. Union City was the first city in the United States to create a memorial specifically for the heroes of Flight 93, before the national memorial in Shanksville, Pennsylvania was created. The memorial includes 40 granite stones bearing the names of the passengers and crew members along a path that begins at a "Circle of Remembrance". On the front side of the 40 stones is a polished stainless-steel mirror to reflect the viewer's own image to signify that it could have been any one of us aboard Flight 93 that day. The back of the 40 remembrance stones were left unfinished to signify that the heroes had unfinished lives. The stones end at a "Circle of Hope", which contains an American flag that symbolizes the bravery and courage of the passengers and crew, as well as hand-painted tiles from local children that represent a more hopeful future. The City of Union City hosts memorial ceremonies every five years at the memorial site. The last memorial service took place on September 11, 2021 for the 20 year anniversary. Sources:

The memorial is the brainchild of Marine veteran Michael L. Emerson, of Hayward, CA. He felt that the nation had mostly forgotten about the passengers and crew of United Airlines Flight 93. In 2002, Emerson began what would become an extensive effort to create the Flight 93 Memorial in Union City, which was dedicated on December 8, 2007. Emerson and Robert Mowat, of the San Francisco-based landscapearchitectural firm Robert Mowat Associates, designed the memorial. Emerson first approached officials in his home town of Hayward about finding a site, but they weren't interested. Emerson then approached city officials in Union City. They were "very enthusiastic" and helped him find the site in Sugar Mill Landing Park. The cost of building the memorial was about \$500,000. City officials were able to find donors for most of the necessary materials and union workers donated their time it. 





Plans for the building were first discussed in 1960 and construction was started six years later. The reason for the delay was due to the fast-paced changes in the development of new aircraft. With the announcement of airplanes such as the SST, DC-10 and Boeing 747 and with these planes definitely on the way, United knew what would be needed in the Training Facilities. The Training Center was designed to meet the goals of providing complete Training for Pilot and Flight Crews.

In April 1966, the design plans for the buildings were finalized and construction began. Because the Flight Center was located entirely on Stapleton Airport property, the required Training Flights for Pilots was easy to arrange and coordinate.

The Flight Training Center was designed by Architectural teams from The Perkins and Will Partnership and Paul R. Reddy and Associates. It was dedicated August 23, 1968 and cost some \$7.5 million to construct.
