### Introducing New Officers and a Regional Director

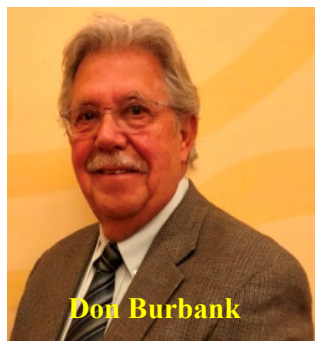


**Virgil Gooselaw**

## Membership DUES INFORMATION

The cost of living continues to go up as everyone knows. While RUAEA is solvent at the present time, we do need to look to the future. Your Board of Directors found it necessary to approve an increase in the annual domestic dues to \$30.00 per year. The dues for Canada/Mexico and Foreign will remain the same at \$47.00 and \$52.00 respectively. Canada/Mexico and Foreign members who opt for Web Newsletters only will pay the new domestic rate. Also the charge for both paper and Web Newsletters will remain at an additional \$5.00 per year.

This increase will help us keep abreast with increased printing and mailing cost for our monthly Newsletter. This increase may seem high to some but think of it as just an extra gallon of gas each year. The information you receive via the RUAEA Newsletter is well worth your extra investment in knowing what is happening with United and your benefits. Effective date for the new rate is January 1, 2019.

Michelle Pritchett, United Airlines Employee Travel Representative stated that there are no policy changes at this time:

- ✓ Imputed income invoices are released on a quarterly basis. It is imperative that the coupon along with a check be returned by the due date to avoid interruption to pass travel.
- ✓ Beginning in January, 2019 retirees will receive W2 forms instead of the current 1099. The W2 aligns with current employee documentation.
- ✓ Exciting enhancements to pass travel information will be released by United shortly.
- ✓ Friends Pass travel enrollment change is twice a year. A benefit offered only to retirees and not current employees.

Alliant President and CEO, David Mooney:

- ❖ Alliant has continued membership growth and has now passed the \$10 billion mark in assets.
- ❖ Saving interest has been increased to 1.80% or 1.90% if your savings balance is more than \$100.
- ❖ Recognizing members' disappointment in the closing of several branch offices, they will continue to the evolution to phone and digital banking. The cost is 60% lower than branch bank locations.

**Business Meeting –**  
**Cleveland Airport Marriott Hotel Grand Ball Room**  
**Saturday, September 22, 2018, 0830-0930**



Meeting was called to order at 0834 by President **Virgil Gooselaw**. Virgil welcomed and thanked everyone for their support of his Presidency the past two years.

**Motion** - A motion was made by **Hank Gosselin** to approve the minutes as published and waived their reading. The motion was second by **Tom Cunningham** and all approved.

Virgil spoke on the state of RUAEA as we, like many other organizations, continue to find a decrease in membership. We will continue to work toward recruiting new retirees.

**Don Burbank** has accepted the position as President. Don retired 3 years ago and still has some good contacts at United. Don stated that while we do have some problems, we can work our way through them. **Tom Cunningham** will be the new Executive V.P. He was formerly the Regional Director of the Northwest Region.

Bylaw changes were approved by the board and must be voted on by the membership.

- ❖ Changes were published in the July 2018 Newsletter affecting Article 7 section 8 and section 15 and Article 8.
- ❖ **Claudia Blancett** is the new Communications Liaison. She is listed in the Newsletter and if you would like to be on her mailing list let her know.
- ❖ Terms of office has changed allowing member to run for more than one office was proposed.

**Motion** – A motion was made by **Wanda Bryce** to allow members to hold more than one position. It was seconded by **Linda Scriven** and all agreed.

**Jim Simon** - *Executive V.P.*, thanked Virgil for all of his work on creating our 501 (c) 3. We are having the benefit of saving in several areas.

- Regional Directors are no longer required to travel to the chapter but may do so with prior approval.
- We are proposing a \$3 increase in dues which will take effect at the beginning of the year. The increase must be posted in the Newsletter 60 days prior to the effective date.

- Jim spoke on the benefits of volunteering and encouraged others to consider getting involved. He extended his thank you for the support he has received and what a great pleasure it was to have served.

**Pam Ziebarth** - *Treasurer*

- ✓ Last year's income was about \$120,000 and expenses of nearly \$107,000 for a surplus of about \$13,000.
- ✓ Expenses were largely due to the Newsletter, which account for about 53%. Website is a little over 12% and board travel is 16%. Remaining 18% goes to various operating expenses.
- ✓ Cash Reserves, which is savings, checking and five CD's are \$216,000 compared to \$201,000 at this time last year; thus \$15,000 more.
- ✓ Current income from dues, contributions and interest is \$75,000 and running about \$9,000 less than last year, at this time. Two big expenses, Newsletter and board travel will impact this situation negatively during the next three months.
- ✓ For the future, we have one of our \$15,000 CD's maturing in December. Suggest we have the board vote on adding \$10,000 and make it a \$25,000 CD maturing at the end of four years.
- ✓ Bottom line is RUAEA is solvent.

**Hank Gosselin** - *Past President*. Hank has served in many positions in the last 14 years but found the last two years the most frustrating due to lack of volunteers.

- We have not had an election in the last two years for that reason. **Diane Webb** and **Sonda Sandstedt** have been a great help to Hank in recruiting efforts.
- **Ruth Morabito** has stepped forward to become the Region Director for Mountain Region and Arizona.
- Virgil will now assume the position of Past President and since he also works in the Denver office, he still needs everyone's co-operation.

**Ron Bertacini** - *Site Selection Committee*

- ✓ 2019 Convention site will be at the Double Tree by Hilton Stapleton North. This facility has recently been renovated. The convention dates will be September 24 – 28. Hotel cost is \$129 plus tax, breakfast is included and 10% discount on lunch and dinner. Hotel price available September 22-29.
- ✓ **John Koehl** sends his regards and his regret that he will no longer be able to serve on the

Site Selection Committee. We thank John for his years of service and dedication.

**Torgy's Travel Tips – November 2018**  
**Kansas City Secrets**

3 Tips beyond BBQ ~ Of course, Kansas City is renowned for BBQ mid-west style, with that thick, sweet yet tangy, tomato based sauce gracing perfectly smoked brisket, pork, chicken or turkey. Yum, I can

already taste it! But this month I'd like to suggest 3 sites (or sights, perhaps) in Kansas City that just might have you looking at EmpRes to book a quick get-a-way. They are SubTropolis, The TWA Museum and The National Airline History Museum. Here's the story.

**SubTropolis** is the world's largest underground business

complex, carved out of limestone that dates back 270 million years. Now give me a minute to explain why you might want to see this. This gigantic facility is the size of 14 football fields, located 100 ft inside a hill, 10 minutes from downtown. It is the remnant of limestone excavation needed to make concrete and asphalt for freeways, malls and parking lots all over the country. Since the limestone was excavated horizontally (instead of vertically through a shaft), giant pillars about 25ft square, spaced about 40 ft apart were left intact. This created empty spaces between the pillars known as "rooms". So what do you do with millions of sq ft of empty rooms where the temperature is a constant 65 degrees, with no tornados or precipitation? Well, if you were Lamar Hunt, the owner of the Kansas City Chiefs and creator of the American Football League in the 1960's, you'd buy up the property, build an amusement park on the top (Worlds of Fun) and start leasing out the underground rooms to Ford, Pillsbury and Russell Stover. And so he did.

Today, over 55 companies and US government agencies are tenants. All US collectable postage stamps are stored here. Hollywood movie studios store thousands and thousands of original, in-the-can movies such as Gone with the Wind, The Wizard of Oz and Ben Hur. TV series such as Seinfeld and the old Roadrunner cartoons shows are preserved here. "Automotive Alley" is where new Ford fleet trucks/vans are customized for huge companies like Fed-Ex and UPS. And if you ever have wondered where that ubiquitous "cloud" that stores our photos and data is located, well SubTropolis is one address.

The facility is completely paved and lit, and is open to visitors Mon-Fri 6AM-6PM. The location is 8300 NE Underground Dr, just east of I-435. Worlds of Fun Amusement Park, which is open April-December, is conveniently located (on the surface) 2.7 miles away.

The **TWA Museum** located at Wheeler Downtown Airport in Kansas City, showcases aircraft, memorabilia, flight simulators, cockpit panel simulations and a plethora of reminders of the "good old days" of Trans World Airlines. It's fun to compare our two companies, the similarities and the differences. Kansas City was the



world headquarters for TWA so the volunteers who staff the museum have decades of history working at TWA. The museum is open Tues.-Sat. 10AM-4PM. A small admission fee helps support the museum. The location is 10 Richards Rd. and there is plenty of free parking. (Oh, I almost forgot: there will be a new hotel opening at JFK airport in 2019 called the TWA Hotel. Built with the colors, furniture style, logos and accoutrements reminiscent of TWA's 1962 flight center at Idlewild airport, it will have views of JFK's runways, a 10,000 sq ft observation deck with pool and "flight tubes" connecting to Jet Blue flights. Check out [www.TWAhotel.com](http://www.TWAhotel.com) for more info).

Back to Kansas City, located at the same downtown airport is the **National Airline History Museum**, or Hangar 9 as it is routinely called. The museum began in 1986 as the Airline History Museum. In 2011, the word "National" was added to its name making the museum eligible for federal grants and national funding. Two UA pilots sit on the museum's advisory board.

The hangar portion of the museum houses 5 aircraft, 2 of which are in flying condition: a Martin 4-0-4 and a Lockheed Super G Constellation (complete with first class sleeper seats in the rear—way ahead of its time!). Work is underway restoring a DC-3. There is also a Lockheed L-1011 Tri-Star and the original Howard Hughes TWA Moonliner which used to adorn TWA's corporate headquarters in Kansas City. The museum portion houses all kinds of memorabilia including some from UA, near and dear to the hearts of all of us. Their address is 201 NW Lou Holland Dr. And before you leave to savor some BBQ at *Arthur Bryant's*, be sure to check out the nice view of the Kansas City skyline from the south doors of the hangar building.

As a reminder, when listing for flights to Kansas City (MCI) there is nonstop service from ORD, DEN, IAD, IAH, EWR and SFO.

year as a Maintenance Base. Several from our chapter plan to attend. I will report on this event in next month's newsletter.

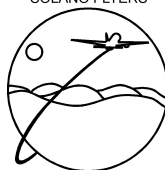

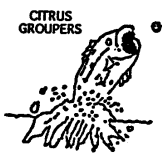

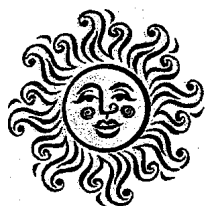

Our members have travelled a lot since our last report. The **Sugas** (BOSSW/CS) retired, had a lovely time exploring South Africa.

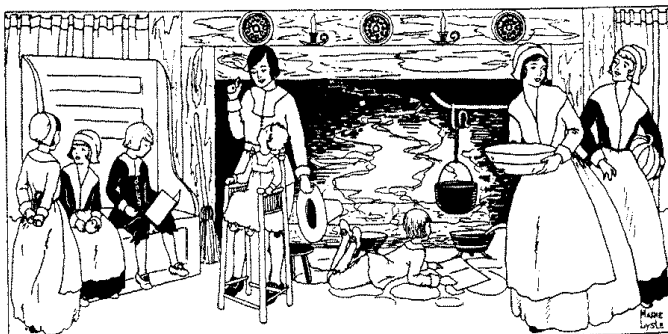

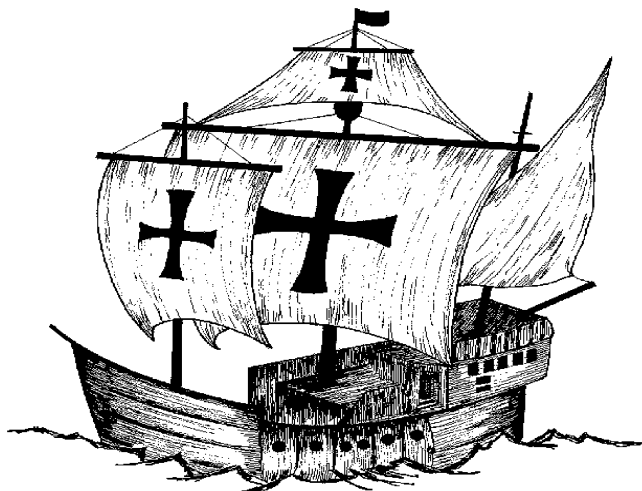

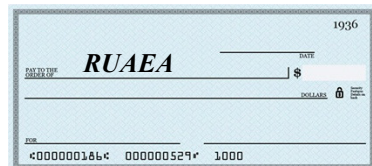
