Donald Gene Burbank *June 6, 1945 - August 25, 2024*



Donald Gene Burbank passed away at his home in Golden, Colorado, on August 25, 2024, at the age of 79. In true Burbank fashion, when Don was diagnosed with terminal gastric cancer, he told his doctor he would kick cancer's butt. He did so with contagious optimism for more than a year.

Don was preceded in death by his parents, Harold & Ella Burbank (Schneider). He is survived by his wife Toby, his brother Jim and his wife Pat, his children Dani, Jeff, and Julie, their spouses Andi and Jason, seven grandchildren, and his beloved dogs.

He was known as Boss, Dad, Papa, Brain, and Coach. His energy and passion for life were evident in his early hobbies of fixing engines and taunting the local sheriff. He continued fixing his entire life but also raced boats, four-wheeled through the foothills of Colorado, and rode snowmobiles, motorcycles, and horses. He also skied, traveled, coached football, and wrangled hogs just to name a few.

Don was a master storyteller, captivating everyone around him with his humor and charisma. He was one of the original "influencers" and could talk anyone into doing nearly anything (stealing cars, riding roller coasters, or jumping off the roof, to name a few).

Don turned his hobby of fixing engines into a remarkable career earning the prestigious FAA Charles Taylor Master Mechanic Award for 50 years of service well before he retired. His journey began as an airline mechanic when he joined the Navy at 18—a decision recommended by the sheriff as Don told the story. He went on to work for Frontier Airlines and ultimately retired as United Airlines' Senior Vice President of Europe, South America, and the Eastern United States. Even in retirement, Don remained dedicated to aviation, volunteering to rebuild aircraft at the Smithsonian Air and Space Museum, serving as flight crew for the B-17, and leading the Retired United Airlines Employees Association as its President.

Don loved animals. His households always had pets—fish, cats, dogs, horses, and more dogs if possible. He also helped his kids raise hogs, sheep, and even cows one year. Don embraced all those around him. After marrying Toby later in life, he took great pride in his blended family welcoming her adult children—John, Alli, Julie—and their children into his life.

Everyone has a story to tell about Don and they are almost all funny or inspirational. Please come share your stories as we celebrate Don's life on September 15, 2024, from 1-4pm at the Wings Over the Rockies Air and Space Museum. ■

The Writer's Column
Boeing Aircraft Model 247

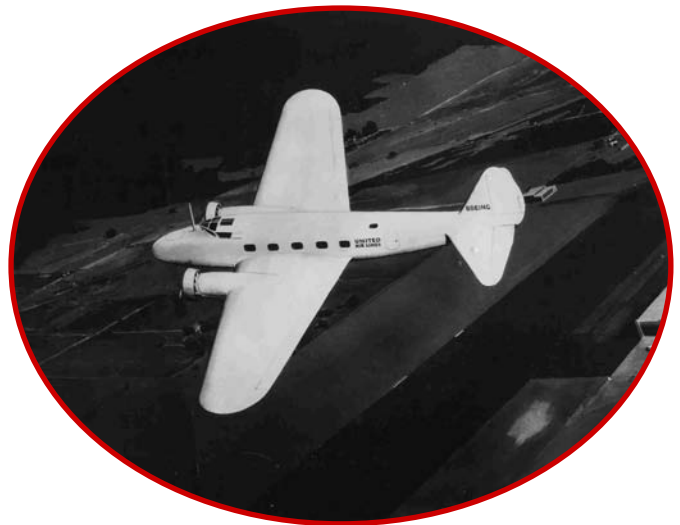
Beginning in the early 1920's, aircraft were primarily designed to carry mail. When the US government changed the method used to set the price of carrying mail, from a total weight method to an available volume method, aircraft design began to change. Regardless if the aircraft had a full load of mail or not, the airline received a fixed payment. Although this proved to be a lucrative business, airlines sought a way to increase profits. Aircraft design began to make space for passengers, just one or two in most cases, which achieved the desired results. Despite the changes, not many citizens were interested in flying in tiny, cramped quarters. However, the ability to cross the country in much less time than the train, appealed to corporations and also had the ability to pay the high ticket costs.

When Charles Lindberg flew across the Atlantic, his feat was communicated around the world. With his subsequent tour across the country, the interest by the population in flying, subsequently grew significantly. Airlines quickly began negotiating with manufactures to design aircraft to accommodate passengers. A large number of various aircraft took to the skies, among them was the Boeing B-80, and the Ford Trimotor. Although more space was provided to increase the number passengers and their comfort, the 3 engine design created a lot

of cabin noise and a rough ride. So much so that airlines would offer gum and cotton to the passengers.

The government revised the mail payment in an effort to get airlines to make improvements. Thus they provided a subsidy to airlines to make aircraft safer, incorporate two way radios, navigation equipment, and carry more passengers. This proved to be the encouragement aircraft manufacturers needed to completely design planes around the passenger. Boeing immediately set about to design such a plane.

In 1926, 31 year old Phillip Johnson became the president of Boeing. By 1929, he had overseen the acquisition of engine manufacture Pratt & Whitney and a host of other companies. Approached with the idea of a new aircraft, Johnson set about to make that a reality. The aircraft would become known as the B-247. While other manufacturers focused of designing aircraft that could carry more passengers, Johnson held the theory that speed was more important, so he envisioned an aircraft that could carry 8 to 10 passengers and capable of flying coast to coast quicker than their competitors. This new plane was to be constructed entirely out of metal, unlike the past aircraft of wood or metal tubing covered with fabric, fitted with just two engines. To reduce drag the landing gear would be retractable. An auto pilot would be installed for night flying. Cabin air would be temperature controlled and other amenities incorporated for passenger comfort. Johnson also added that it needed to be constructed with the utmost urgency. Johnson insisted that this new aircraft exceed the fastest of the current aircraft by 50%, or over 180 mph and capable of a range of at least 485 miles. An initial purchase agreement was reached for 60 aircraft to be built.



In an effort to the reduce the design/construction timeline, Boeing drew upon the experience of an all-metal construction it utilized on an aircraft which it was to build for the military as a bomber. It had a single non braced wing to improve airflow and just two engines,

although rejected by the military due to poor performance, this would provide a foothold on fuselage design for the B-247. To improve aerodynamics, a portion of the wing structure would pass thru the lower center of the fuselage, through the cabin, although creating a hump for passengers.

Boeing's greatest concern was weight. A heavier fuselage, retractable gear assembly, avionics, fuel capacity and passenger amenities, would have an impact on the size of engines and their weight, required to achieve a 180 + mph aircraft. Several items of contention between Boeing and United Airlines arose. Boeing pushed for one pilot, while United insisted on two for safety. The width of the aisle between the seats, 9" or 12", would increase the fuselage width and weight. Boeing felt that a toilet was not necessary, but United insisted. Even the need of a mirror in the toilet was argued, with United winning out. However, Boeing insisted on some items to include; no onboard engine starters, no cut-out switches on the landing gear and the aircraft would not be painted, in an effort to save weight.



Once agreement was reached, Boeing began production. Initially many parts were hand fabricated and then drawings made, saving time. Landing gear production, and other tasks, were outsourced. Production worker number increased as well as shift and overtime requirements were agreed upon. Boeing implemented a number of aerodynamic improvements developed by the predecessor to NASA, such as installation of engine cowlings and engine placement on the wings. The biggest issue was the power plant and propeller, eventually settling on a three bladed variable pitch propeller mounted to a 550hp radial engine.

On February 8, 1933, and behind schedule, the first test flight was accomplished. The aircraft performed flawlessly. Achieving a top speed of 182 MPH and a calculated range of 485 miles, the B-247 would be the

fastest plane of its day (the model 'D' would increase speed to 200 mph and range to 750 miles). The unit cost of \$68K exceeded the cost estimate, but United was so pleased with the aircraft, they were confident they could recoup the costs. The aircraft soon entered service and received a positive response from flyers. The cost of a ticket remained the same flying on previous aircraft; however travel time on similar routes was greatly reduced. A SFO to NYC would only take 21 hours, a savings of 4 hours flying time.

Although United heavily marketed the B-247 and it was the finest aircraft built at the time, the aircraft industry was quickly catching up on the need to manufacture larger, faster planes. With the arrival of the Douglas DC-2 in 1934, the B-247 and all its advances, would soon be become outdated and were being sold. Two excellent examples of the B-247 are on display in Seattle and Washington DC.

United Goes Back to School with \$1.25 Million Contribution to DonorsChoose August 28, 2024



United is kicking off the school year with a \$1.25 million donation through education nonprofit DonorsChoose, funding aviation and science, technology, engineering

and mathematics (STEM) classroom projects across the country. United will triple the amount of donations for DonorsChoose aviation projects submitted by teachers in nine markets and match funding for STEM projects at Equity Focus Schools.

For the second year in a row, United's contributions will help bring aviation and select STEM-focused projects to life as they're posted on DonorsChoose over the next few months. If teachers in the selected cities are interested in submitting a project to be considered for funding, and viewing 2023 funded projects, they can visit donorschoose.org/united. Participating cities include Chicago, Denver, Washington, D.C., New York,

Houston, San Francisco, and Los Angeles, as well as in Phoenix and across Hawaii.

"This program is a testament to United's commitment to diversifying our workforce and removing barriers to STEM and aviation education and careers for underrepresented groups," said Helon Hammond, VP of Global Learning, People and Community Impact for United. *"Last year, we were able to help fund 2,592 projects across our hub cities and target markets. We're proud to collaborate with DonorsChoose for the second year in a row and continuing efforts to support the organization as their sole aviation partner."*

DonorsChoose was founded in 2000 by a high school teacher. According to a 2024 survey by the non-profit, educators spend an average of \$610 of their own money on supplies for their students, and the cost is higher for teachers of color and teachers at Equity Focus Schools.

DonorsChoose empowers public school teachers to request the classroom resources they need for their students, and supporters who feel inspired to give can help fund those resources. DonorsChoose ensures the integrity of funding at every step of every project by vetting all requests, purchasing each item, and shipping materials directly to verified teachers.

"United Airlines is helping the new school year take off on a strong note," said Alix Guerrier, CEO of DonorsChoose. *"By directly funding DonorsChoose projects, United Airlines will fulfill ideas and programs that will inspire students to explore futures in aviation and STEM."*

With nearly 100,000 employees worldwide, United offers a wide variety of career opportunities within the STEM field ranging from pilots, aviation maintenance technicians, flight dispatchers, and network planners. Last year United also gave \$1.25 million to DonorsChoose in support of aviation projects, making a total of \$2.5 million in just the last two years.

United is the first to purchase sustainable aviation fuel for Chicago O'Hare August 12, 2024



Sustainable Aviation Fuel (SAF) is chemically identical to normal jet fuel, but it's made from renewable materials rather than fossil fuels and can reduce carbon emissions on a lifecycle basis by up to 85%, compared to normal jet fuel.

United brought SAF to O'Hare largely due to the Illinois SAF tax credits that Illinois Governor J.B. Pritzker signed into law in 2023 – the first legislation of its kind in the Midwest.

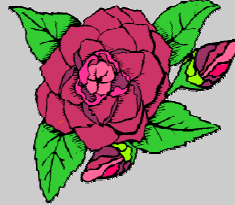

Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me at 30 San Piedras Place, San Ramon, CA 94583-3018. This is such an easy thing to do to support our troops. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say Manufacturer’s Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too; however, please send in coupons at least every other month so the troops have a longer time to use them. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated - food, nonfood, baby and pet; and current and expired

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022. In September, I turned in an incredible 1073 coupons! Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. All the coupon cutters are telling me that they are not getting coupons like they used to. It’s really bad in the SF Bay Area and I’m glad that other areas of the country are still able to send coupons. If it weren’t for the RUAEA folks from all over the country sending me coupons, my chapter would have very few coupons. We had an update from **AnnMarie Sutherland** who is the president of the American Legion Auxil-

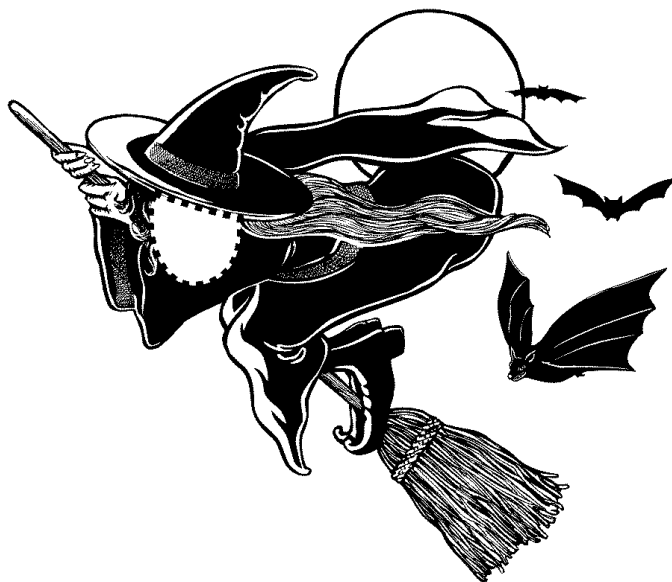

The Reunion Team is working very hard to make all your efforts worthwhile so you can have a great time with us and that it will make up for all of your effort in getting here.

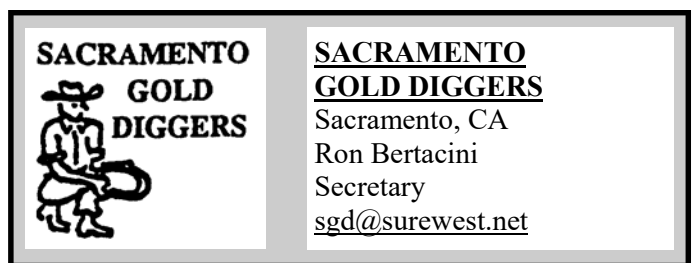

From Marty Etler's memories, August 1964:

As I watched this year's Democratic National Convention in Chicago and heard the various speakers, my mind slipped back to August 1964 when the Democratic National Convention was held in Atlantic City, New Jersey.

In November 1963, President John F. Kennedy was assassinated and Vice President Lyndon Baines Johnson became the President. I remember although there was a period of mourning, there was a nationwide hope that Johnson would succeed in the presidency.

I don't know if any of you have ever been to the Democratic National Convention in Atlantic City, it is immense. To hold 7000 people there is nothing, the new one they built is even bigger. Violet and I were given tickets for the opening day, from one of our political friends who couldn't be there on that day, so he gave them to us. Violet was elated; she really loved all the action that was going on.

As we got to our seats, it was so noisy in the auditorium, you could hardly think. If you wanted to talk

to anyone, you had to shout because there was so much noise. About 7 o'clock, the chairman tried to bring this convention to order with about 5000 people in attendance; I saw a small man come up to the podium and take his position to speak, I found out later it was Senator Pastori from Rhode Island.


With all the noise, he started to speak, and when everybody realized it was a eulogy to the late John F. Kennedy, the place came to an eerie silence. He talked in a clear resounding booming voice, something that Violet and I had never heard; he talked for about 20 minutes and stopped. There was absolutely no sound in this giant auditorium, then someone started to clap and more people clapped and soon there was a resounding echoing noise all through this auditorium.

People were standing on the chairs and whistling and yelling and trying to be heard; even Violet was standing up and clapping for all her worth. I finally got up on a chair and I did the same thing. Normally I'm not a guy who goes for this type of thing, but I was caught up in the whole atmosphere to show appreciation.

On our way home the next day, there was silence in the car, and finally Violet said, "Well what do you think". I said it is one astounding memory that both of us will have for the rest of our lives. There were many times when we talked about this special day, and now it has come back to mind.

On November 5, 1964, Lyndon Baines Johnson faced Barry Goldwater for the general election for president. Johnson won the election with more than 16 million votes. I had never seen an election like that, and I doubt if I ever will.

- ☺ My car broke down between the marina and the Hallmark store. Now I'm stuck between a dock and a card place.

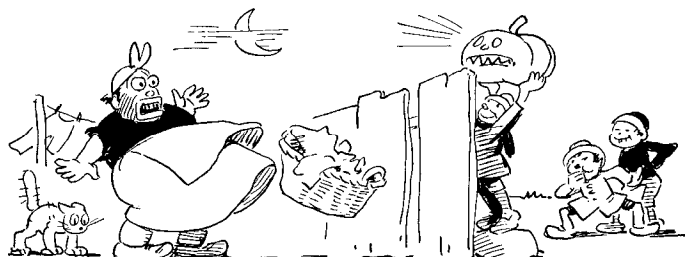

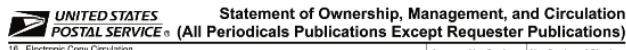
