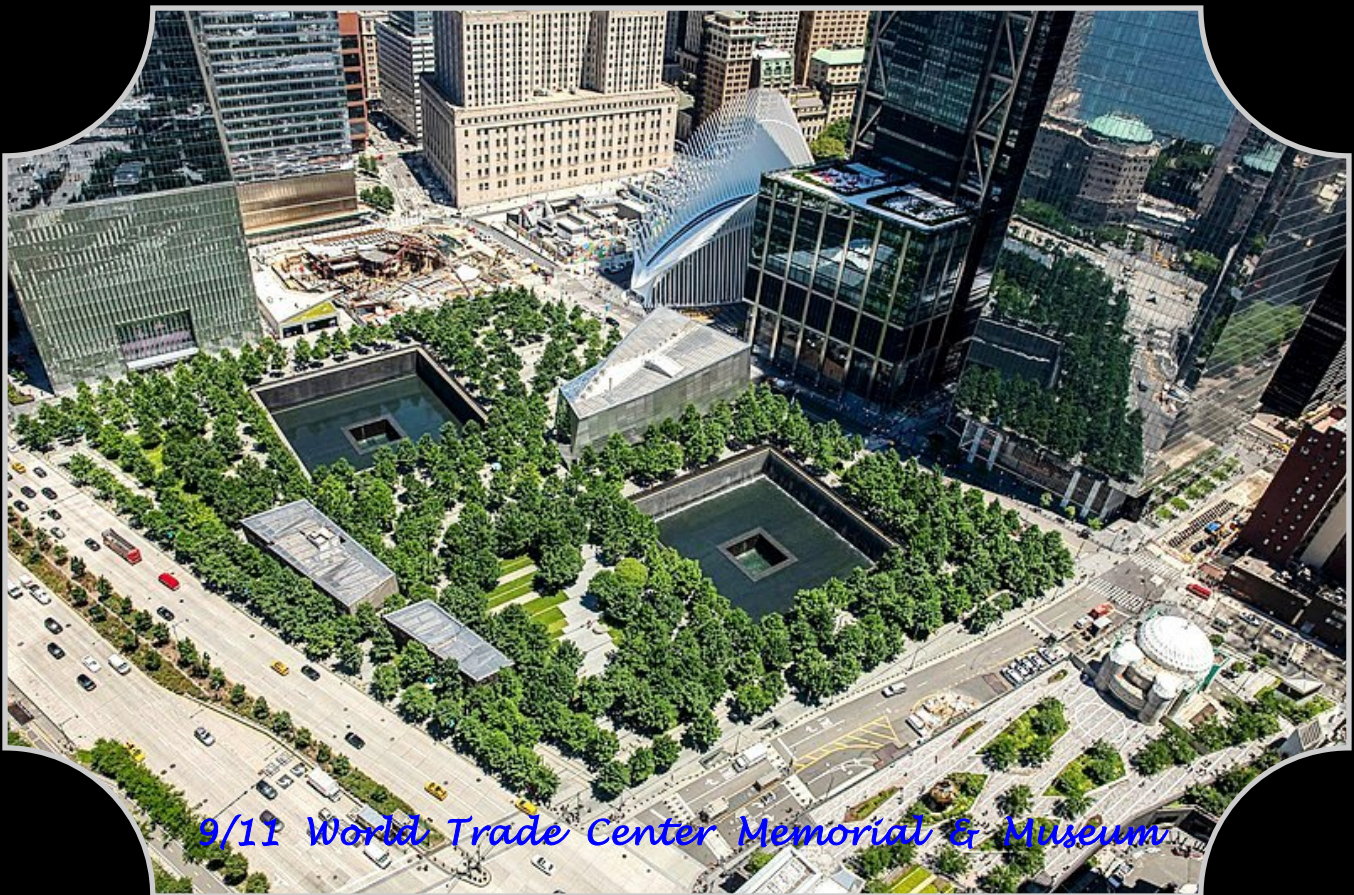

20 Years Later – We Remember – 9/11/2001



As September 11, 2021 approaches, it is obvious the attack 20 years ago has not been forgotten. Our United Family members have been remembered in writing by **Ron Bertacini**, who has written about Flight 175 and **Dave Detwiler** who has written about Flight 93. **Kathleen Denker**, President of

EWR Clipped Wings Chapter has written about the EWR Clipped Wings Activities for 9/11 20th Anniversary. We are sure there will be many commemorations throughout the country. The United crews, the American crews, the passengers, firefighters, police, first responders, the thousands of lives lost in the Twin Towers, the Pentagon and on the ground, as well as on the planes will be remembered. Indeed, they are still grieved and deeply missed, but not forgotten

United Airlines Flight 175 by Ron Bertacini ~
United Airlines Flight 175 was a scheduled domestic passenger flight from Logan International Airport, in Boston, Massachusetts, to Los Angeles International Airport in Los Angeles, California. On September 11, 2001, the Boeing 767-200 was flown by **Victor Saracini** and **Michael Horrocks**, (both based at JFK). The crew included flight attendants, **Robert Fangman**, **Amy Jarret**, **Amy King**, **Kathryn Laborie**, **Alfred Marchand**, **Michael Tarrou** and **Alicia Titus** (Based at BOS).

The plane was hijacked by five Al-Qaeda terrorists and was deliberately crashed into the South Tower of the World Trade Center in New York City, killing all 65 people aboard and an unconfirmed number in the building's impact zone.

Approximately thirty minutes into the flight, the hijackers forcibly breached the cockpit and overpowered the captain and first officer, allowing the lead hijacker and trained pilot to take over the controls. Unlike American Flight 11, whose transponder was turned off, Flight 175's transponder was visible on New York Center's radar, which depicted the aircraft's deviation from its assigned flight path for four minutes before air traffic controllers took notice at 08:51 EDT. Thereafter, they made several unsuccessful attempts to contact the cockpit. Unbeknownst to the hijackers, several passengers and crew

members aboard made phone calls to family members and relayed information regarding the hijackers and casualties suffered by passengers and crew.

The aircraft crashed into Tower Two (the South Tower) of the World Trade Center at 09:03. The Flight 175 hijacking was coordinated with that of American Airlines Flight 11, which struck the upper floors of Tower One (the North Tower) 17 minutes earlier. The crash of Flight 175 into the South Tower was the only impact televised live around the world. The crash and subsequent fire caused the South Tower to collapse 56 minutes later at 09:59, resulting in hundreds of additional casualties. During the recovery effort at the World Trade Center site, workers uncovered and identified remains from some Flight 175 victims, but many other body fragments could not be identified.

Now, 20 years after those horrendous attacks on the United States, we commemorate the thousands who died that day, especially the members of our United Family. They are gone, but they are always remembered, never forgotten.

The 81 minutes of United Airlines Flight 93 By Dave Detwiler ~ At 0700 of September 11, 2001, Captain **Jason Dahl** and First Officer **LeRoy Homer**, both based at JFK, were in a secure area of the Newark, NJ terminal planning their flight to San Francisco that day.

In a nearby area the flight attendants were being given their assignments by purser **Debra Welsh**; she and **Wanda Green** would be working first class. **Lorraine Bay**, **Sandy Bradshaw**, and **CeeCee Lyles** would be in coach. The flight attendants were based at EWR.

By 0730 the cabin was prepared and early boarding had begun. It was going to be a light load today, only 37 passengers in a cabin with 168 seats. Forty of these passengers and crew were just ordinary people, living their lives, going to San Francisco, some for business, others for pleasure. None of them knew they would be in a fight for their life today. However there were four men among the passengers who were Al Qaeda terrorists. They knew they were going to die today along with all the rest of the passengers and crew. Their plan was to hijack the airplane within fifteen minutes from takeoff.

The doors were closed and the plane pushed off the gate one minute late. However the 8 AM bank was heavy this morning and it took another 41 minutes to reach the runway. At 8:42 Capt. Dahl pushed both throttles forward to the takeoff power setting and the two engines produced a combined 73000 pounds thrust pushing the 757 quickly to the rotate speed. Capt. Dahl eased back on the controls and the airplane lifted quickly off the runway increasing speed as it went.

Four minutes later at 8:46 American Airlines flight 11, a 767 out of Boston, crashed into the upper floors of the north tower of the World Trade Center. The crew and passengers on flight 93 were not aware of this. They

continued climbing over Pennsylvania until 9:02 AM. The autopilots were engaged. One minute later at 09:03 United Airlines Flight 175, another 767 out of Boston slammed into the south tower of the World Trade Center. Now the world knew this was no accident, this was a terror attack. The crew and passengers on flight 93 were still not aware of what was going on.

At 09:24 an alarming ACARS message arrived in the cockpit of flight 93. It was from a dispatcher in Chicago whose name was Ed Ballinger. The message said *“Be aware of cockpit intrusion, two aircraft in NY hit trade center builds”*. At 9:26 Captain Dahl sent a reply to Ballinger’s message which said, *“Ed, confirm latest message”*. Two minutes later at 9:28 there was a disturbance at the cockpit door, the hijacking of United Airlines Flight 93 had begun.

Back in the cabin the four terrorists put red bandanas on their heads. The two assigned to break into the cockpit went straight to the cockpit door. We do not know precisely how they got the door open. Air traffic controllers could hear someone shouting *“Get out of here, get out of here”* then, *“Mayday, mayday, mayday”*. The pilots fought back the only way they could, they keyed their microphones and yelled out over the ATC frequency.

At 9:31, an unfamiliar voice came over the radio saying *“Ladies and gentlemen, here the captain, please sit down and remain sitting, we have a bomb onboard, so sit”*. The terrorist pilot had hit the wrong button on the radio panel and was transmitting to ATC instead of the PA system to the passengers. The first class passengers were herded to the back of the airplane.

From this point on much of what we know is from the transcript of the cockpit voice recorder, CVR.

At 9:37, American Airlines flight 77 crashes into the Pentagon. At this point the passengers started using the airphones attached to the seatbacks. They soon found out about the three planes crashing into buildings. Word spread quickly among the passengers. Now they know what their fate is going to be if they don’t do something about it. They quickly take a vote and form a plan. The flight attendants start making pots of boiling water to throw on the terrorists and the men plan to rush forward and take out the two terrorists in first class then break into the cockpit and take over the airplane from those terrorists.

At 9:45, passenger Todd Beamer attempted to call his wife using an airphone but the call did not go through. Then he dialed zero and finally reached the call center supervisor. He made her promise to call his wife at home and tell her how much he loved her and the two kids. During their conversation they prayed the Lord’s Prayer together, then recited the 23rd Psalm together.

At 9:57 he ended their conversation and said, *“Okay guys, are you ready, let’s roll”*. The next six minutes are chaos, the CVR picks up sounds of a fight near the cock-

pit door. There are screams, men yelling, things crashing. The fight lasts two minutes. At 9:59 there are sounds of a food cart crashing into the cockpit door, dishes and glasses breaking.

At 10:03 the CVR goes silent, Flight 93 is down.

In spite of all the years of planning by all the terrorists these forty crew and passengers of flight 93 had thwarted their plans and prevented them from using the airplane to murder untold people in Washington DC. Flight 93 was the only one of the four hijacked flights that did not reach its target on 9/11, it was the only one where no one was killed on the ground, and no one was even injured on the ground. These forty crew and passengers are truly heroes and should always be remembered as such.

I can remember way back then how everyone said, *“We will never forget”*. Sadly, many have already forgotten, both the 40 brave folks on flight 93, but also the 2977 who perished on 9/11/01. On this, the 20th anniversary of 9/11, I hope that all of us will never forget what happened that day.

EWR Clipped Wings Activities for 9/11 20th Anniversary by Kathleen Denker, President of EWR Clipped Wings Chapter ~ There are several activities that we are

involved in for the 9/11 20th Anniversary! There is a large group of EWR F/A’s who were fund raisers for our monument in Shanksville for 5 years after 9/11 to help the members of the families of our F/A’s and the monument! Some of the people that go are members of CW and some are not. Many of us go to Shanksville for the anniversary (we went as a large group for the 1st, 5th, 10th, 15th and now the 20th anniversary). Since many of us in our EWR Chapter go to this 2 day Shanksville trip, we planned for our Clipped Wings of EWR to do something different. We will go to the Garden of Reflection in Bucks County PA on September 30 as a group to honor our crew heroes from that sad day; the Garden of Reflection is The Official Pennsylvania Memorial to the Victims of the September 11, 2001 terrorist attacks. The trip to Shanksville is coordinated by a few F/A for getting the bus and hotel for us. As usual, our bus is full but we will be there in uniform for the ceremony on 9/11.

One more thing that EWR CW is involved in is assisting with an essay contest driven by the author of *“Reclaiming the Skies”* named Tom Murphy. Several of us have reached out to schools and our membership to participate in this contest which is in honor of the 20th anniversary of 9/11. There is going to be a gathering on September 1 at EWR (I am not sure exactly where yet) to bring together the creators of the essay contest with some of the writers and announce the winners. One of our members is actually a Judge in the contest. Several of us in EWR CW will be attending this event! If you are interested in learning more about this endeavor, please let me know and I can get you to the right person. The book

is amazing in the connections this self-employed airline trainer writes about.

As you can see, the EWR CW Chapter has not forgotten and continues to honor the crew heroes of 9/11.

Order up: Pre-order available now
July 28, 2021



Starting today on select flights, all customers – no matter what cabin of service they're in – can use our award-winning mobile app and website to pre-order meals, snacks and beverages up to five days before they're scheduled to travel. We are the first and only U.S. airline to offer economy customers the option to pre-order snacks and beverages, a reflection of our United Next plan to transform the customer experience throughout our operation.

This technology is an extension of our contactless payment platform that allows customers to store payment information in a digital wallet. Our pre-order option is now available on select flights departing from ORD to HNL (Honolulu), SNA (Orange County, Calif.), SMF (Sacramento, Calif.) and SAN (San Diego, Calif.) and will expand to all flights over 1,500 miles by early fall.

"Our new pre-order option reflects the customer experience transformation taking place across the airline – customers in our economy cabins will have an easy, convenient way to choose their snack or drink, and our flight attendants can move through the cabin faster, delivering more personalized service," said EVP and Chief Customer Officer Toby Enqvist.

How it works: Five days prior to departure, customers will see an option in the Reservation Details section of the United app or on [United.com](https://www.united.com) to pre-order food and beverage items available for their specific flight. Customers will also receive an email notifying them when pre-order is available.

In economy cabins, customers can pre-order snacks and beverages from our buy-on-board menu. They will be asked to enter their credit card information but will not be charged until the items are served to them on-board.

In premium cabins, customers can select their meal option directly from the United app or website. Once they make their selection, they will get a receipt emailed to them.

England reopens to US travelers August 2
July 28, 2021



London is calling! England announced it will reopen to travelers from the U.S. beginning August 2. Visitors must be fully COVID-19 vaccinated with vaccines that have been approved by

the FDA in the U.S. and must take a test before departure, as well as a PCR test within the first two days of arrival.

Additionally, passengers will need to complete a passenger locator form prior to traveling to England and provide proof of U.S. residency. To help make things easier, the Travel-Ready Center (TRC) in the United app will walk customers through the required documents when they book a trip to London. COVID-19 test results and vaccination records can be stored in the TRC.

"Today's announcement is yet another major milestone in recovering from the COVID-19 pandemic with the opening of one of the most important markets from the U.S.," said International Network and Alliances VP Patrick Quayle. *"United has demonstrated that we can operate flights between the U.S. and England safely, and we are eager to help rebuild these economies by facilitating business and leisure travel."*

Currently, we operate daily flights to LHR (London Heathrow) from ORD, EWR, IAD and SFO. In August, we'll have six daily flights between the U.S. and LHR, including a second daily flight from IAD and increased service from IAH from five times a week to daily.

We've proudly provided service to LHR for nearly 30 years and have maintained continuous service between the U.S. and LHR over the course of the pandemic. We look forward to resuming additional LHR service in the coming months, as well as launching new nonstop service between BOS (Boston) and LHR.

Torgy's Travel Tips – September 2021
The Latest News and Travel Tips

Open or closed? Mask or no mask? Vaccination certificate or PCR test (or both!) Just as we thought restrictions on travel were lifting, the Delta variant is packing a one, two punch into our daily lives again. Former UA colleagues in Australia update me weekly on severe restrictions escalating in Sydney due to an explosion of Delta

variant cases, hospitalizations and deaths. Cruise ship staff is isolating passengers who test positive after leaving port while still attempting to maintain a festive atmosphere. Schools were set to reopen with fewer restrictions than those in place for the last 16 months, but many districts are now re-thinking their plans. So, is there any good news? Yes! **Please note that the information described below was current and correct as of August 7, 2021. Always verify before you travel as rules can and do change!**

United Kingdom: August 2, 2021 fully vaccinated US citizens were welcomed into the UK. Requirements include proof of vaccination and a negative Covid test before departure, a PCR test within the first 2 days of arrival and a passenger locator form. UA flights to London originate in Chicago, Newark, San Francisco and Washington Dulles.

Canada: Our neighbors to the north have opened the border for fully vaccinated US citizens to enter effective August 9th, 2021. UA will begin operating flights into Vancouver, Toronto, Calgary and Montreal at that time. Proof of vaccination is required but there is no quarantine upon arrival. Land crossings will also open August 9th.

Winter warm weather flights: On the home front, UA will serve 150 warm weather locations this winter. Destinations include Cozumel, Belize, Liberia Costa Rica and Nassau as well as US locations of Key West, Fort Myers, Savannah, Charleston, Jacksonville, Las Vegas, Phoenix and San Diego.

Free economy meals to Hawaii: UA flights from Chicago, Newark and Washington Dulles now offer free meals even in economy. Flights returning to the mainland will only include free meals to Denver and Houston.

Pre-order meals: And speaking of meals, the option to pre-order meals, snacks and beverages for purchase can now be made up to 5 days before departure for confirmed passengers who use the United app. Payment is stored online in a digital wallet and is not charged until the meal is actually served onboard. Currently, this option is available on flights from Chicago to San Diego, Orange County and Sacramento but ALL flights over 1500 miles will offer pre-order in early fall.

Trusted Travel Programs: If your TSA Pre✓, Global Passport or Nexus cards are nearing their renewal dates be sure to get online now! If you apply for renewal before your current card expires, you will receive a grace period, up to 18 months, to compensate for the possibility of delays in processing your renewal. I recently applied to renew my card and was informed that my current card would remain valid until Dec 2022. But surprisingly, my new card arrived in the mail within 8 days! Go to www.login.gov to begin the renewal (or 1st time application)

Passport Renewals: Not such good news here – passport renewals are taking 18 weeks to process and mail!

For expedited service, which costs an additional \$60, the passport office quoted 12 weeks. Please be aware that many countries require your passport to be valid for 3 to 6 months beyond your travel dates. So don't wait to get the renewal process started!

Denied Boarding Compensation: We all know that flying standby can often be “iffy”. You may decide to use the myUAdiscount to book a confirmed seat at a 20% discount. Or you may just outright purchase a revenue ticket on Southwest or Delta, etc. Because both kinds of tickets are considered revenue tickets, if an oversell situation occurs you may volunteer to give up your seat for compensation and a confirmed booking on a later flight. Often the compensation amount increases when the number of seats needed is greater. So, if you volunteer first, politely ask that you want the same compensation as that given to the final volunteer. In addition, there are often opportunities to bargain for meal vouchers or lounge access etc., if you just ask.

That's it for this time. Stay safe, everyone.

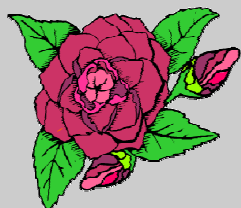

Update on China’s Wandering Elephant ~ Since March 2020, a herd of 15 endangered Asian elephants have become a worldwide media sensation when they left their habitat and trekked 300 miles northward. Emergency workers, vehicles, thermal imaging and drones were deployed to monitor the elephants’ movements and protect local residents. Chinese state television launched a 24-hour live feed of the herd.

Chinese authorities sent police to escort the herd and evacuated roads and villages to facilitate their passage. They used food to distract them from entering densely populated areas during their journey and to follow routes predetermined by officials. In May, “food baiting” began to work and the herd began moving south. In July, an injured baby elephant, who was born on the trek, was rescued after locals spotted the calf alone on a tea plantation. An infected wound on its leg could have been life-threatening without treatment, according to state broadcaster CCTV. Also, a male 10-year-old elephant that strayed from the herd in June was anesthetized and returned to the nature reserve.

As I write this on August 7, China’s now-famous

herd of wandering elephants is approaching their original habitat in the southwestern province of Yunnan after traveling southward for days. I’m glad they are “home” safe and sound, but I sure will miss hearing about them and their antics.

Attention California Drivers ~ On June 21, the Department of Motor Vehicles announced that Californians who renewed driver’s licenses or ID cards during the COVID-19 pandemic are eligible to upgrade to Real ID cards for free. Due to pandemic concerns, the agency allowed all Californians 70 and older, and those who already reached their limit on out-of-office renewals, to renew online or by mail, but an office visit continued to be required to receive a Real ID card. The DMV said it would waive the application fee for those who seek to upgrade through the end of the year.

Since March of last year, DMV officials said they have issued more than 5 million licenses and ID cards that are not Real ID to those who are eligible for one. Cards that are not compliant with Real ID are stamped with the words “Federal Limits Apply.”

“We don’t want Californians to pay the price for not getting a Real ID during the pandemic,” DMV director Steve Gordon said in a statement. *“While the federal government has extended the enforcement date for a Real ID, there is no need to procrastinate.”*

In May 2023, the Department of Homeland Security will require a Real ID card or a passport to board flights within the United States or to enter federal facilities or military bases.

Before the pandemic, the rush to get a Real ID ahead of the previous October 2020 deadline led to long lines at offices and prompted a state audit of the DMV. The agency said it has since streamlined the process, by allowing applicants to upload their documents and schedule in-person appointments online.

Additional information about the Real ID application process can be found on the DMV website.

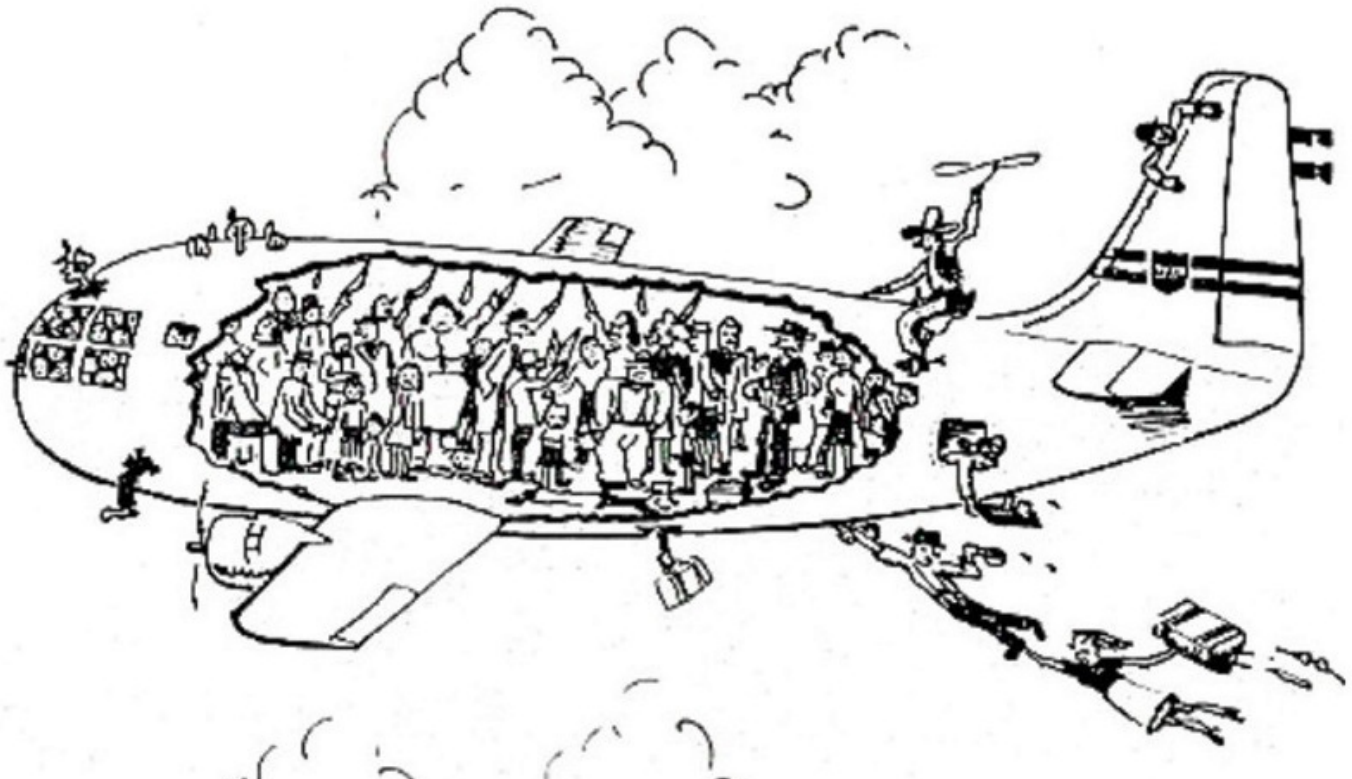
