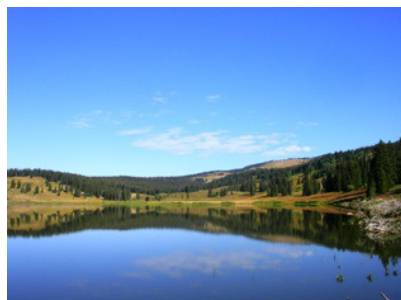

### News From The Flight 93 National Memorial By David Detwiler



There are several items of major news this summer at the memorial. Since I am writing this in mid-June, most of this news will have already happened by the time you read this in the September newsletter.

First, N591UA is coming back to the memorial to be buried near the crash site. Since the Federal Bureau of Investigation completed its on-site investigation of the crash in September of 2001, the wreckage has been stored in a secure warehouse until an appropriate time to return the wreckage to the crash site at Flight 93 National Memorial near Shanksville, PA. It will be buried in a restricted area near the crash site and will not be accessible to the general public or the media.

This is the result of long standing efforts by the families of Flight 93, the National Park Service, and the National Park Foundation.

In September 2015, the National Memorial opened its doors to its Visitor Center and this year will mark the completion of the original design with the dedication of the Tower of Voices, a 93 foot tall structure with 40 wind chimes representing passengers and crew members. Each wind chime will be tuned to a certain pitch which will result in a harmonious sound. I cannot wait to hear this. If you google Tower of voices you can get some idea of what it will look like when finished.

Going back to the wreckage of N591UA, the National Park Service is going to complete a final search of every piece of wreckage to make sure there are no identifiable objects of the crew or passengers. They are going to handle every piece of wreckage which will be no small task because the 757 weighs close to 130,000 pounds and the wreckage is all small pieces as a result of flying into the ground at 563 miles per hour.

Superintendent Stephen Clark said, the National Park Service is honored to be a partner to the Families of Flight 93 and to preserve the memory of the 40 passengers and crew members whose courageous actions on Sept. 11, 2001 thwarted a terrorist attack on our nation's capital.

Speaking for myself, I am starting my third year of volunteering at the memorial and speaking with people from all over the United States and other countries. I get to tell them about the courage of the passengers and crew and the lives they saved as a result of their actions.

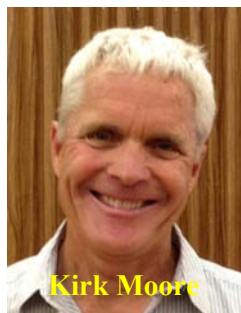
The pledge reaffirms United's commitment to equip-

### **Kirk Moore Pass Travel Update August 2018**

**1) Did you miss crucial information from the ETC?** Some retirees may not have received important messages from the ETC because their email addresses on file are not correct, their mailboxes were "full" or their email security settings did not allow the messages through.

**Make sure the email address you have on file with United is correct!**

There are *two places* to confirm it on Flying Together (check both):

1. Go to [ft.ual.com](http://ft.ual.com) > Travel > employeeRES > Quick Links > Employee Travel Profile > Saved employeeRES information box.
2. Go to [ft.ual.com](http://ft.ual.com) > Employee services > "Health and insurance YBR". Then go to "Your Profile" (in the very top menu) > "Personal Information". Make certain your permanent mailing address and phone number are also correct in YBR since United uses that data to contact you about healthcare benefits.

Ideally your email address should match in both locations above.

Alternatively, you can submit a request through Help Hub (link: [helphub.ual.com](http://helphub.ual.com)) and the Employee Travel Center will add you to their YBR list for email updates.

**If the ETC's messages went into your spam or junk folder,** add "[donotreply.etc@united.com](mailto:donotreply.etc@united.com)" to your address book. That way future emails from the ETC will not be routed to your junk or spam folder.



Even if YOU received the emails from the ETC (in June) about Pass Travel Enrollment for Retirees, please share the above information with other eligible retirees who did not. **2) Lesson learned from EF enrollment** ~ Some retirees could not add a new Enrolled Friend during June enrollment because their travel profile in the Dependent Management System (DMS) had too many **inactive** EF names (max allowed is 4).

Solution: If you have an available empty slot(s) to add an enrolled friend but do not see "Enrolled Friend" in the drop down menu, first remove "**INACTIVE**" EF(s) by clicking the purple "i" button to the left of their name. Then click "Remove Dependent" on the screen that appears below. Now add a new EF to your DMS by clicking the blue "+" sign and follow the 5 steps to "certify" them. Keep in mind, it can take up to 24 hours before their name appears in employeeRES to be eligible for travel – so plan ahead.

Your "DMS" is accessed via [ft.ual.com](http://ft.ual.com) > **Travel** > **Manage pass riders**.

The enrollment period for EFs for the January 1 – June 30, 2019 travel period is open through December 28<sup>th</sup> (until 11:59 p.m. CT). The ETC will remind retirees in December to take action if changes are needed like they did in June.

**3) Travel with Friends on Other Airlines** ~ United retirees enjoy excellent Enrolled Friends privileges but we are not eligible for "buddy passes". However, as **Capt. Pat Palazzolo** of RUPA points out, we can travel space-available with our friends as "Star Companions" on 11 Star Alliance Airlines! Your "friends" can be anyone (your mother-in-law or your yoga instructor or your Enrolled

Friends). To buy tickets for yourself and your friends visit [ft.ual.com](http://ft.ual.com) > **Travel** > **"Other airline interline travel"**, then go to **"myIDtravelPurchase"**. Note: "friends" are referred to as "Travel Partners" on myIDtravel and *you must accompany them on all segments*.

You may also accompany your registered Enrolled Friends on Hawaiian Airlines.

#### **United notched another star as on-time performance trends upward**



Air travel data analytics firm OAG awarded United a coveted 4-star designation for on-time performance in its latest Airport and Airline Star Ratings, a step up from the 3 stars United earned in 2017. United

has now surpassed American (AA) and Southwest (WN), and pulled even with Delta (DL) in OAG's ratings.

OAG's On-Time Performance Stars Ratings are updated twice each year based on the previous 12 months. From June 1, 2017, through May 31, 2018 (the most recent period measured), United operated nearly 1.7 million flights and achieved an 80.7 percent on-time performance, which is defined by OAG as flights arriving within 15 minutes of scheduled arrival time. By comparison, DL recorded an 83.8 percent on-time performance rate while AA and WN finished at 79.4 and 78 percent, respectively.

This upward trend isn't surprising given United's focus on on-time departures and the top-tier D :00 finishes United has achieved throughout 2017 and early 2018. It also serves as further confirmation that employees are making an impact when it comes to getting United's customers to their destinations safely and on time.

#### **PetSafe resumes accepting accompanied pets traveling in cargo**



In July, United reached a major milestone in its re-launch of United's PetSafe program as the company resumed acceptance of certain pets traveling in the cargo compartment, including the pets of military servicemen and women and the pets of other customers traveling on the same flight as their pet parent or guardian.

In March, United began a comprehensive review of its transportation of animals. In May, the company began working with American Humane, the country's first na-

tional humane animal organization, to improve the well-being of all pets that travel with United. The resumption of United's PetSafe program follows the implementation of several new policies and process improvements to enhance the safety of the pet travel experience.

*"On behalf of pet owners around the world who rely on PetSafe to provide safe and comfortable travel for their pets, I want to thank the hundreds of United employees who collaborated on the PetSafe relaunch,"* said Cargo VP Jan Krems. *"Team members from nearly every United department contributed, and everyone shared the same goals: to ensure all animals traveling on our aircraft are treated with special care and attention and to deliver the best possible experience for our customers and their pets."*

The next step in the PetSafe relaunch is the acceptance of reservations for pets traveling unaccompanied, which United expects to begin July 16 for travel on or after July 30. United continues to work with American Humane to review all pet handling policies and processes, including in-cabin pet travel; UAL looks forward to utilizing the expertise to help the company further improve the safety and comfort of the pets that travel. ### **IAD-TLV coming in 2019**



On August 2, United announced a new non-stop flight between IAD and TLV (Tel Aviv, Israel) – the first route to be operated between the two cities by a U.S. airline.

Subject to government approval, the route will launch May 22, 2019, the year that also marks United's 20<sup>th</sup> year of service to Israel.

*"As we begin celebrating 20 years of service in Israel, we want to thank our customers and employees who have helped make United the top U.S. airline serving Israel,"* said International Network VP Patrick Quayle. *"We thank the Israeli government for its ongoing support and partnership. We look forward to continuing to serve Israel with this new service for our customers traveling between the U.S. capital and one of the most advanced science and technology sectors in the world."*

This will be United's fourth nonstop flight to TLV, strengthening its position as the U.S. airline offering the most nonstop service between the U.S. and Israel and offering United's customers convenient connections to nearly 70 destinations throughout the U.S.

Flight 72 will depart IAD at 10:30 p.m. on Wednesdays, Fridays and Sunday, and arrive at TLV at 4:30 p.m. the next day. Returning, Flight 73 will depart TLV at 12:20 a.m. on Tuesdays, Fridays and Sundays, and arrive at IAD at 5:50 a.m. that same day. United will serve the route with a Boeing 777-200ER.

### **U.S. airlines change websites referencing Taiwan**

Earlier this year, the government of the People's Republic of China requested that foreign airlines (as well as other foreign-based businesses operating in China) stop referring to and treating Taiwan as a sovereign nation. This week, United, American and Delta have begun making changes to their digital systems to address China's requirements, as it is United's position to abide by and respect local laws and regulations in the markets and jurisdictions in which United operates and conducts business. United's flights to mainland China, Hong Kong and Taiwan will continue to operate normally.

### **Torgy's Travel Tips – September 2018** **Before, After or Instead of an Alaskan Cruise**

As September approaches, the cruise season to Alaska is winding down and maybe, once again, you just didn't get around to making that trip. Or maybe you've had enough of the cruising scene – tired of the endless onboard push to make you buy, buy, buy while you're supposed to be relaxing. I understand. Well I have 3 suggestions for do-it-yourself style trips, all in British Columbia, Canada. They can be used instead of a cruise, or added on for a pre-or-post trip. Take a look:

**Option 1:** The Sunshine Coast to Princess Louise Inlet. The inlet is really a fjord with steep granite walls topped with thick evergreen trees rising out of clear, calm, deep blue water. There is a 5 hour boat trip that traverses the fjord, culminating at Chatterbox Falls. Going ashore at the Provincial Park offers the opportunity to get up close (and I've even seen some folks go behind the falls) as the water crashes into the fjord. Recently a black bear and her cub were seen on the return portion of the trip. Check out [www.sunshinecoasttours.com](http://www.sunshinecoasttours.com) for lots of pictures of this wonderful area.

To reach this paradise, simply take Hwy 1 (Trans Canada Hwy) from Vancouver to Horseshoe Bay Ferry Terminal in West Vancouver. Take the 40 minute ferry to Langdale, and follow the signs to Egmont. Your drive follows the beautiful coastline and dips in and out of the small picturesque communities of Sechelt, Garden Bay, Ruby Lake and Madeira Park. There are airbnb and small hotels throughout the area. We recently reserved a beautiful home for 2 nights in Madeira Park, right on the water that worked perfectly for us and our friends visiting from Perth, Australia. For ferry info see, [www.bcferrries.com](http://www.bcferrries.com) and note that you can reserve a specific time for CAD \$10 at the time of booking and then pay the actual fare when you board. The fare to the Sunshine Coast (Langdale), is collected only on the outbound journey, the return is free.

**Option 2:** Victoria, BC via ferry. Although Vancouver is the largest city in BC, the province's capital city of Victoria is located on Vancouver Island. Long a stop on the Alaskan cruise route, you can venture here easily on your own time and terms. This beautiful and friendly international port feels like a "wee bit of England". In the spring and summer, the flower baskets adorning the ornate light poles are a riot of color. There are free outdoor concerts near Bastion Square, walking tours of the Parliament Building, the Royal BC Museum, High Tea at the Grande dame Empress Hotel, and on Sundays, the tiny taxi boats perform a "ballet" in the Inner Harbour! And no visit to Victoria is complete without a trip to Butchart Gardens. I counted 9 different languages being spoken around me in the first 10 minutes of my most recent visit. The gardens are open all year and the foliage and blossoms differ with each season. On Saturday evenings in July and August, stay for the Fireworks Show, watched from the Fireworks Lawn. It is a ground and aerial display of unique fireworks sure to have you ooh-ing and awe-ing! For more info, see [www.butchartgardens.com](http://www.butchartgardens.com)

To reach Victoria by ferry, first determine from where you want to originate. From Vancouver, BC Ferries operates between Tsawwassen (a short drive south of the Vancouver airport) and Swartz Bay located 20 miles north of Victoria. The 1 hour 35 minute crossing weaves between several of the Gulf Islands, sometimes coming so close to the islands you can almost hold a conversation with the residents! Again, I would recommend booking a reservation in advance if you travel during the summer or around holiday periods.

From Seattle, the Victoria Clipper catamaran from Pier 69 offers a fast 3 hour cruise directly to Victoria's Inner Harbour. This is strictly a passenger only vessel, which is really no problem as everything is reachable by foot, bus or Uber once you're in Victoria. See [www.clippervacations.com](http://www.clippervacations.com) for more info.

If you want to take your own car from Seattle, choose either the Coho Ferry from Port Angeles, [www.cohoferry.com](http://www.cohoferry.com), or take a Washington state ferry [www.wsdot.com/ferry](http://www.wsdot.com/ferry) from Anacortes. Washington State operates the largest ferry system in the US and the Anacortes-Sidney, BC route is beautiful and extremely popular. The ferry sails through the stunning San Juan Islands and docks at Sidney, BC, a 17 mile drive north of Victoria. The Coho, operated by Blackball Lines is a 90 minute voyage crossing the Salish Sea (Strait of Juan de Fuca) from Port Angeles and docks right in front of the Empress Hotel in the Inner Harbour. Both of these vessels sail through areas often populated with Orca whales. We saw 3 on our last trip in June.

**Option 3:** If you'd really rather skip the whole luxury cruise ship idea, you can still experience the beauty of the Inside Passage by taking BC Ferries from Port Hardy on the northern tip of Vancouver Island to Prince Rupert. During the spring and summer there is one daytime crossing offered every other day and the trip takes 15 hours. The voyage includes stops in the First Nations villages of

Bella Bella and/or Bella Coola on its way through the Queen Charlotte Strait. (In the off-season, the voyage is at night and takes 18 hours.) Needless to say, the daytime departure is coveted and reservations are a must. You can reserve a cabin or just relax in the common areas. You cross the same area as the big cruise ships, but on a much more intimate scale. Once you arrive in Prince Rupert you can connect with another ferry to Haida Gwaii (previously known as Queen Charlotte Island), the home of the Haida Nation who have lived on this archipelago for 13,000 years. The island is known for its abundance of wildlife, especially the largest subspecies of black bear and there is a prominent National Park Preserve and Haida Heritage site on the southern part of the island.

You can drive east from Prince Rupert to Prince George on Hwy 16 and then choose to either continue on Hwy 16 to Jasper, Banff and Lake Louise or turn south on Hwy 97 heading towards Harrison Hot Springs, Chilliwack and eventually Vancouver.

Whichever option you choose, you will not be disappointed. Like the saying goes, "*The world is a book. Those who do not travel only read one page.*"

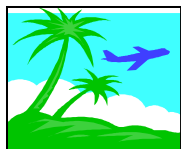

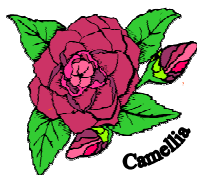

Thanks to **Bob Donovan** for making up name tags for our new comers, the **Woods** and **Coopers**.

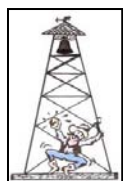
