United States Airmail Service

Although it was a very short flight, the first US Airmail flight took place on September 25, 1911. Flown by aviation pioneer Earle Ovington, flying from Garden City Estates, NY and dropping a mailbag from his plane in Mineola, NY. After more experimental flights were made throughout the next six years, congress came to realize that airmail delivery was feasible and approved funding.

Beginning on May 15, 1918 limited airmail service began, using six Army Air Corps Curtiss Jenny planes and Army

pilots. However, less than six months later the Post Office extended contracts for civilian pilots, to fly specially built mail planes. During the next few years, this service

primarily was provided for the East Coast. People were not too interested in this service with its additional cost for the little saving over ground delivery times; still the delivery time only improved by just 22 hours over train service only.

In hope this would be more of an interest for citizens to use the service; discussions began to make airmail delivery possible clear across the United States. In 1920, utilizing a system of landing strips from New York to San Francisco, cross country flights began. These flights were limited to daylight only, so planes were off loaded to trains for night transport from one landing field to another.

With no navigation aids, early airmail pilots used landmarks to find their way. Flying long distances, in aircraft that could fail at any time was a challenge, particularly when encountering inclement weather. Still it was necessary to find a way to get the mail de-





livered more quickly. The idea of night flying was the only way to ensure faster delivery than the train. In 1921, four planes, two from San Francisco and two from New York were to fly round the clock. Two planes were halted by storms, one crashed killing the pilot, but one succeeded making the trip in just over 33 hours.

As a result of the test flights, it was proven that mail service round the clock could be possible. However a process needed to be developed to ensure the safety of the pilots. In 1923, the Post Office set about improving the instruments on its planes and installing navigation lighting. To help pilots to find their way at night, a system of lighted airways was to be built spanning the entire country.

During the next six years a series of 1,500 light towers one every 10 miles were constructed from New York to San Francisco. They consisted of a 70 foot long concrete dual pointed arrow painted bright Yellow. Over the center of the arrow a 51 foot tower was constructed with a million power rotating light. At each end of the arrow, were two beacons, which would flash in Morse code a unique locator ID for that tower. A small shed was constructed to house an acetylene gas powered lights in the early days, or generator, where electrical power was not available. On top of the shed was the location ID which was used during the daylight hours. Emergency landing sites were also constructed along the route.

The entire system was supported by personnel. Pilots could fly these routes, from 184 to 486 miles each and make fifteen stops for service and mail across country, making the entire trip in 30 hours. Beginning in 1933, with the improvement in low range radio frequency transmission, the towers began to become obsolete. The majority would ceased operation during the 1940's, with the last one shut down in 1973. If you are interested, a few towers and many more concrete arrows can still be seen today, a number of websites list their locations.

Beginning in 1926, the post office began contracting out airmail delivery. The experienced pilots used by the post office were quickly hired by a vast number of airlines, eager enter into lucrative contracts with the government. Many new airlines were created as a result of privatizing of airmail delivery. All together there were 34 Contract Air Mail (CAM) routes established. The first contract issued was to Varney airlines, predecessor of United Airlines on April 5, 1926 and flown by Leon Cuddeback using a Swallow biplane aircraft. Passenger service around this era was just beginning, so flying mail helped airlines grow and is said to be responsible for the future of airlines in general.

Despite the profits being made flying airmail, airlines began to take advantage. Since they were paid by

the weight they transported, some airlines insisted on having pad-locks on each bag, others were discovered stuffing the bags with 'junk mail', or flying freight as mail. President Hoover in 1930 gave postmaster Brown extraordinary power to fix the system. The program instituted by postmaster Brown, was to simplify the contract process and approved only three airlines to fly airmail for the post office. From the onset, the decision was considered very controversial by the media.

With a new president, Franklin Roosevelt, being elected in 1933, he quickly set up an investigation to look into how the airmail contracts had been established and maintained. The investigation confirmed that process of selecting only three airlines to fly the mail, brought to question the legality and ethics. Just days after a series of hearings concluded that the process must be changed, Roosevelt, canceled all airmail contracts. The Army was given the task to provide airmail service. However, the Army was not equipped for such a task. Pilots had less than 2 years flying experienced, insufficient maintenance personnel positioned across the US and lack of operational supplies, among other issues. After a number of pilot deaths, the Army was forced to reduce the number of routes flown, as well as flying at night. Problems continued and pilot deaths climbed. Roosevelt was faced with public furor and was being forced to make further changes.

At the insistence of Roosevelt, the Air Mail Act was passed by congress in 1934. This returned airmail delivery to the public sector, based on bids. One of the provisions of the act was that no former airlines could be part of the bidding, as well as holding companies. Thus United Airlines, among others, became an independent entity, separated from aircraft manufacture (Boeing), aircraft engines (Pratt & Whitney), for the sole purpose to legally bid and be awarded airmail contracts. As a result, airmail was just another source of income for the airlines, who now focused on increasing passenger numbers. This created the need for new aircraft and passenger improvements.

The first airmail flight carried 9,285 pieces of mail over a route of 525 miles. Today the post office handles over 706 million pieces of mail daily, relying on aircraft for quick and efficient transport of a majority of mail it handles, on routes of thousands of miles.■



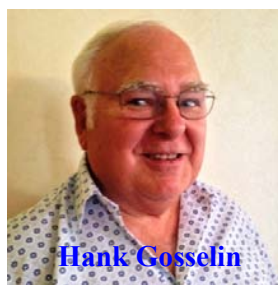

In the March 2023 issue of the Newsletter, UAHF section, we incorrectly reported that the collection of UAL historical items currently in Denver will be transferred to the United Legacy Foundation in Chicago. We apologize for the error and any inconveniences it caused, following is the clarification:

As mentioned in the March newsletter, the bulk of the UAHF Archive items in the "A" basement at the Denver Flight Training Center (DFTC) were temporarily relocated to a remote storage facility nearby as a result of space that is needed for increased training activity. The exceptions to this are the items that were placed in a permanent display at DFTC.

The UAHF Board of Directors is in discussions with the newly formed United Airlines Legacy Foundation and United Airlines, Inc. to acquire the items in storage for transport to Chicago for permanent retention. We will continue to keep you updated on the status.

Air Canada and United Airlines to Offer More than 260 Daily Transborder Flights and Two New Routes this Summer February 23, 2023



Air Canada and United Airlines announced today that, through their enhanced transborder joint business agreement, they will offer industry leading capacity and new routes between Canada and the U.S. for summer 2023 – including a new United-operated flight between Washington-Dulles and Calgary and a new Air Canada-operated flight between Washington-Dulles and Vancouver. The carriers have collaboratively optimized their schedules, subject to applicable government and regulatory conditions, and added more flights to provide customers greater connectivity and more flexible flight times, with over 80 transborder codeshare routes and more than 260 daily flights.

"Through our longstanding partnership with United Airlines, Air Canada has been able to offer customers ever-increasing and significant benefits. This summer, customers will have even greater choice and convenience with our joint summer schedule made possible by our airlines' new enhanced transborder agreement. Together we will offer more than 260 daily departures to the U.S, and new non-stop flights from Vancouver and Calgary to Washington-Dulles," said Mark Galardo, Senior Vice President Network Planning and Revenue Management at Air Canada. "Our coordinated schedules will provide business travelers with the convenience of hourly service and the additional comfort of a business cabin on all flights between Toronto and New York and Chicago, as well as Vancouver and San Francisco."

"We're proud of our continued work with Air Canada to provide customers with even greater transborder connectivity, including adding more flights and new direct service to Calgary and Vancouver from Washington Dulles," said Patrick Quayle, Senior Vice President of Global Network Planning and Alliances at United Airlines. "With schedules designed to give customers more flexibility with timing and more convenient connection options, as well as the ability to enjoy the benefits of both airlines' loyalty programs, our agreement with Air Canada makes United the premier U.S. airline for travel to Canada."

New Non-stop Flights Between Vancouver, Calgary and Washington ~ New, non-stop service between Vancouver and Washington-Dulles will begin June 1 and will be operated with an Air Canada Boeing 737 Max 8. United will also introduce a new, non-stop flight between Calgary and Washington-Dulles on June 2 on an Airbus 319. Air Canada and United will codeshare on these flights, allowing Aeroplan or MileagePlus® members to accumulate and redeem miles. Eligible customers and loyalty plan members will also be able to enjoy benefits including priority check-in, lounge access, priority boarding and other benefits where available.

Transborder Schedule ~ The two carriers will operate more than 260 daily transborder departures in summer 2023, about a 20 percent increase in schedule capacity compared to summer 2022. The schedule will include up to 120 daily departures between the airlines' hub markets, an increase from 101 in summer 2021. Flights will be timed to offer optimized connections at both Air Canada and United's hubs and line stations.

Shuttle-Style Schedule ~ The coordinated schedule will enable both carriers to offer shuttle-style hourly service throughout the day between key Air Canada and United hubs. The airlines will offer 29 daily flights with complementary timings between Toronto and New York/Newark and Chicago, and 11 daily flights between Vancouver and San Francisco.

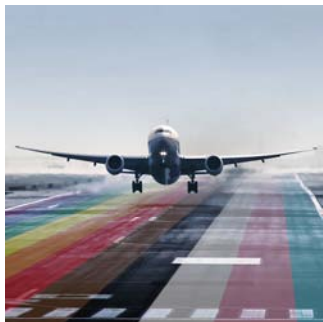
Enhanced Western Canada Network to the U.S. ~ The airlines' summer schedule also provides increased transborder service between the U.S. and Western Canada. There will be nine daily flights between Vancouver and New York/Newark, Houston and Chicago, and seven flights daily between Los Angeles and Vancouver. A second daily flight will be added between Calgary and both Chicago and Houston, and a second daily flight will also be added from Edmonton to Denver.

Customer Experience ~ Air Canada and United will offer business class seats on every flight between their respective hubs. All eligible customers will be able to enjoy Air Canada's Maple Leaf Lounges and United's lounges, as well as the benefits of the carriers' Aeroplan and MileagePlus® loyalty programs. Additionally, customers will have a wider range of flight options with more than 80 transborder codeshare routes. Overall, customers will be able to connect to over 100 codeshare destinations in the U.S. and 25 of the most popular cities in Canada.

Building on a Long-Standing Partnership ~ In July 2022, Air Canada and United announced a joint business agreement for the Canada-U.S. transborder market, building on their long-standing partnership that will give more flight options and better flight schedules to customers traveling between the two countries (coordination subject to regulatory conditions). Air Canada and United are also founding members of Star Alliance and a transatlantic joint business agreement with the Lufthansa Group.

In 2019, the U.S.-Canada transborder market was the second largest international passenger air transportation market in the world and the largest international market for both Canada and the U.S., as measured by seats.

**United and Virgin Australia to Celebrate
LGBTQ+ Pride on Flight
from San Francisco to Sydney
February 22, 2023**



United Airlines is partnering with Virgin Australia to connect U.S. travelers to the world's largest celebration of Pride in Sydney with a special flight staffed entirely by members and allies of the LGBTQ+ community. Departing on Wednesday, February 22 from San Francisco International Airport, the festivities will kick off with a celebration at the gate, continue with giveaways and activities onboard the flight and culminate with a welcome party upon arrival in Sydney. While Virgin Aus-

tralia has offered special domestic flights in Australia for Pride since 2021, this is the first time United is joining this effort. Additionally, United made a \$25,000 donation to the Trevor Project to support their mission of helping LGBTQ young people.

**United Rallies Businesses and Consumers
with New, First-of-its-Kind
\$100+ Million Sustainable Flight Fund
February 21, 2023**



In an effort to rally businesses and consumers, United today launched the United Airlines Ventures Sustainable Flight Fund, a first-of-its-kind investment vehicle designed to support start-ups focused on decarbonizing air travel by accelerating the research, production and technologies associated with sustainable aviation fuel (SAF).

The fund starts with more than \$100 million in investments from United and its inaugural partners** Air Canada, Boeing, GE Aerospace, JPMorgan Chase, and Honeywell. Through the fund, these and potentially additional corporate participants will invest alongside United in SAF technology and production start-ups identified by United. In the past two years alone, United Airlines Ventures has invested in start-ups such as Cemvita, Dimensional Energy, and NEXT Renewable Fuels.

And in a first among U.S. airlines, anyone who buys a ticket on the United website or app now has the option to contribute to supplement United's investment in the fund. The first 10,000 people who choose to contribute will each receive 500 MileagePlus Miles as a thank-you.

SAF is an alternative to conventional jet fuel that, on a lifecycle basis, reduces greenhouse gas (GHG) emissions associated with air travel compared to conventional jet fuel alone. SAF, which currently must be blended with conventional jet fuel to meet regulatory requirements for use within the aircraft, is being made from used cooking oil and agricultural waste, and, in the future, could be made from other feedstocks including household trash or forest waste. To date, United has invested in the future production of over three billion

gallons of SAF - the most of any airline in the world.

"Solving climate change is doable but it requires hard work and real leadership," said United CEO Scott Kirby. "This fund is unique. It's not about offsets or things that are just greenwashing. Instead, we're creating a system that drives investment to build a new industry around sustainable aviation fuel, essentially from scratch. That's the only way we can actually decarbonize aviation."

UAV Sustainable Flight Fund ~ The UAV Sustainable Flight Fund is open to investment by corporations across industries and the fund will prioritize investment in new technology, advanced fuel sources and proven producers, all in an effort to scale the supply of SAF. Partners of the fund also have the potential to gain preferential access to environmental attributes associated with United's supply of SAF. Companies interested in joining the fund can visit united.com/ventures.

United has already made investments in or signed purchase agreements with companies using a variety of ingredients and technologies to produce SAF, including feedstocks like ethanol, animal byproducts, forestry and crop waste, and municipal waste, as well as early-stage, promising technologies like synthetic biology and power to liquids. United Airlines Ventures will move selected existing SAF investments to establish the UAV Sustainable Flight Fund portfolio.

Consumer Awareness and Call to Action ~ United is also educating consumers about their air travel carbon footprint and giving them the option to take action.

Starting today on United.com and the United app, United becomes the first U.S. airline to show customers an estimate of each flight's carbon footprint in their search. Green shading will indicate a lower-carbon option on a per economy seat passenger basis in a customer's chosen itinerary. A flight's carbon footprint is measured in kg CO₂e (kilograms of carbon dioxide equivalent) and United's estimates, which could differ from actual flight emissions, are based on aircraft type, flying time, seat capacity and the number of people and cargo on a given flight.

And consumers who book travel through United for travel within or from the U.S. will now see an option to contribute to supplement United's investment in the UAV Sustainable Flight Fund before check-out. Customers have the choice to contribute \$1, \$3.50 or \$7.00.

The default option for customer contributions is set at \$3.50 to illustrate the potential impact of customer action at scale: If the 152 million people who flew on United in 2022 each contributed just \$3.50 to the UAV Sustainable Flight Fund, that would be enough to design and build a SAF refinery capable of producing as much as 40 million gallons of alternative fuel annually.

The Federal Government Recognizes the Value of SAF ~ The 2022 Inflation Reduction Act includes the

largest governmental climate change investments in U.S. history - a new blender's tax credit specifically for SAF along with other critical incentives for clean energy and carbon capture – that will help spur an increase in SAF infrastructure and supply while lowering costs for SAF consumers.

The U.S. military currently uses nearly five billion gallons of jet fuel annually and the Department of Defense will use a jet fuel blend containing at least 10% SAF by 2028 because of the 2023 National Defense Authorization Act.

And according to the U.S. Department of Energy, the country's vast feedstock resources are enough to meet the projected SAF demand of the entire U.S. aviation industry.

United's Commitment to Net Zero Emissions by 2050 ~ United aims to be 100% green by reducing its GHG emissions 100% by 2050, without relying on traditional carbon offsets. In addition to the UAV Sustainable Flight Fund, United has launched a SAF purchasing program called the Eco-Skies Alliance and established a venture fund – United Airlines Ventures - to identify and invest in companies and technologies that can decarbonize air travel. These strategic investments include carbon capture, hydrogen-electric engines, electric regional aircraft, and air taxis.

United Makes It Easier for Families to Sit Together **February 20, 2023**



United today announced an improved family seating policy that makes it easier than ever for children under 12-years old to sit next to an adult in their party for free - including customers who purchase Basic Economy tickets.

United's new policy is made possible through a series of investments in a new seat map feature that dynamically finds available adjacent seats at the time of booking. The online seat engine first reviews all available free Economy seats and then opens complimentary upgrades to available Preferred Seats, if needed.

Customers traveling with children under 12 will start to see more adjacent seat options immediately and the complete policy change will go into effect in early March. In instances when adjacent seats are not available prior to travel - due to things like last minute bookings, full flights or unscheduled aircraft changes – United's new policy also lets customers switch for free to a flight to the same destination with adjacent seat availability in the same cabin. Customers also won't be charged if there is a difference in fare price between the original and new flight.

"In an era where more families are working in a hybrid environment, they're traveling more often – and they're flying United," said Linda Jojo, Chief Customer Officer for United. "We're focused on delivering a great experience for our younger passengers and their parents and know it often starts with the right seat. We look forward to rolling out more family-friendly features this year."

Many airlines try and use a more manual process to seat families together that can include blocking random seats or asking agents to facilitate seat swaps at the gate. Those circumstances often result in more stress and a longer boarding process for everyone.

Today's announcement reflects the investments United has made in its technology and tools. Since last summer, the airline has worked to improve its ability to seat families together more easily by optimizing the airline's seat engine to prioritize families who did not have seats assigned before their day of travel and prioritize adjacent seating for families during schedule changes, aircraft swaps or irregular operations.

United Polaris®, United First Class® and Economy Plus® seats remain separate products and are excluded from this family seating policy change.

Corn Spoonbread:

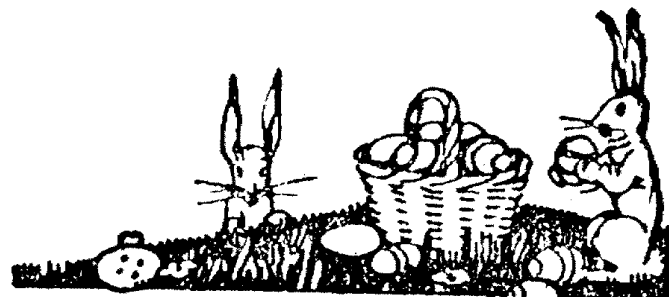
1 (8½ ounce) package corn muffin mix. I use Jiffy

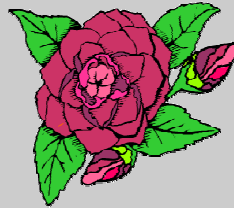

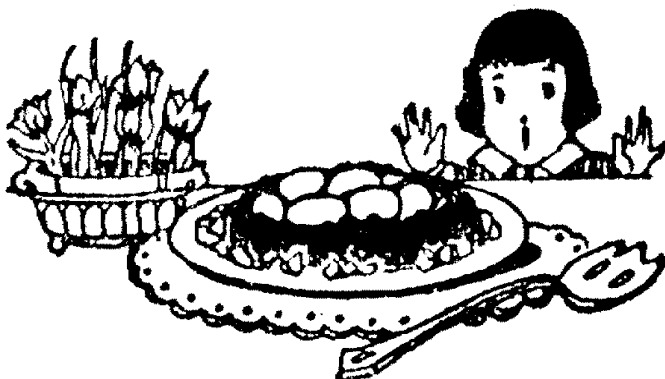



Happy Easter to everyone from the East Bay Diablos group! As I write this on March 7, the San Francisco Bay Area is awaiting another atmospheric river but it should be nothing like the series of storms we had in January. In Southern California, people living in the San Bernardino Mountains have been snowed in and trapped in their homes for about a week. Fire crews are going door to door to rescue people, but in the most remote areas, some residents may not be rescued for another week. Wow!

Our group holds in person monthly meetings on the first Monday of the month all year long. The restaurants are still dealing with staff shortages, so we have to give them a count beforehand for our meetings. If you are going to attend our meetings, you must RSVP prior to the meeting. Sue & Ed VonEmster and Poldi vonMuhlfeld**. **Russ Kennedy** conducted the raffle and **Rich Bouska** won the money. We only had one bottle of wine in the raffle which was won by **Jan Soderstrom**. In honor of St. Patrick's Day, green was the color theme of the day.

None of the people sitting near me at lunch had redeemed their Alliant Visa Rewards Program points, so I suspect a lot of you out in RUAEA Land haven't either. I really encourage everyone to check the bottom of your Alliant Visa statement for both the number of points and their expiration date. For every dollar you charge, you get one reward point, and at times there are also double points for certain stores. You then redeem your points and get 1% back in cash, merchandise, event tickets, gift cards or travel. It is very simple to redeem your points online. Follow the instructions at the bottom of your Visa statement to get into your Rewards account. You can redeem all of your points at one time or a partial amount. For a cash reward, you have it deposited to either an Alliant checking or savings account.

Another owl story ~ Many of you will remember the heartwarming saga of Rocky, the tiny Saw-whet Owl that was discovered by workers setting up the 75-foot Norway Spruce in Rockefeller Center in November 2020. She most likely hitched a ride from upstate New York but she could also have flown into the tree during its 170-mile ride from Oneonta to New York City. Saw-whet owls are tiny, about the size of a robin. As such they are prey to larger birds like Great Horned Owls, Barred Owls, and diurnal raptors like Northern Goshawks, so they spend the bulk of their day in cavities or dense vegetation for safety. Rocky might have been hiding all the way from Oneonta or ended up in the tree during transportation and stayed in place as if there were predators around. When rescued, she hadn't had food or water for several days. She was cared for at a rehabilitation facility for a few days and then successfully released back into the wild from upstate New York.

Now another owl has captured the hearts of New

Yorkers. On February 2nd, zookeepers at the Central Park Zoo discovered that vandals had cut the stainless steel mesh on the enclosure for Flaco, a Eurasian eagle-owl, one of the larger owl species with a wingspan of up to 79 inches. The bird's name in Spanish means "skinny," and it seemed he was in danger of living up to his name in the early days of his escape because he hadn't been seen eating. For two weeks, Flaco flew from treetop to treetop, eluding capture and amassing legions of fans worried about his ability to survive alone in the big city. With a collective sigh of relief, the answer was a resounding no: It appears Flaco has regained his killer instincts and is becoming an old hand at swooping down from his lofty perch to feed on the park's bounty of rats. Recovering Flaco has proven difficult, especially since he has been very successful at hunting. One bird-watcher quipped that Flaco's name should now be changed to Gordo, which means fat in Spanish. Most recently, zoo officials tried to lure Flaco with bait and recordings of eagle-owl calls. He showed some interest but didn't fall for the ruse. Flaco has made his rounds of upper Manhattan but hasn't strayed too far from the park. He flew to the nearby shopping hub of Fifth Avenue, where police officers tried to catch him and failed. He captivated audiences wherever he went, including a visit to Central Park's skating rink. Twitter has been aflutter with sightings, and the hashtag #freeflaco, as well as an online petition to keep him free, soon took flight. As a result, zoo officials announced that they were suspending recovery operations, at least for now, but will keep a close eye on the owl's health. The main concern is that Flaco might consume rodents that have been poisoned. *"We are going to continue monitoring Flaco and his activities and to be prepared to resume recovery efforts if he shows any sign of difficulty or distress."* Source: AP, February 18, 2023.

Notre Dame Cathedral Restoration update ~ On April 15, 2019, the world watched in horror as this famous landmark was heavily devastated by fire. At the time, French president Emanuel Macron vowed to have restoration completed in time for the 2024 Summer Olympics in Paris. That goal was always ambitious, and became even more so after pandemic lockdown restrictions meant work ground to a halt for much of 2020. It took two years just to stabilize and reinforce the structure—which was at risk of collapse—before reconstruction could begin in earnest. The cathedral's iconic spire collapsed in the blaze, and has been a major focus of the reconstruction. The plan is to rebuild the cathedral identically, including the spire. Architect Philippe Villeneuve is supervising the reconstruction. *"The return of the spire in Paris' sky will in my opinion be the symbol that we are winning the battle of Notre Dame,"* stated General Jean-Louis Georgelin, the army general in charge of the restoration project.

The reopening of the cathedral itself, with the reconstructed spire, has now been delayed to December 2024 and some work will continue into 2025. A team of 1,000 people are currently at work on the cathedral, using period-appropriate materials and techniques to faithfully rebuild the structure. That includes a stone vaulted ceiling—not modern-day concrete—and the wooden timbers of "The Forest," as the attic is known, which is being reconstructed from 1000 150-year-old trees.

In the interim, visitors to Notre Dame still have things to see. Notre Dame's parvis — the public square outside the cathedral — has been open to visitors since May 2020, as well as the cathedral's crypt. The footbridge was reopened to pedestrians and cyclists in September 2022. And on March 6, a free exhibition called "Notre-Dame de Paris: At the heart of the construction site" opened to visitors. The exhibition is staged in an underground space in the forecourt of the cathedral. A display of charred roof timbers and lead ornaments melted by the intense heat of the blaze illustrate the devastating effects of the fire. The rest of the show gives viewers a glimpse into the ongoing work to reopen the cathedral and celebrates the expertise and skills of the workers. Stained glass windows and other artworks from the cathedral are on view alongside a scale model of Notre Dame, as well as part of the church's massive pipe organ. The instrument needed to be disassembled and cleaned; putting the 8,000 pipes back together is expected to take a full year. The reconstruction of the gothic cathedral will largely return it to how it once looked, but the grounds are getting a more drastic makeover. Last year, landscape architect Bureau Bas Smets was selected to redevelop the cathedral's surroundings with an enlarged square behind the cathedral, a new park, an underground walkway, a welcome center, and an archaeological museum. Jan Soderstrom is collecting coupons for the charity Support our Troops. This is a service project of her Daughters of the American Revolution (DAR) chapter. According to Feeding America, an estimated 160,000 military families experienced difficulty putting food on the table in 2020. Troops in junior enlisted ranks are especially vulnerable to food insecurity — almost 30% need help.

I would like to ask all of you to cut out coupons and mail them to me at 30 San Piedras Place, San Ramon, CA 94583-3018. This is such an easy thing to do to support our troops. For the price of a first class stamp, you can get about 90 coupons in an envelope. The coupons have to say “Manufacturer’s Coupon”. If they come in a strip, could you please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. In my area, the coupons come in Tuesday’s mail along with the supermarket ads, and then in the Sunday paper. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated. I get so excited when I get a coupon for eggs! I am so grateful for the kindness of all the RUAEA members who are helping me with this project. On March 6th, I turned in 1847 coupons to my coupon chairperson. This is due to members in my local chapter as well as members all over the country. Thank you all!



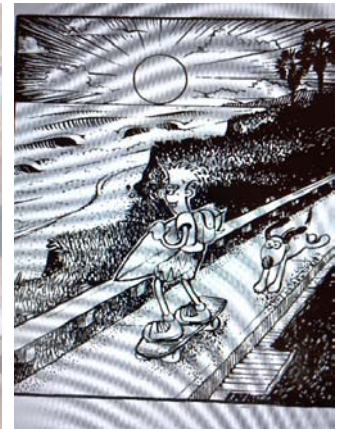


Time is flying along; we have had unusually cold weather and there is a strong tendency to stay in, be warm and read good books.

Since our chapter won't be meeting until March 29th, here is another quick stroll down memory lane:

One day when I came into work, my chief said we have a DC-6 down in Bradley field Connecticut. He told me and my partner to get some parts, take the pickup truck and head up there right away to fix it.

It took us a couple hours but we finally got there and found the plane. We checked the log book to see what the complaint was, we put a brand-new set of spark plugs in and change the distributor, we ran it, and it ran like a top.

We called both Newark and San Francisco line maintenance to let them know that the plane was back in service. Just as we were packing up and about to leave, a Navy A4 D plane comes alongside of us. As a single engine piston plane, but it is a big engine. Frankly I don't know what they use it for. Anyway the pilot gets out and sees us and asks us for some help. Of course we asked what happened, and he said I lost all my hydraulic fluid and now I'm on emergency air for my brakes.

Normally we don't perform any maintenance without being authorized, however, after we agreed, he did show us how the cowling came off on the side of the engine. When we opened it, the whole inside was covered with hydraulic fluid. Sure enough, I saw what the trouble was; it was a broken rubber hose from his hydraulic pump, and easy fix.


However, we still have to clean out that whole accessory compartment. We went up to the base supply where we found a kerosene pump and a rubber hose, and we fixed everything up for him. However, I told him that he has to get refilled with hydraulic fluid.

One thing that they taught me at an aviation school, the Navy uses a blue fluid, and everybody else uses red, and under no conditions do you ever mix them up. You will destroy the system. So I told him to call Pawtuxit, his base in Rhode Island, and tell them to bring the proper fluid.

I told him to get his guys to fill the system, and then run the engine and exercise all the controls, and he would be good to go. He thanked me and my partner and then asked if there is anything he should sign for

charges. I said are you Navy or Marines, he said Marines, I said in that case, all our labor was on the house. We wished him well and left, when I got back I told my chief the whole story and he said, "you did good Ollie".

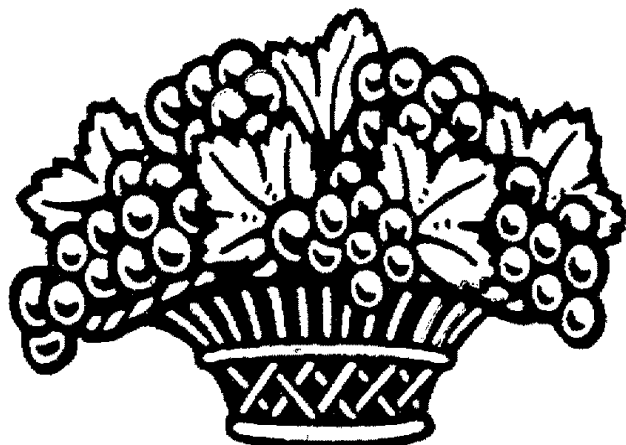

The Acorn Days

Amazing History of US Aviation - Part 1

Decades before “geeks” and “nerds” altered the world; young pioneers changed the world not with “brick and mortar” but with wood, bailing wire, canvas, and later aluminum. ~ Ray Lahr

How many of you know that in 1910 the mighty **Martin Marietta Company** got its start in an abandoned Church in Santa Ana, CA? That's where the late **Glenn L. Martin** with his mother Minta Martin, and a mechanic named Roy Beal, built a fragile contraption with which Glenn taught himself to fly. It has often been told how the **Douglas Company** started operations in 1920 by renting the rear of a Barbershop on Pico Boulevard in Los Angeles. The Barbershop is still there. **The Lockheed Company** built its first Vega in 1927 in what is now the Victory Cleaners and Dryers at 1040 Sycamore Avenue in Hollywood.

Claude Ryan, who at 24, held a reserve commission as a flyer, had his hair cut in San Diego one day in 1922. The barber told him how the town aviator was in jail for smuggling Chinese across the border. Claude investigated and stayed on in San Diego to rent the Old Airfield from the city at fifty dollars a month and replace the guy in the “pokey”. He agreed to fly North instead of South.

In 1928, the **Curtiss Aeroplane and Motor Company**, **Transcontinental Air Transport (now TWA)** and **the Douglas Company** chipped in enough money to start **North American Aviation**, a holding company. The present company bearing the **Northrop** name came into being in a Small Hotel in Hawthorne. The Hotel was conveniently vacant and available because the police had raided it and found that steady residents were a “passel of money-minded gals” who entertained transitory male guests.

After **Glenn Martin** built his airplane in the Church, he moved to a vacant Apricot Cannery in Santa Ana and built two more. In 1912, he moved to 9th and Los Angeles Streets in downtown Los Angeles. **Glenn Martin** was then running a Three-Ring-Circus. Foremost, he was a Showman who traveled the circuit of County Fairs and Air Meets as an Exhibitionist Aviator; secondly, he was an Airplane Manufacturer. He met his payroll and bought his lumber, linen and bailing wire from the proceeds of his Precision Exhibition Flying. - (To be continued next month).■
