#### <u>Torgy's Travel Tips-May 2020</u> <u>Travel During The Coronavirus Pandemic</u>




Ithough this newsletter is destined for release in May 2020, I am writing this in late March, cocooned at home. I hope the majority of you are as well. We here in the Seattle area have been keenly attuned to the situation since late February when the first US cases appeared in a rehab facility only 11 miles from downtown. How incredulous it is seeing my friend on the March 30 cover of Time magazine because she was at that facility only for a short post-surgical rehab opportunity and now cannot leave because the virus spread to her room. And this all happened before we flipped the calendar to March. Our health care providers are counting on us to do so or they won't be able to keep up with this pandemic.

I was mulling over all these thoughts (again) as I prepared breakfast this morning. As I reached into the drawer for a spatula, I picked up the small wire whip with the Delft porcelain handle and recalled where I bought that in Holland. The spoon holder on the stove, purchased in Lisbon over 20 years ago, still clearly shows the name of the artist who painted it. The cuckoo clock suddenly announced the hour, another reminder of happy times in Switzerland. Just then, my husband came around the corner holding his prized backscratcher/shoe horn I lovingly bought him in Poland, last year. Every time he uses it, he thanks me!

How about you? What memorable items pop into mind from all of your travels over the years? Do you still have a matchbook from that little restaurant in Paris you ducked into during the rainstorm? How about that gaudy sombrero you actually dragged home from Mexico? Or maybe those 15 collector spoons hanging on a dusty display rack or tucked into a silverware chest? All of these tell a story – a story that only you can tell. Think of all funny little things that have happened on some of your trips. Even the worst trips make good stories!

Exactly 30 years ago, we drove from Budapest to Vienna. There were still ox-drawn carts on the smaller roads in those days and hotels were few and far between, except in large cities. After searching for quite some time, we



finally found a sign for a small hotel. I spoke to the desk clerk (in German, the only common language between us) only to learn that the last rooms had just been taken. Sensing my fatigue and predicament, the young lady discreetly told me that her friend's mother had room in her home in a nearby village that she sometimes let people stay in. After a quick phone call, the young lady drew me a map and off we drove. By now, it was dark. The village had only 1 light pole and the shutters were closed on the few houses. headlights finally illuminated the white apron of a matronly figure waving to us from the middle of the road. We slowly ap-

proached and she opened a pair of massive wooden gates, revealing a large courtyard where she motioned us to park and promptly locked the gates behind us. Speaking to us in Hungarian and using charade-style gestures, we were taken up a dimly lit interior concrete stairway to the 2<sup>nd</sup> floor, which revealed a narrow hallway with 5 closed doors. We were shown a bathroom containing a small chipped sink, a toilet with 2 pieces of wood as a makeshift seat and a freestanding tub with a handheld shower hose. We smiled and nodded at our hostess who then took us to our room at the other end of the hall. The room was Spartan, but clean. Through a toothless grin, she smiled, rubbed her tummy while pointing at her watch, indicating that breakfast would be at 8AM. Now my husband was very uneasy about the whole situation, beginning with those large wooden gates locking us in. We really didn't know where we were or who were with. His protective mode kicked in right away when the lock on the room door didn't work. So he slid a chest of drawers across the room to block the door. Finally, we fell asleep in exhaustion.

We awoke at 7AM to brilliant sunshine streaming through the skylight, the only window in our room. After dressing and removing the dresser, we peaked out into the hallway. All was quiet but for a few voices from the floor below. We quietly descended the concrete stairs and the daylight revealed a room containing a long bar with 6 stools, a few small wooden tables and linoleum with many cigarette burns. But in the middle, was another table beautifully set with a white linen tablecloth and a fresh flower in a vase. A moment later, our hostess appeared carrying a jar of just-purchased English marmalade. Between hand gestures and fractured German, we came to understand that this room was the town pub, and the rooms for let were usually for locals. To lodge a foreigner was indeed a big deal – hence the marmalade. Our hostess was actually the owner of a prosperous noodle factory on the ground floor and the large courtyard allowed the delivery trucks to come and go. We were invited, no—actually pulled down the stairs to meet the women workers, amid the racks of drying noodles. We were showered with bags and bags of noodles to take with us. When we got out to our car the owner's son had washed and dried it. And what do you think this adventure cost: Five US dollars. What was it worth: Priceless.

So, while we may not be able to travel for a while, draw on the priceless memories you've made and share them. We're all in this together. Please stay safe.

### United Daily Pass Travel Update March 18, 2020



Good Morning Retiree Leaders,

We wanted to share some important news and updates about pass travel and support options at this time. Please share this message with your organization. Thank you for your patience and support.

#### Important updates on pass travel support

If you're using our pass travel benefits, please be mindful that entry restrictions continue to change around the world (including when returning to the U.S. or visiting other countries). Remember that you will need to follow self-quarantine guidelines before coming back to work if you've traveled to high-risk areas, including Europe, the People's Republic of China and the Islamic Republic of Iran. The CDC advises that travelers coming back to the U.S. from these countries should stay home and monitor their health for 14 days after returning to the U.S.

Please visit Flying Together for the latest updates about COVID-19 impacts and reach out to your leader or HR partner if you have any questions. Let's all continue to take care of ourselves and each other!

#### Need help with your pass travel?

To help stop the spread of COVID-19 (coronavirus), government-imposed restrictions have been put in place on travel and everyday life in countries around the world. This is impacting our business in many ways, and it is now affecting the ability of our Employee Travel Center (ETC) to support our employees during their travel, as the ETC call center team is currently not able to get to work and answer employees' phone calls.

The team is working hard to prioritize requests by urgency, and if you need pass travel assistance, we ask that you take advantage of self-service options first, when possible, and submit any other requests through Help Hub.

Self-service options:

- ◆ Add or edit pass rider information in our Dependent Management System (DMS)
- Book and manage travel in eRES
- Add, change or remove pass riders through our DMS
- Purchase tickets using myUAdiscount
- Review policies and procedures in the Travel section on Flying Together

Types of requests that the Employee Travel team **will** prioritize:

- Ticketing assistance (for travel that can't be ticketed in employeeRES)
- eRES system issues
- Company Business offline travel (COBUS)

### Disinfecting aircraft using electrostatic sprayers March 26, 2020



Thank you,

United Airlines is now using electrostatic sprayers filled with high-grade disinfectant to clean widebody aircraft arriving from international destinations at EWR, with plans to distribute more sprayers to other hubs as soon as possible.

When sprayed in the aircraft cabins, lavatories, galleys and crew rest areas, the disinfectant quickly adheres to hard and soft surfaces, as well as areas that traditional trigger sprayers or cloth wipes cannot reach. The disinfectant being used, which is registered by the Environmental Protection Agency, has demonstrated the ability to kill a number of bacteria and viruses, including coronaviruses.

The product is safe and has been used to clean United's fleet for many years. The only difference now is that UAL is distributing it throughout the aircraft using the electrostatic sprayers as an added level of protection against communicable disease.

Over the past few weeks, United has convened stakeholders from its Operations Policy and Support group, Airport Operations, Flight Ops, Inflight Services, Catering, Tech Ops and Safety, among others. Those team members have worked together in performing safety risk assessments on the sprayers, amending our aircraft cleaning and turn procedures, and training employees on how to use the new equipment.

It should take the cabin cleaning crews approximately 15-20 minutes to spray a widebody aircraft. That will be done only after customers and flight crew members have deplaned. Once the spraying is complete and the sprayers are taken off the aircraft, Catering, Tech Ops and Cabin Cleaning and Provisioning teams can begin their normal aircraft turn tasks.

This is an additional step on top of the cleaning process United currently has in place, which includes a thorough wipe down of all touch-points (lavatories, gal-

leys, tray tables, window shades and armrests) using a high-grade disinfectant and multi-purpose cleaner.

### Finding the right spaces for the right aircraft March 26, 2020



Schedule reductions require United to locate secure places to temporarily store aircraft while keeping the fleet safe and compliant on all required

maintenance so they can be quickly returned to the skies when they are needed again.

### Cargo charters keeping United's planes flying March 23, 2020



While recent schedule reductions have left United with a surplus of parked aircraft, the company is putting a portion of its grounded Boeing 777 and 787 fleet to good use flying

dedicated cargo routes.

Presently, United is operating 40 such flights a week from domestic hubs to key international destinations, and will continue to seek opportunities to increase that number.

Keeping the global supply chain moving and getting goods, particularly critical goods, like medical supplies, into the hands of the businesses and people who need them most is of vital importance right now. United owes a debt of thanks to a number of its work groups, including Cargo, Ramp Service, Airport Ops, Flight Ops, Catering and Tech Ops, not to mention the men and women in the Network Operations Center, for making this happen.

"Connecting products to people around the world is the United Cargo mission," said Cargo VP Jan Krems. "That role has never been more crucial than during the current crisis. Our team is working around the clock to provide innovative solutions for our customers and keep our business going. It was inspiring to see the United team come together to get these flights full and in the air to support our cargo customers and the global community." As always, United's employees' health and wellbeing remain the top priority, along with that of customers. The company is taking extra precautions to limit the possibility that someone working one of these flights might be exposed to COVID-19. Additionally, United is continually monitoring entry and exit restrictions around the world.

#### KOA employees making masks for local healthcare workers April 2, 2020



With fewer passengers flying right now, employees at KOA (Kona, Hawaii) are making the most of their downtime by helping supply the state's healthcare workers with much-needed medical masks and mask covers.

Using sheets of donated fabric from a local linen manufacturer, the group has already hand cut more than 2,000 washable, reusable covers for N95 masks, which protect against COVID-19, and hundreds more standard masks for use around patients who aren't experiencing COVID-19 symptoms.

Retiree Linda Hayes has been taking the masks and covers from the airport and delivering them to a friend of hers whose quilting group is sewing elastic bands and ribbon ties onto them. The finished products are then being sent to the Hamakua Health Center and the North Hawaii Community Hospital.

The need for medical masks has never been greater, nor has the supply chain for those items been more hampered, than it is presently. Grass-roots efforts like these are enabling our healthcare professional on the front lines to continue safely caring for patients battling COVID-19.

"Pretty much everyone here has been great about doing different parts, whether it's tracing patterns or cutting or sewing, and our boss Charlene [Goo, KOA General Manager] has been super supportive," said KOA Ramp Service Employee Melanie Hervert, who has been heavily involved in producing the masks. "It helps us pass the time and makes us feel useful, like we're helping in some way."

### <u>United cargo moves crucial medical component</u> <u>March 31, 2020</u>



In the midst of mobilizing United's cargo operations, the teams at EWR and JAX (Jacksonville) stepped in to assist Roche Diagnostics with transporting a vital component for an instrument being used for COVID-19 testing.

The component was stuck at EWR en route to the Mayo Clinic in Florida after another airline's flights were cancelled. A Roche employee contacted United asking for help and, within a few hours, United's teams had the piece loaded onto a JAX-bound aircraft, with arrangements in place to deliver it to the customer.

Roche thanked United for the quick work, saying the shipped item will allow the Mayo Clinic in Florida to process hundreds of COVID-19 tests per day. Mayo Clinic Laboratories has been on the front lines of increasing testing capacity to expedite caring for patients at this critical time and working to ease the burden felt at test processing laboratories in a growing number of areas.

Thank you to everyone at EWR and JAX who was involved in this critical operation.

### Writers Column ~ Aviation Pioneer By George Midwin



John J. Montgomery

When one thinks about the history of aviation, one name comes to mind above all others, as the pioneers, or inventers of the airplane, the Wright brothers. However, one American who preceded the Wrights first flight by twenty years, is much less known. That person was John J. Montgomery. His efforts beginning in 1884 lead to the understanding of airflow

and lateral control. However, the lack of documented accounts of his initial flights, have left much doubt as to giving him credit for being the true pioneer of the first flight in the US.

Born in 1858 in Yuba City, California, one of 8 children to parents who came to California during the Gold rush. At an early age his curiosity leads him to evaluate how and why things functioned as they did. He took a deep interest in kites and was especially fascinated with the "flying top". This was a simple wooden toy, with a propeller attached to a stick and when spun rapidly through the hands would fly up. At the age of eleven, he was witness to the first controllable lighter than air dirigible and built a small-scale model. When hot air balloons began carrying people, his interest in manned flight took off.

John graduated with a Master degree from St. Ignatius College in San Francisco, receiving public acknowledgement for his unusual aptitude in science and his faith in the visionary field of aeronautics. He worked for a short time in his family's business, until his father closed the business and moved to Otay in San Diego to ranch. When he wasn't needed on the ranch, John would study birds in exhausting detail. He also developed an understanding of forces on wings, by observations and actual wind tunnel studies. After a couple failed attempts at building an 'ornithopter' (a machine with flapping wings), John began his focus on gliding.

Those around the globe at the time, those who had been seeking an understanding of flight, believed that a flat surface would provide sufficient lift for flight. However, Montgomery's in depth study of birds led him to believe that mimicking the curved surface of a bird's wing would be the key to creating lift. With the assistance of his father, they were able to bend wood by steaming it to a desired curvature. With the assistance of his sisters, they sewed unbleached cloth to the wood frame and brushed it with linseed oil. The completed wing measured 20 feet long and had a width of  $4\frac{1}{2}$  feet. A semicircular tail was attached and the entire structure weighed a total of 40 lbs.

Having faced the ridicule from his neighbors after the failure of his ornithopter, he decided that the flight of his glider would be done without any neighbors in attendance. So with only his brother, they strapped the glider to a hay wagon and road to a place John had previously selected on the Otay Mesa. From the top of the hill, John climbed onto the glider and with a little run and jump, started gliding. He estimates that he had traveled about 600 yards, but what stood out the most, was his ability to have some control over the glider direction by shifting his weight. That first flight, April 1884, was only witnessed by his younger brother. No photographers, no news media, no neighbors and not even his father, present.

After his initial success of flight, Montgomery continued his research on birds and built small scale models to prove his theories. His focus was on control and incorporated designs which would permit the pilot to maneuver the glider. Through a variety of experiments he was able to design what is known today the aileron. This device, located on outmost portion of the trailing edge of the wing, was connected via cables to just behind the glider seat. As the rider leaned from one side to the other, he could manipulate the devices. This permitted the rider with limited directional control, which was effective in combating the effects of wind gusts.

In 1897 John accepted a teaching position at Santa Clara College in California, teaching aerodynamics. He quickly developed a following as he continued his research on lighter than air craft. In 1903 hot air balloonists were appearing more and more common. This gave John the idea of launching his glider from higher altitudes than hillsides could provide. In 1904, with Daniel Maloney, who had performed stunts from balloons, sitting in a glider, attached to an unmanned hot air balloon, released himself at an altitude above 2,000 feet and successfully controlled the glider back to earth. This attracted attention throughout the US and in Europe. This led to a milestone in aviation, when John Montgomery's glider, with Daniel Maloney in the seat, was released from a balloon at 4,000 feet. As it descended, Daniel performed a series of maneuvers and made a soft landing, in full view of hundreds of spectators and the media.

The great earthquake of 1906 in San Francisco, curtailed John's experiments until 1911, when he began his work again in San Jose, Calif. He was effective in devising a system which provided much improved control of his gliders. Along this time he also was planning on adding a motor. He completed 50 successful glider flights from a hillside in the Evergreen area. During an attempt to land at low speed, the glider encountered turbulence, crashed, killing John.

There may be many reasons for the obscurity associated with John Montgomery, among them may be the

trial by the heirs of Montgomery against the proprietary claims of the Wright Brothers in 1920. This created much ill will which has lasted to this date. Perhaps someday, scholars will agree that John J. Montgomery was the true pioneer of aviation in the US.

This month, we are highlighting a couple, who both worked for United Airlines, and are members of our Re-United's Chapter, **John & Joann Griffin**. They have been very active members of our chapter, and are currently our Treasurer & Membership Chairman.

John & Joann first met during the summer of 1972 when Joann started with United Airlines. John had been hired in 1970 as a summer temp while he went to college. They both worked at the Narrow Body Flight Kitchen in Chicago (ORDHN). John's title was Food Service Clerk (FSC), a non-union job and Joann's was a Food Service Assistant (FSA) in the union. This was during the time that the airlines actually fed you on domestic flights for free!

Two years later in 1974, Joann also became a Food Service Clerk. As clerks, they were able to work different shifts and departments; Liquor, Shipping & Receiving, Manpower at the kitchen, or as a Standby Food Clerk at the field.

Standby Food was located behind two big black double doors on the E concourse next to gate E3 at O'Hare in old Terminal 2. Standby Foods was a fun job. They went from flight to flight at departure time to make sure the Flight Attendants had enough meals or snacks, ice, soda, or whatever they thought they needed. Back then flight loads fluctuated greatly so they were a cost saving department for United.

It was a great place to work where they had a lot of fun and interaction with gate agents and flight attendants. John & Joann met and made lots of friends who they still see today. John & Joann got married on December 19, 1983. Joann had one son from a previous marriage and now they have 3 grandchildren and enjoy being with them.

In 1983, there was a rumor circulating that all the flight kitchens, system wide, were going to be sold. United wanted to get out of the food service business and focus on the airline. These were the days of outsourcing. Thankfully, their supervisors advised them to look for other positions within the company; otherwise they would have to work for the new vendor, whoever that was going to be. John & Joann both had over 11 years with UAL and didn't want to leave United so Joann put in a transfer for reservations at CHIRR and John opted for the ramp at O'Hare, ORDCG. Joann transferred in 1984 and John got his transfer to the ramp in 1986. All the flight kitchens were finally sold in 1993.

In 1987, the huge, fancy, brand new Terminal 1 was opening at ORD with the flashy, musical underground walkways between B & C concourses for United. It was opening that summer, so Joann put in a transfer for Customer Service at ORDCS and since John was already on the ramp, they were able to work the same shift and carpool to work together. Joann worked in several different areas at ORDCS. Joann started as a Gate agent and eventually got to work in the Special Service Center for Wheelchairs and unaccompanied minors. She also worked in the Control Center which was the main operations hub for United at O'Hare.

They moved to Crystal Lake, IL in 1990 so they had about an hour commute to ORD every day. Carpooling with each other or other employees was crucial, especially in the winter with all the ice and snow that the Chicago area gets. Finally, Joann got tired of getting up at 3:00AM in the morning to go to the airport every day, so she decided to put in a transfer for Aircraft Routing at OPBOP at WHQ or the old EXO North building. It was another Control Center but for the whole system not just ORD. Her job was to manage a fleet of aircraft 737s, 727s, 320s or the Widebody fleet for its mandatory FAA maintenance checks. The FAA levied huge fines on United if an aircraft went overtime for its checks. It was a challenging and interesting job, but after a few years later, right before the 2<sup>nd</sup> bankruptcy ended, Joann turned 55 and said "OK, time to retire". She had 33 years and 6 months.

John worked the ramp in a lot different departments, too. He was a food runner until the kitchens were sold, put in for a Lead Ramp Serviceman for a while and then he was a Fueler for many years. During the first bankruptcy, United was still contracting out different departments to save money, and pare down employees. The aircraft cleaners were the first to go and then fueling got eliminated, too. After that he worked mostly relief where he could be assigned just about anywhere; Airfreight, deicing, city runner, gates or wherever he was needed.

So after 2 labor strikes, 1 layoff in 1979, 2 bank-ruptcies, ESOP, 9/11, a broken rib from falling on ice at 5:00 am on the ramp; (6 weeks off with all his sick time) and then the merger with Continental, John decided it was time to retire too. He stuck it out until 2012 when he was turning 60. He had 39 years and 4 months; plus a buyout! Yay!

They sold their Illinois house in 2012, and moved to Wisconsin to be near John's family. Most of Joann's family was still in Illinois; so not very far away and Wisconsin was a refreshing change. Joann's parents had a condo in Fountain of the Sun, so they often visited in Arizona, and really liked it. After Joann's parents passed away, they bought the condo and later they bought a house in Fountain of the Sun in Mesa. They are happily snow birding between Wisconsin and Arizona and loving every minute of it! They're enjoying their retirement; take cruises, go fishing and boating in the summer and fall. In the winter and spring, they party with friends and John plays pickle ball. They have been members of the Arizona Re-United's Chapter since 2013, and currently John is Treasurer, and Joann is the Membership Chairman. 



But fate intervened, and I was hired as an interpreter by Pan Am in 1973. Two years later, United Airlines lured me to the Friendly Skies where I spent the next 32 years. My first assignment was in SEARR – reservations.

"United was on the cusp of innovation in the mid '70s introducing computers into the travel agency community ... We worked directly with hardware and software computer technicians ... [and] had to learn all this from scratch. And that's where my future husband, Gary [Torgison] comes into the picture."

(We'll profile Gary in another issue, but here is more of Kathie's story. She writes so beautifully that I had hoped she might be persuaded to take over this column – but others talked her into serving as co-president before I got around to that! Gay)

"I was lucky to be among the first group of instructors assigned to teach travel agents how to use Apollo in the US and Canada. A few years later, UA introduced the product to Europe. I was chosen as part of a 5member team based in Paris, to provide the technical expertise needed to UA's sales department to sell contracts for Apollo to travel agencies in 11 countries. What a marvelous assignment that was! My apartment was located at 22 Place Vendome, across the plaza from the Ritz Hotel Paris!

... Meanwhile, after a couple of years as instructor for City Ticket Offices, I worked in Sales for a while and then I moved to airport customer service as Senior Instructor of Airport Operations Training reporting to WHQTD, but residing in SEA. Following the merger with Pan Am and subsequent further expansion, international stations from Taiwan to Saigon, Sydney to Shanghai, Dublin to Düsseldorf were my home, as I would spend 3 to 5 weeks at a time teaching new employees the United way of service."

Kathie retired in 2007 and immediately volunteered to staff the UA Retiree Travel Desk in Seattle. Though she and others tried to keep the Travel Desk alive, it was

disbanded by management, after which Kathie and two other retirees offered classes on the Flying Together website in local libraries to help our aging retiree population keep up with emerging ways to use the site for listing and ticketing.

"In 2013, I assumed the duties previously handled by retiree **Bob Brumfield** in the national RUAEA newsletter by authoring articles 6 times a year."

The year of 2019 was not a good one for me, so let's hope 2020 is an improvement.


