

#### **UAL Benefits News Update**

United Kingdom APD (GB) tax changes: Due to a recent audit with U.K. tax authorities, United needs to change the way we collect the Air Passenger Duty tax (APD) out of the U.K. In the past, pass travelers were charged the Economy cabin APD tax regardless of the cabin for which they listed. Effective immediately, United is required to charge the appropriate APD tax in the cabin in which you list. If you use payroll deduction, you will be properly charged after travel takes place, based on the cabin in which you flew. If you prepaid with a credit card for your travel and listed for a premium cabin, but were cleared in economy, you will need to request a refund of the difference in APD tax by going to the United.com Refund policies page and specify that you paid APD tax for the premium cabin but were accommodated in Economy. Please be sure you submit the ticket number for the ticket used to depart from the U.K., and not connecting ticket numbers. Also as previously communicated, we are no longer able to issue transit refunds if your inbound flight to the U.K. was not on the same ticket as your connecting United

Retiree enrolled friend changes deadline: The deadline for you to make changes to your enrolled friends for the Jan. 1 - Jun. 30, 2025 travel period is Saturday, December 28 (until 11:59 p.m. CT). There is a helpful page on Flying Together with lots of details and a video on how to make changes if you need to. If you don't want to make any changes, you do not need to take any action. Current enrolled friends will automatically roll over to the next travel period, just like your spouse/domestic partner, children and parents do. Keep in mind, once a new travel period begins; your current enrolled friends can be removed but cannot be replaced within the same travel period. Exception request will not be accepted once the deadline passes.

You may have heard the saying, "inflation hurts savers and benefits borrowers."

The expression suggests that borrowers benefit from inflation because they pay back lenders with dollars worth less than when the money was initially borrowed. But for savers, your hard-earned dollars may lose buying power over time.

#### An important message from the Denver office



RUAEA has been using a database for many years to keep all of the membership data that we use to get you a quality Newsletter each month.

As you all know, **Cas Spokas** passed away in November of 2023; he was the person who was responsible for the database. For many

years, Cas maintained, updated and wrote programs to accomplish new functions. It got to the point that corrections needed to be made every time we used the database. Cas taught me a lot to keep it going; he was an amazing and kind person; I could never get to his level of technical expertise.

We have been able to partially use the programs and get the newsletter out. It was decided by the RUAEA Board of Directors to have a new database created. The company, Arc Seven who maintains our website, was contracted to create it. Luckily, RUPA (Retired United Pilots Association) uses the same company to handle theirs; this economized the cost.

To explain the website and database simply; you access the website to join, or renew your membership and paying with CC and read all the free info. Members who opted for **both** or **web**, sign into the website to read the newsletter online. That is the only reason to sign into the website. Why you may ask; the website costs money to register and operate. It's not free.

The database is maintained by the Denver office. You don't see this. When you send in your changes or renew by CC or send in obituaries to be printed in the newsletter, these are managed by the database. Also, "Thank You" letters sent in with CC renewals go into a file to be printed in the Newsletter. The letters you send in with your check are processed by our Letters Editor **Martha Gooselaw** and entered in the Letters Section; a lot of work. And to answer your question, we read them all and they are greatly appreciated, thank you!

The website and the database interact with each other. When we do the final merger of the old and new

databases, the operation will be much more streamlined.

Now to the basis of this message: The arrears list email and US mail arrears letters are being streamlined. The old way of doing business is going away. Put it simply, members who receive a mailed newsletter or are both; both meaning you get a mailed newsletter and have access to the Newsletters on the website.

The Newsletter has a mailing label printed on the back. It contains the member's address. It also has the members file number above the name to the left. Above the name to the right is the member's expiration date. As an example, 9/3/2024 xpd, expiration date. In case you don't look at this, please pay attention to this message. And don't bring up "I thought it was my birth-day". That's been gone forever.

A month before your membership expires; there will be a renewal message in red above your mailing label. Read your mailing label every time you receive a newsletter. It's your last newsletter; time for the checkbook or your CC. For <u>Web Access Only</u> or <u>Both</u> members; you will get an email 1 month before your renewal is up. To clarify, members who sign up for <u>both</u> will get an email and a red renewal message on your newsletter. That's because you're both, not special, just both. Everybody gets one renewal notice 1 month before, that's it. That's the important message.

Now, just to show you I'm not as strict as this sounds, I have extended the US mail letters to January 1<sup>st</sup>. The reason for this is that I know a lot of our members do not have an email or a computer. I respect that and want to accommodate those members who still communicate via US Mail.

Renewing your membership is your responsibility. Renewing early makes my job easier. Some members think if they renew early, they lose time; nothing could be farther from the truth. The database was written to extend your membership a year from your renewal date, not on the day we process your renewal notice. Of course, if you are in arrears, it's a year from the day you pay. If you renew today, then forget and renew again tomorrow, you just renew for 2 years. Not to worry, we take care of you at the Denver office.

On a related subject, the Denver office has moved to a different space from our prior space at TK. Yes, another move. It was not fun. You almost did not get a May, June or maybe a July newsletter. We now share an office with the Mainliner Club Manager. And no, I can't get you a discount. It is a great location and we are greatly pleased, the new office is a little larger than the last one. There is still not a lot of storage space. When members call and are in arrears and would like multiple past issues of the Newsletter, we can't accommodate those requests. We only keep a few extra issues each month for those instances that the Newsletter did not get delivered by the US Postal Service. If I get a call stating "I haven't gotten a newsletter for 6 months", this is not a good call. If your newsletter didn't arrive, email or call, I answer them all. How's that for a motto. To give you good service, I need all the help I can get. And if you tell me nobody answers the phone, I'll tell you that you are correct; we are talking now. If you call and hang up because we are not able to answer the phone, you will only frustrate yourself. Leave a message, let me help you.

To put it simply, I check the emails and voicemails every couple of days and respond promptly. You are my coworkers and your questions matter to me greatly. Let me help you whenever I can.

When you don't put your file number on the check, I have to look you up. Smith and Jones, you know who you are. I have to look through all your names and match up your address. If you have an uncommon name, you are forgiven.

This letter kind of ran away. It was supposed to be about the new arrears messages. But, I just wanted to take the opportunity to let you know the amount of effort that goes into getting you a newsletter every month and how much we appreciate your membership, your kind letters and renewing early.

One last thing, I have had calls about chapters not having articles in the newsletter. When there is not an article from a chapter, the statement, no article this month, is printed. If a chapter is inactive, they are removed from the newsletter. Of course if they become active again, they are back. If they are inactive and submit a letter, it is included under the chapter region name.

In closing, thank you for your membership. You can now go on to read your local chapter articles.

And remember, enjoy your newsletter, also look at your mailing label and act appropriately.

# United Makes It Easier For Fans to Follow Chicago Bears on the Road with More Flights and Later Departure Times to Return Home August 6, 2024



United Airlines today launched a first-of-its kind flight schedule to make it easier for Chicago Bears fans to travel to every away game this season. For the first time ever, the airline is

adjusting departure times of six flights so fans have the option to fly home the same night as away games. United is also flying larger planes on two routes and adding an additional nonstop flight between O'Hare and London's Heathrow Airport for the Week 6 Bears/Jaguars game at Tottenham Hotspur Stadium – giving fans four total nonstop flight options to get to London.

According to data from the NFL, Chicago Bears fans are among the most dedicated road warriors in the league; more than 76,000 Bears fans traveled to away games during the 2023-24 season.

"As Chicago's Hometown Airline® and longstanding sponsor of the Chicago Bears, we're proud to show our support this season with this special schedule for fans," said Patrick Quayle, United's Senior Vice President of Global Network Planning. "Our enhanced schedule gives customers options no other carrier is providing, making it easier for fans to support the Bears on the road during some of the biggest games of the season."

United is Chicago's largest airline, operating more than 500 daily departures from Chicago O'Hare with nonstop service to 148 cities in the United States and nonstop service to more than 40 international destinations.

United Airlines has been the official airline of the Chicago Bears for more than 50 years, flying the team to more than 350 games and making it easier for thousands of fans to cheer on the Bears on the road every year. The two organizations consistently partner for community engagements in the Chicago area including earlier this summer, when Chicago Bears Tight End Cole Kmet worked alongside the airline's Special Olympics Service Ambassadors for the day to help drive awareness of the organization's travel needs.

"We are fortunate to continue building on our progressive and collaborative partnership with United Airlines by creating more unique opportunities to accommodate our loyal and passionate fans," said Bears Senior Advisor to the President/CEO & Chief Administrative Officer, Ted Crews.

"As Bears fans create their travel plans for the upcoming season, it is a welcomed and appreciated gesture by United to provide optimal travel accommodations through increased flight options, helping our fans return to Chicago, and wherever they call home, safely and efficiently," said Karen Murphy, Bears Executive Vice President of Stadium Development & Chief Operating Officer.

<u>Bears Away Schedule</u> ~ United is making it easier for fans to see every away game this season including:

- A Retiming return flights to Chicago for seven games so fans have the option to fly home on game night, or early the next morning:
  - Houston, TX (IAH) on September 15 evening flight departs at 11:59 p.m.
  - Indianapolis, IN (IND) on September 22 evening flight departs at 7:19 p.m.
  - Phoenix, AZ (PHX) on November 3 evening flight departs at 8:45 p.m.
  - Detroit, MI (DTW) on November 28 evening flight departs at 5:30 p.m.
  - San Jose, CA (SJC) on December 8 evening flight departs at 7:00 p.m.
  - Minneapolis, MN (MSP) on December 17 flight departs at 7:20 a.m., the morning after the game.
  - Green Bay, WI (GRB) on January 5 flight departs at 7:41 p.m.
- ▲ Flying larger planes between Chicago O'Hare and Reagan National Airport on October 27 as well as to Green Bay, WI when the game is announced.
- Adding an additional flight between Chicago O'Hare and London Heathrow on October 9 and 10, returning October 14 and 15.

# United Is First Airline to Purchase Sustainable Aviation Fuel (SAF) for O'Hare International Airport July 31, 2024



United today became the first airline to purchase sustainable aviation fuel (SAF) for use

at O'Hare International Airport (ORD) and Governor JB Pritzker joined the airline's leadership at ORD to highlight the role that Illinois' SAF tax credits played in bringing sustainable aviation fuel to one of the largest airports in the U.S.

SAF producer Neste will provide up to 1 million gallons of Neste MY Sustainable Aviation Fuel<sup>TM</sup> to United at ORD in 2024 with the first supply arriving in August. United was the first airline to create a goal of reaching net zero greenhouse gas emission by 2050, without relying on voluntary carbon offsets, and remains

a U.S. industry leader in the purchase and use of SAF. The airline purchased more sustainable fuel than any U.S. airline in 2023 and the agreement with Neste makes O'Hare the fifth airport where United has purchased SAF for operational use – among the most locations of any U.S. airline.

"Since day one as Governor, I've committed to making Illinois a national leader in sustainability and clean energy, which is why I was proud to support a nation-leading SAF tax credit last year," said Governor JB Pritzker. "Illinois's position as a hub of innovation with some of the most connected airports in the country perfectly aligns with the work of companies like United to build a more sustainable future for travel and reach our shared goal of zero emissions."

SAF is an alternative to conventional jet fuel that can reduce GHG emissions by up to 85% on a lifecycle basis – from production to end use - because it is made from renewable materials rather than drilled fossil oil. SAF is among aviation's best, most scalable options to push the industry towards net zero emissions in part because it can be used right now with existing infrastructure - no changes to fuel systems or aircraft engines required.

"This is what happens when innovation, leadership and policy come together," said United President Brett Hart, who was at ORD today with the Governor. "While the market for SAF is still in its infancy, there is a huge opportunity today for airlines and policymakers to work together to support its continued growth – SAF at O'Hare was made possible thanks to Governor Pritzker and the Illinois Legislature passing tax incentives."

United has now purchased SAF for airports in Los Angeles, San Francisco, Chicago, London, and Amsterdam.

"I'm pleased to see United Airlines making this significant move forward by using sustainable aviation fuel daily in flights from O'Hare," U.S. Senator Tammy Duckworth (D-IL) said. "One of the most important things we can do to make American aviation more sustainable is increase the supply of SAF. At the federal level, I've been pushing for the increased use of SAF, and I'm going to keep pushing to increase the supply of American-grown, American-made SAF, a true win-win solution that supports domestic farmers and blenders while reducing our nation's carbon footprint."

United SAF Policy Leadership ~ United is a chief advocate for legislation to grow the SAF market, and helped push for the successful adoption of a federal SAF Blender's Tax Credit, DOT grants to promote SAF usage, and incentives for hydrogen production and carbon capture. At the state level, the airline has helped secure the passage of SAF tax credits in Illinois, Colorado, California and Washington that encourage the purchase of SAF for local airports.

To further develop and deploy SAF in the U.S. and advocate for policies that will help U.S. fuel producers lead this growing industry, United helped found the SAF Coalition, a consortium that includes more than 40 airlines and aircraft operators, agricultural enterprises, aircraft and aircraft equipment manufacturers, airports, technology developers, labor unions and biofuel produc-United Leadership & Coalition Building ~ United's roadmap to achieve its emission goals includes driving operational efficiencies, adding hundreds of new, fuel-efficient planes, using SAF, and investing in other low carbon onboard products and alternate propulsion technologies.

Importantly though, the airline recognizes that no one carrier or industry can solve climate change alone and that's why United has also rallied the business community to scale more sustainable aviation fuel.

- ▲ SAF purchased for United's flights is paid for in part through the company's Eco-Skies Alliance SM, where participating companies work together to share the "green premium", or the cost associated with purchasing lower emission fuels. Since 2021, the alliance has collectively contributed toward the purchase of more than 10.5 million gallons of SAF. ESAcompanies include Autodesk, Bank of America, BCG, DB Schenker, Envirotainer, First Eagle Investments, Marken, Thermo Fisher Scientific, Salesforce, Meta, ZS, SEKO, Sidley Austin LLP, and Yusen Logistics.
- Launched in 2023, the UAV Sustainable Flight Fund<sup>SM</sup> is a first-of-its-kind investment vehicle designed to leverage support from crossindustry businesses in order to support start-ups focused on decarbonizing air travel. The fund is comprised of more than \$200 million in investment commitments from United and 21 corporate partners.

#### **United Airlines Announces Second-Quarter 2024** Financial Results; Achieves 2Q EPS Expectations July 17, 2024



United Airlines (UAL) today reported second-quarter 2024 financial results. The company had pretax earnings of \$1.7 billion, with a pre-tax margin of 11.6%; adjusted UNITED pre-tax earnings of \$1.8 billion, with an adjusted pre-tax margin of

12.1%. The company expects pre-tax margin to be near the top of the industry. The company also achieved diluted earnings per share of \$3.96; adjusted diluted earnings per share of \$4.14, in line with second-quarter 2024 guidance provided at the start of the quarter. The company continues to expect full-year 2024 adjusted diluted earnings per share<sup>2</sup> of \$9 to \$11.

For nearly two years, the airline has been anticipating significant domestic capacity reductions recently announced by a variety of U.S. airlines this summer and mid-August is an inflection point, with published schedule changes showing an approximately 3 point decline in industry capacity growth rate. The airline expects three critical revenue diversity advantages that propelled it to the top of the industry during this challenging period to further accelerate. The first, premium revenue, grew 8.5% in the second quarter versus the same quarter last year. The second, Basic Economy revenue, grew 38% year-over-year during the quarter. The third, market share among domestic road warriors, increased during the quarter year-over-year.

"The revenue diversity advantages that we've built with our premium customers, Basic Economy customers, and domestic road warriors, on top of the world's best loyalty program and leading customer service, have propelled our margins to near the top of the industry," said United Airlines CEO Scott Kirby. "Looking forward, we see multiple airlines have begun to cancel loss-making capacity, and we expect leading unit revenue performance among our largest peers in the second half of the third quarter. United has long been preparing for the moment when industry wide domestic capacity would adjust – it's now clear that inflection point is just 30 days away."

United has also continued to strategically manage the business in the face of industry wide challenges. United reduced costs and delivered CASM of down 4.8% and better-than-expected CASM-ex of up 2.1%. The airline also generated net cash provided by operating activities of \$2.9 billion and \$1.9 billion of free cash flow in the quarter. In early July, the company voluntarily prepaid the remaining balance of the high-cost MileagePlus term loan, totaling \$1.8 billion, which further strengthens its balance sheet and reduces the airline's interest burden in the years ahead. The airline ended the quarter with trailing twelve months adjusted net debt to EBITDAR of 2.6x. Looking ahead, United has also reduced planned domestic capacity by approximately 3 points in the fourth quarter, compared to the company's previous plan – reflecting the airline's firm commitment to taking its own action to adjust to current trends.

#### <u>Torgy's Travel Tips – September 2024</u> <u>A Lighthearted Review of Airline Vocabulary</u>



- © Codeshare: Magic trick in which aircraft from several different airlines leave from the same gate at the very same moment to fly the same route.


- © Direct Flight: A connecting flight in disguise.

The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too; however, please send in coupons at least every other month so the troops have a longer time to use them. Unfortunately, manufacturers are cutting back on the coupons they are issuing, especially on food items, just when people need help the most. So anything we can send to the troops is greatly appreciated. I get so excited when I get a coupon for eggs!

I am so grateful for the kindness of all the RUAEA members who are helping me with this project. I have been turning in coupons every month since May 2022. In July, I turned in 909 coupons and on August 7, I turned in 836. I think the numbers have dropped the last two months because people may be traveling. Thank you so much to the members in my local RUAEA chapter and to members from all over the country who are sending coupons. All the coupon cutters are telling me that they are not getting coupons like they used to. It's really bad in the SF Bay Area and I'm glad that other areas of the country are still able to send coupons. If it

weren't for the RUAEA folks from all over the country sending me coupons, my chapter would have very few coupons. # Patricia Winterson Obituary May 7, 2024 San Anselmo, CA (1936-2024)

Patricia Marilyn Winterson, age 87, of Marin County, California, passed away on April 27, 2024. Pat was born on June 11, 1936, in New Bedford, Massachusetts, to Harold and Sophie Winterson (née Rapoza).

Pat knew heartache at a very early age when her mother died of tuberculosis. The events that followed shaped her into a fiercely independent and courageous young woman. She grew close to her Massachusetts relatives, graduated from New Bedford High School in 1954, and shortly thereafter moved to California seeking new experiences and adventure. She landed in San Francisco, and eventually moved to her home in Mill Valley where she lived most of her life.

Pat had an impressive and rewarding career at United Airlines that began as a flight attendant in 1958 in San Francisco. She worked for United for 43 years, and in 1973 was the highest ranking woman at the company (managing more than 1,300 people). Pat helped challenge gender-based discrimination and promote equality in the workplace. In 1976, she delivered a speech about women in management, the first time in the history of United that the subject had been addressed publicly.

She was incredibly driven, pushing the boundaries at work, and also pushing herself intellectually, reading entire collections of classic authors, and seeking mentors and friends who expanded her horizons and perspectives. She earned a degree from University of San Francisco in 1979.

A curious adventurer, Pat's life was full of travel and exploration. She loved bargain shopping in Hong Kong, exploring museums and architecture in Paris, and passing the time in restaurants and bookstores in Florence. She was a beloved daughter, sister, cousin, aunt, friend and employee. She was a lover of novels and biographies, a generous supporter of animals, and an old movie buff. And she loved her dear Gracie, Sophie and Phoenix.

Pat is survived by many dear family and friends, and is predeceased by her partner of 20 years and best friend, Frank Murphy, and her three beloved brothers. She has spent her life exploring with people she loved, and now she's on to her next voyage, with lots of love waiting for her on the other side.■
