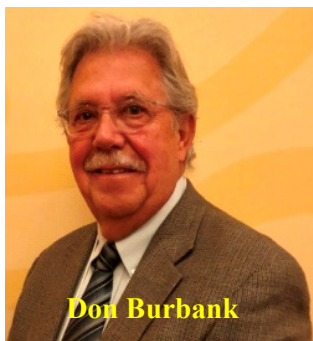

Think before you go:

Ways to keep your data safe while traveling



As National Cyber Security Awareness Month (NCSAM) comes to an end, it is important to remember that cyber security isn't something we need to just focus on in October but rather

something we need to keep in mind throughout the year. As we get ready to transition into the holiday travel season, here are some ways to keep you and your data safe while on the go:

Before you go:

- ✓ Update all of your software and apps and back up important information such as contacts, photos and other documents.
- ✓ Use password-protected home screens and always lock your device when not in use.
- ✓ Turn off Siri and pop-up notifications on the lock screen.
- ✓ Turn off the automatic connection option for nearby hotspots and disable your Bluetooth connection when not in use.
- ✓ Install a tracking application in case your device gets lost, stolen or left behind.

On the go:

- ❖ Refrain from using unsecure public Wi-Fi networks and pay attention to warning messages that say "server cannot be verified." If you have to log onto an unsecure network, avoid using online banking, shopping, social media sites or any other site that transmits sensitive or personal identification information.

- ❖ If you have to make a sensitive transaction, your mobile network connection is generally more secure than a public Wi-Fi network – make those sure those sites begin with "https://."
- ❖ Eliminate hacker entry points by avoiding USB charging stations, because they could be compromised.

Don't conduct personal business on hotel computers, since they may not have the latest operating system and security updates; they could also be infected with malicious software or viruses. When traveling, have a plan. Taking the necessary steps ahead of time to protect yourself and your loved ones from cyber criminals to avoid adding something unpleasant to your long holiday to-do list. DT in DC



Leaders from United's Digital Technology (DT) group visited the U.S. Capitol Building in Washington, D.C. where they met with senior-level staff members of key aviation committees to discuss steps United has taken from a mobile technology perspective to make its customers' lives easier when flying.

The United contingent included Application Development Director Jim Stathopoulos, Senior IT Project Manager Sean Johnson, Senior Product Owner Jaymes Todero and Employee and Enterprise Systems Managing Director Eric Ensminger. Appearing before their Capitol Hill hosts, the United group touted things like United's mobile app features, the first-of-its-kind "in-the-moment care app" that employees use to compensate passengers in real time after a disservice, and the ways in which United is using mobile devices to untether its workforce for the benefit of its customers.

"One example we used was the Tech Ops mobile tool," Eric said. "By equipping our technicians with iPads, maintenance is releasing aircraft six minutes faster, on average, per turn. The paperwork they used to do manually can now be done electronically, and that's helping reduce delays."

Another tool that was well received was the recently added "every flight has a story" feature on the United app, which gives customers insight into what's going on with their aircraft during a delay, eliminating some of the frustration associated with those episodes. They also discussed upcoming improvements to the customer app. *"The reaction we got was very positive," Eric continued. "This isn't something we normally do, but it was important that we show we truly are a customer-centric carrier. And the staff members we met with were recep-*

tive to the work we're doing in this space.” Congressional Affairs Managing Director Karen Kuhlman had a similar assessment, saying the staffers with whom they met seemed genuinely impressed with the work being done by United’s DT team. “It was unique because we were able to take airport technology to them and show the significant investments we’ve made in our customers and employees,” she said. As Karen pointed out, the visit served several purposes, but chief among them was showing government officials that United is an innovator in the tech space, which can have an impact on future passenger-focused legislation.

United released the third-quarter 2018 financial results on Oct. 16, 2018.



United reported third-quarter adjusted net income of \$837 million, adjusted diluted earnings per share of \$3.06, adjusted pre-tax earnings of \$1.1 billion and adjusted pre-tax margin of 9.7 percent.

The company currently expects to recapture approximately 90 percent of the estimated \$2.5 billion year-over-year increase in full-year 2018 fuel expense.

1. **employeeRES**: Major improvements coming. A new employeeRES coming later this fall will look/feel like united.com. It will be mobile-friendly and has been beta-tested by thousands of employees. Look for some cool new features like:

- ✓ Flight Watch: monitor up to 10 different segments
- ✓ Open Search: see flights with most available seats to a destination
- ✓ Potential Misconnects: how many revenue passengers may miss your flight
- ✓ myUADiscount: prices displayed right in employeeRES! <https://ft.ual.com/news/2018/10/19/new-employeeeres-investing-in-you>

2. Access to important updates

- ✓ Before you go to the airport, view the latest updates for flight cancellations, travel waivers, airport construction and other items that could affect your travel with this link: <https://www.united.com/CMS/en-US/travel/news/Pages/travelnotices.aspx>
- ✓ Smart idea: Save that link to the home screen on your mobile device(s).

3. **Merged! Flying as One** ~ Implementation of the flight attendant joint collective bargaining agreement (JCBA) on October 1 marked the final milestone in the United and Continental merger. “Common Metal” that unites all 24,000 flight attendants plus new boarding times for passengers are in this Oct 1st news article: “Flying as one United”:

Scroll down the articles to read about new checked baggage fees for passengers that went into effect 8/31/2018. Keep in mind that pass riders flying standby or on myUADiscount tickets get two free checked bags on United.

4. **FAA bill passes; new inflight regs coming** ~ 10 hour (instead of 8 hrs.) minimum rest between flights, no bumping pax off planes, no pets allowed in overhead bins, FAA will set minimum seat sizes & pitch, no inflight mobile phone calls or e-cigarettes allowed and other rules have been approved by the Senate. 5. **Not getting premium seats?** Standbys rarely get premium seats on domestic flights because all MileagePlus (MP) passengers are upgraded for free. Internationally there are better chances since MPs have to pay for upgrades. But, don’t get your hopes up for those FC or BF seats until you actually get your boarding passes. Here are two retiree standby stories:

- SYD-SFO 787 2-class: we were #1 & #2 standbys for 6 available BF seats. No upgrades were displayed at check-in; CSRs said “you’ll get seats at gate”. No names appeared on upgrade list, no announcements made for upgrades. We were given Y seats and all standbys junior to us got Y seats. Agents apparently asked MP customers individually at check-in if they’d like to upgrade to BC for a fee.
- IAD-CDG 777 3-class: we were #2 & #3 standbys for 4 available FC seats. EmployeeRES showed 4/-3/5 available seats and 6 upgrades. Boarding totals showed “capacity” to be 8/40/221 and “authorized” to be 0/48/222, meaning BC can be over-

sold. All standbys got Y seats when the over-sold revenue BC pax were upgraded to FC and BC filled with MP upgrades.

Understand that United needs to make money and it's just harder to get those coveted premium seats these days, even when it looks like a "slam dunk" you'll be seated in luxury. Be aware of negative (oversold) numbers, "authorized" numbers and upgrade numbers just before boarding. Check both employeeRES and the United app's "flight status" info for the latest data to avoid last minute disappointment at the gate. Pass riders' best strategy: list for premium, expect economy and be pleasantly surprised (once in a while).

6. **New United flights announced** ~ Travel to snowy resorts this winter with over 100 flights to 12 ski destinations: Aspen, Big Sky, Crested Butte, Jackson Hole, Mammoth, Reno/Tahoe, Salt Lake City, Steamboat Springs, Sun Valley, Telluride & Whitefish, <https://hub.united.com/united-winter-just-got-cooler-2608164960.html>. Then check out these new routes/increased flying for 2019:

- ❖ New flights coming in March: IAD to HHH (Hilton Head), LAX to EUG (Eugene), MSN (Madison), PSC (Pasco)
- ❖ New flights coming in April: EWR and ORD to HHH
- ❖ New flights coming in June: DEN to CHS (Charleston), ACV (Eureka), FAI (Fairbanks), EWR to PNS (Pensacola), SFO to CMH (Columbus)
- ❖ Increased flying from EWR to ANC (Anchorage), DTW (Detroit), STL (St Louis), MCI (Kansas City), OMA (Omaha) and RIC (Richmond)

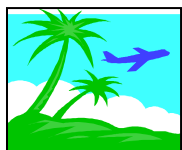

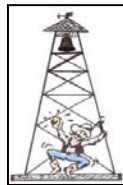

The ship was small and showed her age, however, that handling of the embarkation and debarkation in Havana, including customs and money exchange, took less than an hour. We didn't get to hear any of the Cuban Jazz music but we were truly blessed with a view into a world most will never know. Cuba is an extremely poor country where enterprising individuals find it necessary to find creative ways to earn extra money. Our tour guide for instance, is a Pediatrician by trade but makes more money being a tour guide than he does by practicing medicine.

Travelers are warned not to consume the water or eat any food products washed in it. This is due to the lack of a clean water and sewage infrastructure. As for the great classical cars you may see and read about, not one of them is sitting on its original chassis. Auto imports and the ability to buy parts came to a halt after the revolution and all the pre revolution vehicles have been retrofitted with Russian and Chinese chassis and run on diesel fuel. Most important, they are all privately owned and used strictly for tourism as the average person cannot afford to own a car. The old Spanish influenced architecture is in constant repair since the many years of trade embargoes, make supplies and equipment hard to obtain. As for shopping, Cuban hand-rolled cigars, rum and authentic Cuban art are the only real bargains. Workers in the cigar and rum factories are rationed out a small amount for their personal use each month. The average Cuban can't afford them.

Cuba is a photographer's paradise. Whether from its pre and post-revolutionary architecture, classic cars, and music, to its beautiful people. It has something for every visitor. We found that the Cuban people don't particularly care for the American government, they do love her people. We exchanged email address with several people and do plan to keep in touch. 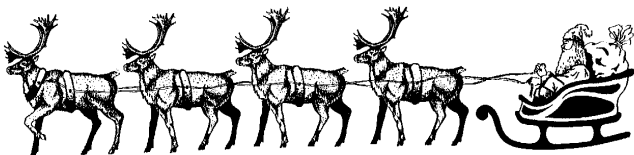
Jim Braden is doing very well, he has had 7 out of 12 chemo treatments and the scans show the tumors are receding. That's very good news.

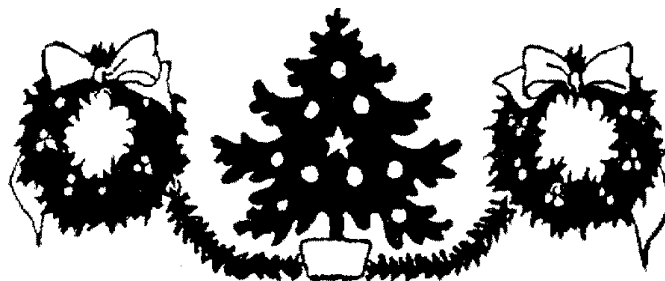

(Part two of three) ~ By James H. (Jack) Knight,
Experimental Night Flying

We welded the cylinder and finally got into North Platte at about 4 o'clock. After a little work on the motor, I made a test-flight from 5:00 until 5:50; then made another flight from 6:30 until 7:00. I had intended staying aloft about an hour longer, but my motor was running irregularly and my ammeter points were sticking - so I landed about 15 minutes after dark by aid of my Wing-tip lights.

On February 21st, I flew back to Omaha after laying-out four locations for the Route lights (Blinker lights put out by the Gas Accumulator Co.). We located these lights three miles apart in fields that would be large enough to land in - in case of an emergency.

I flew back to North Platte on February 23rd and had trouble with the voltage regulator and burnt out my generator completely. I had to "limp" into North Platte, flying on my battery, with a badly "missing" motor.

I might say right here that the motor in #242 was surely the poorest Liberty motor I'd ever confessed sitting behind, and my language en route was highly uncomplimentary. My generator could not be repaired, so with Superintendent Colyer's permission, I borrowed ship #281, and that night flew for over an hour back and forth over the Route lights at all altitudes and under all conditions. I found 2500 feet the best altitude for seeing these lights and at that height I could see two Blinkers ahead (about 6 miles).

I made two good landings and take-offs this night (the 21st) with the aid of a small Search-light suspended under the wing and hooked up to the storage battery.

This night we had a 12 mile course, lighted with Route lights three miles apart, and also used four Blinkers for boundary lights on the field. I am strongly for a clear, steady burning light for Boundary lights on all permanent fields, as an intermittent light has a tendency to confuse you during a landing.

It was a great relief to fly a good motor again after riding behind the "oil can" in #242.

I stayed around with Mr. McKee all day Saturday, hoping it would be possible to fix the generator in #242 good enough to get back to Omaha. We ordered a new generator and voltage regulator from Dayton, Ohio. I then "Trained-back" to Omaha Saturday night arriving at 7:00 P.M. - Union Pacific Railroad time.

In Omaha, I flew a test-flight on ship #226 on the 26th of February. North Platte had made temporary repairs on the generator of ship #242 so I "Trained" to that station on February 27th and flew #242 back to Omaha on the 28th. Supt. Colyer is going to have a new motor, generator and voltage regulator installed in #242 at this field by March 9th.

On March 2nd, I flew Mr. Magee to North Platte in #226, a ship borrowed from Colyer. On March 3rd, I flew #226 to Grand Island, Nebraska as a relief to Pilot Lewis who had motor trouble in that locality. Too much stormy weather and only 15 minutes of daylight remaining did not allow a flight back to North Platte.

I flew #226 on to Omaha on March 4th and am at present waiting out the weather, and the motor in #242.

I find at the present time that the Experimental Night Flying stage is in "crying need" of a car at North Platte (equipped with speedometer and large enough to carry supplies back and forth to the emergency fields).

It is absolutely essential that we have the Hispano-Suiza motored ship that was promised us by Chicago. This ship should have "detachable dual controls"; a sturdy landing-gear with wide-tread and oversize tires for landing in soft fields; and it should be equipped with 40 gallon gas tanks and enough oil for 4 hours. Such a ship is in Chicago at present - awaiting assembly.

We need about 4 Search lights; 2 Rotary Beacons and about 25 steady-burning Boundary lights. I would suggest that the present DH4 Liberty exhaust manifolds flare badly at night and I hope (with the aid of Supt. Colyer) in the near future to have a set of exhausts installed on #242 that are "glare-proof".

My own personal opinion of the Wing-tip landing lights is that I believe they are in the wrong location and should be located either under the lower wing 7 or 8 feet from the fuselage or directly under the fuselage with adjustable beams thrown ahead, to right, or left, or straight down. This point is debatable, and on the earliest convenient night, Mr. Lewis, Mr. Yager and Mr. H. C. Smith have consented to fly the ship and see what their consensus of opinion is in regard to the best location for the lights.

I hope it will be possible to do away with the 12-15 volt generator, the three-wire system, the voltage regulator, etc., as too much "delicately adjusted" electrical equipment spells trouble and requires an Electrical Engineer's supervision.
