### Renewed focus on carry-on compliance began March 1



For several months, UAL has provided the tools, training and technology necessary to raise customers' awareness of its carry-on baggage requirements. United also educated customers on its policy. Along with updates to [united.com](http://united.com), MileagePlus members have received emails detailing our policy. United recently launched an email called "Over, Under, Checked", to reinforce its baggage policy before customers arrive at the gate.

The message has been simple:

- ✓ **Over:** One carry-on item that fits in the overhead bin (no larger than 9 x 14 x 22 inches including handles and wheels)
- ✓ **Under:** One personal item that fits under the seat in front of you, such as a laptop case or other small item (no larger than 9 x 10 x 17 inches)
- ✓ **Checked:** Any oversized or extra items that do not comply with the over/under guidelines

United can ensure smoother boarding and fairness to those in later boarding groups by assisting customers with non-compliant bags before they reach the gate, which will ease the strain on customers and employees.

***IE11 Alert on Flying Together homepage removed***

~ Some users of Internet Explorer 11 get weekly “auto-updates” from Microsoft. If you use IE11 and can no longer access parts of Flying Together (employeeRES, My Info), call the IT Service Desk for assistance 800-255-5801. Corporate Communications has removed the ALERT message on Flying Together that used to guide users in configuring IE to be compatible with Flying Together.

***My info in “All About Me” = 403 Forbidden for retirees*** ~ Retirees who click on the “My Info” link in “All About Me” will be faced with a “403 Forbidden notice”. The “My Info” link is for active employees only. Don’t despair; retiree information is in the “Your Benefits Resources-YBR” link in All About Me, under Benefits. Once in YBR, go to “Your Profile” at the top of the page and click on “Personal Information” to see and edit your information. To effect a name change, however, you must call the Benefits Service Center: 800-651-1007.

***Tell your survivors about pass travel!*** ~ Read the Survivor Pass Travel policy! When you die, your surviving spouse/domestic partner will get passes until remarried or re-partnered (boarding at SA1P for 30 days then SA2R). Dependent children can fly until age 26, parents fly for 3 years, and Enrolled Friends for 90 days (children, parents, EFs will board @ SA4P).

Survivors should call the Benefits Svc Center 800-651-1007 to report a retiree’s death then email etc@united.com to confirm their pass travel “privileges” and to get instructions on listing. The “Survivor Pass Travel” policy is under Travel Policies (in the left panel) of the Travel page on Flying Together.

***Form 1099-MISC Box 7 vs. Box 3*** ~ Tax filing information for retirees who received a 1099-MISC from United for pass travel. If you did not receive a 1099-MISC from United, you may ignore this article.

***Using box 7 instead of box 3 will cost retirees more in taxes:*** Like last year, United has placed retirees’ imputed income from pass travel in Box 7 “non-employee compensation” on 1099-MISC forms. Box 7 is normally used for vendors/contractors who accrue income by *performing a service* for United and it usually triggers the need to fill out a Schedule C and pay self-employment *and* Social Security taxes in addition to regular federal/state taxes. Retirees are ... retired, we do not “perform a service” for United and should not have to pay those additional SE or SS taxes or even fill out a Schedule C, right?

Unfortunately, **United Airlines will not change how it files nor will it amend the 1099-MISC forms.** I emailed Chris Kenny, United’s VP & Controller. He re-

plied, “Our reading of the IRS rules requires this be reported in box 7. The pass travel benefit retirees receive is in exchange for the service they provided when they were active employees and is not tied to the current year”. On the other hand, Mr. Kenny also stated: “I checked with our internal tax department and they indicated that there is no clear IRS official ruling on this matter.”

So, I called the IRS Help Line (800-829-1040, opt 1, 2, 2, 4, 1), asked for a “1099-MISC specialist” and waited approximately 60 minutes on hold. The agent could not find any ruling in the tax code about box 7 or box 3 for retirees. The agent agreed that retirees do not “perform services” for United so they should not have to fill out a Schedule C. **The agent then suggested retirees declare pass travel imputed income as if it was listed in box 3: Put it on line #21 of form 1040 and write “retired employee benefit” on the dotted line.** The IRS Help Line agent said that “could possibly” trigger an audit, but, in that unlikely event, retirees should explain they did not “provide a service” to United during the tax period, therefore the income should be in box 3, not box 7.

I have spoken to several retirees and they tell me:

1. When income is reported in box 7, **some tax software programs** will ask the user questions, then move it to box 3 and place the income on line 21 of form 1040.
2. **CPAs** agree retirees’ pass travel imputed income *should* be in box 3.
3. Conservative CPAs may advise clients to leave it in box 7 and pay the extra tax to avoid the possibility of an audit. Other CPAs advise box 3 with a note saying United is using the wrong box.

**Bottom line: Retirees should consult with their CPA or the IRS to determine the best method of declaring pass travel imputed income on their IRS tax returns.**

**Traveling on OA’s**

We are very close to becoming paperless when traveling on OA’s, next one on the list is Southwest (WN). **Please note this is a totally different process.**

Starting February 10<sup>th</sup>, eligible co-workers and retirees will purchase eTickets for themselves and/or their eligible pass riders to travel on WN by calling the United Pass Line (UPL). The UPL desk will list and eticket the pass riders on WN flights. This is a temporary solution while we work toward a self-service online solution.

Eligible co-workers and retirees will call 866-FLY-EPAS (359-3727) when dialing within the United States,



or 713-324-PASS (7277) when dialing from an international location. Select the option of "Other Airline Employee" and you will be connected to an agent. You will be advised of the \$25 booking service fee (BSF), however for WN eTickets the BSF will be temporarily waived. Payments for WN eTickets will be pre-paid with a valid credit card/debit card.

**Refunds:** To request a refund of an existing paper ticket, the refund request form and instructions can be found on the Travel tab > Travel Programs > Other Airline/Interline Travel > Refunds (at the bottom of the page).

### **Correction To February 2014 - Ask The Pharmacist**



One of our members was unsuccessful when she tried to enroll in the My Medicine Cabinet on the Smartphone app. She was not able to obtain assistance to do so. Our Express Scripts contact investigated for us and her response follows.

*There are some aspects of the Mobile App that aren't available to members, depending on the type of prescription drug coverage/plan design the patient has. I wasn't aware of the limitation in our system. Due to a slight variation of the plan coverage, some members will have access to all aspects of the Mobile App and some will not.*

*I apologize for providing you an article that wasn't applicable to your entire population. Our folks are aware of the limitation and at this time aren't actively pursuing any changes at this time.*

### **Flight 93 Memorial Chapel by Frank Egges**



Over 7,000 visitors, including 12 members of the Philadelphia Independents attended the commissioning of the USS Somerset in Philadelphia on Saturday, March 1, 2014.

As this important ship was originally scheduled to go to Baltimore, we give thanks to Senators Edward Casey and Pat Toomey from Pennsylvania on their successful efforts to bring it to Philadelphia. The Somerset honors the passengers and crew of United Flight 93 and is named for the Pennsylvania County where Flight 93 crashed.

The commanding officer, Thomas L. Dearborn officially accepted command of the USS Somerset following the commissioning and 20 gun salute. At that time, two large metal doors opened on the side of the ship displaying large landing crafts supported by large cranes for easy lowering them to the water. The bow stem, the leading edge as the ship moves through the water was cast from tons of steel from the crash site. In addition to the officers, there are 360 sailors and Marines, 699 troops can be accommodated.

The ship has a 24 bed ward, two operating rooms and two dental operating rooms. Displayed on the top deck was a new tilt rotor MV22 Osprey.

Those attending the commissioning received a color magazine containing the names of the passengers and crew of Flight 93. In addition, names and pictures were listed on the bulkhead inside the ship. There was also a large 93 Memorial flag displayed.

We also received a red zip lunch bag complete with lots of goodies, complements of WaWa and Sheets. USS Somerset will be based out of San Diego, California. For further information go to the website [ussomersetcommissioning.org](http://ussomersetcommissioning.org).

For MetLife, it is easy to accomplish that only after you get an agent via a phone call to help you. Their website, [Met-life.com](http://Met-life.com), is confusing and hard to find which department you need. After you find the department you are seeking, you can get a phone number. Of course when you call that number all agents will be busy helping other customers. Stay on the line or you will lose your place, even though the line appears to be dead (no sound) someone will eventually answer and help you out. Here is a direct number for United retiree pensions benefits. It is: 1-800-638-5656, again, if they put you on hold stay on the line! MetLife will send you any documents you need after they are satisfied you are who you say you are! They will not allow you to print copies via the computer.

For the PBGC, it's fast and easy to update your profile through MyPBA. You need to set up a MyPBA account. Setting up an account is fast, free and easy; log on through their website [www.pbgc.gov/usingmypba](http://www.pbgc.gov/usingmypba). MyPBA is available to us 24 hours a day, seven days a week and our online transactions are safe and confidential. We can change our address, sign up for direct deposit, designate your beneficiary, print out your IRS Form 1099-R, change federal withholdings, view your payment info and more. One other thing, we might want to consider is to send the PBGC a copy

of a durable Power of Attorney. At some point, we may want or need someone we trust to deal with the PBGC on our behalf. A durable power of attorney authorizes another person to act for us even if we become mentally or physically incapacitated. The PBGC will not transact any business with anyone other than the employee unless they have a durable power of attorney on file. You can send a clear legible copy to PBGC/Benefits Administration and Payment Department. P.O. Box 151750, Alexandria, VA 22315-1750. For those of us who do not like dealing with computers and wish not to set up a MyPBA account, no worries, we can call PBGC customer service Monday - Friday 8:00am to 7:00pm ET. That number is 1-800-400-7242.

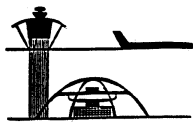

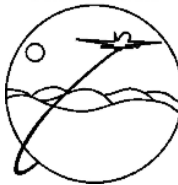

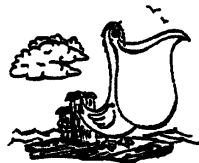

Other than that, I am waiting for Spring. This winter has been long and cold. I know we are not alone in this though.

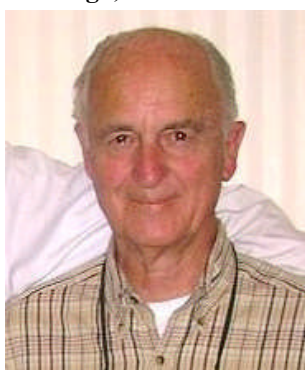

**Anton Leopold (Tony) Seidl** succumbed to the ravages of lymphoma at age 84. We will be holding a memorial service on Monday, 3/24/14 at 10:30 am at St Joseph's of Cupertino (<http://www.stjoscup.org/>, 10110 North De Anza Boulevard, Cupertino, CA 95014-2211 USA) with light refreshments to follow in the adjacent social hall. All friends are wel-

come.

We've lost our beloved patriarch, hero, and best friend, and our lives will never be the same. Tony's story was one of superlatives in overcoming the greatest of adversities, but this final assault proved too much for him. He is survived by his loving wife of 57 years, Helen Rose, his two admiring sons Francis and Vincent, his daughters-in-law Kathleen and Nathalie, his devoted grandsons Tony, Fritz, Vince, and Christian, his granddaughter-in-law Shannon, and his infant great-granddaughter Anna Catherine Seidl.

Tony's biography is a one-man illustration of the best that humanity has to offer. From humble origins at the end of World War II as a fourteen-year-old orphan with a mere 8<sup>th</sup> grade education in the most despised nation on the planet, he undertook creating a new life that would have made Horatio Alger proud. He was raised in Munich by his widowed mother, Anna Franziska Seidl, who was taken from him by pneumonia when he was only twelve. His older brother, Franz, was killed in action on the Eastern Front a short time later. Living then with an uncle and aunt (Fritz & Anna Seidl) and enduring daily bombing raids, he became an apprentice tailor while also occupying his time as a member of the bomb disposal squad and the fire department. In early May of 1945, he disembarked from the train transporting him to the Western Front, discarded his new military uniform, and walked home. During the post-war occupation, he taught himself English and won the competition to become the first foreign exchange student in a German delegation sent to the USA in 1949. His sponsor family in Youngstown, Ohio (the Witts) taught him about the states and helped him join the US Air Force, which put him to work in an aircraft support group at Brady Field in Japan during the Korean War. After the war, while stationed at Smyrna AFB, this dashing young man set his sights upon a southern belle (Helen Rose Floersh) at a Knights of Columbus dance in Nashville. After a 9-month courtship, they were married in 1956. He then accepted a job with Capital Airlines in Washington DC, where he also took courses at Georgetown and studied to be a UN translator. When Capital Airlines was absorbed by United Airlines in 1961, Tony brought his wife and two young sons (Francis and Vincent) to Cupertino, where Tony then committed to a daily commute to San Francisco Airport for the next 40 years. He continued to study languages at San Jose State University, adding French and Spanish to his linguistic repertoire, and also obtaining a masters degree in French Literature. At work, he progressed from a mechanic in United's sheet metal shop to become one of the company's world-renowned experts in composites, fasteners, repair procedures, and a host of other engineering disciplines.

After retirement, he worked on various consulting jobs, including Piramoon Engineering on ultra-high-speed composite centrifuges and NASA for the Sofia 747-based Telescope project. Tony continued to participate actively in the Knights of Columbus and Retired United Airlines Employees Association (RUAEA). He was also a tutor to his local grandsons, Tony and Fritz, teaching them both Latin and German, though he confessed to having disliked Latin while in grade school. An avid hiker, he enjoyed exploring the local coastal mountains as much as he had the Alps in his



youth. Tony excelled at oil painting and pottery, enjoyed documenting family genealogy and studying world history. He was known at times to go on at great lengths about topics such as why Germans still tell their children that the Swedes will get them if they don't behave (a lingering memory of the 30 Years War) or to explain the continuing importance of the conflict between the Ghibellines and the Guelfs.

Tony's friends and family will miss his encyclopedic knowledge of languages, engineering, history, and everything else, as well as his humor, nurturing attitude, boundless energy, and unwavering commitment to traditional Christian ideals.

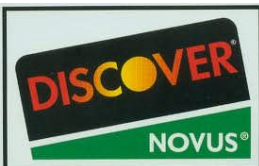

## United Airlines Historical Foundation



"Preserving the Past, Inspiring the Future"

In 1954, United Air Lines installed two Convair 340 and two DC-6 Simulators at the Flight Training Centers in Denver (Stapleton) and Chicago (Midway). The Convair 340 Simulator (shown below) was the first of four electronic "Dehmel Trainers" built by the Curtiss-Wright plant in Carlstadt, N.J. for United Air Lines.

The Convair "nose-sections" were purchased from Consolidated Vultee. The Simulator Cockpit was equipped with the same switches, pedestal, instrument panels and other flight controls used on United's "Mainliner" Convairs. In the Simulator, the crew heard the roar of engine speed increase or decrease, propeller-tip noise and in-flight aerodynamics. During landing, the "screech" of tires was audible.

The four Simulators were the first to be purchased by any Domestic Airline and the largest number of

simulators purchased by any Airline. They were the invention of Richard C. Dehmel, Chief Engineer of Curtiss-Wright's Electronic Division.

The four Simulators cost more than \$3,000,000 in 1954 dollars. They enabled United's Flight Training to proceed without the necessity of withdrawing Convairs & DC-6s from scheduled flights.

United continued using Link Trainers in addition to the four new Dehmel Trainers with three "Links" in Denver and two in Chicago.
