#### FROM THE PRESIDENT

### **GENERAL NEWS**

I regret I must inform you that Glenn Tilton will not be available to speak at our convention in Seattle, due to a major change in his schedule.

Our speaker will be John P. Tague who now serves as Executive Vice President - Customer for United at company headquarters.

John joined United May 2003 and is responsible for Worldwide Alliance, Marketing, UAL Loyalty Service, Advertising, Sales and Reservations. Prior to joining United, Tague served as President and Chief Executive officer to ATA Holdings Corp., America's 10<sup>th</sup> largest airline. He is doing some exciting new things to benefit our customers in the areas of marketing and sales. I think convention attendees will find his presentation exciting and informative.

Health Insurance - Since I talked to you last month the bankruptcy court made its selections of who will represent the nonunion, management & salaried retirees in the proceedings before the court on the matter of health care costs for retirees.

The members of the committee that were selected are: Mort Wax, Chick McErlean, Ed DelGenio, Ed Westervelt & Michael Richards. I will give you a short background of each of our representatives:

Mort Wax - holds a B.S. degree in accounting from the University of Illinois. He was manager of several departments during his career with United, Supervisor of Accounting & Manager of General Accounting, Manager of Capital Expenditures. He served RUAEA as chairman of the Audit Committee & four years as Treasurer. Mort retired in 1993.

Chick McErlean - retired attorney from UAL Law Department.

Ed Delgenio - retired attorney, spent his time with labor relations on contracts & system board cases.

Ed Westervelt - retired from EXOHR, primarily involved with contract negotiations & administrations of Flight Attendant contracts, long-time employee of Personnel.

Michael Richards - held several positions with United: Customer Service Representative, IR Rep in the Central Division, Station Manager in Sacramento & Reservations Sales Manager in Seattle.

Four members of our committee have labor relations experience; two are attorneys. The committee has agreed that Chick McErlean will be the chairman.

On Mar. 3 the committee met with the bankruptcy court trustee, was briefed on their responsibilities and the procedure that must be followed during these hearings. The immediate task of the committee is to select and hire legal counsel and thereupon, with assistance, select and hire financial analysts.

Formal commencement of negotiations with all committees and advisors is scheduled for Mar. 11, (but could be delayed a week or so to give us time to select and hire advisors). At that time the company will give an overview of why modifications to retiree medical benefits are necessary for United's reorganization and successful exit from Chapter 11.

The committee's position is that the company's financial material will be scrutinized; all of the attributes of the existing medical benefits plans will be identified, comparability with other company medical plans and outside purchase plans will be evaluated.

Our committee has decided to coordinate its activity with the retired pilots committee, but each committee will be represented by separate counsel, both to eliminate any impression that either group is influenced by the other, also to provide separate evaluation of the company material as well as the identification of different alternatives. Negotiating positions will be identified by the advisors, submitted to the committee for review - then be iterated back to company representatives for further negotiations.

The company's outside counsel indicated they are shooting for an April 30 submittal of a plan to

the bankruptcy judge.

The unions' representatives (IAM-AFA) have had their advisors in place for some time.

Bylaw Change - At the Board of Directors meeting in Seattle on Jan. 28, a motion was made to revise the RUAEA bylaws (Section 3, Associate Members) to allow associate members to vote and to hold office in all RUAEA activities. The motion was approved and you will be asked to vote on this revision at the business meeting at the convention on May 29.

As RUAEA becomes more proactive in retiree issues, I have appointed Tom Goodyear & Gordon Starr to review and rewrite the RUAEA bylaws for your approval. They will start at the top and would appreciate any suggestions you may have.

#### FROM THE EXECUTIVE VICE PRESIDENT

How are recent events affecting you?

Since I have retired I realized how certain events affect me. Especially life marker events like grandchildren, great grandchildren, selling the old place, moving to some retirement community, serious illnesses or the death of a family member or dear friend. I have redefined what is important. I view things differently. My priorities change.

Look what has happened over the past 15 months in things that affect us as retirees - the bankruptcy status of United Airlines; changes in our travel privileges; the unknown forthcoming changes in our medical insurance. What are the things we are talking about when we get together with other retirees? What's the content of our emails? Our views of United Airlines and its management, our relationships with other retirees and what is important to us in retirement, have been redefined.

We become very critical and outspoken about the company and its management. We complain about the pass service charges. It's the medical insurance - where we don't know the outcome - that we really become agitated, denouncing the company, castigating Glenn Tilton and rallying our fellow retirees in the cause. This is a very normal reaction on our part in these areas that affect us and threaten our well being. (Jim's letter in this issue

discusses the process currently going on in our negotiation with the company.)

As we participate in RUAEA activities - local chapters and the national organization - we view the purpose and function of RUAEA changing. Frank Murdock mentioned to me that it's very evident that RUAEA, in the past has been a great social organization, with very few serious challenges. In looking into the future, all that has changed - from an easy-going friendly organization to one where many problems have to be resolved.

As your elected Officers and Directors of RUAEA, we are doing the best we know how, representing you and your interests in these matters. We have met with Glenn Tilton five times over the past year discussing these issues; we have established RUAEA representation in WHQ; we are actively involved in the medical insurance negotiations; we are trying to keep you informed through the newsletter, Website, response to your e-mails, letters & meeting with you. Our focus is to keep things positive, channel our efforts and energies in productive ways, and achieve the most equitable solutions possible for our retirees, while assuring that in the process we don't provide any more impetus to "killing the goose that laid the golden egg" than already exists. We need your support in this.

In the annual business meeting in the SEA convention, one item of new business will be the changing role of RUAEA - to be an advocate of retiree interests and concerns. Important are your views on this matter, that they are expressed and reflected in the meeting. When the vote is taken, assure that your vote counts. (This alone is a compelling reason to attend the convention.) This will have major implications of the future of RUAEA.

# RUAEA BOARD OF DIRECTORS MEETING January 28, 2004

RUAEA will become more proactive in retirees issues and best interests.

The Financial Statements for the 4<sup>th</sup> quarter and year 2003 were distributed and reported to the Board. Audit for 2003 was completed satisfactorily.

RUAEA is financially solvent.

Progress report for the Seattle Convention of 2004 was given. Future convention site details were reported.

Motion made and carried to present at the May 29, 2004 Annual Business Meeting revisions to the RUAEA bylaws to allow Associate Members to vote and hold office. The addition of four newly appointed positions to the RUAEA organization which are a Denver Office Co-Manager, a Liaison with WHQ & two RUAEA Website Managers.

The slate of candidates for election was presented to the Board as well as a sample of the ballot, which will appear in the April Newsletter.

Over 10,200 Newsletters are now being mailed. The RUAEA Denver office now has an e-mail address that you can use for change of address, membership records, articles and items to be published in the Newsletter. ruaea@aol.com.

A reminder that the member's survivor will receive free Newsletters for two months after the death of a member, then must sign up for RUAEA membership to continue to receive the Newsletter.

Motion made and carried to accept Spectrum Data (RUAEA website developer) one year contract effective April 3, 2004 for \$6,900 to be paid quarterly.

Regional directors attended the Board meeting and turned in chapter reports for their respective regions.

We urge all of you to attend the Seattle convention.

#### **BYLAW CHANGE**

Present bylaw: Section 3 - Associate Members

Widows or widowers of Regular or Life Members may become Associate Members by paying the required dues. In addition, a spouse of a deceased retired employee, who was not a Regular or Life Member, may become an Associate Member by paying the required dues. A spouse of a deceased employee who at the time of death was eligible for retirement may also become an Associate Member by paying required dues. Exceptions may be approved by the Board of Directors. Associate Members shall enjoy the same privileges as

Regular Members except that they may not vote or hold office in the Association. They may continue membership if they remarry.

New bylaw to read: Section 3 - Associate Members Widows or widowers of Regular or Life Members may become Associate Members by paying the required dues. In addition, a spouse of a deceased retired employee, who was not a Regular or Life Member, may become an Associate Member by paying the required dues. A spouse of a deceased employee who at the time of death was eligible for retirement may also become an Associate Member by paying required dues. Exceptions may be approved by the Board of Directors. Associate Members shall enjoy the same privileges as Regular Members. They may vote and hold National office in all activities\_of the Association. They may continue membership if they remarry.

# NONSTOP SERVICE BETWEEN CHICAGO & HONOLULU

United is reinstating its daily nonstop service between Chicago O'Hare International Airport & Honolulu effective June 3, 2004.

Flights will be daily between CHI & HNL with Boeing 777 aircraft configured with 36 seats in First & 312 seats in Economy. Flight 001 will leave CHI at 10:15 a.m. & arrive in HNL at 13:45. The return flight #002 will depart HNL 16:25, arrive CHI 05:15 a.m.

The new CHI service will complement United's existing service to HWI from its other hubs in LAX, SFO & DEN. With 24 daily, nonstop flights from 3 hub cities in the U.S. to 4 Hawaiian Islands -- Oahu, Maui, Hawaii & Kauai -- United offers the most flights between the mainland & HWI.

United has been serving Hawaii since 1947.

#### NONSTOP SERVICE TO BERMUDA

United will launch nonstop, Sat. service for the summer season to Hamilton, Bermuda (BDA), from CHI O'Hare International Airport (ORD), on May 1, 2004, through Sept. 11, 2004, initiating the only nonstop flight in the market.

The new service will use Airbus A320s with 138 seats, configured with 12 seats in United First & 126 seats in United Economy. The southbound flight will depart CHI each Sat. at 8:00 a.m., arrive Bermuda 13:29. The return flight will depart BDA Sat. afternoon 14:29 & arrive ORD at 16:15.

I feel strongly that many of the retirees & active-duty employees of United Airlines would benefit from the publication of the following article:

#### FREE HEARING AIDS, ANYONE?

A little known & seldom used provision of the United Airlines Medical Benefits program for both active-duty personnel & retirees, is the fact that United, through their associate organization, Illinois Blue Cross/Blue Shield, will reimburse a claimant for up to \$5,000 for hearing aids purchased since 6/14/02.

Reference is made here to United Airlines medical benefits document dated 6/14/02 which announced several changes to the United Traditional Medical Plan. Under "Traditional Medical Plan Before-Medicare Coverage," specifically paragraph 4 of said document, is the following statement:

"Annual hearing aid examinations, prescribed hearing aids & batteries for hearing aids will be covered under the Traditional Medical Plan. Expenses incurred on or after 7/1/02 are payable from the Plan at 100%, without satisfying the annual deductible, up to a lifetime payment of \$5,000 per person."

The document is signed by Virginia Grady, Director of Benefit Programs.

Being the user of two hearing aids which were becoming somewhat decrepit, it entered my mind to inquire if it would be possible to spend the **entire sum of \$5,000** to replace both of my aids. A call to United Airlines Medical Benefits representative elicited the reply that, as far as United was concerned, I could spend \$5, \$50.00, \$500.00 or \$5,000 at any one time.

I went to my local hospital which has a non-profit hearing aid clinic (this is the least expensive approach to getting hearing aids, as opposed to some of the private companies which charge a healthy profit on their wares), ordered 2 each top-of-line 16 channel digital hearing aids at a total of \$5600.00.

When I presented the bill to Illinois Blue Cross/Blue Shield, they were shocked & refused to

reimburse me, stating that I was the first (and would surely be the last) claimant of \$5,000 for hearing aids. I told them that the reimbursement information was gotten from a United Airlines Medical Benefits brochure. I had to fax a copy of the applicable brochure page to Blue Cross/Blue Shield in order to prove to them that I wasn't kidding!

Weeks & weeks passed, with no action on the matter. Several phone calls only told me that my "case was being worked on", and that I "probably would be paid". Evidently everyone hoped that I would go away. I even received an Explanationm of Benefits (EOB) statement from Illinois Blue Cross/Blue Shield telling me that my claim was denied.

The upshot of the entire matter was that 3 months later I finally did get a reimbursement check to the amount of \$5,000 from Illinois Blue Cross/Blue Shield. It would seem that United Medical and/or Illinois Blue Cross/Blue Shield will still reimburse claimants to to \$5,000 for hearing aids. To this date I have never seen or heard of anything in writing which would change the terms of the United Airline Benefits document of 6/14/02.

At this point, I must need to issue a legal disclaimer and tell you that I am not dispensing legal and/or medical advice. If you go for the full amount of reimbursement, you will be fought at every step of the way, for no one wants to pay out \$5,000 unless they absolutely must. Believe me when I say that it was a long, hard, uphill fight, all the way to the end! Don't let anyone try to tell you "that's not he way it works....blah, blah." If stated otherwise, someone is letting themselves in for a court suit with a possible legal charge of misrepresentation!

If you do not have a copy of the mentioned United document dated 7/14/02, feel free to contact me & I'll send you a copy.

Since moving to CA I really do appreciate the Newsletter, especially since I do not have a computer. I really miss those monthly breakfasts that we had, mostly the camaraderie.
