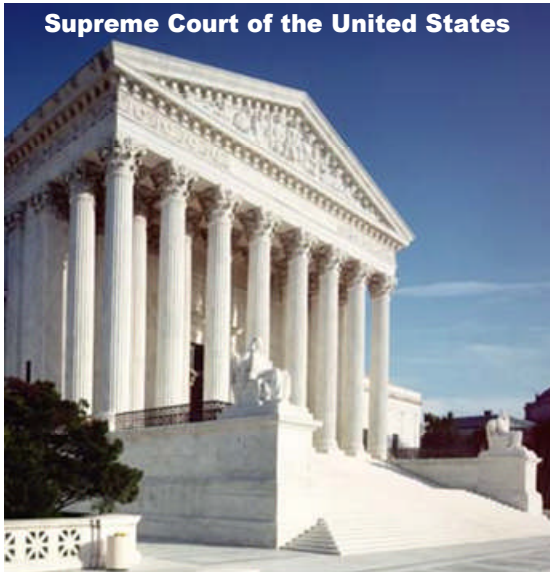

## **FROM THE PRESIDENT**

Since I was elected President of RUAEA, about two years ago, I have been writing an article for the newsletter every month. Because of the bankruptcy of United Airlines many of them have been focused on the issues relating to this dilemma, the interests & concerns of us retirees. We, the whole staff & officers of RUAEA, have been committed to keep you informed about these matters; we – especially Ed Tolle - have been working with the principals in WHQ resolving individual problems you are experiencing & in the larger scope, general problems & issues affecting retirees.

I have been a member of RUAEA since I retired in 1993. I was a member of the Chicago Skyliners; plus coordinated the involvement & participation of retirees in working on temporary assignments for the company also volunteer activities with & for the company. Since we moved to FL for the winters Marilyn & I have been members of the Real McCoys. I have been an Officer or Director of RUAEA for the past 8 years. I personally have found my membership in RUAEA & local chapters to be very enjoyable and personally rewarding. I have been able to continue my association & relationships with many fellow retirees I worked with; plus I have become close friends with many more retirees who I have met thru RUAEA. I value that association. Plus, when United Airlines filed bankruptcy we – RUAEA- established a formal collaborative relationship with the top officers of United focusing on matters affecting & relating to retirees. This is an important & critical role for RUAEA.

This has been the focus & concentration of my efforts as your President, formerly Executive Vice-President. Then something personally occurred in our family on Dec. 23. Marilyn & I traveled to Denver to celebrate Christmas with our family. On Dec. 23 Marilyn suffered a stroke. She was hospitalized for a month; had out-patient therapy for another month before we were able to return to FL. We returned to FL in late Feb. We are now in our own home. We are engaged in a simple, structured consistent program of therapy & rehabilitation. We are doing pretty well. We will recover.

What has overwhelmed both Marilyn & me is the out-pouring of concern, affection & prayers from our fellow retirees and members of RUAEA. Many chapters we have visited over the past 4 years sent cards and notes. She received individual cards, telephone calls & emails from so many of you. These spanned the Mainline from San Diego to Boston, Seattle to Florida, plus all the places in between. I really began to realize how wide-spread & close-knit our organization is. It is times like this when we really appreciate & value the friends and relationship we have through RUAEA. This has had a great impact on Marilyn – and me. It makes difficult times easier. Your expression of care, concern, the bright side of things plus your prayers mean so much to us; and are aiding us in our road to recovery. It has made a difference.

As a final comment, and I wish I could do this personally, I thank every one of you. This personal experience has made me even more proud to be a member of the Retired United Airlines Employees Association.

## **UNITED TO ADD 32 FLIGHTS FROM DENVER**

United Airlines plans to add 32 more flights from Denver by June, a 4% year-over-year increase, following moves by competitors Southwest & Frontier Airlines to increase flights.

United & its regional operation United Express will add flights on its existing routes, including DEN to BOS, Baltimore, NY-La Guardia, LAX SFO & St. Louis. Ted will add flights on its existing routes to LAS, RNO, & Ontario.

With the additions, United will have 455 daily departures from DEN, a 7% increase from its current schedule.

## **LATIN AMERICA OFFICE MOVED FROM MIAMI TO MEXICO CITY**

United moved its Latin America Sales & Marketing office from Miami, where United has scaled back service, to Mexico City, an increasingly popular destination for United customers.

Moving our office to Mexico delivers the very clear message that Latin America, particularly Mexico, remains important to United.

The Mexico City office will also handle general administrative responsibilities for United's Latin America service.

United now offers 91 weekly flights between our U.S. hubs & Mexico – including 42 flights to Mexico City & 49 flights to 4 Mexico beach destinations.

Cuddeback said that when flying into Elko, he had to dive the C-6 Swallow to gain enough speed to clear the 8000 ft. mountain peaks. Installing the "Whirlwind" J-4 engines solved that problem. By late 1926, Salt Lake City had replaced Elko at the route's southeast end. Varney Air Line's first fatal accident occurred April 15, 1927 on a flight between Salt Lake City and Boise, killing Pilot William E. Sanborn. Following this accident Varney contacted Lloyd Stearman with his thoughts for a better mail plane.

Early in 1929 Varney began replacing the Swallows with Stearman's new 525 h.p. Cyclone M-2 "Speedmail". This plane had 91 cubic feet of cargo space, carried a thousand-pound payload and cruised at 125 m.p.h.

Varney had continued to bid for additional C.A.M routes and in 1929 was awarded the route linking Portland, Seattle & Spokane to his Pasco, Boise & Salt Lake City route. Varney Pilot Joe Taff flew the inaugural flight on this route in mid-September 1929. Taff said that the forest-fire smoke was so thick that he couldn't see the recently-installed beacons along the Columbia River Gorge.

### **TRAVEL DESK – PDX & SEA**

Both Travel Desks in PDX & SEA are having security authorization problems with the computers - somehow sometimes we may not be accepted or recognized as an entity in the United family - maybe just plain over looked. We are present as volunteers, however, we may not be able to service your

calls with the information you are seeking - companion or retiree service charges, Interline information & discounted items.

Principally the internal service Skynet is not available. We are trying to search out where & with whom to correct this problem - that we are a viable entity. The SkyNet version on your home computers is NOT affected!

The basic Apollo has been out-sourced, we are going through the problems until the new folks learn the system & who is who.

A couple of our "snow-birds" have returned to the home nest so they have lost their profiles after some months absence. We have learned how to circumnavigate this problem, at least for the moment. We are back up to full force to take your listings for flights & give you load information..

To all of you who have **Apollo**, perhaps through CompuServe, **do keep your password current**. If you are an infrequent user "sign-in" once a week to maintain your use of Apollo. If you cannot sign-in now, you are **OUT** & will **NOT** be allowed back as a Retiree, for what are called "security reasons." Active Flight Attendants & Pilots will not be affected at the present time. When Pilots & Attendants do retire they will lose access to Apollo. This is our understanding presently.

Apollo will be phased out (termination time is unknown), a new system will be put in-place, perhaps something similar to "fast-air" that has preprogrammed entries.

We appreciate patience & understanding if we are unable to give the information you desire. We expect to solve our SkyNet authorization sometime next week. Continue to call us and we will do the best we can at that time.

As a Second Generation United employee, I keep reading about some of you who were the "early pioneers" of United so I decided it was time to write something about my father, Carl Krebs, in hopes that some of you out there might remember him & get in touch with me to say hello. (I know Jo will remember him).

In the 1960's I asked my Dad to write some of his experiences for me. The following is verbatim from his hand written notes.

I enlisted in the Army Air Corps in July 1917. Went overseas in March 1918. Served 14 months in France as Motorcycle Dispatch Rider. There were no radio communications in those days and telephone services were often interrupted, especially close to the front. Carrying messages by motorcycle was the fastest & most dependable method of communications.

Returned in May 1919, arrived at Mitchell Field.

Re-enlisted for one more year. While stationed at Mitchell Field on 7/5/19, I delivered the films of the Willard Dempsey fight pictures to the New York Herald paper in New York City. These pictures were flown from Toledo Ohio (scene of the fight) to Long Island.

In Aug. 1919 was transferred to Langley Field, VA & was assigned to The Headquarters Flight 2<sup>nd</sup> Observation Wing. From that time until May 1920 I put in all my time as Sgt. in charge of the line. We had 6 DeHaviland Liberty Engine planes & 3 Lincoln Standards. Line work consisted of maintenance, servicing, trouble shooting & periodic checks. Mechanical instruction manuals were very limited, most mechanical knowledge had to be obtained the hard way.

May 1920 finished my 2<sup>nd</sup> hitch in the army. That fall the Transcontinental Air Mail Service was started under the post office dept. I started as a mechanic in Dec. 1920 at Cheyenne, WY. We were

using army surplus DeHaviland Liberty Engine planes. These planes were rebuilt by airmail service mechanics at Maywood IL Repair base. These planes carried about 350 pounds of mail, no passengers except occasionally a mechanic in the mail pit. A cruising speed of approx. 100 mph. No radio equipment or navigation equipment except a magnetic compass. (They followed the railroad lines). From Cheyenne east, we had fields at North Platte, Omaha, etc. West; Rock Springs, Salt Lake, etc. Due to strong prevailing west winds the majority of the westbound planes had to land at Rawlins to take on fuel. March 1921 it was decided to open a regular field at Rawlins for a westbound plane to stop regularly. I was transferred to this field as field manager to supervise the clearing of sage brush off the field & building of a hangar large enough to store one spare plane, a repair shop, stock room & office. This was completed fall of 1921. The air mail service only survived those early years with the help of the town's contributions. Congress appropriated only one million dollars a year to finance the operating of the entire transcontinental for that fiscal year. (The post office dept. was very creative about getting the money to pay the airmail employees.

There were no starters on plane engines in those days. To start the engine we had to pull the propeller through by hand. It could be done by one man, but this was a dangerous procedure. Usually 2 or 3 men would join hands & pull the propeller through. A hard way to start the engine especially in cold weather.

On 9/12/22, the east bound plane out of Rock Springs developed engine trouble & landed on a dry lake bed west of Wamsutter, approx. 60 miles west of Rawlins. The pilot flagged a Union Pacific train & rode on to Rawlins. The pilot & I flew the reserve plane to the downed plane, transferred the mail to the reserve plane & proceeded to Cheyenne. I had a date in Rawlins that evening with my future wife which I could not have kept unless I flew the plane to Rawlins, which I did. Having never had any flying training I made the flight ok. The next morning the superintendent at Omaha advised that I would make no more unauthorized flights. I almost got fired, but later was offered to fly as a reserve pilot. I didn't accept as I was always more interested in the mechanical part of the service.

On Jan. 1923, I was transferred to Rock Springs. (This ends Carl's notes)

Carl left the Air Mail Service in 1925. The Air Mail Service officially came to an end 8/31/1927, when the government turned the operation over to private enterprise. In July of 1927 the San Francisco-Chicago leg was turned over to Boeing Air Transport Inc., the predecessor of UAL.

In 1929 Carl & his wife, Macey, moved to Cheyenne where he started his career with United. As a mechanic, Carl wore white overalls. His always had to be spotless & Macey spent hours washing, bleaching & ironing. In 1940 he transferred to DEN. In 1941-43, he traveled for the government, with United & trained Army personnel in Canada to do maintenance work on government planes. In 1943 he became part of the Air Transport Command. This was part of the group he trained earlier. He started with the rank of Lt. & later Captain. The Air Transport Command was part of the airlines, but even though civilians they were considered part of the Air Force. He flew all over the South Pacific as a flight engineer. He recalls hanging his jacket over the empty fuel gage so they wouldn't have to watch it when no island was in sight. They always made it. His group was on Guam, Iwo Jima, Guadacanal, Sipan, Okinawa, as well as in and out of Australia & Hawaii. After the war Carl transferred to Hawaii when United started service there. It was there he retired in 1960. He passed away in Denver, 1/9/73.
