Camelback Mountain

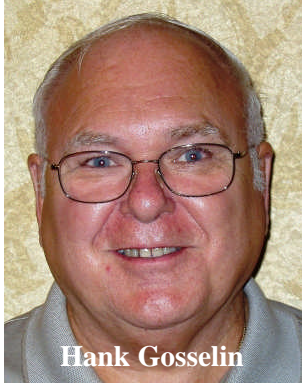

Life Insurance Benefits

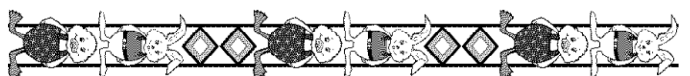

United Bolsters Its Service to Australia

With the introduction of United International Premium Travel Experience on all flights to Australia - from Los Angeles (LAX) and San Francisco (SFO) - United's first and business class customers traveling "Down Under" now enjoy a more comfortable and relaxing flight on United's B747.

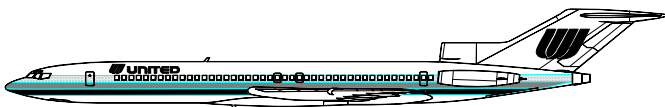
The new, international lie-flat first and business class seats provide customers with the optimal space to work, sleep or relax while traveling between the U.S. and Australia.

"The multi-million dollar investments we are making in our international aircraft provide our customers with a more comfortable and relaxing way to fly," says Dennis Cary, SVP and Chief Customer Officer. *"Australia is a pivotal part of United's network, and we look forward to building on our 23 years of serving this market with competitive fares, an unmatched frequent flier program and a new level of both first and business class service."*

The U.S. and Australia route will be increasingly competitive, as Virgin Group start-up V Australia this month joins Virgin Blue and Qantas in offering service to Australia. V Australia began daily flights between Sydney and Los Angeles on February 28, three months later than originally planned because of aircraft delays. It will begin three flights a week between Brisbane and LAX on April 8. In July, Delta also is expected to enter the market.

Through its hubs in SFO and LAX; United offers Australia customers more destinations across the U.S. than any other airline. United and United Express has 185 daily departures to 57 destinations; that's 67 more departures to 25 more destinations than American, the next-largest carrier at LAX. Delta offers flights to fewer than half as many nonstop destinations.

From Sydney, United's codeshare agreements with Virgin Blue and Air New Zealand enable its customers to connect to 11 cities in Australia and New Zealand; from Melbourne, customers can connect to four cities.



Flight of the Oscars

A Hollywood icon - the Oscar statuette - was one of United's important cargo customers last week: United flew nine packages of the gold, 13.5-inch-tall awards on UA Flights 109 and 121 between Chicago O'Hare (ORD) to Los Angeles (LAX).

United ORD freight facility team handled the 428-pound Oscar shipments using United Cargo's small package delivery (SPD) service - its most reliable, fastest premium cargo service. As with any award winning-performance, United would like to acknowledge those who made this possible. At O'Hare, this includes Lisa Cole, customer service specialist; Bob Chance, cargo expeditor; Chris Kriz, planeside resource supervisor; Kristen Gerulis, cargo supervisor; Jackie Denofrio, cargo manager; and the Swissport team; and at LAX, Adam Cooper, cargo operating manager.

United is the official airline of the Academy of Motion Picture Arts and Sciences, which sponsors the annual Oscars ceremony. The 2009 Oscars event took place on February 22.

British Airways Now Offering Enhanced Travel Privileges to United Employees and Retirees

Effective February 24th, United employees, travel eligibles and retirees will have access to Zonal Employee Discount fares (ZED) for economy pleasure travel on British Airways (BA) and any BA-operated CityFlyer, Sun-Air and Comair Flights.

As British Airways is the United Kingdom's largest international scheduled airline, this agreement significantly expands the number of destinations available for pleasure travel. *"We are pleased to announce this significant addition to the offline travel program,"* says Peter Hammer, managing director Worldwide Sales. *"Our employees around the world have asked for this and, with the inclusion of British Airways and selected affiliate carriers, the agreement adds a number of geographies and destinations to our rapidly growing pleasure travel portfolio."*

Over the past 12 months, United's pleasure travel program for employees has doubled in size. ZED pricing is designed to simplify and significantly reduce the cost of non-revenue, space-available interline pleasure travel. ZED fares are offered through an interline fare program used by many carriers worldwide for space-available travel, replacing industry discount (ID) 90/95 fares for interline travel on specific carriers.

Credit & Debit Cards Accepted for Inflight Purchases Beginning in March

United made the search for exact change a thing of the past on March 23, when customers were able to use credit and debit cards for onboard purchases.

After a brief transition period through the spring break holidays, United phased out cash and only accept credit and debit cards on flights within the United States (including Hawaii) and on flights to and from Canada, Mexico, Central America and the Caribbean. United will continue to accept cash in addition to credit and debit cards on flights to and from Europe, Asia, the Middle East and South America. The change does not apply to United Express flights, where cash will continue to be the accepted form of payment.

"Our customers have responded very positively over the past year as we tested credit and debit card purchases on many of our flights, including transcontinental routes," says Alex Marren, SVP- Onboard Service.

Customers, as well as employees/retirees traveling non-revenue space-available or positive-space, will be able to take advantage of EasyPurchase using major credit cards, including Visa, MasterCard, American Express, Discover, and Diners Club, and debit cards bearing the Visa or MasterCard logos.

In addition, users of Mileage Plus Visa cards from Chase - including employees -- will earn 10 miles for every dollar spent on inflight purchases. Travelers who apply and are approved for a Chase Mileage Plus Visa card using the exclusive onboard application will earn 30,000 Mileage Plus bonus miles and receive 25 dollars off their next United ticket, after their first purchase.

The Battle for Australia

"Australia is part of United's DNA," says Mark Schwab, VP-Pacific, in an interview with "The Australian," the country's national newspaper, on the eve of greater competition beginning in the Australian market. Recently, Virgin Group start-up V Australia launches service from the land "Down Under," while Delta is preparing to enter the market later this year.

Mark says United will use its experience in the highly competitive U.S. aviation market to battle new competitors across the Pacific.

"We know how to hold our own, and we're certainly going to fight for our position in the Australian market," says Mark. He points to United's customer-pleasing reconfigured premium cabins offering First Suites and lie-flat business seats, in addition to a superior route network, with United's hubs in Los Angeles and San Francisco offering more daily service to more destinations across the U.S. and North America than its competitors.

The rallying cry to win Australia is echoing throughout United's operation.

"This is a call to arms, and we're fired up," says Jack Paluska, SOC manager at our LAX hub. *"We can't understate the importance of our team performance in this market. Together, we can beat the Virgin Australia competition through service excellence."*

Cross-divisional teams are working more diligently than ever to ensure top-notch performance, with a focus ranging from on-time performance and improved cabin condition to superior onboard service.

With Dignity and Honor

First officer Charles Schweiss, Jr., a lieutenant colonel in the U.S. Air Force, tells United about the outstanding service and dignity that the company provided for the final journey of USAF Captain Levi Torkelson, who was deployed three times in the Middle East, awarded a Bronze Star for heroic actions in Iraq and later served as an instructor at the Air Force Academy. Levi, who was killed in a car accident, received full military honors as his body was returned to Denver.

"Levi's parents delayed the funeral service and burial until his brother, who was driving the car at the time of the accident, recovered from his severe injuries. The family had Levi flown into Denver on February 4, 2009. Five officers and I were selected as the military honor guard detail. As a DCA B777 First Officer for our airline and fellow Air Force officer, I wanted to ensure all went well for Levi's return to the Air Force Academy."

"Denver Regional Flight Office First Officer Dave Giles alerted all parties of Levi's flight, and to fine tune Levi's arrival, I spoke with Bill Kennedy, Southwest Region domicile business manager, and Captain Bebe O'Neil. We wanted to ensure Levi's arrival and transfer received the dignity he deserved."

"Our honor guard detail drove from the Air Force Academy in a van and received police escort on the airfield. As we approached gate B-21, I was overcome with pride at what I witnessed. A cast of many waited for the arrival of Flight 369. First Officer Matt Spenks took the lead that morning, and everyone from baggage handlers to managers was ready."

"I take great pride in serving our country. I also take great pride in knowing Team United recognizes the service of our women and men in the US military. And I take great pride in knowing I am part of a great airline. Please recognize the efforts of all our United Airlines employees who honored Captain Levi Torkelson."

Ask The Doctor –

SIS – What Is It? What To Do About It?

We need to CHANGE to eliminate or reduce SIS! Here are the major SIS lifestyle choices we need to eliminate or reduce NOW!

SMOKING: The one single SIS that has accounted for almost all the premature deaths from lung cancer and chronic lung disease. It is the one SINGLE most impor-

tant SIS that accounts for excessive upper and lower respiratory disorders that fills ERs and Urgent Care facilities in the winter months. ELIMINATE this SIS and the world would be infinitely healthier in as little as two years!

ALCOHOL: The one SIS that is the MOST important cause of drug abuse in the country and perhaps the world. No, cocaine and meth and marijuana and heroin are NOT the leading cause of drug abuse. ALCOHOL, by far, accounts for more deaths, excessive absenteeism from work, divorces, mental illness, serious medical conditions, loss of jobs, and almost every other major societal problem in the country. If we intervene, evaluate, and treat alcoholism, we will save millions of dollars in health care costs each year.

OBESITY: Fast becoming, if not already, a major medical issue not only for adults but for our children and even grandchildren. The availability of cheap fast food on almost every corner in our towns and cities has contributed significantly to this medical condition and has created an "epidemic" of monumental significance. "TV Dinners" are a very attractive way to feed our families for dinner – fast, minimal preparation – perfect for families with two working parents. BUT, high in fat and salt. The outcome is obvious – weight gain for ALL. The answer is simple – eat responsibly!

SLOTH: Another phrase is COUCH POTATO. We have remote controls to operate our widescreen plasma or LCD home entertainment centers. We have hundreds of channels to choose from on cable or dish networks. We surf the net. We sit for hours playing video games. Worse, our children and grand children DO THE SAME THING! We WATCH sports instead of playing them. We don't even walk up one flight of stairs in a mall or office building! We search and search for a parking space close to the main entrance rather than parking farther away and walking to our destination! The solution – walk about 4 miles a week as a leisurely pace, if you are medically able.

ISOLATION: It's much easier to send E-mails, TXT messages, or chat over YouTube or MySpace or webcams than it is to actually have a face-to-face interaction with our friends. We no longer need to have actual human contact to buy or sell items or interest to us. We confine ourselves to our own "space" and stare at a monitor screen. Have a healthy breakfast or a cup of coffee with a friend rather than sending an E-mail!

Addressing just these few examples of SIS will increase our state of health, alleviate much of our daily aches and pains, protect our body's vital organs (think heart, kidney, liver, brain), increase our vitality, minimize our periods of depression, and give us a real chance of greater longevity so we can enjoy our children and grandchildren more than ever. We can spend our income on travel, materiel needs for ourselves, and en-

tertainment for ourselves and our families, and NOT on drugs, hospital and doctor bills, and caregivers. In other words, we will have a much greater chance of a long, healthy, and rewarding life. GO FOR IT!

RUAEA Membership Dues Increase

**(Please Note that this policy is not effective until
JUNE 1, 2009)**

RUAEA, like any other organization that provides a service to its membership has to weigh the expense of providing the service relative to its income. Our source of income is primarily from membership dues and a nominal amount of income from savings accounts. Another source is from contributions, of which we are grateful. In view of the fact that our costs have gradually increased over the last ten years (since our last dues increase) we feel it necessary to make an adjustment. At our last Board of Directors meeting, an increase in dues was recommended. The recommendation was weighed and after due consideration the board approved a nominal increase. In addition to the increase, a multi-years' choice (*at a discount*) was also approved, for a limited period of time, and an option to receive both the web/internet and paper versions. The new dues structure (**effective June 1, 2009**) is as follows:

Domestic Members:

- * One year - \$25.00
- * Two years - \$45.00
- * Three years - \$60.00

Domestic and Foreign Regular members can receive the monthly RUEA newsletter either via the U.S. mail or the Internet (*usually available 3 weeks ahead of the mailed edition*). If you would like to have both Internet and US mail, you can get it for an additional \$5.00 per year. **NOTE:** The option of both paper and Internet is not available for Life Members. You can have one but not both.

Canadian Members:

- ☞ One year - \$45.00
- ☞ Two years - \$85.00
- ☞ Three years - \$105.00

Foreign Members:

- ✈ One year - \$50.00
- ✈ Two years - \$95.00
- ✈ Three years - \$120.00

Regular Members from Canada or Foreign locations may receive their Newsletter by the internet only at the Domestic yearly rates. **NOTE:** Once this option is selected, you cannot revert back to the paper Newsletter until the membership expiration date.

NOTE: The two and three year options listed above will be available for one time only beginning **June 1, 2009** and ending **June 1, 2010**. After that, the dues structure will revert to one year increments.

Proposed Amendments to By-Laws

Following are the proposed amendments to the RUEA By-laws.

The explanation for the proposed changes are shown in "*italics*" and the amended By-law shown below. As stated in the By-laws Article XII, amendment of these By-laws must be publicized in the Newsletter at least thirty (30) days prior to voting by the membership at the Annual Meeting. All members present at the Annual Meeting in Phoenix, AZ on Saturday, May 23rd, 2009 will vote on these changes.

ARTICLE III - MEMBERSHIP

This amendment combines and incorporates Section 3 into Section 1 and eliminates the wording pertaining to Associate Members. After approval, Associate Members become Regular Members.

Section 1 - Regular Members

All former employees of United Airlines who have reached retirement age are eligible to become members of RUEA. Spouses of retirees may become a regular member. All may do so by making application and paying the required dues. Widows or Widowers of deceased Regular Members will become Regular Members until the deceased retired employees' Membership expires. At this time Regular Membership may be continued by paying required dues. Widows or Widowers of Life Members may become Regular Members by paying the required dues. In addition, a spouse of a deceased retired employee, who was not a Regular or Life Member may become a Regular Member by paying the required dues. A spouse of a deceased employee, who at the time of death was eligible for retirement, may also become a Regular Member by paying required dues. Spouses who become Regular Members may continue membership if they remarry. Regular Members may vote and hold National office in the Association. Exceptions may be approved by the Board of Directors.

ARTICLE IV - DUES

This amendment removes the words "and Associates".

Dues shall be payable by Regular Members 12 calendar months from the date, dues were last received. Dues amount shall be established by the Board of Directors.

ARTICLE VII - OFFICERS AND DIRECTORS

This amendment states the appointed staff will be members of the Board of Directors

Section 1 - Board of Directors

The control of the affairs of this Association shall be vested in a Board of Directors consisting of all Officers, Directors and Staff listed in this Article VII of the By Laws, whether elected, appointed or selected. A majority of the Board members shall constitute a quorum at any meeting.

This amendment adds the Chair Person of the Site Selection Committee to the Board of Directors

Section 16 - Chair Person of the Site Selection Committee (Appointed)

The person responsible for guiding the Site Selection Committee and establishing the criteria for which it functions in the planning and selection of convention sites. Oversees the site selection process and is responsible for negotiating site contracts. This person is appointed by the President with advice and consent of the Board. He/she will report to the Vice President of Conventions.

ARTICLE XI - ALLIANCES

This amendment removes (Section 16 United Airlines Historical Foundation) from Article VII and places it in Article XI Section 1. Additionally the wording of Section 1 is amended to clarify Board Status and responsibility for expenses

Section 1 - United Airlines Historical Foundation

The United Airlines Historical Foundation will be independent of RUAEA. The purpose of the UAHF is dedicated to: "Preserving the Past, Inspiring the Future", provide scholarships and maintain a collection of historical memorabilia. The President of UAHF is invited to sit on the RUAEA Board of Directors for the purpose of fostering communication and cooperation. The President of the UAHF is a non voting member and attends the board meetings without expense to RUAEA. Exceptions to this section may be made by the President of RUAEA with the concurrence of the Board of Directors.

This amendment rennumbers (Dissolution of RUAEA) to Article XII and (Amendment of these By-Laws) is re-numbered to Article XIII.

ARTICLE XII - DISSOLUTION OF RUAEA

ARTICLE XIII - AMENDMENT OF THESE BY-LAWS

Lloyd O. Goto and I worked together as shop mechanics in the old auto shop in the Stearman-Hammond building at the north end of the MOC in the 1960s. Lloyd was a very modest, private guy who kept his feelings pretty much to himself, but he and I hit it off from the start. We spent many a lunch hour together sitting in a company pick-up truck, talking about hundreds of different things. Lloyd would occasionally bring Sushi to me, enough for my entire family, which his mom had made for us. He also shared with me a lot about his life.

Lloyd was a second generation Japanese-American, or Nisei, who had lived in Los Angeles as a boy, where I believe his folks owned a small restaurant. During the dark early days of WWII, the US government, fearful for national security, rounded up thousands of Japanese, including Lloyd and his family, and shipped them off to internment camps around the country. Lloyd's family was sent to Colorado. As a result, they lost their business.

As the war progressed, Lloyd, by then in his late teens, was asked, along with many of his friends, if he would like to join a special group in the Army to help win the war against the Axis Powers. About 3800 accepted and were sent for infantry training. Their outfit was made up of mainland and Hawaiian-born Nisei, who became known as the "Fighting 442nd." Their motto was "Go for Broke!" They were sent to Italy, France and Germany where they distinguished themselves as being the most highly decorated military unit in the history of the US Armed Forces. After his discharge, Lloyd returned to Colorado, and eventually learned the body and fender repair business. In 1957, he applied for a job with United Airlines, where I met him in the early '60s at SFOMB. We worked together for several years until Lloyd was promoted to the position of foreman. Several years later, he chose to return to the mechanic trade. He finished his career in the 1990s at the SFOGQ auto shop. Meanwhile, I was promoted to instructor and spent the last ten years of my career in maintenance training at SFOMT, retiring on January 1, 1988. 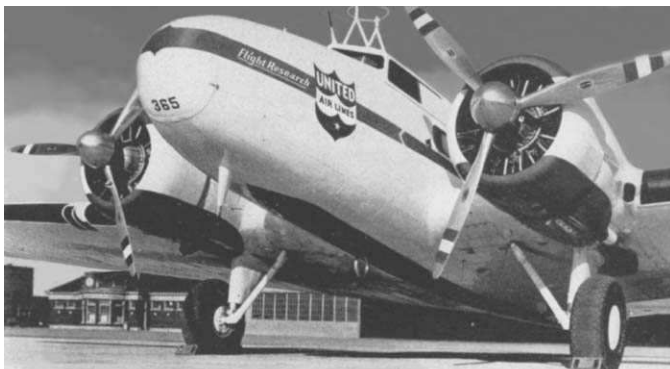

"Preserving the Past, Inspiring the Future"

Pilots and electronics technicians knew radio static had to be conquered, but nobody knew what caused it. Bert Ball, a United pilot, tackled the problem in his spare time.



Ball was a former sea-faring navigator and had studied Aerial Navigation and Air Mass Meteorology at Massachusetts Institute of Technology. In his pilot's reports, he often made observations about storm activity

that were so good the airline's weathermen saved them.

He proposed taking Professor Marcus O'Day of Portland's Reed College along with him in an airplane to hunt storms. O'Day had spent weeks at a time gathering storm data on the summit of Mt. Hood. When Ball's managers thought it was too risky, Ball sent some copies of his in-flight weather reports to Pat Patterson.

Patterson said, "This fellow is on the trail of something, let's give him a plane for a while".

Ball and Herbert Huckle gathered a crew of five college professors and five radio experts from outstanding laboratories around the country. Day-after-day for three months they sought storms in their flying laboratory. It was discovered that the metal airplane itself was the cause of high-voltage electrical discharges that burst from the plane's wings and other trailing edges.

Ball and Huckle dangled trailing wires from these edges, the static discharged itself and the radios worked perfectly even in the worst storms. Unfortunately the cables tended to whip-off in flight. They then discovered that a 10-inch metal strip would discharge the static.
