### Letter From The President

As I write you this month, again there will probably be important news released by the time you get this Newsletter. The new Pass Travel Policy should have been released before the end of March. Most if not all of the new policy will not become effective until January 2012. As soon as the new policy is made

public, you will see it on SkyNet and we will post it on our website [www.ruaea.org](http://www.ruaea.org). Checking our website frequently is a great way to keep up with new happenings. You also might be surprised with some of the links we have available to you. Again, if you do not have a computer, get a friend who does or check out what you can do at your local library.

On February 3<sup>rd</sup>, your Board of Directors had their Winter Meeting in Portland at the convention hotel. The Marriott Waterfront is a very nice and accommodating facility. We look forward to another great convention. Your Board of Directors approved the submission of a By-laws change that will allow anyone who has worked for Continental Airlines and is of retirement age to be eligible to join RUAEA. This will be voted on by the members at convention.

On February 17<sup>th</sup>, there was a Retiree Leadership Luncheon Meeting held at what us "old-timers" knew as EXO. The luncheon meeting was brought about by the company and had representatives from the major retiree organizations from both United and Continental. A recap of that meeting follows.

I know everyone is eager to know about the much advertised February 17<sup>th</sup> meeting. The event was hosted by Donna Towle VP-Human Resources, Employee Relations along with a couple from her staff, Mary Luzader and Penny Thomas. The attendees were: Ron Jersey and Phyllis Cleveland from RUPA, Mickey Manfre and Don Popovich from ARECA, Gary Humphries and Bill Chambers from Golden Eagles, Barbara Vincent and Christel Ilg from Clipped Wings, Judi Jagger and Ann Wall from the Golden Penguins, Georgia Neilsen from RAFA, Jackie Monilaw of the Chicago Mainliner Club and Hank Gosselin, Ed Tolle and myself representing RUAEA.

It was a very positive meeting as we all got to know each other and shared background information. Donna is a very dynamic and energized person, she started her career with Continental as a customer service agent at LGA. Getting these groups together is a way of improving communications to the retiree community. Donna has a very positive attitude and comes across as a dedicated team player. All are quite interested in attending our Portland Convention and some have already made arrangements. There is strong interest from the leaders to get our organizations closer together. I believe that we will have an opportunity to work on this when we get together in Portland.

Of course, you all want to know what if anything was said about pass travel. Donna let us know that a final decision has not been made but they are getting close and all employees and retirees will be affected. She shared that it will not be the Continental plan, nor will it be the United plan, but a compromise of the two. It should be announced within the next few weeks. Some parts of the new plan could become effective right away but most of the new plan would not become effective until the first of the year.

We have let it be known that the leadership of the four major organizations, RUAEA, RUPA, ARECA and Golden Eagles are in agreement that our constituents want to see as much of the UA policy retained as possible and that boarding priority should be based on date of hire for all employees, retirees and their eligibles.

The merger process is moving along and the company appears to be on target to have the single operating certificate by year end.

Prior to the luncheon meeting, we were treated to a tour of the Operations Control Center. This is a very large room filled with teams monitoring all aspects of the daily operations. Most individuals had three to four screens in front of them to keep track of all flights around the world. All the areas of the daily operations were covered: maintenance by equipment type, dispatch, weather, crew scheduling (pilots and flight attendants), customer service, etc, etc. In a word "awesome!"

It was proposed that there will be future meetings to see how the company can assist the retirees as the new company moves forward and in some cases how the retirees can assist the company. All in all it was a worthwhile and positive experience.

### Recommended Amendments to RUAEA By-Laws

The RUAEA Board of Directors recommends the following amendments to the By-Laws in accordance with Article XIII - Amendment of These By-Laws.



## ARTICLE XIII - AMENDMENT OF THESE BY-LAWS

Amendments to these By-laws shall be passed by a majority of the Board of Directors prior to submission to the membership at the Annual Meeting, and must be publicized in the Newsletter at least thirty (30) days prior to voting by the membership at the Annual Meeting. A majority

vote is required. An amendment may be proposed by a member upon presentation to the President by January 1 in any year.

The applicable proposed amendments are either **bold underlined** (new) or ***bold italic*** (deletion). A brief explanation, in **bold underlined italics**, of the amendment/s follows each section.

## ARTICLE III - MEMBERSHIP

### Section 1 - Regular Members

All former employees of United Airlines **and/or Continental Airlines** who have reached retirement age are eligible to become members of RUAEA. Spouses of retirees may become a regular member. All may do so by making application and paying the required dues. Widows or widowers of deceased Regular Members will become Regular Members until the deceased retired employees' membership expires. At this time Regular Membership may be continued by paying required dues. Widows or widowers of Life Members may become Regular Members by paying the required dues. In addition, a spouse of a deceased retired employee, who was not a Regular or Life Member may become a Regular Member by paying the required dues. A spouse of a deceased employee, who at the time of death was eligible for retirement, may also become a Regular Member by paying required dues. Spouses who become Regular Members may continue membership if they remarry. Regular Members may vote and hold National office in the Association. Exceptions may be approved by the Board of Directors.

## ARTICLE VII - OFFICERS AND DIRECTORS

### Section 12 - Membership/Support Manager (Appointed)

Membership/Support Manager will be responsible to the Executive Vice President for RUAEA membership activities, automation support and Website functions. **Act as RUAEA Registered Agent to the State of Colorado.** Appointed by the President with advice and consent of the Board.

**Amend to allow the Membership/Support Manager, located in the Denver Office to act as RUAEA Registered Agent to the State of Colorado.**

### Section 13 - Newsletter Manager (Appointed)

Newsletter Manager will report to the Executive Vice President for all Newsletter management functions, including publishing and distribution. **Act as RUAEA Registered Agent to the State of Colorado. In the absence of a Newsletter Editor (Section 10 Newsletter Editor) the Newsletter Manager will be responsible for all editorial functions.** Appointed by the President with advice and consent of the Board

**Amend to remove the Registered Agent responsibility from the Newsletter Manager. Amend to make the Newsletter Manager responsible for all editorial functions.**

## ARTICLE VIII - TERM OF OFFICE

The term of office for all officers and directors shall be two (2) years and thereafter until their successors are installed. In an effort to maintain experience and continuity, no more than five (5) Regional Directors will be elected in any single year. With the concurrence of the Nominating Committee, officers and directors may run for **continual terms. a second term, but in no case may anyone serve more than two consecutive terms in a single position.** Officers and directors may be nominated, elected and serve in another office even though their current term has not expired. Upon election to another office, his/her office shall be declared vacant.

**Amend to remove term limits of office for Officers and Directors.**

### **Larger fleet opens utilization options**

The new UA's large fleet of 707 mainline aircrafts is providing more options for matching the right airplane to a particular route on our expanded network. For instance, starting February 17, United is be operating the Houston-Lima (IAH-LIM) route with a UA B767-300 instead of a smaller CO B757-200. The B767-300 can capitalize on cargo opportunities on the route, while also better meeting passenger demand with 29 percent more seats. In turn, the B757 gets assigned to missions more suited to its capabilities.

In the coming months, United will be redeploying more aircraft throughout the system, the EWR and IAD hubs in particular will see these changes occurring on some trans-Atlantic routes. United's reservations systems will soon be reflecting the following changes in aircraft equipment, for operations effective on the date shown:

- ➔ Effective June 9, IAD will add a second daily round trip frequency to the IAD-CDG market operated with CO B757 equipment.
- ➔ Effective June 10, the EWR-ZRH round trip



will transition from a CO B767-200 to a UA B767-300.

- ➔ Effective September 1, the IAD-AMS roundtrip will transition from a UA B777 to a CO B757.
- ➔ Effective September 29, the original IAD-CDG round trip will transition from a UA B777 to a CO B757.
- ➔ Effective September 29, the EWR-BRU round trip will transition from a CO B767-400 to a UA B777.

*“These changes don’t affect the total amount of flying we perform,” said Planning SVP Greg Hart. “We’re taking a fresh look at our existing network and fleet, and better aligning each aircraft type with the mission it is performing.”*

### **Fuel Council takes efficiency actions**



United’s Fuel Council met in February to review plans to reduce fuel consumption further. For example, the Boeing 777 Performance Improvement Package project makes subtle changes to the aircraft, such as installing smaller vortex generators on the wing, that can reduce fuel burn by one percent, or approximately 5 million gallons annually, once installed. The company has approved funding to install this package on UA’s 52 B777 aircraft; CO previously modified 22 B777s and shared the benefit of its experience with the UA team.

A fuel-efficient fleet is United’s best hedge against rising fuel prices. United also signed a contract with the International Air Transport Association to conduct a fuel efficiency gap analysis of both UA and CO in April so that the company can see how its performance measures up against the industry’s.

*“We need to look closely at opportunities to reduce our consumption safely, and our combined Fuel Efficiency Council is doing just that,” said Operations Planning-Fuel Efficiency Managing Director Joel Booth. “Our two airlines burn about \$20,000 of fuel every minute on average, so we’re looking at ways to reduce auxiliary power unit burn, lighten aircraft loads and fly routes more efficiently.”*

### **UA brings “kid rock” to the Oscars**

On February 25, 64 10-year-olds from Staten Island, N.Y., flew from John F. Kennedy International Airport (JFK) to LAX for the chance of a lifetime: performing at the 83<sup>rd</sup> Annual Academy Awards.

As the official airline of the Academy of Motion Picture Arts and Sciences, UA was proud to fly the chorus from Public School 22 and help make the weekend



special for these talented children. They received a celebrity welcome from Good Morning America, which featured the chorus’ departure from JFK on its morning program. In Los Angeles, the Academy featured the children’s journey on UA during its pre-show program on Sunday evening.

### **UA and CO finish top tier in 2010 A :14**

For the second consecutive year, UA finished first in on-time performance for U.S. domestic scheduled flights among America’s five largest global carriers.

UA finished 2010 with 85.2 percent of flights arriving within 14 minutes of the scheduled arrival time, according to data published Thursday by the U.S Department of Transportation in the Air Travel Consumer Report. CO finished third among network carriers with 81.4 percent of flights arriving within 14 minutes of scheduled arrive time.

*“We outperformed our network peers by having good daily operating plans and co-workers who did a great job executing those plans throughout the year,” EVP and Chief Operations Officer Pete McDonald said. “Together, we are top tier in delivering on-time performance. In 2011, we’ll continue our commitment to providing our customers reliable service to destinations around the world.”*

### **CO flight attendants ratify contract**

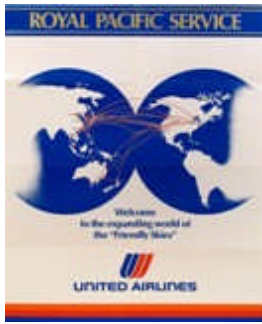


CO flight attendants represented by the International Association of Machinists and Aerospace Workers (IAM) on February 25<sup>th</sup>, ratified their collective bargaining agreement with the company. The agreement covers about 9,300 CO flight attendants located throughout the United States.

*“Our flight attendants provide great service to our customers as a critical part of our team, and it is to their credit that we have a new contract in place that rewards them for their hard work,” said Inflight Service VP Sam Risoli.*

### **SFO celebrates 25<sup>th</sup> anniversary of “Royal Pacific” launch**

Customer Service at SFO’s International Terminal on Feb. 11<sup>th</sup>, commemorated the silver anniversary of



UA's "Royal Pacific Service" with lobby decorations and a reception for co-workers.

United started its first-ever flights from SFO across the Pacific on Feb. 11, 1986, using routes acquired from Pan Am. On that day, United had nearly as many flights – three, to NRT, Hong Kong (HKG) and Osaka (KIX) –

as it did SFO-based customer service representatives fluent in Cantonese and Japanese – four.

Those new routes were among those that brought UA's Asian destinations to 13. Just three years earlier, UA launched its first-ever Pacific service, from Seattle (SEA) to NRT and to HKG.

Even though the Royal Pacific Service name is long gone, United is today the leading U.S. airline across the Pacific from SFO and flies to Asia from six hubs, and each has numerous multilingual agents.

### **First 747 in new livery made debut**



Co-workers at SFO and Seoul (ICN), South Korea, had the chance to see the largest aircraft in UA fleet painted in its new livery. United's first Boeing 747 to sport the new

United livery returned to revenue service Wednesday, February 23<sup>rd</sup>, after spending some time in the spotlight for customers, co-workers, passers-by and the media at the SFO International Terminal.

The plane (nose number 8427) left United's paint vendor in Amarillo, Texas, and was ferried to SFO. It will operate as Flight 893. While the plane was at the SFO gate, there was a media tour on the ramp. While there were no ceremonies planned, customers and co-workers got a good look from inside the terminal.

With this 747 completed and 22 more on the way (one of the fleet of 24 is in the Star Alliance livery), United now has at least one plane of each mainline fleet type painted in the new livery. You can get regular updates on Flying Together > Integration Information Center > [New United Livery](#).

### **Tuskegee Airmen visit ORD**



Co-workers at ORD met a living part of aviation history on February 16<sup>th</sup>, as members of the Tuskegee Airmen paid a visit to speak with co-workers and customers in celebration of Black History Month.

Milton Williams and Dr. Welton Taylor, original members of the group, joined new members Ken Rapier and Duane Hayden. The airmen took time to share a video on the history of the Tuskegee Airmen, as well as discuss the importance of the group's continuing efforts to promote aviation careers in the African-American community. Co-workers who attended the event were able to tell the airmen in person how their roles in shaping history inspired new generations to pursue their own dreams in aviation.

*"The airmen's visit today showed the living connection between African-American history and the industry that they changed forever,"* said Human Resources VP Doug Rose. *"It is truly amazing the direct impact these airmen had on our co-workers."*

### **United launches new service from EWR, IAD and IAH**



United launched new nonstop service to and from its EWR, IAD and IAH hubs mid February. The new services will bring more customers from other markets into United's

hubs, and provide them with access to points all around the company's global network.

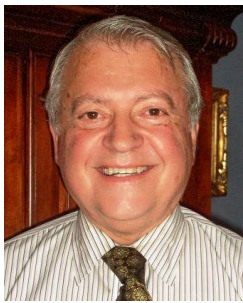
United launched daily nonstop flights between IAH and Reno (RNO). CO will operate the service with a B737 aircraft. Launch events occurred in both IAH and RNO and featured Olympic gold medalist Jonny Moseley. On Feb. 18, United launched service between EWR and Providenciales, Turks and Caicos Islands (PLS). CO will operate the service four times a week, using B737 aircraft. On Feb. 19, United began service between IAD and Grand Cayman in the Cayman Islands (GCM). UA will operate the service on Saturdays, using Airbus 320 aircraft.

In addition to the route launches, the company announced a second nonstop service between EWR and Lisbon (LIS), beginning in May 2011. CO will operate the service three times a week on a seasonal basis with B757 aircraft.

### **Ask The Doctor - The Most Dangerous Drug of Abuse In the World Today (Part II)**

From what we know about the drug Alcohol in my last article, the next step would be how to identify those people who abuse the drug. At first look, this may seem to be an easy task. Don't be so sure about that.

You may say immediately that the obvious people who are alcoholics are the homeless, the beggars on the street, those people we see at freeway/bypass highways/interstate exits holding signs asking for help. It may be

surprising for you to know, but those unfortunate people are just a small tip of a very big iceberg. Let me explain. Alcoholics can be men, women, senior citizens, hippies, yuppies, boomers, doctors, dentists, lawyers, pilots, mechanics, CEOs, teachers, bus drivers, policemen, firemen, soccer moms, stay at home moms, clergymen, politicians, actors, athletes, AND retirees. Shocked? You shouldn't be. What I am saying is that since the only requirement to be an alcoholic is to drink alcohol, any of the above people are at risk. If the prevalence of alcoholism is about 10%, that means about one out of every eleven people on the list could be alcoholic if they drink. Think about that and then realize how many alcoholics there must be. Notice I didn't say recovering alcoholics. I just said alcoholics. Unfortunately, there are many, many more untreated alcoholics than recovering ones. These statements deserve more explanation.

The list of possible alcoholics is not inclusive at all. Any one of you can add other vocations to that list, probably avocations as well. The point is that most alcoholics are functioning normally in society and are expert at hiding their addiction. The scary thing about that is we come in contact with "normal" people daily who may be a functioning alcoholic. And we don't know it because they do their jobs so well and have always done superior work for you and others. Practicing alcoholics are good at what their vocation or avocation is. Their vocations suffer only at the very end. Remember that.

Accept the idea that there are lots and lots of functioning alcoholics in society who are intelligent, creative, successful, and assertive. Most of them are high achievers. If that is true, then what can possibly cause these people to give up all their accomplishments for a killer drug like alcohol? Why do that? Simplistically, it's complicated.

Alcoholism is a complex of genetic, physical, psychological, environmental, and societal influences. Any one, some, or all of these factors will eventually bring the alcoholic to destruction. Full explanations of the interaction of these factors are very academic, but suffice to say that each of them is extremely important in the evaluation, treatment, rehabilitation, and long-term sobriety of the recovering alcoholic.

The alcoholic is functional because they are clever, scheming, manipulative, and smart. They connive, lie, blame, accuse, you name it. All to protect their drinking and the source of their salvation – alcohol. They sacrifice everything to hang on to their salvation. They need a dependable source of income so they preserve their vocation at all costs. After all, they have to buy their

alcohol with something, right? But, at what price.

The alcoholic will sacrifice their position in society, their friendships, their faith, their health, and even their families. All of these important parts of everyone's lives have lost their importance for the alcoholic. All of them. The only remaining part is the job. The job remains because it represents the last source of income needed to buy alcohol. It also represents the last vestige of respect they have.

Given the extent that disease of alcoholism permeates individuals in all phases of our lives, what can we do to identify, evaluate, treat, and rehabilitate these individuals and restore them to normalcy in every phase of their lives? That will be the subject of a future article.

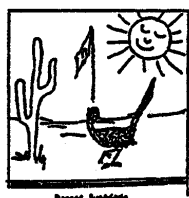
**Jim & Virginia Van Patten** appeared again, and, this time, renewed their membership and paid dues. We hope they will continue attending meetings.

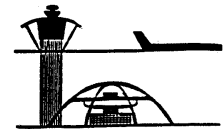

**Personally Speaking:** Being widowed and not being the UAL employee, thus ineligible for interline privileges, ZED fares and companion passes, I have just become aware of the UA **20 per cent travel discount**, positive space that I am eligible for. I didn't want to risk flying "Standby" in May trying to get to the Portland RUAEA Convention amidst revenue passengers. A regular ticket, round trip, SFO to PDX, would have been \$328. This way, with taxes included, I will be paying \$288.60.
