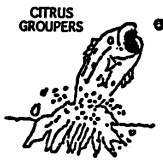
I also attended the Denver Mile Highers breakfast on March 2nd and was excited about their enthusiasm for volunteering for preplanning and assisting at the Hotel in October.

After a year and a half of planning, the first ever “Florida Retirees Uniting” event was hosted by the Citrus Groupers. We met in The Villages, Florida at the beautiful Waterfront Inn. We had retirees from our host chapter, the Orlando Real McCoys, The Southwest Pelican Drop-Ins, the Tampa Bay and Treasure Coast chapters as well as the RUAEA National President, **Hank Gosselin**, and our Florida Regional Director, **Paul Brown**.

We started with registration at 1:00 in the afternoon and by 5 PM; we had registered all 55 people in attendance. Friday evening everyone was treated to dessert at a Welcome Party in the Mangrove Room at the hotel. Many old friendships were rediscovered and lots of new ones made. **Lisa Leighty** of the Real McCoys and **Pat Townsend** of the Citrus Groupers walked the microphone around the room getting everyone to give us their name, station and a little story of their experience at United.

1. On the top right “*Employee Services*”
2. On the left, below Information for all co-workers, “*Benefits*”
3. Below Learn Enroll , “*Your Benefits Resources (YBR)*”
4. On top, above your benefit resources “*Your Profile*”
5. Click on “*Personal Information*”

Your personal information should pop up and any changes to it can be made right there.

United prepares to manage through
U.S. government “sequester” budget cuts

Effective March 1, the U.S. government will begin to reduce spending by \$85 billion. The government has until September 30 to make the reductions, although Congress has the ability to avoid this even after the effective date.



United is closely monitoring how this could affect the airline industry, as it relies on the FAA, TSA, U.S. Customs and Border Protection and other agencies for air-traffic control, airport security, customs checkpoints and other services that support our operation. United is in discussions with these agencies at both a federal and local level to determine how it can work together should the government not reach an agreement in the near future. United does not anticipate any immediate effect on its operations or its customers, since most reductions - if they take effect - would be phased in over time. For example, any furloughs at these agencies are not expected to take effect until early April.

If there are any airport or operational issues, United will encourage customers to check for updates on united.com. Co-workers may check Flying Together, where United will post operations updates as necessary.

United will have contingency plans for responding to any changes in its operating environment brought on by the government cutbacks should they take effect and the company will communicate any changes should they arise.

United ranks among FORTUNE's most admired airlines



On February 28th, FORTUNE released its 2012-2013 World's Most Admired Companies rankings. United was among three U.S. carriers to make the airline industry list, along with Delta and Southwest. A survey of corporate executives, airline executives, boards of directors and industry analysts determined the rankings, and only the top seven global airlines made the published list.

United was scored in nine categories from "innovation" to "global competitiveness."

IT Service Desk automates password resets



Effective March 1, when you call to reset your Flying Together, Active Directory, e-Directory, Oracle ERP or coair password, you will be using a simple, automated telephone system. By automating this system, United will free up IT Service Desk co-workers to handle more complicated issues.

Here's how to do it: Call the IT Service Desk at 1-847-700-5800 or 1-800-255-5801 and choose option 1 for password resets. Follow the prompts to enter your ID number and personal information. The system will give you a temporary password that you'll need to write down – it's valid for only 24 hours. Then you'll get an email with a link to reset your password. You may also go to flyingtogether.ual.com and log in with your temporary password. Follow the directions to change your password.

More power, more space for bags coming to gate rooms



What are some of the things that bother customers the most about waiting in gate rooms at the airport? Lack of power outlets to charge personal electronic devices? Seats blocked off by bags and other possessions? United's Airport Strategy and Corporate Real Estate teams are on the case. *"In December, we chose three seating configurations at three distinct seating areas at gates in Terminal 2 at ORD to test alternatives to our rows and rows of linear seats,"* said Airport Strategy Manager Chris Perry. *"We installed a minimum of linear seats, more tables for customers and cluster seating in pods. We also tested a long, barstool-like configuration with access to power at the tables."*

To the delight of customers, United went from an average of six power outlets in those areas to 45 power outlets and 43 USB ports. *"Our Airport Strategy and Industrial Engineering teams observed the percentage of seats used by customers and the percentage of seats blocked by bags,"* Chris said. *"The new seating configuration cut the number of seats blocked by bags in half. Not surprisingly, customers also enjoyed having easier access to power."*

"We'll use the results we gathered as a guideline when we have the opportunity to upgrade gate rooms in the future," said Corporate Real Estate Senior Project Manager Brandon Shimer. *"First up is the immediate need at IAH as we outfit Terminal B, and we are finalizing the details there."*

Tuskegee Airmen Thrill Chicago Contact Center Co-workers

In celebration of Black History Month, Chicago Contact Center co-workers recently met living history, as two of the original Tuskegee Airmen, Virgil Poole and Beverly Dunjill, shared experiences as pilots who courageously fought in World War II.



Both men were part of the 332nd Fighter Group and the 447th Bombardment Group of the U.S. Army Air Corps. They discussed working to protect U.S. bombers and what it was like to

be African-American in an army that was not yet integrated. The men trained at a separate institution, Tuskegee.

"Tuskegee is an important part of African-American heritage and American heritage as a whole. They explained to us that they were not only fighting a war in Europe, but also fighting a war for equality," Reservations Sales and Service Representative Landa Midgley said. *"It was very moving to be a part of this event. It reminded me of my grandfather. They may not be around very much longer and I really appreciated the opportunity to ask these American heroes questions about serving in World War II."*

"They are an inspiration to all of us. If you like what you are doing, then keep doing it. We can only get better and better. Mr. Poole and Mr. Dunjill really proved that point, even with the odds stacked against them," Reservations Sales and Service Representative Kathryn Powers said.

After the event, co-workers were able to ask questions, interact with the two men and get autographs. The Chicago Contact Center Black History Committee also organized other events throughout February, such a celebration for the 104th Anniversary of the National Association for the Advancement of Colored People (NAACP) and a presentation from the DuSable Museum of African-American History.

"These events are very important to me. At an earlier event, I saw the words 'Diversity flies with us, United' and thought about how these events exemplify that idea. We have been able to share experiences and learn about different elements of our heritage that make us United and a great company," Landa said.

Calling the ePass Line and giving the agent my six letter Travel Plan (used to be called Record Locator) for the affected flights allowed the agent to check if refunds of passes or charges were in process or start the process if

needed. This check now shows all of my passes and charges are accounted for.

Aside from Global Warming, many states, including Arizona, have been experiencing a very cold and wet winter. This does put quite a damper on golf outings for many snowbirds.

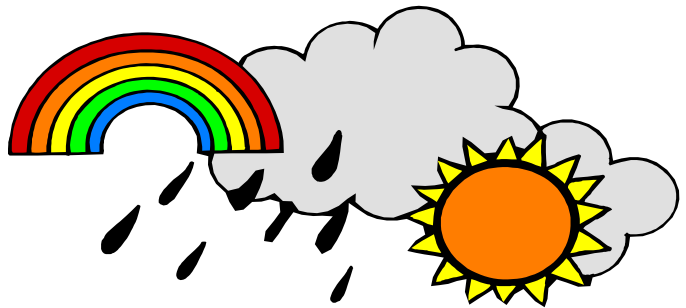

I arrived in Dubai late afternoon of September 30th. I rested in a hotel for a few hours before returning to the airport to connect to a flight to Johannesburg on Emirates, October 1 at 0440. I went to Staff check in at 0020/01 Oct., handed in my ZED paper ticket and was told that effective Oct. 1, Emirates would no longer accept paper tickets, only E-tickets. This was Monday morning in Dubai and late Sunday night in the US. Long story short, I had to purchase a Y ticket from Dubai to Johannesburg for \$824. And on the return, a ticket from Johannesburg to Frankfurt for \$600, where I was able to take a United flight to the States. 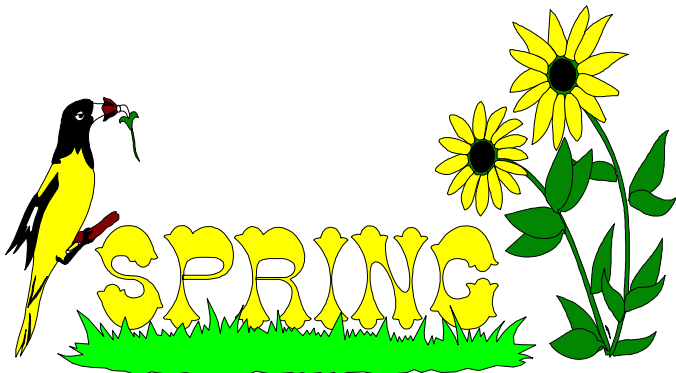

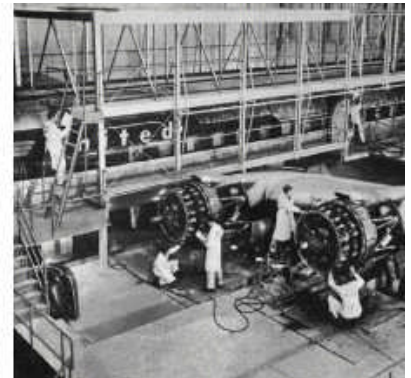
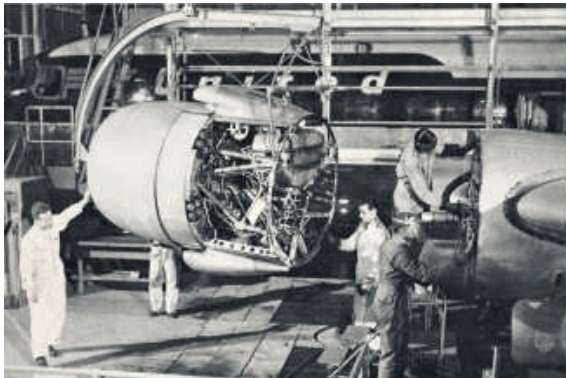

In 1955, United's 129 acre Maintenance Base in San Francisco was the most complete airline maintenance facility in the U.S. The base's over 3,000 Mechanical Conditioning employees were part of United's 18,515 "behind the scenes" Maintenance employees.

At SFOMM, carefully executed overhaul procedures ensured United's planes were maintained in excellent operating condition. As many as eight four-engine planes could be overhauled simultaneously at the base's docks and shops.

In every city United served the fleet received daily-inspections and every "United Mainliner" had a preflight-check performed before takeoff. Additionally, each plane
