

Or you can book online by going to <a href="www.ruaea.org">www.ruaea.org</a> for the link ~ click on the 2016 Convention icon and then on RESERVE TODAY. The rate is \$129.00 plus tax and includes breakfast for two. The rate is available three days prior and three days post based on availability, so book early. All you need to secure a reservation is to have a credit card on file with the hotel. If you are driving, parking is free unless you have an RV. Remember the convention dates are September 21-24, 2016.

Ground Service Equipment Maintenance is deploying 475 tail stands to hubs and stations starting this month to support the aft ends of Boeing 737-900 and -900ER aircraft while parked at the gate to enable immediate deplaning of customers from the front of the plane.

The stands will ensure customer and employee safety and reduce deplaning delays that are necessitated by having to offload aft cargo before allowing customers off the front of the aircraft to keep the plane balanced. United has also changed its load planning procedures since last year to prevent dealing with imbalanced aircraft upon arrival, when stabilizing fuel volumes have been greatly reduced during flight.

United looked at a number of options and fully tested two models of tail stands, one provided by the manufacturer and another developed by Structures Engineering Lead Principal Engineer Chris Ton-That; United settled on the United model for its light weight, ease of use and cost - less than half the cost per unit of the manufacturer's model, said GSE Engineering Senior Manager Andy Alexander.

"The UA-engineered tail stand allows our below-the-wing crews the ability to offload the front and rear cargo holds simultaneously," said Airport Operations Ground Equipment Senior Staff Representative Larry Koldoff. "This offload process improvement will ensure safety and also help our stations meet metrics for bag performance and reliability."

United is evaluating the use of the stands now in hubs and will fully deploy them at hubs by March and at line stations after that. Airport Operations will handle training and Ground Service Equipment will maintain the stands.

#### United's Cuba application



On March 2, United <u>applied</u> for service to Cuba from EWR, IAH, IAD and ORD; many of United's competitors filed applications, too. The DOT will make a decision on applications quickly.

United's hubs are well positioned to serve this market and the company is excited about the opportunity to add HAV (Havana) to it unmatched global network.

- The Newark/New York City metropolitan area has the second-largest Cuban-American population in the U.S. EWR-HAV service would increase community connections and offer new business development opportunities.
- → Nearly 20,000 Cuban-Americans reside in Houston. IAH-HAV service would connect communities across the central and western U.S. that, in total, have a Cuban-American population approaching 200,000. This proposed service would directly connect 20 key markets across the central and western U.S. to Cuba with just one stop in IAH.
- → IAD-HAV service would increase the range of consumer options for travel to Cuba from the East Coast, providing one-stop connecting opportunities for passengers from several central and western cities in the U.S. This service would naturally provide an important link between capital cities and serve a promising and growing export and diplomatic market.
- → Chicago serves as a key connection point for our country. ORD-HAV service would provide one-stop connecting opportunities for passengers from throughout the U.S. and provide an important link between Chicagoland's nearly 10 million residents and the Cuban market.

"We expect our competitors to fight hard to win the right to serve Havana. And we will too," said Regulatory and Policy VP Steve Morrissey. "United's proposed service will compete effectively and is ideally positioned to offer our customers choice and convenience in the U.S-Cuba market."

United's application is already enjoying support from a number of community leaders, including Newark Mayor Ras J. Baraka, New Jersey Congressman Donald M. Payne Jr., Houston Mayor Sylvester Turner, Virginia Senators Mark R. Warner and Tim Kaine, Virginia Governor Terence M. McAuliffe, Illinois Senator Richard J. Durbin and Chicago Mayor Rahm Emanuel. United's application has also already received the support of the African American Chamber of Commerce of New Jersey.

#### Hello, electronic Flight Attendant Operating Manual

The days of United's flight attendants having to carry a five-pound, 800-page Flight Attendant Operations Manual (FAOM) are almost over.

United recently rolled out the electronic FAOM to flight attendants via their Link devices, providing the FAOM in a digital format.

"This version is a huge benefit to us flight attendants - so much more convenient," ORD Flight Attendant Bo Kelley said. "The information we need is much easier to find and the graphics are much more in-depth."

United collaborated with the FAA and flight attendants throughout the development and implementation processes, and more than 700 flight attendants tested the eFAOM prior to rollout.

On February 9, United entered a six-month validation period during which the FAA will be auditing its flight attendants and their use of the eFAOM on the job. If there are no issues during the six-month period, the FAA will give United permission to retire the paper FAOM.

#### New and improved ACARS gate messaging a big hit

United's pilots now have a better idea mid-flight of what their gate assignment at their destination is and what time that gate will open thanks to a recently released improved Aircraft Communications Addressing and Reporting System (ACARS) gate message.

This new gate message automatically provides flight crews with their up-line gate status at least three times during every flight - 10 minutes after they release the brake, 45 minutes before estimated wheels on (EON) and immediately upon wheels on. The new gate message also includes gate availability time based on the estimated departure time of the previous flight to occupy the gate, provides their flight's EON and information on the status of the ground power availability, which helps reduce auxiliary power unit (APU) usage.

Pilots used to receive this information through an on-demand request process, but collaboration among Airport Operations, Flight Operations and IT about what's the best information to get to pilots resulted in this automated process, which has been a big hit.

#### So Simple from Sheryl



This recipe for pork chops is delicious and so easy. The nice thing is you can make them up early and just pop them in the oven an hour before you're ready to serve dinner. I hope you enjoy your next easy recipe.

Coca Cola Pork Chops

4 pork chops

1 cup ketchup

½ cup Coca Cola

Brown Sugar

4 slices of pineapple (I use canned)

4 maraschino cherries

Salt and pepper to taste

Place pork chops in a baking pan. Season with salt and pepper. Mix ketchup and Coca Cola. Pour over the chops. Top with sliced pineapple and a maraschino cherry in center of pineapple. Sprinkle with brown sugar. Bake uncovered at 350 oven for 1 hour or until pork chops are tender.

Then, suddenly, he stopped in the middle of the sentence. There was a slight pause, then he shot one short burst: "If there is anything I can't stand, it's a smartass!" Dr. George Kidera, M.D., an icon in UAL history. RIP"

The holiday season brought back warm and nostalgic memories of my association with United Airlines, which I would like to share with you.

After my discharge from the US Army in 1953, I had the good fortune to meet the president of United Airlines, William (Bill) Patterson at a Rotary Club luncheon.

Mr. Patterson suggested that I should see Dave Holcom, industrial relations manager at the SFO Maintenance Operations Center, not knowing on that fateful day, I would be with United Airlines for the next thirty six years of my life.

The next five years, my job assignments involved the following: Industrial Engineering, Environmental Safety, Safety and Health Training, Parts procurement, Workload scheduling, Accident Investigation, Union/Management relations, Line Station operations & Training, Motivation programs/Public relations, Management Training.

As I reflect on my career with United, I can't help but recall the people, events, and changes, which made my tenure with United Airlines a most interesting, exciting, challenging, and rewarding life experience!

I will always remember and value the team spirit of the people who helped me produce the following productions:

January 27, 1979, the musical presentation of "Viva Gypsy", featuring Hollywood star, Phyllis Diller, Dr. Lou Krasno's Gypsy Trio, Rosa Montoya, Bailes Flamenco, and San Francisco opera star, John Miller. Two new United films were produced for audiences across the Main Line during September 1954. One film was "Flying Colors" dramatizing activities at the San Francisco Maintenance Base and "The Sky is for Everyone" featured the Mainliner Convair.

"Flying Colors" was written by Walter Wise and produced by Cate & McGlone under the direction of Bernard Kovnat, United's Promotional Advertising Manager and was dedicated to the "thousands of United men and women in aircraft maintenance."

All the "actors" in the "Flying Colors" film were United employees photographed on the job at the SFO Maintenance Base and at stations along the Main Line.





In "The Sky is for Everyone", Betty Ashton, secretary to Curtis Barkes Vice-President of Finance, enacted the role of a Traveling Shoe Buyer. The film's technical details were discussed by (left to right) Bernard Kovnat, Melvin Douglas & Charles Palmer.

"The Sky is for Everyone" demonstrated how the Mainliner Convair brought modern high-speed air transportation to intermediate-sized cities and benefited everyone from the local doctor to the traveling salesman. In both films, the cast of United employees performed with professional aplomb.

The "Sky" film was written by Charles Palmer of Hollywood, narrated by Hollywood screen star Melvyn Douglas and produced by Telefilm of Chicago under Bernard Kovnat's supervision. Prints of the two pictures were distributed to Main Line cities for screening at business, social and civic groups.

Sometime in late August 2001 the attack date was set at 9/11. It is thought they selected this date because the U.S. Congress was due back from their summer break then, so the Capitol must have been the fourth target. Four flights were selected that departed within twenty minutes of each other for maximum shock value. Coast to coast flights were selected for maximum fuel loads thus maximum damage. September 11 arrived and the rest is history. KSM is the man responsible for almost 3000 lives. He truly is an evil man.

As our tour bus enters this field that was formerly called The Diamond T Strip Mine, as retirees of United Airlines, let's try to remember what happened here fourteen years ago this month. Seven of our fellow employees and thirty three of our flying customers died here

performing an act of extreme bravery. They weren't able to save their own lives but they saved the lives of countless lives in our nation's capital. This is sacred ground. A COMMON FIELD ONE DAY, A FIELD OF HONOR FOREVER. (Flight 93 mission statement)

Most of the information I've presented here is short summation of the book FLIGHT 93, THE STORY, THE AFTERMATH AND THE LEGACY OF AMERICAN COURAGE ON 9/11.
