#### **Letter From The President**



February and March are usually quiet winter months, but this year they have been a flurry of activity. Our Denver Office has moved out of the facilities where we resided for around 22 years. Our new home is a 6 x 6 foot cubical. It's small, but it's amazing how people can figure out how to make something work with limited resources. I'm sure you are aware that the entire Training facility is being renovated to accommodate all of United's Flight Training. The project completion time line may go into next year.

Our March Board of Directors Meeting is scheduled for March 22 in LAS. We have had some good comments submitted concerning the business of RUAEA and where areas of change are necessary we will work towards that end. And, planning will continue for the 2017 Convention in Las Vegas. More information will be out in

subsequent Newsletters concerning the convention.

Much time has been devoted to our next Retiree meeting with Oscar Munoz. The date is set for April 12<sup>th</sup> at WHQ in Chicago. The Retiree organizations leaders were asked to submit the three items of greatest concern for possible inclusion in the agenda for the April meeting. From RUAEA we had many submissions and the top three were pass travel related. There were others and as opportunity presents itself, they will be discussed at future meetings.

#### The top three are:

- 1. Pass Boarding: All boarding priorities should be by seniority, active employees and retirees <u>all</u> treated the same. Date of hire seniority should be the benchmark, but years of service seniority will also work, just so all are treated equal. There should be no "super" classification of pass priority such as those who commute. Where one lives is of their choice and the risk of traveling to and from work assignments should be with the employee and not at the expense of others. Business passes, emergencies or unusual circumstances would be the exception.
- 2. <u>Vacation Passes:</u> All personnel, active and retirees, should be allotted the same number of vacation passes. And they should be valid for the same number of years. Although it may be true that retirees don't use as many as active employees. There are many retirees that do a lot of traveling and they shouldn't be penalized because others don't use their allotment.
- 3. **Enrolled Friends:** There is a strong desire for more enrolled friends (increase to 4) since the retiree gets no "buddy passes". The retiree should be allowed to remove and install enrolled friends during the year. The desire is to be able to do that at will, but, if because of logistics a minimum of twice or quarterly would be better than being locked into whoever is on record for the year. Along with this widows or widowers should be awarded enrolled friends privileges the same as it was before their retiree spouse died.

As we continue to have these meetings with Oscar, I'll keep you informed of the progress. We must keep in mind that RUAEA is one retiree organization out of seven that has been invited to attend these meetings with Oscar. At this point we "have his ear" and we want to maintain the relationship. We have no legal bargaining power and we rely on the good will of United's current leaders. It is certainly a breath of fresh air compared to the past. For these Retiree meetings with Oscar, please keep your comments and suggestions channeled through your Chapter Presidents, Regional Directors, directly to **Jim Simon**, our Executive VP or me, **Virgil Gooselaw**, your President. Please do not send them directly to the company or go outside of the channels within RUAEA. This is what we are being asked by our HR rep. therefore we need to honor the request.

#### Oscar spotlights innovation, ATC modernization and a level playing field at U.S. aviation summit



Oscar participated in a keynote discussion at the U.S. Chamber of Commerce Aviation Summit with Carol Hallett, counselor to the U.S. Chamber and former president and CEO of the Air Transport Association of America (now known as Airlines for America). He joined more than 800 experts and leaders from all sectors of the aviation community in discussing critical issues facing the industry.

Of the opportunities for jobs in aviation, he said he was "cautiously bullish" and "optimistic", noting the creation of tens of thousands of aviation-related jobs in a healthy and competitive global industry.

During the conversation, Oscar compared the current state of air traffic control to "having a gravel road when we need a highway. You would never drive your Ferrari on a gravel road. We're very supportive as a company" of ATC reform.

He also highlighted United's approach to innovation, which he called "relevant innovation - what is relevant to us today that we can actively move forward". From providing tools that link employees above and below the wing to the information they need to better serve our customers, Oscar said, "Innovation is the key. It doesn't have to be something new and shiny and opulent, it has to be constantly forward-thinking. We should march forward with technology, but create technology that is relevant today."

Of the planned launch this month of Emirates Airline's service from ATH (Athens, Greece) to EWR, Oscar noted his fact-based approach to examining the evidence around massive government subsidization of the three state-owned Gulf carriers - Qatar Airways (QR), Etihad Airways (EY) and Emirates (EK) - and the harm this would cause to U.S. airlines and U.S. jobs. "Facts tend to overcome a lot of emotion and a lot of bias," Oscar said. "There are hundreds of thousands of employees who have been through hell and back in the history of the airline industry here in America, and all of a sudden in the last couple of years they're enjoying the benefits of an industry that's doing so well. To start edging away from that, and the potential for an un-level playing field and its competitive impact on their roles, you're going to have a huge uproar from Americans. If there's any question about where United stands, we are in the camp of supporting our people."

#### United joins forces with NASA to demo air traffic innovations



United, in cooperation with NASA, Boeing and Honeywell, is participating in a series of demonstration flights in Seattle meant to show the effectiveness of new NASA-developed flight deck interval management and controller-managed spacing tools. The first demonstration flight occurred on Jan. 20, with additional flights continuing through the end of February.

NASA tools were temporarily installed onboard for the demonstrations

NASA's technology relies on Global Positioning System (GPS) satellites to more accurately gauge the distance between approaching aircraft. The tools will allow flight crews and air

traffic controllers to maintain more precise spacing between arriving aircraft, reducing fuel emissions and increasing landing frequencies at airports. The technology also has the benefit of raising arrival rates during inclement weather when visual approaches aren't feasible.

DEN Technical Pilot Rocky Stone was present for the demonstrations. "We are involved in this because one of our core goals is to improve reliability. This technology will make gray weather days more like blue sky

days, in the way that we can maintain our arrival rates," he said. "We want to run a reliable airline and we want our customers to be confident that we are doing the best we can to be on time. This technology will allow us to do that more often."

United has been an industry leader in pushing for "NextGen" Air Traffic Management (ATM) technologies. Last August, United participated in a demonstration of a <u>satellite-based precision landing system at SFO</u>. The GPS Landing System (GLS) can replace the aging Instrument Landing Systems that have been in use at airports around the world for decades.

- 2 packages Bear Creek tortilla soup mix (found in soup section of market)
- 4 boneless chicken breast, cooked and diced (can use rotisserie chicken from deli)
  - 18 oz. can black beans
  - 1 8 oz. can diced tomatoes
  - 1 medium onion
  - 1½ cup green pepper

Prior to meeting for their monthly lunch on February 16, a group of twenty-one Roadrunners met at the University of Arizona for a tour of the Laboratory of Tree-Ring Research which had been arranged by **Pat** & **Rich DiLallo**.

As we entered the new building, we encountered an exhibit by artist Julia Comnick who rendered pictures of each of sixteen Arizona forest fires using small samples of the charcoal that had been collected around each of the fires. She transferred the images from photos of the fires onto a special paper which allowed her to then blow the charcoal dust over the images creating the "drawings" we saw. We then went to couple of the labs where our docent-guide Randall Smith talked to us about why and how important Tree-Ring Research is to human life. Aside from revealing the age of a tree, it can tell the conditions a tree encountered in its existence including weather, flooding and fires, etc. Those who took the tour found it very interesting and enjoyable. While there was no charge for the tour, Treasurer **Pat DiLallo** collected over \$130 donations which was send to the Laboratory of Tree-Ring Research.

The following story is contributed by **Dave Garland** and occurred when he was working as a mechanic at SFO. Names have been omitted to protect the innocent. "While working at an airline it might seem rather routine. But then you realize that it's not so routine after all. There is something different happening every day. And then there are those times when something occurs that is completely unexpected. Add humor to that and it becomes an event to remember.

I was working on the sheet metal crew in the overhaul docks at San Francisco working on a DC-8 in for an overhaul. I and a few other mechanics had been given work inside the forward cargo pit. The pit had been recently 'opened up,' meaning that the fiber glass lining had been removed and the structure was exposed. One

mechanic was working on a scab patch near the basket loading door and I was just inside the cargo pit forward of the door. Not too long into the shift the aircraft cleaners showed up to do their cleaning in the pit. They used soapy water and brushes to clean the exposed structure and a wet vacuum to suck up the water as the cleaning progressed. One of the cleaners wearing his coveralls came into the pit near me, sat down, and started his cleaning. The sheet metal mechanic outside was getting ready to drill holes in the scab patch so it could be installed. He looked inside the doorway to verify it was clear before drilling pilot holes with a small diameter drill bit. As soon as he checked the area, the cleaner moved to continue his cleaning. The mechanic, being cautious, went slowly with his first pilot hole. He later said that it felt a little strange as the drill bit went through the skin of the aircraft so he stopped. At the same moment the cleaner got a surprised look on his face, said something to the effect of 'what the heck,' and stood up as much as he could inside the cargo pit. As I am observing all of this, I notice a mass of white threads coming out of the seat of his coveralls. It didn't seem like he was hurt and as I assumed I was seeing underwear material, I started laughing. You guessed it. The place he chose to sit down was the same place the holes were being drilled. Work completely stopped in the cargo pit area and it seemed like everyone was laughing except the cleaner. The mechanic who had drilled the hole popped his head into the pit again wondering what had happened. After the laughter settled down a bit, it was all explained. The drill bit went through the aircraft skin, through the cleaner's coveralls, through his jeans, and started winding up his underwear before it reached his skin. That was when the mechanic felt something odd and stopped drilling. As he was pulling the drill bit out of the hole, the cleaner was simultaneously standing up and the wound up underwear was being pulled through his jeans to the outside of his coveralls. Eventually, the scab patch got installed and the cargo pit structure was cleaned too. It was certainly a mishap to remember and to chuckle about later."


