FROM THE PRESIDENT

At the business meeting during the convention I reported that we had made very good progress in the development of the RUAEA website, but that we had a way to go. It is not a question of "IF" we will get it done, but "when" will it get done.

Many of our members have been trying to access the RUAEA website, <u>www.ruaea.org</u>, and have been unable to do so; I apologize for that.

If you have not yet registered to view the newsletter, you may now do so online. This online registration supersedes any instructions previously given in the June & July editions of the RUAEA Newsletter.

We sent Spectrum Data a copy of the RUAEA membership database. Members can now register online using their last name with a zip code (5 digits).

They are asking for an e-mail address so they can add the information to the database for future use. For security reasons, we ask members NOT to use their file numbers as a log in name or password. This should solve the log in problem and allow members to view the newsletter as soon as they register.

To compensate for any inconvenience to our members we will extend the website trial period through Sept. 30. This way members have a better chance to view the website.

We will be meeting with Spectrum Data soon to work on any remaining problems. We will keep you informed of our progress.

ANNUAL BUSINESS MEETING May 24, 2003

President Jim Fauber called the Annual Business Meeting to order at 10:50 a.m. This meeting is in accordance with the RUAEA Bylaws. Motion was made & seconded to waive the reading of last year's minutes. Motion carried. The new Newsletter website www.ruaea.org or .com or .net (all three are applicable) will have no alteration from the written Newsletter. There will be no delay in receiving the website Newsletter. It will be available the 1st of each month. The March Newsletter mailing was 9,125 copies for a total \$9,600. Will look for a manager in the Chicago area for the new website.

Executive V.P. Marlin Lade reported that there is no formal relationship between UAL and its retirees, need a link between WHQ & RUAEA to establish a planned process which will give us accurate, timely and informative information regarding communications about UAL, also impact/affect on retirees, allow retirees to provide input on issues & decisions that impact/affect retirees and explore ways retirees can assist/support UAL in its recovery. Glenn Tilton endorsed and offered support, information to retirees and how to access it. Use Skynet & RUAEA website, also 1-800-1-AMUA. Ed Tolle has been appointed by Pres. Fauber to be the RUAEA liaison with WHQ.

Treas. Charlie Lewis reported net revenue, less expenses for 2002, was down 71%: \$6,550 in 2002 vs. \$22,471 in 2001. The cost of producing & mailing the newsletter was up 108%: \$47,944 in 2001, \$99,709 in 2002. Year-end cash balance which includes both the checking account & savings account in the Credit Union was \$108,322, down 0.3% from 2001. CD investments totaled \$142,913, up 5% from 2001 balance of \$135,824. Total amount of revenue received from our membership was up 44%, \$148,397 vs. \$102,737. First quarter 2003 results revenues were \$14,605 over budget, expenses \$15,216 under budget. Revenues & expenses were properly accounted for and reports were free of any material misstatement for the 2002 DEN Convention. Total cash & investments as of May 20, 2003 total \$293,673.

V.P.-Conventions, Bud Hubbard, reported there are 1062 attendees at the Chicago convention. The 2004 convention in SEA will be chaired by Hank Gosselin. The Site Selection committee is working on the 2005 convention location.

Past Pres., Frank Murdock, announced the election results. New Directors elected are: Tom Goodyear, Mountain Region & Jeri Juth, NE Region. Incumbents Tom Harvey-NW Region & Gordon Starr-AZ Region, were reelected. Bernie McNamee & Ned Yundt received Certificates of Appreciation in recognition of their dedication & service during their terms as directors.

Newsletter Editor, Jo Madden, was the sole attendee from the Newsletter staff. Mel Conine could not get to ORD so missed the Convention. Membership Secretaries, Mary Ann Wallace, Harriet Ahr & Adele Fishler were also absent, so Jo gave the RUAEA membership report. Jo reported

that Kinkos was giving us excellent service in printing our Newsletter. Regular membership has increased to 9,001, including 357 new members since 3/31/03. Reminder to members to include their file number on all checks. 2 new fields have been added to the retiree's record. Next to the file number on their check, if they wish, the retiree can add their station & department code from where they retired.

A question & answer session followed. Pres., Jim Fauber, adjourned the meeting at 12 noon. The door prize raffles were then conducted.

TRAVEL POLICY CHANGES

In the July newsletter we printed penalties for non-payment of Service Charges on NRSA or Companion Tickets. Be sure to save the envelope with the postmark stamped on it to show when invoice for travel charges was mailed. Retirees have advised that date of invoice was earlier than postmark on envelope - some as much as a week or 10 days earlier than envelope; SO save the envelope!

JULY SCHEDULE CHANGE INCLUDED SEASONAL ADDITIONS, REINSTATEMENT OF SOME PACIFIC FLYING

United added 54 flights to its schedule in July, including seasonal service additions, plus reinstatement of some Pacific flights cancelled in June due to the SARS-related drop in demand. United offered 3,359 mainline & United Express flights in July, up from 3,305 in June.

Effective July 1, United made the following changes to its international flight schedule:

- Reinstated service between SFO & Hong Kong that was discontinued in June, due to the SARS-related drop in demand. United will offer flights 3 days a week.
- Increased service between SFO & Shanghai from 3 days a week in June to 5 in July.

Effective July 6, United made the following changes to U.S. domestic schedule:

- Added 7th daily round-trip between CHI & Buffalo, NY.
- Increased from 1 to 3 daily round-trips between CHI & Calgary
- Added a fourth daily round-trip between CHI & Vancouver
- Added 1 more daily round-trip between CHI & each of the following cities: LAS, LAX & Orlando
- Added another daily round-trip between LAX & both SEA & Washington Dulles
- Added a 4th daily round-trip between SFO & Vancouver
- Added a 2nd daily round-trip between DEN & Anchorage
- Added a 7th daily round-trip between DEN & Oakland, CA

United Express will increase regional jet service from DEN to Aspen, CO; Edmonton, Alberta, Canada; Eugene, OR; Fresno, CA & Nashville, TN. United Express also will launch new service between Washington Dulles & Montreal, as well as supplement United's daily mainline round-trips between Washington Dulles & New Orleans with 2 additional regional jet round-trips.

UNITED STREAMLINES PROCESSING OF BENEFITS INFORMATION & CLOSES WHQ BENEFITS SERVICE CENTER

Effective July 1, United closed the Benefits Service Center (BSC) at World Headquarters & outsourcing the work to ADP. The change will allow United to automate some benefits paperwork also speed up processing. ADP currently serves as the Benefits Service Center for retirees and now will serve active employees on the U.S. payroll as well.

Retirees can call & speak to a service center representative at the new United Benefits Service Center, #1-888-825-0188, by selecting option 0. The representatives will be available to answer questions from 7 a.m. until 7 p.m. Central Time, Mon. through Fri.


