United stopped transporting U.S. domestic mail June 30, when our current domestic mail contract with the US Postal Service (USPS) ended.

United will continue to serve the USPS by carrying international mail, which makes up the majority of our mail service in both volume and revenue

Based on United's on-time domestic mail delivery performance during the evaluation period selected by the USPS, Oct. 2005 - March 2006, United did not qualify for a five-year contract renewal according to USPS requirements. United's strong performance over the last two months met these requirements, but was not taken into consideration by the USPS in its evaluation.

United has declined the Postal Service's offer to extend the current contract for a period of 3 months through Sept. 30.

As the largest carrier of domestic mail, United was the only airline that handled the entire network for domestic mail service -- including difficult-to-handle transfers.

This development highlights the fact that execution is critical, in both the passenger & cargo sides of the operation. We have to execute on our promise of service to every customer. Although the service expectations of all of our customers are increasing, we need to adapt and always maintain the very high level of service and reliability our customers expect of us.

United's next opportunity to bid for U.S. domestic mail service will be in 2011.

ALL CHICAGO MIDWAY SERVICE DISCONTINUED ON SEPT. 5

United will discontinue service from Chicago's Midway International Airport, Sept. 5.

All 37 Ramp Service & Customer Service employees currently stationed at Midway will have the option to apply for positions at CHI O'Hare International Ariport.

United will continue to operate charter flights from Midway.

There was a demand for bigger planes carrying more passengers & mail so PAT acquired a five-passenger Fokker Universal (above).

On a passenger-less flight in fog north of San Francisco, the pilot parachuted-out leaving the Fokker to run-out-of-gas. The plane nearly made a perfect landing by itself, unfortunately it hit a mound of dirt in the middle of a field and cart-wheeled into a total loss. In the three winter months of 1927/28, PAT lost three planes due to pilots "jumping".

After the loss of so many planes, Vern Gorst, Chief Pilot Grover Tyler & W. A. 'Pat' Patterson met with William Boeing. They wanted to rebuild the PAT fleet with the \$25,000 Boeing Model 40-C planes, but Boeing refused to sell the planes on credit.

Patterson then suggested that Boeing buy PAT, paying \$200 per share for all the PAT stock. Wm. Boeing agreed to this and to Gorst's stipulation that all of PAT's personnel be retained. Gorst was made a Boeing V. P. & put on the Board of Directors.

Gorst was paid \$94,000 for his controlling interest in PAT. He promptly bought a new Boeing B-1-D Flying Boat to start an Alaska airline. He hoped to receive an Alaska airmail contract.

As word of Boeing's buyout spread, PAT's nearly worthless, \$100 par-value, shares skyrocketed to as much as \$666 per share.


Shortly after the PAT sale, Boeing president Philip G. Johnson phoned 'Pat' Patterson at the San Francisco Wells Fargo Bank regarding a BAT license to fly in Mexico. After investigating, Patterson recommended against the venture.

Johnson then offered Patterson a job as his assistant in Seattle. On January 22, 1929, at age 29, 'Pat' Patterson was officially in the "aviation-game". One of Patterson's first assignments was to track-down owners of 4,500 nonvoting shares of Pacific Air Transport.

"United" Concorde Model



UAHF was recently given this model of the Concorde in United livery. United held options on 6 Concordes and 6 Boeing SSTs.

By mid 1964, 21 U.S. & foreign airlines had placed deposits for 91 Concordes. In 1965, United optioned for 6. The 16 American option-holders formed a committee under Chairman William Mentzer, V.P. UA, regarding the Concorde design.

In late 1969, U.S. government approval was granted for the Boeing SST. Boeing had already contacted airlines throughout the world, Pan Am had optioned 15, TWA 12, United Airlines 6, Japan Air Lines 5. Altogether, 26 operators optioned 122 of the Model 2707s.

March 1971, the U.S. government voted to terminate the Boeing SST program.

Oct. 26, 1972, United Airlines canceled its 6 Concorde options, saying the SST didn't meet its needs since its flights were primarily continental.

January 1976, British Airways and Air France began scheduled flights of the Concorde.

I apologize for the lack of a newsletter from GEG for the past few months. We returned home from PSP the end of March. I had not heard from anyone regarding events or news from GEG so I had nothing to report. Plenty to report from PSP as on Feb. 2 my pant leg caught a sprinkler riser sticking out over the sidewalk, I took a nosedive into the front door of our condo onto the tile floor. I am scheduled for surgery to move my nose back to where it used to be. I cannot breathe through my right nostril as it moved the cartilage over the nasal passage. By the time you read this I should be on my way to normal, whatever that may be. If not back to normal I will be fertilizing daisies.
