#### LETTER FROM THE PRESIDENT – JULY/AUGUST, 2007

This month I want to address some changes recently made to the travel program. You may already have read about them elsewhere, but I want to repeat them to insure that everyone knows about them and where and how to find out the details applicable to them. As I have reported to you, RUAEA has been working on enhancements to our travel program privileges. These are two we have been working on for a while.

First, Aer Lingus has been added to the list of carriers, which have made available Zonal Employee Discount (ZED) fares which simplify and reduce pricing for non-revenue, space-available interline travel. We believe that more are in the works and we will report them to you as they occur.

Second, Air Tran has made available space-available travel to their US and Bahamas destination for a flat fee of \$25 one-way plus security fee.

Detail information on these and other interline travel privileges are available on SkyNet.

Also, we have learned that those who retired from an international domicile, were unable to make advance planning requests for interline reduced-fare pleasure travel tickets using the same ticket-by-mail process, as those retiring from US-based domiciles. They were restricted to being ticketed only at a United airport counter. This provision affected only about 400 of our retiree community but you can imagine the impact it could have on them. Through discussions with the Benefits group at the company, a change has been made which will permit any of these retirees, who provide a US mailing and credit card billing address, to access the same process as everybody else. Of course, ticketing at a United airport counter is still available. Information, again, on the details is available in SkyNet.

I am well aware that many of you have other enhancements in mind that you want to see adopted. RUAEA will continue to work on making them available as we can.

#### ROME NRSA TRAVEL ADVISORY

Full flights between Washington Dulles and Rome since the route's April launch have made non-revenue, space-available (NRSA) travel on the route difficult - including some unaccompanied companions being stranded for several days. United is advising NRSA travelers to be aware of especially high load factors during the busy summer travel season when making travel plans, particularly when considering Rome.

- → Planning alternative travel options is advised, in the event that NRSA travelers cannot be accommodated on a United flight.
- Back-up tickets on other airlines should be arranged prior to travel as United has no employee ticketing function in Rome.

#### **GETTING BACK IN BUSINESS IN BRAZIL**

United recently signed a memorandum of understanding to develop an agreement to begin operating codeshare flights with TAM Airlines, the market-leading Brazilian airline.

- The restructuring of our former Star Alliance partner, VARIG, limited our access to Brazil, and significantly reduced the number of flight offerings for customers flying to Sao Paulo and Rio de Janeiro.
- TAM, which serves 49 cities in Brazil, currently has a codeshare agreement with American Airlines, but will be shifting that agreement to United in late 2007.

- → Once implemented, United customers will enjoy expanded service to South America, and will receive frequent flyer accrual and redemption benefits for their travel on TAM.
- TAM's leadership, strength and presence in South America, as well as its reputation for providing excellent service to its customers, position it as an excellent partner for United. Additionally, this agreement complements our strategy to offer our customers a broad global network.
- The agreement's implementation is subject to formal approval of both the U.S. and Brazilian governments, and the finalization of other details are expected to be in place by late 2007.

#### UNITED LAUNCHES NONSTOP SAN FRANCISCO - TAIPEI SERVICE

In response to increasing customer demand for more frequent service to Asia, and further strengthening our international network, United launched nonstop passenger & cargo service between San Francisco (SFO) and Taipei (TPE). United is the only U.S. carrier to offer this nonstop service.

- United now offers daily roundtrip service between SFO & TPE. The new nonstop route further strengthens our San Francisco hub as an international gateway to the Pacific.
- "We are pleased to offer our customers direct access to an important economic and cultural center by establishing a nonstop link between the Bay Area, Silicon Valley and Taipei," said Kevin Knight, United's senior vice president-planning.
- → United formerly offered nonstop service between SFO & TPE, and discontinued the routes when customer demand declined following Sept. 11, 2001.

# UNITED DISCONTINUES FALL, WINTER MAINLINE SERVICE TO ANCHORAGE (ANC)

As part of the company's continuous improvement efforts, United will discontinue mainline service to ANC between the months of September and April, effective this fall. Our Denver (DEN)-ANC service will continue through Oct. 2 this year. Beginning in the summer of 2008, United will offer seasonal service to ANC, and will use a third-party vendor to service those flights.

- → In 2008, our seasonal DEN-ANC service will begin in May, with O'Hare (ORD) flights operating June August. All seasonal service will end the first week of September.
- + United has experienced a loss of revenue on its

- mainline service to ANC for some time, and the change is part of our efforts to ensure we are building the most efficient and cost-effective organization and optimizing our revenue.
- Using a third-party vendor at ANC to provide ground handling and customer service for our seasonal flights will allow us to take advantage of local infrastructure, systems and processes. This measure aligns with our ongoing goal to balance customer demands in the most costeffective manner.
- → United Human Resources representatives are working closely with IAM and senior leadership to address ANC employees' individual employment options.

# UNITED INCREASES SERVICE TO EMERGING MIDDLE EAST REGION

In response to customer demand for service to the Middle East, United has announced that it will increase service to Kuwait to daily and will sign a codeshare agreement with Qatar Airways, a premier Middle East airline.

- "The Middle East is one of the fastest growing business regions in the world, and our customers tell us they want more service, with convenient schedules, to this emerging destination," says Mike Whitaker, United's senior vice president of Alliances, International and Regulatory Affairs. "We are pleased to give our customers what they want by increasing our own flights to Kuwait and by partnering with Qatar Airways to offer flights to five countries we've never served before."
- → In October 2006, United became the first U.S. carrier to offer commercial service to Kuwait when we began offering three weekly nonstop flights between Washington, D.C., and Kuwait City. Due to the strong customer response, we will increase the service to daily. The new flights, which will begin operating in January 2008, are now open for sale.
- → Our codeshare agreement with Qatar, pending regulatory approval, will offer United customers more options to the Middle East and South and Southeast Asia.
- For the first time, our customers will have service to five countries new to United's offerings, including cities Doha, Qatar; Colombo, Sri Lanka; Kuala Lumpur, Malaysia; Male, Maldives; and Peshawar, Pakistan. Also, United Mileage Plus members now will be able to redeem miles in addition to accruing them when traveling on Qatar's flights.

The agreement complements the cargo agreement already in place between United and Qatar, and our increased service to Kuwait will enhance our cargo capacity into the region.

#### FROM THE DENVER OFFICE

In the last issue we said that the Newsletter would be mailed out by a vendor starting with the July issue. The July issue is now history and the process went well. I have received many complimentary remarks concerning the new format. I think it will serve us well and allow us to do some things to further enhance the appearance of the Newsletter.

As a reminder, with the new process, the traditional "Red Stamp" is no longer used since the labeling of the Newsletter is now done by a vendor. But "Red" will still be present on the Newsletter mailing labels when it is time to renew. The vendor prints the renewal messages on the labels in red. The wording on the labels is the same and are intended to advise of 2 different scenarios:

**1.** For *Current Membership Expiration Month* - The wording on the labels will be:

It's Time to renew your Membership. Disregard this message if your dues are already paid.

**2.** For *Month Following Expiration* - The wording on the labels will be:

Your membership will expire unless your dues are received.

Please submit your dues payment at this time

Disregard this notice if your dues are already paid.

On June 27<sup>th</sup>, I watched the first few Newsletters being labeled and the red ink being applied to the labels that had renewal information on them. The speed the machine does this process is simply amazing. The Newsletters pass through the print heads so fast that they are nothing more than a blur. The time to label, band and ship almost 8,000 Newsletters to the Post Office took a total of 3½ hours.

<u>Names in the Newsletter</u>. We have had numerous suggestions requesting that names be "**bolded**". This makes it easier for the reader to pick out names. Starting with this issue we will attempt to bold any names in the Local News Section submitted by the Chapter correspondents. If we overlook some, it is not intentional.

Letters for the "Letters" column. If possible, please send your letters to us via e-mail or send the letter typed on a white piece of paper so we can scan it into a word document. Send it "Attn. Letters Column" in the subject line. By sending the letters to us in a

digital format (email) or typed, we don't have to manually retype them. But, if you are unable to send your submission to us any way other than hand written, we will gladly accept it. The "Letters" section is popular as it is a means of letting our friends know what is happening with us.

Also, if you have an e-mail address and want it posted along with your name and address, include it. Many have expressed a desire to have the email address included.

At this time, I still had some usable vision left and

began raising and hand-feeding baby parrots from my own small stock of breeding birds. I loved raising these babies and sold them as pets to people I considered worthy of caring for my babies. As my sight gradually became worse I gave up raising birds and applied for a guide dog to make my forays into the community safer and more fun. My first guide dog, Kylie, a yellow Lab, was with me for nine years until her death in 2005. I now have my little black Lab, Bonsai, who became my guide in late 2005. My interests include going to my water aerobics class three times a week, cooking, surfing different websites on my computer, which, by the way, has a screen reading software program, which allows it to read the screen to me. I also enjoy being with friends and being involved in my church activities. I sometimes go to different facilities to give a talk about guide dogs and how they are raised, trained and how my dog has enhanced my life. Forester & I are members of the Sacramento chapter of RUAEA and I am the current President of "The Gold Diggers", which currently has about 239 members. I may be the only President of a chapter with her own personal staff person (aka, Forester) to be a printed materials reader and gofer. We live in Grass Valley with 10 parrots, 2 cats and, of course, my beautiful little black Lab, Bonsai.


Another successful raffle & the floral centerpieces were greatly appreciated.



The "B & W" seaplane - Boeing Model 1

William Edward Boeing was a wealthy Seattle lumber company owner. July 4, 1914, during Seattle's Independence Day celebration, he took his first flight in a "pusher" Curtiss seaplane piloted by barnstormer Terah Maroney. The 30 minute ride "hooked" Boeing on flying.

October 1915, following lessons at Glenn Martin's flight school in Los Angeles, Boeing took delivery of a \$10,000 Martin-built seaplane. He soon "cracked-up" the fragile plane.

When the Martin Company informed him that a replacement would take six months, Boeing declared that "he could build a better airplane, and do it faster!" A good friend of Boeing's, U.S. Navy officer Commander Conrad Westervelt, was astonished when Boeing asked

him to design the new seaplane.

With the wrecked Martin as a guide, the new plane was constructed in less than six months. Wings and floats were assembled at Boeing's Heath Shipyard on Puget Sound's Elliott Bay and the fuselage was built in a hangar on Seattle's Lake Union.

The first "B & W" (named for Boeing & Westervelt) was test-flown by Boeing in June of 1916.

It was powered by a 125 hp Hall-Scott A-5 & cruised at 70 mph with a range of 320 miles.

As WWI came closer, the Navy transferred Commander Conrad Westervelt to the East coast.

Boeing "crated-up" the second "B & W", contacted the U.S. Navy, asked for test flights & for a government contract to build the "B & W".

"Pacific Aero Products Company" was incorporated July 15, 1916 with Boeing as President and his cousin, E. N. Gott as Vice-President.
