#### **ASK THE DOCTOR - Circadian Rhythm 101**

As a retiree, we can enjoy many benefits as a result of working for United Airlines. Probably no benefit is more popular than the travel benefit. This prized benefit allows us to literally travel around the world and visit many exotic places. This travel benefit does come with some medical consequences. One of the main ones is disturbance of our circadian rhythm. What is that?

The human body functions best when it is in a state of homeostasis. That is, the body functions at its best when we have a repetitive stable routine of sleep – wake – activity – sleep. This pattern follows a 24 hour cycle that we call our circadian rhythm (literally "around the day"). As long as we are in our home environment, this cycle functions without much difficulty. Even though we occasionally do not get adequate sleep, the body adapts quite nicely and continues in this stable cyclical pattern. Then, the travel urges hit us and we want to visit Timbuktu. Now what happens to that stable homeostasis? A lot, and some of it is not good.

Because of jet travel, we suddenly find ourselves in Timbuktu and our homeostasis and circadian rhythm becomes totally out of sync. We are wide awake when we should be sleeping and vice versa. We should be eating breakfast, but it is dinner time. The body rebels and we feel miserable. We now have the so-called *jet lag*. Medically, we have disrupted our circadian rhythm. How can we avoid this or, at least, how can we minimize this miserable feeling?

Let me start by saying, the body will easily adapt if the time zone shift is no more than four zones. Thus, LAX to JFK or the reverse is not too difficult. However, adaptation to even that three time zone shift is harder if we are over age 50, overweight, smoke, and are physically inactive. Too bad for us. Most of us are some of these, right? If you have been following the recommendations provided in an earlier article of mine, the only problem we can't fix is our age. What happens if we travel LAX to LHR (London)? Now, we have a big problem. How about LAX to SYD (Sydney)? An even bigger problem. What can we do?

*First*, lose weight and exercise regularly to minimize the bad effect and maintain that. You can't stop aging, so live with it. During the flight, drink plenty of fluids (NOT ALCOHOL). Take a walk in-flight at least once per hour. Loosen clothing, wear slip-on shoes, and eat lightly and frequently. Take some healthy snacks with you.

**Second**, if you can, plan your arrival in the late afternoon or early evening. After a light dinner, plan to retire for the night at the normal bedtime for your destination (NOT YOUR BEDTIME AT HOME). This is not easy. Taking an over-the-counter single dose of diphenhydramine (Benadryl) or a generic dose of Melatonin may help. There are prescription medications available as well. Take these ONLY on the advice of your personal physician. These MAY interfere with other medications you normally take.

**Third**, take your regular medications at the normal time for your destination, unless your physician recommends otherwise.

**Fourth**, on the first full day in Timbuktu, **DO NOT** plan a full day of furious sight-seeing or other excursions. **TAKE IT EASY**. For example, on our first full day in Paris in September 2007, my wife and I ate a light breakfast and then took an orientation guided tour of the city in a small 12 passenger motor coach. This tour lasted about three hours, oriented us to the city, but did not leave us exhausted. We ended our first full day about 5PM, Paris time, and spent the evening in our hotel. We saved our heavy sightseeing adventures for the following days. We did, however, plan on two down days with minimal activity during our stay.

*Fifth*, as a rule of thumb, it takes ONE FULL DAY for our bodies to adjust to the new time for EVERY HOUR time zone shift beyond FOUR time zones. For example, if your trip spans eight time zones, full adjustment will require four days after your arrival (4 time zones beyond the first four zones means 4 days for the 4 hours, for a total of 8 time zones). When we were younger (no offense), we could cheat on this formula and not feel any ill effect. However, even younger people should still follow the formula.

*Sixth*, it is ALWAYS easier to return from EAST to WEST. That is, returning to California FROM Paris will be easier than returning to New York FROM Honolulu. Think about leaving HNL in the early morning and then arriving in JFK at night the same day. Then, get up at your usual New York time the next day (your "clock" is still in HNL). The rule of thumb still applies when you return home. REMEMBER THAT.

Former crew members become somewhat acclimatized to this shift because of repetition on a regular schedule. Further, they usually returned shortly after arriving (36-48 hours later). The body clock has minimal disruption before returning to the home time zone. Nevertheless, disruption does occur and diet and exercise are vital to keep the body clock healthy. Crew members who lived a healthy lifestyle generally adapted much better to these regular time zone shifts. AND, they were younger.

Hope this short course in Circadian Rhythm 101 is helpful to you and your companions as you enjoy your well-earned travel benefit. Bon Voyage!

#### **ASK THE PHARMACIST: Medication safety tips for travelers**

The key to healthy, fun traveling is to plan ahead. This is particularly true if you're taking medications, which may potentially pose health risks due to travel, sun, and exposure to extreme temperature changes. To keep you and your medications safe while traveling, try these tips:

- 1. Always keep your medications with you. Medications should always be kept in carry-on luggage to avoid the possibility of getting lost with checked baggage. Also, checked baggage may be exposed to extreme temperatures and that may decrease the effectiveness of some medications.
- 2. Always keep a list of your medications. On the list, be sure to include specifics, such as the doses and why you take each medication.
- 3. Consider time zone changes and when to take your medications. If you're traveling to a different time zone, ask your pharmacist about how to adjust your dosing schedule so you can avoid missing doses. The adjustment will vary according to the type of medication. Call a Medco pharmacist to find out how to stay on track with your doses while traveling.
- 4. *Carry prescriptions in their original containers*. It may cause confusion, or hold you up at the airport if they're kept in unlabeled containers or bags.
- 5. *Prepare for weather changes*. Medications that need refrigeration should be stored in plastic bags with a cold pack.

In addition to traveling, leisure plans often include getting back to nature. Below are some guidelines to follow when spending time in the great outdoors:

- ( *Take precautions with sun-sensitive medications*. Some medications, such as benzoyl peroxide and ibuprofen, can cause a reaction when skin is exposed to the sun. Medications usually include instructions that will tell you to wear sunscreen or to stay out of the sun altogether.
- ( *Treating poison ivy and other rashes*. Calamine lotion or hydrocortisone may be helpful in stopping the itch. In severe cases, doctors may suggest taking an oral steroid.
- ( *Know the symptoms of heat exhaustion*. They include dizziness, sweating, headache and nausea. Stay hydrated. During the hottest time of day, wear lightweight clothing and refrain from strenuous activities. It's especially important for seniors to stay out of intense heat.

#### Carrying your medications when flying

According to the Transportation Security Administration (TSA), air travelers may now carry liquids, gels, and aerosols in their carry-on bag when going through security checkpoints. The TSA's "3-1-1" guidelines state:

- ( All liquids, gels, and aerosols must be in three-ounce or smaller containers. Larger containers that are half-full or toothpaste tubes rolled up are not allowed. Each container must be three ounces or smaller.
- ( All liquids, gels, and aerosols must be placed in a single, quart-size, zip-top, clear plastic bag. Gallon-size bags or bags that are not zip-top such as fold-over sandwich bags are not allowed. Each traveler can use only one, quart-size, zip-top, clear plastic bag.
- ( Travelers must remove their quart-sized plastic, zip-top bag from their carry-on and place it in a bin or on the conveyor belt for X-ray screening. X-raying separately will allow TSA security officers to more easily examine the declared items.

## PLANNED REDUCTION IN FLEET BY 100 AIRCRAFTS TO RESULT IN 950 PILOT FURLOUGHS BY YEAR END 2009

United announced initial details concerning the first wave of pilot furloughs resulting from its plans to take 100 aircrafts from the mainline fleet due to record high oil prices and a softening U.S. economy. The first notices to furlough approximately 100 pilots for the flying month of September will be issued in mid-July.

By the end of 2009, when United expects to complete the full reduction of 94 B737 aircraft and six B747s (see June 4 NewsReal), United anticipates the need to furlough approximately 950 active pilots. This process is one of the difficult but necessary steps United needs to take to size the business appropriately to reflect the current market reality.

Due to the number of United pilots on military and personal leave, approximately 1,450 furlough notices will be distributed over time in order to reduce the active pilot ranks by 950.

United currently is discussing with ALPA ways to reduce the number of involuntary furloughs, and will communicate any agreements that result. With respect to frontline employees, United will identify what reductions are necessary as schedules are finalized. United will continue to explore financially and operationally viable alternatives to minimize the impact on employees with unions representing the employees.

As previously announced, workforce reductions are occurring in every area of the company. Layoffs of salaried and management staffs have already begun in a number of departments. In Flight Operations, reductions of salaried and management employees are expected to begin in mid-July.

Additionally, Airport Operations and Onboard Service plan to announce their salaried and management layoffs this week. In total, the number of salaried and management positions at United will be reduced by 1,400-1,600 people.

United's competitors are facing similar decisions in response to this unprecedented environment. At last count, U.S. network carriers had announced plans to remove nearly 300 mainline aircraft from their fleets by the end of 2009 in order to reduce industry capacity.

## UNITED, CONTINENTAL LAUNCH PLANS FOR COMPREHENSIVE PARTNERSHIP: CONTINENTAL PLANS TO JOIN STAR-ALLIANCE

United and Continental plan to form a new partnership that will link the airlines' networks and services worldwide to the benefit of customers, employees and shareholders, creating new revenue opportunities, cost savings and other efficiencies. In addition, Continental plans to join United and its 19 other partners in the Star Alliance, the most comprehensive airline alliance in the world.

"With this relationship, we and Continental will be in a position to compete far more effectively than we can do today against strong global competitors," says Glenn Tilton. "We will offer the most comprehensive national network in the U.S. As Continental joins in the Star Alliance, we will offer the broadest scope and greatest choices of service in the entire world, making us highly effective competitors within the U.S. and in key international markets."

Teams from the two organizations worked intensively over the last several weeks exploring creative solutions for how the two companies could achieve efficiencies and synergies that expand beyond the well-established benefits of codesharing. Their work focused on plans for significant cooperation on frequent flyer programs, lounges, the use of facilities, information technology and procurement. This work benefited from the analysis done during the merger discussions.

In addition, United and Continental plan to establish joint ventures including other partner airlines, so that they can work together as a team with common incentives to deliver consistent and excellent service to global travelers. Continental will request the U.S. Department of Transportation to allow it to join Lufthansa, Air Canada and six other carriers in their already established anti- trust immunized alliance.

This will enable Continental, United, Air Canada and other immunized Star Alliance carriers to work closely together to establish trans-Atlantic and other international joint ventures to deliver highly competitive flight schedules, fares and service. Joint ventures are also planned for the Latin America and Asia/Pacific regions. Both anti-trust immunity and codesharing are subject to receipt of approvals from applicable national authorities.

"This partnership is also a key component of our five-point plan, giving us access to a new and growing source of revenue and an opportunity to find efficiencies and cost savings," Tilton says. "At the same time, it builds our competitiveness both within the U.S. market and internationally, strengthening our reach, customer base and our already world-leading alliance."

In the United States market, where antitrust immunity for solely domestic travel would not apply, customers will benefit as the two airlines plan to begin broad codesharing, which eases travel for customers flying on itineraries using both carriers, and cooperation on frequent flyer programs, elite customer recognition and airport lounges, subject to regulatory notice and Continental exiting certain of its current alliance relationships.

Continental's and United's route networks are highly complementary, with little overlap, so they add value to each other and to customers who are planning domestic and international itineraries. Under codesharing, customers will benefit from a coordinated process for reservations/ticketing, check-in, flight connections and baggage transfer. Frequent flyer reciprocity will allow members of Continental's OnePass program and United's Mileage Plus program to earn miles in their accounts when flying on either partner airline and redeem awards on both carriers. Travel on either carrier will count toward elite customer recognition. Similarly, each carrier's customers will have access to both Continental's Presidents Club network and United's Red Carpet Club network of airport lounges.

Continental's plans to join the Star Alliance and other planned cooperation are subject to the termination of certain contractual relationships, including Continental's existing agreements with SkyTeam members that restrict its participation in another global alliance. For example, a principal contractual restriction will not terminate until nine months after the closing of the proposed Delta/Northwest merger.

#### UNITED ANNOUNCES NEW ZED AGREEMENT WITH QANTAS

United employees and retirees can now take advantage of expanded interline travel privileges with Qantas.

Qantas is Australia's largest airline, operating throughout Australia, New Zealand, Asia, North and South America and Europe. United's new ZED agreement also includes travel on Qantas' subsidiary Jetstar.

For more information about the new and existing fare agreements between United and other worldwide carriers, visit SkyNet's Travel section and link to Interline Travel Privilege, Individual Carrier Agreements. Carrier eligibility requirements and restrictions are updated regularly.

*Note*: It's helpful for employees to purchase tickets for interline space-available travel as far in advance as possible. Also, be sure to review each airline's policies regarding dress code, minimum check-in time and baggage limits before traveling.

#### Charge it: Many Airlines no longer taking cash onboard

Per an article in Forbes Magazine, starting 8/5/2008, Alaska Airlines will become the latest carrier to go cashless for in-flight purchases such as headphones, cocktails and snacks. Both Credit Cards and Debit Cards are accepted.

Others who have gone cashless are American, Frontier, JetBlue, AirTran, Virgin, American, and Midwest.

Northwest takes cash only on domestic and credit cards on International, Delta is accepting cash or credit cards presently and stay tuned for United to announce their procedures.

Many International flights already use handheld credit card swipes to check validity.

#### **Additional fees**

Most airlines are tacking on additional fees trying to offset the surge in fuel costs. A David Horsey cartoon on Airline fees is comical but helps to lighten up the situation a bit. Some of the add-on fees are: First Bag \$15, Second Bag \$25. In the Feb 5<sup>th</sup>, 2008 NewsReal, the following statement is found regarding some of those exempt from these add-on fees: "*Employees traveling on a positive space or NRSA basis also are exempt from this policy*." The NRSA should cover Retirees and Companions, but it's difficult to find the specifics in print. Oversize and over weight baggage will be charged. Carry-on bags are very critical on all flights check the bag if at all possible.

#### A brief review of NRSA traveling:

- ( <u>Should I still use Weblist, Apollo, and 1-800-UAL-LIST to list for flights?</u> Yes, you should always list for travel and continue to use these preferred methods to list yourself and eligible's for flights. If you have problems listing, try calling one of the three Retiree Travel Desks.
- ( With no paper ticket, will we still be able to check luggage curbside? Wherever curbside check-in is allowed for employees, you will be able to check your luggage at the curb as long as you are listed for the flight. Standard charge is now \$2 per bag which goes to the Sky Cap Company. It's always acceptable for excellent service, in addition to the \$2.00 per bag charge, to tip the Sky Cap person. That's your choice.
- At every airport I have been to recently, the TSA folks want to see a ticket to get through security. With no write-your-own (WYO) travel passes, how are employees/retirees supposed to get through security? If you are at an airport that requires a ticket to get through security, you will need to check in for the flight and receive your departure management card prior to proceeding to the security checkpoint. Your departure management card, along with proper identification, will allow you to pass through security. If you are at an airport that does not offer curbside check-in or Easy Check-In, you must check in with the CSR to obtain your departure management card. It is best to check-in at home, print your own boarding pass using SkyNet and you're ready to go. Come on now, it's a good time to get a computer so you can take care of your own travel.
- ( <u>How do my eligible's and companions list for E-Travel?</u> Listing procedures will not be any different than they are today. As a reminder, the employee/retiree sponsor must always make the initial listing for their companion travelers. Upon listing in UAL-LIST, the employee sponsor must know their PIN number and use it each time a change is made for an eligible.
- ( <u>Does it matter if I check in with a CSR, a Skycap or Easy Check-In?</u> Yes. Non-revenue travelers should check in for flights using one of the three automated systems: Easy Check-In Online, Easy Check-In Kiosks or Easy Check-In Curbside. The reason the company is pushing us towards self help is to allow the airport CSR staff to focus on better serving United's revenue customers.
- ( <u>Do I need to have my travel card with me when I travel NRSA on United, or United Express?</u> No, a Travel Card is not required for pleasure travel on United or United Express. Travel cards for employees will no longer be issued or required when all employee travel becomes paperless. Retirees will be issued travel cards for United identification which is, at times, requested to obtain airline discounts at hotels and cruise lines. They also work in Easy Check-In Kiosks if the card contains a magnetic stripe, if it doesn't work, use any credit/debit card. And, it is the only thing that a Retiree has that establishes their relationship with United Airlines.

#### Miscellaneous travel tidbits.

NRSA Travel will be tight this summer and perhaps more so this fall with fewer flights. So, if you want to go, then list for the first daily flight; get out to airport and standby. You stand a good chance of getting on, but be prepared for alternate routing.

I suggest you list for First Class which will let you use any seat on the aircraft. If you list for Economy you are restricted to Economy with no upgrade.

To watch your stand-by progress, look for flight & standby information at gate signs in HUB cities; you will see your standby status number - with the first three letters of your last name and first name initial.

Pacific Air Transport then became part of United Air Lines. Bob was station manager in Spokane, and then moved to Seattle to become chief mechanic and finally maintenance manager. He officially retired from United in 1975 and ranked number 1 on United's seniority list. A memorial will he held Sunday, August 10 at 11:00 AM at the Museum of Flight in Seattle.

I soon realized that it wasn't working so I asked the flight attendant if I could have some oxygen. Then the whole wonderful experience happened. I was handled with the utmost of care and concern. Another passenger (a cardiology nurse from Kaiser) offered to sit with me and attend to my needs. The flight crew was wonderful and the flight attendants marvelous. To make a long story short, we got to Sacramento and I was loaded off by EMT's and taken to the emergency room at Kaiser Hospital north in Sacramento. I am recuperating and thankfully, there were no signs of an actual heart attack or stroke.

To think that complete strangers stepped up and took care of my needs thousands of feet in the air, doing their job with so much concern is overwhelming.

I'm thankful of United more than you can know!

History!

In Truckee, Nevada on top of a mountain, there is a general aviation airport on one of the mountain hills with one of the runways very short. The runway is so short that it has a warning sign about mid-point that states not to go if you are not flying at this point. If you cannot stop with full flaps, power retorted, and brakes just as you clear the end of the runway, you will find the plane going down immediately. You have to make a sharp left with full power. The airplane will continue to sink down several feet before reaching flying speed again. Meanwhile, you have to watch the mountain on each side of you. What was once out in the front of you is now on your right and the mountain top you just came off of on, that runway is now on your left. That is a most frightening experience; a pilot would not like to be in it for the first time. Once out of that place, if you flew in, you do not wish to ever fly back again.

If it is a rent-a-plane in Truckee, just as soon as the pilot gets the plane back to the Truckee airport, and back on the ground, a pilot's thoughts are to pick up his car and go home. You will say this to yourself over and over again "Truckee airport is not for me to fly in and out of"!

Although it is true that it is a good airport and a good place to get mountain terrain flying training, all the same, it is a very frightening experience.

It is like a navy pilot looking for the tiny speck of a ship in the huge ocean, which is a very small place to land on, and the runway is very, very short. One experience flying in the mountains like Truckee airport, that is all a pilot needs.

For an airline airplane approach to the airport, once the pilot sees that the runway can be made and has flaps, he will need to go full flaps down, pick up a normal glide with power let down, then make the landing and stop just as soon as the ground roll is under control, then turn off to a taxi strip.

Once in Truckee, Nevada is enough for any pilot. It is too frightening and dangerous with mountains all around and landing on top of one of those mountains.







### **UNITED AIR LINES**

In January 1929, William Allan "Pat" Patterson joined Boeing as Philip Johnson's assistant. As President of United Aircraft & Transport Company, Johnson was often in the New York City headquarters. Johnson gave Pat Patterson the authority to "make decisions as he saw fit" regarding Boeing Air Transport and the newly acquired Pacific Air Transport. April 1, 1930 United Air Lines was created as a "management company" for the four air transport companies (BAT, PAT, NAT & Stout) with Johnson as President. He was also the President of each of the individual airlines.

UATC then merged Stout and NAT. Following the Varney acquisition later in 1930, the airlines again numbered four. At this time, the "United Air Lines" logos

(right) were used. (lower right "Varney" logo is my speculation. MB)

In midsummer 1931, Pat Patterson was named General Manager of United Air Lines, Inc. and moved from Seattle to Chicago, taking charge of the new United Air Lines Headquarters.

United Air Lines owned no airplanes or other equipment, signed no contracts, had no earnings and was supported jointly by the airlines. This was to


become important on February 9, 1934, when the government abruptly canceled the mail contracts.

At the time, money from the air mail contracts was 45 percent of United's total revenue and although increasing steadily, passenger and cargo revenue alone fell far short of supporting the airline.

Following the air mail contract suspensions, Patterson made the decision to keep all four of his companies flying their full schedules, hoping that additional passengers, express and cargo would replace the lost mail revenue. His argument was "Our pilots and ground crews have to eat ... this is our opportunity to show our people that they are in a stable business". United lost more than one million dollars during the quarter that followed, flying with half-full airplanes.

The U.S. Government's decision to have Army pilots fly the mail was disastrous. In the 78 days, twelve Army pilots died, ten in the first 3 weeks.

Roosevelt put the mail contracts back for bids.
