# **Letter from the Executive Vice President**



Membership - As reported in last month's Newsletter, a significant By-Laws change was approved at the convention in Phoenix. Membership in RUAEA is now open to anyone who has worked for United and is of retirement age (55). This applies to those who started their career with United Airlines but for different reasons, did not finish their careers with United. Many ended up with "spin-offs" of the company such as Covia and Galileo. We have heard from many of these individuals over the years, wanting to join our organization to further friendships made while at United. Now they have that opportunity. If you know of anyone who meets the new criteria, encourage them to come and join us not only on the local level but also on the National level.

Another change in the membership By-Law is that spouses of RUAEA members, non-members who meet the above criteria and widows/widowers are also eligible to join RUAEA. This is important in that many spouses are

very active in the local chapters and in some cases, are what keep those chapters going. These folks are a great resource to our organization and now have the opportunity to become active in RUAEA with all the privileges such as voting and holding office.

We are encouraged by these new changes. In addition, we had a mailing to nearly 4400 recent retirees with a letter from President **Ron Robertson**, a new brochure and an application. The June results gave us over 300 new members and early results for July are showing the same amount of interest.

**Apollo** - Recently we have had questions and concerns regarding the use of Apollo. The current policy with United is that once you retire, you can no longer access Apollo. This situation leaves us retirees with SkyNet for our travel needs. Taking an informal poll of many retirees indicates that SkyNet fulfills the needs for checking availability and listing not only for our own travel needs but companions as well. Granted, Apollo provides additional information such as seniority of other standbys but as retirees, at least for now, we will have to make do with what is available to us which is SkyNet. We also understand that Apollo will be replaced with a new system in the not too distant future.

If anyone has problems with using SkyNet, please look into using one of the three Travel Desks supported by RUAEA. The Travel Desks contact information are listed in the "*Important Phone Number*" section of the Newsletter.

The concept for a travel desk started in 1995 with one in Seattle. We now have three: Seattle, Portland and Chicago. We operate them through the generosity of United, giving us Apollo access, office space and printers. They are manned exclusively by volunteers. The costs of the calls are underwritten by RUAEA and RUPA. They can check real time loads, list for travel and supply general information. They cannot check loads for other airlines, issue travel letters or reduced fare tickets.

# International SOS Provides Employees with Valuable Assistance while Traveling Overseas

Have you ever wondered what you would do in an emergency situation while traveling outside of your home country? What if your passport was stolen or you lost your prescription medicine? In today's volatile world, finding yourself in the middle of political or social protests is not even far-fetched.

The new program is available to all employees, retirees and travel eligibles (including Enrolled Friends). Prior to your travels, visit the International SOS Website (<a href="www.internationalsos.com">www.internationalsos.com</a>), which offers medical alerts, cultural tips, visa information, country facts and other relevant information. It's easy to access from the member's section by entering United's member ID number: 11BYCA000027.



If you need to find a doctor or have a general health question, medical and dental referrals are simply a phone call away. The centers are available 24 hours a day, 7 days a week.

For crews on an active ID and other employees traveling on company business, International SOS will provide medical resources in an emergency or evacuation to a medical center of excellence.

# San Francisco Base Will Again Host Blue Angels, Stage Employee Event


And, also for the fourth time since 2006, the base will host a huge party for thousands of United employees, retirees and their guests. This year's Fleet Week Employee Event will take place from 11AM to 5PM Sunday, October 11.

More than 10,000 people are expected for the event, which features the Blue Angels, who leave from SFO for their Fleet Week air show over San Francisco, and return to the base to sign autographs and meet attendees. There will also be entertainment; a variety of food and drinks for sale; collectors' cars, motorcycles and small aircraft; tours of a United jetliner

and the Jet Shop flow line; other exhibits and attractions; an expanded children's area; plane pull contests; and much more.

As in the past, coded wristbands will be required for entry. Information on how to obtain those will be released this summer. Although the event typically attracts attendees from Northern California, employees from throughout the system are welcome to request wristbands.

To make the event a success, hundreds of volunteers are needed. More detailed information will be made available in the coming weeks but it is not too early to sign up. Before I get started on this month's column, I have received a few emails/phone calls regarding last month's "Easy Does It" column and I would like to add the following clarification: "Addendum! DRAIN that can of <u>fruit cocktail</u> in last month's INSTANT SALAD (Creamy Fruit & Cottage Cheese) recipe." Now, on to this month's column:

My mother was a city girl, born in Ballard, otherwise known as "Snoose Junction", the Swedish section of Seattle, Washington, as the youngest daughter of Swedish immigrant parents. She later became a "country girl" when she married my father and they bought 15 acres of rich farming land called Maple Valley just 50 Km. southwest of Seattle. Being "City-Bred Farmers", they populated this land with Whiteface cattle (Hereford), Suffolk and Hampshire sheep, China White pigs (only 2 at a time), gray geese, several large varieties of rabbits including Flemish Giants, and

Rhode Island Red chickens. Rainbow trout were available year round and salmon in the Fall when they came to

spawn through our property up two fast running creeks. Mom's courageous Swedish blood served her well as she learned to prepare and cook all of these different types of meats. Following is her recipe for Oven-Baked Chicken which she used to make in our old black iron woodstove:

- 1. Preheat oven to 425°F.
- 2. Depending on the number of skinless thighs you buy, melt 1 cube of butter in a large metal pan or glass baking dish.
- 3. Mix together in large bowl: 3 cups flour and 1 tablespoon each of seasoning salt, garlic powder and paprika.
- 4. Thoroughly roll and coat both sides of the chicken first in the flour mixture, then in the pan holding the melted butter. Have chicken in one layer in the pan. Do not allow butter to run around; you only need enough to coat both sides of the chicken.
- 5. The number of thighs you buy will determine whether or not you will need an additional amount of the flour mixture and/or melted butter. Discard leftover flour and melted butter.
- 6. Bake, uncovered, 20 minutes.
- 7. Carefully turn over. Bake an additional 20 minutes or until chicken is a nice golden brown color.
- 8. Drain if necessary on paper towels.
- 9. Cover and keep warm or serve immediately.

# Ask The Doctor - Compliance: A Doctor's Dilemma

In my medical career with United Airlines and the US Air Force, there has always been one particular issue that has posed a very difficult issue for me to resolve. It may not be what you expect. This issue is compliance with recommendations of treatment.

More specifically, I tell a patient what I want them to do and upon a re-visit, find there has been some or complete deviation from my recommendations. The patient did not take the medication as I directed. The patient did not use ice or heat as directed. The patient did not do this or that. Yes, there have been times when non-compliance occurs when there is a break down in authorization for a procedure or treatment. But, aside from that issue, patient compliance remains a serious dilemma for all medical providers.

Let me illustrate with the use of antibiotics. More than once, I have received a call from a patient who began describing a respiratory infection. After giving me some basic symptoms, the patient would casually state he/she had taken a dose(s) of an antibiotic. Upon my inquiry, the patient would calmly say they had the antibiotic "left over" from a previous infection. *There is no such thing as left over antibiotic!* Every medical provider will order a precise number of antibiotic capsules, pills, etc. and will tell the patient to take <u>every</u> dose until the bottle is empty. The cost of medications today is very high, and ordering more than is necessary is <u>not</u> done. A medical provider tells the patient to take three doses per day for 10 days. By my calculation, that means the provider orders 30 pills, capsules, etc. Not 36 or 40. The provider orders 30. Just enough to complete the course of treatment.

A more serious compliance problem occurs when a patient allows a prescription to lapse without getting a refill in a timely manner. This commonly happens with a patient taking medication for a chronic disease such as high blood pressure or diabetes. For a variety of reasons, the patient uses the last dose of a medication(s) and "forgets" to obtain a refill for several days. That omission could be very, very dangerous. The outcome of such "forgetfulness" could be a stroke or heart attack or a diabetic coma. It <u>can</u> happen and unfortunately <u>does</u> happen too often. I understand that cost may be an issue or the Medicare "donut hole" may occur. My experience is that is <u>not</u> common among retirees from United Airlines. <u>If</u> we have the company drug program, "running out" of medication should **not** happen. For your personal health, it <u>must</u> not happen.

A sort of peripheral non-compliance issue is not about medication use, but involves rehabilitation issues. A patient suffers a painful injury, such as a back strain or ankle sprain or has a fender-bender car accident. X-rays are negative for fractures or dislocations and there are no lacerations requiring stitches. **But**, the patient has multiple bruises and feels "total" body pain. Aside from ice, a muscle rub, pain medication, and an anti-inflammatory medication, the provider orders physical therapy with three visits per week for two weeks. Typically, these sessions last about 45-60 minutes. They involve modalities, mobilization and/or manipulation, graduated exercises, and a home program. All too often, I find that the patient returns for a re-check visit in 10

days and has missed 1-3 sessions. The therapist states the patient was a no-show. Why? The patient states they still have pain, they can't sleep, they are stiff, they limp, etc. Remember, the injury causes inflammation which produces pain, swelling and tenderness. Therapy from a certified therapist addresses each of those problems with an individualized program to expedite full recovery. The combination of medication and therapy will achieve a recovery in 2 – 4 weeks in over 80% of the cases. However, the patient must take the medication and must do the therapy, and must do the home program. Recognize that if you are over 50 years of age, you will recover at a slower rate than you did when you were an aggressive party animal of 20. Compliance with a provider will result in a recovery with a steady patient approach over time.

The bottom line for us is seek appropriate medical assessment for a medical problem, ask the provider pointed questions, listen to the recommendations, ask questions if you are not sure about the recommendations, and <u>finally</u> be compliant with those recommendations. That approach will result in resolution of the problem almost every time. You will have some discomfort that will persist for a certain period of time. With <u>full</u> compliance on our part, we can recover from the "bump" in the road and then carry on with our retirement. *Try* it. You'll like it.



The following is submitted by the son of **Cornelis "Cor" Chel** who passed away on April 1, 2009. Cornelis was proud to have worked for United and United was part of his family.

My father, mother and I emigrated from the Netherlands in 1953, arriving in New York. An Uncle picked us up there and drove us to Chicago. We had arrived in Chicago on a Friday. That Sunday, my father found an advertisement for employment with TWA. That Monday he took the bus to the airport. At the bus drop-off, he looked down the street and saw that TWA was a significant walk, but United was directly across the street. He applied at United at 8AM, passed all the requirements and started working at 2PM, as a ramp serviceman. He worked for United for nearly 30 years.

About a year into the job, my father played a part during a fueling fire. He, along with several others, evacuated the aircraft (which was on fire), pulled a fueler from the flaming wing, doused the flames that had engulfed the fueler, and rendered first aid. He and another gentleman were recognized for their efforts. I have several articles from the local papers, as well as recognition letters if you care to have copies of them.

Many people congratulated my father over the next few days, but one gentleman stood out. After congratulating my father, he asked what were his goals with United. My father mentioned that he would love to move to Los Angeles. Within a day or two, transfer papers to Burbank ("but I wanted to go to LA!") were issued. The man was Mr. Patterson. Mr. Patterson and my father visited the fueler several times before the

fueler passed away from his injuries. The two remained friends until Mr. Patterson's passing. I have very fond memories of visiting Mr. Patterson in the desert outside Los Angeles as a small child and have several pictures from company events. I will never forget the stories and the cigars.

Thank you all for putting together this informative newsletter. But it so happens that having withstood the advent of time, I seldom see anyone that I might know. I will be retired 31 years on July 2<sup>nd</sup>, 2009 but have so many memories of UAL of the early years, feel I should share a pilot's remembrance of them.

I was hired on December 16, 1941, by **Seely V. Hall**, then VP of Western Ops. His secretary was **Ken Gallagher**. When I went into the UAL hangar at SFO (SF then), Ken asked if he could help me. So I responded "I would like to apply for a job as a pilot". Come in he said, and took me into a conference room. He came back with a Staine-Wadsworth Test. As I took it, he graded it, and when I finished, he took me to Dr. Ladd's medical department. Gave me a physical, and I was hired to replace a 2<sup>nd</sup> Lt. in the air force, I recalled.

I was sent to CYS to the Boeing school of aeronautics 8<sup>th</sup> class. We studied meteorology, power plants, company policy, navigation, radio communication, airplanes, DC-3, Boeing 247. Ground instructors included **Jim Newman, Marsh Caley, Gudy Gudmanson**, link trainer. And in the flight department, **G. I. Meyers** – Superintendent; **G. H Willingham**, Chief instructor. My cross country instructor was **Bud Jordan**, instrument instructor, **George Wilbur**; **Nat Messer** and **Charles Doyle** were my twin engine instructors.

There was some discrepancy as to whether to call the 8<sup>th</sup> Class Tracey, or United 1. Nevertheless, much of my grading sheets were designated VIII, so I presumed Boeing class 8 was indicative of the name. There were two or three classes after that, which they called United 2, 3, etc. And then the school was moved to Denver, where the school was located in the temple court building in downtown Denver.

After I graduated from the school in July 1942, I was assigned to the CYS shuttles with **Charles Doyle**, flying the Boeing 247. Then I was reassigned to SFO to be trained as a navigator for the Pacific Operations. The celestial navigation instructor was **Ned Simpson**. We also went to the Navy Morse code school in Oakland, California. We were part of a group from Boeing school CYS, as we had just finished a very comprehensive navigation training and only lacked the celestial and Morse code training to be up to speed as navigators.

Luckily, the line navigators finished their training before we got the airplanes. The C-87 was the aircraft we used for the Pacific Operations. A B24, converted to cargo and passengers. The flight department then reassigned me to SFO as a co-pilot in the DC-3. Then in March 1943, I was reassigned to Pacific Operations as a co-pilot. I stayed in that assignment until April 1944. Flying from Hamilton field, California to Hickam, Hawaii Canton Island, Fiji islands, New Caledonia, Brisbane, Australia. Then as the war progressed we flew into Guadalcanal, Port Moresby, New Guinea, Auckland, New Zealand. Lots of other islands, such as Attitaky, Bora Bora, I can hardly remember as it seemed like they were all at night, raining, and we were in and out as rapidly as possible.

After that stint, I was assigned to Portland, Oregon to start the process of checking out as captain. As the seniority was more junior at MDW, they decided to finish my training in MDQ, so in December 1944, I arrived in MDW and was promoted to captain in July 1945.

I will continue this epic next year with experiences flying the DC-3 during the early years.

Phyllis has been busy creating the most beautiful knitted sweaters, unbelievable. Happily, I am still instructing. Happy landings!





installed 145-hp Axelson engine, became Model 81B following a BSA student engine-change to a 115-hp Axelson and was changed again to a 165-hp five-cylinder J-6-5. The plane became Model 81C following the next engine change to a 100-hp five-cylinder radial Kinner K-5.

The Boeing 203 first flew on July 4, 1929. In addition to the three previouslymentioned "factory" 203s, two 203s were built at BSA

In the years following the Boeing School of Aeronautics' formation in 1929, a wide variety of aircraft types were used for flight training. The January 1930 issue of the "Boeing News" states: "BSA flying equipment consists of three Model 203 Boeing training planes, one Boeing Model 81, one Hamilton "Wasp" eight-place and a Boeing Model 40 converted mail-passenger plane."

Neither the Boeing Model 81A (top photo) nor the Boeing Model 203 were advertised or sold to the public.

The Model 81A first flew December 27, 1928 and was delivered to BSA. The 81A, with the factory-

by "shop-course students" from the Boeing plans, one in 1935 and the other in 1936.

BSA students changed the 203's factory-engines to J-6 Whirlwinds. In 1932, one J-6 Whirlwind engine was changed again to a 220-hp Lycoming R-680 engine.

The 203s were used at the BSA in Oakland until 1941 when they were moved to the new Tracy School. Boeing's 203 plans were sold to the Stearman Company and served as a basis for the WWII era, Kaydett trainer.

Among the aircraft types at BSA were a Boeing 247 and a Boeing 40-B equipped for "blind-landings". These two planes were shared with United Air Lines for the training of United line-pilots. A Hamilton H-45 and a Stinson SM-2AA were used to teach aerial photography and a Stinson SM-8A was used for night-flight training.

Listed among the variety of BSA aircraft was this "Link Trainer". It was used at the school from 1937 to 1942. *Marvin Berryman, DENTK (Ret.)*
