Letter From The President



Merger! Merger! It seems like most every day, there is something in the news about the United-Continental merger. Congressional hearings, stockholder law suits, passenger group law suits, talks with pilot groups, etc., etc. Then we can add on the endless rumors from employees, retirees and the public at large.

Well, here is what we know. The merger process is moving forward with many hurdles ahead, stockholders approval along with approval from the Departments of Justice and Transportation. The two companies have put together Integration Planning teams. You can find more information and get updates on what is happening from a couple of sources. In Skynet, you will find an icon in the upper right corner "Let's Fly Together", which will take you to various screens of information relating to the merger activities. You can even see the Integration Planning Structure with the assigned parties from each company. The other way to find this information is to go to united.com

and click on "*Investor Relations*" at the bottom of the screen. You will get much of the same information as what is provided from the Skynet source. There are many FAQs relating to ticket, travel, Mileage Plus and the Red Carpet Room use. In both cases, you can register your email address to get updates on the merger process.

Now on the retiree side of what is happening. There are essentially two retiree groups from United, RUAEA and RUPA (Retired United Pilots Association). Continental retirees also have two main groups, ARECA (Association of Retired Employees Continental Airlines) and a pilots group called the Golden Eagles. We (RUAEA), have contacts with the other three groups. As you may know, RUAEA does have a Corporate Liaison, Ed Tolle, who has and does meet frequently with senior officers at United on behalf of retiree benefit issues. RUAEA also has had a seat on the United Travel Advisory Board in the person of Mort Wax. Having a voice on this board was instrumental in retaining the BP-6 boarding priority for retirees a while back. RUAEA is the only organization of the four retiree groups that has direct contact with United. In addition, I have named two other Past Presidents of RUAEA, Marlin Lade and Ron Robertson to join Mort as the UA-CO Merger Committee to assist **Ed** with coordination with the other groups. We want to make sure we speak with a unified voice regarding retiree issue with the two companies. One big issue is there are major differences between the two companies' Travel Programs, especially in regards to retirees. We have essentially been told that no decisions will be forthcoming until the merger is complete but we want to have on record what outcome we would like to see. We not only represent our members but really all retirees and with United, there are about 40,000 retirees and with Continental over 20,000. This is a substantial number of people that could do a lot of letter writing. At times like this, it seems to me that membership in RUAEA is a bargain at about seven cents a day. I would encourage you to encourage your fellow retirees who are not members to join in support, one voice can be lost but thousands together can make a difference.

UAL Corp. Holds 2010 Annual Meeting; Details Progress and Opportunity

United held its annual stockholders meeting at the Training Center, where Glenn Tilton, Kathryn Mikells and John Tague had an opportunity to provide an update on the company's operational and financial progress and the proposed merger with Continental, and also discuss opportunities ahead.

"We are realigning our base business to better match current and future market realties, using every opportunity at our disposal to strengthen our company," Glenn said. "Improvements have been made across every key element of our business. We are a dramatically improved airline, a credit to the work going on across the company, and to our people."

The work, Glenn said, enables United to enter the merger from a position of strength, and must continue if the company is to achieve profitability.



"Sufficient profitability is necessary not only to generate returns for shareholders, but also to de-lever our balance sheet, to invest in better products for our customers and to create stability for our people," Kathryn said. "What we know with certainty is that our hypercompetitive industry in the future must look significantly different from the past in order to break the boom and bust cycle that has been the norm."

Asked what United will do to continue the momentum as it goes through the merger, Glenn said John is leading the work to execute the plan and identify ways to exceed its targets.

"Our commitment to you is clear," John told stockholders, "to produce a fully competitive United Airlines while playing a leadership role in creating the changes in the industry that will be necessary to meet our financial objectives, a bar we set much higher than simply surviving from year to year."

Tom Sabatino, United's new General Counsel, ran the business portion of the meeting, during which stockholders re-elected the Board to another one-year term. Board members elected were: Richard J. Almeida, Mary K. Bush, W. James Farrell, Jane C. Garvey, Walter Isaacson, Robert D. Krebs, Robert S. Miller, James J. O'Connor, David J. Vitale, John H. Walker and Glenn. Captain Wendy J. Morse and Stephen R. Canale were also elected to the board as UAL labor representatives.

IATA Recognizes United for Shift to Bar Coded Boarding Passes



At its annual general meeting in Berlin this week, IATA is recognizing United as the first major U.S. airline to achieve 100% use of 2D bar code boarding passes. The shift from paper, magnetic stripe boarding passes paves the way for United to offer mobile check-in, which is currently available at nearly 30 of its airports.

"The new technology facilitates home printing of boarding passes for multi-segment journeys and even allows customers to use their mobile phones as a boarding pass," says Manager-Customer Service Planning Ana Aceves Garcia.

Nineteen of United's Star Alliance partners also use the 2D technology. IATA calculates that the bar coded boarding passes save the industry up to 1.5 billion U.S. dollars every year.

"Before we went to bar codes, employees at our airports had to reprint other carriers' boarding passes when customers had itineraries with segments flown by other airlines, because we couldn't read their bar codes," Ana says. "Now, we can read any other airline's bar code just by scanning them at our gate readers, and we eliminated the printing of 2.5 million other airline boarding passes."

Ana credits the project's success to 24-hour cutover support, contingency planning and teamwork among airport operations planning, IT and our vendor partners, as well as project managers Tom Johnson in IT and Jim Hargis in Airport Operations Planning.

ODA Authority Helps United Bring B747 Back Into Service

Using a special authorization granted by the Federal Aviation Administration, United Services was recently able to authorize the permit to bring aircraft 8194, a Boeing 747, out of storage in the desert to add spare capacity to support the operation during the busy summer travel season.

The aircraft had gone beyond its inspection limit and, without a special flight permit from the FAA, which can take weeks; it could not have been flown to the overhaul site to be prepared for flight. However, a year ago, the FAA granted Organization Designation Authorization (ODA) to United, allowing it to perform as a representative of the FAA on design, production, repair, alteration and airworthiness certification procedures.



ODA authority allows United to do FAA reviews, approvals and explore more complicated repairs and changes because United can reduce cycle time.

"ODA also keeps us focused on developing key disciplines that are going to be increasingly drawn upon as the airline invests in more projects to improve our product," says Jim Miccio, managing director – Safety and Compliance. Three United Services ODA teams, each responsible for a specific type of change authorization, have been working during the past year on several of these projects:

The Airworthiness team, led by Bob Scoble, managing director – Inspection, and John Fox, lead – Inspection Process Coordinators, has exercised ODA authority to verify that maintenance procedures United performs on the fleet as it ages are safe and compliant with FAA regulations. And in addition to issuing the 747 special flight permit, they've worked with Aircraft Sales, to authorize delivery of retired United aircraft to buyers, including foreign carriers that want to register the aircraft in their countries.

The Major Repair and Alteration (MRA) team, led by Mike Arata, managing director – Engineering, can develop and authorize new repairs, which can in turn reduce airplane downtime and cost. "The Maintenance division has been able to apply a new repair to Boeing 757s that helps ensure reliability. As we build our experience level and develop our expertise even further, we envision offering United's repair design approval capability to other operators as well."

The Supplemental Type Certificate (STC) team, managed by Dave Hendryx, senior manager – Aircraft Certification Engineering, can authorize modifications to the aircraft itself – such as interiors and flight deck systems. A current project involves the Boeing 747 Enhanced Ground Proximity Warning System Runway Awareness and Advisory System (RAAS).

"The RAAS provides pilots better situational awareness while the airplane is moving around the airport, especially during adverse conditions including heavy fog and aborted take-off," says Dave. "An added bonus of the ODA is that, whereas for the 777 RAAS project we had to pay someone outside United to approve the work, the 747 and future RAAS projects will be authorized in-house."

Despite Weather Changes, A:14/UP Above Goal in June



Just as the case was a year ago, June has been a challenging weather month - especially at Chicago O'Hare (ORD).

Weather has been a major issue throughout the entire Midwest of late, resulting in a high number of ground delay programs at ORD. But despite those issues, United entered July's operation with an Arrival:14 (A:14) percentage of 79.9 - 4.5 points above the June goal of 75.4 percent. United also has had a strong customer satisfaction showing this month, as measured by United Promoters (UP), with a score of 32 -- 3.4 points above goal.

While United is well above its internal A :14 goal this month, the company is behind US Airways and Continental in the June A :14 standings. As United makes the final push over the next week to move up the monthly rankings, it's also important to remember that every flight counts in the yearly standings. As of June 29, United sat atop the 2010 rankings at 82.5 percent, according to Flightstats.com.

United Flight Attendants' service is a big reason why the Consolidated UP score is strong this month. It also has been assisted by positive reaction to United's recent leather cabin updates.

If United finishes No. 1 in A:14 this month, there will be a 65 dollar payout. If United finishes second or meets its internal goal, a 40 dollar payout will be awarded. If United beats the UP goal by one point or more, the June Cash Incentive payout for eligible employees will be 65 dollars. Meeting the monthly goal, but not exceeding it by one point, will earn employees 40 dollars.




JetBlue is joining other carriers offering onboard food for sale. Five new snack boxes will go for 6 dollars each. Several other domestic airlines offer snack packs or meals for sale on longer flights, including United, US Airways and Delta (Source: Associated Press).

Increasing numbers of travelers are looking into travel insurance in the wake of the volcanic ash clouds shutting down dozens of European airports. "We've seen a nearly 50 percent increase in calls since the Icelandic volcano eruption in April," said Bob Chambers, director of operations for CSA Travel

Protection. "The calls are coming from prospective customers inquiring about plan coverage for things such as the volcano, oil spill and other events, as well as current customers seeking reassurance they will be covered". (Source: New York Times)

United Shows Improvement in ACSI Annual Survey



The annual American Customer Satisfaction Index was released June 15, and while United is pleased with its improvement over 2009, the largest among surveyed airlines, the company will continue its efforts to improve its ranking and overall customer service.

The improvement is another validation of the progress United is making in improving its overall customer satisfaction. Earlier this month, United also had the largest improvement among peer carriers in the 2010 JD Power study – moving up 26 points. And, United continues to see increases in satisfaction scores taken directly from its premium customers as measured by United

Promoters(R). The data show a 13 percent increase from 2009 to 2010 YTD, and a 17.6 percent increase from May 2009 to May 2010.

"Consumer surveys like ACSI help inform us, and we value all the feedback we receive," says United President John Tague. "We are proud of our employees' continued efforts to deliver excellent customer service and are confident our focus on the fundamentals and every single customer interaction will continue to drive United's customer service in the right direction."

In the ACSI survey, conducted by the University of Michigan, United's overall satisfaction score was 60 (out of 100), up 7.1 percent over the 2009 score of 56. While that increase was the greatest among the airlines included, United trailed in the list that was topped by Southwest at 79. The combined rating for all airlines was 66, and most of its peers (American, Delta, Northwest, US Airways) were also in the low 60s. Continental was in first place among the top 6 U.S. global carriers. (The study did not consider Delta and Northwest as a merged carrier.)

Customers Appreciate Upgraded Domestic Cabins

As United continues to maintain its focus on delivering a clean, workable product for its customers and its employees who work the aircraft, a yearlong project to upgrade certain items on the domestic fleet cabins has been completed ahead of schedule, and has contributed to significant improvements in customer satisfaction.




The most visible change in the past year's body of work has been the upgrading of United First(R) seat covers to leather on its A319, A320, B757, and domestic B767 and B777 airplanes. Those seats also feature new, more comfortable seat cushions, and the planes have new carpeting in high-traffic areas.


When upgrades to the final mainline B757 and domestic B767 planes were done in early June, the original scope of the Cabin Cleanliness, Condition and Workability program was completed. A few projects that were added later - such as Decor 5.5 upgrades on B757s - are ongoing and on target, with 24 of 35 planes in that

project already completed. Decor work will continue on another batch of B757s with the installation of new bulkhead panels, a job that will start this fall. And, 22 of 24 international B777s in line for IPTE conversions have received interim improvements to carpeting and to United First(R) and United Business(R) seat covers and cushions.

The changes have contributed to greatly improved customer ratings for cabin cleanliness, condition and workability. Since the start of the program, condition scores have increased 7.8 points for the A319, 6.9 points for the A320 and 7.4 points for the B757. Workability scores for the A319 have gone up 10 points for the A319, 12.4 point for the A320 and 9.9 points for the B757. Cleanliness scores are also up across the board, in part due to the new CCCW seat covers and carpets.

Customer Experience has received many positive comments on the new seating, with one premium customer echoing the words of many: "The new leather seats really do make a difference."





Recently, a Boeing 767 aircraft departed Washington Dulles for Accra, Ghana, marking United's first-ever service to the continent of Africa. This new service expands United's global network to six continents. Joining customers on the inaugural flight was The Honorable Daniel Ohene Agyekum, Ghanaian Ambassador to the U.S., and "American Idol" finalist, recording artist and Malaria No More spokesperson Elliott Yamin.

United's new service to Accra not only provides economic value to the Ghanaian community, it allows the company to fulfill its commitment to addressing critical needs in the communities it

serves. United is teaming up with Malaria No More to include 1,500 pre-treated mosquito nets on initial flights to Accra. Those nets will then be distributed to regions in rural Ghana affected by the disease.

United's network is well-positioned to serve Africa, with almost a third of the demand for travel to Africa coming from its five hub cities. The Dulles hub's location near the center of the U.S. East Coast makes it a great connecting point for U.S.-Africa traffic.

United's employees have been instrumental in making the service to the capital of Ghana a reality. Many departments worked together to launch the service, including: Revenue Management; Sales; International Schedule Planning; Cargo; Airport Operations; Security; Alliances; International and Regulatory Affairs; Maintenance; Onboard Service; and Flight Operations.

Integration Management Office Takes Next Steps in Integration Planning



The Integration Management Office (IMO) co-led by Lori Gobillot, Staff VP and Assistant General Counsel at Continental, and United's EVP and Chief Administrative Officer Pete McDonald met in Chicago with the IMO leaders from both companies to begin outlining the process for integration planning for its proposed merger with Continental.

As mentioned previously, the IMO will consist of teams that will focus on significant bodies of work that will fall into the following categories - commercial, operations, corporate functions, IT systems integration, single operating certificate planning and

customer experience.

The three broadest areas - including commercial, operations, and corporate functions, include all the major functions of both companies. For example, commercial will include functions such as network planning and sales and marketing; operations will include safety, security, quality and compliance as well as the operations control center, among others; and corporate functions will encompass areas such as finance and HR.

In all, approximately 30 teams are being formed to support each of the major planning and functional areas of both companies.

"The teams we are forming will take a structured, phased approach to their work and will look carefully at all aspects of integration planning to ensure that we set the right foundation for our success post closing," said Pete

United and Continental chose Bain and Company as their merger integration planning advisors. Bain has significant experience in this area, having advised Delta/Northwest on their merger.

In July, United expects to share the full structure and names of the team leaders that will lead integration planning. That team is scheduled to meet for a formal kickoff session together with Continental at the end of the month in Houston.

"We will look for opportunities to use the expertise and knowledge of our organization as we work through the integration planning process," Pete said. "However, it is a priority for the majority of us to stay focused on running the airline and providing exceptional service to our customers."

As the process moves forward, United will continue to provide updates on the progress.

Flight 93 Memorial Chapel Updates

Upon viewing Thunder Bell, Bishop Mascherino was deeply moved to call Thunder Bell the voice of Flight 93, symbolizing the resounding message of the heroes of Flight 93. A summary of what he wrote follows;

"As the impact of their aircraft thundered across the hills and valleys of this tranquil region, shattering the silence of a peaceful day, so their message should thunder in our hearts and lives. Thunder Bell explodes with the message of liberty, freedom and courage. It has a powerful impact in our hearts and minds reminding all who hear it ring that this is what we will never forget. In a very few moments, those on Flight 93 grasped the implication of their desperate situation, and with full realization that they probably would not survive, they acted with courage, determination and conviction. In so doing, they averted unfathomable violence against the nation's Capital. This is the treasure we honor and preserve, that these dead shall not have died in vain."

Competitive Outlook: Offering More Options to the Washington Metro Area



Whether it is business or pleasure, United offers customers more options to the Washington Metro area than any other carrier.

Between Washington Dulles and Reagan Washington National, United has 311 daily flights with 848,000 total seats to 104 cities worldwide. United's closest competitor, US Airways, only offers 185 flights to 51 cities each day. And Delta has fewer than 100 daily flights to a mere 23 cities.

Ask the Doctor – Put The Glass Down



Recently, a friend of mind sent me an account of a lecturer giving a class on stress management. Perhaps some of you have read or heard of this already. I found it amazingly simplistic but very appropriate to each of us as we travel the road of life. Here are the comments in their entirety. I hope you find the words and the message as meaningful as I did.

The lecturer raised a glass of water and asked the audience, "How heavy to do you think this glass of water is?" The audience answers ranged from 2 oz to 10 oz. The lecturer said, "It does not matter on the absolute weight. It depends on how long you hold it.

- ❖ If I hold it for a minute, there is no problem.
- ❖ If I hold it for an hour, I will have an ache in my arm.
- ❖ If I hold it for a day, you will have to call an ambulance.

It is the exact same weight, but the longer I hold it, the heavier it becomes.

If we carry our burdens all the time, sooner or later, we will not be able to carry on, the burden becomes increasingly heavier.

What you have to do is to put the glass down, rest for a while before holding it up again.

We have to put down the burden periodically, so that we can be refreshed and are able to carry on.

So before you return home from work, put the burden of work down. Don't carry it back home. You can pick it up tomorrow.

Whatever burdens you are having now on your shoulders, let it down for a moment if you can. Pick it up later when you have rested.

Rest and relax. Life is short, enjoy it.

The lecture is simplistic in its content, but what a message it conveys! Each of us has burdens to bear during our daily lives. Some of these burdens are rewarding and pleasant, but some are emotionally and/or physically extremely difficult. Some are light and some are heavy. Whatever they are, we need to put them down and rest before we resume the task of carrying them. The point is we need the rest to recharge our batteries. We cannot carry the burden(s) 24/7. Within a short time, we will have a physical or emotional breakdown because our mind and body cannot cope with the stress every minute of every day.

All too often, we continue to carry our burdens then visit our doctor to ask for help. All too often, the doctor listens for a few minutes and then pulls out a prescription pad to give us a pill to take to relieve that stress. If we examine the largest selling medications in the country, we find almost all of the top 10 are tranquilizers, sleeping aids, antidepressants, anxiolytics, etc. Or, they are stomach remedies for reflux, irritable bowel syndrome, colitis, or gastritis. Think about that. If all we did was set down our burdens for a while, the drug companies would be able to focus their research efforts on cancer drugs or Alzheimer's drugs instead of producing endless numbers of drugs to help us cope with stress.

Don't underestimate our bodies reserve for spontaneous recovery if we just set down our burdens for a moment. We don't need a remedy from a pill bottle. Take the advice of the lecturer holding the glass of water. It's not the weight; it's the length of time we hold it. Words and thoughts to live by.

Tilton Named by President Obama to Export Council



Glenn Tilton was named recently by President Obama to the Presidential Export Council, a group of private sector individuals from business and labor asked to advise the White House on ways to double U.S. exports over the next five years.

"The U.S. aviation industry, specifically network carriers that fly internationally, will play a critical role in achieving the goal of doubling America's exports over the next five years, and will continue to be an engine of economic growth enabling global trade and the movement of people and goods," Glenn said.

Glenn, chairman of the Air Transport Association, also serves on Transportation Secretary LaHood's Future of Aviation Advisory Committee, which was formed in April.

In announcing the council members, President Obama said, "Export growth leads to job growth and economic growth. At a time when jobs are in short supply, building exports is an imperative."

"But this isn't just about where jobs are today; this is where American jobs will be tomorrow. Ninety-five percent of the world's customers and fastest growing markets are beyond our borders. So if we want to find new growth streams, if we want to find new markets and new opportunity, we've got to compete for those new customers -- because other nations are competing for those new customers."

Glenn and the other business executives, Obama said, "will offer their unfiltered advice and expertise on how best to promote exports."

Moving Time in San Francisco Leads to Projected Savings of \$140 Million

As with any personal move, when your lease comes up for renewal, it's the right time to make decisions about how to get the most for your money, balancing your financial requirements and your need to make the best use of space. The same is true for United, so when its most recent lease at San Francisco International Airport provided an opportunity to modify the leasehold, United's employees on the Corporate Real Estate team

and at the airport - Flight Operations, Onboard and Customer Service, Maintenance and Operations - rolled up their sleeves and got to work on the move.



Projected to save United nearly 140 million dollars over the 10-year life of the new lease, the relocation and consolidation took place in phases in June, with the Onboard Service domicile moving to the Ramp level, followed by the Flight Operations domicile, the business office and the customer service team.

"We were able to return 100,000 square feet of underutilized space to the airport," says Mike Wuertzer, director-Real Estate Optimization, who emphasized that the space primarily included airport office locations, not gates. In fact, the Corporate Real Estate team has been actively working with stations to right-size our

airport properties to improve the efficiency of our facilities and reduce costs.

"It was a big change for the staff and flight attendants, but the new space looks great and is very functional," says Matt Boom, project specialist-Onboard Service. "What's nice about a new space is that it allows us to look toward the future in the way we operate, communicate, and relate to each other that wasn't available in the old domicile."

"Flight Attendants were pleasantly surprised with the efficient layout and design of the new office," says Peter Haralabopoulos, manager-Onboard Service. "Having Flight Operations, Maintenance, and station leadership nearby will drive even better communication and teaming amongst these departments."

2010 Walk to Empower Proves Abundance of Team Spirit



On Mother's Day weekend, more than 1,500 United employees, family and friends across 10 U.S. cities participated in the sixth annual Breast Cancer Network of Strength Walk to Empower.

And once again, United was represented by more team members and raised more dollars than any other company that participated - nearly 300,000 dollars so far, with money still rolling in.

Easily spotted in all cities with their green shirts and big smiles, the United team was the team to walk with. In Chicago - where the largest walk event takes place every year - even the Governor, who

According to Jamie, the team's original fundraising goal was 3,000 dollars and they weren't sure if they would be able to reach that. "We more than doubled it," he says.

Looking back on race day and the support she and her family received from her colleagues, Milica says, "There are no words to explain how it felt to have everyone there - it was very emotional for me. To be there as not only a participant, but also as a patient ... it was a very meaningful experience for me and my family."

Over in San Francisco, SVP of United Services and Walk to Empower Chair Jim Keenan and the rest of the United team led the charge for their second year of walking - with employees, friends and family members representing almost half of all the participants in the city's walk.

In his opening address to the entire crowd, Jim said, "United's commitment to the Bay Area community is reflected in our nearly 400 teammates here today and their many more supporters behind the scenes."

Red Wolf Pups Fly Toward a Brighter Future



They're downright adorable, and they're some of the youngest VIPs United has ever hosted. Two Very Important Pups - endangered red wolves from Chicago's Lincoln Park Zoo - traveled in first class recently on a special journey to help rebuild their population in the wild.

The pups were accompanied by a zoo employee on an early morning flight a few weeks ago from Chicago (ORD) to Norfolk, VA (ORF).

"I met them curbside, checked them in and escorted them through security," says Dede Kellen, ORD Global Services

Concierge. "We had to take the pups out of their carry-on kennel for screening and I couldn't believe they stayed asleep the whole time."

The pups were later transported to North Carolina and placed with a family of wild red wolves being monitored by the Red Wolf Recovery Program.

"My thanks really go to everyone at the station who were ready when the pups arrived just after 4:00 a.m.," says David Lewis, senior staff representative-Airport Operations Planning, Safety and Regulatory Compliance, who helped organize the trip. "Everything went really well and it was a great job by the whole team."

"It's very rewarding for us to help our partners at the Lincoln Park Zoo in this wonderful effort," says Sonya Jackson, managing director-Corporate Social Investment.

"It's a win-win when we can use our resources to build on a great relationship and support an important, nonprofit community partner."

It's not the first time United has teamed up with the zoo to transport red wolf pups. Last year, United flew four newborn pups to be introduced to the same wildlife recovery program.





A new way to reduce delays by improving the way last-minute aircraft repairs are confirmed and communicated to flight crews is in place at all five hubs and will be rolling out to other stations soon.

Too often, delays happened only because information about something that had to be fixed at the last minute is not communicated to the flight crew at the right time. In many cases, after pilots request a Maintenance Release Document, they've begun their pre-flight checklists. If they were aware of the pending release of the document, they could in many cases push back,

confident they would have what they need by the time they start to taxi out to the runway.

"While they're completing last minute flight preparations and waiting for the doors to close, the flight crews are not necessarily monitoring the maintenance radio frequency," says Flight Dispatch Senior Staff Engineer Don Eberlein.

Meanwhile, a maintenance technician or supervisor is finalizing the necessary paperwork and generating the computer report needed to release the plane, but without knowing the release is imminent, the flight crew often has no choice but to delay push-back.

In an effort to determine the root cause of these short delays, Senior Staff Specialist-Line Maintenance Policies and Procedures Hector Chahin spent time in the O'Hare System Operations Center with Maintenance Controller Dave McKinney. That's where Dave suggested a more direct link to the flight deck during those crucial final minutes.

Hector reached out to First Officer John Cowan of Flight Standards, who suggested using ACARS to let flight crews know when the paperwork is on its way. Don Eberlein helped facilitate that, and so far it's working well at the five hubs.

"Don made me aware that there is already a tool out there, and all we had to do was tailor it to our needs," Hector says.

The ACARS message, Hector stresses, does not replace the maintenance release document, "but is simply a notification that the MRD is imminent, and that pushing back while waiting is a reasonable option."

Once the message is received, pilots can push back from the gate, but cannot taxi until the final paperwork is received, says Cal Janacek, assistant chief pilot at O'Hare. "Most of the time, that doesn't take long," Cal says. "It usually comes through before we've started up the engines, and we're on our way with no delay."

Cal says this is one of many recent examples of how better communication among work groups is having a positive impact on our performance.

"So many times, it boils down to communication," he says. "This is one more piece of the puzzle, and we're getting better little by little, day by day."

Back at the O'Hare SOC, Dave says he has been sending messages to one or two flights per shift, and "I have yet to take a delay on any of them."



As a result, his employee turnover is only 17%, compared to 50-200% for the industry. Mr. Rosen is a most impressive individual.



The Australian Commanding Officer didn't want the "ATC civilians" housed with his "uniformed men". Hall obtained three wooden barracks for the ground crews and billeted the flight crews in Townsville's lone hotel. Shortly after Townsville "became livable", the ATC destination moved to Nadzab Field in the Markham Valley of New Guinea. Here the airfield had 3 landing strips, but no lighting facilities. The crew "living-

quarters" was three miles away on a hillside. It was cooler on the hillside, but the tropical rain-water poured into the tents and turned the road into "gumbo-mud".

Meat and vegetables had been available in Australia, but in New Guinea "C" rations were the "order-of-the-day". The Equatorial sun turned the often shirtless, shorts-clad ground crews as brown as the natives.

At Nadzab, Seely Hall found the crews bathing and washing their clothes in a nearby stream. Heeding their request for a washing machine, upon his return to San Francisco, he found a hand-operated washing machine. The washing machine was flown to New Guinea along with two fir trees ... just in time for Christmas. By this time the crews had moved-on to Biak, New Guinea. The day after Christmas 1944, they received orders to move to Guam (but at least they had clean clothes).



"Ops-Pacific" flying required finding the ever changing destinations while avoiding islands still held by the Japanese. Landings were usually at night and often on "blacked-out" runways (due to air-raids).

Seely Hall, vice-president of United's Western Division assumed the role of Manager - ATC Ops-Pacific. When Hall and Bill Hoare, Superintendent of Maintenance, arrived in Townsville, Australia they found the ground crews living in a muddy tent-city with no lights and eating standing-up in a dirty mess-hall (see photo).
