Letter From The President



On June 28th, **Hank Gosselin**, **Ed Tolle** and I, from RUAEA along with **Ron Jersey** & **Leon Scarbrough** from RUPA, **Don Popovich** from ARECA, **Barbara Vincent** from Clipped Wings, **Gary Humphries** & **Bill Chambers** from Golden Eagles and **Georgia Nielsen** & **Cicina Norton** from RAFA-CW met with Donna Towle and her staff, Mary Luzader, Penny Thomas, Karen Kukla, Darby James from the company.

The main topic was of course the New Pass Travel Program to begin next year. Donna advised that the New Pass Travel Program will be implemented as published. No changes are expected before implementation. The company will continue to look at the program and another survey will probably happen within a year or so.

We let her know that by the company not furnishing any details regarding the new program that many retirees and for that matter, employees are very frustrated. Also the lack of information generates more rumors. She agreed that the company needs to do a better job with communications on this issue and will publish more details on Skynet. We again said that we still have not had any

official response to the combined letter sent to the company on April 8th. Donna agreed to send a response to the issues in that letter. With one item, what about surviving spouses, the answer was that they will continue to have the same pass benefits that they do now at United.

Donna admitted that the company is getting much feedback from employees about the amount of vacation passes in the new program. Also the fact that CO employees and retirees will carryover banked vacation passes. The banked passes will work as they do with the current CO program ... that is one vacation pass per individual. So a family of four would need 4 passes ... with the new vacation passes, all four could fly on just one pass providing they are going to the same destination.

Forwarded emails with add-ons or cut & paste type emails will be ignored and deleted. The petition campaign has had no impact what-so-ever. When sending something to mypasstravel@united.com, be specific about comments, concerns, or questions.

There was a lot of discussion about Date of Hire vs. Years of Service ... bottom line is that this was a conscious decision not based on the survey. Nobody can recall any question in the survey that addressed this issue. With Years of Service, retirees with over 25 years of service will no longer accrue seniority. This is especially harmful to anyone that was required to retire at a certain age like pilots. To begin with Years of Service for United retirees will be calculated from date of hire to date of retirement. It was unclear if adjustments will be made in the future that consider furloughs or other time away from the job.

All United and Continental employees now have pictured ID badges. Continental retirees also have a pictured ID badge. The badges may be used to obtain discounts from various companies. The company will try to get Southwest to accept the ID badge in lieu of the current letter they request for "pass" travel. So the company is working on how best to provide these to the United retirees. More information will be forthcoming on this issue. File numbers ... apparently the only change will be that Continental employee will have new file numbers ... there will be no change to United employees or retirees file numbers.

There was discussion regarding the future of the three Travel Desks that are supported by RUAEA and RUPA. The new leadership was not aware of the Travel Desks and how they work. **Ed Tolle** and **Jack Hooper** have provided them with some historical data. Donna will discuss with Pete McDonald about the future of the Travel Desks. With Continental, there are staff travel offices in the large hubs that can help with plans and issue ZED tickets. Laura Motelet, Director of Employee Travel, is working on having all interline travel on e-ticketing. If a Continental employee/retiree calls their reservation system there is an additional charge.

The quarterly retiree data we have been receiving from the company will no longer be available. The statement was that they have been advised by Legal not to do so. They will include our application and information about RUAEA in the retirement package.

Medical Insurance was briefly discussed but with no new information.

United and Continental operate differently in almost everything. From what we gathered, the integration is not going smoothly. Co-operation between the companies is difficult. Unions are presenting problems. Service in many areas has suffered. Our concerns about the pass policy are miniscule compared to the ongoing problem of integration. It is believed the new pass policy was put in place so the company can move on to the bigger problems.

The company would like to have these meetings on a quarterly basis with the next gathering in October, at which time we would discuss Retiree medical benefits and continue to discuss the pass travel program.

The pass travel program is one of the most emotionally charged issues since the bankruptcy. I never lack for getting emails or phone calls almost daily regarding the “new” program. A lot of the opinions and suggestions are about personal needs and wants. Many think that with the retiree organizations meeting with the company that we are negotiating, but there is no negotiating per se. Although we represent the retiree community, we have no legal standing to negotiate on their behalf. Besides our face to face meetings, there have been volumes of emails and letters sent to the company regarding the new policy. There also has been a petition sent to the company, grievances filed with no impact to date.

Something to consider ... although very few if any of the United retirees along with many employees are satisfied with the new program, but it could have been much worse. Many think that they will never get on an airplane under the new policy. Today there are many retirees with less than 25 years that travel as BP8A and still get on planes. Granted they are in the same boarding category as employees but then there are companions that travel as BP8Cs and they also get on planes. I would like to pass on a quote from a retiree *“I retired with 11 years 4 months seniority in ‘97” and have enjoyed my flight benefits to the fullest in the time I’ve been retired and that includes traveling all over the world with annual trips to and from China. My point is I have always gotten on a flight, maybe not always in the section I’d like to have had but always gotten on. Do I have to wait sometimes a little longer than I would like, yes **that has happened**, but that is just part of the process of traveling as a SA. Most of my problems (troubles getting on) have always been domestic (I have to just laugh to myself and as my son says: Suck it up) when I walk up to the new reader boards and find I’m number 36 or more on the Stand-by list but somehow I always make it to my destination. So, as you can see I’m happy and glad that I have what I’ve got and just hope that I can keep this benefit until I can no longer use them.”*

Don’t get the wrong idea that myself and the leadership of RUAEA will not strive to get as much of the United program back in place. We will continue to do whatever possible to see improvements. And also do not forget travel is not the only benefit that can be changed. Medical Insurance is in most cases much more important. We are addressing that issue as well.

Take advantage of fee-waived economy pass travel



As United announced in June, all subsidiary UA, CO and Continental Micronesia co-workers, retirees, early outs and eligible pass riders can pass travel fee-waived in economy class, regardless of their years of active company service, on all US CO and UA domestic flights, including Alaska and Hawaii. Fee-waived economy travel also applies to flights within the Micronesian islands, as well as between Guam and the Micronesian islands.

The new fee-waived economy travel privileges remove the ZED service charges from the interim program that UA co-workers pay to fly on CO flights, as well as the charges CO co-workers pay for travel on UA flights in all domestic markets. UA and CO co-workers will continue to pay applicable service charges for traveling in premium classes on their respective carriers. Co-workers of each subsidiary will continue to receive a 33 percent discount on ZED fares for travel in premium classes on flights operated by the other subsidiary. Service charges for buddy passes/companion passes remain the same for flights on both subsidiaries.

United urges pass riders who have pending domestic economy reservations created before June 7 to cancel the bookings online and re-list to take advantage of fee-waived travel. The changes are part of the company’s efforts to harmonize its new pass travel program for co-workers and retirees. The full program will be effective

United signs up for bio-jet fuel derived from municipal waste



On June 20th, at the Paris Air Show, United led a core group of airlines in signing a letter of intent with Solena Fuels, LLC to purchase a future supply of jet fuel produced in Northern California and derived exclusively from municipal and agricultural waste. The project will divert approximately 550,000 metric tons of waste annually that otherwise would go to a landfill, while producing jet fuel with significantly lower emissions of greenhouse gases and local pollutants than petroleum-based fuels.

“This agreement demonstrates our commitment to a future that is environmentally sustainable, by advancing and using environmentally responsible and cost-efficient alternative fuels,” said Environmental and Security VP Toby Enqvist.

The Solena agreement is similar to those United has signed in the past with Rentech, AltAir and Gevo. In each case, every deal has to meet United’s requirements to achieve lower emissions on a lifecycle basis, be no more expensive than conventional jet fuel, meet operational performance characteristics and achieve strict safety standards.

United expects approval from the American Society for Testing and Materials in July on the biomass-derived fuel certification, making bio-jet fuels a reality for commercial use as a 50/50 blend with conventional jet fuel.

“The project is well-positioned to provide the new United with low-carbon fuels for flights to the European Union out of San Francisco, potentially offsetting some of our cost exposure to carbon regulation in Europe,” said Global Environmental Sustainability Managing Director Jimmy Samartzis. *“This project helps achieve our environmental and operational goals, as well as address cost both from a fuel volatility and regulatory perspective.”*

Narrowbody seat numbers now aligned



Overnight June 8th, crews installed new seat row numbers on 234 of UA’s Boeing 757 and Airbus 319 and 320 aircraft (except p.s.-configured B757s). The renumbering aligns UA and CO subsidiary fleets, which enables a more seamless experience for its customers and simplifies seat re-accommodation due to schedule or equipment changes.

United began preparation in March when it loaded the new seat map into Apollo. Since then, agents have successfully worked with customers who had questions about the seat assignments on their PNRs when booking travel for June 9 and beyond, because some

row numbers will not be sequential.

In addition, *“we briefed flight attendants and prepared them for potential customer issues,”* said Onboard Service Planning Senior Staff Representative Dana Sorensen. Also, customer service representatives prepared for possible operational issues; including inadvertent use of old seat maps before the maps are decommissioned. Meanwhile, maintenance crews installed the new placards.

Tech Ops Manager Bob Loess teamed with stakeholders from Line, Base and on-call Maintenance, Maintenance Control, Maintenance Schedule Planning and the Operations Control Center to remove the old placards on all but a handful of aircraft that were in paint or maintenance. *“The collaboration and focus paid off, with no delays attributed to the installation,”* Bob said.

Airport Operations Merchandise Loyalty Program Manager Sharon Tenuta pointed out that, *“with the support of the Automated Check-in and Day of Departure Desk teams, we were able to minimize operational disruptions.”*

Chicago Mayor, Jeff talk jobs and aviation, visit Ops Center



Chicago Mayor Rahm Emanuel and Jeff announced on June 10th, that United will locate approximately 1,300 jobs from around the system in downtown Chicago in the next 18 months, in addition to those the company publicly announced previously.

All of the approximately 1,300 Chicago positions are built into United's divisions' organization plans as part of the integration planning. United has already notified many co-workers whose positions are moving to Chicago. Others are dependent upon the completion of the talent selection process, and the company expects that there will be few instances where management and administrative roles not currently earmarked for Chicago will be located in Chicago.

This will bring the total number of co-workers in downtown Chicago to just over 4,000 when the moves are complete. As United has said previously, it plans to continue to maintain a significant presence in Houston, as well.

Mayor Emanuel also announced that he and Jeff discussed hosting a meeting of international aviation experts in Chicago within the next three months to discuss how to make the city more economically competitive.

Flight attendants vote to be represented by AFA



The National Mediation Board announced on June 29th, that United's flight attendants have elected the Association of Flight Attendants (AFA) to represent them. More than 21,000 UA, CO and CO-Micronesia co-workers took part in the voting. The final tally was 11,942 for AFA and 9,745 for International Association of Machinists (IAM).

"This is another important step forward in our integration process," said Inflight Services SVP Sam Risoli. "We will continue to focus on reaching combined agreements for our flight attendants, and we look forward to a constructive working relationship with the Association of Flight Attendants."

UA orders winglets for 767-300ERs



To continue to reduce fuel burn, United has ordered winglets for UA Boeing 767-300ER aircraft. Aviation Partners Boeing (APB) announced the order at the Paris Air Show.

"The installation of winglets on our aircraft improves the fuel efficiency of our fleet and also reduces our greenhouse gas emissions," said Fuel Efficiency Managing Director Joel Booth.

“Fuel is our largest, most volatile expense, and winglets help offset rising fuel costs.”

United plans to begin installing winglets on the UA B767-300ERs early next year. Winglets on the B767-300ERs can extend the range of the aircraft or increase the payload of the aircraft.

United currently has winglets on B737-500s, -700s, -800s, -900s, -900ERs, and on its B757-200s and -300s. The Airbus aircrafts feature wingtip fences that also help increase fuel efficiency.

Boarding process tests continue at IAH and ORD



United is currently testing various boarding processes at IAH and ORD to determine the best way to board in zones moving forward. With differences in boarding times, Economy Plus and bin sizes, there are a number of factors playing a role in United's overall decision making.

Based on customer and co-worker feedback, United decided to simplify its boarding process and boarding announcements. UA flights returned to boarding by zones, while CO flights will continue to board rear-to-front for the time being. The Information Technology department has found a way for Shares to support zone boarding, which will allow CO to board in zones in the near future.

United has not, however, made a final decision on the long-term

zone boarding process.

“We saw a substantial increase in the number of UA delays after we rolled out the aligned boarding process on May 11 and believe these recent changes will make it easier for our gate co-workers to better serve our customers,” Airport Operations and Cargo Sr. VP Scott Dolan said.

According to comments on a number of social media outlets, such as FlyerTalk, Facebook, Twitter and other travel blogs, customers seem to be happy with United's latest decision.

“It's always nice to see when United responds to customer and employee prompting,” said Matt D. on the Live and Let's Fly travel blog on upgrd.com.

United focused on root cause of routing failure



A network connectivity issue at the Operations Center's Data Center on June 17th, significantly impacted UA operations, causing about 30 cancellations and more than 400 delays through the weekend. Many co-workers at both companies worked tirelessly throughout the weekend to resolve the issues and restore stability to the more than 40 applications affected by the outage (see the story posted on Flying Together and an email from COO Pete McDonald for more details).

“What is most important is that we are learning from this experience and improving our operation to prevent a recurrence,” said Chief Information Officer Bob Edwards. *“The technology*

team will dig deep into understanding the root cause of the routing failure that prevented our stations from communicating with critical systems. We will make architectural changes if we determine those will help prevent this from happening again and will continue to focus on our incident management procedures.”

CO, UA now co-located in 43 airports



United's gates and ticket counters are now co-located in Indianapolis (IND), bringing to 43 the number of airports where its two subsidiaries are positioned side-by-side.

The transition went very smoothly, said General Manager Ophelia Caldwell-Dames, and customer feedback was very positive. *“They were delighted we had finally moved together,”* she said. She thanked IT, Corporate Real Estate and co-workers for making the change virtually seamless. Four to six more domestic stations are scheduled for at least partial co-location before the end of June.

In addition to the airport co-locations, United continues to bring city offices together in places where CO and UA previously had separate operations, including Frankfurt (FRA), Germany, and Zurich (ZRH), Switzerland, most recently.

New Stuttgart service proving successful after smooth startup



Customer reaction to United's new EWR-Stuttgart (STR), Germany, service has been very positive, and United's new station overcame a relatively short start-up schedule with exceptional cross-divisional cooperation and support from the airport and service partners.

Bookings, including those for BusinessFirst, are *"in line with our expectations,"* said Sales Regional Director Thorsten Lettnin. Since the launch of EWR-STR Boeing 757 service on June 9, he added, *"we have had corporate travel managers calling our sales managers to thank us for putting this route into service."*

Airport Operations Regional Managing Director-Europe Jill Eshbaugh said great collaboration among teams of co-workers from many divisions and departments made the station opening *"one of the smoothest we've had."* STR airport officials and the airport community, United's service partners, and the leadership of Station Manager Andrea Kuchenbuch-Schipper all contributed to the successful launch.

Firms based in Stuttgart include Daimler, Porsche and Bosch.

United is promoting the new United in Ireland, Northern Ireland



Transatlantic, Middle East & India Sales VP Charles Duncan joined United's Irish Sales team for a series of events in Ireland and Northern Ireland recently to promote the new United to customers, travel agents, government officials and the media.

In Belfast, Charles met with Bombardier, CO's largest corporate account in Northern Ireland, government and airport officials, trade professionals and the US Consul General. In Dublin, Charles and U.K. & Ireland Managing Director Bob Schumacher co-hosted the annual Travel Agency Advisory Bureau luncheon, attended by 15 of United's top travel trade partners with combined revenue of close to 15 million Euros.

"CO's close relationship with local business partners is founded on our commitment to providing year-round service from three airports in the island of Ireland," said Ireland & Northern Ireland Sales Regional Manager Yvonne Muldoon. *"Our business customers are delighted with our newly enhanced BusinessFirst product; the flat-bed seat differentiates us from the competition."*

More than 600 U.S. companies have operations in Ireland, with 20 more planning to start operations. CO operates non-stop flights from EWR to Dublin (DUB) twice daily, Shannon (SNN) 11 times weekly and Belfast (BFS) daily.

United builds its brand in Scandinavia



United's Sales team recently concluded a month-long sales blitz in Oslo, Norway; Copenhagen, Denmark; and Stockholm, Sweden, focused on building United's presence in the market. The team visited approximately 1,500 travel agents in each Scandinavian country, touting our New York area service. More than 100 travel agents from travel management companies and major travel agencies attended each event during United's *"Scandinavia Travel Agent Appreciation Month."*

Europe, Middle East, Africa and India Marketing Regional Director Shaul Shambico and Sales Regional Director Northern Europe Lucas Geerts thanked the travel agents for their nonstop support of United. In addition, United showed its appreciation with entertainment provided by a group from New York City that put on a "Late Show"-style show at each event to promote the company and our nonstop service to New York.

United operates daily Boeing 757-200 service between EWR and Oslo (OSL), Copenhagen (CPH) and Stockholm (ARN).

United battles weather and more volcanic ash, misses on-time goals



Challenging spring weather continued into summer, with violent thunderstorms in DEN and ORD and United's East Coast hubs and extreme heat in IAH in June. United also faced a double ash threat with erupting volcanoes in South America and Africa affecting routes across several continents.

During the month, United had four severe weather days, when the company canceled or delayed 10 percent or more of its flights due to weather or ATC conditions.

Co-workers worked hard through these difficulties and a system outage. United did not achieve its domestic or international on-time

Arrival :14 (A :14) goals in June, after earning a \$50 payout for meeting its international goal in May.

For the month of June, United's preliminary Arrival :14 (A :14) on-time percentage for U.S. domestic was 74.8 percent and for international was 76.7 percent. The company's On-Time Bonus Program goal for both measurements is 80 percent.

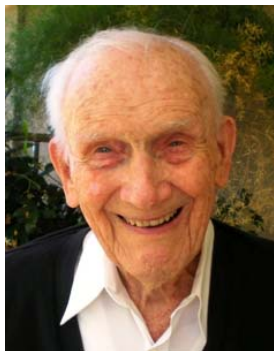

Writer's Column - Al Kaiser, by R. D. Jaramillo



Meeting Al Kaiser, in the capacity as one of his caretakers, brought to vivid life the writings of Tom Brokaw, the NBC anchor, who wrote "*The Greatest Generation*." Al is well respected as a former top negotiator for United Airlines at the time of its most prolific growth, the years right after the Second World War. Because of his interpersonal skills, and the values and attitudes, so well articulated by Brokaw as representative of his generation of Americans, Al was voted to be the representative for all airlines in their dealings with municipal, state and federal institutions.

Al is 98 years young now, and in remarkably good mental, emotional and physical health in Vineyard, a suburb of the state capital, Sacramento, California. His intellectual and social acuity is immediately experienced upon first meeting: He looks at you directly with a gaze that appraises and considers attentively, functions extremely well-honed after decades of negotiation at United. Something indefinable begins to take shape in your mind

regarding Al after time spent with him: A sense of integrity, a rather strict correspondence between what he thinks, feels and says and what he does. You can trust this man. He is honest, straightforward, and he is a people person. Unusual in this age, Al is other oriented and centered. There is no other way he would have been so good at what he did - earning his daily bread - but by taking a proactive part in understanding others first, so that he could find a way to satisfy all concerned in the negotiating dynamic. Being with others, we all understand that complete individual satisfaction may not be attained, but a group consensus that is fair minded, and above board is nearly always possible. It takes work, Al was never afraid of work, in fact it has provided breadth and depth to his being; and it takes “smarts,” or, perhaps more accurately stated, it takes an attitude of active listening, and wanting to find mutual solutions. Like a person of his generation might be heard to say, “*You have got to give respect before you receive it!*” That’s the way Al comes across, as he puts his full attention to you: that you are worthwhile, and that you deserve being listened to.

Isn’t this what Brokaw was referring to, these values and attitudes that made this generation so unique and successful? The perspective that we’re all in this together, that we have a common purpose, that each of us has value; and to achieve the understanding, that first, and, “*above all, responsibility for oneself*” is the key principle. Al apparently learned the lesson early in life. Being the second oldest child, and oldest male in a Kansas family, his father was a pastor, a man who had turned to taking care of others after initially being a farmer. Al graduated from Wichita State before attending law school at the University of Kansas, at Lawrence, about a year before war broke out for America. Times were tough for a just graduated attorney. His first good paying job came as a result of a return meeting with one of his professors, who thought, of all the law graduates, Al had the best chance of succeeding as a counselor. But the job he obtained was for the Federal Farm Security Administration, where typically he had to negotiate fair settlements with farmers whose cows had broken through fences and been struck by a locomotive. Al had to find a fair price by reading the local paper on the price of cattle. He brought facts to the table. That and his honest approach to people made his tenure at this employment successful.

Another tip by a friend led to his employment with United, not as an attorney, but as a manager of the ticket counter at the Chicago airport, a position he kept for about two years. Then, for six months, he went to the United Airlines school for management training, at the end of which time, his supervisor told Al that he was better at his job than he was. Then, Al was cast into the position of competing with other airlines to secure city airports for United’s passenger business. Now, these were the “Wild West” times of opening airports in various cities, and Al, through his fair handed approach, was voted to be the representative of all airlines in negotiating with the government entities. By Al’s own account, a few of the other airlines were not acting in the interest of all, but only themselves. This behavior, he explained in his usual matter-of-fact and reasonable way, was not conducive to any one airline’s interest, much less to them all, and would only cause confusion for all involved. I wish you could hear exactly how Al describes these encounters, since his demeanor and even voiced explanations of what rational, productive behavior would produce, would affect you as it did the representatives of most of the other airlines. That’s why Al was selected by them to act as the one voice to interface with the government agencies. Again, that trust factor, that transparent and intelligent voice of reasonable analysis and probable predicted beneficial outcome for all involved, would sway you today as it did for those airline representatives and government spokesmen of yesteryear. Even after retirement, Al was one of the founders and the first president of the Sacramento Gold Diggers, the local branch of the Retired United Airlines Employees Association.

At his retirement in 1978, United Airlines’ top negotiators flew in from all parts of the America to pay homage to a peer who had distinguished himself in their profession. As it happened, snowstorms kept many of them at airports, but they stayed there until the weather cleared, then continued on for the commemoration of Al’s retirement, because they had formed personal relationships with Al and they would not miss saying goodbye. “*The Greatest Generation*” lives on in the person of Alfred Kaiser. We can learn from him what it really means to be an American. If you give him a call, and he’s open to it, you might be reminded about the values and attitudes - that perspective and state of mind- that made us a great nation, and why it’s still possible to be the best we can be. Al has always seen it in you. Maybe that’s what makes him so special.

My personal bio will explain something about the history of United Air Lines in its early period.

In 1940-41, I had a small flying school in Sacramento, CA, flying an Aeronca Chief and an Aeronca Defender. After December 7, 1941, all civilian flying was suspended within 150 miles of the west coast. My school of course, was affected. I closed the business preparing to join a former student who was an Air Force officer who transferred from Mather Field to Long Beach, CA. He was to set up a ferry command and asked if I would be interested. If so, come to Long Beach for indoctrination.

I usually drove to Los Angeles on Highway 99 to the Los Angeles area. This time, however and fortunately, I chose to take Highway 101. This one small choice changed my whole life. Driving down, I saw a large sign which read "Airport" and also the words "United Air Lines". I drove in without hesitation, entered the building and looked around. I noticed a gentleman coming out of Seely J. Hall's office with a long yellow legal pad and pen in hand. He introduced himself as **Ken Gallagher** and asked if he could help. My answer was, "Yes, I would like to apply as a pilot". "Come with me" was his immediate reply.

Ken Gallagher took me to a conference room, excused himself to get some papers. He asked that I fill out the required Holmes Wadsworth Test. As I completed each sheet of questions, he graded them. When finished, he took me to Dr. Ladd in the Medical Department. I was given a complete physical at that time. I passed the physical and they sent me home to wait for the Sacramento Station Manager's pass indicating that I had been chosen to attend the Boeing School of Aeronautics, a subsidiary of UAL, training co-pilots with the emphasis on becoming captains. Needless to say, my trip south to Long Beach went no farther.

Boeing School of Aeronautics had been relocated from Tracy, CA to Cheyenne, WY. My class was "eighth" at Cheyenne. During that time, from March until May, the school was humming with activity. **G. I. Meyers** was the Director of Flight Training. And there were a number of instructors. I was assigned to **Bud Jordan** for my cross country work in a Ranger Fairchild 24. **George Wilbur** was my instructor for instrument training. The DC-3 and Boeing 247 check out was conducted by **Nat Messer** and **Charles Doyle**.

Our ground school consisted of meteorology, instrument training, and the Link Trainer. **Doris Langher**, a "99er" with many hours of cross country races to her credit, was the instructor with Link Training. I have 270 hours of Link Trainer time. At that time, simulator experience was very new. Mr. Orendorf was my meteorology instructor. His philosophy was that we know 280 "bits" of information. By ""bits", I learned he

meant paragraphs! For our final test, the information was taken off a teletype, we drew a weather map and forecasted the weather at the stations to which we were flying. Although it was a very tough test, we ended up as senior meteorology forecaster, which has helped me all through my career and beyond.

Upon graduation, I was assigned to Pacific Operations as a navigator-in-training. The navigators that were hired had not finished their training. This group from the Boeing School was trained in everything except celestial which we took with **Ned Simpson** instructing. Ned had been a navigator with Pan Am until transferring to UAL as a co-pilot. To finish our course, we went to Oakland Naval Base to be taught Morse code. Fifteen words per minute were necessary to send and receive. At this point we were assigned crews. But, since the airplanes from the Army Air Force had not arrived, we were reassigned to SFO as DCS co-pilots.

March 1943, I was reassigned to Pacific Operations as a co-pilot checking out in the C-87 (a B-24 converted to cargo). I recall it held 35 passengers and 4000 pounds of cargo. The crew consisted of a Captain, First Officer, Engineer, Navigator, Radio Operator, and Purser. Remembering some of my first captains during those early years were **Larry Letson, Jimmy Johnson, R. T. Freng, George Boyd** and **George Douglas** whom I flew with in transitioning to the C-54 (better known on the line as the Mainliner 230). During this period, we flew under the auspices of the Air Transport Command. My 13 month tour at that time took me from Hamilton Field to the South Pacific, Hick am, Canton Island, Fiji Island, New Caledonia and Brisbane, Australia. We also flew into Guadalcanal, Port Moresby, New Guinea, Auckland, New Zealand, and sometimes, Attutaki, Bora Bora, and Samoa Group. These were wonderful experiences.

In March 1944, to continue my co-pilot duties and to start my captain training, I transferred to PDX. **Bill Groen** was the Chief Pilot. He informed me that I was now being transferred to MDW, Chicago. Foolishly I said I wanted to go to LAX, since family was there. He was very clear. His answer was *"You have a choice, either go to MDW or I was fired."* My answer was quick and very clear. *"What time does the train leave for Chicago?"* If any of you knew **Bill Groen**, you will understand.

In January of 1945, I was graduated to three and a half striper captain, cargo only. In July, I took my check ride for passenger four striper captain and was upgraded on the DC-4 -6-7, Convair 340, Douglas DC-8, Boeing 720 and Boeing 747. I flew the Boeing 747 from 1972 until July 15, 1978.

During the Korean War, I flew Mac Charters, and during 6 years of the Viet Nam War, I flew DC-8 Charters. So my navigation training was put to good use. After retiring in 1978, I had the opportunity to fly for 17 years for Mercy Flights Inc., an air ambulance company in Medford, OR. The insurance company happened to notice I was then 77 years old and thought that was much too old. However, it was my good fortune to acquire my flight instructor rating. My wife, Phyllis, had encouraged me to get this rating along with CFI, CFII and MEI. In 1987, I started instructing and am still doing so now. I have given left seat time in the DC-3 and DC-4 using my ATP. They did that way back then. I really enjoy the challenge of instructing a student who has never flown and watch them blossom into a fine aviator. Tomorrow, my student will be flying a Lance. Each student brings an enjoyable challenge.

During my career with UAL, I had the privilege of being Council Chairman of Council 57, LAX. I saw the airline grow from a small seedling to the beautiful airline of the 60's and 70's when ocean to ocean service was the epicurean delight and people travelled in attractive attire. I hope this bio helps to show the training and background of most of the UAL pilots during those early years. Their skills and dedication brought UAL the coveted title of "the on-time airline".

I will have some fun stories for next year - especially one about **Marv Stolley** and the monkey. My Phyllis has been really busy with her knitting designs. She now has 17 dress forms in her knitting studio, each wearing one of her creations and there are more to come she says. Tatiana, our Coton de Tulear, keeps us both delighted and amused all the time. Love to all, Cliff Chaney

I took the test and passed it and worked for 18 years as an inspector. I worked 6 years as a jet mechanic and retired with 23 years of service.

This is a story that will be understood by retirees I call, "**old timers**". It took place sometime between 1966 and 1970 during **George Keck's** Administration; I was in Chicago with a team of mechanics repairing a damaged airplane. I had a very good friend in Chicago who was an Instructor in the Education and Training Department at the Headquarters building. At this time, I had been with UAL somewhere between 18 to 22 years and had never been to the Head Office. My friend showed up at the airport and told me he could not understand how anybody could work for UAL that long and never been to the Headquarters. He insisted that I go with him to that Building for a tour, so I went with him.

We toured the Building and then came to the section where the President's offices were. He told me this was hallowed ground and we couldn't go there. I poked my head around the corner so that I could see down the hallway. There was a desk in the hallway with a lady sitting behind it. She saw me and asked if she could help me. I told her I was a visitor and my friend had said I couldn't go into that section. She laughed and said, come on in, there is nobody here and I will show you the offices. My friend refused to go down that hallway, so I went alone. The first Office she showed me was George Keck's. He was the President that took the office in 1966 after William Patterson retired. She then showed me the conference room and told me that William Patterson had cried because they had to shorten his favorite walnut conference table in order to make it fit this room when they moved the new Headquarters. She then told me to go into Patterson's office where he had a glass case with many mementos in it. I went in there alone and was bending down looking at all the mementos when there was a tap on my shoulder. I turned around and much to my surprise, it was William Patterson. He was just returning from his daughter's American Airlines stewardess graduation in Texas. It was the first time I had seen him in person and told him I thought he was a myth. We had a nice chat about people we both knew in San Francisco. I don't know why but I felt uneasy and told him I had to get back to the Airport to make sure the job was going OK. The reason I am telling this story is because what he said when I told him I had to leave, it was one of the saddest statements I will never forget.

He said, "*that's the problem, nobody has time for me anymore*". This statement came from an industry wide, well respected man that practically built United Airlines.

For people that are not familiar with that era of United Airlines, it would pay you to go to Google and type in, "United Airlines President William Patterson". You will be amazed at the difference in the way United was managed at that time compared to the way it is managed today. I believe the retirees from that era worked in the "**golden years**".
