

# RUAEA 2012 Convention, October 3-7



Currently, the Hyatt Regency is very low on rooms for October 1-3. There are a number of other hotels in the area that might still have accommodations. We would also suggest The Americana Hotel at 1400 Jefferson Davis Highway a short distance from the Hyatt. #### Heat alters operations, especially at high altitude



While hot weather can affect United's operations anywhere, it can be much more disruptive at high-altitude stations, including DEN (5,141 feet) and others ranging from BOG (Bogota, Colombia, 8,361 feet) to MEX (Mexico City, 7,316 feet)

High, hot air is thin air that reduces lift. To compensate, UAL often reduces takeoff weight, adds fuel stops or increases takeoff roll distance. In extreme cases, United may have to cancel flights. At DEN, a high of 100 degrees and an altimeter setting of 29.40 forced United to cancel a dozen ExpressJet flights affecting about

400 customers. Those 50-seaters face restrictions when the mercury rises to 95 or higher.

#### United makes progress on through flights



If you've checked availability or flight status lately, you may have noticed that United has a lot more flights that make stops than it used to. United's increased usage of these types of flights, otherwise known as "through flights," isn't because of a change in strategy but rather because the company does not have enough flight numbers to support its entire United/United Express operation.

Unfortunately, many of United's systems do not handle through flights well. Normal processes like upgrades, seat assignments, mileage credit and more don't work in the same way as they do for individual nonstop flights.

Permanent improvements for handling through flights are in the works for next year, but in the meantime United has made some great progress toward reducing the symptoms. For one, the company is addressing the most critical issue, which is upgrades, by dividing through flights into individual flight segments for its Premier members before their upgrade window opens.

As a direct result, customers booked on through flights are now clearing upgrades more reliably. In addition, United is reducing the number of through flights. Starting August 28, United will no longer sell domestic to/from long-haul international through flights except for those markets in which they are mandated by regulatory reasons. United is also targeting similar efforts for the remainder of its network by year-end. This is a collaborative effort between the Network, Contact Center, IT and Customer Experience teams to improve the traveling experience for United's customers.

#### United's growth means more gates at SFO



As SFO operations grow, United is using additional gates for some domestic arrivals and departures. United is using gates in Terminal 1 to augment its operation in Terminal 3 and the International Terminal and is providing frequent airside bus links.

UAL is using the new gates primarily for Southern California and LAS (Las Vegas, NV) traffic. The <u>SFO website</u> has detailed information on how the changes affect transit to, from and through the airport. United will use the gates until

renovations of Terminal 3's Boarding Area E are complete in November 2013.

#### Get the latest interline travel updates



Airlines regularly change policies and procedures for interline travel. Visit the <u>Travel tab</u> to get the latest updates.

Austrian Airlines, Thai Airways and Adria Airways introduced new listing procedures for co-workers, retirees and eligible pass riders through the MyIDTravel website. Pass riders will continue to order tickets on these carriers through the ZED & ID Ticket Request Form. Please request interline tickets at least 24 hours in advance of your travel date.

Meanwhile, LOT Polish Airlines and Swiss no longer offer listing through <u>flyzed.com</u>. Going forward, eligible pass riders who wish to travel

on Swiss will visit swiss.com/zed, while those who want to travel on LOT must contact the airline's call center at 48-22-577-95-72. See News & Bulletins on the Travel tab for details.

#### Turbulence injures five on IAH flight

Severe turbulence rocked a Boeing 737 that was en route from IAH to LGA (New York-LaGuardia), injuring three flight attendants and two customers. The turbulence struck about a half-hour after takeoff. United diverted the flight to LCH (Lake Charles, LA) for several hours before the flight resumed to LGA.



Aviation Safety has launched a formal investigation and is working closely with both the NTSB and the FAA, which is routine in such cases. Inflight Services representatives went to LCH to support the injured co-workers.

Staying safe during turbulence remains a priority for United's flight crews year-round, but in North America the chances of choppy air typically increase from April through September. While dispatchers and flight crews can anticipate conditions that may create turbulence and plan accordingly, sudden shifts in air

movement can happen without any warning. United's cross-divisional Turbulence Mitigation Team stresses improved awareness and communication among its crews as well as between pilots and the Network Operations Center, air traffic controllers and pilots of other flights.

#### **Scanners speed entry to United Clubs**



Checking in to the United Clubs is now smoother thanks to a solution that grew out of the PSS SWAT Team's work. Now, club members may present their boarding passes rather than membership cards and ID to enter any of United's clubs. United deployed additional scanners to the clubs and modified the Automated Tracking System (ATS) software so that it can read boarding passes and quickly validate membership.

"Scanning boarding passes is more efficient and eliminates the need for a second form of identification," explained United Clubs & Global Services Operations Managing Director Russ Compa.

#### Jet fuel price now more closely tracks price of Brent oil



The price of jet fuel now more closely tracks the price of Brent crude oil rather than West Texas Intermediate (WTI) crude oil, and that's a significant consideration for United in running its business.

Since the mid-80s, WTI had been the U.S. benchmark for crude oil prices and a key barometer for crude oil prices globally. Starting in the fourth quarter of 2010, however, a mismatch between growing North American (Canadian and U.S.) oil production and physical infrastructure for transportation and refining of oil in the U.S. has led to a buildup of surplus oil inventories in North America. As a result, the price of WTI has been depressed relative to other benchmark global crude oil prices,

sometimes up to \$25 or \$30 lower, and does not track changes in jet fuel prices well.

Until these physical infrastructure constraints are adequately addressed, experts expect WTI to be a "broken" benchmark for jet fuel and world oil prices. Over the same time period, the price of Brent, another key global oil benchmark, has tracked very well with jet fuel. In addition, Brent crude oil is used to set the price for nearly two thirds of the world's oil consumption. Many airlines have stopped using WTI in their financial planning and hedging activities, as the financial trading community moves to Brent as the benchmark for crude oil prices.

Variability in the price of jet fuel, which is refined from crude oil, is so important to United's business because jet fuel is close to 40 percent of its operating cost. It's not only the single largest cost, it's also the most volatile, and this year United saw swings of more than \$2 billion in the company's annual fuel bill in a single month (May). Since airlines operate in a brutally competitive market with tight margins and sell tickets for a fixed price well in advance of the date of travel, United generally doesn't have the ability to react to volatility quickly. It takes time for United to adjust capacity and fares, and the price of oil (and jet fuel) moves rapidly.

Therefore, tracking against Brent allows United to more accurately plan for fuel costs and improves its ability to more effectively hedge fuel costs. For the near term, United will publish both WTI and Brent prices in United Daily so that co-workers can see the often significant volatility in this market. United expects to publish only Brent (and jet fuel) prices soon, as Brent has become the relevant benchmark.

#### **Travel Tips from RUAEA Members**



In this issue, we include a comprehensive Travel Policy Guide starting on page 35 as part of our effort to provide members with as much information as we can in understanding the new pass travel rules. We would also like to publish tips sent to us from retirees who want to share their travel experiences with other RUAEA members. The following letters are from those retirees. **Editor's Note**: *The following members have offered suggestions to assist us* 

with our travel needs. The RUAEA newsletter staff welcomes suggestions to share. However, we have not verified them and do not confirm their accuracy.

From Carrie Ettredge (carelin606@gmail.com) ~ Seems like you need some kind of smart phone or PDA to travel standby. I looked at smart phones and decided, not for me! The Nook (sold at Barnes & Nobles bookstores) or the Amazon Kindle Fire (sold on internet) are useful alternatives, with no monthly fees like the smart phones. The Nook and Amazon Kindle Fire cost about \$200. You can get on the internet at any Wi-Fi place, which I understand, is almost anywhere nowadays. I didn't understand Wi-Fi but the Nook just goes to it automatically when in range. There are many other uses for it, reading books, magazines, email, games, etc. but I bought it to use on standby. This information may be useful for those retirees not online at all or like me, afraid to venture out on standby status without net access.

Remember to ask the sales person if the E-reader you choose has web browser capabilities. Not all E-readers do and you need it to access the internet.

From **Ed Martin** (edmartintx@gmail.com) ~ I just returned from a trip to Europe and discovered a new procedure in refunding an unused ZED ticket. So I thought I would pass this along to any retirees that may occasionally buy a ZED ticket backup for foreign travel. Previously, we could get ZED tickets refunded at the local ticket counter (depending on work load) or send then to WHQAK for processing. **No longer!** There is a new procedure now with a new form and address. Most important is the address that it is sent to: Houston, Not Chicago. The address shown on the form is: United Airlines Refunds Department, Attn: Refund Accounting, PO Box 4607, Dept. HQJRF, Houston, TX 77253.

From Steve Peek (<a href="mailto:scpeek@gmail.com">scpeek@gmail.com</a>) ~ I thought I needed to advise retirees about a problem I ran into when returning to DEN from FRA this week. I booked a flight for my wife, myself and enrolled friends. I received a record locator, so I thought I was booked. The next morning at FRA, I was told that no ticket numbers were attached to that booking. Because of this, we missed standing by for the ORD flight. I was told that the agent couldn't help me and that I had to rebook on a later flight via the internet.

The gist of the story is, when you book your flight, don't assume that you are set; just because you get a record locator, don't assume you are booked. Get ticket numbers and print them or write them down, otherwise you might get stuck like I was. Also, on the way to FRA, our flight from IAD to FRA was diverted to BOS. It then canceled about 0300 and we stayed overnight at a hotel. The flight, with a new flight number, left for FRA the next evening. This caused me to be charged with two more vacation passes than were actually used. What a great system! Retirees: beware.

May be this will help someone avoid the problem I had

We miss seeing two of our favorite people, **Frank** and **Brigitte Murdock**. Brigitte assures me that they are in good health but need to stay close to home these days now that Frank is slowing down at age 93. I was able to encourage them to submit his UAL history which is an important part of history for so many of us. It is as follows:

Frank N. Murdock – UAL Bio – 1943 – 1980 ~ In 1939, when 20 years old, and prior to his airline employment, Frank worked as a truck driver and became a member of the Internat'l Brotherhood of Teamsters. Because of the worsening world situation, he decided to be part of the war effort by becoming an aircraft dispatcher at Hill AFB. These duties were similar to those in the airline industry. While Frank was in training at the Base, the U.S. gov't established the U.S. Air Transport Command, which, in Sept. 1947, was renamed

USAF. He first worked for Continental Air Lines until their gov't mail contract expired. He then sought employment with UAL in SLC and was hired the next day, to be assigned again to Hill AFB in the capacity of UAL's Air Cargo Representative. By 1944, UAL's gov't mail contract had also expired and Frank was transferred from SLC to PDT where he was drafted into military service. His tour of duty included stays in Illinois, Texas, and Missouri before being sent to Natal/Brazil as U.S. Air Corps Control Tower operator, with obligatory knowledge of Morse Code, to ferry in home-bound U.S. military aircraft as they came in over safer South Atlantic routes before flying north to MIA and points beyond. He left the Service in 1946 after being hospitalized at SFO's Letterman Gen'l Hospital for three months for a service-related lung infection. He rejoined UAL in SLC and, in 1949, was transferred to Moline as Sr. Agent. Then, it was off to PVD as Station Mgr. He left R. I. for MDW as CSM/Asst. to Regional Mgr. and soon moved to LGA as Sta. Mgr.

In 1961 he transferred to PIT as Sta. Mgr. In 1963, it was back to NYC's JFK as Sta. Mgr. From 1967 until 1969, he was ORD CSM, when he was asked to work at EXO as Dir. of Ramp & Customer Service. By 1973, a SFO CSM position opened and he requested to be transferred out of EXO in order to rejoin "The Field." He always wanted to retire at age 60 and, in early 1980 he actively worked on a move to SLC, his career's starting point. There, his official title was City Sales & Service Mgr. until his retirement in Sept. 1980.

Frank served as RUAEA's president from 2000 to 2002, with an additional two years as "past president." To this day, Frank (93) recalls the fun he had while working in UAL's field operations; of being part of the travel scene; and of participating in the PR end of it. He liked his coworkers who labored with him for the benefit of 'their company' - and he never forgot his early beginnings in a business that brought him great rewards for work well done, along with meeting so many dedicated coworkers. He & his family took ample opportunity of the travel around the nation & throughout the world. SLC/UT - June 30, 2012.

In closing we wish all of you good health and safety for the rest of the summer months. Here in the western states it has been so dry and so many are combating fires, including those of us here in Utah. Our prayers and love go out to those who have lost their homes and loved ones along the way. We'll talk to you again in September. Just so you know, today we are "dancing in the rain!"

# TRAVEL POLICY OVERVIEW As of August, 2012

Leisure passes	Unlimited for travel on United and United Express. Most service charges waived for travel systemwide. Two checked bags allowed per ticket.	
Vacation passes	8 one-way per year. <b>Highest boarding priority</b> . All eligible pass-riders traveling together on at least <b>one</b> leg of the journey will use only one Vacation Pass. Most service charges & taxes waived, depending on years of service. Two checked bags allowed per ticket.	
myUAdiscount	20% discount on revenue tickets systemwide. Two checked bags allowed per ticket. Enrolled Friends are also eligible.	
Enrolled Friends	Up to 2 friends or family members may be designated annually. They are <u>not</u> eligible for travel on any other carriers, including Express/regional carriers <b>except</b> Hawaiian Airlines.	
Interline Travel	Interline discounts and ZED (Zonal Employee Discount) fares for all employees, retirees & eligible pass riders <b>except</b> Enrolled Friends. Buddy Passes	Retirees NOT eligible.	
Emergency Travel	Retiree or spouse/domestic partner are eligible for emergency, <b>positive space</b> , <b>fee-waived</b> travel if either becomes ill <i>while traveling</i> . Should either die <i>while traveling</i> , the other is eligible for <b>positive space</b> , <b>fee-waived</b> travel to accompany the human remains. Dependents are not eligible.	

Eligibility	
Retiree & eligible passriders	Unlimited Leisure Passes. 8 one-way Vacation Passes annually in January, valid for 5 years.

## Service Charges

**Coach:** all retirees, employees & eligible pass riders, charges waived for both domestic and international travel except for departure taxes/regulatory fees. **First & Business, Domestic:** 25+ years, charges waived (with above exceptions), 0-24 years, 90% discount off ZED fare. **First & Business, Int'l:** 25+ years, charges waived (with above exceptions), 0-24 years, 50% discount of ZED fare. ## **Inputed Income Tax**

Some travel is taxed as imputed income to the employee/retiree. Examples: Domestic partners', enrolled friends', non-dependent children between 18-26 yrs, dependent children in the military between 21-26 yrs and myUAdiscount tickets. (See <u>Flyingtogether.ual.com</u>> "Travel">"Travel Policies"). You'll receive a W-2 for all travel exceeding \$600 value.

How To	
Authorize pass riders	Log in to <u>flyingtogether.ual.com</u> and click on "All About Me" in the upper-left corner. On that page in the upper-left corner are the links to healthcare and travel authorizations. Click on the appropriate link and follow the instructions.
Check your pass balance	Log in to <u>flyingtogether.ual.com</u> and click on "employeeRES" located in the Travel box, upper-right corner. On left side banner, click on "My ePass Balances".
List for travel	Log in to flyingtogether.ual.com and click on "employeeRES" located in the Travel box, upper-right corner. On left side banner, click on "Flight Search". <i>Very Important</i> : if your plans are for round-trip travel, list <i>each way separately</i> and <b>make a note of the record locator/confirmation number of each</b> . If you want to be boarded regardless of class, list for FC. If you're boarded in another class, keep your boarding card and apply for a refund (see below).
Special note about listing!	At the time of this printing, the airport check-in system will board you only in the class for which you are listed. It boards by class of service listed and "Board Year", in that order. Example: you are the 3rd standby and you listed FC. The first person listed FC which filled the cabin. The 2nd person listed Coach and was accommodated. The system will bypass you and board all the rest on the list who listed for Coach even though your boarding priority is higher. After everyone who listed in Coach is accommodated, then you will be, too if seats remain.
Pre-pay charges	At time of listing, you will be required to enter a credit card number. WRITE DOWN THE AMOUNT shown for your travel <u>before</u> clicking on "Book Itinerary". Any applicable charges for listed travel will be <b>immediately</b> charged to your account. If your plans change, BE SURE TO CANCEL!
Service charge calculator	Log on to flyingtogether.ual.com and click on "employeeRES" located in the Travel box, upper-right corner. On left side banner, click on "Quick Links" and then "Pass Calculator". It will show not only the charges for your travel, but also the imputed income taxes.
Other airlines (ZED fare travel)	Log in to <u>flyingtogether.ual.com</u> and click on "Travel", then "Travel Policies", then "Other Airline/Interline Travel". Be sure to check the travel agreement that UAL has with your desired carrier. The "ZED & Industry Travel Discount Form" will provide a fill-in format for your desired travel. It's personalized, since you've already logged on to the Company website. You'll receive an email within 5-20 hours with your confirmation number. Take that to a United ticket counter to have the ticket/s written. In a few cases, payment & listing may be available online. There is also a link to Refund request, should that be necessary.
Applying for a refund of United charges	If this is necessary, go to "united.com", click on "reservations", then "refund policy".
Checking in from home	May be done 24 hours in advance. Go to "flyingtogether.ual.com" > "employeeRES" > "MyTravelPlans" or "united.com" and get 'er done. All you need is your record locator/confirmation number. You can print your boarding pass from your personal printer.

What Happens If	
I change my mind?	Any applicable fees were charged to your credit card at time of listing. You MUST cancel the listing to credit your account or you'll have to suffer through the refund process.
I listed FC but rode Coach?	See "Applying for a Refund" above, if necessary. Remember, much of the travel is service charge waived!
I wasn't accommodated on the flight?	The CSR <i>should</i> automatically roll the standby list over to the next flight that day for the city pairs for which you are listed.
Some of my party rode a different flight than I?	If your party was split up to accommodate you all, the original listing (PNR) will determine the charges for everyone.
I couldn't get out and had to spend the night?	It will be necessary to make a new listing for the next day. The airport standby lists do not roll over from one day to the next. Best to call the ePass Line at (866) 359-3727 before you leave for a hotel, beg & plead one of the CSR's to do it for you or open up your laptop & redo it yourself.
