### **GENERAL NEWS**

#### FROM THE PRESIDENT

The primary activities of RUAEA are the publication of a national newsletter and to conduct an annual convention. I would like to take this opportunity to talk to you about how a convention is planned and what it will take to keep this important part of our organization going.

The convention site selection committee starts two to three years in advance of a convention talking to hotels that have enough rooms available to hold a convention, usually a minimum of 500 rooms, reception space & banquet facilities for 1,200 people, meeting space for committee meetings, and most important, the price of the hotel rooms. It is very hard to predict how the economy will affect the price of the hotel rooms two years in advance, but the contracts must be signed this far in advance to get the dates we need for the convention, also the price of the hotel rooms that our members can afford.

We must commit to between 1730 to 1850 room-nights during the convention to acquire the additional concessions we need for our meeting and banquet rooms. Failure to meet these room night commitments means we must pay a penalty for any unused rooms. It is very important that you stay at the convention hotel to support RUAEA for the next convention, also future conventions, and you will not miss any of the fun times.

As you know, 2004 convention is in Seattle. The room rates are very good - free shuttle service to the hotel and free parking, so come early and stay late - May 23 to May 30, 2004. The criteria for a convention city to meet are:

- 1. Attractive hotel, beautiful city and great tours.
- 2. Transportation on United or United Express.
- 3. Local group strong enough to operate a convention. Seattle has it all.

The RUAEA Executive Committee, the Board of Directors & staff extend to you and your family a very Merry Christmas and a Happy & Prosperous New Year.

#### FROM THE EXECUTIVE VICE-PRESIDENT

#### **RUAEA'S Denver Office**

The charter and bylaws of RUAEA state: "The purpose of this organization is social, to maintain the friendships & associations of its members. Additionally, the Association shall function as an information source between United Airlines & the RUAEA membership..." The Policy and Procedures Manual states, "The primary activities of RUAEA are the publication of a national newsletter and the conduct of an annual convention." In this issue Jim Fauber discusses the importance and intricacies involved in the annual convention. I will briefly discuss RUAEA's Denver office.

The Denver office has two main functions: one, it publishes & mails RUAEA's monthly newsletter; two, it manages & maintains all correspondence to RUAEA, membership records, processing & files.

You all know Jo Madden, our editor of RUAEA's newsletter. She is ably assisted by Bonnie Ceperley & Shirley Smith. Jo collects information from all chapter correspondents, the convention committee, various sources in United Airlines, the Membership Secretaries, letters and comments from members, plus any other source she can find to glean information she feels would be of interest to retirees. The "stuff" she receives includes neatly typed notes, articles, hand-written notes, scribbled comments on scraps of paper & most anything you can imagine. It's incredible how Jo, Bonnie & Shirley pull all that together to produce this newsletter you are reading. (As I reviewed all this with Jo the past month, this is a Herculean job. I must say we, RUAEA members, are getting our money's worth.)

Once the newsletter is "in the can" on a computer disk and a paper copy ready for reproduction, Mel Conine, Office Manager, goes into action. DENTK "print shop" prints, collates, staples & produces about 10,300 copies ready for mailing. The Membership Secretaries provide Mel with a disk of current members' addresses. On the last Sat. of every month a group of 40-50 retiree volunteers meet at DENTK to affix mailing labels, bundle newsletters by ZIP code, sort & bag them in U.S. Mail bags ready to be transported to the Post Office. Mel, with help, does all the preparatory

work, follows through with the Post Office to assure your newsletter is "in the mail", also makes sure that all bills are paid.

Our Membership Secretaries are Harriet Ahr, Adele Fishler & Bev Strand. They handle and process correspondence, payment & deposits of annual dues, changes of address, special requests, etc. They update all RUAEA records at least three times per week. Other than conventions & financial, they manage & maintain the official records & files of RUAEA.

Dean Moberg has provided the technical computer support. He has had to resign from this support due to health reasons. Howard Tress, with help from Harvey Collin, is moving in to provide this support.

The recent development of the RUAEA website has added a significant dimension to the Denver Office operation. The newsletter & membership data are coordinated with our website developer. We are still in the early stages of developing a truly comprehensive website. We currently are resolving some everyday "bugs" striving to make it more reliable & consistent. We are looking to develop it much beyond publishing the newsletter electronically. We are looking at features that will provide retirees with more information about the company, benefits, industry & leisure activities to name a few. Next month we will include an article in the newsletter addressing the many questions many of you have asked about our website.

To support the Denver Office operation we have assessed what we need to do to be more effective & efficient in serving our membership. We are up-grading our Denver Office to provide these volunteers with the tools they need to do their jobs. We will keep you informed on our progress and developments.

#### UNITED INTRODUCES DAILY NONSTOP SERVICE BETWEEN WASHINGTON, D.C., & SAN JOSE, COSTA RICA

United will launch daily, nonstop service to San Jose, Costa Rica (SJO), from its hub at Washington Dulles International Airport (IAD) effective Feb.

12, 2004, pending government approval.

This move follows United's expansion in the Caribbean, which includes flights to the regional leisure destinations of Grand Cayman, San Juan, Aruba and St. Thomas, U.S. Virgin Islands. In addition, service from Washington Dulles to Cancun, Mexico, will begin on Feb. 14, 2004, pending government approval.

According to David Leib, manager-Network Strategy, "The success of our nonstop service from Dulles to Mexico City and our recent new services to Buenos Aires & Sao Paulo led us to explore more opportunities in Central & South America. We have been developing the San Jose-U.S. market on a one-stop basis -- via Mexico City & Guatemala City -- our data shows that traffic has grown to the point where it can support nonstop service."

The new service will use Boeing 757 aircraft. The southbound flight will depart Washington daily 5:25 p.m., arrive in San Jose 9:22 p.m. The return flight will depart daily from San Jose 10:15 a.m., arrive in Washington 3:37 p.m.



#### FIRESTORM-SAN DIEGO COUNTY

For those of you who have been reading about the devastating fires in San Diego County, which began 10/26, we would like to thank one & all for your thoughts and prayers. It is the most heartbreaking occurrence since the 1906 earthquake, the worst fire in California history. So many good people lost their homes & all of their lifetime treasures. Some folks had barely 10 minutes to gather personal items, which may have taken a lifetime to acquire. Every day was like twilight all day; by 3:30 p.m. we would have total darkness. Occasionally the sun would show through all of the smoke as a huge orange ball. It was so very eerie. We now have help from No. CA, AZ, NM, UT, CO, OR & other states. Also C-130s for water and retardant drops. So with all of that manpower & equipment available to help, the fire SHOULD be contained early Nov., barring a return of the heavy winds & hot temperatures, which turned the fire into a firestorm. Up to now, 8 volunteer firefighters lost their own homes while fighting to save the homes of others.

At news letter time: 1 firefighter from Marin County was killed, 16 people were killed when they could not outrun the fire, 2,337 homes were lost, 391,856 acres are burned - an area larger than LAX. Never in the history of firefighting here in CA have so many come to help. 4,275 personnel are now on hand. Most are being sheltered at a mini-city quickly set up at Gillespie Field, (an airport for private planes), in El Cajon. An appeal went out for cots, blankets, pillows, toiletries & food. So many residents responded that shortly after the appeal was made, another announcement thanked everyone for their response, said that there was no more space for donations.

Our Halloween Party was held at the Fireside Restaurant in Escondido on Oct. 30 as planned. It was touch & go as to whether we would be able to do so due to the fires & the unhealthy air quality. Pres. Marian Owens, asked for a moment of silence in respect for all those who lost their lives &

Even with your home closed up tight, you could still smell & inhale the smoke and soot. Our families are also safe; that is the greatest blessing.
