#### **FROM THE PRESIDENT**

Many retirees received a Solicitation Package from the Bankruptcy Court. Many are asking even more questions, "What is this all about?", "What does this mean?", "What should I do?"

"What is this all about?" This is all a part of the bankruptcy process. In Sept., United filed the Disclosure Statement and Plan of Reorganization in Bankruptcy Court. Objections were filed by the PBGC, Public Debt Group & U.S. Trustee. United agreed to some changes requested by the parties. On Oct. 23, 2005 Judge Wedolf of the bankruptcy court approved the Disclosure Statement and Plan of Reorganization. Following this approval, on Oct. 27, 2005, the bankruptcy court mailed a solicitation package to all creditors entitled to vote on the Disclosure Statement and Plan of Reorganization. The Bankruptcy Court determined & identified who should get this Solicitation Package and vote. In this Solicitation Package are the Disclosure Statement, Plan of Reorganization, supplemental information, voting instructions and a ballot. Voters have until Dec. 19, 2005 to accept or reject the Plan. (That is, votes must be received by Dec. 19, 2005 by 16:30 PST for votes to count.) The confirmation hearing in bankruptcy court is scheduled to begin Jan. 18, 2006. The court will review the voting results, determine if United has met all necessary requirements – specifically, the Plan is proposed in good faith, it complies with all statutory requirements, it's not likely to be followed by liquidation, there is no likely need for further financial reorganization. If all this is met the court will confirm it and United plans to officially emerge from bankruptcy in February, 2006.

"What does this mean?" That is a very good question. Refer to "From the Executive Vice-President" article.

"What should I do?" We - RUAEA - will not take a position or advise anyone what he/she should do. We will not give any legal advice to "Accept" or "Reject" the Plan. This is a decision each individual must make.

#### FROM THE EXECUTIVE VICE PRESIDENT

By now you know that the initial signup period for Medicare Part D prescription drug coverage in 2006 STARTS on Nov. 15, 2005 & ENDS on May 15, 2006. That coverage will, if accepted, applies to all those of us eligible for Medicare, however, before you decide to signup with one of the companies certified to provide that coverage in your state, please focus on the following:

#### **IMPORTANT**:

- Read & understand the "Medicare and You 2006" booklet you have already received (particularly pages 44 -45 if you are now covered by an existing medical/prescription drug plan).
- If you are covered by the United Medical Plan or by another plan from a former employer or union, read & understand the Notice of Creditable Coverage they were required to send you (United's was sent dated October 5). If that plan is, on average, at least as good as the Medicare coverage you may want to stay right where you are.

#### **EVEN MORE IMPORTANT:**

If you decide that prescription drug coverage through the Medicare plan makes sense for you, do the following <u>before</u> you contact any of the companies that will provide the Medicare coverage in your area:

- List the medications you take & the dosage.
- List what you currently pay for your prescription drugs.
- List the name, address & phone number for the pharmacies that you like to use.
- Talk to your family members, health care provider or pharmacist about choosing the best plan for you.

If you need help in understanding your options, call your State's Health Insurance Assistance Program (their number is on the inside back cover of the "Medicare and You -2006" booklet)

#### FROM THE EXECUTIVE VICE PRESIDENT

# INFORMATION ABOUT HOW TO VOTE ON THE UNITED AIRLINES REORGANIZATION PLAN FOR PRE-JULY 1, 2003 RETIREES BALLOTS ARE DUE BY DEC. 19, 2005

Recently, United mailed copies of its Reorganization Plan & Disclosure Statement to creditors including certain eligible to vote retirees. **These documents are found on the computer disk you received in the mail.** You can also find a copy of these documents at United's website: <a href="www.pd-ual.com">www.pd-ual.com</a>.

In summary, the reorganization plan is a contract between United & its creditors, under which United agrees to pay its creditors. Creditors are entitled to vote whether they wish to accept the plan or not. Only if a sufficient number of creditors vote to accept the Plan, & the Court finds it meets certain legal requirements, will the Plan become binding. The Disclosure Statement contains financial and other information to allow creditors to decide how they should vote. You also should have received a colored paper ballot, a summary of the Plan (the full document is on the computer disk) plus notice telling you what the deadlines are for voting, together with an envelope you should use to return your ballot.

#### RETIREE MEDICAL BENEFIT RELATED CLAIMS:

Retirees eligible to vote are those who retired before July 1, 2003 & who were enrolled in the UAL medical plan, because they have claims against United for medical benefits that they will not receive. As you know, United asked the Bankruptcy Court to allow changes in the medical plan for its pre-July 1, 2003 retirees. A Retiree Coalition represented those retirees in connection with United's request in negotiations which resulted in adjustments to retiree medical benefits. You have previously been told about these changes which went into effect in 2004, thereafter, a claim was filed against United on behalf of all retirees in the medical plan for the value of medical benefits they will not receive in the future & the increased costs they must now pay for the adjusted medical benefits.

Upon confirmation of the Reorganization Plan, United must continue to offer medical benefits to its pre-July 1, 2003 retirees at the levels negotiated during the bankruptcy case & will not be able to legally change these benefits. These agreements are described at pages 77-78 of the Plan (Appendix A on the disk; Adobe Acrobat page numbers 83-84) also page numbers 139-141 of the Disclosure Statement (the Disclosure Statement is on the disk; adobe acrobat page numbers are pages 144-146).

On the front of your ballot is a box which states "Amount of Claim." Line 2 in this box states the amount of your "Section 1114 Claim." The dollar amount listed after the description "Section 1114 Claim" is the dollar amount that United owes to you because it modified its promise to provide you with medical benefits during your retirement. This box also contains two other types of claims which are described below. The Section 1114 Claim has nothing to do with amounts you will receive in the future for your Pension.

In its Reorganization Plan, United proposes that all of its retirees' claims for retiree medical benefits be included in a "Retiree Convenience Class." The description for how United will treat these claims is found at pages 51-52 of the Plan (Appendix A on the disk; Adobe Acrobat page numbers are 57-58) also page numbers 113 & 139-141 of the Disclosure Statement (the Disclosure Statement is on the disk; Adobe Acrobat page numbers are 118 & 144-146).

#### **YOUR VOTE:**

Your first decision is whether to vote for the Plan: If you decide not to vote, and the Plan is approved by the Bankruptcy Court, you will still receive payment for your Section 1114 Claim. United is proposing to satisfy the claims of all of its unsecured creditor retirees by distributing new common stock in the reorganized company in full satisfaction of the claims. The Disclosure Statement explains why United believes you should support the Plan.

Retirees also have two additional decisions to make: United has grouped all of the Section 1114 Claims in a Retiree Convenience Class. United proposes that it be allowed to sell the stock for retirees & distribute the cash. Other unsecured creditors will receive the stock directly. If you do not do anything, United will sell that stock for you, deduct the costs of sale from the money received for the stock & any applicable taxes that would be due, pay you in cash what remains. United has not stated in the Plan what the costs of sale will be or how or when it will sell the stock. If you would prefer to receive the stock and decide whether or when to sell your stock, you must elect not to be included in the Retiree Convenience Class. This requires you to complete & return the ballot form, check the box on the Ballot listed under Item 4 – Optional Election.

In addition, United has stated on the Ballot what it believes the amount of your Section 1114 Claim to be. The Retiree Coalition has reviewed United's calculations of the claim amounts & agrees with those amounts. You have the right, however, to change the amount, by stating a different amount on the ballot, but if you do, United may require you to go to Court to defend the number you place in Item 4 on the Ballot. If United does so, you will have to appear in Bankruptcy Court to defend the amount you selected. This may require you to hire a lawyer & expert witnesses to support your number. If you do not put anything on the line found under Item 4, your claim will be the amount stated at the top of the Ballot.

#### SERP CLAIMS AND PILOT NON-QUALIFIED BENEFIT CLAIMS:

Your ballot will only list a dollar amount at the top for "SERP Claim" or "Pilot Non-Qualified Benefit Claim" if you are a retired pilot or retired member of management that participated in the non-qualified plans for retirement benefits.

#### UNITED LAUNCHES LIBERIA, COSTA RICA SERVICE

The lesser known Liberia – a resort community on the Pacific side of Costa Rica, far from West Africa – becomes a new United destination in Dec., just in time for the winter holidays.

The new seasonal service between Chicago O'Hare will run from Dec. 15 to April 29, & gives customers in the US access to another sun destination.

The flights operate on Sat. only. United flight #1099 departs CHI 8:30 a.m., arrives in Liberia, Guanacaste 1:45 p.m. Flight #1098 departs Liberia 2:40 p.m., arrives CHI 7:54 p.m. The new flights will be operated with an Airbus 320 aircraft.

#### **UNITED AIRLINES HISTORICAL FOUNDATION**





Nov. issue of the RUAEA Newsletter explained the service pins. I found out from Barbara Hanson that the first service pins were issued in 1937. The 4 stars at the top of the service pins represent the 4 small airlines that formed United Airlines. They were Boeing Air Transport, Varney Air lines, Pacific Air Transport & National Air Transport. These airlines were among the first airlines in the USA & came into being as a result of the 1917 Post Office air mail contracts for an airmail service trancontinentally between New York & San Francisco. Boeing Air transport won the Chicago - San Francisco section & flew it successfully using 25 Boeing B-40a biplanes.

National Air Transport won the contract for the Chicago - New York section of the route & service was started using single-engine Curtiss Falcon biplanes, which could also carry passengers.

Pacific Air Transport won the Seattle - San Francisco - Los Angeles section of the mail route & began its operation with the Ryan M-1

Varney Air Lines was awarded the Elko-Pasco leg & flew it using the famous Swallow Biplane.

United Air Lines Inc. of Chicago began on March 28, 1931 as the holding company of these 4 mid-1920s US air carriers.

Now we know what the 4 stars mean in the service pins.

#### **KATRINA HURRICANE NEWS**

RUAEA Pres. Marlin Lade mailed letters to all Retirees in the areas of Hurricane Katrina trying to contact them to find out how they were impacted, how they were getting along, offering any help RUAEA could extend & advising them of the "Employee Relief Fund".

We thought our members would like to read some of the letters we have received:

Earnestine Marie Whitney: Thank you so much for your concerns & prayers. My family & I are all well; we were not terribly affected by the hurricane. I'm in Clinton, MS – only experienced power outage for about 1½ days only inconvenienced a short while. I also experienced long waiting periods to get gas for about 4-5 days. My daughter's power was out a week. We lost a little food, they lost time from work & the children from school, however, it was nothing close to the lost of lives & livelihood that so many have experienced. We thank God & still remember those less fortunate ones in our prayers.

Thank you again for your concern, I really appreciate it & was happy to hear from you.

**Bob Wendrock**: Thanks for your kind interest in United retirees in Louisiana in general & the Wendrock family specifically. We made it through both storms mostly unscathed. The Baton Rouge area sustained lots of rain, wind, power outages for days plus some structural damage, but nothing like New Orleans & points east (Katrina), Lake Charles & points west (Rita). We are blessed & thankful. As you probably know Baton Rouge doubled in size almost overnight causing all the problems that you might expect without the infrastructure to sustain it. The good news is we are now a fairly major city. It's time for United to fly into here like the other carriers are starting to do.

All of our families & friends in those hard hit areas made it through okay as far as we know. Except for 6 weeks of extended family living with us -- a 85 year old, a 3 year old, a one month old with parents, 4 dogs, 2 cats -- and the life style change that causes, we can say we are now back to normal.

Again, thank you for your concern.

<u>Mike Martin</u>: Here is an update on my damages following Katrina. My house had minor damages, but lost a refrig & freezer. I was away from my home for 3 weeks and had some expense. I also lost a home in Mississippi. I have not heard from an adjuster & don't know what will be my out of pocket cost. I am one of the lucky ones & able to live in my home with no interior damages. Thanks for your interest.

Joan Frasier, 107 Coachman Drive, Houma, LA 70360: Thanks for the offer for help. We have been so blessed, just a few limbs off the tree in the back yard, a little damage to the fence and gate. Within just a few miles flooding & devastation everywhere here in Terrebonne Parrish. We're 54 miles from New Orleans, over 300 miles from Lake Charles & Cameron, LA. We also have an RV lot in Pass Christian, MS. We sold our RV there just a few months ago. We lost an 8' x 10' storage shed that was on the lot. All the motor homes & 5th wheel trailers were in 8' of water, all were totaled. Thankfully no injuries or loss of life. Thanks again for your concern.

Thomas Dowd, 18 Downing Dr., Covington, LA: Thanks for the letter of concern for the retired employees in Louisiana & Mississippi. I live 25 miles north of New Orleans; by the grace of God survived the hurricane. All the trees that were knocked down missed the house by inches. We had no water or wind damage to the homestead. We were without electricity for 15 days but by comparison to what you have seen on TV considered ourselves blessed.

United was always a company defined by its employees care for one another. Once again the light shines through witnessed by your letter. We have a lot of employees in the area who I am sure need assistance, that were not as fortunate as myself. I hope your letter finds them & I will also pass the word to other employees I know.

Gerrit Erickson called me on the telephone. He lives in Ocean Springs, MS, across the bay/bridge from Biloxi. Gerrit retired from MSYOZ in 2003. His place caught the brunt of the hurricane. He ended up with 6 feet of water in his house; it suffered extensive damage. They are going through the process of assessing damages, assessing feasibility of salvage, repair, rebuilding or demolition. Currently he is living with his daughter, about an hour away. I discussed ERF with him. He is working with all the appropriate agencies. This will take time. In the meantime he is in good spirits, has a positive outlook & looking forward to recovering. He mentioned several other retirees in the area who suffered extensive damage. I suggested they contact us; & that he discussed ERF with them.

Joan Kadlubowski, 160 Gavin Rd., Wiggins, MS 39577: I live in southern MS, my husband & I have basically lost our home. We are both disabled, have limited income & no savings left. FEMA is slow to help & the cost involved to keep afloat is more than we can afford. Our story is long & involved. We were hit by the hurricane plus tornadoes. We have received nothing from the Red Cross as well! My phone number is (601) 928-7068. My e-mail is tgfp@bellsouth.net. So much has happened here.

Thank you so much from a fellow retired employee who needs assistance.
