






OTHER CONVENTION NEWS

A reminder from last month, our tour committee is working on a pre-convention & a post-convention tour. The pre-convention tour will begin from a hotel near SFO, include sight-seeing & a layover en route to Sacramento. The post-convention tour will leave from Sacramento, involve sight-seeing & possible entertainment en route back to the SFO area. Other tours that are being worked on include local museums including art, mansions, aviation, gold mines in the area, wineries & river cruises.

An option on getting to Sacramento is purchasing a ticket on United with the employee/retiree discount of 20%. When booking the flights be sure to tell the agent you are a retiree & use the special code which is **S*PMO/EMP20**. Another option is to use a senior fare on Southwest. These fares are at least 50% of the standard fare, are changeable & cancelable with no penalty. You can check them out at www.southwest.com. You do have to be 65 or older. There is also Amtrak. We have heard from several that they are planning to arrive by train. The Amtrak station is about a dozen blocks from the hotel. Finally here is a recap of the space available options. United has a good schedule with 27 daily flights. Also there are many other carriers that offer us a 90% or 95% discount - Alaska/ Horizon, Aloha, American, Continental, Delta, Frontier, Hawaiian, Mexicana, Northwest & US Airways/America West. American offers ZED (Zonal Employee Discount) fares that are based on mileage. An example is DFW to SMF is \$31 each way. To obtain ID90, ID95 or ZED fare tickets, contact the Interline Ticketing Desk at 1-888-874-1581. Their hours are 0700-2100 CT Mon. - Fri. & 0700-1900 CT Sat. & Sun. Last but not least, JetBlue & Southwest offer retirees standby fares \$25 OW, \$50 RT plus taxes. For both of these carriers you will need a letter of introduction that may be obtained by calling United's Benefit Dept., 1-888-825-0188.

Lastly, the Hyatt is now open for booking convention reservations. This can be done in several different ways. You can call their 800 number, 800-233-1234, call the hotel direct 916-443-1234 or go to the RUAEA web-site at www.ruaea.org, there is a link to a Hyatt reservation page with the correct price of \$99 per night plus taxes.

- The first cantilevered internally-braced allmetal airplane wing (and the equipment to build it)
- → The "Batwing Plane" (above, right 1918)
- → The all-metal "Torpedo Plane"
- → The Stout Air Sedan, first commercial allmetal airplane built in the U.S. (and with folding wings!)
- → The 4-bolt attachment for rapid airplane engine exchanges
- → The divided airplane landing gear (no solid axle)
- The "first" Ford Tri-motor (above, left 1926)
- → The "Bicar" motorcycle (two-speed auto-

- matic shift & side-saddle seating for women)
- The railroad "Pullman Railplane & Club Car"
- → The rear-engine "Scarab" automobile (1932)
- → The sliding automobile seat
- → The first rear-engined passenger bus (1934)
- → The first motor-home
- → Prefabricated housing
- The "Skycar" flying automobile (below, 1930)

The summer Stewardess uniform on display belonged to Ethel Anderson "Andy" Green. Andy flew from 1934 to 1941. Thanks go to Andy's family; Shirley Ellgaard & Pamela Berding for providing Andy's uniform.

The cases' walls hold a recently-acquired display of this era. A DC-3 passenger blanket & other artifacts of the period cover the floor.

UNITED REINFORCES CAPITAL-TO-CAPITAL FOCUS WITH NEW WASHING-TON, D.C. – ROME SERVICE

- → Pending foreign government approval, United will offer daily service between Washington Dulles & Rome on April 1, 2007.
- This service & the 2 inaugural flights we will launch later this month from Dulles to Kuwait City & Tokyo Narita reinforces Dulles as our international hub on the East Coast. In addition, we will serve a dozen world capitals directly from Dulles by Nov.
- → We continue to wait for government approval on our proposed service between Washington, D.C. & Beijing.
- → By Nov., we will have increased our international & U.S. domestic service from Washington Dulles by 39 new flights, which represents

roughly 14% increase in departures over last fall.

CAPITAL-TO-CAPITAL SERVICE FROM WASHINGTON, D.C. TO KUWAIT CITY & TOKYO TAKES OFF

United's focus on capital-to-capital service revs up as inaugural flights from Washington Dulles to Kuwait City & Tokyo Narita take off. The new service reinforces Dulles as our international hub on the East Coast. In addition, we will serve a dozen world capitals directly from Dulles by Nov.

- → United Flight 982, the first nonstop commercial service by a U.S. airline to Kuwait City, departed Dulles on Oct. 28, at 9:51 PM.
- United Flight 803 to Tokyo Narita, United's first ever between D.C. & the Asia-Pacific region, departed Dulles on Oct. 29, at 12:20 PM

Providing service from Washington, D.C., to other world capitals boosts governmental, business, academic & cultural relations between the U.S. & other countries.

United continues to wait for government approval on our proposed service between Washington, D.C. & Beijing.

UNITED MAKES CHANGE TO IMPROVE INTERLINE PLEASURE TRAVEL TICKET-ING PROCESS

Effective Nov. 1, 2006, U.S.-based employees, retirees & their travel dependents will be able to contact Detroit Reservations to build a passenger name record (PNR) for same-day, immediate-need interline reduced-fare pleasure travel. Once created, the PNR can be presented to a ticketing representative at the airport. Previously, same-day ticketing was restricted solely to an airport lobby transaction.

This change was made based on feedback from traveling employees & retirees. The Travel Advisory Committee & customer service staff, that obtaining same-day interline pleasure travel tickets at airports was difficult due to the complexity & time needed for the ticketing transaction in a busy airport lobby.

Eligible employees & retirees may obtain inter-

line pleasure travel tickets in three ways: by calling Detroit Reservations at 1-888-874-1581 at least two weeks prior to travel; by visiting any United-operated airport ticket counter; or by calling Detroit Reservations for same-day, immediate-need tickets.

Retirees must arrange interline travel well in advance as tickets are paper & the preferred method of ticketing is by mail (Call the above Toll Free Number for Office Hours). If airport pickup is required, try to allow ample processing time (ideally 72 hours) as customer service representatives (CSRs) may not be immediately available to issue interline tickets during peak travel times.

Retirees must do their flight research & have an itinerary available before requesting interline tickets. Neither reservations sales & service representatives nor CSRs are able to assist with trip planning.

TRAVEL TIPS BY BOB

There are some great websites that have information to help us during our travels.

Since Nov. 2006 the restriction regarding carry on liquids/gels has been relaxed. The Transportation Security Administration has a website at www.tsa.gov with information & instructions that tells us what we can & what we cannot carry on board.

On the home page you will see "3-1-1 on Air Travel". Just follow the links to get all the information. The **3–1–1 on Air Travel rule** is:

- → 3 ounce or less size containers of liquid or gel
- → 1 quart-sized, clear, plastic, zip-top bag holding 3 ounces or less containers
- → 1 bag per traveler placed in the security screening bin.

By understanding and practicing the **3-1-1 on Travel Rule**, your trip through security will be easier.

It's best to use the **3-1-1** rule for short trips. Most liquids, etc are better off being checked. And, even on short trips, if in doubt, be safe & put your liquids in checked luggage.

Some larger quantities such as prescription medications, baby formula & milk are allowed in

quantities exceeding 3 ounces & are not required to be in the zip-top bag, but you should declare these items for inspection at the checkpoint. It's better to give the security people a heads up & ask if the items are permissible than to be bogged down in the security process.

It's a good practice to come early & be prepared to wait. The volumes are heavier now & the increased security calls for patience.

Another good website is **FlightArrivals.com** at www.flightarrivals.com. This website is advertised as "The internets most comprehensive, independent source of arrival and departure information". Flight Information, such as checking a flight's status within a two-hour window by airline, flight number, city, airport etc., is a breeze. Just go to the site and follow the links. It's easy.

Confused about Travel Documents? Go to the U.S. Department of State website at http://travel.state.gov/passport/passport.

The State Department site explains how to obtain, replace or change a passport. User can download applications & forms. It also details how much passports cost & how long they take to get. For visitors traveling abroad, the site contains foreign entry requirements, such as whether a visa is required.

Note: Beginning January 8, 2007 all citizens arriving by ship or air from a foreign country must have a passport. Your local Post Office will also have application forms.

You may wish to save (bookmark) these websites to your "Favorites" for easy future reference. After opening the website click on the "Favorites" icon at the top of your screen & click on "Add to Favorites". It's a done deal!

FROM THE DENVER OFFICE

As with all things, time creates changes, so it is true here at the Membership/Newsletter office. The following information will be important to all our members. Over several months we have been updating the current database. This database, written in 1995, contains information on each member. All of this information is critical to the RUAEA organization. These changes are going to improve our service to our membership by being more accurate. Some of the changes you will notice, but for the most part, many of you won't. These will be the ones that are internal functions only.

There are many reasons why we are doing this. The most important is that it will give us an accurate look at who is active, who isn't in the organization, & will help us control our operating costs.

One of the immediate changes that everyone will see is on the front of the Newsletter & on the mailing label. As all of you know, when your birthday month comes around, there is a red stamp on the newsletter. It's there to wish you Happy Birthday and to remind you that your annual dues are due during this month. On the label, it also says "It's time to renew".

Under our current procedure you would continue receiving your Newsletter for two additional months even though you have not paid your dues on time. Starting Jan. 1, 2007 this process will change. Effective in Jan., you will still receive notification of time to renew on your birthday month as mentioned above. But, on the issue after your birthday month, if you have not paid your dues, you will also be notified that your dues are due, the statement on the label will say "This will be your last issue". This notice is in effect letting you know you are in arrears & this will be your last issue until you reinstate your membership. Any delay in reinstating will delay restarting your Newsletter. The RED stamp will be the same for both birthday month & month after issues. It will simply state "IT'S TIME TO RENEW - READ YOUR MAILING LABEL". (Similar procedure will be implemented for Web users).

The main reason for this change is printing & mailing costs. There are many of our members who do not renew their membership in a timely fashion. These extra mailings cost the organization additional funds. This policy is no different then any other periodical you may be receiving now; hopefully this notice will assist you in preventing an interruption to your Newsletter delivery.

Although changes are taking place, there is one that isn't, it's the Holidays. The Holiday Season is upon us. From all the Membership & Newsletter


Another cordial get-together was held by The Tall Pines group on Oct. 24 at Coco's.


