Let's Go RUAEA - Let's GO - Join us for our RUAEA 2008 CONVENTION - friendships you may meet in Pittsburgh!





#### OTHER CONVENTION NEWS

Pittsburgh International Airport has a landside and an airside. Two people movers transport passengers between each side. The airside has four concourses, A, B, C & D. <u>UAL is located on Concourse C</u>, along with the international arrivals. The Airmall situated along all four concourses giving air travelers a chance to shop. It was also voted the #1 Airport for conveniences for air travelers. The <u>landside</u> consists of car rentals, limos, buses, ticket counter, and the baggage claim area. Our RUAEA Welcoming Committee Chairman, **Carl Chiocci**, and his greeters will be at the baggage claim area to help direct with transportation, etc. Our hosting hotel (<u>OMNI WILLIAM PENN</u>) DOES NOT HAVE A COURTESY VAN TO THE HOTEL FROM THE <u>AIRPORT</u>). There is BUS TRANSPORTATION from the airport to downtown Pittsburgh (BUS 28X) that runs every 30 minutes from the Airport to Downtown PIT (No Charge) and will stop at 7<sup>th</sup> Street and William Penn (which is near the hotel). <u>FOR THOSE OF YOU OVER 65 – BRING YOUR DRIVER'S LICENSE (FOR IDENTIFICATION</u>) - NO CHARGES ON THE BUS TRANSPORTATION. Free transportation is funded by the PA Lottery for seniors over 65.

#### CALIFORNIA WILDFIRES AFFECT MILLIONS, UNITED EMPLOYEES AMONG THEM

Pete McDonald, Executive Vice President and Chief Operating Officer, shared the following update with all employees regarding how our local employees are affected by the southern California wildfires, and ongoing efforts to assist them.

Dear fellow employee:

The destruction caused by wildfires in California has been a major event in the U.S. this week. More than a million people were asked to evacuate their homes. Some of our own people were among them, mainly in the San Diego area.

Thankfully, we have no reports of harm to any of our nearly 4,000 United employees or their families based in southern California. There appears to be only a small number who have suffered damage to their homes. Others were impacted by difficulties in getting to airports in the region, and I'm sure that everyone will be glad to see the wildfires extinguished, so they can resume their normal lives.

Employees who had difficulties getting to their designated airports are working with their managers and supervisors to make arrangements for time off. We are working with employees who were subject to mandatory evacuation to provide appropriate pay protection. For those who lost their homes, we are providing two weeks of initial pay protection. We'll continue to stay in touch with our local management teams to ensure that we're providing the appropriate support in the days and weeks ahead.

Not surprisingly, our people rose to the occasion to address the challenges caused by the wildfires. Employees opened their homes to each other and their families, picked up trips for colleagues who couldn't make their scheduled flights and offered other forms of assistance. Stations offered help to each other with manpower support. Al Turner, SAN station manager, even reported that some employees slept over at the station on Monday evening to ensure that the operation was covered on Tuesday. Scott Dolan, Senior Vice President of Airport Operations, was in SAN on Tuesday and said that the team was doing a great job in the face of adversity.

From an operational perspective, the impact has been minimal. And that's important because, as an airline, we play an important role in areas affected by natural disasters and events such as hurricanes, floods, earthquakes and, of course, wildfires. We provide transportation back home, or to friends and family or to other destinations out of harm's way. Our customers depend on us. Without the dedication and commitment of our people, we wouldn't be able to do so.

I thought it was important to let the organization know that the majority of our people and their property are safe, and we are helping those who need assistance. I want to thank everyone for their role in enabling us to continue to serve our customers and support our colleagues.

He was referring to the RAF in WWII, but the fire fighters on duty during the first days of these fires (too many to count) do, as well. I spent five days working for the Red Cross at the evacuation center in San Bernardino. So many stories, some happy, some very sad, some heroic, but most important: EVERYBODY WAS DOING EVERYTHING POSSIBLE TO HELP THOSE IN NEED.

I am sure there are many stories still to unfold, as we finally learn the true extent of what the fires destroyed. I will close with this recommendation: If you have not recently thanked your local fire fighters (regardless of where you live), now is certainly a great time to do so.

#### UNITED ENHANCES PLEASURE TRAVEL / NRSA POLICY EFFECTIVE NOV. 1

As previously announced, United is enhancing its pleasure travel policy for United, United Express and Mileage Plus travel-eligible employees, **retirees** and travel-eligible family members effective Nov. 1, 2007. Following are the new travel program changes:

- ( First, we will no longer assess service charges in United Economy for domestic and international flights on United and Ted. We will continue to waive service charges for travel in United Economy on United Express. Applicable transportation taxes and fees will continue to apply.
- ( Second, we have simplified the way pleasure travel service charges for United First and United Business are calculated that, in many cases, will reduce the cost. Premium cabin travel prices will be based on a new zonal approach, matching the Zonal Employee Discount (ZED) structure used across the industry-including United in many cases to develop interline fares. ZED pricing is based on each flight segment by the mileage between a point-to-point origin and destination.
  - Premium cabin prices will be discounted 65 percent off of ZED fares for domestic travel and discounted 50 percent off of ZED fares for international travel. The cost for travel to Hawaii, which we have traditionally priced separately from other domestic travel, will be calculated in the same way as mainland domestic.

To assist employees in determining service charges, the Service Charge Calculator on WebList was updated on Nov. 1, so you can quickly and easily view the new pricing.

To make premium cabin pricing more consistent across United's network including mainline, Ted and United Express - we will be introducing the discounted ZED service charges for travel in the United First cabin on United Express.

In the first quarter of 2008, United employees, retirees and travel eligible participants will board United Express flights based on company hire date or years and months of service, according to United's travel policy. This will replace the current boarding at BP-8C, same day, time of check-in policy.

As before, United Express employees will board first on their own carrier, before other non-revenue, space-available travelers. For example, when the aircraft is operated by SkyWest, the boarding priority would be the SkyWest traveler, the United traveler, and then other United Express partner travelers.

# UNITED INTERNATIONAL AMENITY KITS FEATURED AS "BEST OF AMERICAN CARRIERS" IN BUSINESSWEEK REPORT

In September, BusinessWeek reported that United's international amenity kits were rated the best in-flight goody bags among American-based carriers. Both United First(R) and United Business(R) amenity kits were lauded.

Presented in sophisticated document holders or drawstring bags, the kits include such items as socks, eye masks, ear plugs, toothbrushes and toothpaste, mouthwash and, in United First, rejuvenating skincare items from H20 Plus, a Chicago-based brand.

"Amenity kits give us a chance to differentiate ourselves in a small but significant way," said Tom McGrane, managing director, Customer Experience. "They are functional gifts that serve as positive reminders of United."

Packaging design as well as H2O Plus item selections will change annually, with seasonal color variations every six months.

#### **ILLINOIS SENATOR DURBIN MEETS WITH UNITED LEADERS**

Illinois Senator Dick Durbin, a longtime supporter of United and a frequent customer, joined a group of United's managing directors and senior officers last week for a reception at the United Building in downtown Chicago.

Referring to United as a "success story", Senator Durbin talked about the importance of United to the Illinois economy, particularly as a key employer.

"How significant to be honoring you here today", said Glenn Tilton, United's chairman, president and CEO, referring to our Chicago headquarters. He thanked the senator for his support during bankruptcy, for his leadership on modernization of O'Hare airport, and discussed the company's long-term plans to strengthen its core business.

The event also afforded United the opportunity to discuss key issues facing the airline industry in Washington, particularly our priorities for modernization and funding of the Air Traffic Control system (see NewsReal from Sept. 25, 2007). The issue of passenger rights also was discussed, including the proactive actions taken by United with its updated pledge to enhance the customer experience, described in the revised "Our Customer Commitment".

## UNITED SIGNS CODESHARE AGREEMENT WITH TAM, EXPANDS BRAZILIAN FLIGHT OPTIONS FOR CUSTOMERS

United and TAM recently filed a codeshare application with the U.S. Department of Transportation and Brazil's ANAC (the Brazilian National Agency for Civil Aviation). Pending government approval, the partnership will expand destination options for customers of both airlines, and will enable them to earn and redeem frequent flyer miles on the partner carrier. The partnership enhances service to Brazil by adding codeshare flights from Miami (MIA) and New York (JFK) to Sao Paulo and Manaus.

TAM customers will be able to purchase tickets for United flights from Rio de Janeiro and Sao Paulo to Chicago O'Hare (ORD) and Washington-Dulles (IAD). This agreement, which is subject to the approval of the U.S. and Brazilian governments, will enable customers of both airlines to earn and redeem frequent-flyer miles on the partner carrier.

#### TRAVEL TIPS BY BOB

Topic for this month is the new Service Charges on pass travel. The "Base Fee" is \$0.00 for Economy travel for the entire UAL System. <u>All Employees</u> and <u>Retirees</u> will pay the various Fees/Taxes where applicable. There are many different Fees/Taxes as you will see in the Service Charge Calculator details in SkyNet.

Want to know the Fees/Taxes? It's easy: Sign into SkyNet >> From the Home Page click on **Travel** in upper Right >> and look down the Right Column to **Service Charge Calculator**. Enter Origin and Destination cities and you will see complete Fee/Tax details. You also can see if companions are eligible for travel, and the charges. *Note*: The total charge is for **each** segment. If you fly from A to B and have an intermediate stop, you will then be charged for the segment from A and the segment to B. The exception is if the same flight number is maintained and you are listed as a "through" passenger.

The fare base format is new and the calculation is based on interline ZED (Zone Employee Discount) and a percentage discount. Some cities with different mileage will be the same fare as they are in the same zone category. Compared to old fares, they are quite similar although some will be more and some less. The variance I found was in the range of +/- \$5.00, with the exception for International through fares. The overall service charge for International fares is not easy to track and the bottom line is "They are what they are".

#### **RUAEA** features:

- (Yearly dues are \$20.00 payable every 12 months and are processed ONLY through the Denver office.
- ( Dues are used for mailing monthly newsletters on hard copy or accessing monthly newsletters via the internet. For the monthly newsletters, members may choose one of these delivery options but NOT both
- ( Payment does not cover dues for other Chapter organizations within RUAEA.
- ( Chapter dues do not cover RUAEA features.

#### **Chicago Skyliner features:**

- ( Dues are \$5.00 and are payable the beginning of the calendar year in January by the 31st.
- ( Dues cover printing and postage for the activity flyers or correspondence mailed throughout the year.

For example, for someone wanting to join the Chicago Skyliners Chapter AND RUAEA, the total cost to them would be \$25.00, payable to two different locations, generally at two different times of the year. This would enable them to receive the monthly newsletters and local flyers. In order to attend the yearly national convention, one MUST be a member of RUAEA; if not a RUAEA member, they could only attend as a guest.

It is important to include your file number on your check and on any correspondence to the National or Local chapters. It is the desire of the Chapter to encourage members to ask non members to join and also to invite family, friends and guests to our events throughout the year.

It is also important that you keep your family status and address information current, so that flyers and any correspondence can be sent without delay. An audit of our membership list is conducted periodically to update active members' information. These audits include delinquency of dues, change of address, telephone or status. If dues have not been paid by January 31, 2008, members may be dropped from the active membership list and will no longer receive notices of future Skyliners events.

# **BOEING (Continued)**



In early 1924, the Air Mail Dept. of the Post Office opened a competition to design a new air mail plane using the "Liberty" engine. Boeing's entry was the "Model 40". A single "40" prototype was built and bought by the government; however the contract was awarded to Douglas for their "M" series of planes. Boeing then "shelved" the design.

1926 saw major changes in the management of Boeing Airplane Company. President Ed Gott resigned, Phil Johnson became president, Claire Egtvedt was named vice president and Wm. Boeing assumed the chairmanship.

The company had been designing and building various models of military aircraft under government contracts since receiving the "DH-4" modification contract in 1919. In general, business was good.

In the Fall of 1926, Claire Egtvedt was thinking of starting an airline passenger service connecting Seattle, Vancouver and Victoria when Eddie Hubbard told him some exciting news.

The Post Office Department, which had awarded CAM "feeder-contracts" during the previous year, was about to let private contractors bid on the Transcontinental Trunk Route!

The route was to be divided into two legs - San Francisco to Chicago and Chicago to New York. The stipulation for winning a leg was that the successful bidder must furnish 25 planes and begin service by July 1, 1927.

Hubbard believed that Boeing could win the San Francisco - Chicago contract and successfully fly the leg with the "Model 40" (photo).

Substantially underbidding Western Air Express, Boeing won the contract on January 15, 1927.

The design of the "Model 40" was altered to allow 2 passengers in an enclosed cabin and the new air-cooled 410 hp Pratt & Whitney "Wasp" engine replaced the water-cooled "Liberty" engine.

In anticipation of winning the CAM 18 contract, Wm. Boeing organized the Boeing Air Transport company (BAT) with offices in Salt Lake City. Edward Hubbard was hired and named VP of Operations. After winning the contract, the 25 "Model 40A"s were built, pilots were hired and flights began on July 1, 1927.

April 2, 1927, after rescinding the contract it had previously awarded North American Airways, the Post Office Dept. announced that the CAM 17 New York - Chicago route was awarded to National Air Transport (NAT).

NAT flew the CAM 17 inaugural flights Sept. 1, 1927 using Curtiss "Carrier Pigeons" from CAM 3.
